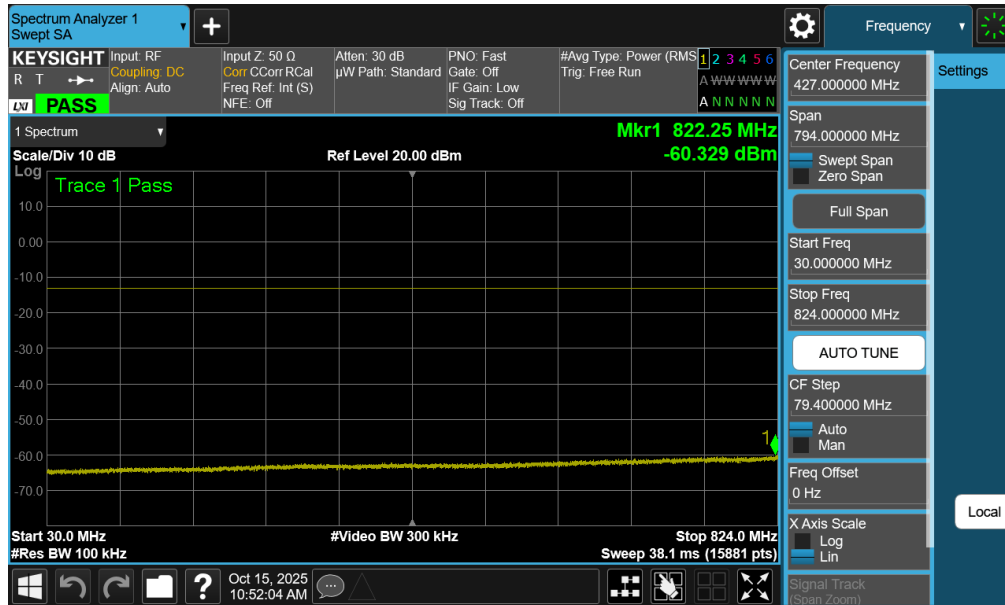
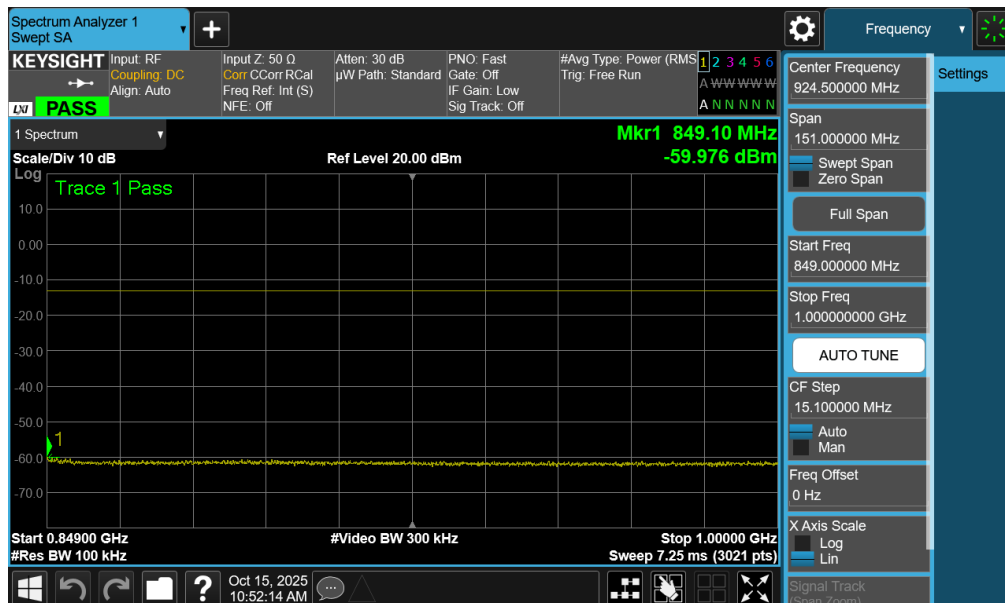


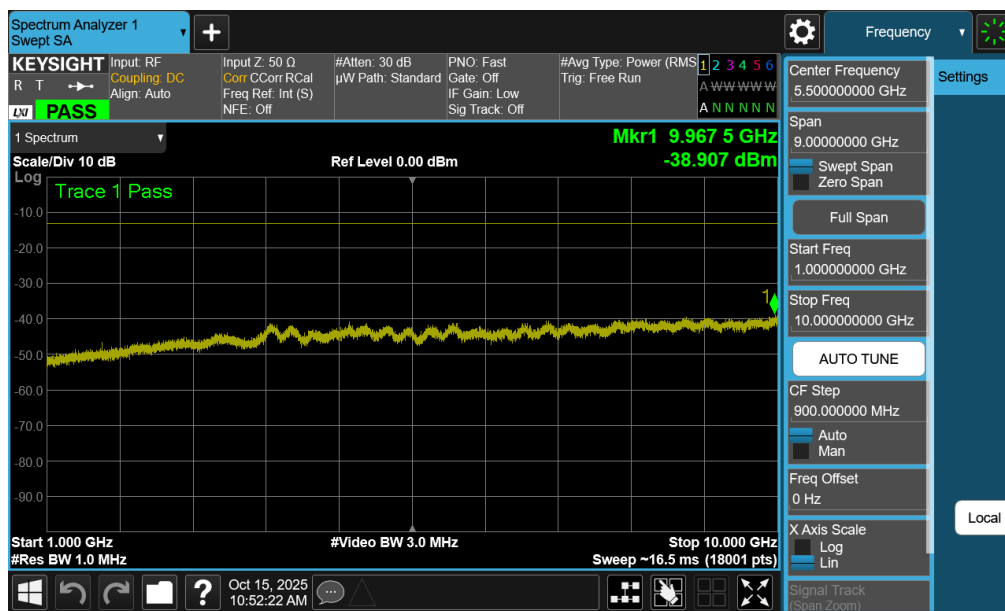


Plot 7-66. Conducted Spurious Plot (NR Band n5 - 20.0MHz - 1 RB - High Channel - Ant1)



Plot 7-67. Conducted Spurious Plot (NR Band n5 - 20.0MHz - 1 RB - High Channel - Ant1)

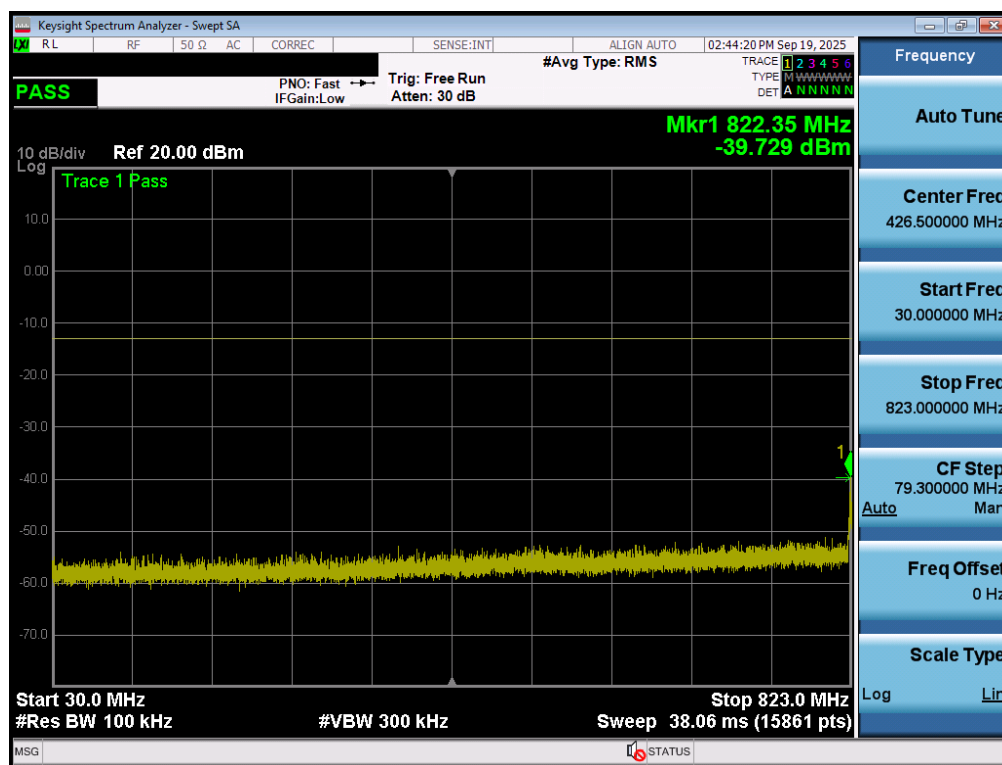

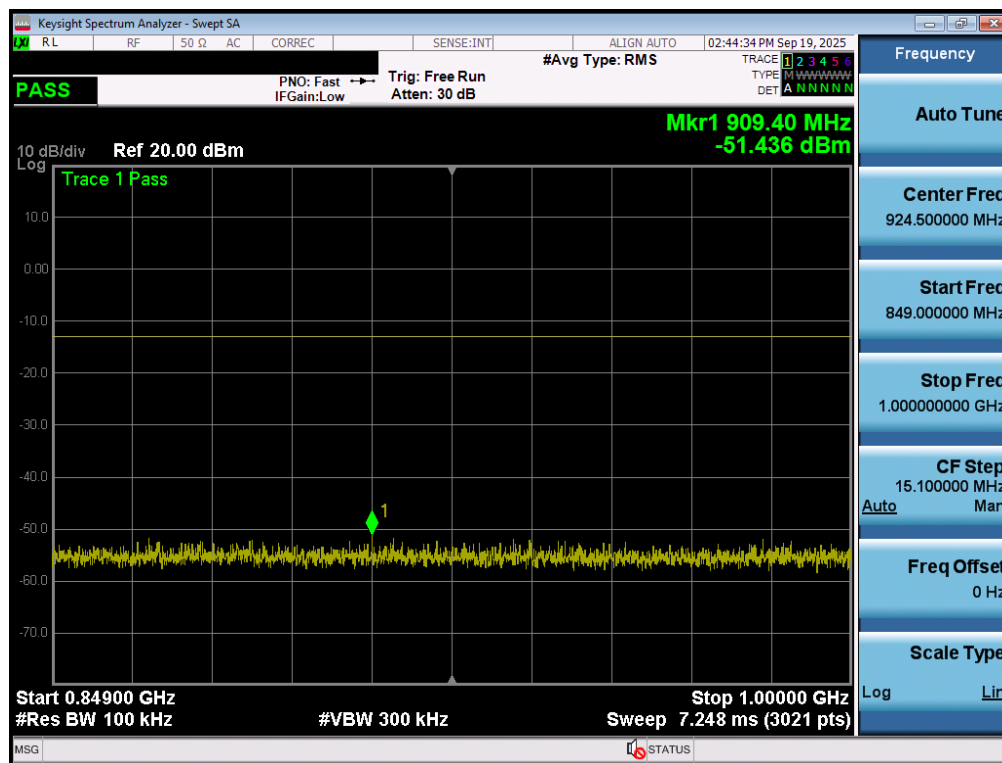
Plot 7-68. Conducted Spurious Plot (NR Band n5 - 20.0MHz - 1 RB - High Channel - Ant1)

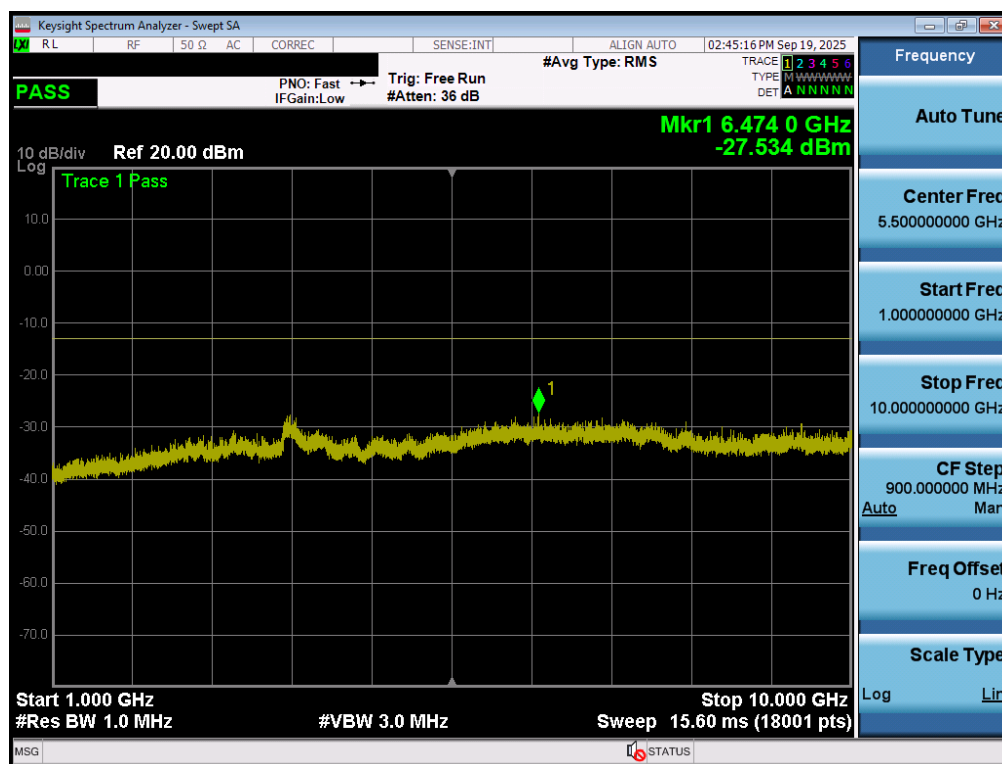


Plot 7-69. Conducted Spurious Plot (GPRS Ch. 128 – Ant1)

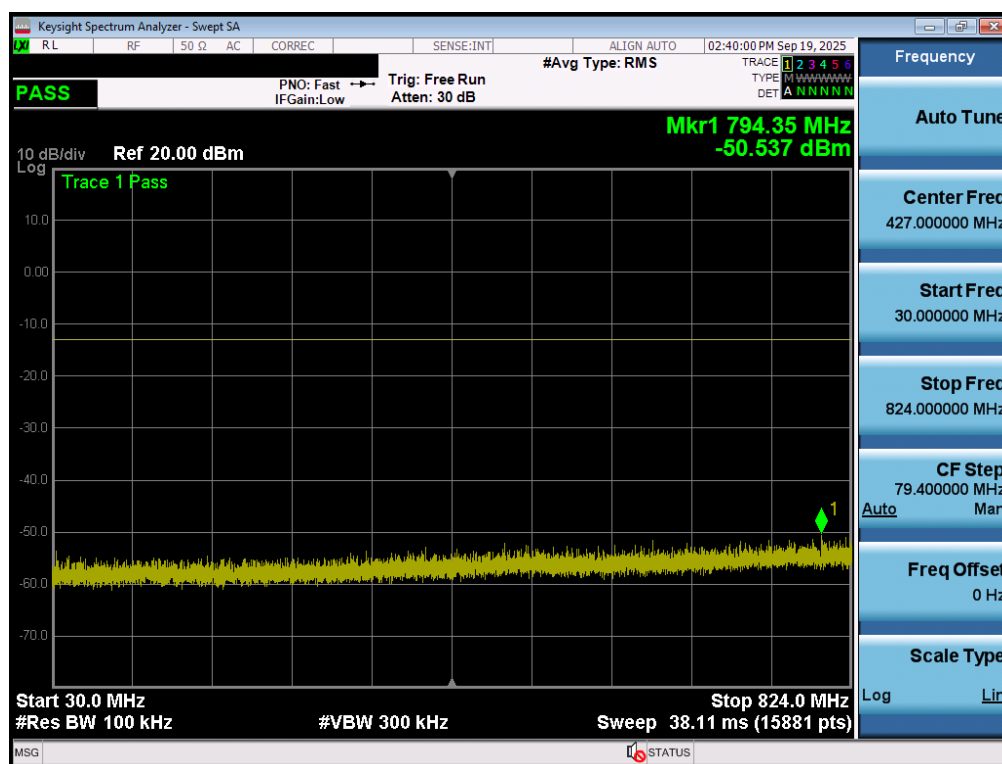


Plot 7-70. Conducted Spurious Plot (GPRS Ch. 128 – Ant1)

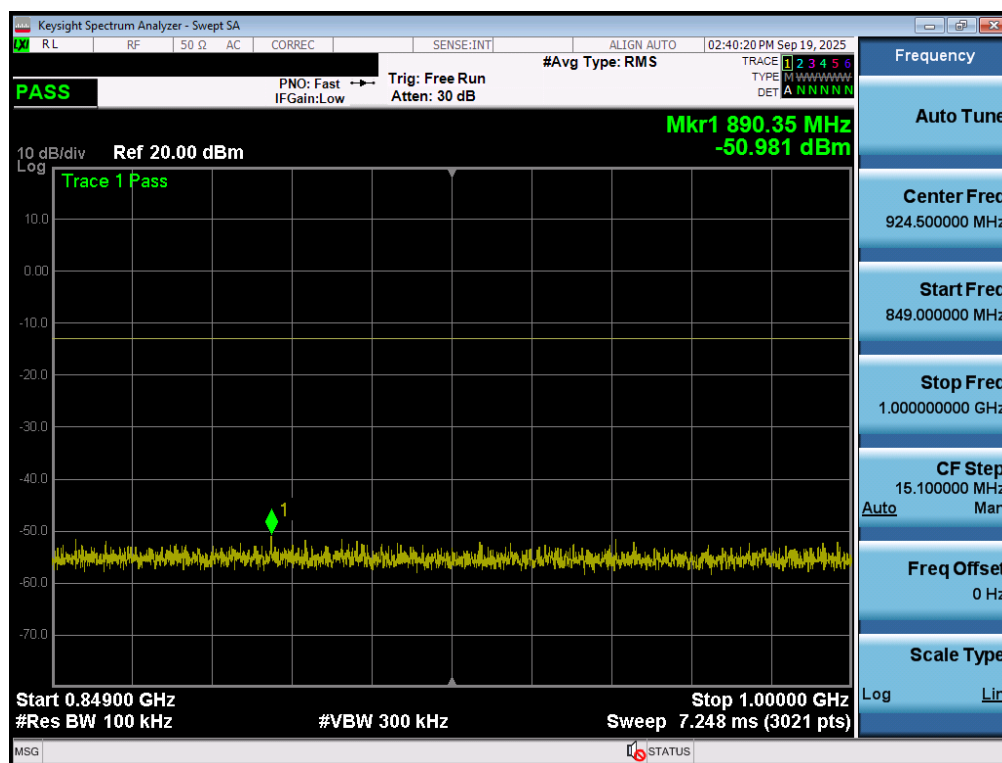


Plot 7-71. Conducted Spurious Plot (GPRS Ch. 128 – Ant1)

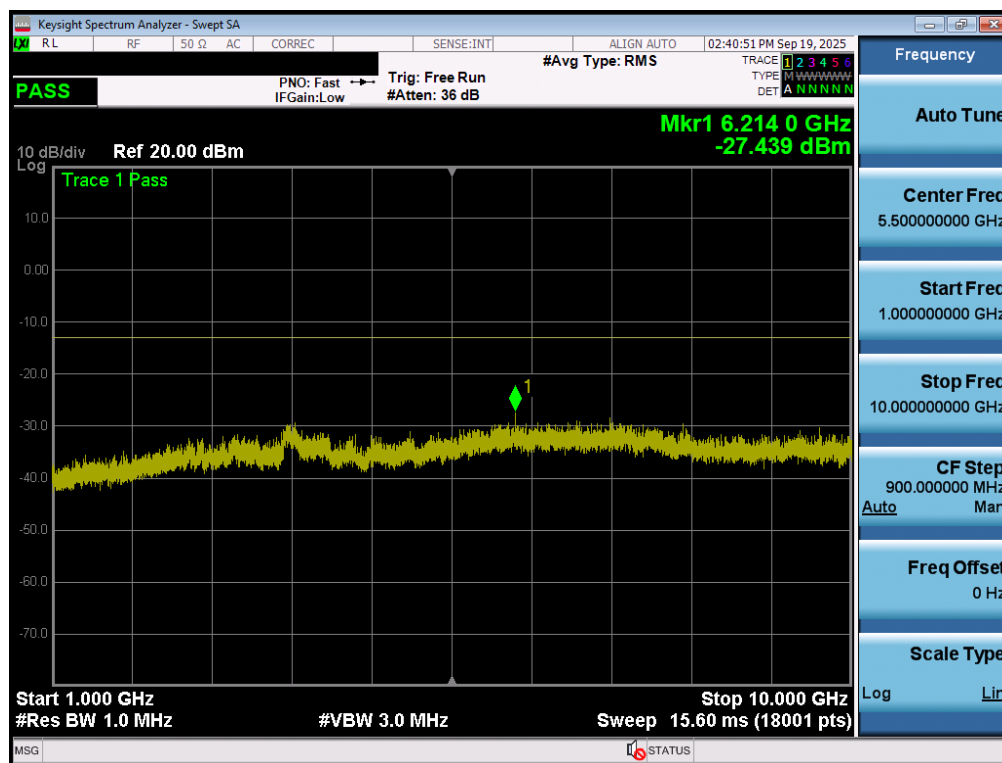


Plot 7-72. Conducted Spurious Plot (GPRS Ch. 190 – Ant1)

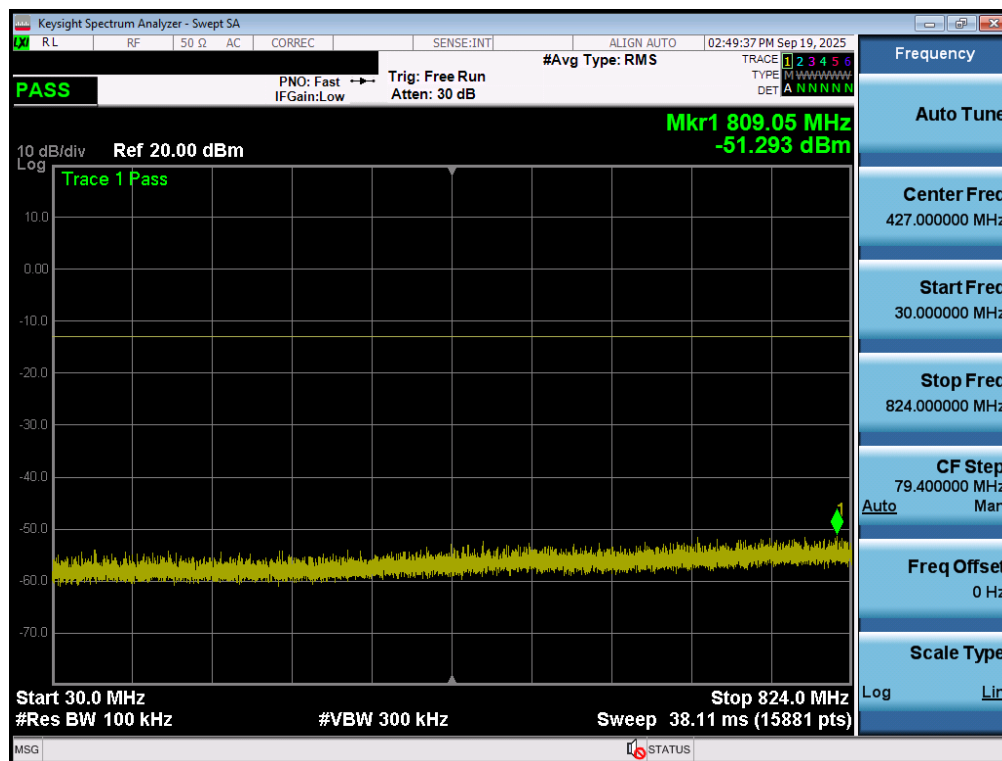


Plot 7-73. Conducted Spurious Plot (GPRS Ch. 190 – Ant1)

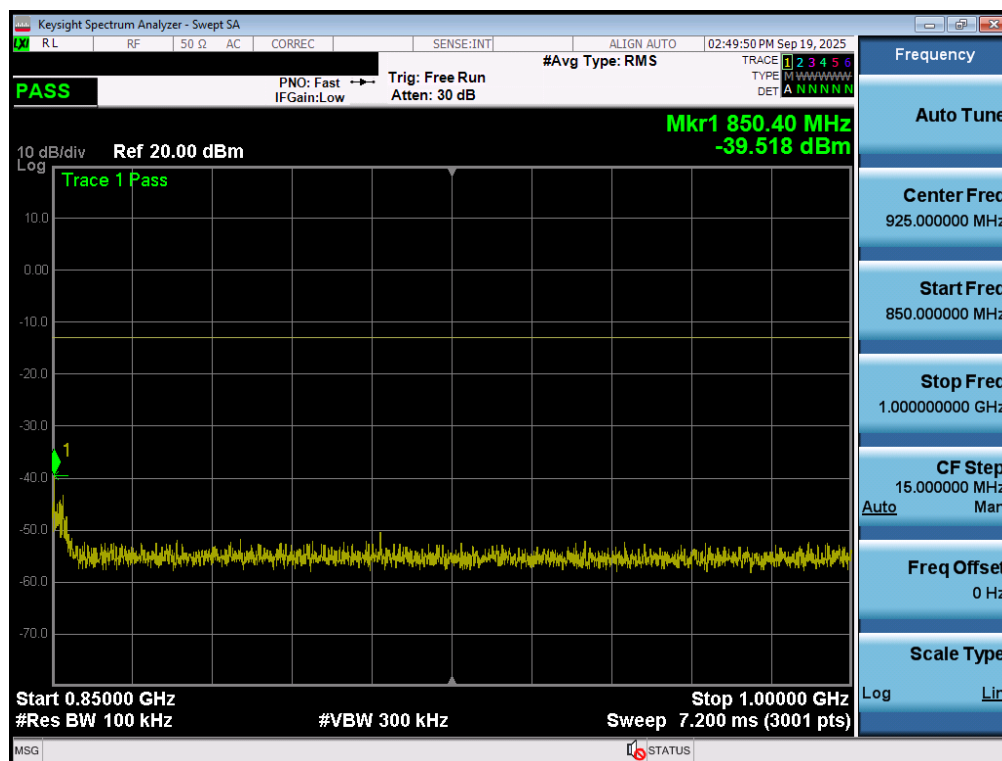


Plot 7-74. Conducted Spurious Plot (GPRS Ch. 190 – Ant1)

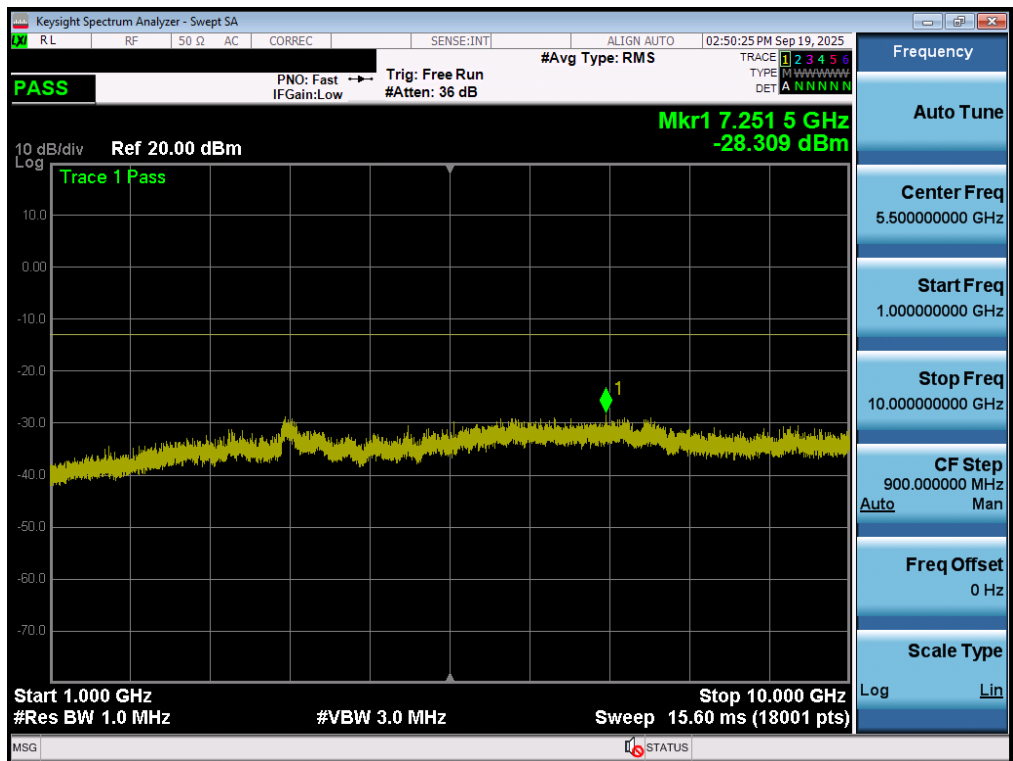


Plot 7-75. Conducted Spurious Plot (GPRS Ch. 251 – Ant1)

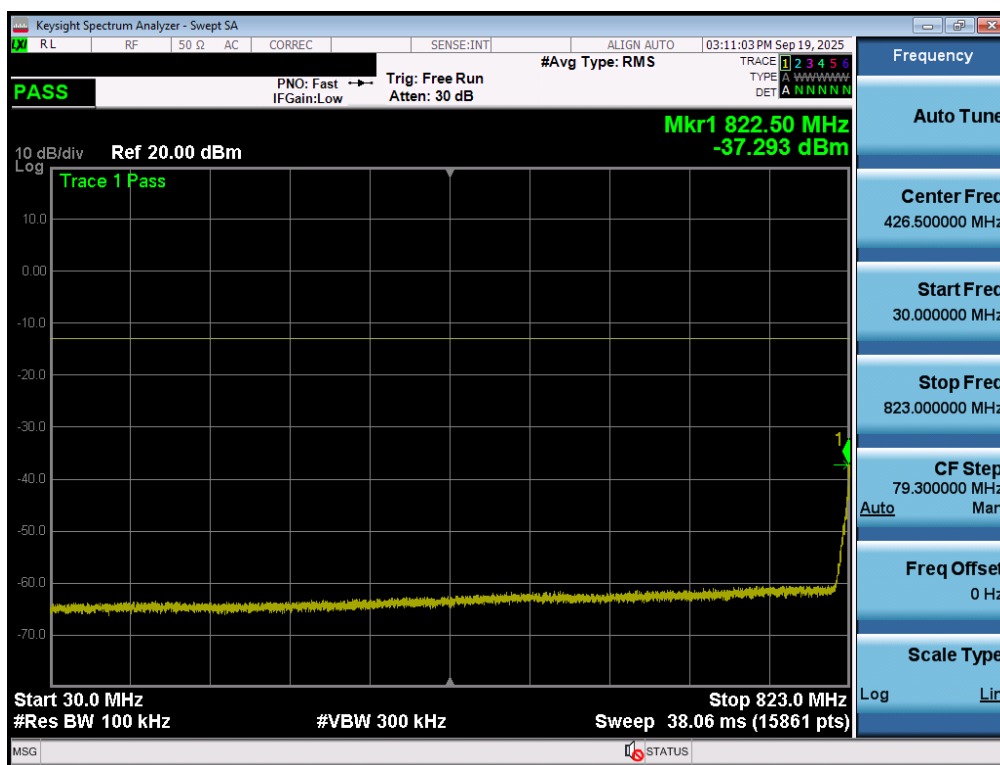

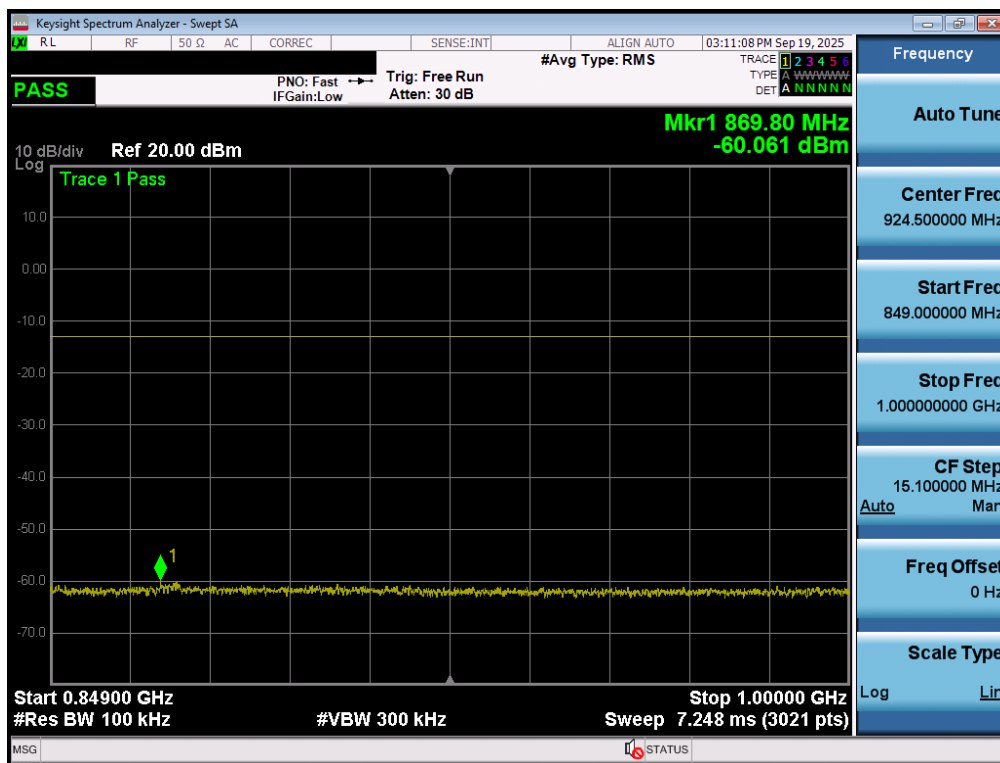

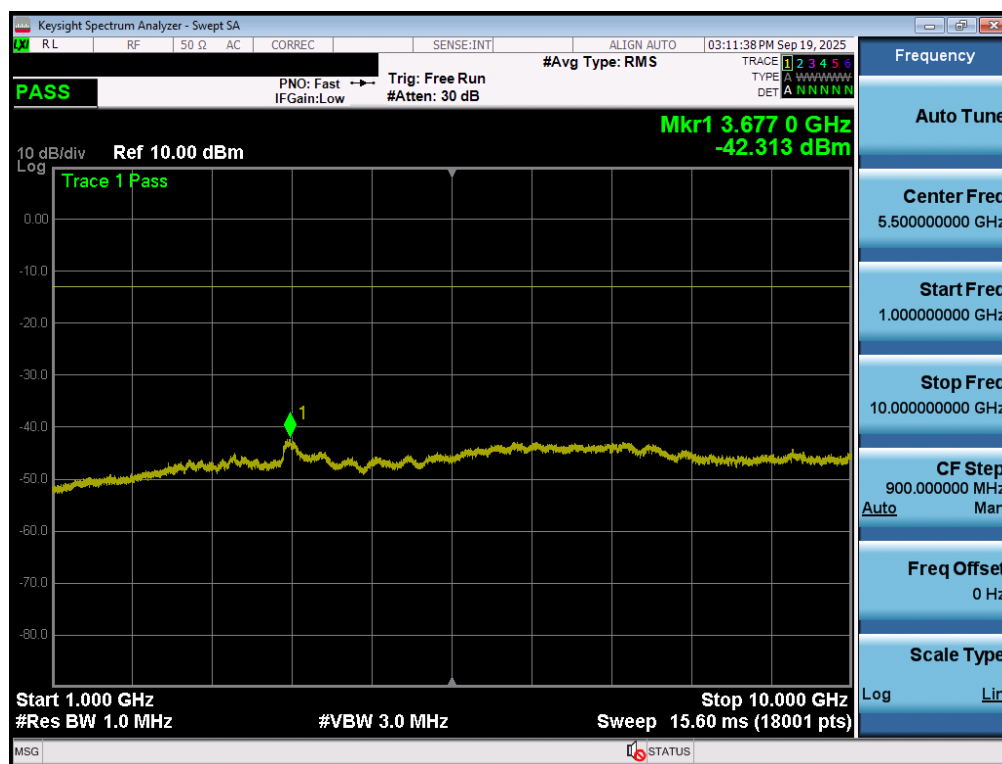


Plot 7-78. Conducted Spurious Plot (WCDMA Ch. 4132 – Ant1)

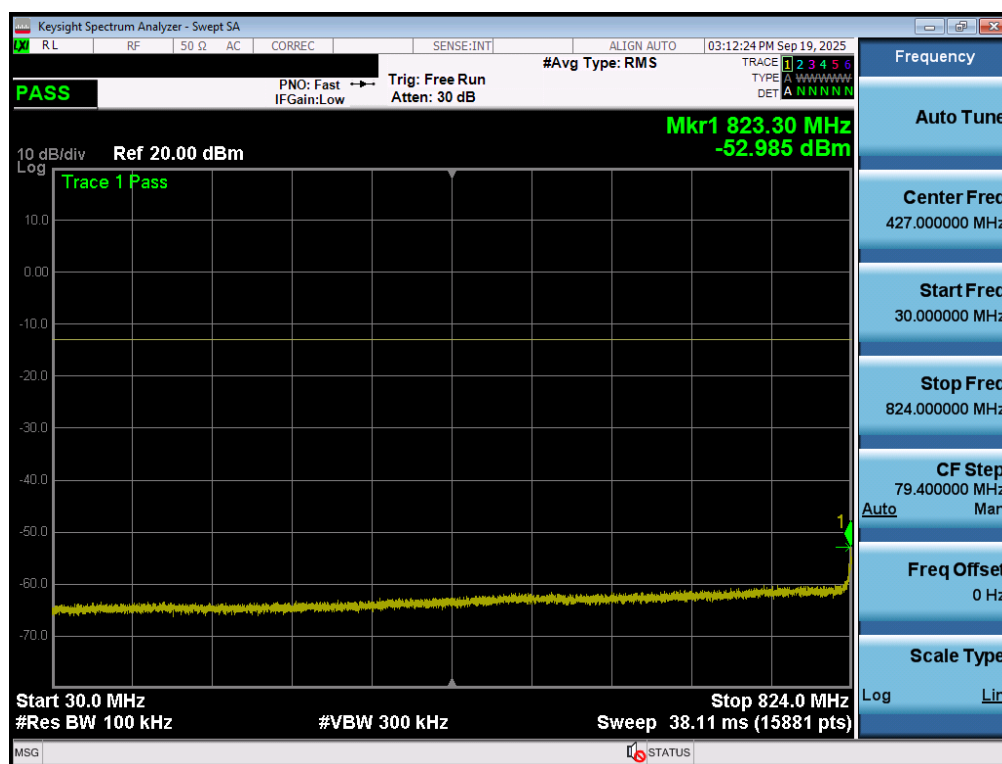


Plot 7-79. Conducted Spurious Plot (WCDMA Ch. 4132 – Ant1)

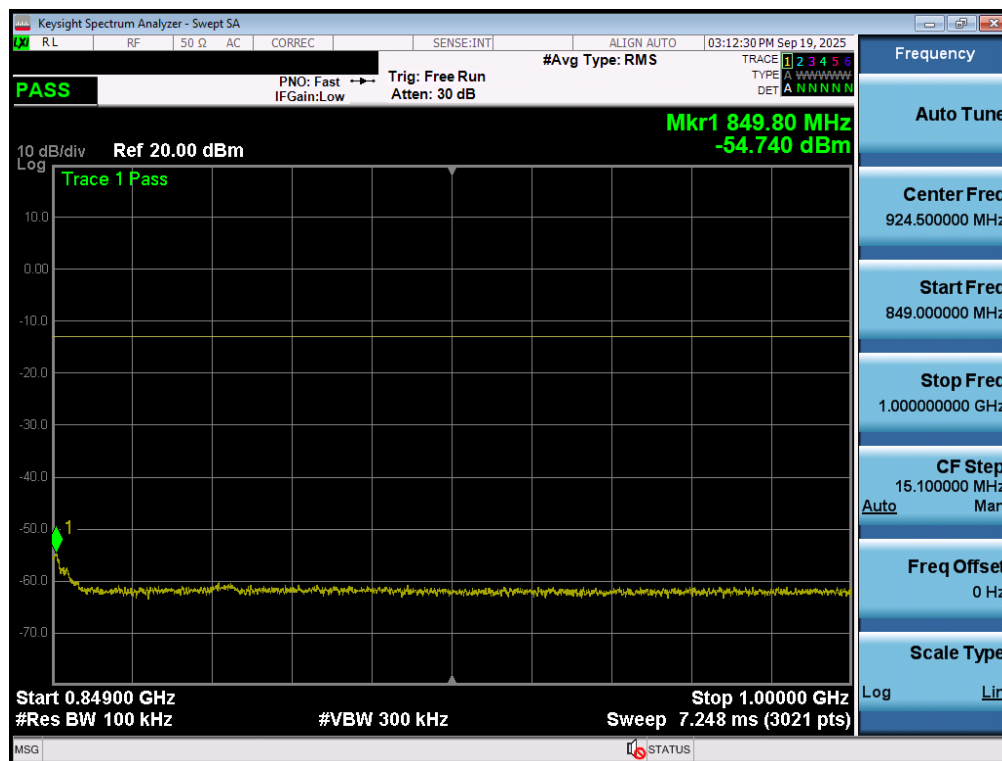


Plot 7-80. Conducted Spurious Plot (WCDMA Ch. 4132 – Ant1)

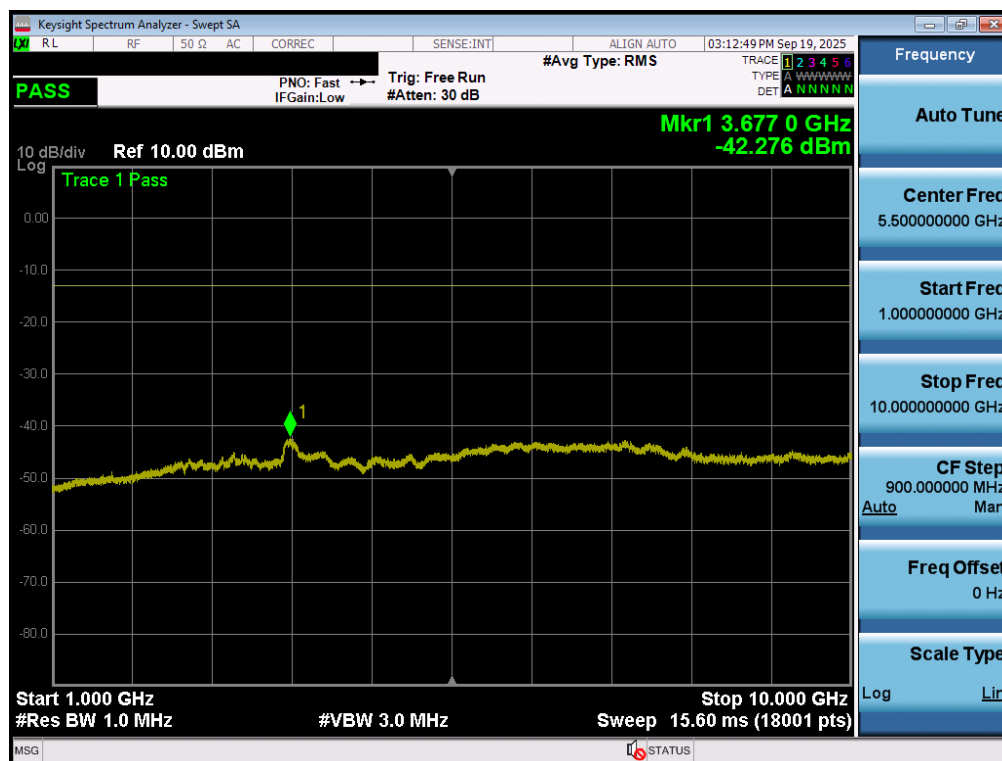


Plot 7-81. Conducted Spurious Plot (WCDMA Ch. 4183 – Ant1)

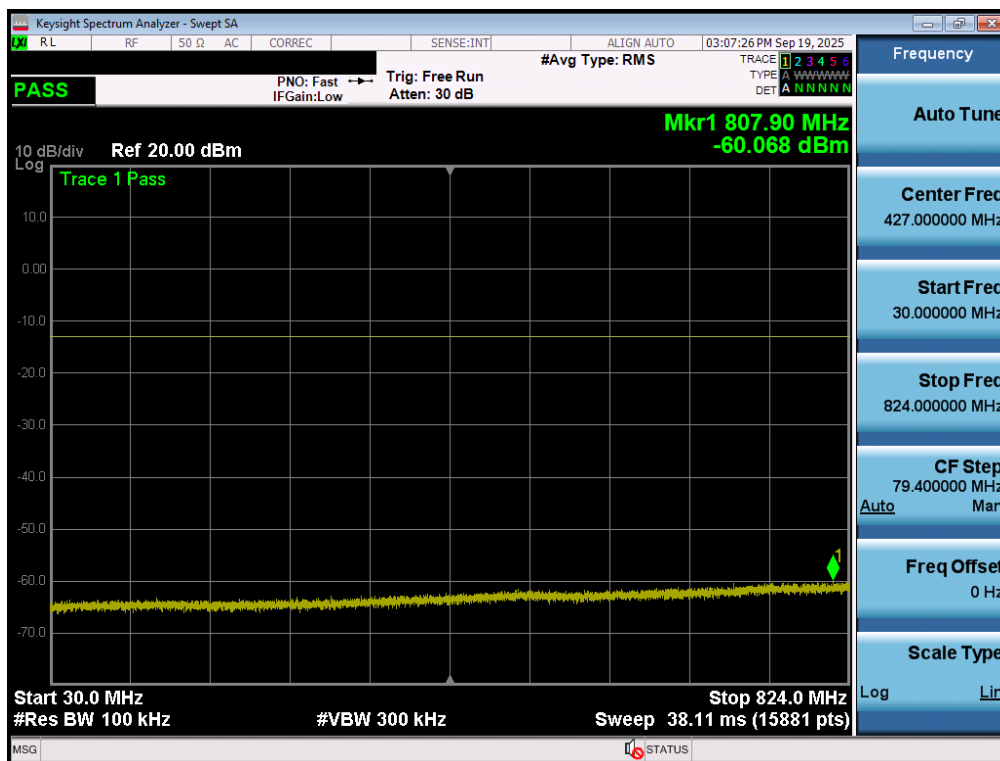


Plot 7-82. Conducted Spurious Plot (WCDMA Ch. 4183 – Ant1)

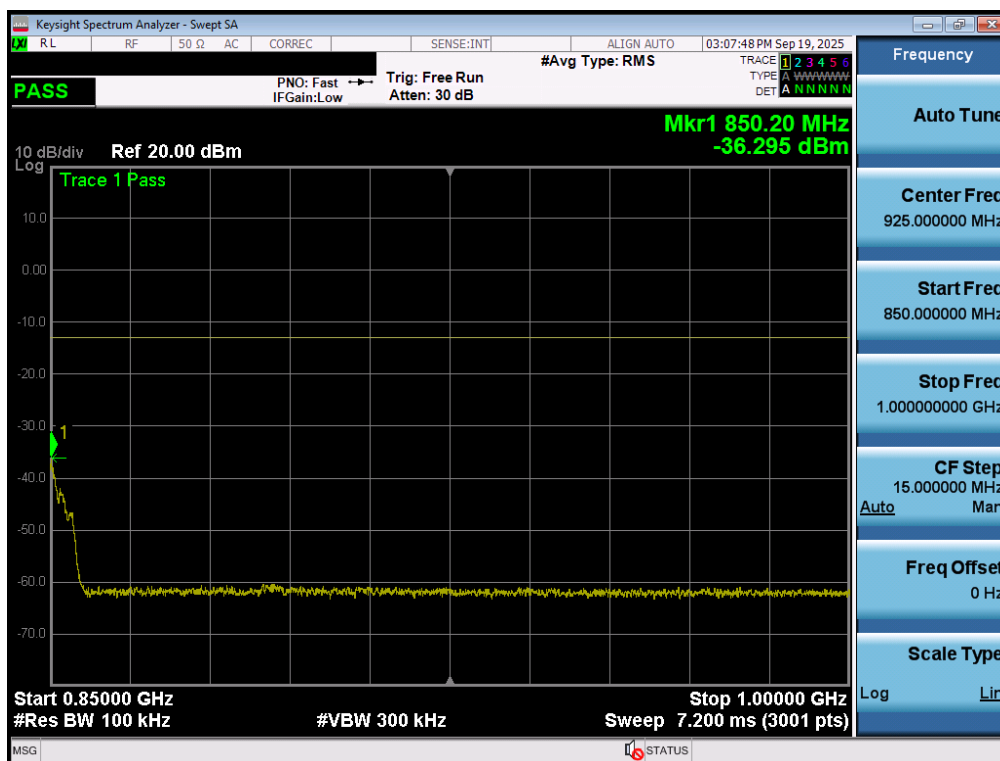


Plot 7-83. Conducted Spurious Plot (WCDMA Ch. 4183 – Ant1)

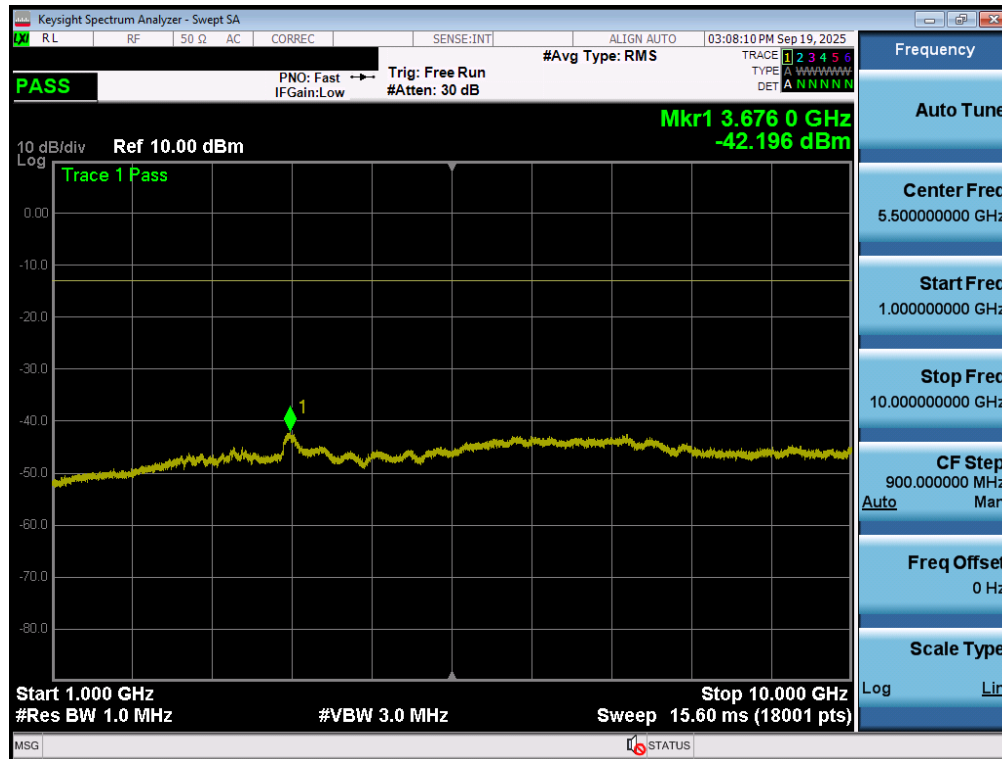


Plot 7-84. Conducted Spurious Plot (WCDMA Ch. 4233 – Ant1)

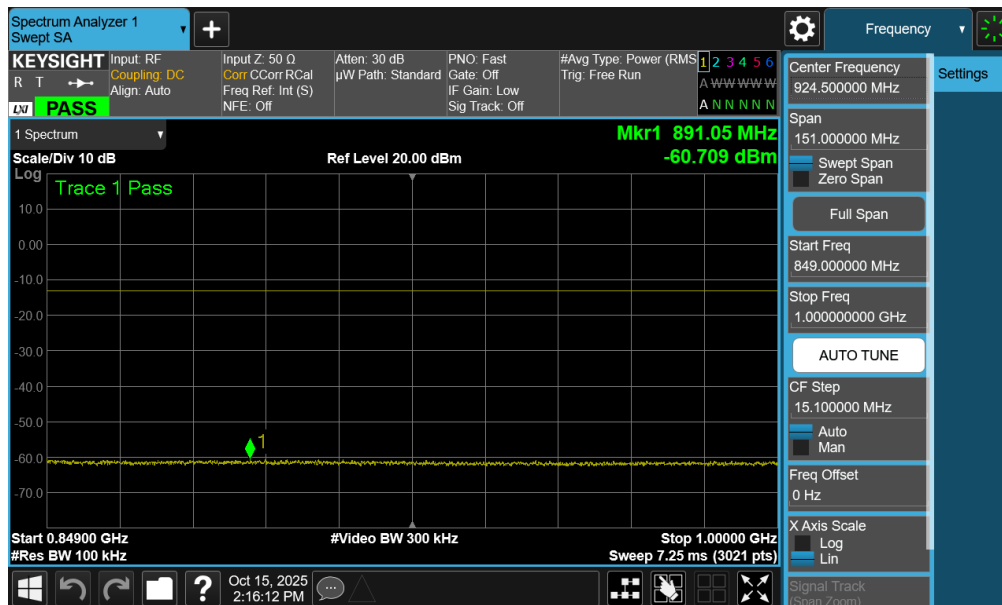
Plot 7-95. Conducted Spurious Plot (LTE Band 26/5 - 15MHz QPSK - 1 RB - High Channel – Ant2)

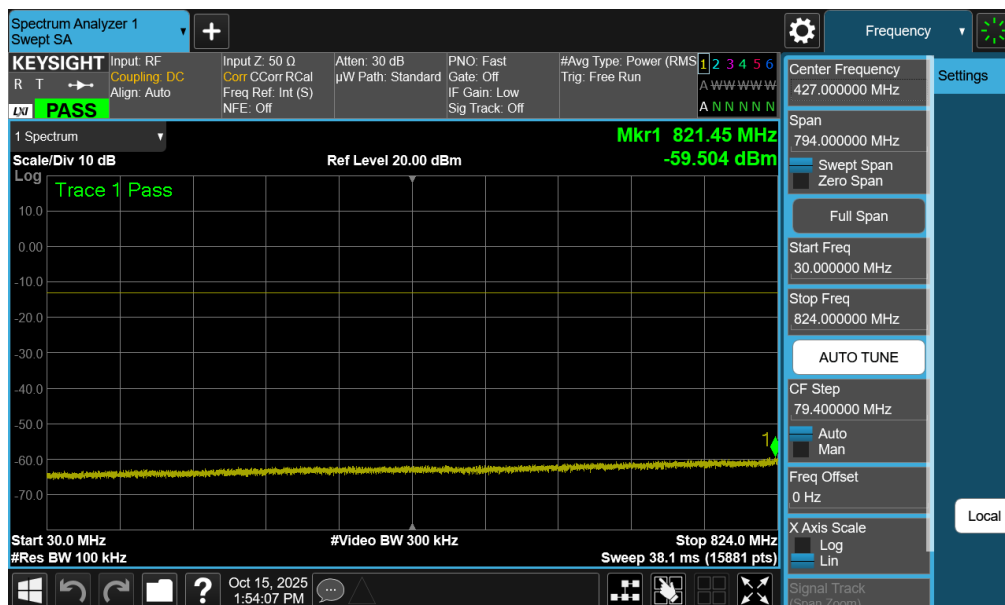
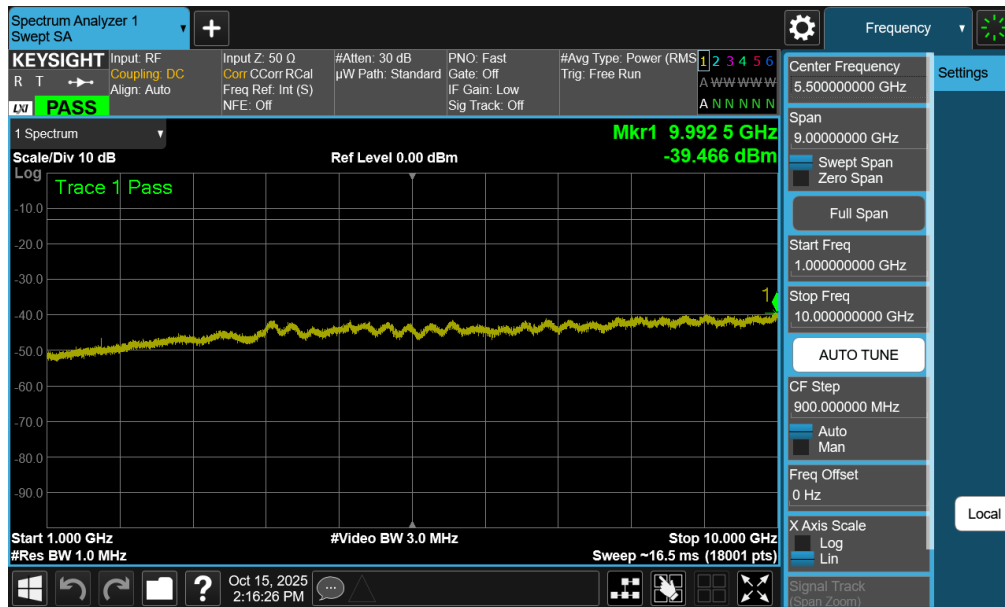


Plot 7-96. Conducted Spurious Plot (NR Band n5 - 20.0MHz - 1 RB - Low Channel - Ant2)

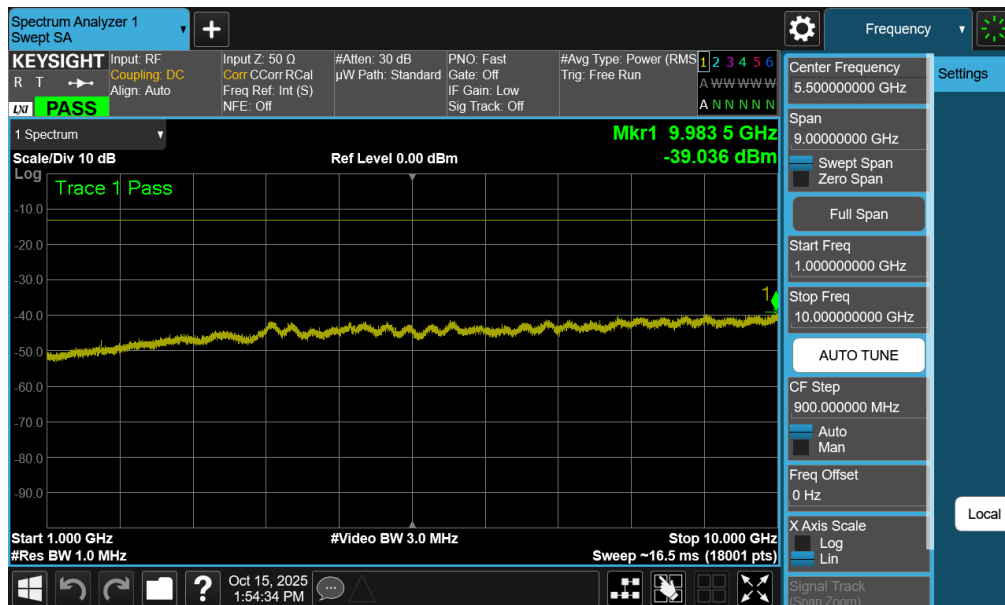
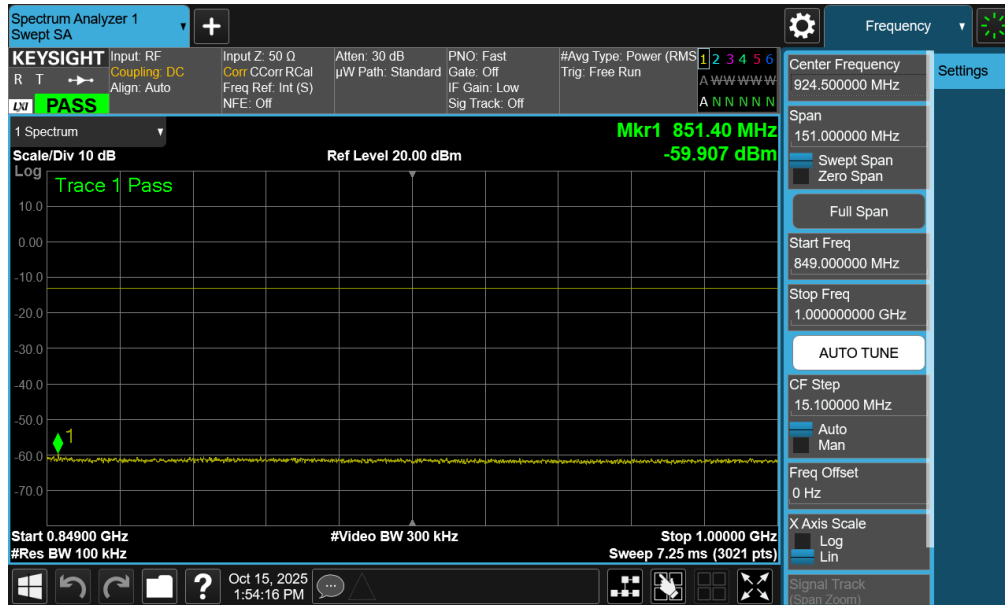


Plot 7-97. Conducted Spurious Plot (NR Band n5 - 20.0MHz - 1 RB - Low Channel - Ant2)

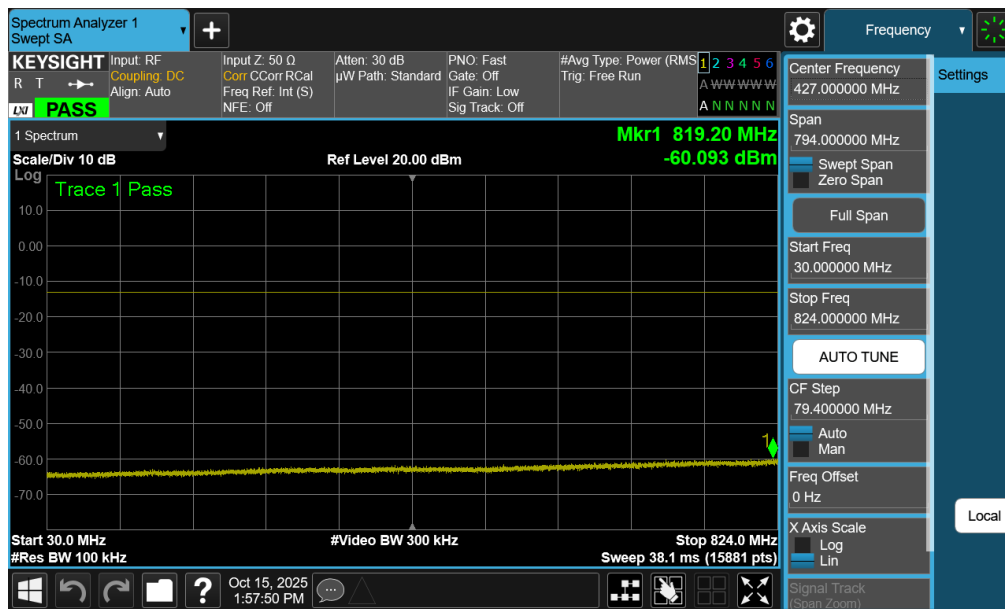

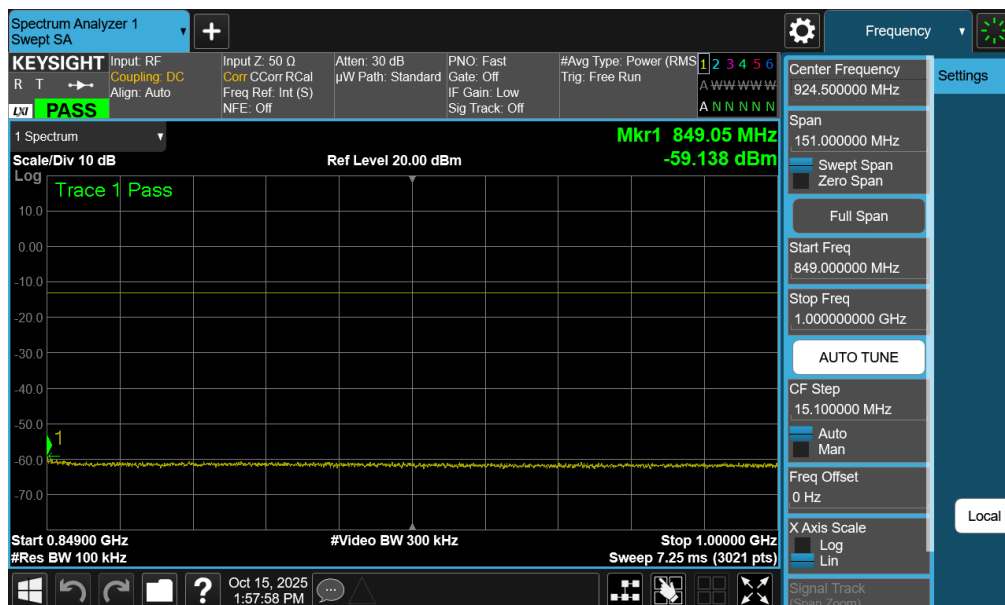

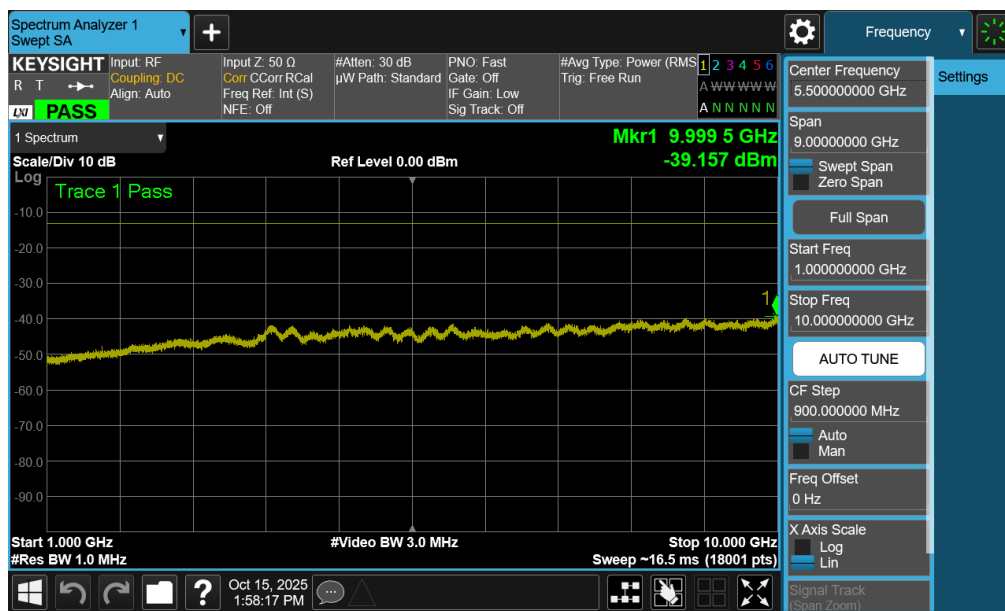


Plot 7-102. Conducted Spurious Plot (NR Band n5 - 20.0MHz - 1 RB - High Channel - Ant2)

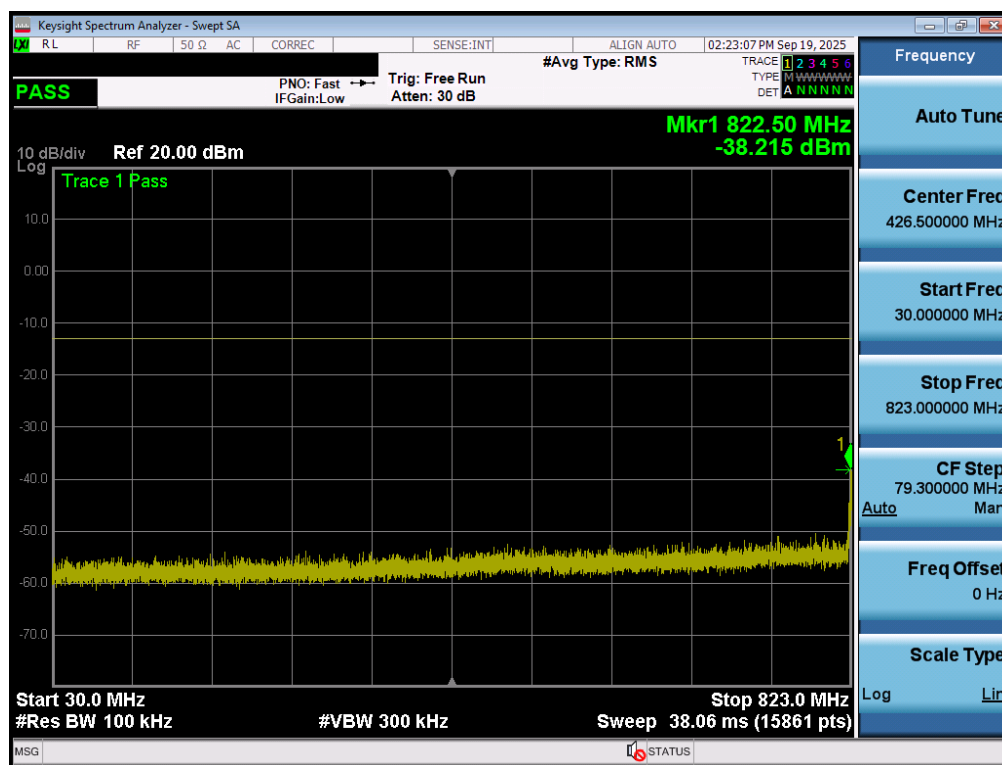

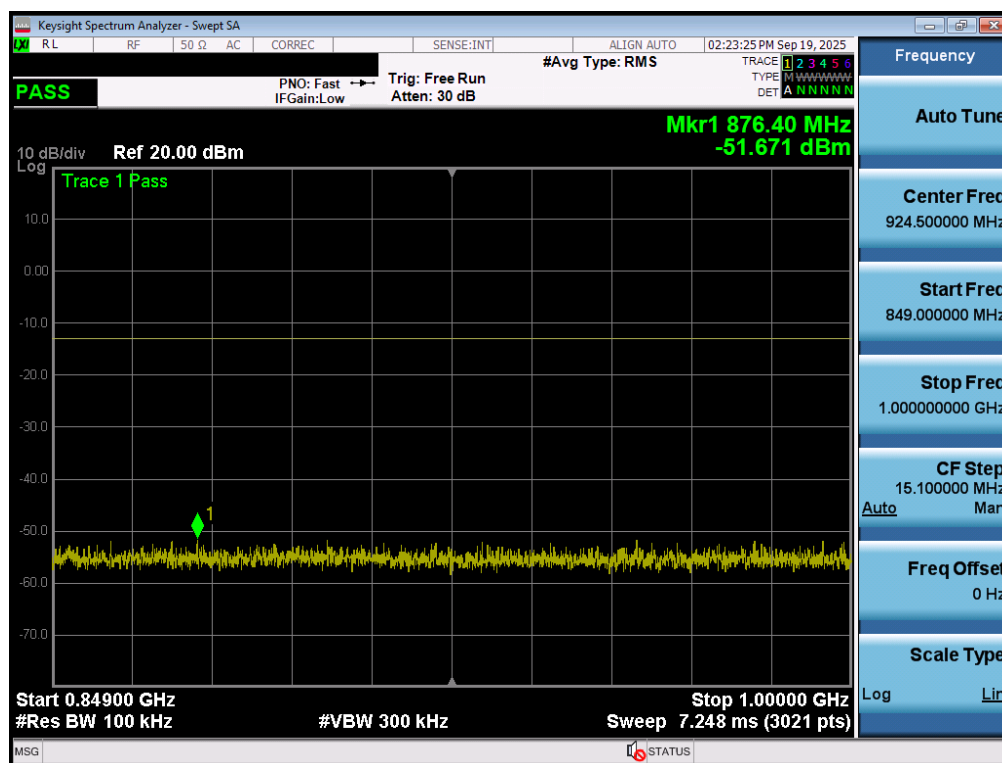
Plot 7-104. Conducted Spurious Plot (NR Band n5 - 20.0MHz - 1 RB - High Channel - Ant2)

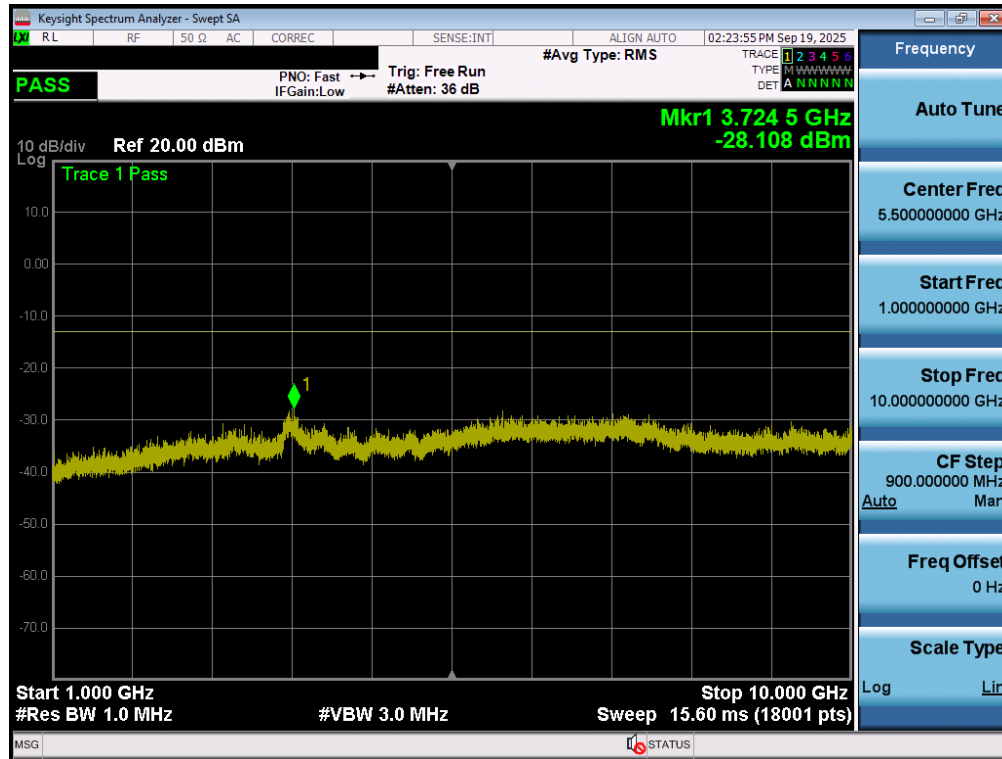


Plot 7-105. Conducted Spurious Plot (GPRS Ch. 128 – Ant2)

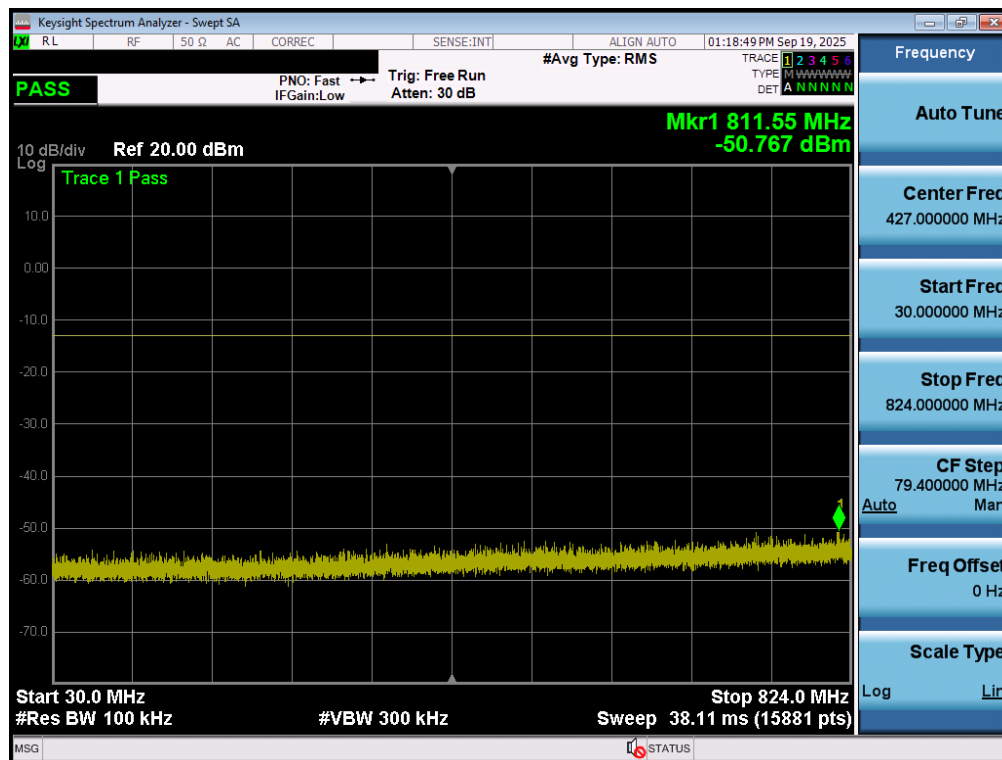

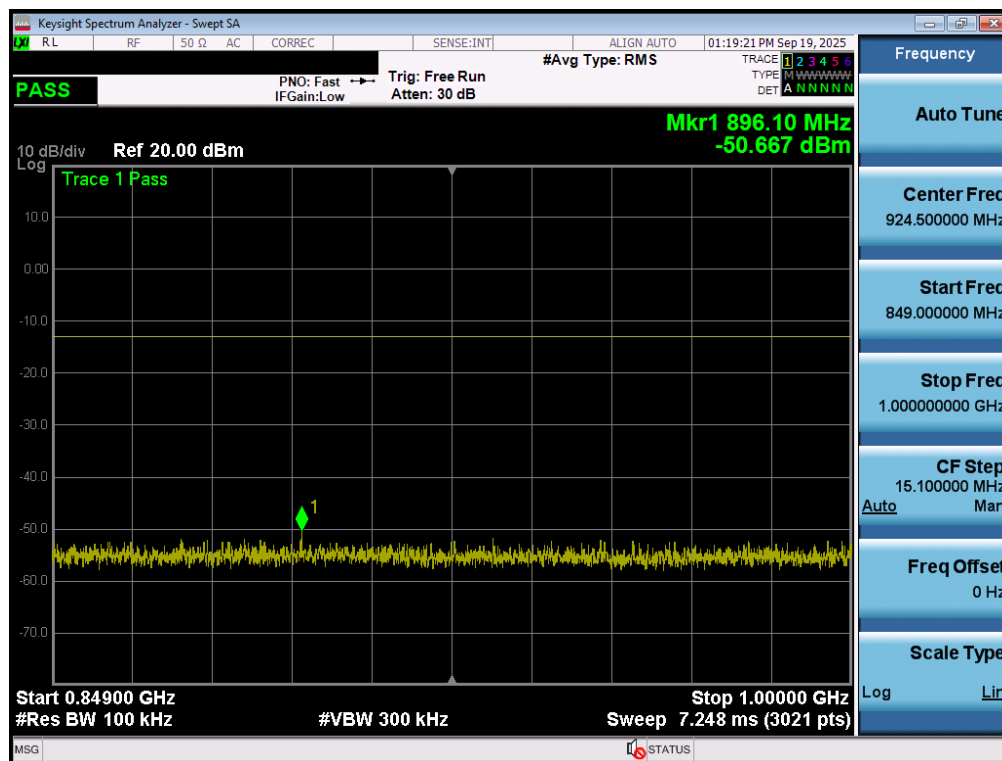


Plot 7-107. Conducted Spurious Plot (GPRS Ch. 128 – Ant2)

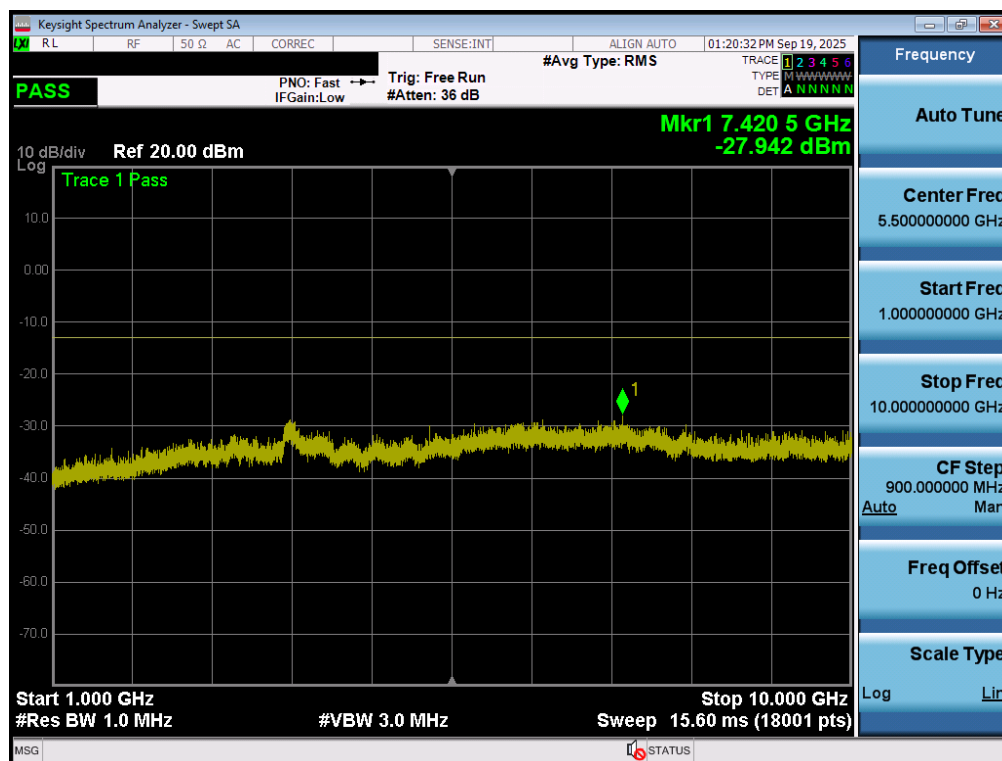


Plot 7-108. Conducted Spurious Plot (GPRS Ch. 190 – Ant2)

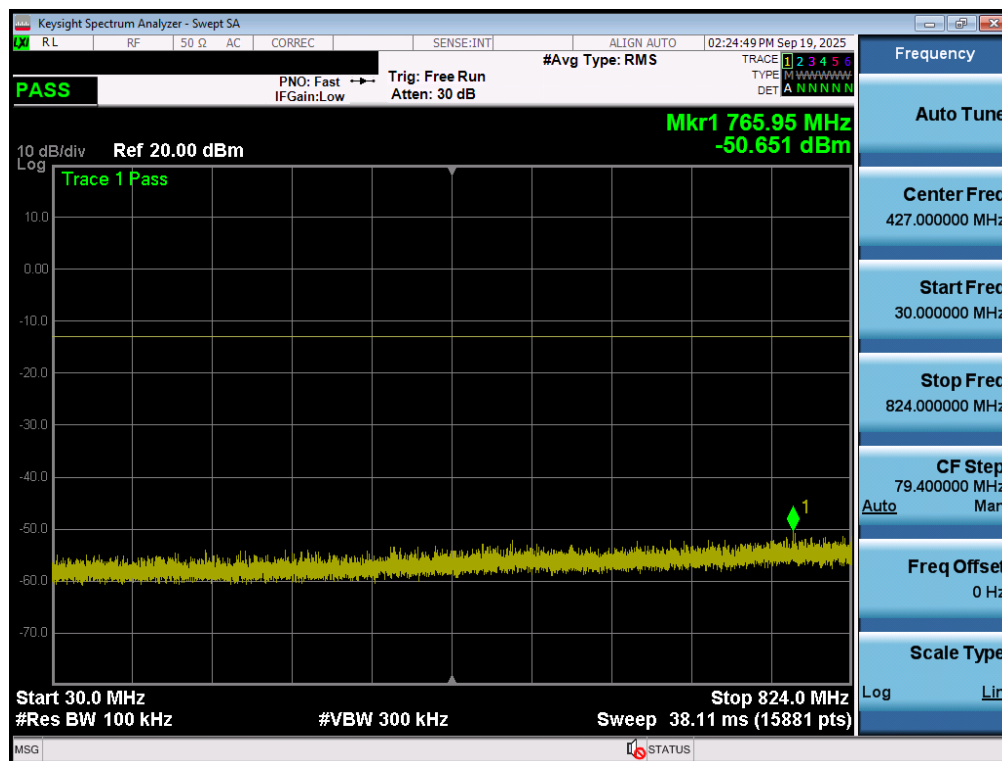


Plot 7-109. Conducted Spurious Plot (GPRS Ch. 190 – Ant2)

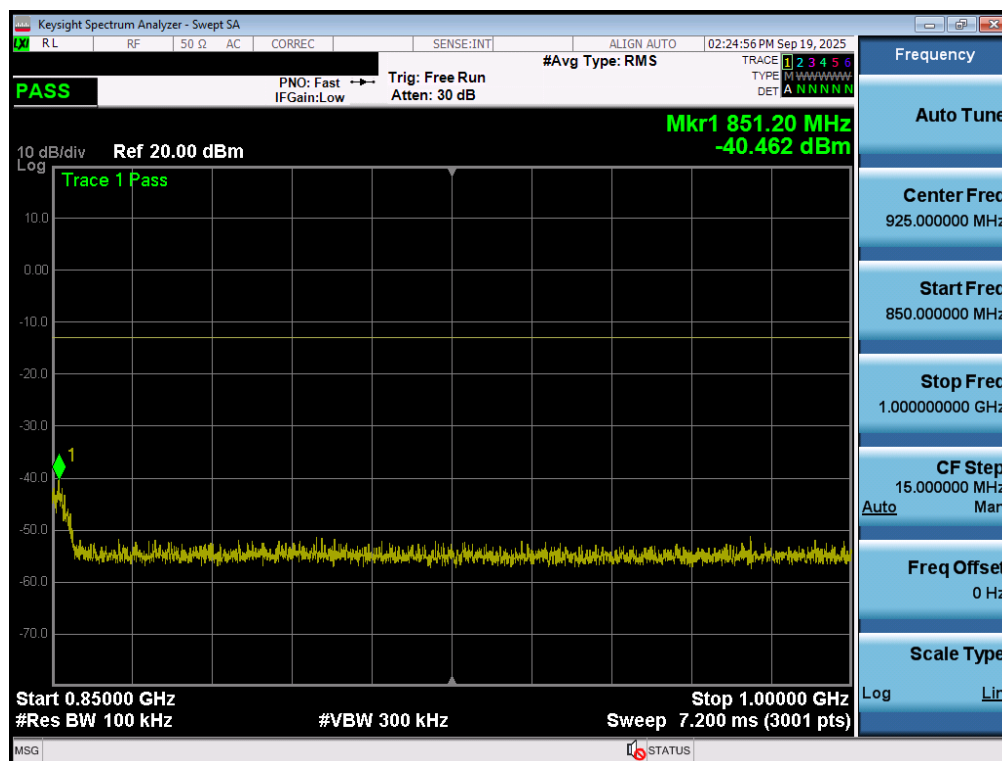

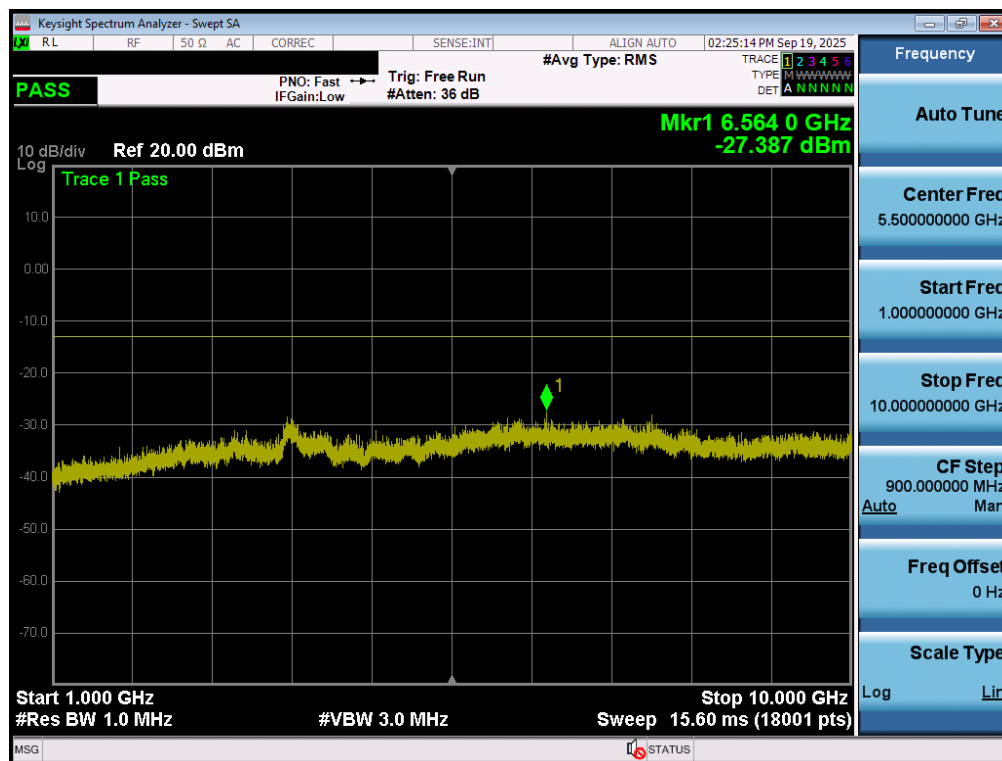


Plot 7-111. Conducted Spurious Plot (GPRS Ch. 251 – Ant2)

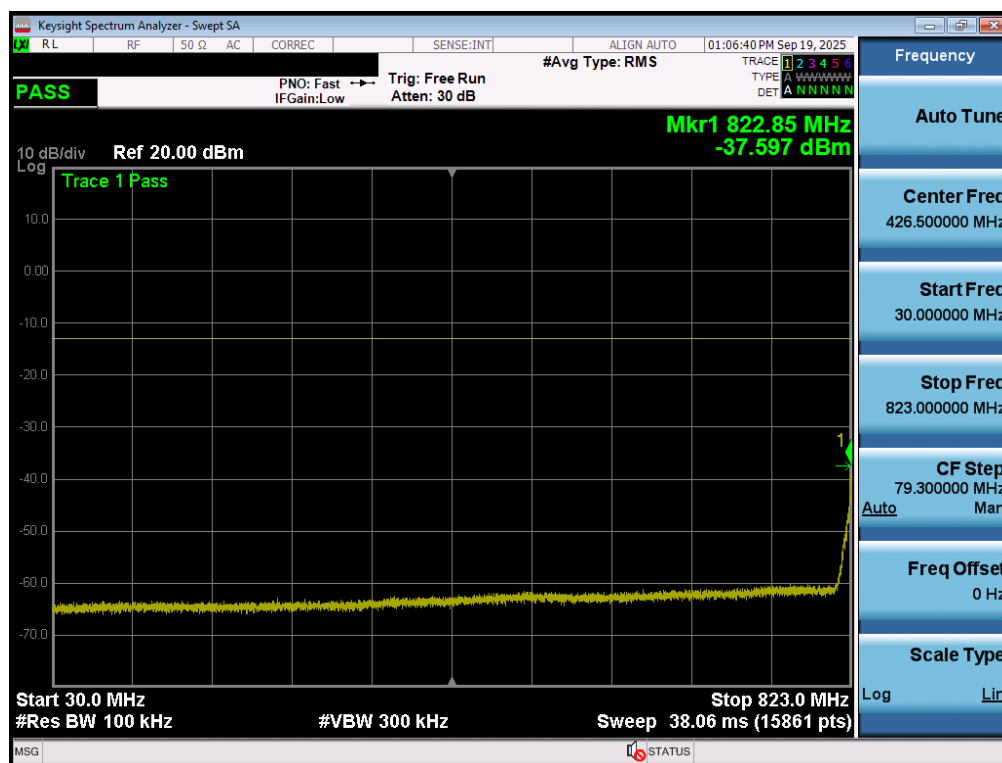

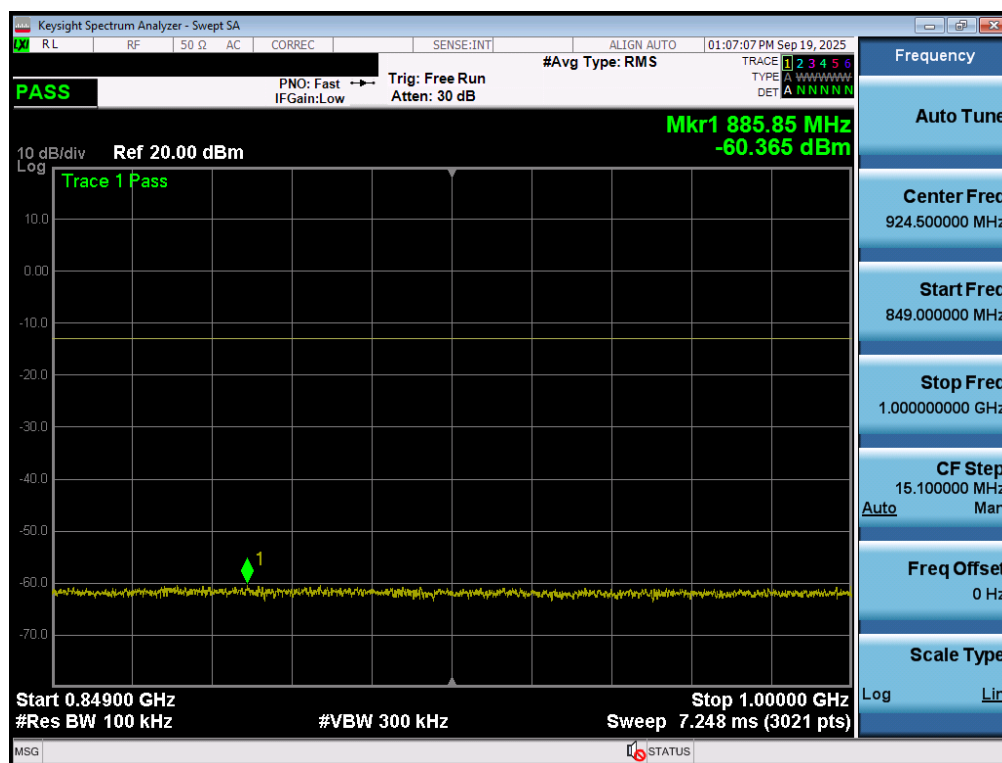

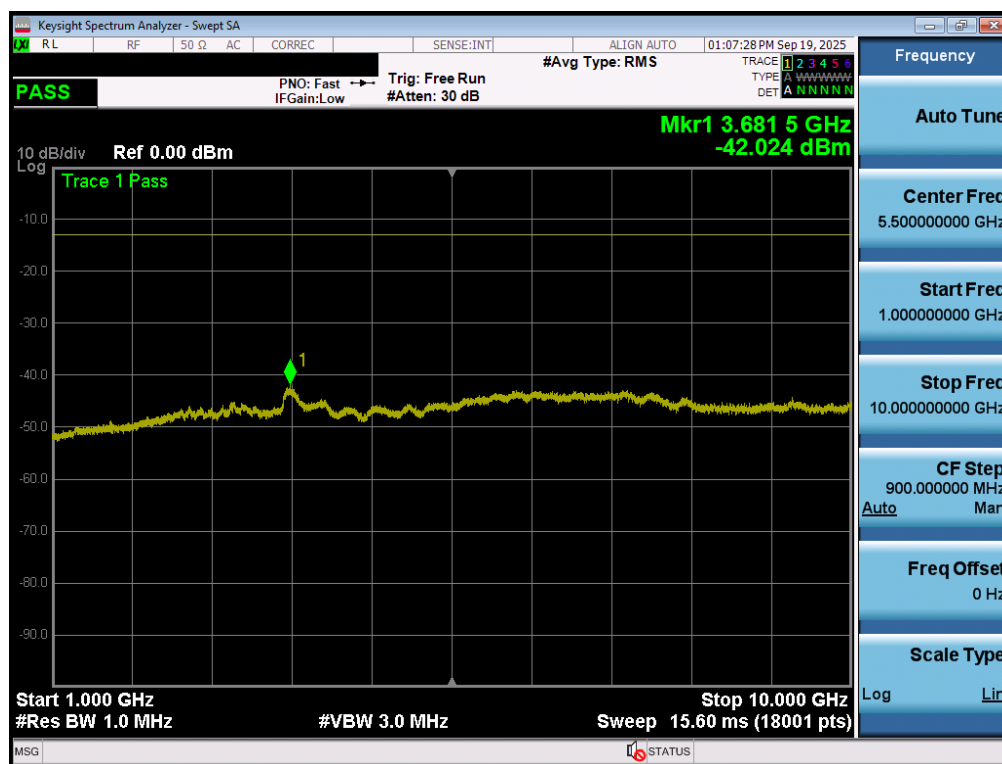


Plot 7-114. Conducted Spurious Plot (WCDMA Ch. 4132 – Ant2)

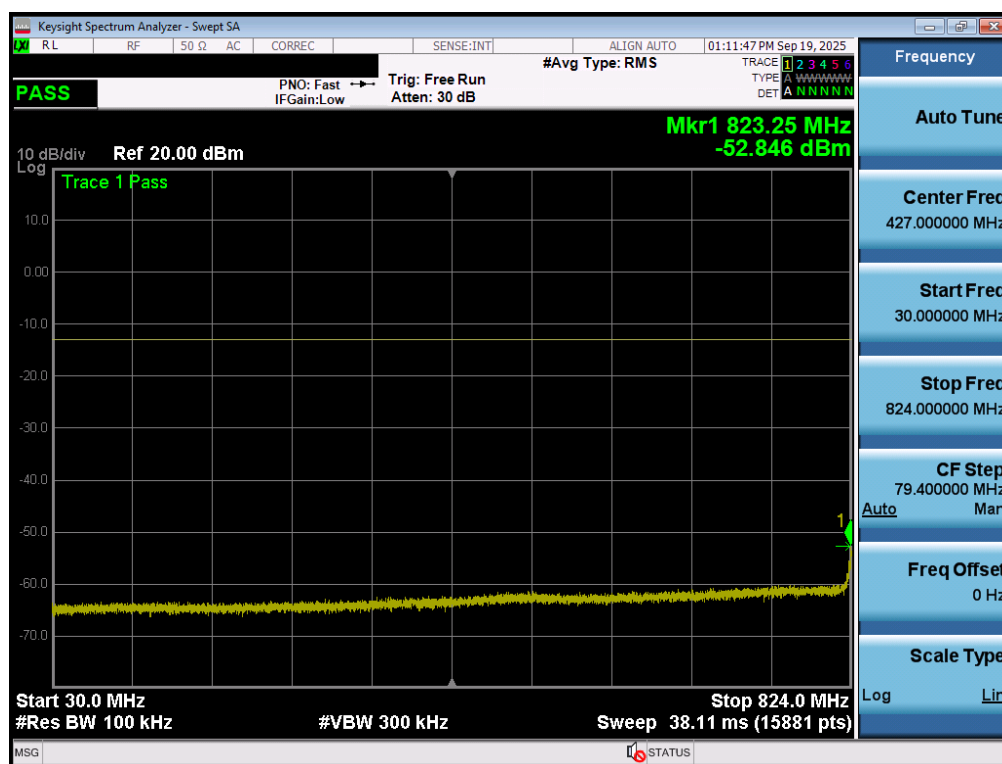

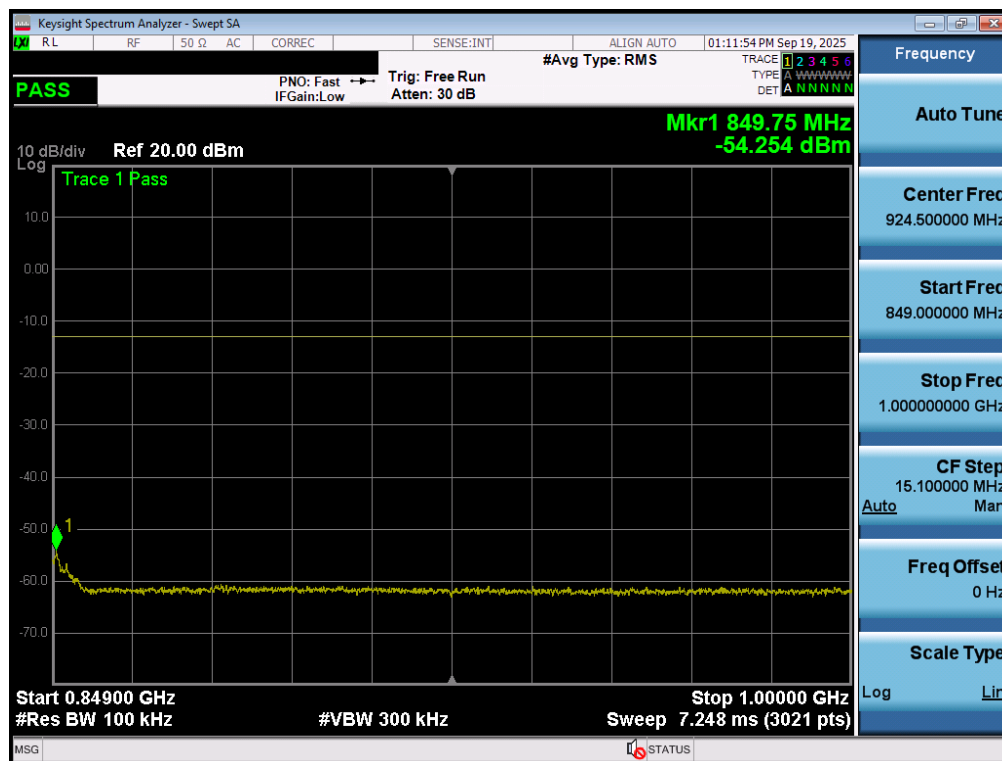


Plot 7-116. Conducted Spurious Plot (WCDMA Ch. 4132 – Ant2)

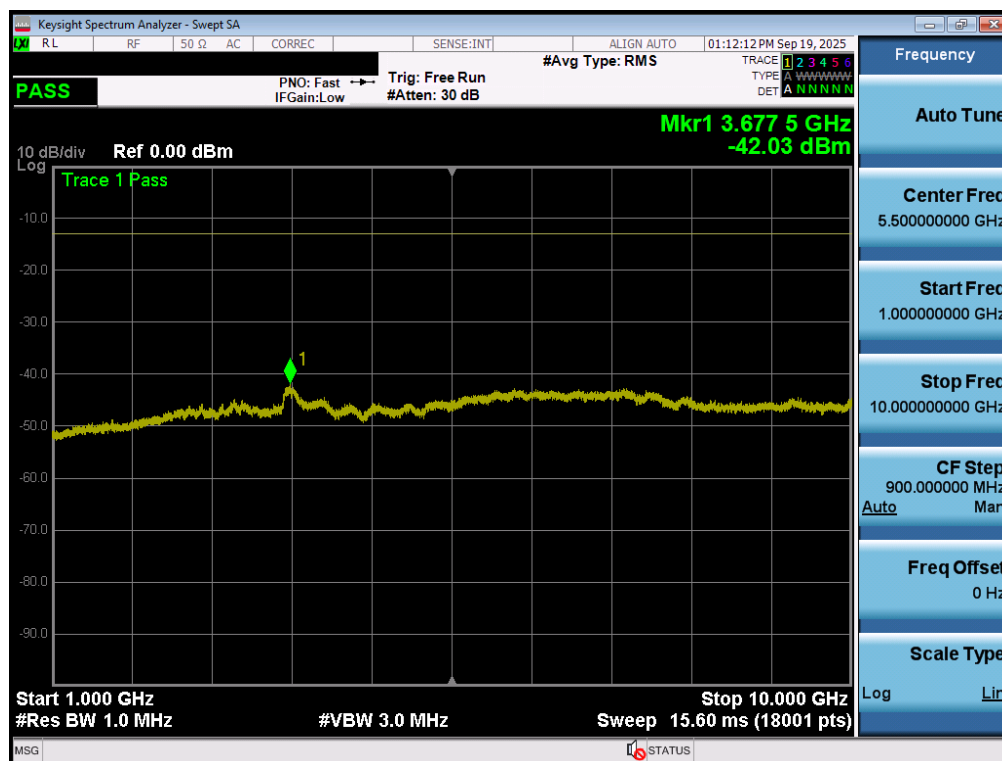

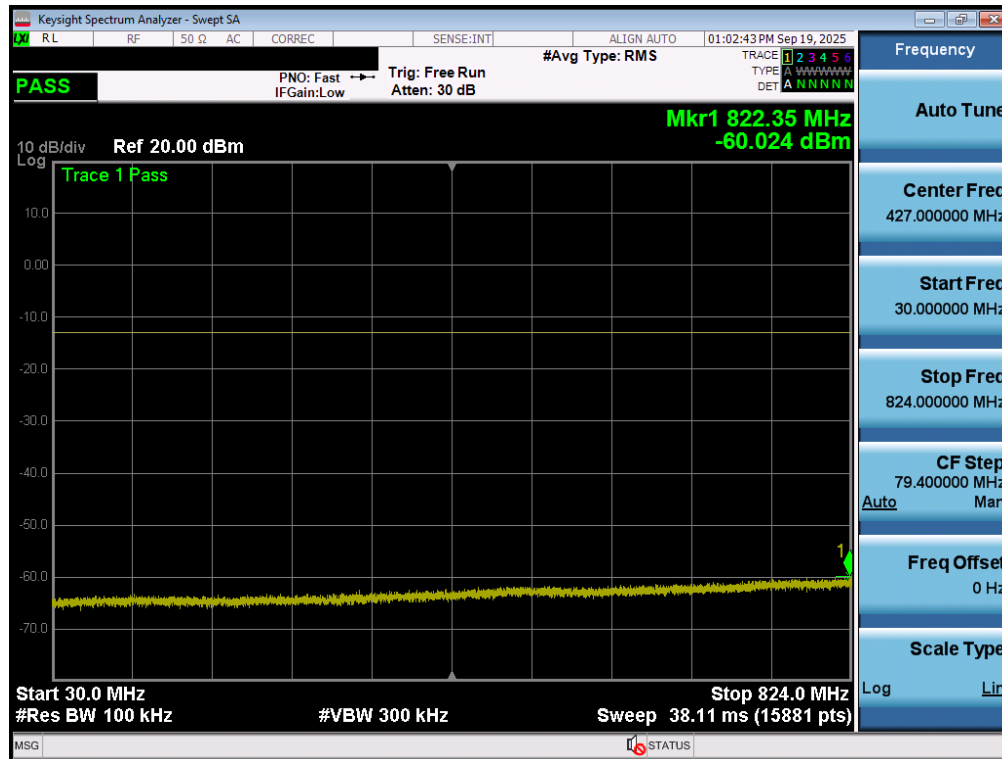


Plot 7-118. Conducted Spurious Plot (WCDMA Ch. 4183 – Ant2)

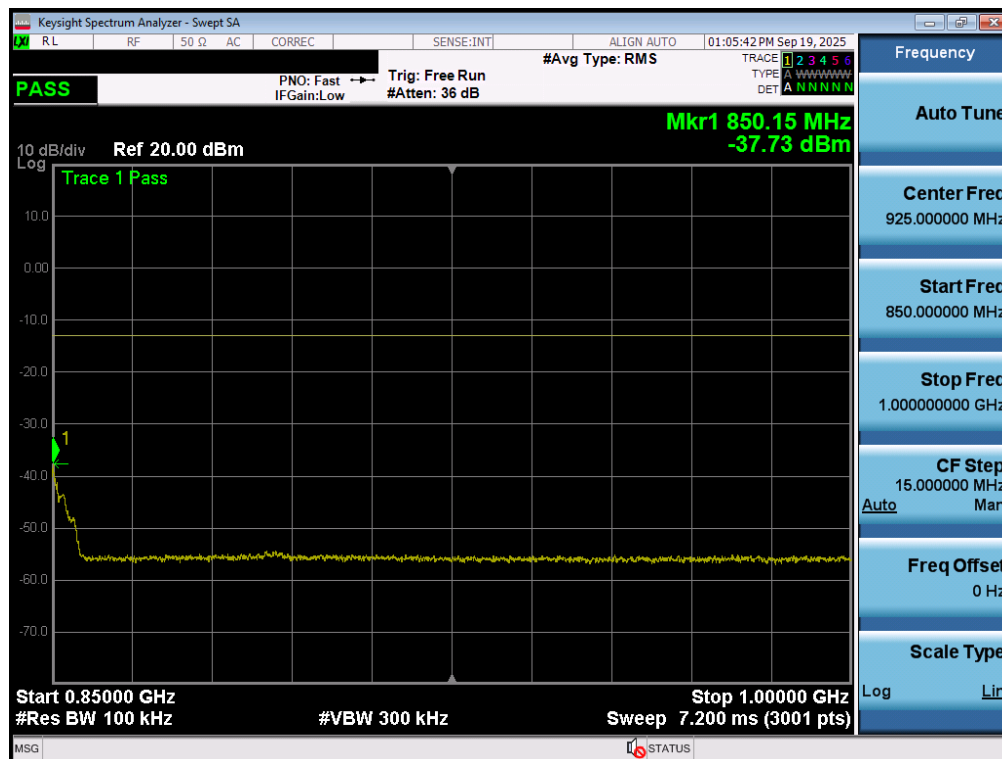

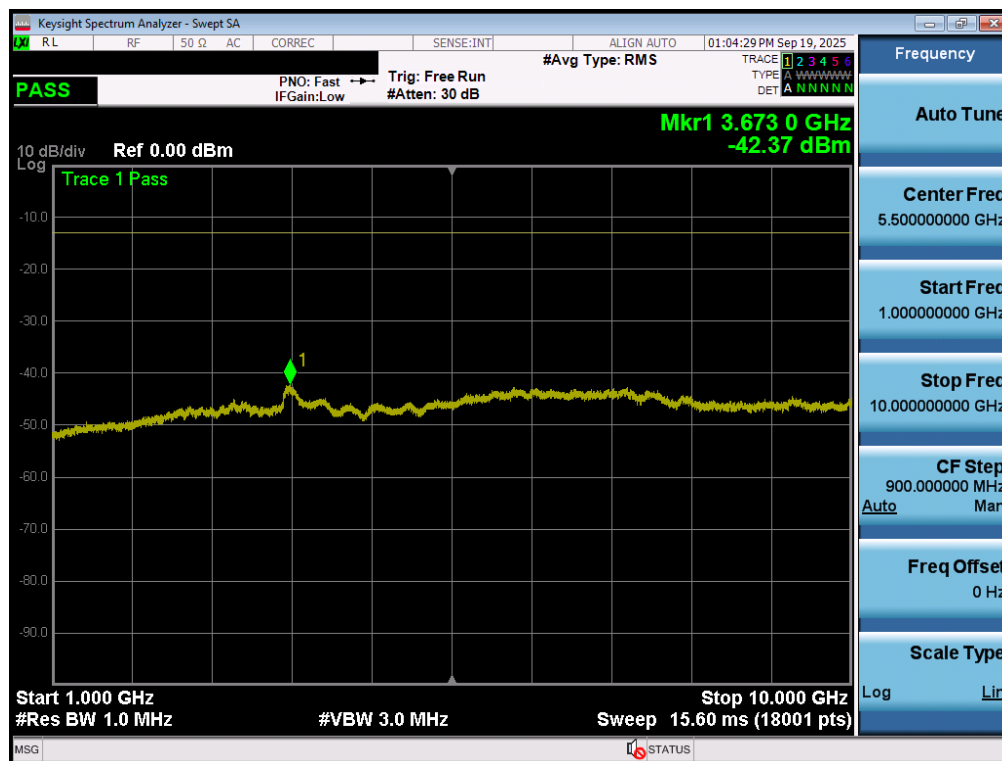


Plot 7-120. Conducted Spurious Plot (WCDMA Ch. 4233 – Ant2)

7.5 Band Edge Emissions at Antenna Terminal

Test Overview

All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.

The minimum permissible attenuation level of any spurious emission is $43 + 10 \log_{10}(P_{\text{Watts}})$, where P is the transmitter power in Watts.

Test Procedure Used

ANSI C63.26:2015 – Section 5.7.3

Test Settings

1. Start and stop frequency were set such that the band edge would be placed in the center of the plot
2. Span was set large enough so as to capture all out of band emissions near the band edge
3. $\text{RBW} \geq 1\%$ of the emission bandwidth
4. $\text{VBW} \geq 3 \times \text{RBW}$
5. Detector = RMS
6. Number of sweep points $\geq 2 \times \text{Span}/\text{RBW}$
7. Trace mode = trace average for continuous emissions, max hold for pulse emissions
8. Sweep time = auto couple
9. The trace was allowed to stabilize

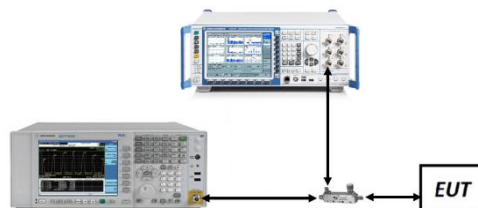


Figure 7-4. Test Instrument & Measurement Setup

Per 22.917(b) and RSS-132(5.5), in the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed to demonstrate compliance with the out-of-band emissions limit. 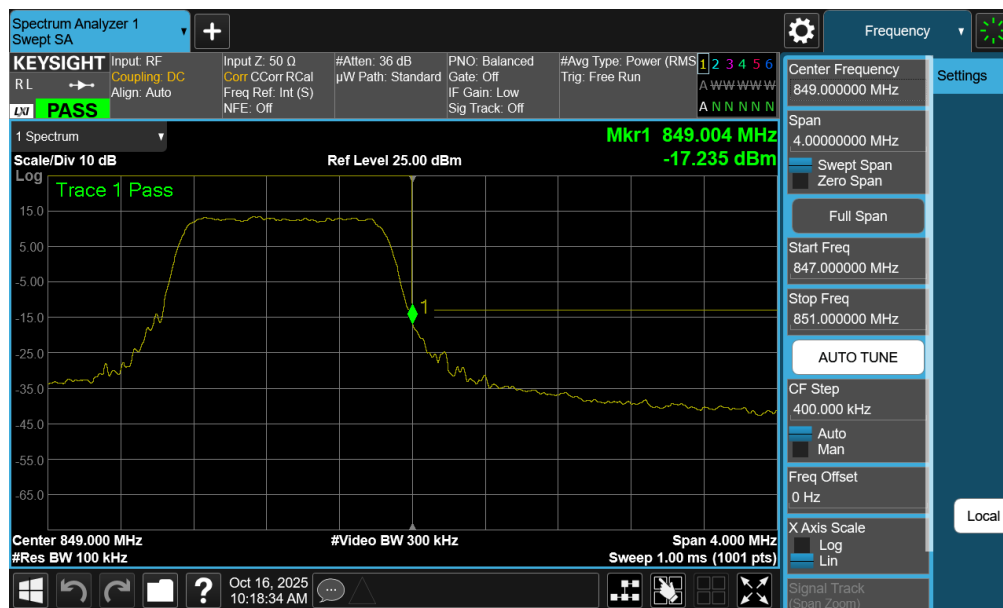
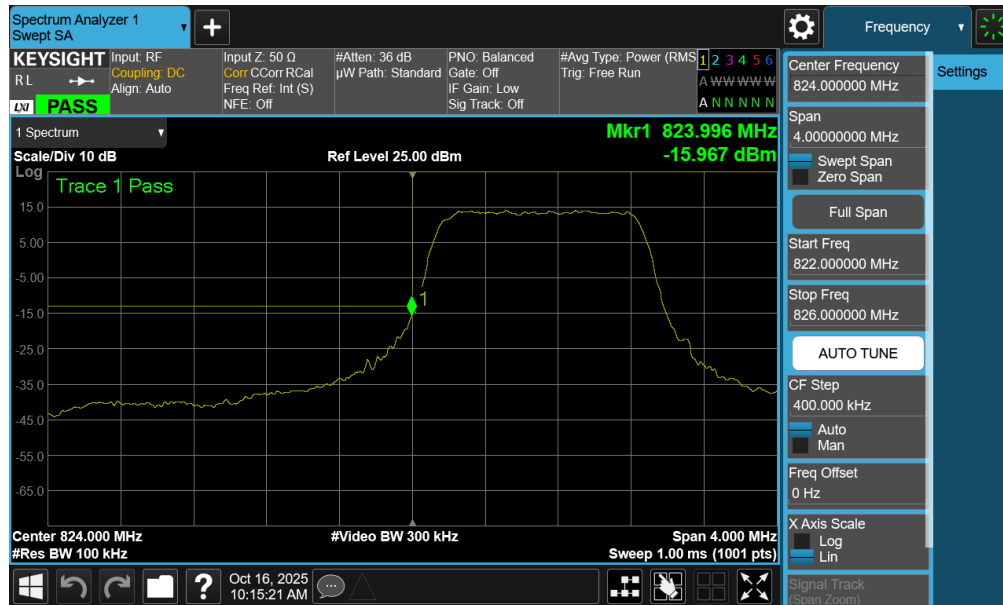


Plot 7-129. Lower Band Edge Plot (LTE Band 26/5 - 3MHz QPSK - Full RB - Ant1)



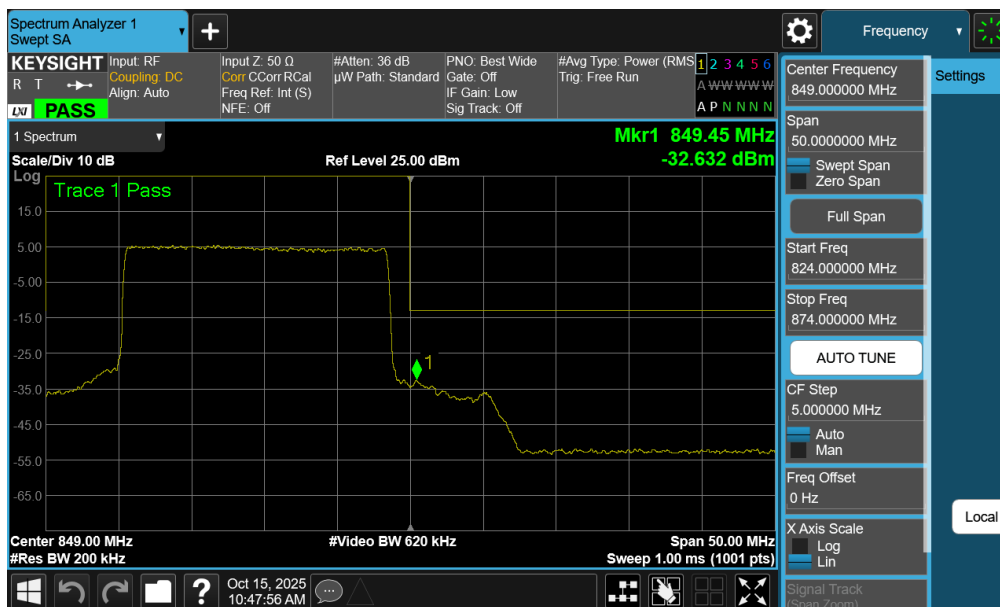
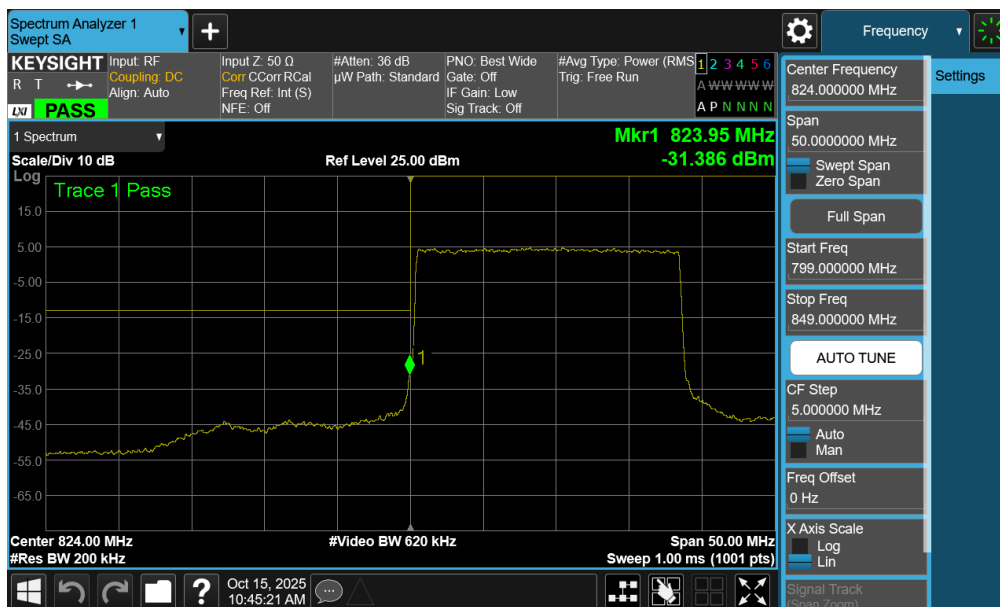
Plot 7-130. Upper Band Edge Plot (LTE Band 26/5 - 3MHz QPSK - Full RB - Ant1)

Plot 7-144. Upper Band Edge Plot (WCDMA Cell – Ch. 4233 – Ant1)

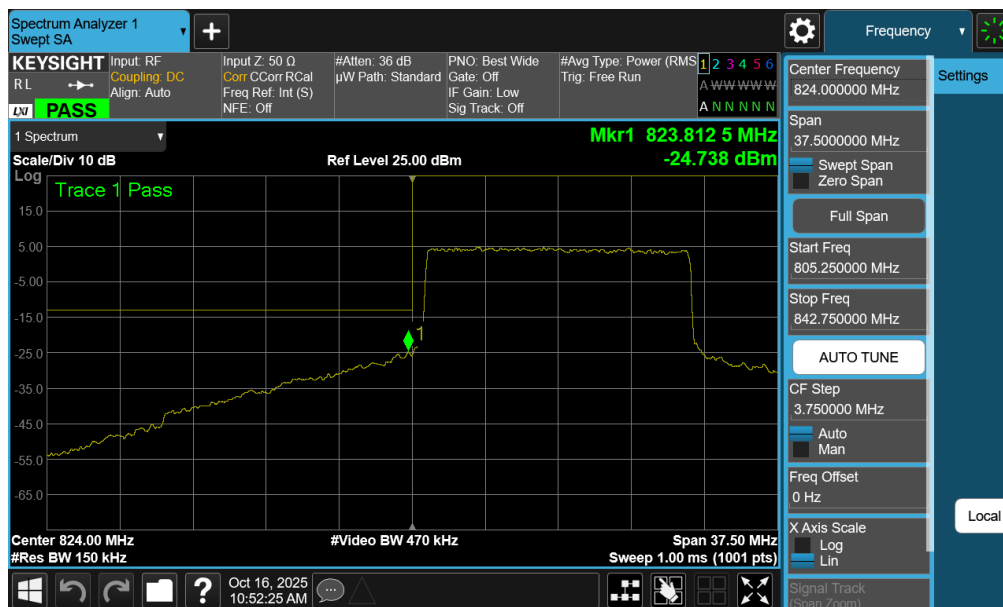

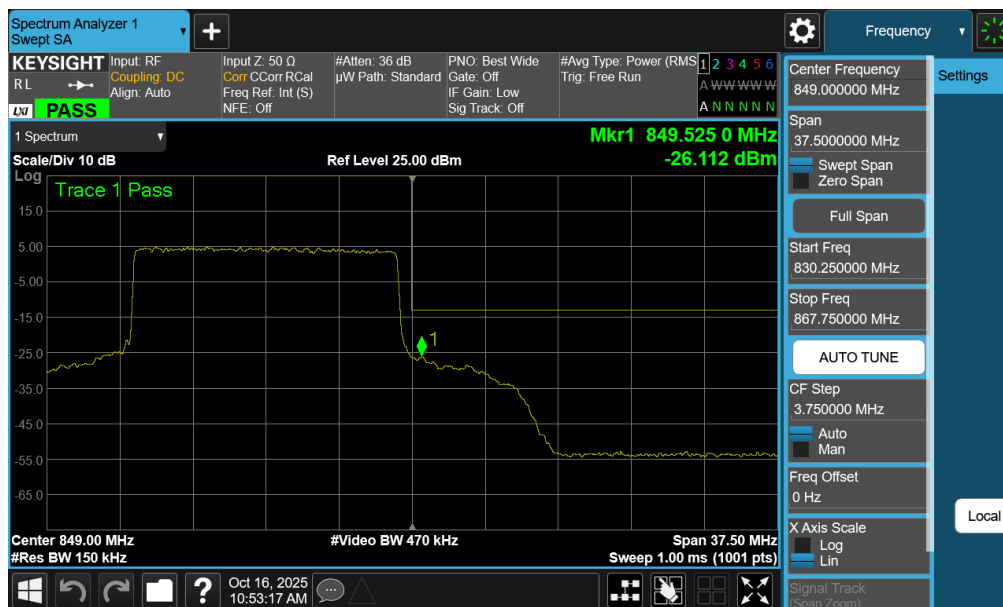
