GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *DDM Brands LLC*'s product, model number: *Andy 5E (FCC ID: A4JANDY5E3)* or the "EUT" in this report was a *Mobile phone*, which was measured approximately: 14.3 cm (L) × 7.9 cm (W) × 0.8 cm (H), rated with input voltage: DC 3.7V rechargeable Li-ion battery or DC 5.0V from adapter.

Note: The serial models Andy 5E3, AM5E3054, AM5E3043, AndyC5E, Andy C5E3, AC5E3054, AC5E3043 and Andy 5E, the difference between them is only the model number due to marketing purpose. Model Andy 5E was selected for testing. The detail was explained in the attached product similarity declaration letter provided and guaranteed by applicant.

Objective

This type approval report is prepared on behalf of *DDM Brands LLC* in accordance with Part 2, Part 22-Subpart H, Part 24-Subpart E and Part 27 of the Federal Communication Commission's rules.

The objective is to determine the compliance of EUT with FCC rules for output power, modulation characteristic, occupied bandwidth, and spurious emission at antenna terminal, spurious radiated emission, frequency stability, and band edge.

Test Methodology

All tests and measurements indicated in this document were performed in accordance with the Code of Federal Regulations Title 47 Part 2, Sub-Part J as well as the following parts:

Part 22 Subpart H - Public Mobile Services

Part 24 Subpart E - Personal Communication Services

Part 27 – Miscellaneous wireless communications services

Applicable Standards: TIA/EIA 603-D, ANSI C63.4-2014.

All radiated and conducted emissions measurements were performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.81 dB for 30MHz-1GHz and 4.88 dB for above 1GHz, 1.95dB for conducted measurement.

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp.(Shenzhen) to collect test data is located in the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). 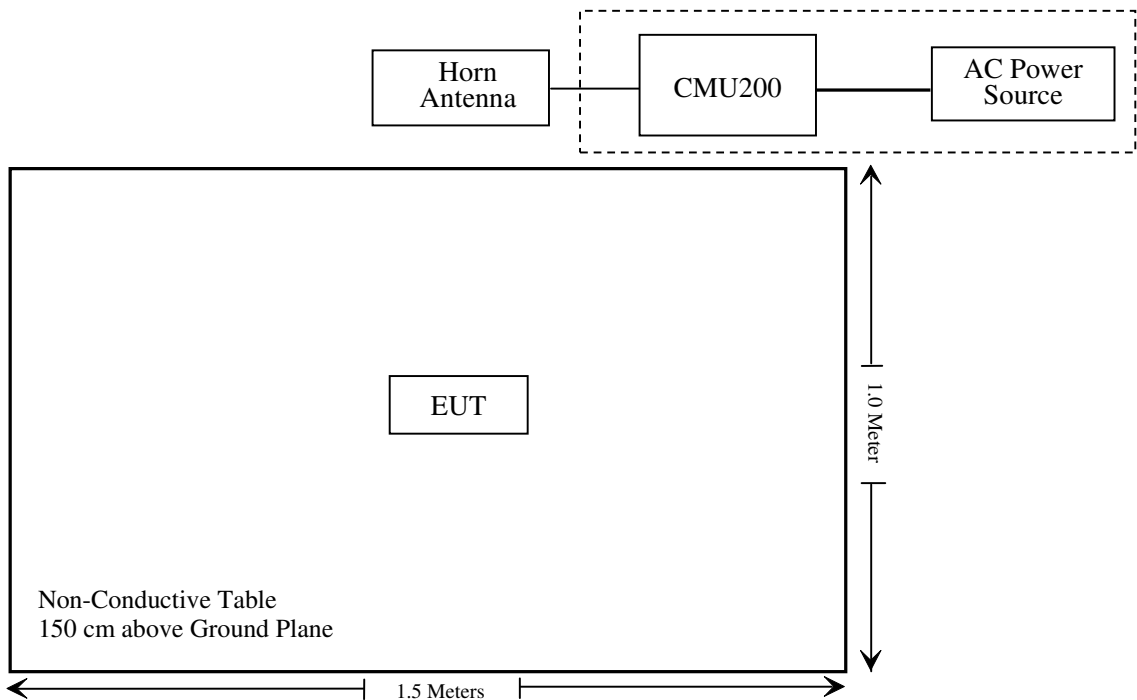

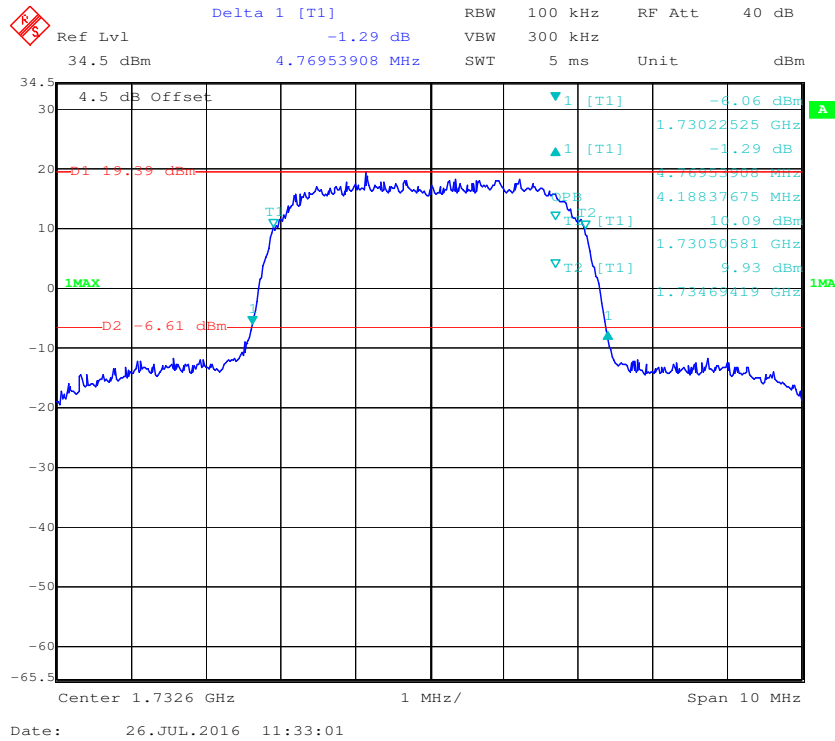


99% Occupied & 26 dB Emissions Bandwidth for WCDMA (BPSK) Mode

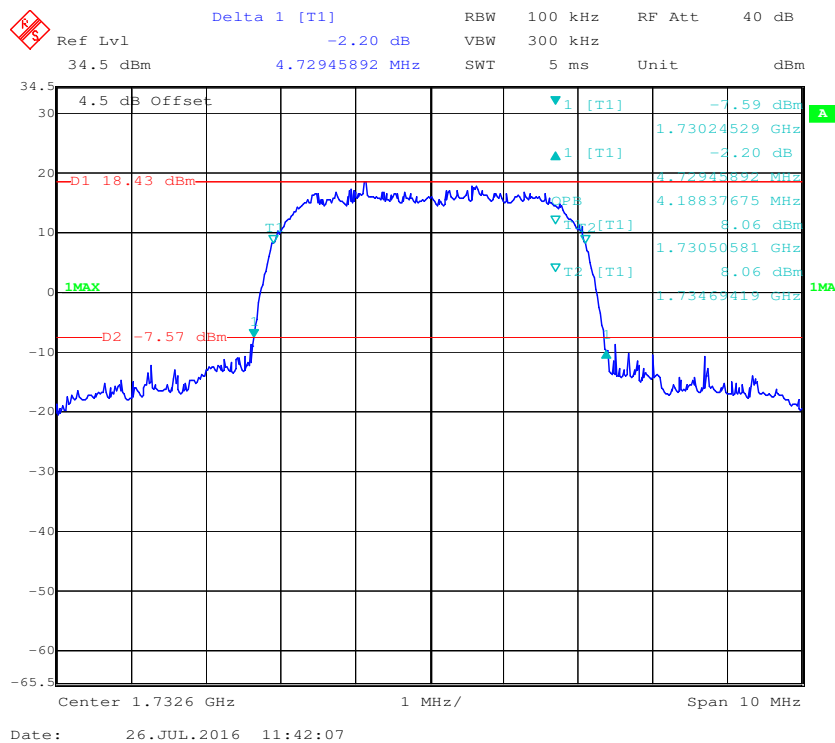

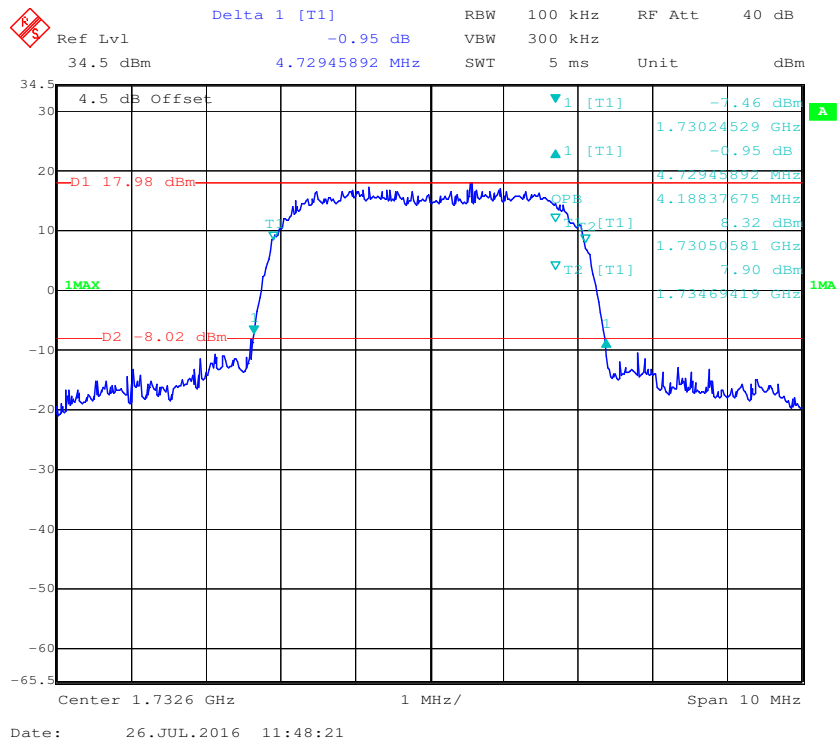

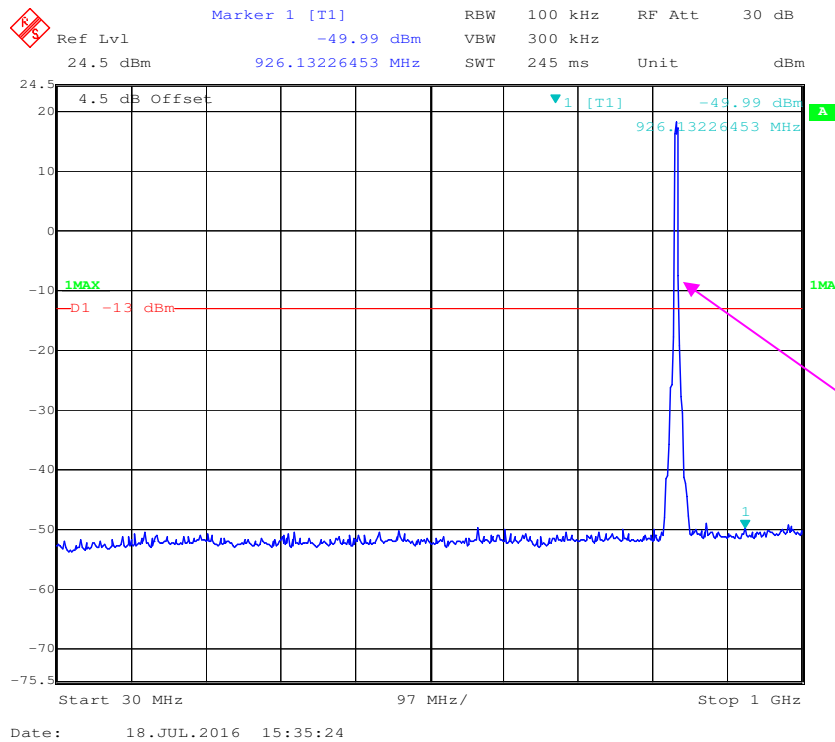
30 MHz – 1 GHz (GSM Mode)



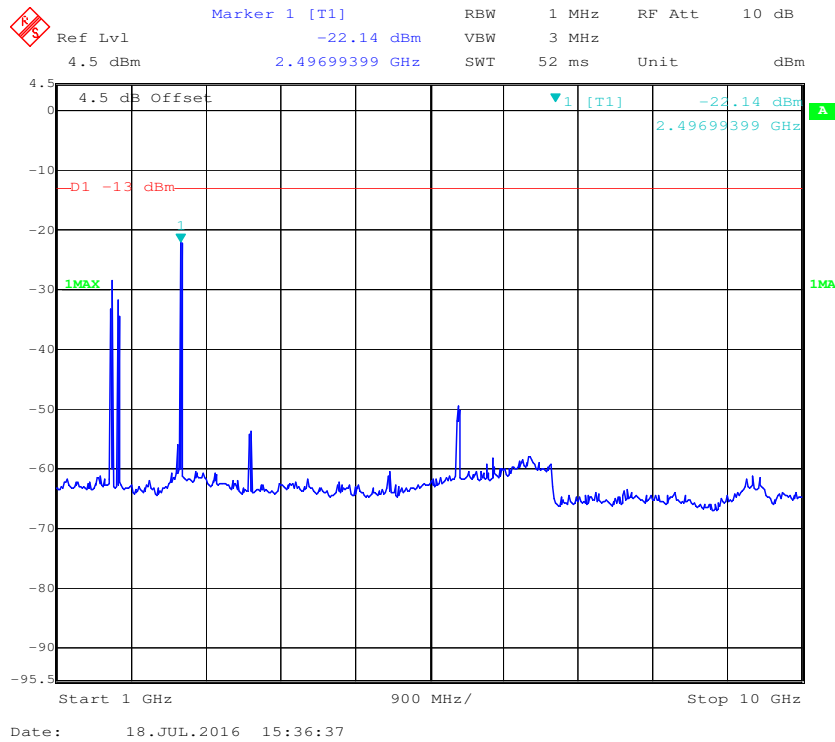
1 GHz – 10 GHz (GSM Mode)

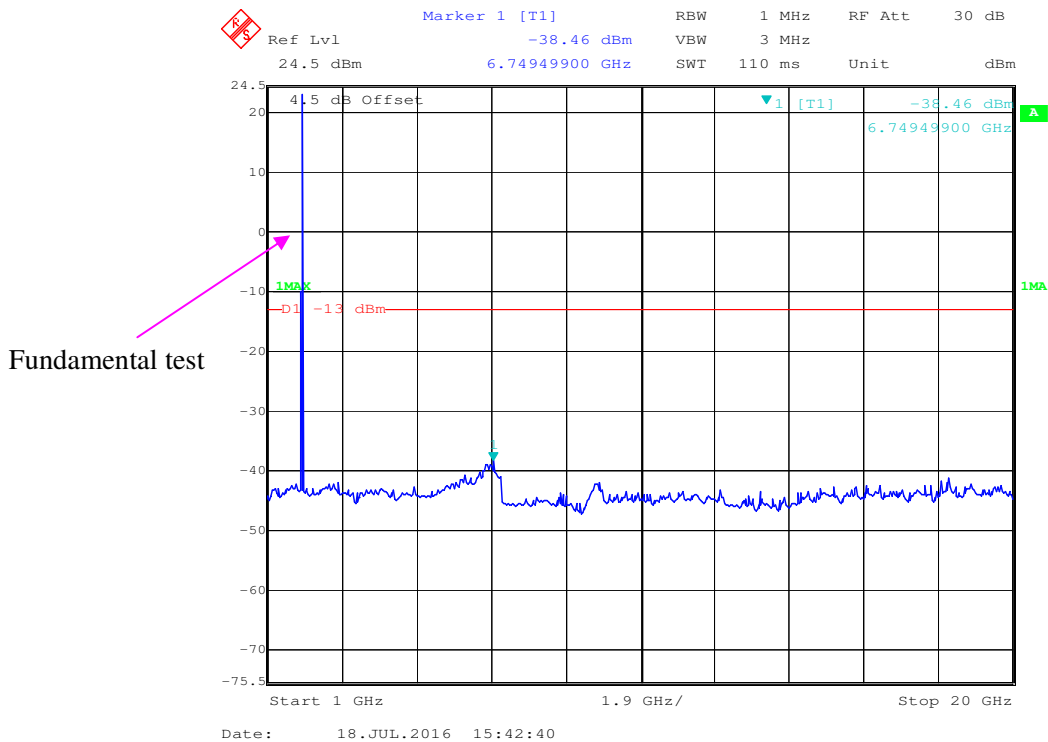
1 GHz – 20 GHz (GSM Mode)

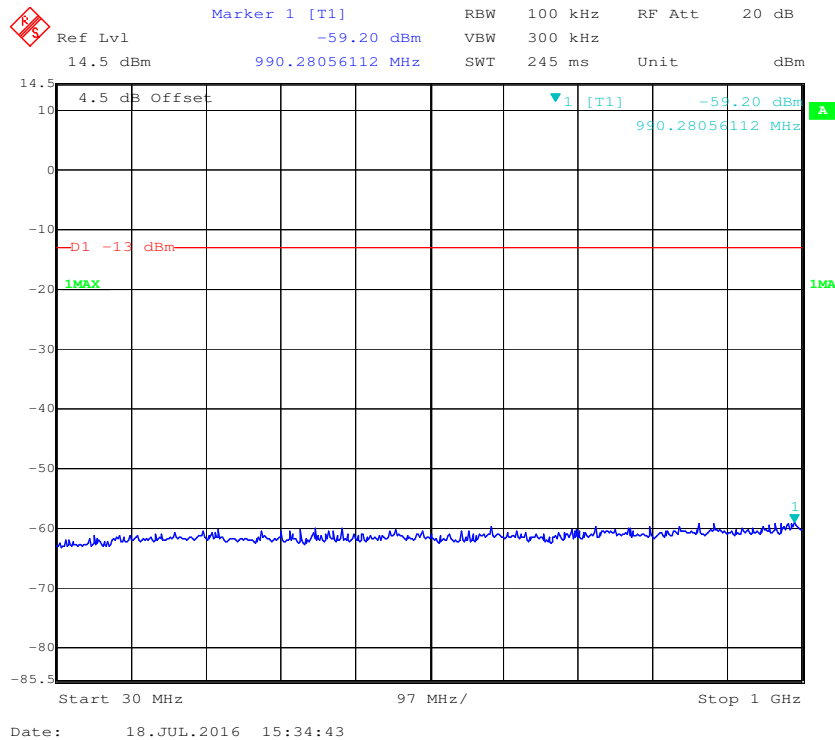

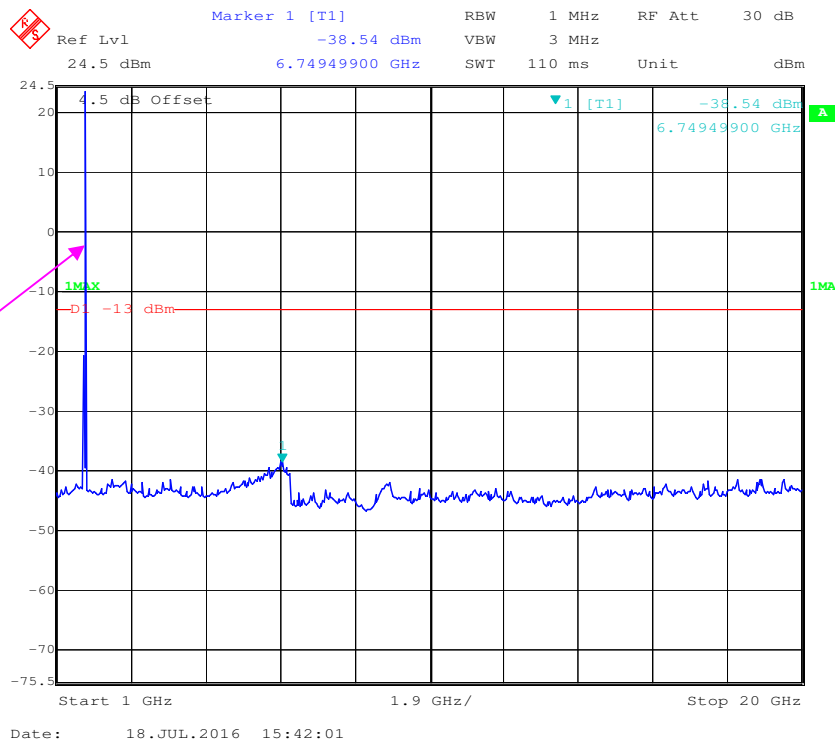

Test Procedure

The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

The frequency range up to tenth harmonic of the fundamental frequency was investigated.

Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.

Spurious emissions in dB = $10 \lg (\text{TX pwr in Watts}/0.001)$ – the absolute level

Spurious attenuation limit in dB = $43 + 10 \lg_{10} (\text{power out in Watts})$

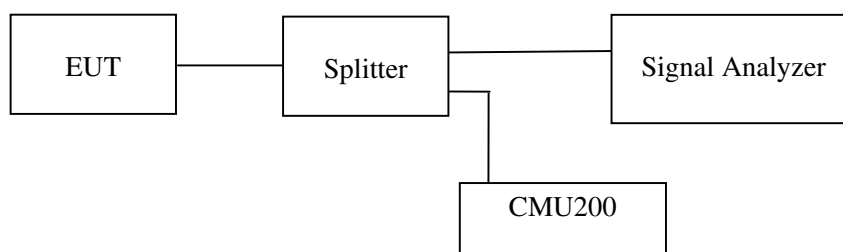

In addition, the attenuation factor shall not be less than $43 + 10 \log(P)$ dB on all frequencies between 2490.5 MHz and 2496 MHz and $55 + 10 \log(P)$ dB at or below 2490.5 MHz. Mobile Satellite Service licensees operating on frequencies below 2495 MHz may also submit a documented interference complaint against BRS licensees operating on channel BRS Channel 1 on the same terms and conditions as adjacent channel BRS or EBS licensees.

Test Procedure

The RF output of the transmitter was connected to the input of the spectrum analyzer through sufficient attenuation.

The center of the spectrum analyzer was set to block edge frequency

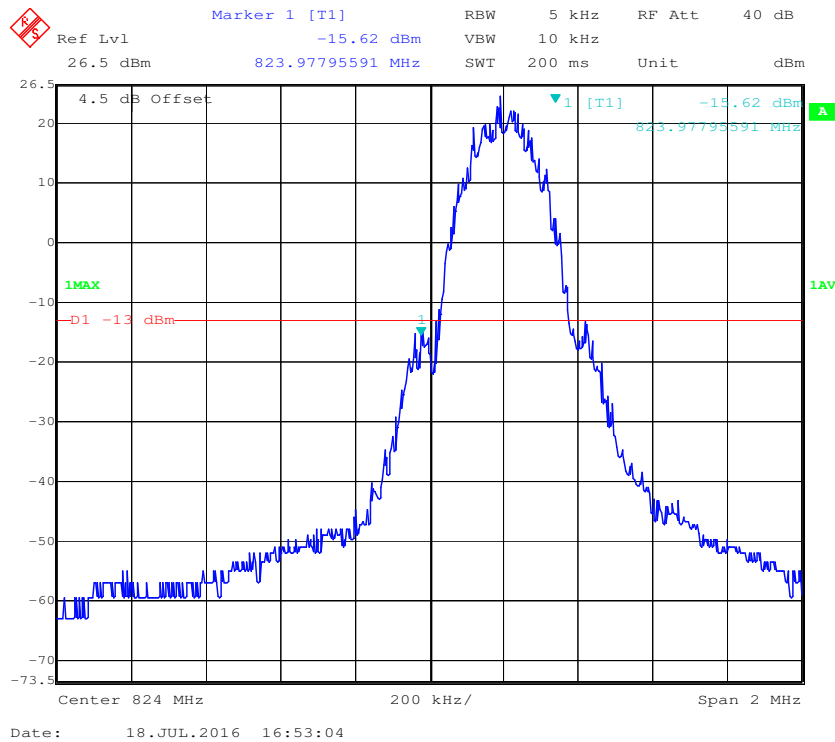

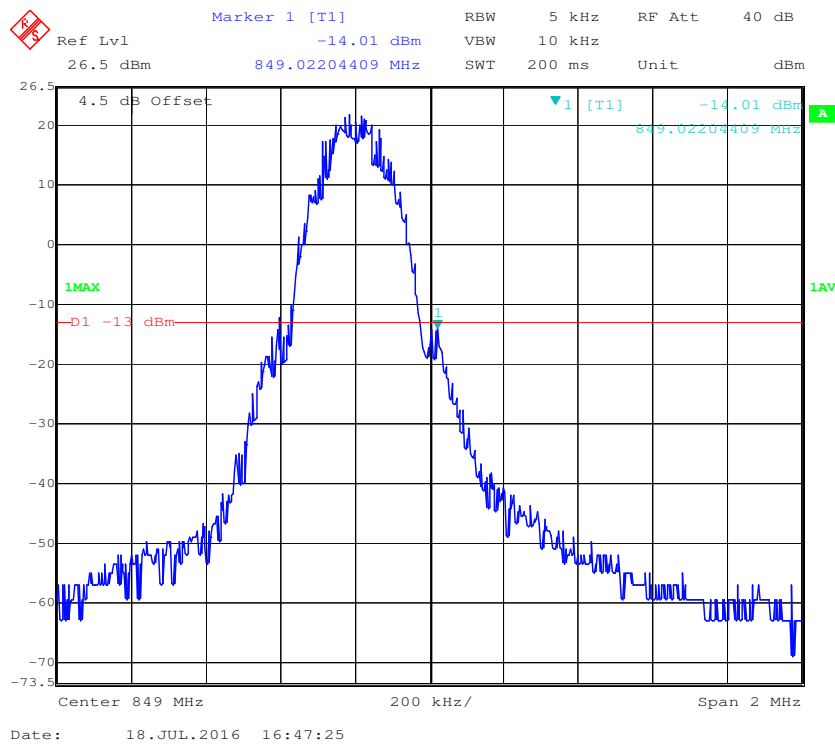

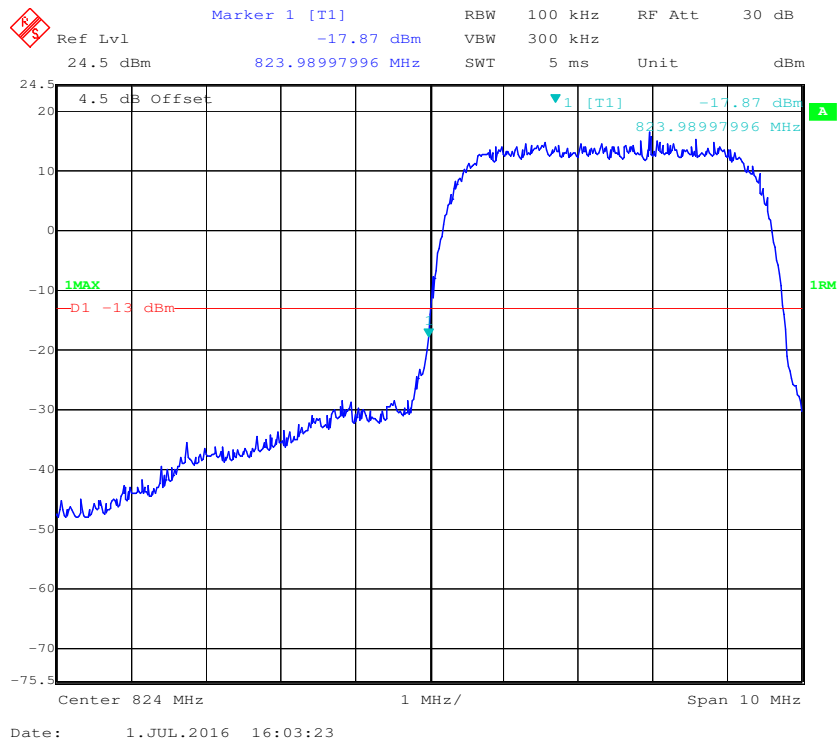
Cellular Band, Left Band Edge for GSM (GMSK) Mode



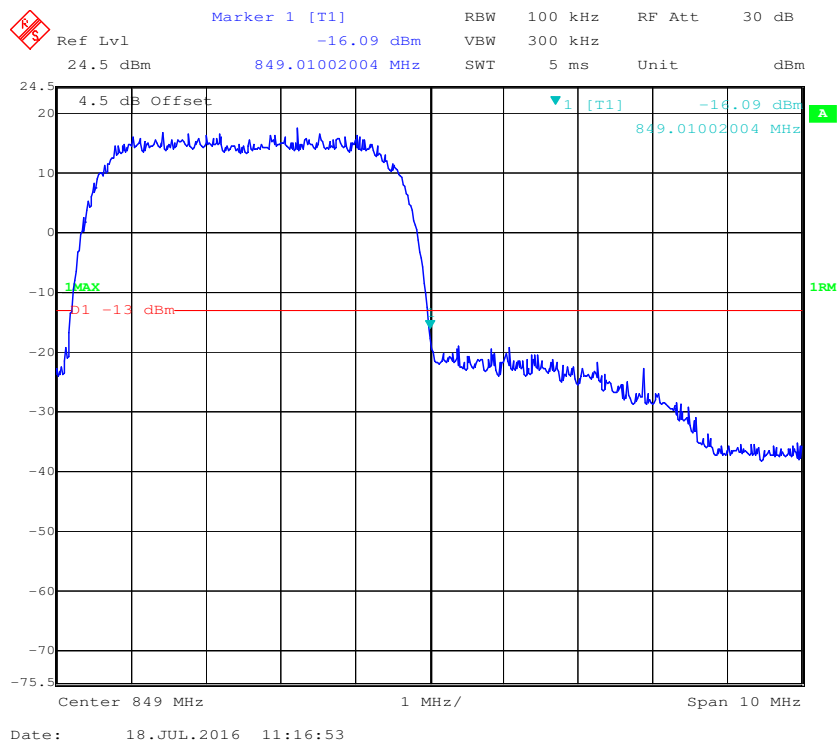
Cellular Band, Right Band Edge for GSM (GMSK) Mode

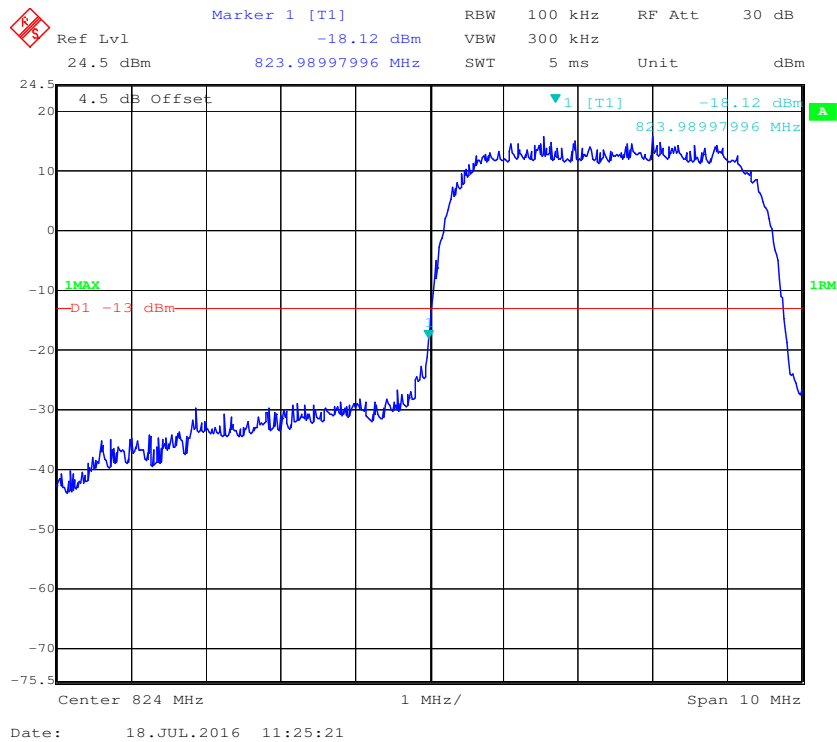
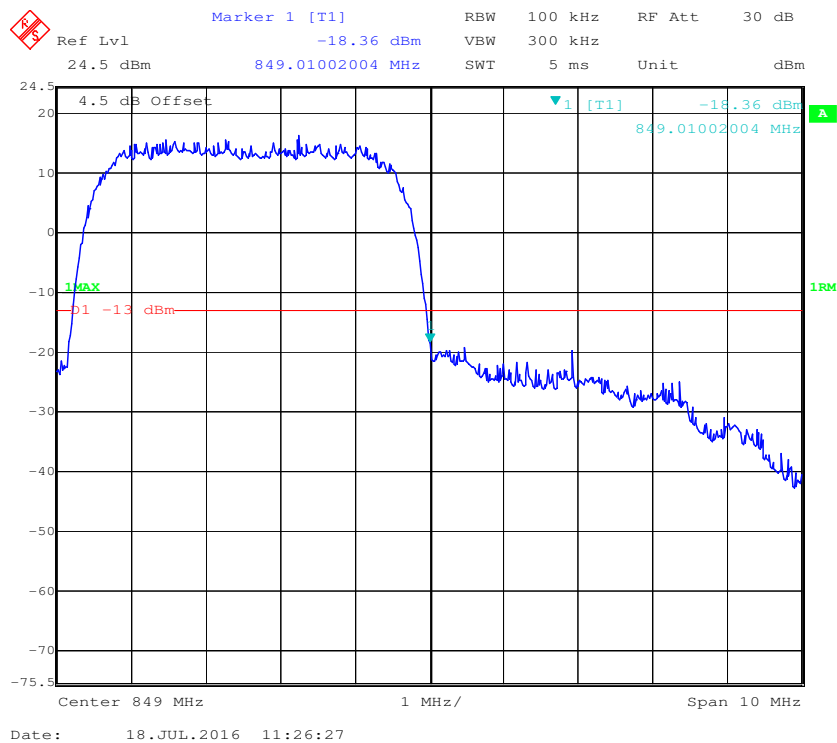


Cellular Band, Left Band Edge for WCDMA (BPSK) Mode

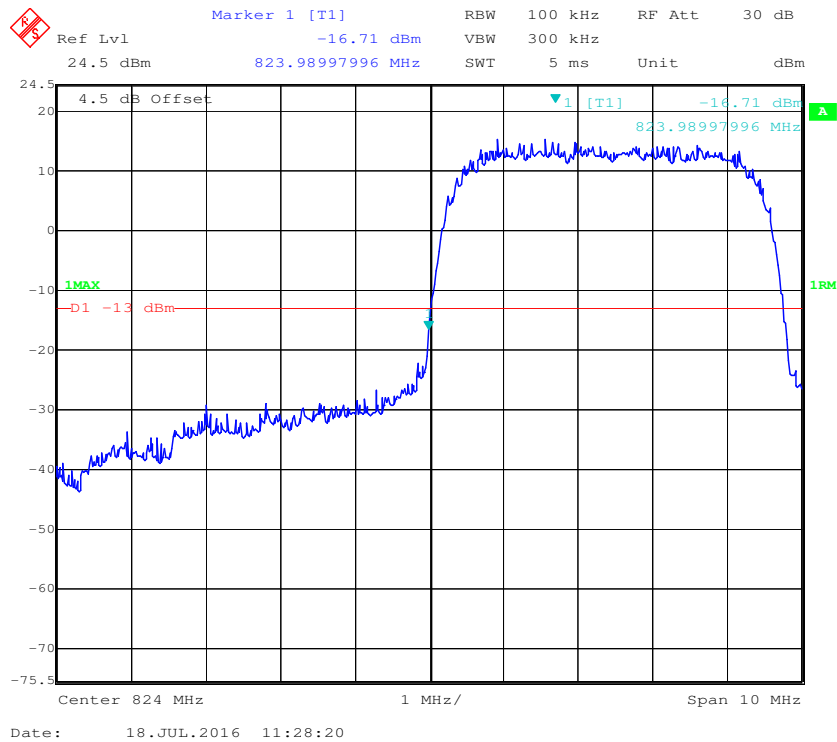


Cellular Band, Right Band Edge for WCDMA (BPSK) Mode

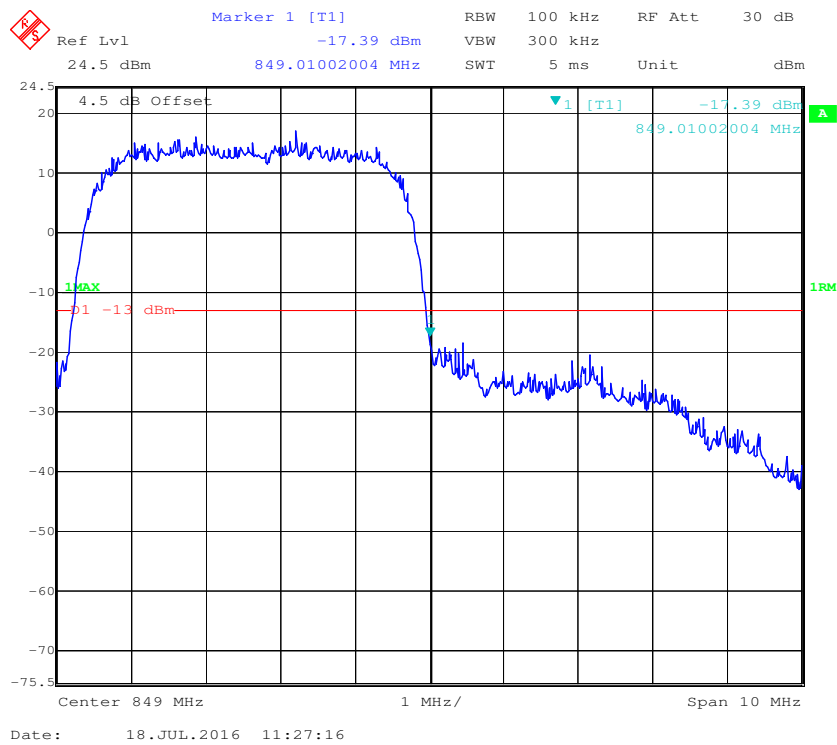

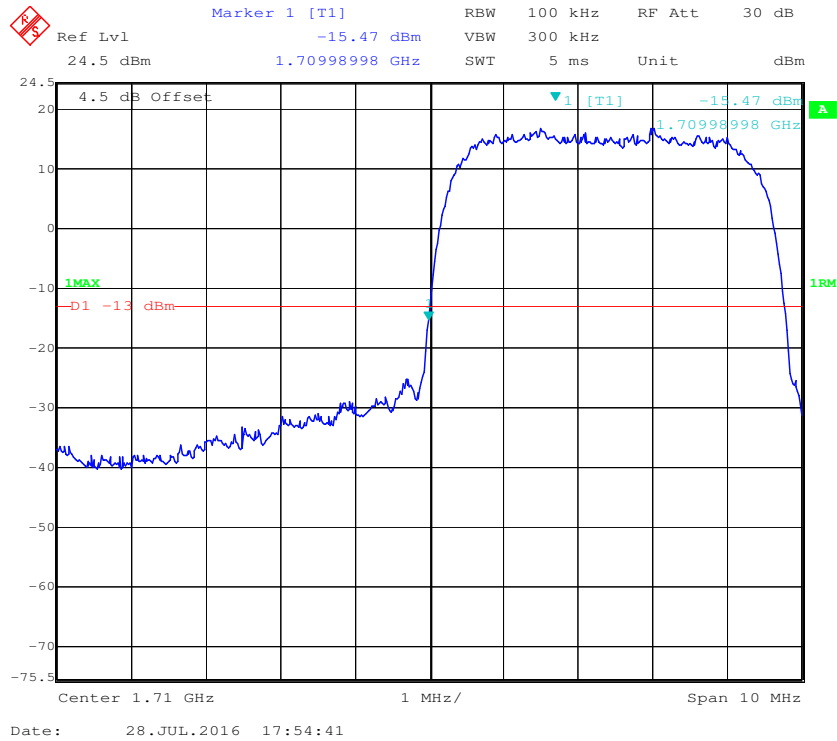
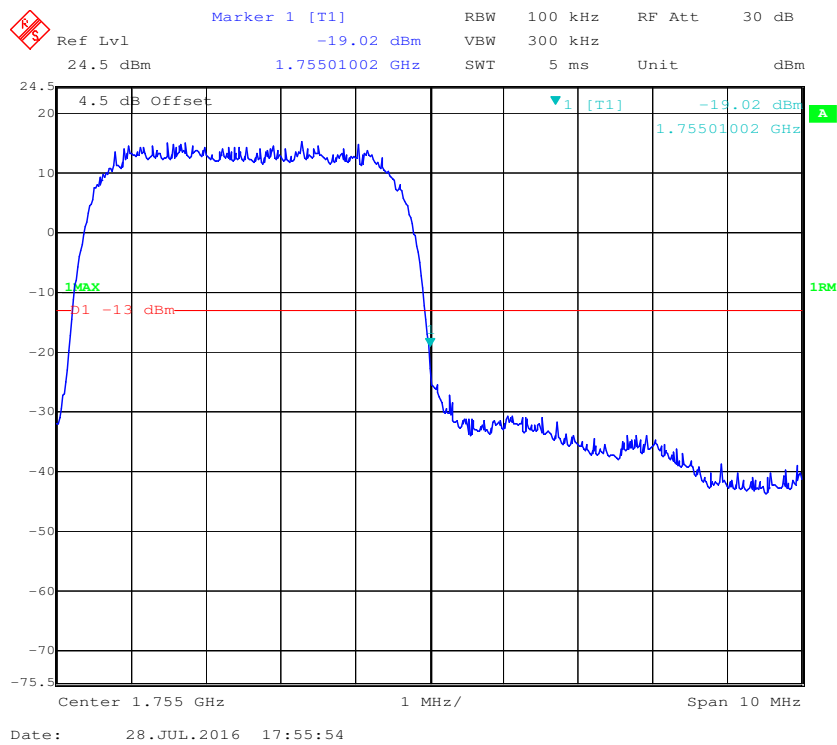


PCS Band, Left Band Edge for HSUPA (BPSK) Mode

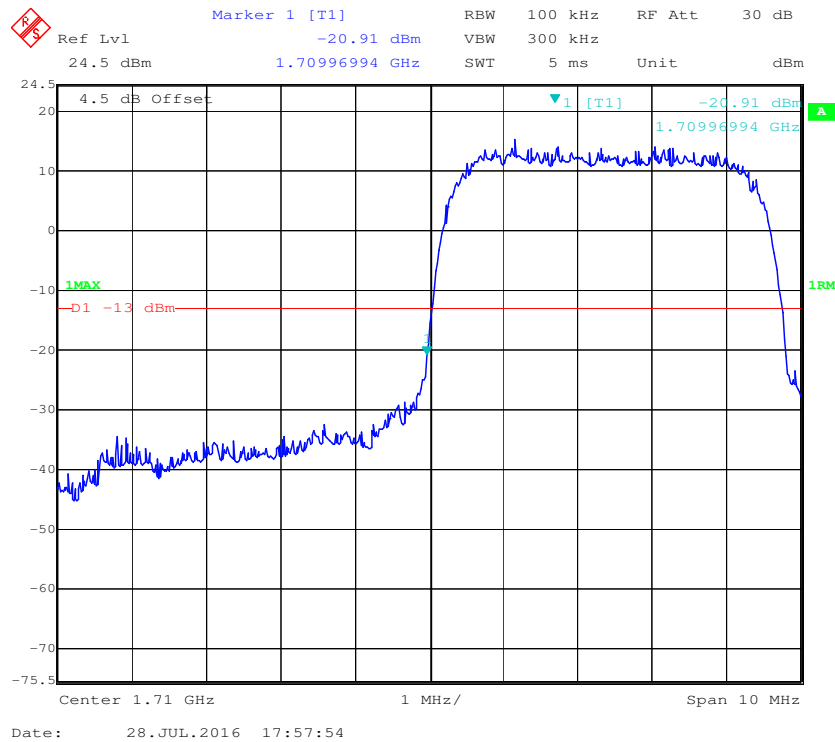

Test Procedure

Frequency Stability vs. Temperature: The equipment under test was connected to an external DC power supply and the RF output was connected to communication test set via feed-through attenuators. The EUT was placed inside the temperature chamber. The DC leads and RF output cable exited the chamber through an opening made for the purpose.

After the temperature stabilized for approximately 20 minutes, the frequency output was recorded from the communication test set.

Frequency Stability vs. Voltage: For hand carried, battery powered equipment; reduce primary supply voltage to the battery operating end point which shall be specified by the manufacturer.
