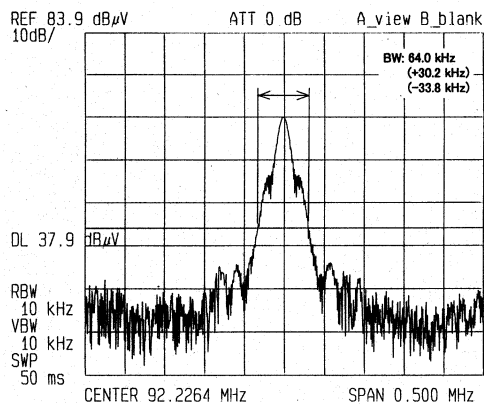

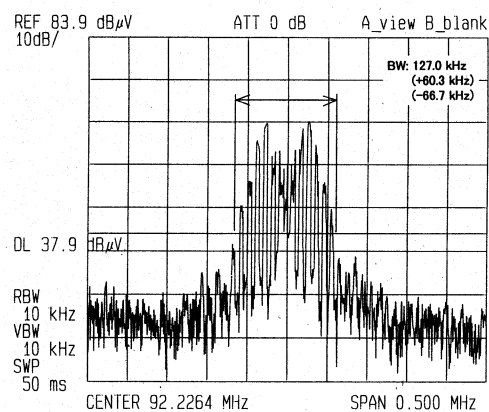

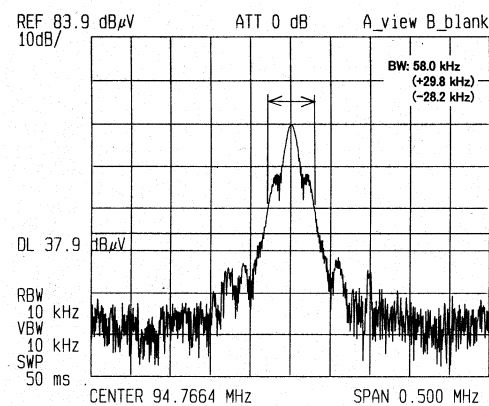


Audio input 1 kHz +8 dBV

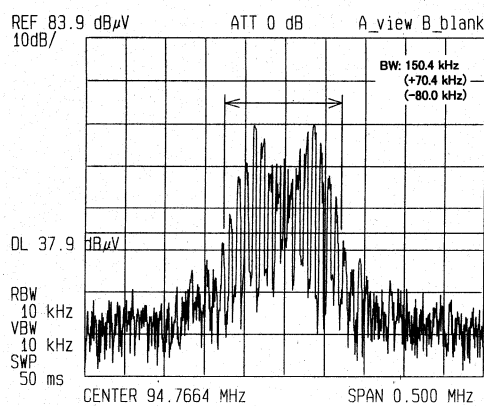


94.77 MHz

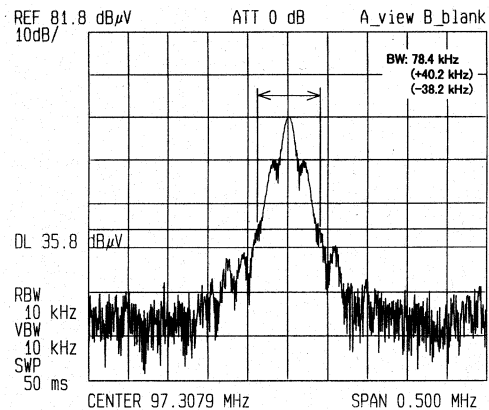


Audio input 1 kHz +8 dBV

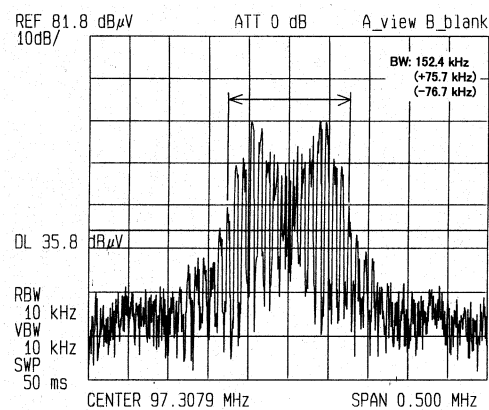

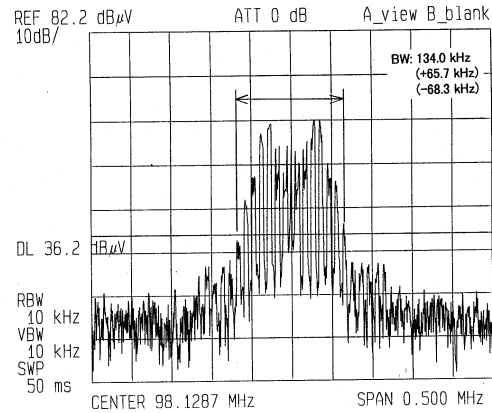

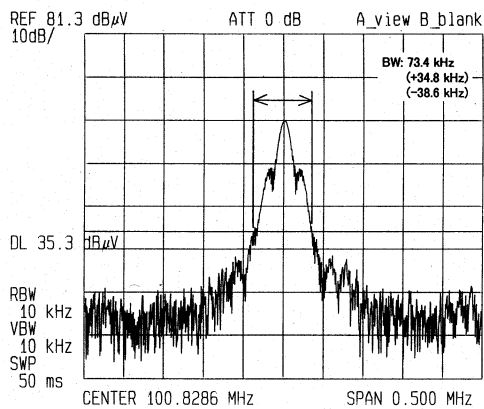


Audio input 1 kHz +8 dBV

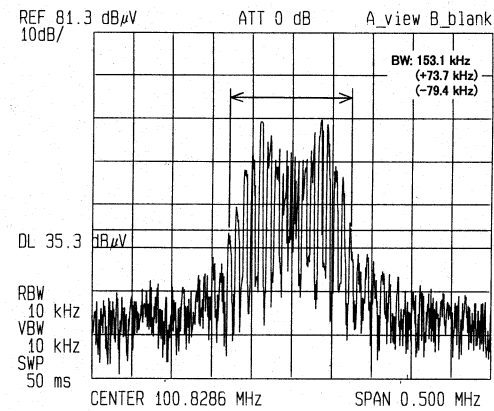


100.83 MHz

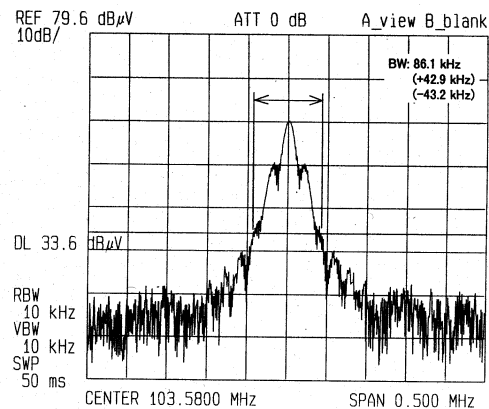


Audio input 1 kHz +8 dBV

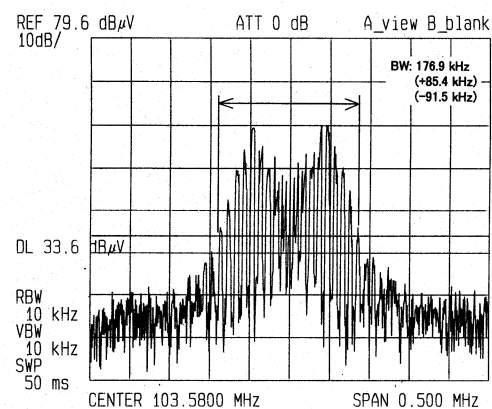
