3.4 Product description and theory of operation

The Arris XG1v4 is an IP Video Gateway (next-gen, set-top technology) with 4K video capability. It is a 4K set-top with multiple 1 GHz tuners that support both MPEG-2 and MPEG-4 AVC services. The all-digital XG1v4 includes the latest audio and video output interfaces, including 4K HDMI video, Award-winning Dolby Digital Plus audio and Dolby Volume Leveling. With the included MoCA home networking, the XG1v4 provides the flexibility to serve as a multimedia client for accessing content from other compatible devices at home. An embedded DOCSIS 2.0+ cable modem provides support for DSG and downstream channel bonding.

Model variant is identical in RF circuits; only different part is in cable TV function.

There are 2 radio interfaces: 1) RF4CE (2.4GHz DSSS); 2) BT BDR+EDR (2.4GHz FHSS) and BLE (2.4GHz DTS).

There are 2 identical trace antennas on PCB for RF4CE. Both can be used at the same time for receiver diversity, but only one can transmit at a time.

3.5 EUT exercise details

A test software was used that allows the change of different RF modes/channels. EUT is set to fixed channel test mode with modulation. Both antenna paths are tested separately, worst case was selected for most Radiated test.

RF conducted test was performed on unit with temporary RF output modification (50Ω SMA before antennas).
TX Power Level = 7.

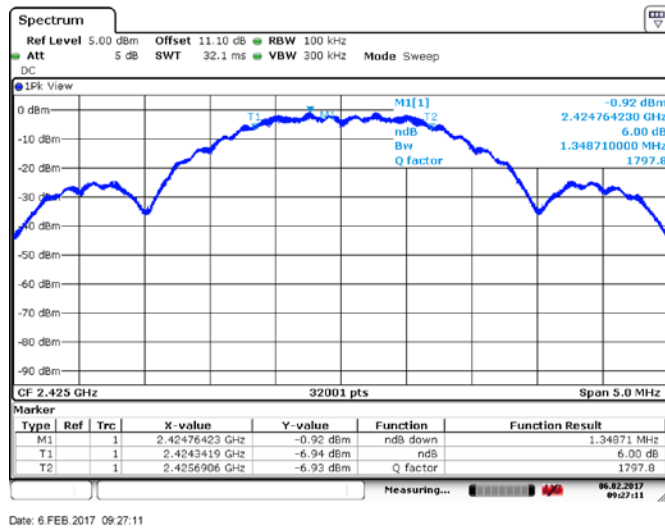


Figure 8.1-1: 6 dB bandwidth, Low CH, Ant o

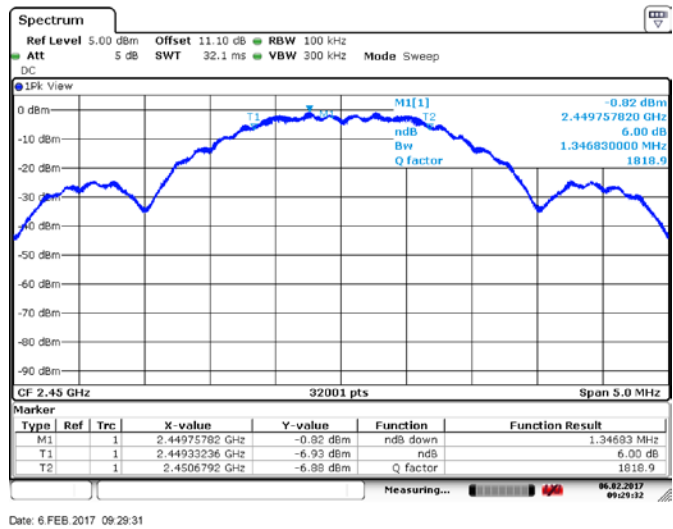


Figure 8.1-2: 6 dB bandwidth, Mid CH, Ant o

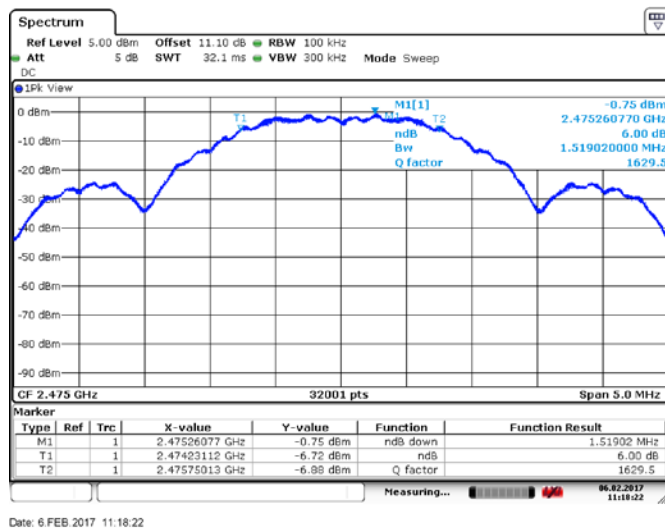


Figure 8.1-3: 6 dB bandwidth, High CH, Ant o

8.2 FCC 15.247(b) and RSS-247 5.4 (4) Transmitter output power and e.i.r.p. requirements

8.2.1 Definitions and limits

FCC:

- (b) The maximum peak conducted output power of the intentional radiator shall not exceed the following:
- (3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.
 - (4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

5.4 Transmitter Output Power and Equivalent Isotropically Radiated Power (E.I.R.P.) Requirements

- (4) For DTSs employing digital modulation techniques operating in the bands 902-928 MHz and 2400-2483.5 MHz, the maximum peak conducted output power shall not exceed 1W. Except as provided in Section 5.4(5), the e.i.r.p. shall not exceed 4 W.

As an alternative to a peak power measurement, compliance can be based on a measurement of the maximum conducted output power. The maximum conducted output power is the total transmit power delivered to all antennas and antenna elements, averaged across all symbols in the signalling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or transmitting at a reduced power level. If multiple modes of operation are implemented, the maximum conducted output power is the highest total transmit power occurring in any mode.

8.3 FCC 15.247(d) and RSS-247 5.5 Spurious (out-of-band) emissions

8.3.1 Definitions and limits

FCC:

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

IC:

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under Section 5.4(4), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

(a) Fundamental components of modulation of licence-exempt radio apparatus shall not fall within the restricted bands of Table 8.4-1 except for apparatus complying under RSS-287;

(b) Unwanted emissions that fall into restricted bands of Table 6 shall comply with the limits specified in RSS-Gen; and

(c) Unwanted emissions that do not fall within the restricted frequency bands of Table 8.4-1 shall comply either with the limits specified in the applicable RSS or with those specified in this RSS-Gen.

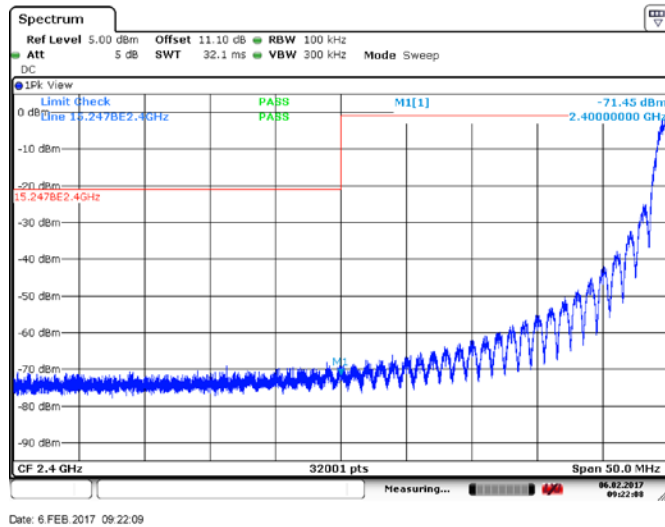


Figure 8.3.1: Bandedge Measurement, low channel, ant 0

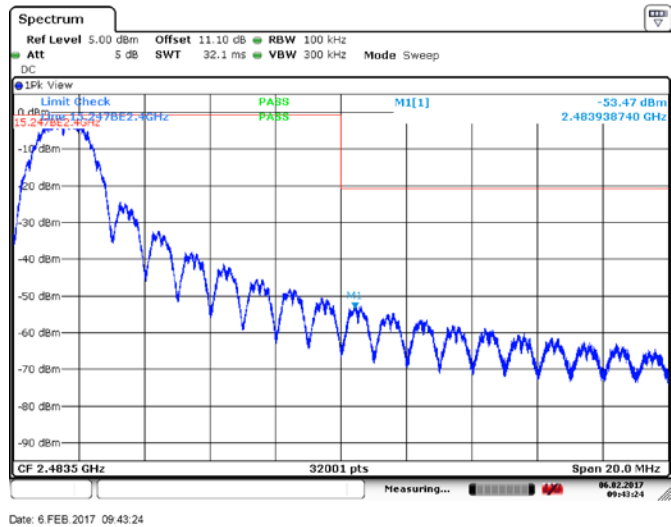


Figure 8.3.2: Bandedge Measurement, high channel, ant 0

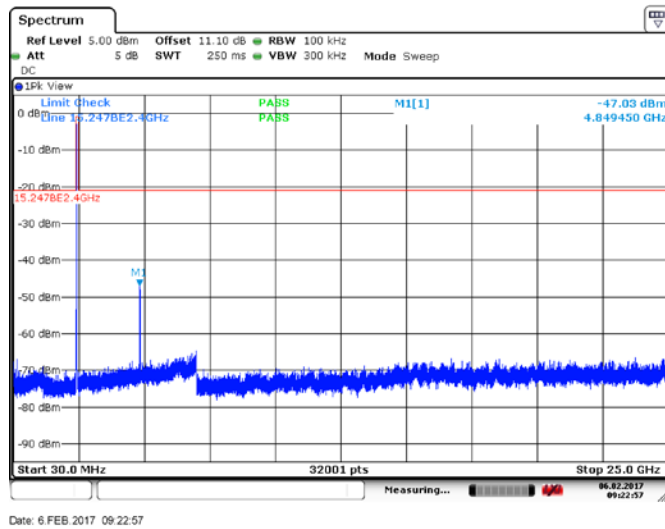


Figure 8.3.3: Conducted spurious emissions, low channel, ant 0

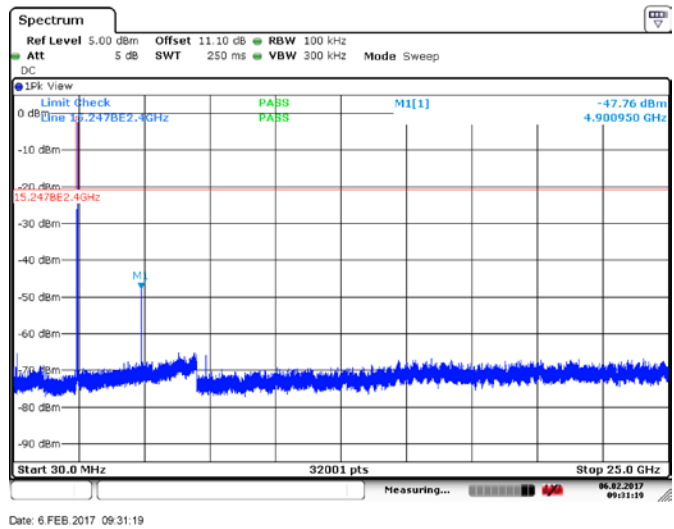


Figure 8.3.4: Conducted spurious emissions, mid channel, ant 0

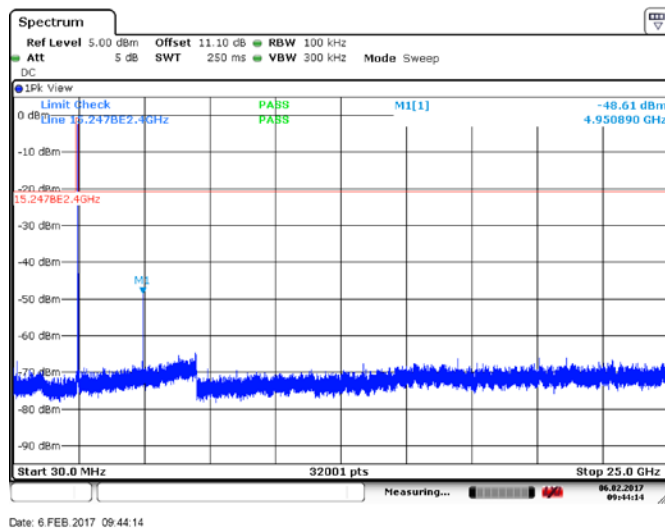


Figure 8.3.5: Conducted spurious emissions, high channel, ant 0

Peaks within 2400-2483.5MHz are transmitter fundamentals.

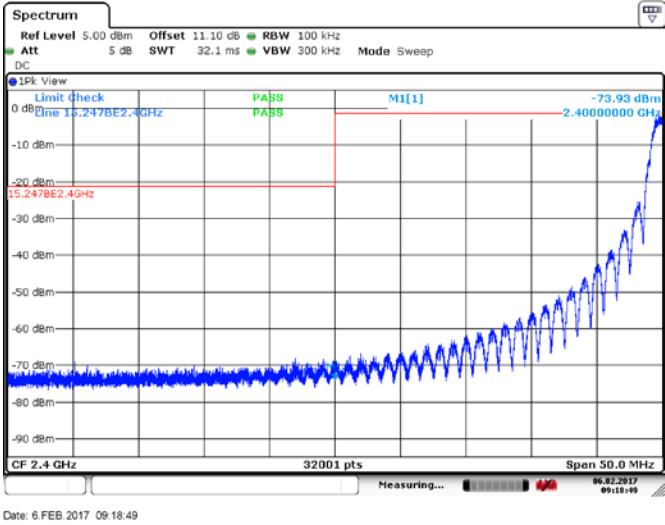


Figure 8.3.6: Bandedge Measurement, low channel, ant 1

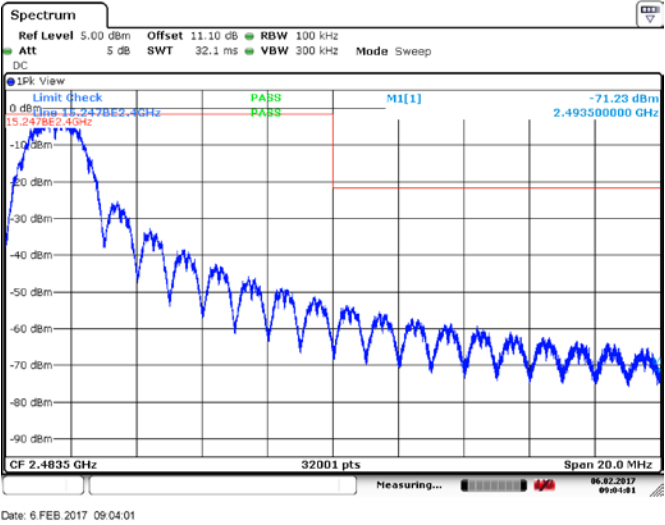


Figure 8.3.7: Bandedge Measurement, high channel, ant 1

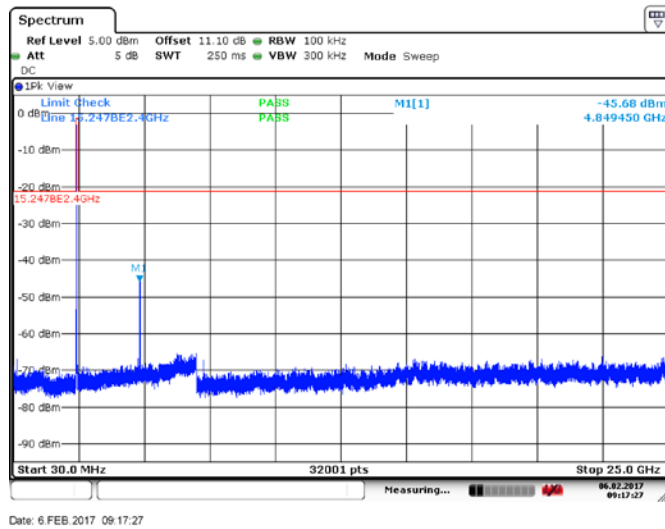


Figure 8.3.8: Conducted spurious emissions, low channel, ant 1

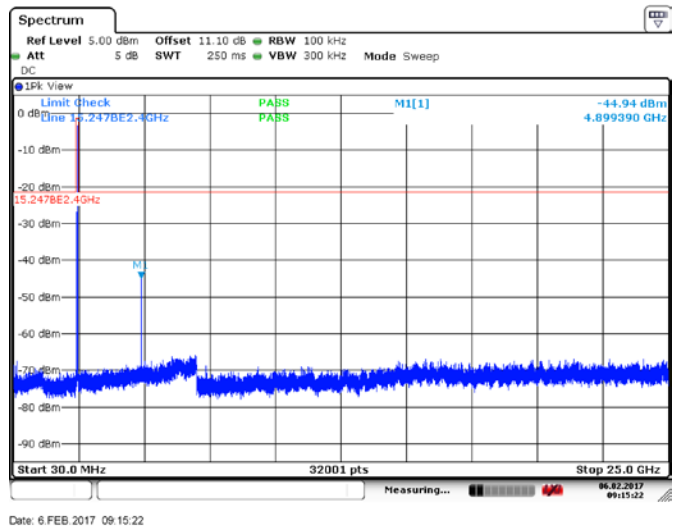


Figure 8.3.9: Conducted spurious emissions, mid channel, ant 1

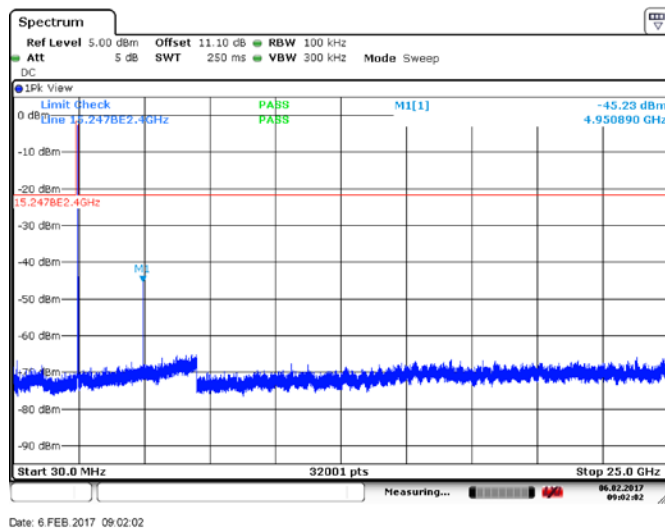


Figure 8.3.10: Conducted spurious emissions, high channel, ant 1

Peaks within 2400-2483.5MHz are transmitter fundamentals.

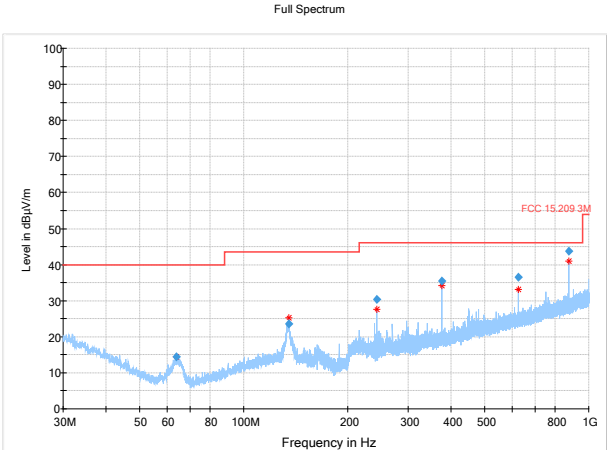


Figure 8.3.11: Radiated spurious emissions, low channel, 30-1000MHz, ant 0

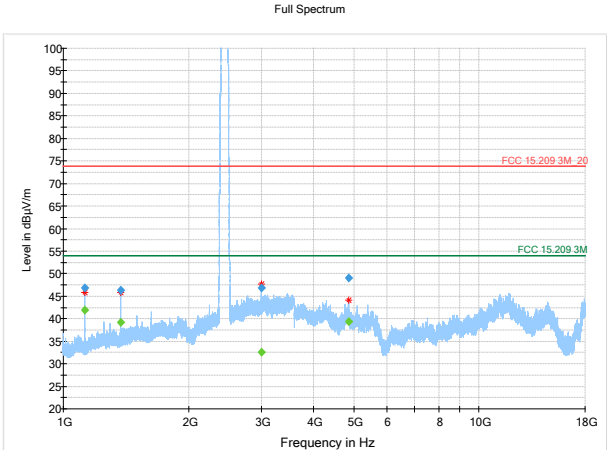


Figure 8.3.12: Radiated spurious emissions, low channel, 1-18GHz, ant 0

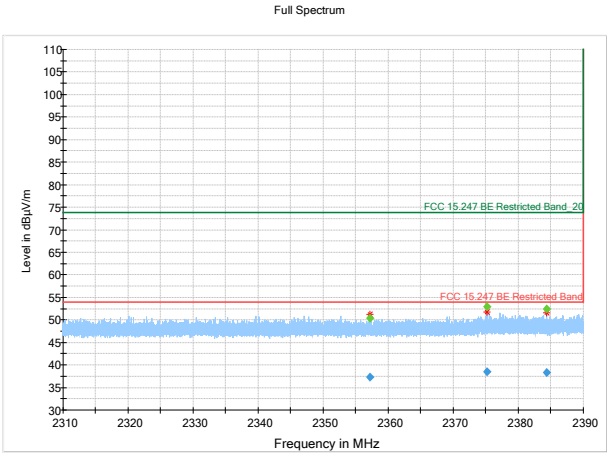


Figure 8.3.13: Radiated Bandedge in Restricted Band, low channel, ant 0

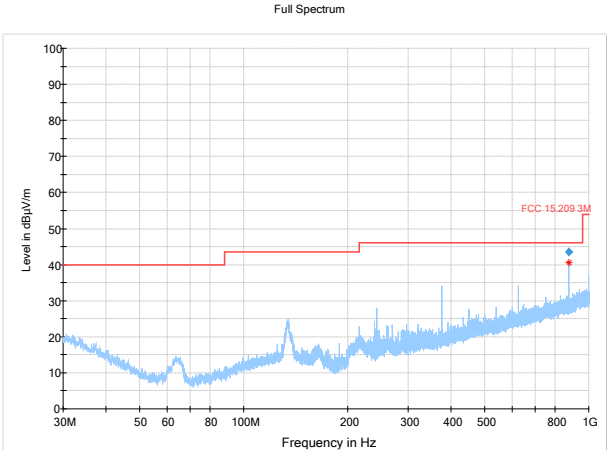


Figure 8.3.14: Radiated spurious emissions, mid channel, 30-1000MHz, ant 0

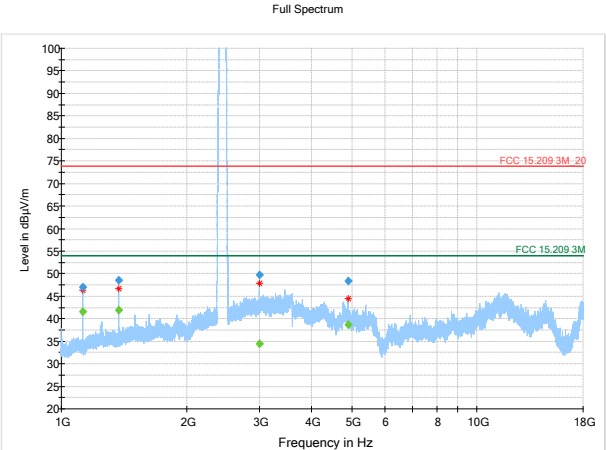


Figure 8.3.15: Radiated spurious emissions, mid channel, 1-18GHz, ant 0

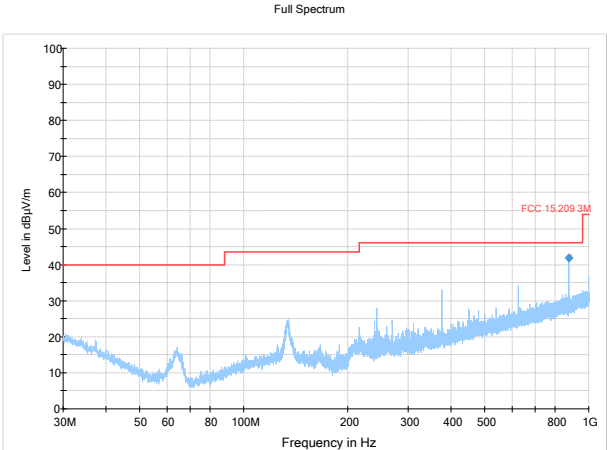


Figure 8.3.16: Radiated spurious emissions, high channel, 30-1000MHz, ant 0

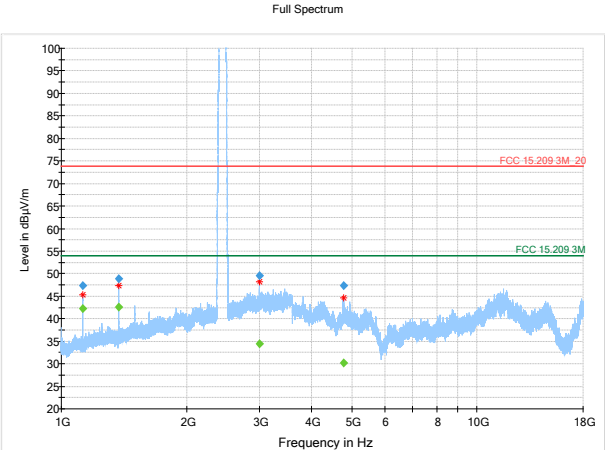


Figure 8.3.17: Radiated spurious emissions, high channel, 1-18GHz, ant 0

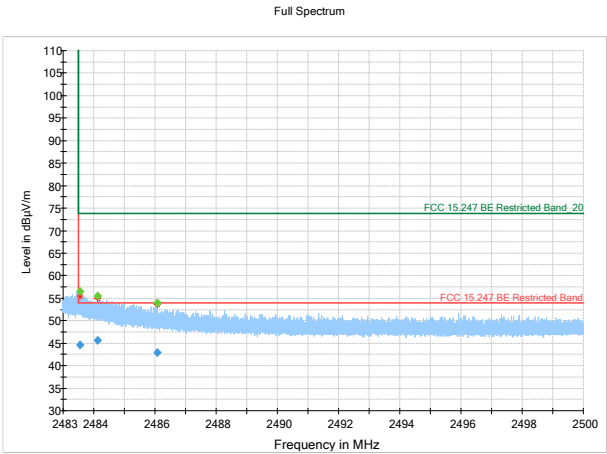


Figure 8.3.18: Radiated Bandedge in Restricted Band, high channel, ant 0

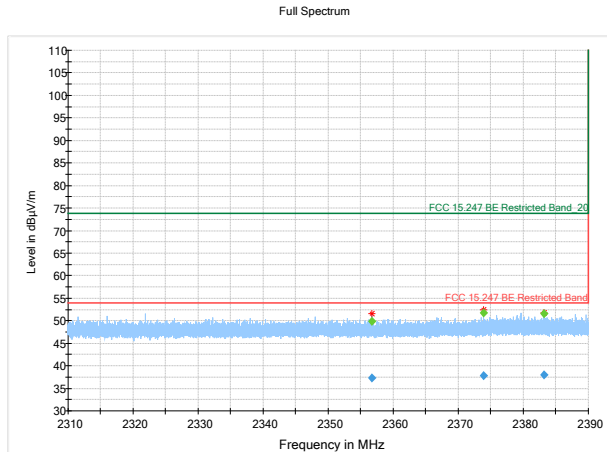


Figure 8.3.19: Radiated Bandedge in Restricted Band, low channel, ant 1

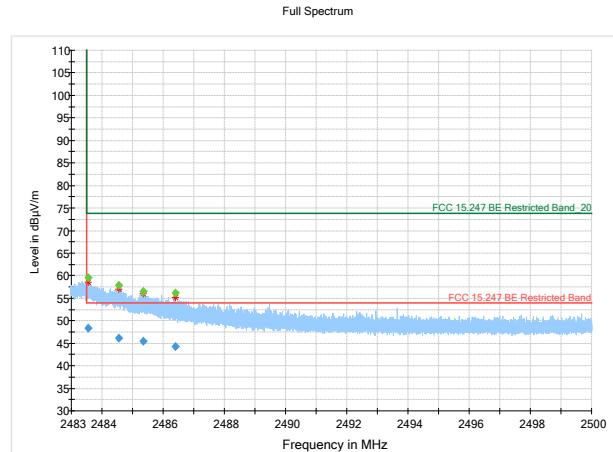


Figure 8.3.20: Radiated Bandedge in Restricted Band, high channel, ant 1

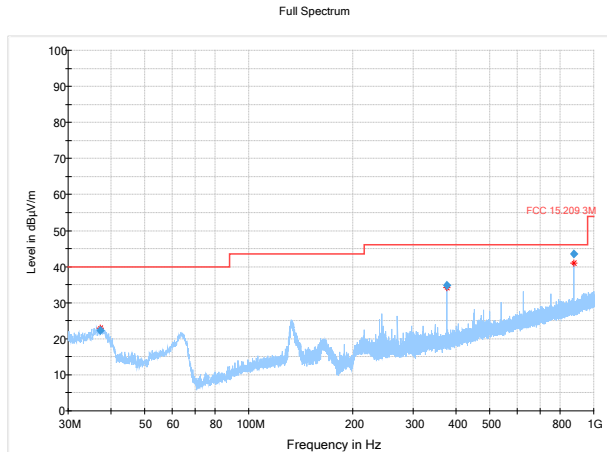


Figure 8.3.21: Radiated spurious emissions, RF4CE CH15 (2425MHz) ant 0, and BT GFSK 2480MHz, 30-1000MHz

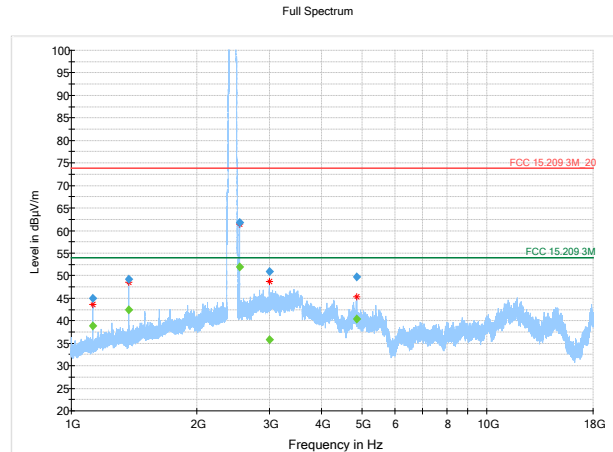


Figure 8.3.22: Radiated spurious emissions, RF4CE CH15 (2425MHz) ant 0, and BT GFSK 2480MHz, 1-18GHz

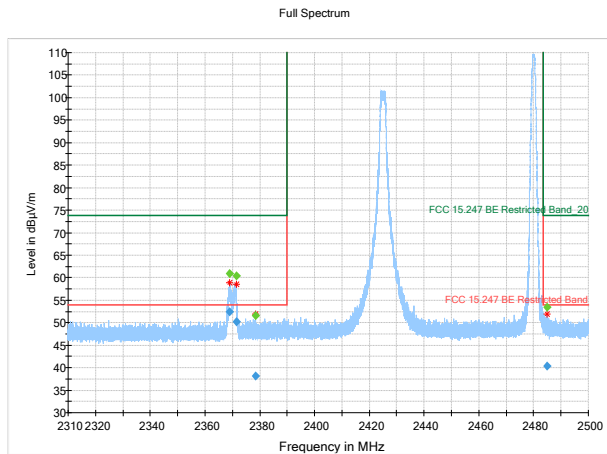


Figure 8.3.23: Radiated Bandedge in Restricted Band, RF4CE CH15 (2425MHz) ant 0, and BT GFSK 2480MHz,

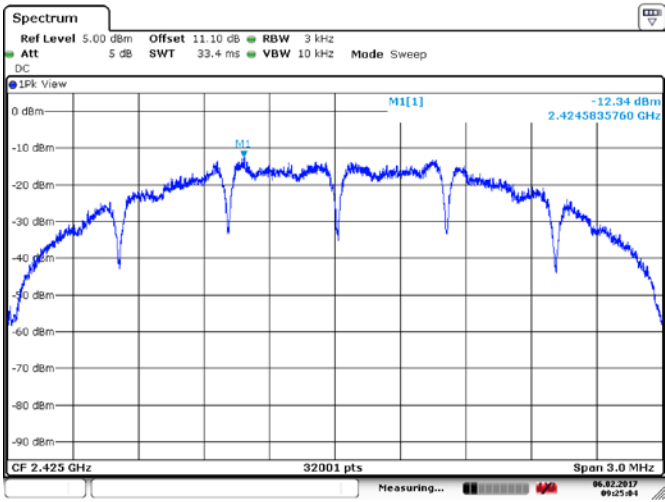


Figure 8.4-1: PSD, Low CH, ant o

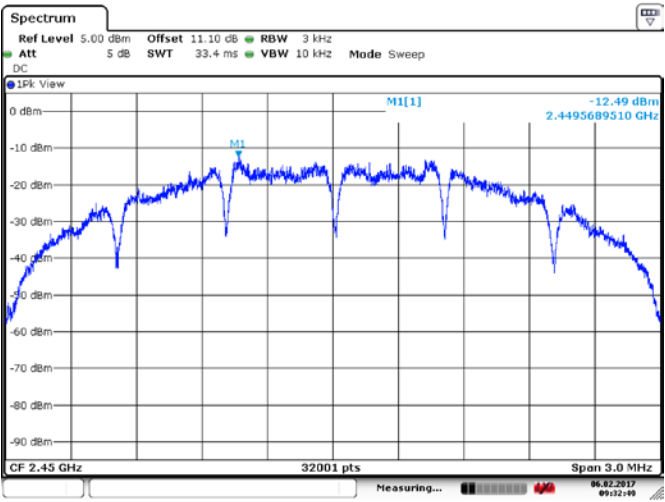


Figure 8.4-2: PSD, Mid CH, ant o

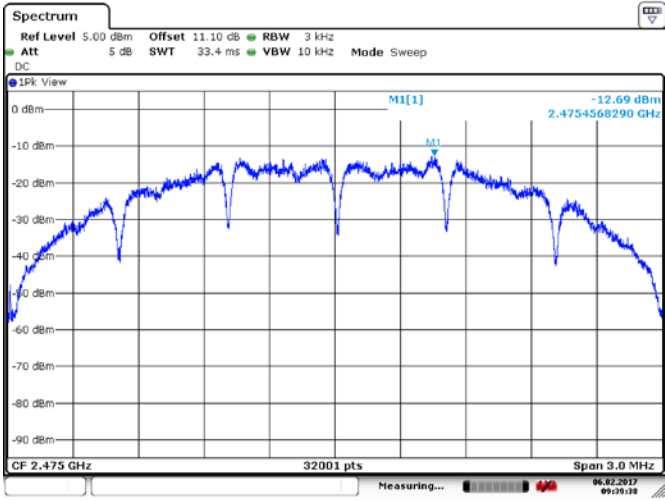


Figure 8.4-3: PSD, High CH, ant o

8.5 FCC 15.207(a) AC power line conducted emissions limits

Except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 MHz, shall not exceed the limits in the following table, as measured using a 50 μ H/50 Ω line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.

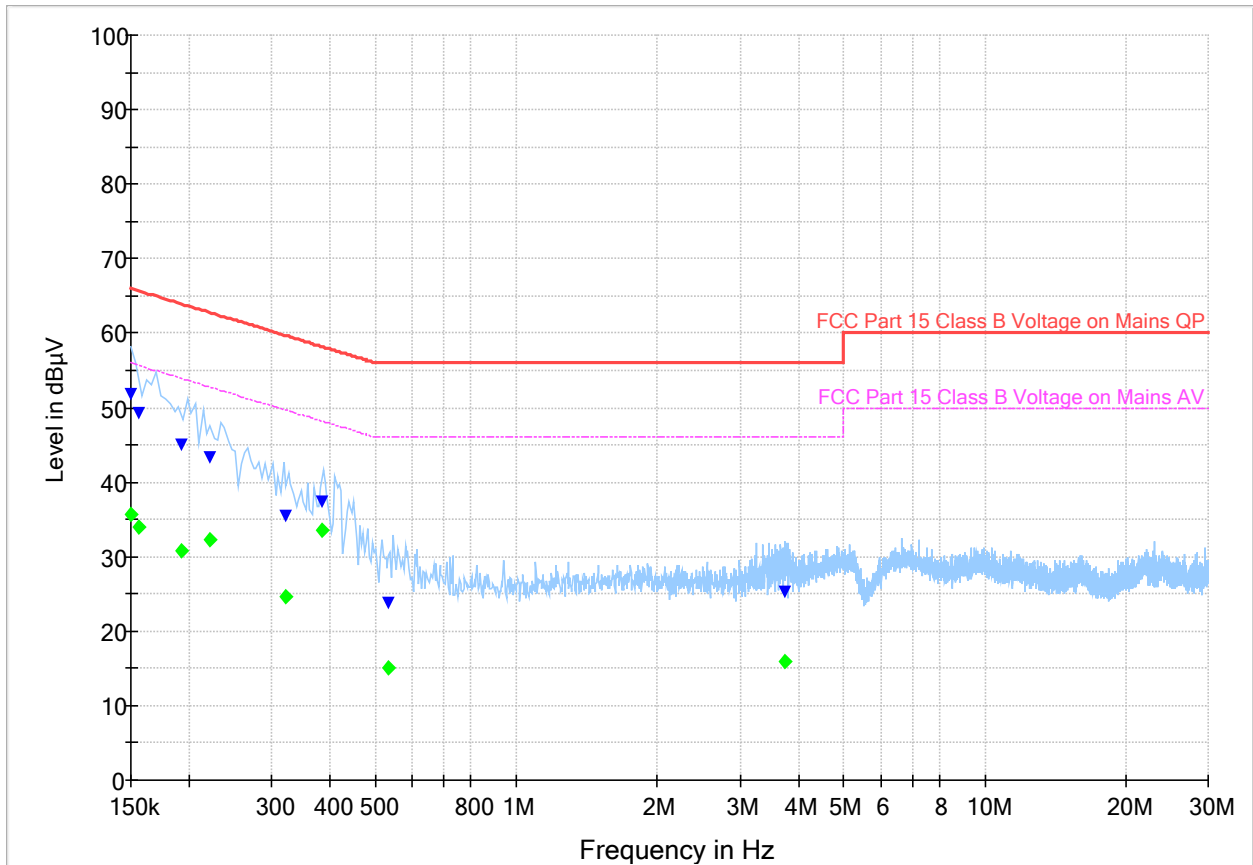

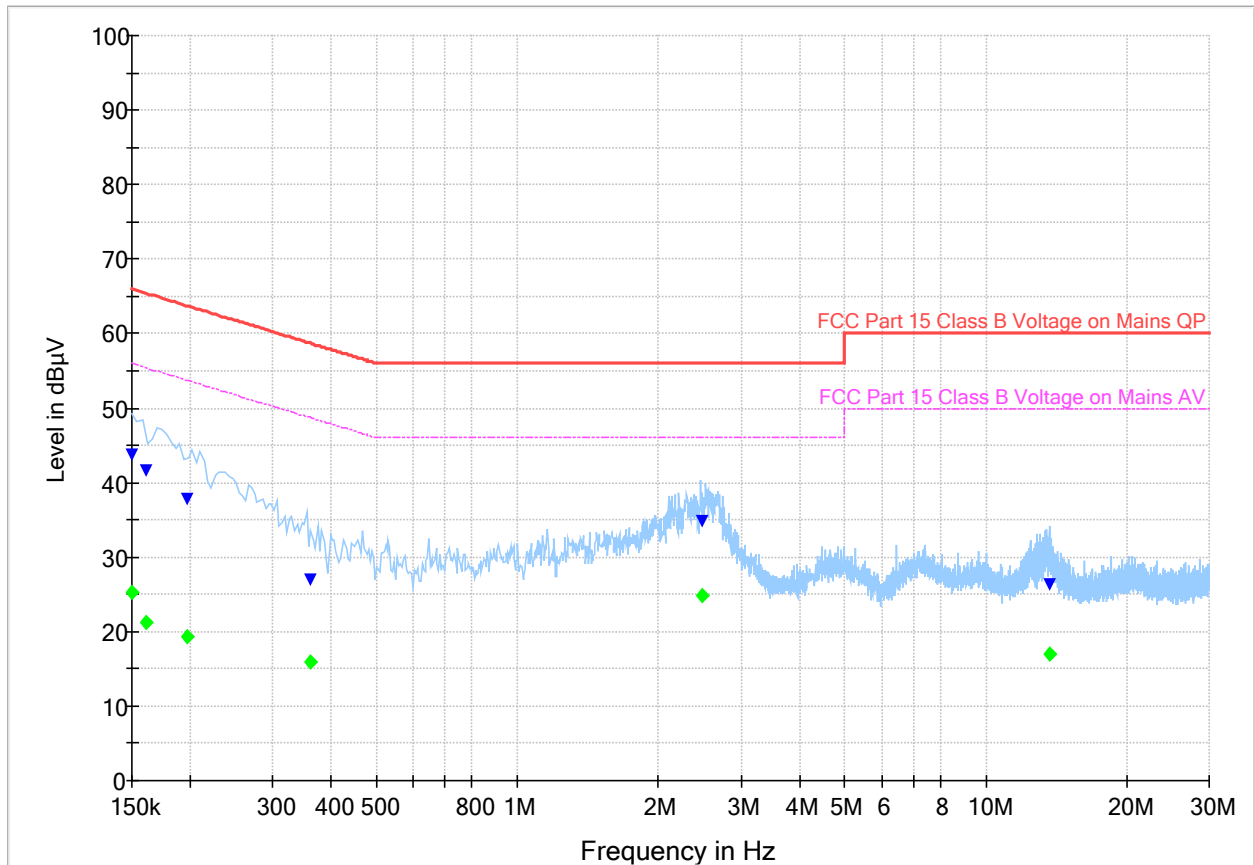


Plot 8.6-1: Conducted emissions RF4CE CH15, ant 0 with RX Diversity ON, ACBEL Supply

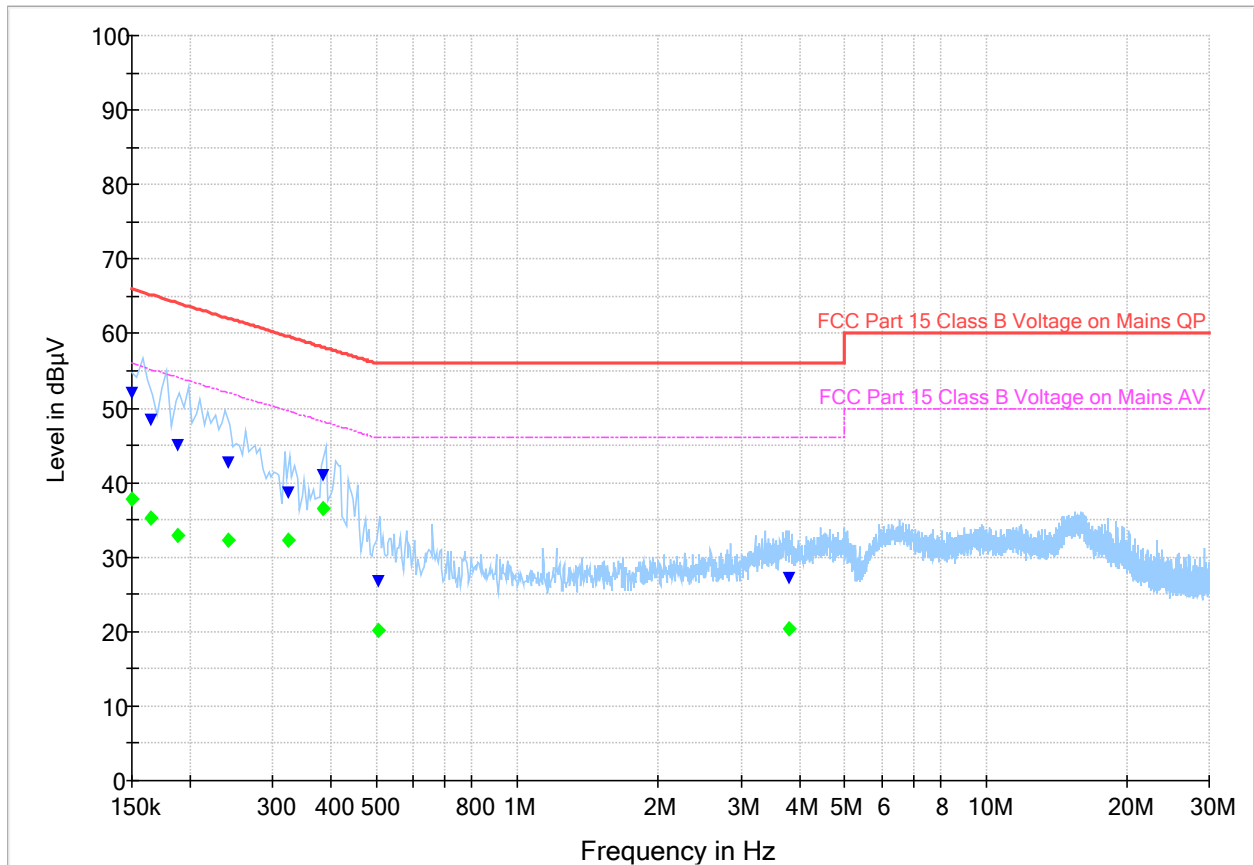


Plot 8.5-2: Conducted emissions, RF4CE CH25, ant o with RX Diversity ON, Delta Supply

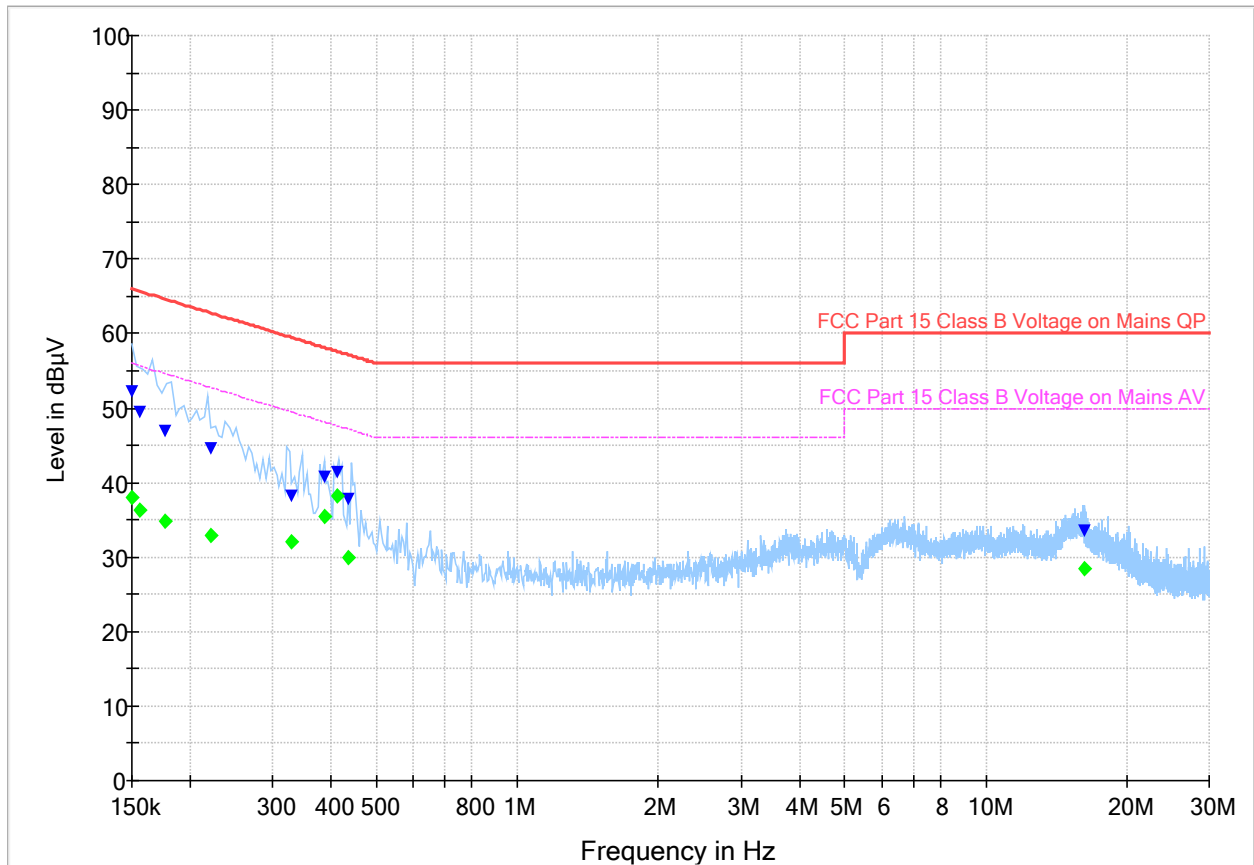

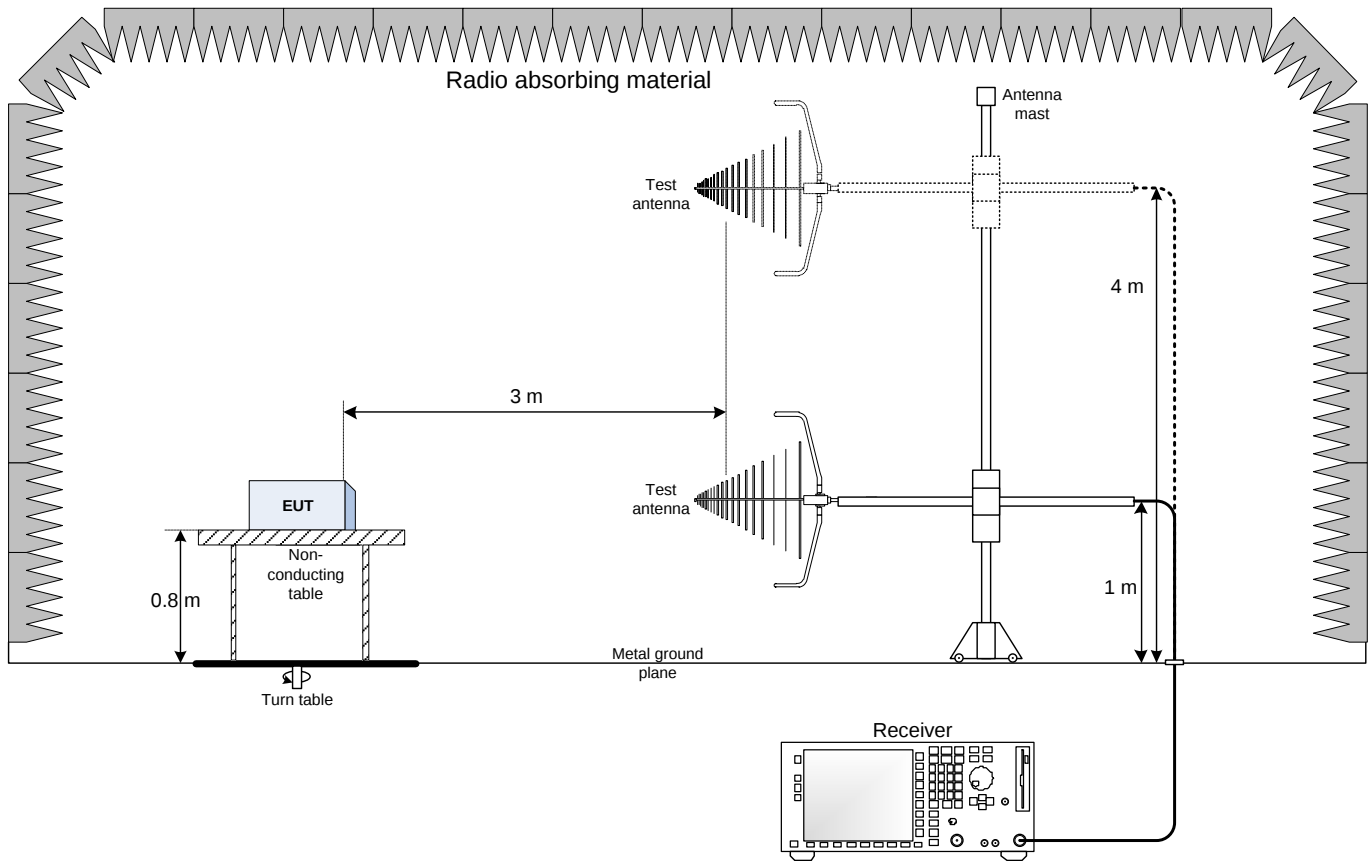
Plot 8.5-4: Conducted emissions, RF4CE CH15 ant o with RX Diversity ON, BTLE 2480MHz, ACBEL Supply

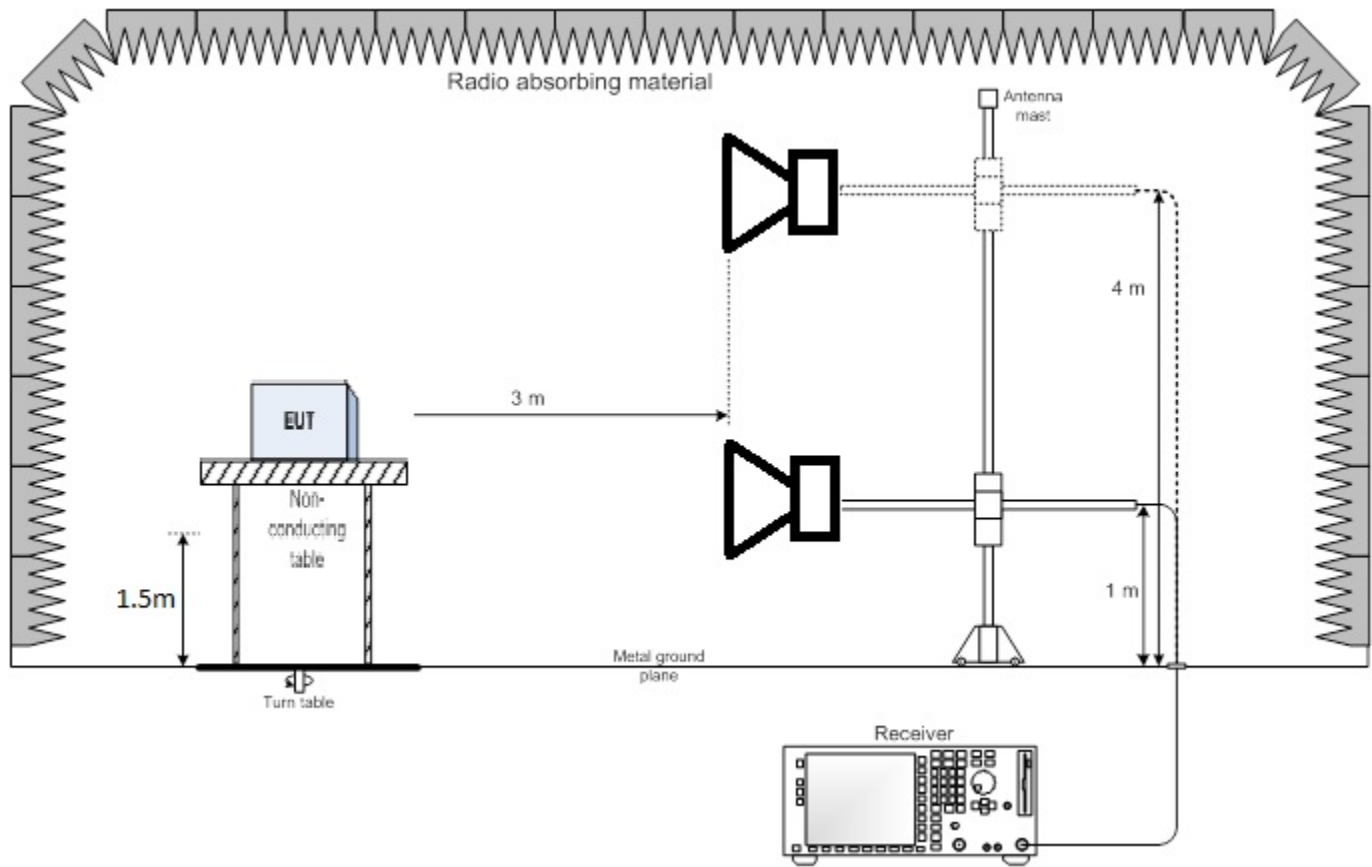
