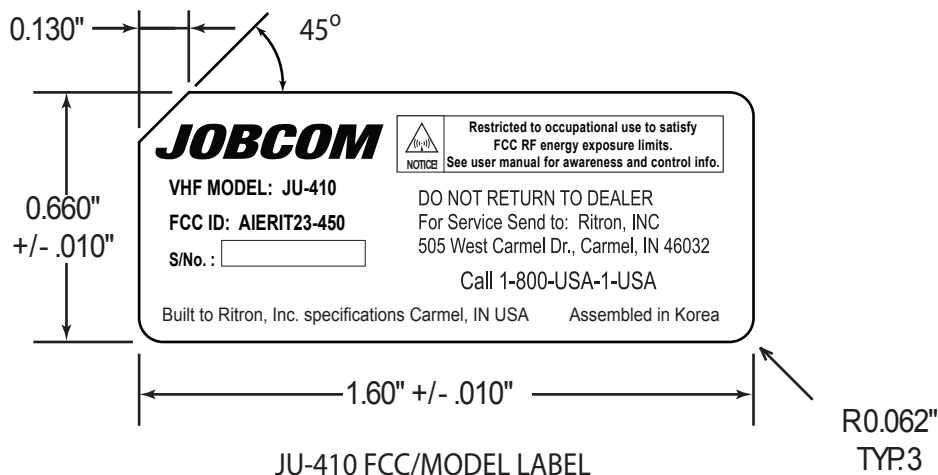

Silver characters, Arial, 4.5pt bold...except S/No., which is same, but 3.5pt font.
- "Restricted to occupational use.....control info."**
Silver characters, Arial, 3 point, center align within box outline area.
- "Built to Ritron, Inc. specification - Carmel, IN USA"**
Silver characters, Arial, 3.5 point, left align below JOB COM logo.
- "Assembled in Korea"** Silver characters, Arial, 3.5 point, right align below restricted box outline.
- "DO NOT RETURN...Carmel, IN 46032"**
Silver characteres, Arial, 3.5 point, left-justified, centered below restricted use box.
- "Call 1-800-USA-1-USA"**
Silver characters, Arial, 4 point font bold, centered below restricted use box.

MATERIAL SPECIFICATIONS:

- MATERIAL** - .010 thick clear Lexan film (#8B35) with velvet/matte finish.
- ADHESIVE** - Part to have .002 thick "tamper proof" destructive adhesive (Scotch #467 or Engineering approved equivalent) with an easy to remove liner.
- GRAPHICS** - To be sub-surface printed on the matte side per Ritron art work definition (see type specifications above), registered to the part edge as shown in View A. Background color to be black.
- The area designated for the SERIAL NUMBER** will be silver, and is 0.55" x 0.10". Serial number characters are black, 8 point size. Serial number to be centered within the silver area.
- The box outline area for the FCC RF Notice is 0.88" x 0.16", 0.20 pt. silver line. A vertical silver line, 0.20 pt., is located 0.13" from the left edge of the box to separate the NOTICE! symbol and the FCC RF warning text.
- NUMBER SERIALIZATION** to use hot stamp process on .0015" silver compucal material with bold black print.
- NOTICE! symbol** and **JOB COM** logo provided on stat sheet, silver graphics.

NOTES:

- Graphics to be registered to the edge of the label within +/- .010"
- The JOB COM logo graphic shown on this drawing is for reference only. Ritron to supply original artwork for JOB COM logo graphic.
- Number Serialization to start with J12345 with number incremented by one on each label.
- The FCC/Model label for the JU-410 will use the above materials/specifications or a RITRON approved equivalent.
- Vendor will supply photoproofs for RITRON Engineering approval prior to manufacturing production labels.
- No changes to label without RITRON engineering approval.
