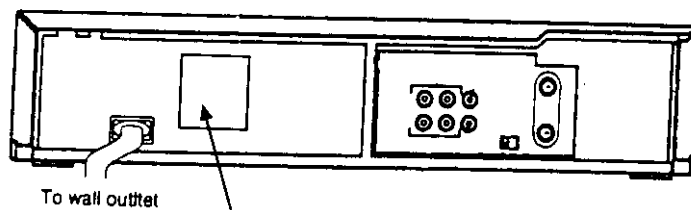


Drawing of FCC Id. Label
