3 Test Methodology

3.1. Mode of Operation

Decision of Test ATL has verified the construction and function in typical operation. All the test modes were carried out with the EUT in normal operation, which was shown in this test report and defined as:

Test Mode
Mode 1: TX Mode
Mode 2: Bluetooth LE TX Mode

Software used to control the EUT for staying in continuous transmitting mode was programmed.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz and power line conducted emissions below 30MHz, which worst case was in normal link mode only.

By preliminary testing and verifying three axis (X, Y and Z) position of EUT transmitted status, it was found that "X axis" position was the worst, then the final test was executed the worst condition and test data were recorded in this report.

Note: The EUT was programmed to be in continuously transmitting mode and the transmit duty cycle is not less than 98%.

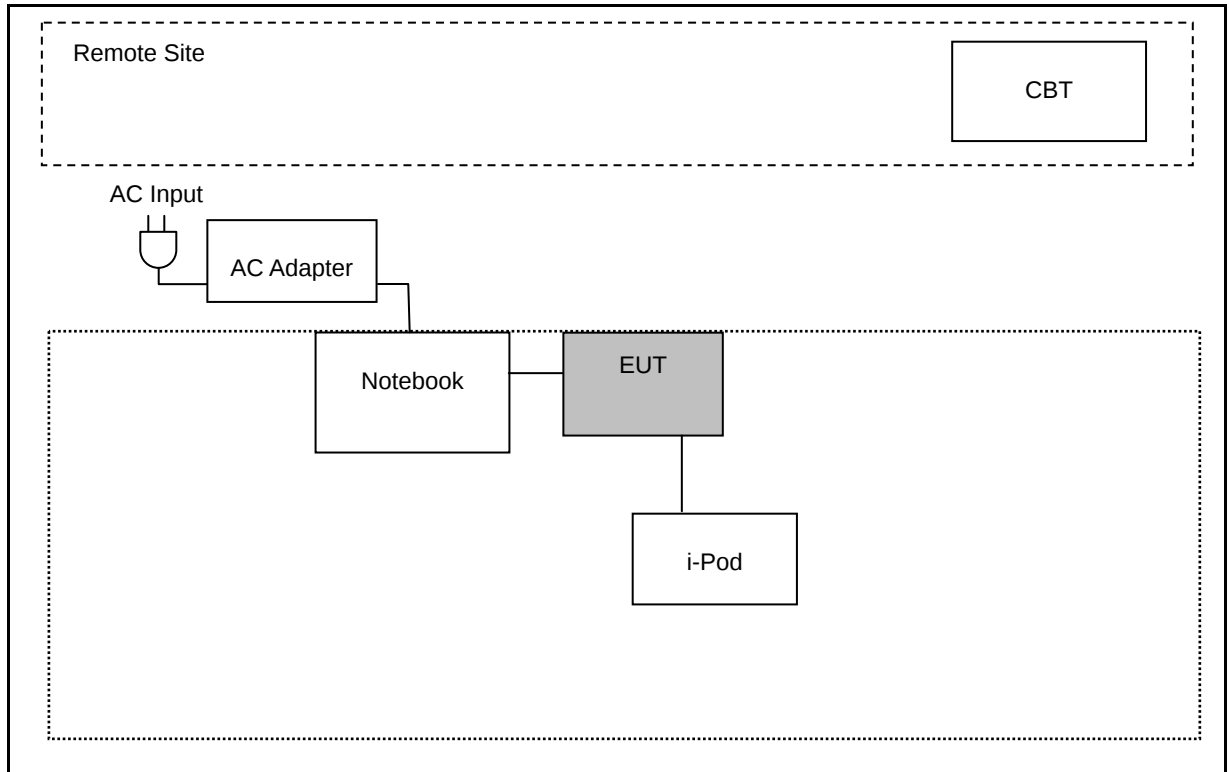

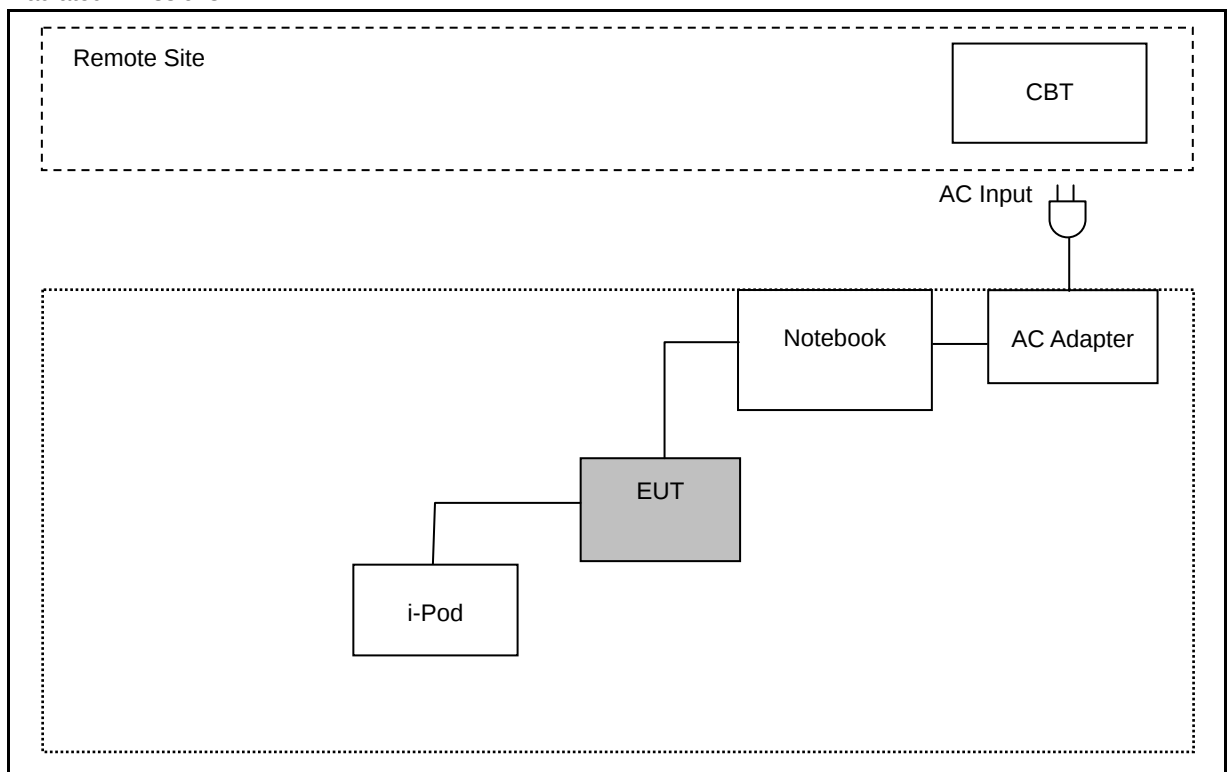

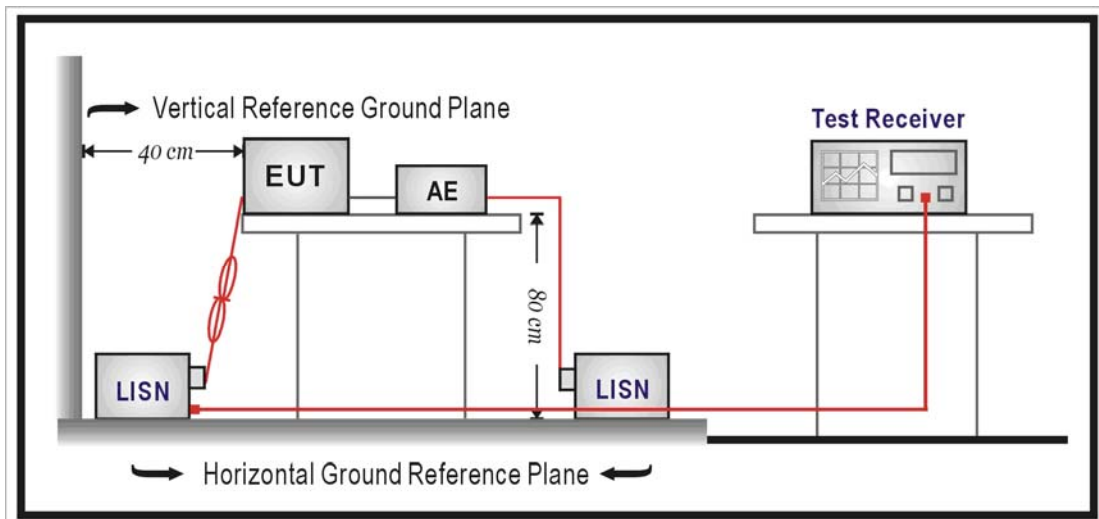

4.4. Test Procedure

The EUT and simulators are connected to the main power through a line impedance stabilization network (L.I.S.N.). This provides a 50 ohm /50uH coupling impedance for the measuring equipment. The peripheral devices are also connected to the main power through a LISN that provides a 50ohm/50uH coupling impedance with 50ohm termination.

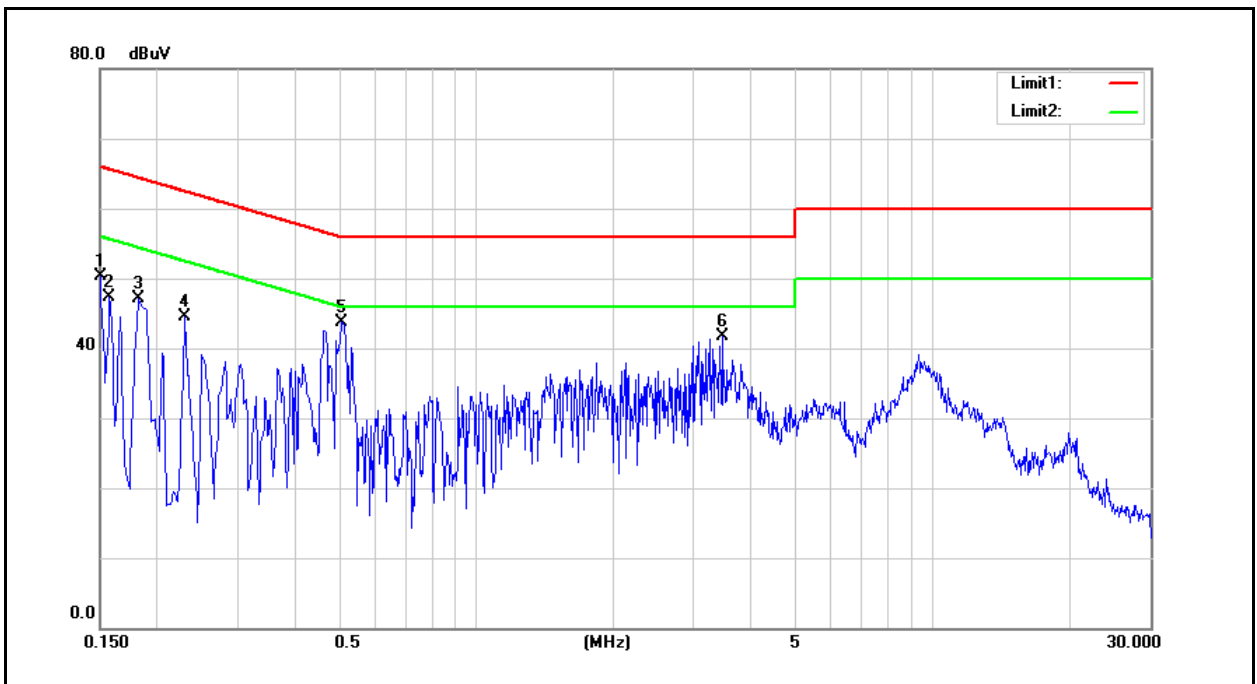
For A.C. mains conducted interference, measured both sides of A.C. lines and carried out using quasi-peak and average detector receivers of maximum conducted interference.

Conducted emissions were investigated over the frequency range from 0.15 MHz to 30 MHz using a receiver bandwidth of 9 kHz. The equipment under test (EUT) shall meet the limits in section 4.1, as applicable, including the average limit and the quasi-peak limit when using respectively, an average detector and quasi-peak detector measured in accordance with the methods described of related standard. The voltage limits shall be met. If the average limit is met when using a quasi-peak detector receiver, the EUT shall be deemed to meet both limits and measurement with the average detector receiver is unnecessary.

If the reading of the measuring receiver shows fluctuations close to the limit, the reading shall be observed for at least 15 s at each measurement frequency; the higher reading shall be recorded with the exception of any brief isolated high reading which shall be ignored.

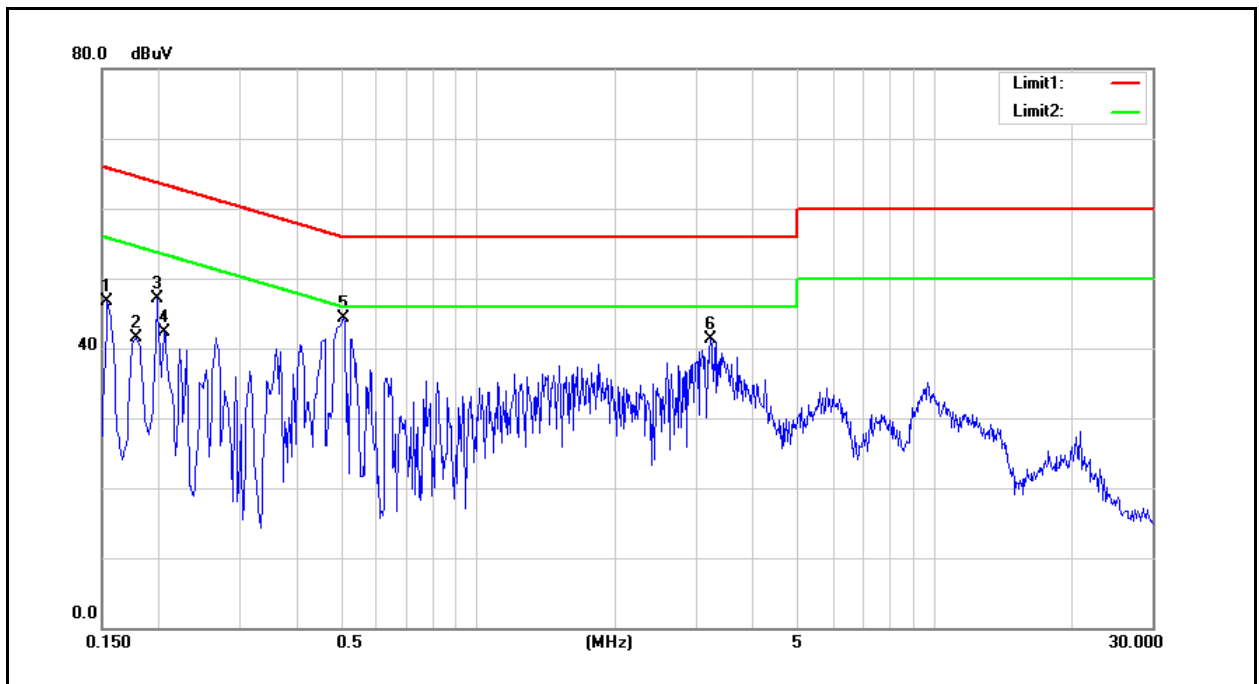

5 Radiated Emission Measurement

5.1. Limit

According to §15.209(a), except as provided elsewhere in this subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:

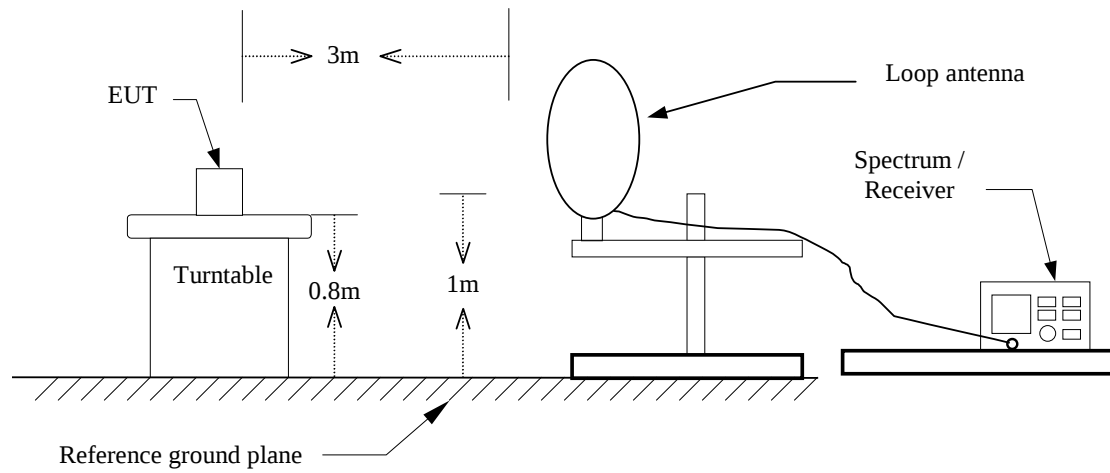

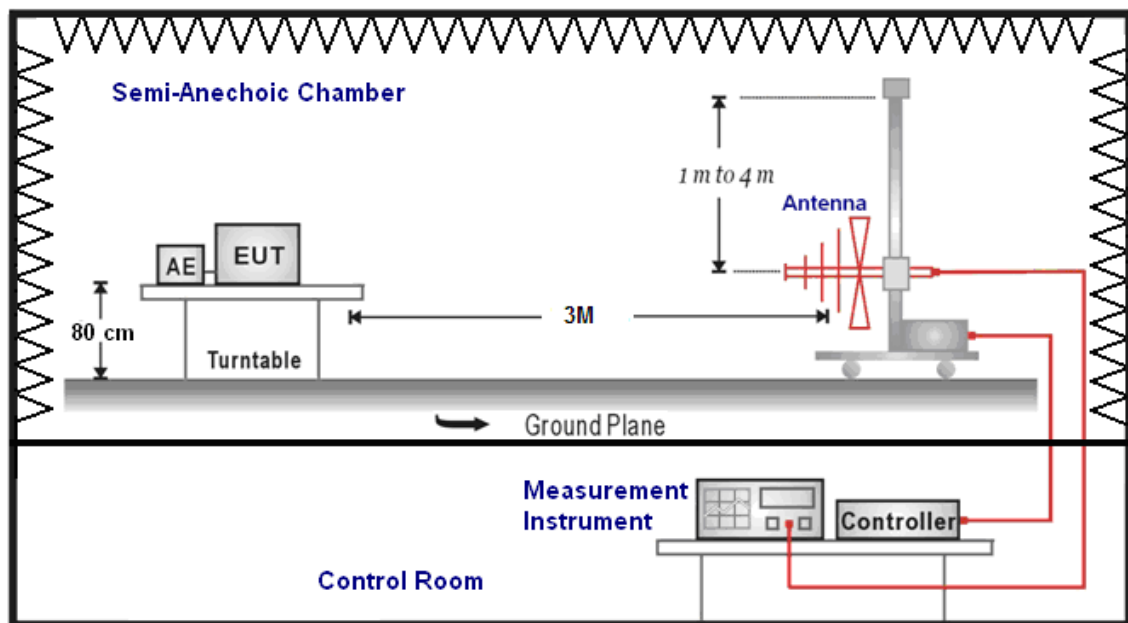

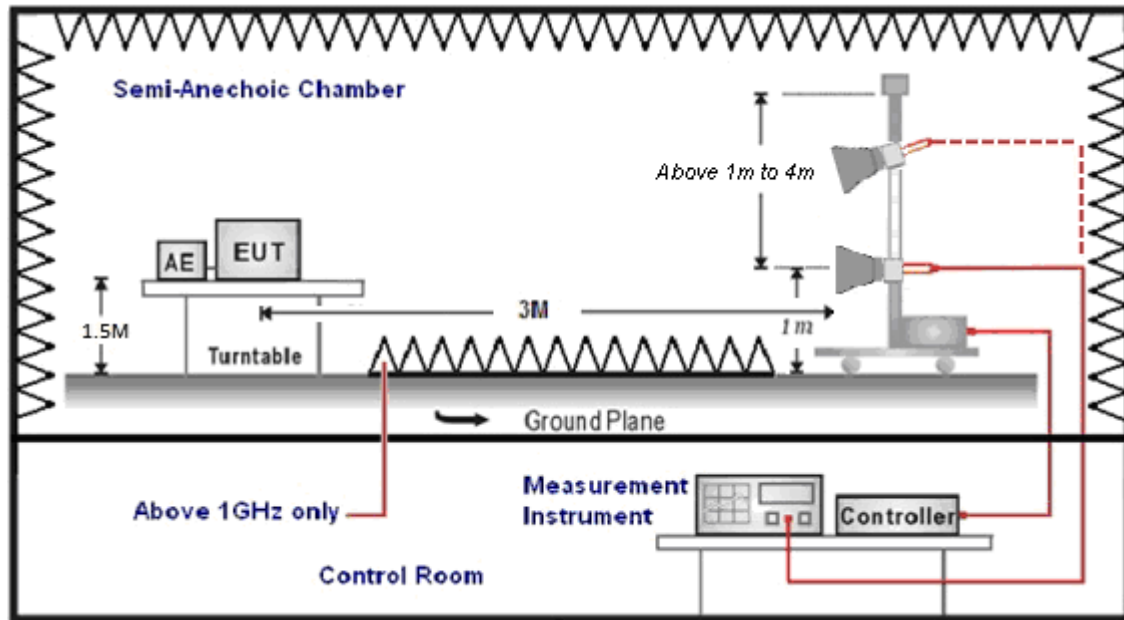
9kHz ~ 30MHz

5.4. Test Procedure

Final radiation measurements were made on a three-meter, Semi Anechoic Chamber. The EUT system was placed on a nonconductive turntable which is 0.8 or 1.5 meters height (below 1GHz use 0.8m turntable / above 1GHz use 1.5m turntable), top surface 1.0 x 1.5 meter. The spectrum was examined from 250 MHz to 2.5 GHz in order to cover the whole spectrum below 10th harmonic which could generate from the EUT. During the test, EUT was set to transmit continuously & Measurements spectrum range from 9 kHz to 26.5 GHz is investigated.

For measurements below 1 GHz the resolution bandwidth is set to 100 kHz for peak detection measurements or 120 kHz for quasi-peak detection measurements. Peak detection is used unless otherwise noted as quasi-peak.

For measurements above 1 GHz the resolution bandwidth is set to 1 MHz, and then the video bandwidth is set to 1 MHz for peak measurements and 10 Hz for average measurements when Duty cycle >98% / 1/T for average measurements when Duty cycle <98%. A nonconductive material surrounded the EUT to supporting the EUT for standing on three orthogonal planes. At each condition, the EUT was rotated 360 degrees, and the antenna was raised and lowered from one to four meters to find the maximum emission levels. Measurements were taken using both horizontal and vertical antenna polarization.

SCHWARZBECK MESS-ELEKTRONIK Biconilog Antenna (model VULB9163) at 3 Meter and the SCHWARZBECK Double Ridged Guide Antenna (model BBHA9120D&9170) was used in frequencies 1 – 26.5 GHz at a distance of 1 meter. All test results were extrapolated to equivalent signal at 3 meters utilizing an inverse linear distance extrapolation Factor (20dB/decade).

For testing above 1GHz, the emission level of the EUT in peak mode was 20dB lower than average limit (that means the emission level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.

Appropriate preamplifiers were used for improving sensitivity and precautions were taken to avoid overloading or desensitizing the spectrum analyzer. No post – detector video filters were used in the test.

The spectrum analyzer's 6 dB bandwidth was set to 1 MHz, and the analyzer was operated in the peak detection mode, for frequencies both below and up 1 GHz. The average levels were obtained by subtracting the duty cycle correction factor from the peak readings.

The following procedures were used to convert the emission levels measured in decibels referenced to 1 microvolt (dBuV) into field intensity in micro volts per meter (uV/m).

The actual field intensity in decibels referenced to 1 microvolt in to field intensity in micro volts per meter (dBuV/m).

The actual field intensity in referenced to 1 microvolt per meter (dBuV/m) is determined by algebraically adding the measured reading in dBuV, the antenna factor (dB), and cable loss (dB) and Subtracting the gain of preamplifier (dB) is auto calculate in spectrum analyzer.

(1) $\text{Amplitude (dBuV/m)} = \text{FI (dBuV)} + \text{AF (dBuV)} + \text{CL (dBuV)} - \text{Gain (dB)}$

FI= Reading of the field intensity.

AF= Antenna factor.

CL= Cable loss.

P.S Amplitude is auto calculate in spectrum analyzer.

(2) $\text{Actual Amplitude (dBuV/m)} = \text{Amplitude (dBuV)} - \text{Dis(dB)}$

The FCC specified emission limits were calculated according the EUT operating frequency and by following linear interpolation equations:

(a) For fundamental frequency : Transmitter Output < +30dBm

(b) For spurious frequency : Spurious emission limits = fundamental emission limit /10

Data of measurement within this frequency range without mark in the table above means the reading of emissions are attenuated more than 20dB below the permissible limits or the field strength is too small to be measured.

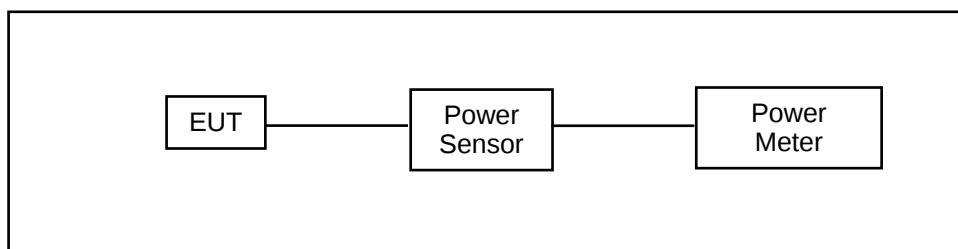

6.4. Test Procedure

The tests below are run with the EUT's transmitter set at high power in TX mode. The EUT is needed to force selection of output power level and channel number. While testing, EUT was set to transmit continuously. Remove the Subjective device's antenna and connect the RF output port to power sensor. The maximum peak output power shall not exceed 1 watt.

Use a direct connection between the antenna port of transmitter and the power sensor, for prevent the power sensor input attenuation 40-50 dB. Set the RBW Bandwidth of the emission or use a channel power meter mode.

For antennas with gains of 6 dBi or less, maximum allowed transmitter output is 1 watt (+30 dBm). For antennas with gains greater than 6 dBi, transmitter output level must be decreased by an amount equal to (GAIN - 6)/3 dBm.

The antenna port of the EUT was connected to the input of a power sensor. Power was read directly and cable loss correction was added to the reading to obtain power at the EUT antenna terminals.

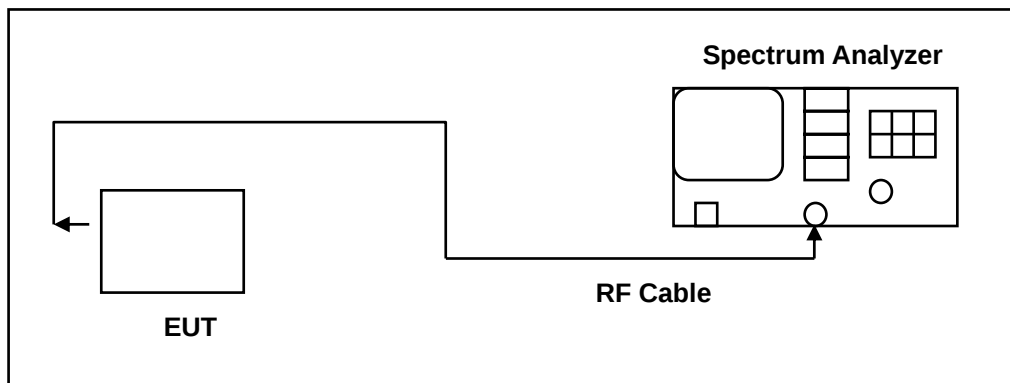

6dB RF Bandwidth: The antenna port of the EUT was connected to the input of a spectrum analyzer. Analyzer RBW was set to 100 kHz. For each RF output channel investigated, the spectrum analyzer center frequency was set to the channel carrier. A peak output reading was taken, a DISPLAY line was drawn 6 dB lower than peak level. The 6 dB bandwidth was determined from where the channel output spectrum intersected the display line.

4. Set the VBW $\geq 3 \times \text{RBW}$.
5. Detector = peak.
6. Sweep time = auto couple.
7. Trace mode = max hold.
8. Allow trace to fully stabilize.
9. Use the peak marker function to determine the maximum amplitude level within the RBW.
10. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

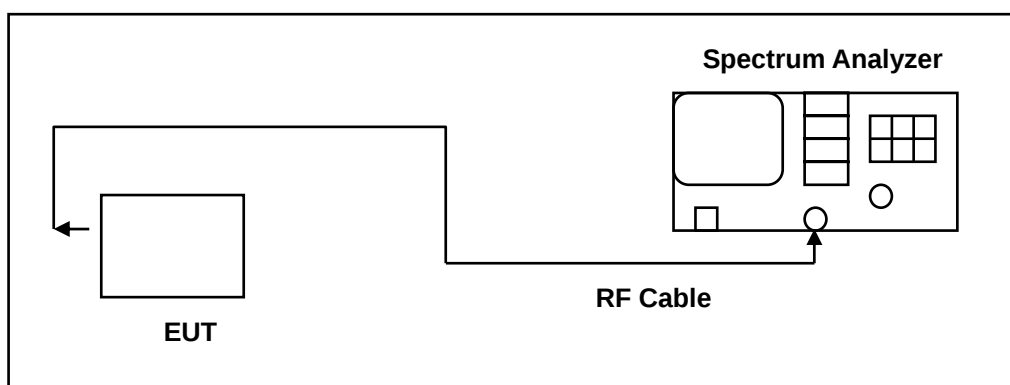

9.4. Test Procedure

In any 100 kHz bandwidth outside the EUT pass band, the RF power produced by the modulation products of the spreading sequence, the information sequence, and the carrier frequency shall be at least 20 dB below that of the maximum in-band 100 kHz emission, antenna output of the EUT was coupled directly to spectrum analyzer; if an external attenuator and/or cable was used, these losses are compensated for with the analyzer OFFSET function.

All other types of emissions from the EUT shall meet the general limits for radiated frequencies outside the pass band.

The test was performed at 3 channels.

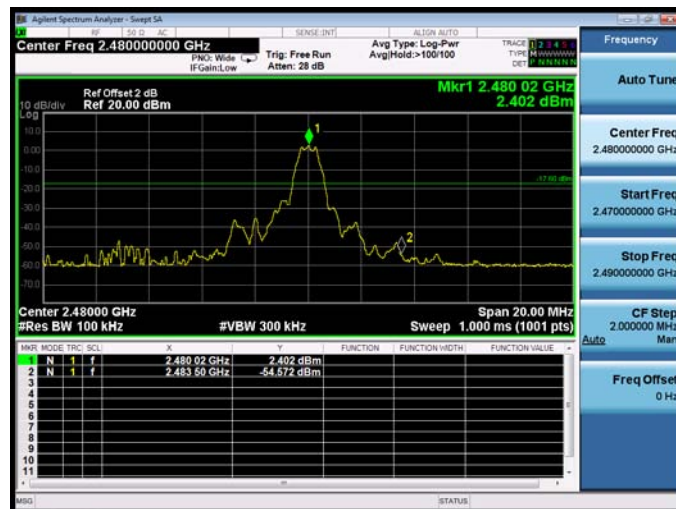
Conducted Band Edge

10 Antenna Measurement

10.1.Limit

For intentional device, according to 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

And According to 15.247 (b), if transmitting antennas of directional gain greater than 6 dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

10.2.Antenna Connector Construction

The antenna used in this product is PCB Antenna. And the maximum Gain of this antenna is 0 dBi.
