

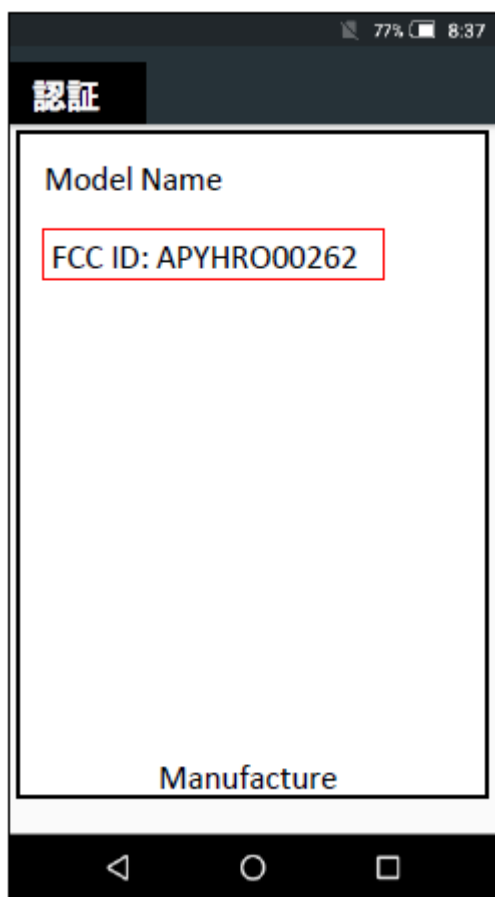
FCC E-Label Information

A. Information to be displayed

1. The information that will be displayed on the e-label and information that will remain in the user manual is shown below:

Information	on E-label	In Manual
FCC ID number	Yes	Yes
FCC logo	No	No
15.19 statement ("This device complies with part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.") B. Access to the required information on the e-label

1. Users must be able to access the information without requiring special access codes or permissions and, in all cases the information must be accessible in no more than three steps in a device's menu.	The actual steps are: To access the e-label information, in the device, Choose: Settings > All setting menu→ System No special access codes or permissions are required to go through the above steps beyond entering a user-defined password to protect against unauthorized access to the device.
2. Devices must not require special accessories or supplemental plug-ins (<i>e.g.</i> , the installation of a SIM/USIM card) to access the information.	Devices do not require special accessories or supplemental plug-ins to access the information.
3. Users must be provided specific instructions on how to access the information. The instructions must be included in the User's manual, operating instructions, insert in the packaging materials, or other similar means. ⁷ Alternately, the access information may be available on the product related website with instructions on how to access the website provided in the packaging material.	The information to the user is provided in the user manual.
4. The equipment authorization application for the device must clearly include the instructions for accessing information as part of the exhibit showing the label information.	Yes, it is included.

C. Labeling for Importation and Purchasing

1. Products utilizing e-labels are required to have a physical label on the product at the time of importation, marketing and sales. For devices imported in bulk and not packaged individually, a removable adhesive label or, for devices in protective bags, a label on the bags is acceptable for this purpose. Any removable label shall be of a type intended to survive normal shipping and handling and must only be removed by the customer after purchase. For devices imported already in individual packages ready for sale, the information may alternatively be provided on the package. It shall contain: 1. The FCC ID and/or the DoC logo (if applicable); and 2. Any other information required by specific rule to be provided on the surface of the product unless such information is permitted to be included in the User's manual or other packaging inserts.	The FCC ID is printed on the package.

D. Other considerations

1. The above information must be programmed by the responsible party and the information must be secured in such a manner that third-parties cannot modify it.	The e-label information is pre-programmed by the grantee. The user cannot modify the e-label information.
2. All the applicable regulatory information required on the packaging or user instructions must be provided according to the rules even if it is displayed electronically. For example, hearing aid compatibility (HAC) ratings for the phones as specified in 47 C.F.R. § 20.19.	Yes it is provided.
