※ 15.247 Requirements for Bluetooth transmitter

▪ This Bluetooth module has been tested by a Bluetooth Qualification Lab, and we confirm the following:

- 1) This system is hopping pseudo-randomly.
- 2) Each frequency is used equally on the average by each transmitter.
- 3) The receiver input bandwidths that match the hopping channel bandwidths of their corresponding transmitters
- 4) The receiver shifts frequencies in synchronization with the transmitted signals.

▪ 15.247(g): The system, consisting of both the transmitter and the receiver, must be designed to comply with all of the regulations in this Section 15.247 should the transmitter be presented with a continuous data (or information) stream.

▪ 15.247(h): The coordination of frequency hopping systems in any other manner for the express purpose of avoiding the simultaneous occupancy of individual hopping frequencies by multiple transmitters is not permitted.

3. TEST METHODOLOGY

The measurement procedure described in the American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices (ANSI C63.10-2013) were used in the measurement of the **LG Electronics Inc. Radio Navigation FCC ID: BEJLANR14**

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements. According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2 of ANSI C63.10. (Version :2013) Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane below 1GHz. Above 1GHz with 1.5m using absorbers between the EUT and receive antenna. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3 m away from the receiving antenna, which varied from 1 m to 4 m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes according to the requirements in Section 8 of ANSI C63.10. (Version: 2013). To record the final measurements, the analyzer detector function was set to CISPR quasi-peak mode and the bandwidth of the spectrum analyzer was set to 120 kHz for frequencies below 1 GHz or 1 MHz for frequencies above 1 GHz. For average measurements above 1 GHz, the analyzer was set to peak detector with a reduced VBW setting(RBW = 1 MHz, VBW = 1/T Hz, where T = Pulse width).

3.4 DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition. Test program used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

Channel low, mid and high with highest data rate (worst case) is chosen for full testing.

4. INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipments, which is traceable to recognized national standards.

5. FACILITIES AND ACCREDITATIONS

5.1 FACILITIES

The SAC(Semi-Anechoic Chamber) and conducted measurement facility used to collect the radiated data are located at the 74, Seoicheon-ro 578beon-gil, Majang-myeon, Icheon-si, Gyeonggi-do, Korea. The site is constructed in conformance with the requirements of ANSI C63.4. (Version :2014) and CISPR Publication 22. Detailed description of test facility was submitted to the Commission and accepted dated July 07, 2015 (Registration Number: 90661)

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of Linearly polarized antennas: tuned dipole, bi-conical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements. Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers. Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

6. ANTENNA REQUIREMENTS

According to FCC 47 CFR §15.203:

"An intentional radiator antenna shall be designed to ensure that no antenna other than that furnished by the responsible party can be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section."

* The antennas of this E.U.T are permanently attached.

*The E.U.T Complies with the requirement of §15.203

8. FCC PART 15.247 REQUIREMENTS

8.1 PEAK POWER

LIMIT

The maximum peak output power of the intentional radiator shall not exceed the following:

1. For frequency hopping systems operating in the 2400–2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725–5850 MHz band: 1 W. For all other frequency hopping systems in the 2400-2483.5 MHz band: 0.125 W.
2. The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi.

TEST PROCEDURE

The transmitter output is connected to the Spectrum Analyzer. The Spectrum Analyzer is set to the peak detector mode. This test is performed with hopping off.

The Spectrum Analyzer is set to (7.8.5 in ANSI 63.10-2013)

- 1) Span: approximately 5 times the 20 dB bandwidth, centered on a hopping channel
- 2) RBW > the 20 dB bandwidth of the emission being measured
- 3) VBW ≥ RBW
- 4) Sweep = Auto
- 5) Detector = Peak
- 6) Trace = Max hold

SAMPLE CALCULATION

$$\begin{aligned}\text{Output Power} &= \text{Spectrum Reading Power} + \text{Power Splitter loss} + \text{Cable loss}(2 \text{ ea}) \\ &= 10 \text{ dBm} + 6 \text{ dB} + 1.5 \text{ dB} = 17.5 \text{ dBm}\end{aligned}$$

Note :

1. Spectrum reading values are not plot data. The power results in plot is already including the actual values of loss for the splitter and cable combination.
2. Spectrum offset = Power Splitter loss + Cable loss

3. We apply to the offset in the 2.4 GHz range that was rounded off to the closest tenth dB. Actual value of loss for the splitter and cable combination is 7 dB at 2402 MHz and is 7 dB at 2480 MHz.

So, 7 dB is offset. And the offset gap in the 2.4 GHz range do not affect the conducted peak power final result.

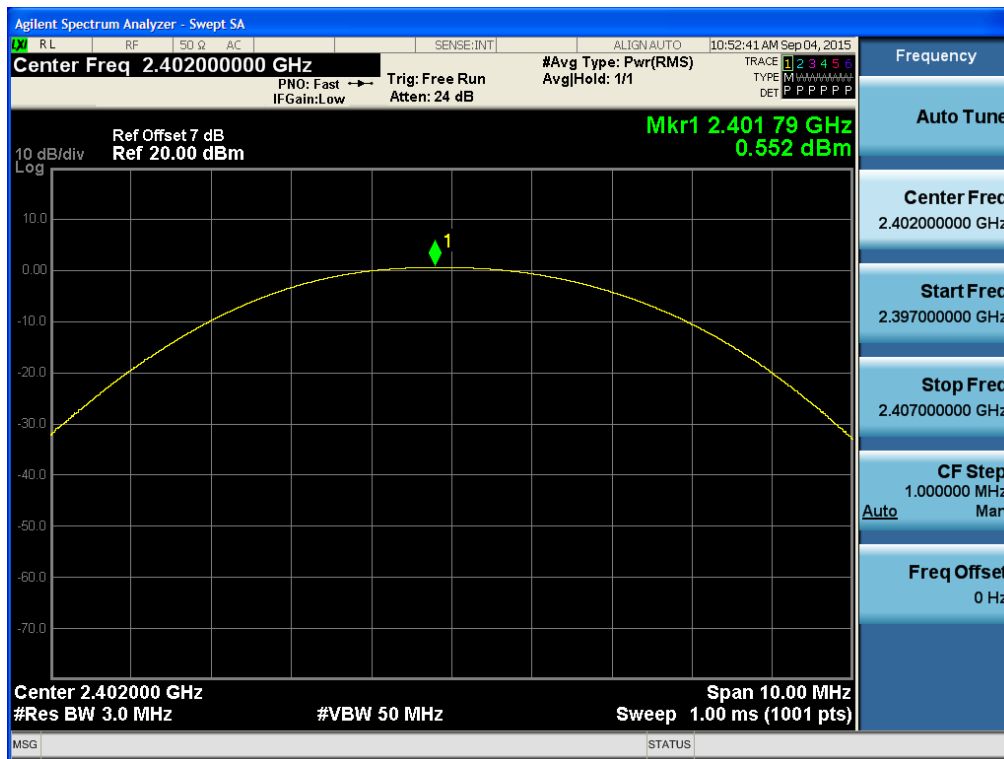

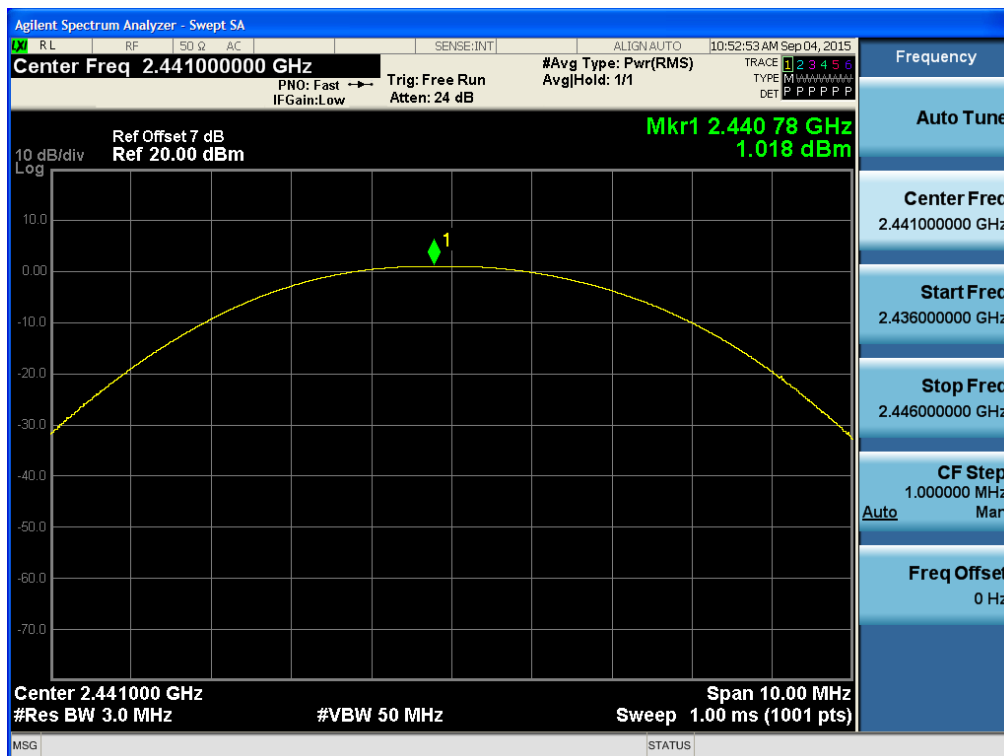

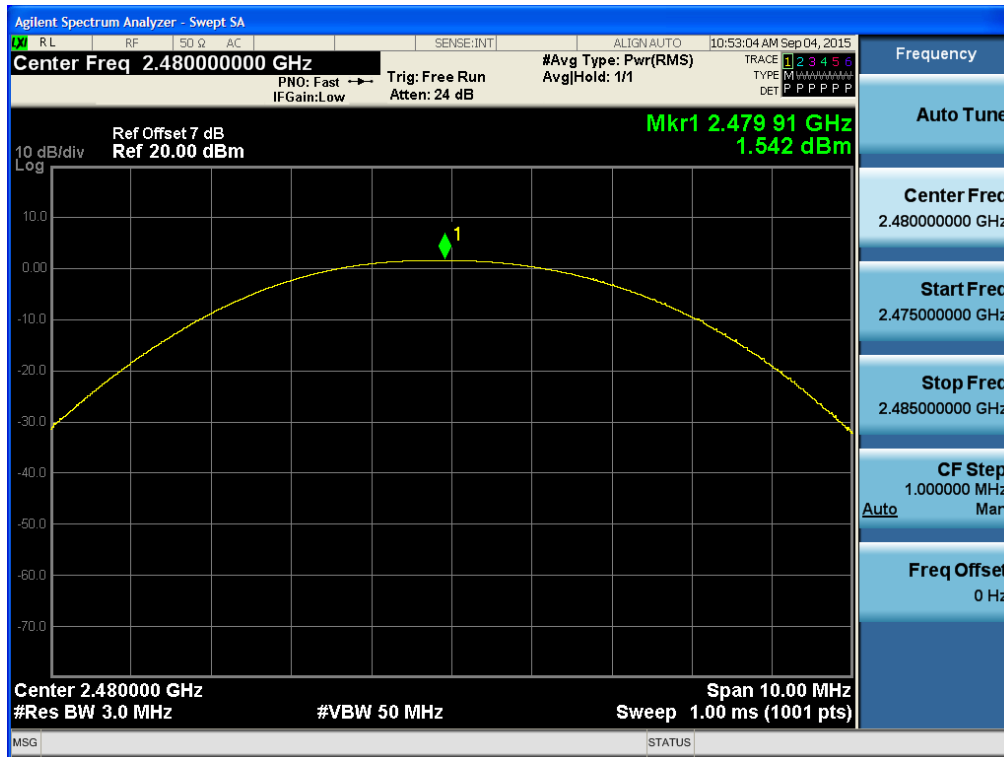

Peak Power (Low-CH)



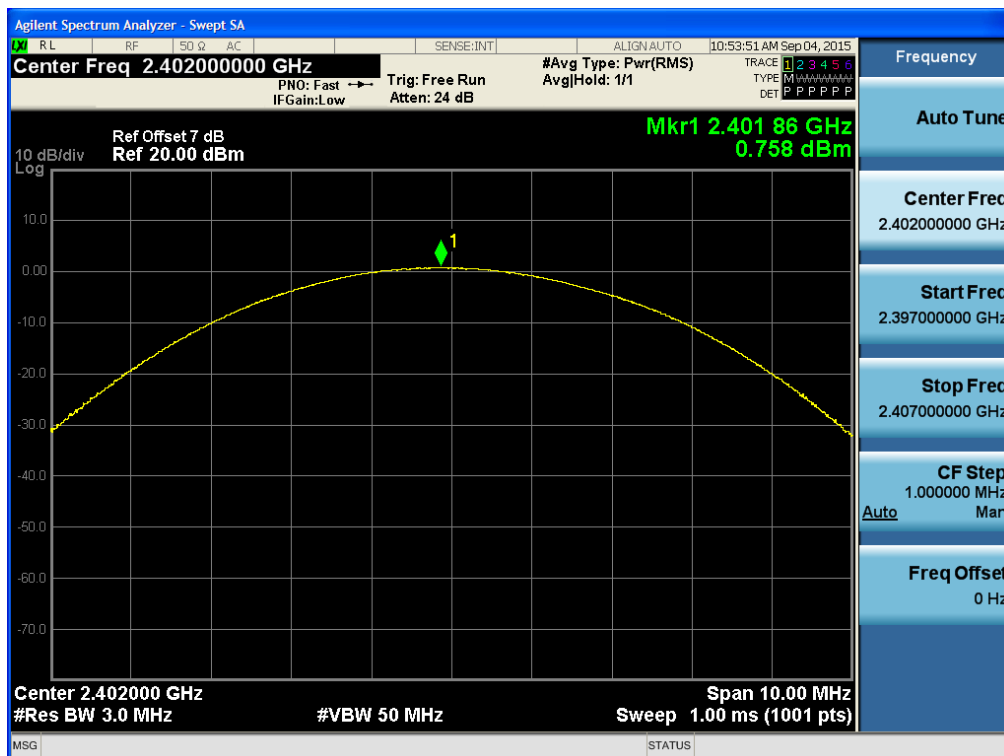
Test Plots (GFSK)
Peak Power (Mid-CH)



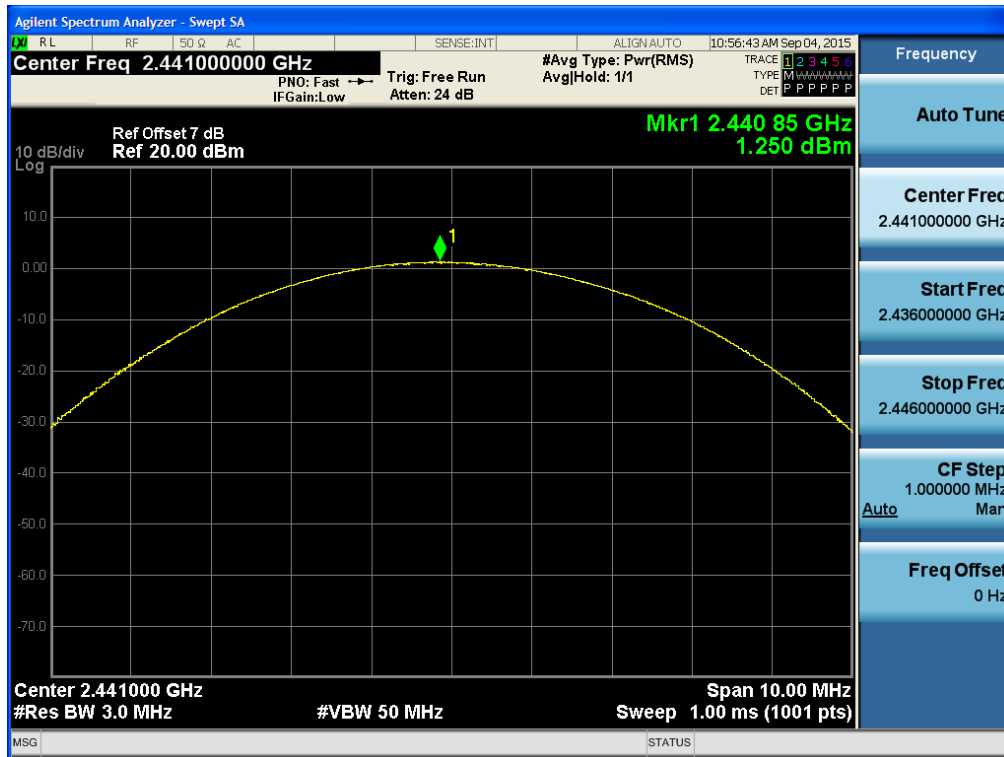

Peak Power (High-CH)



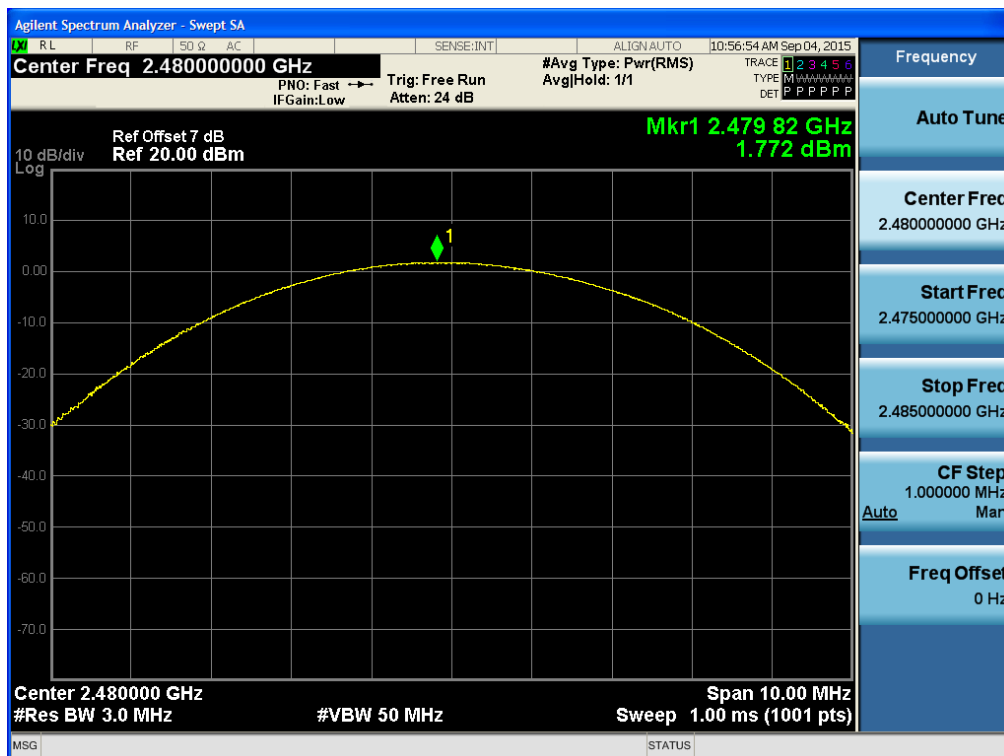

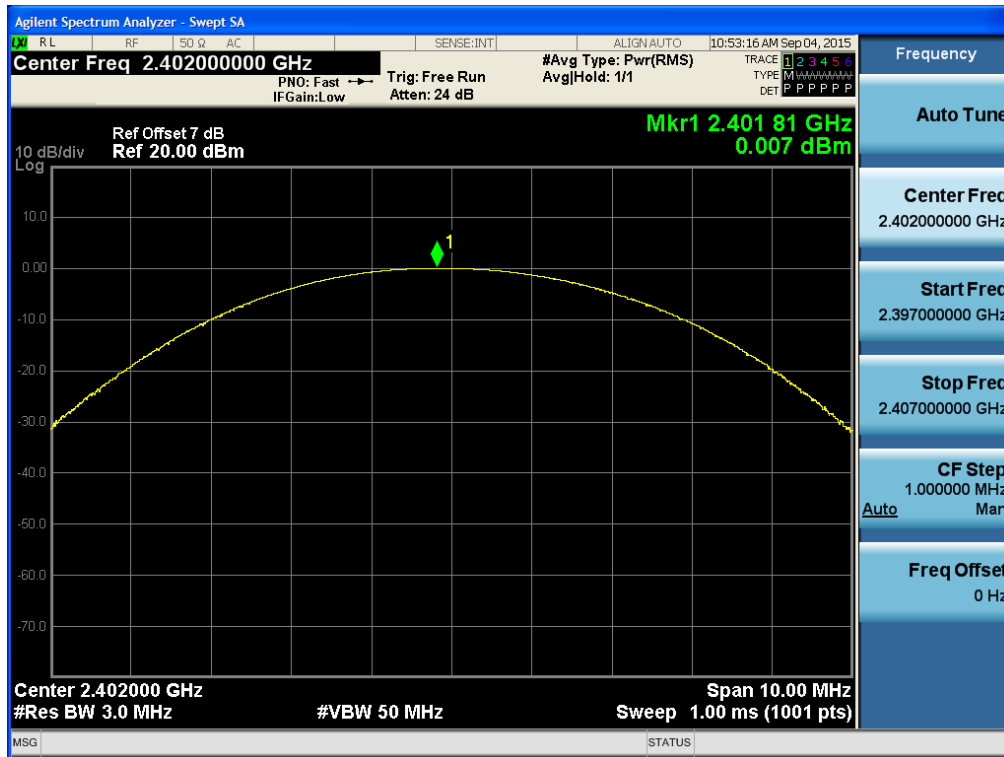

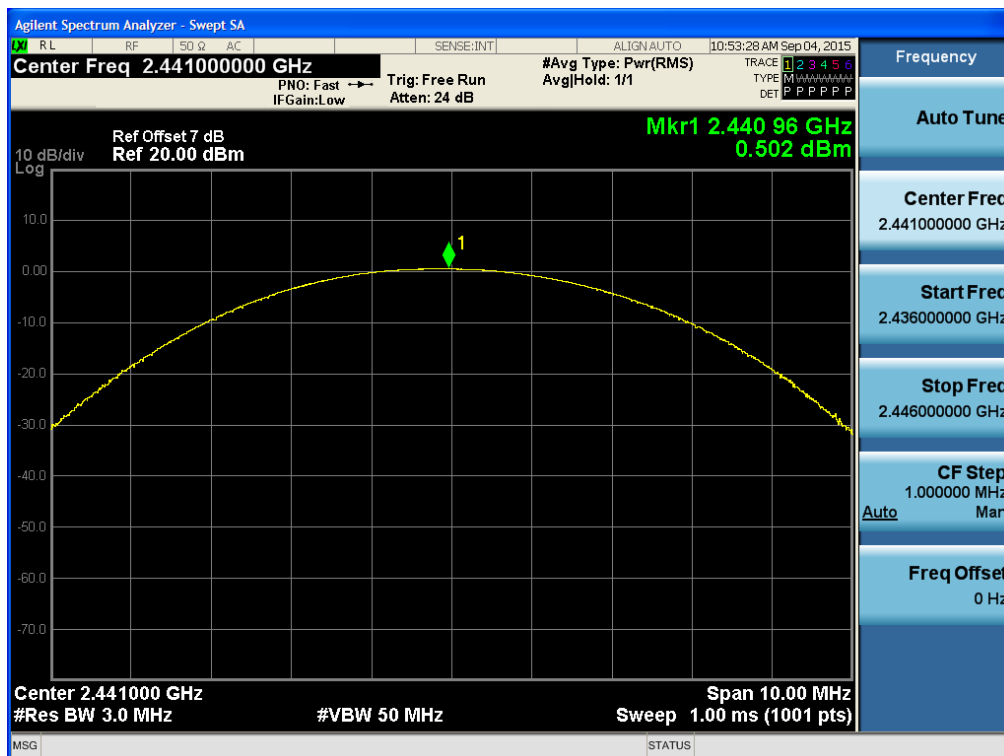

Peak Power (Low-CH)

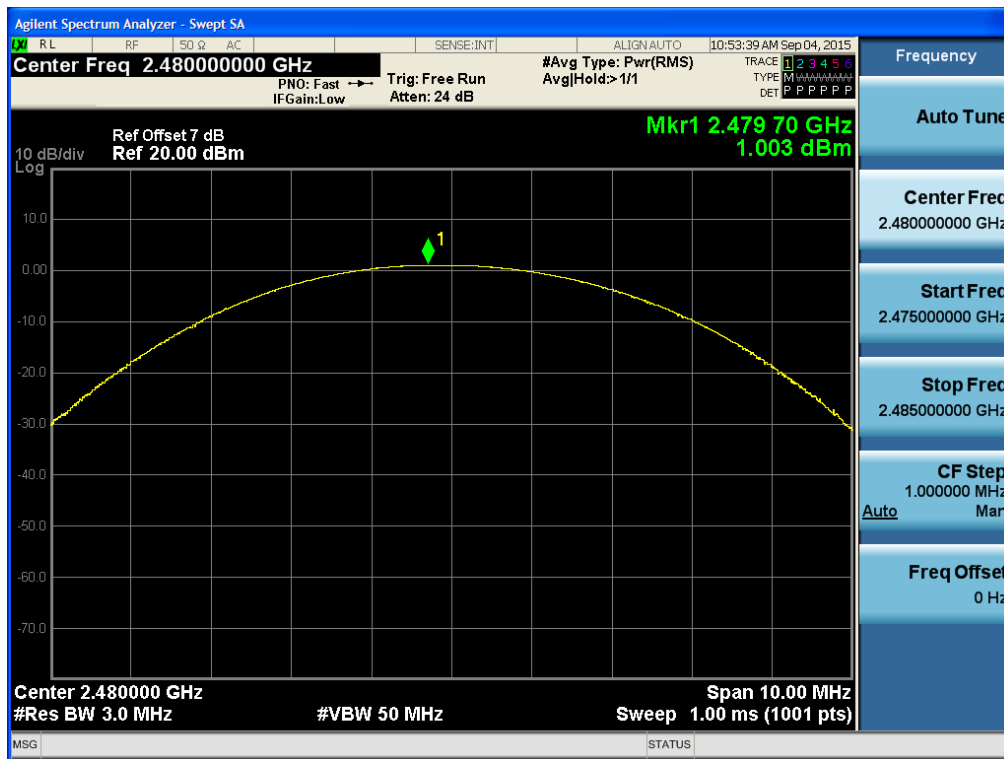


Test Plots ($\pi/4$ DQPSK)

Peak Power (High-CH)

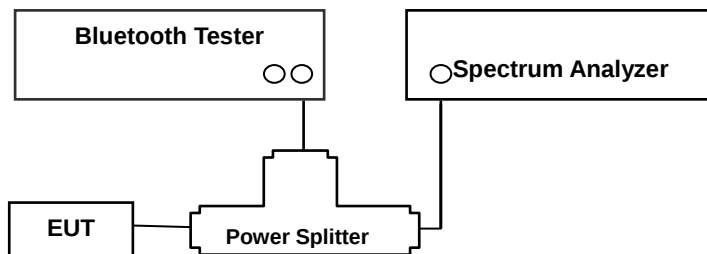


8.2 BAND EDGES

LIMIT

According to §15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits.

TEST PROCEDURE

This test is performed with hopping off and hopping on.

The Spectrum Analyzer is set to (6.10.4 in ANSI 63.10-2013)

- 1) Span: Wide enough to capture the peak level of the emission operating on the channel closest to the band edge, as well as any modulation products which fall outside of the authorized band of operation
- 2) Reference level: As required to keep the signal from exceeding the maximum instrument input mixer level for linear operation. In general, the peak of the spectral envelope shall be more than $[10 \log (OBW/RBW)]$ below the reference level.
- 3) Attenuation: Auto (at least 10 dB preferred).
- 4) Sweep time: Coupled.
- 5) RBW: 100 kHz
- 6) VBW: 300 kHz
- 7) Detector: Peak
- 8) Trace: Max hold

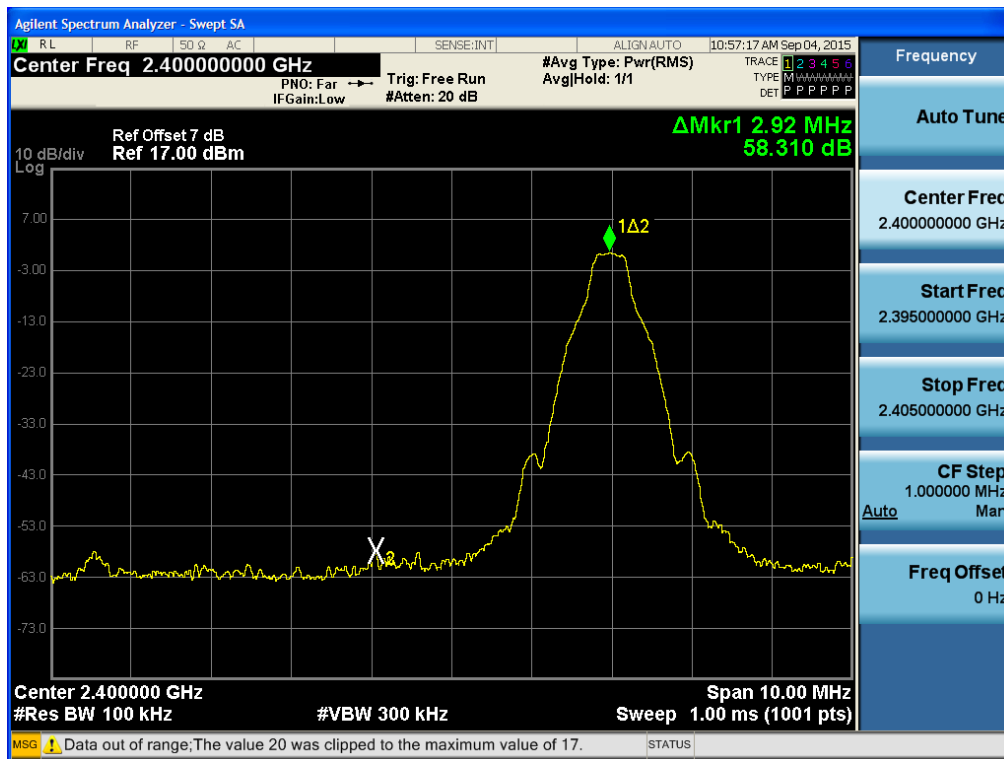

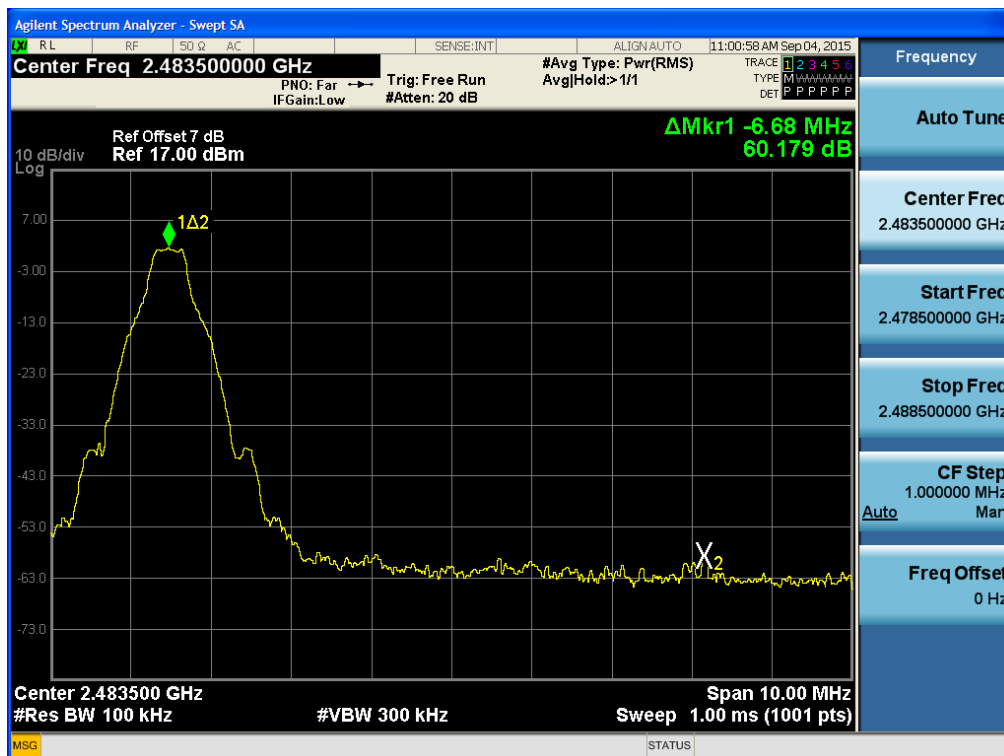

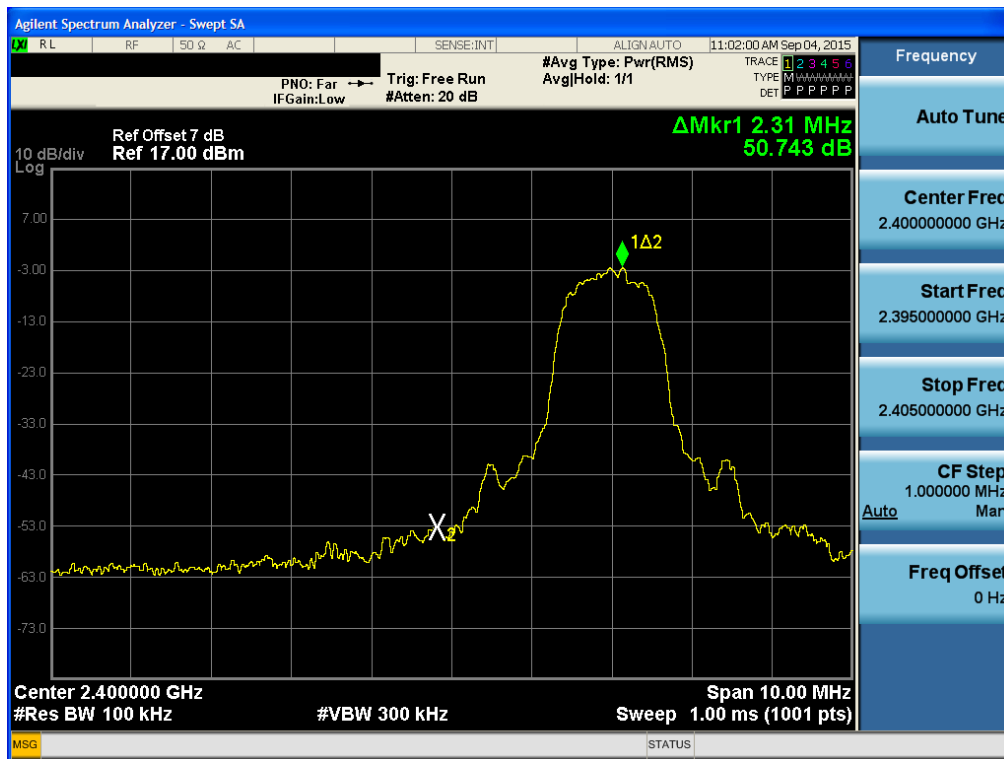

Band Edges (Low-CH)



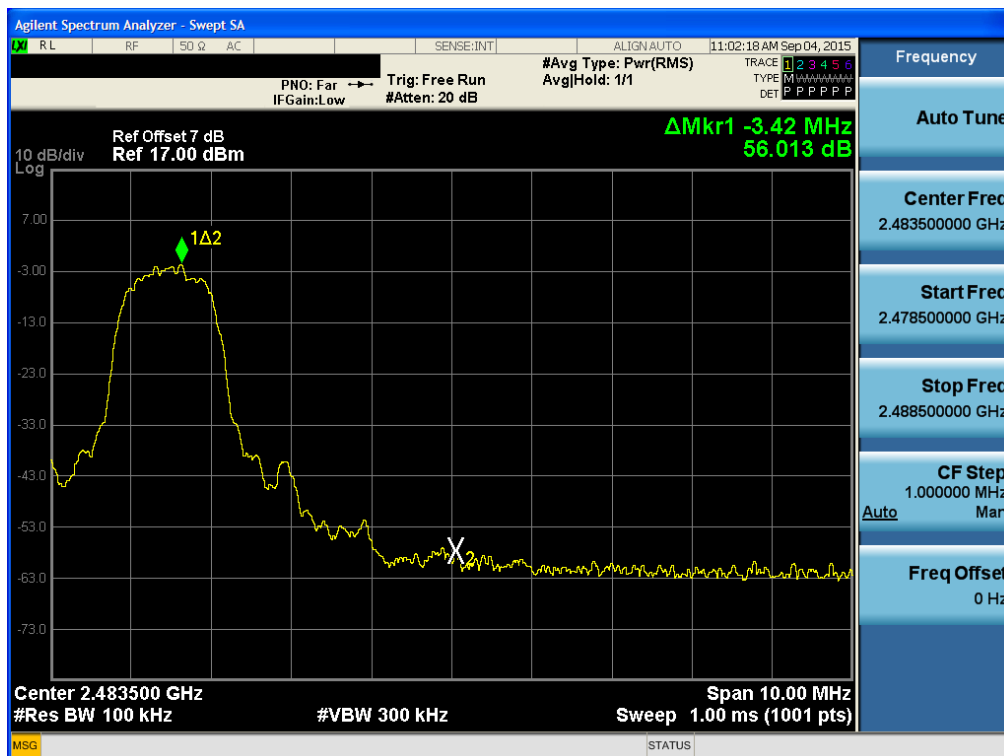
Test Plots without hopping (GFSK)
Band Edges (High-CH)



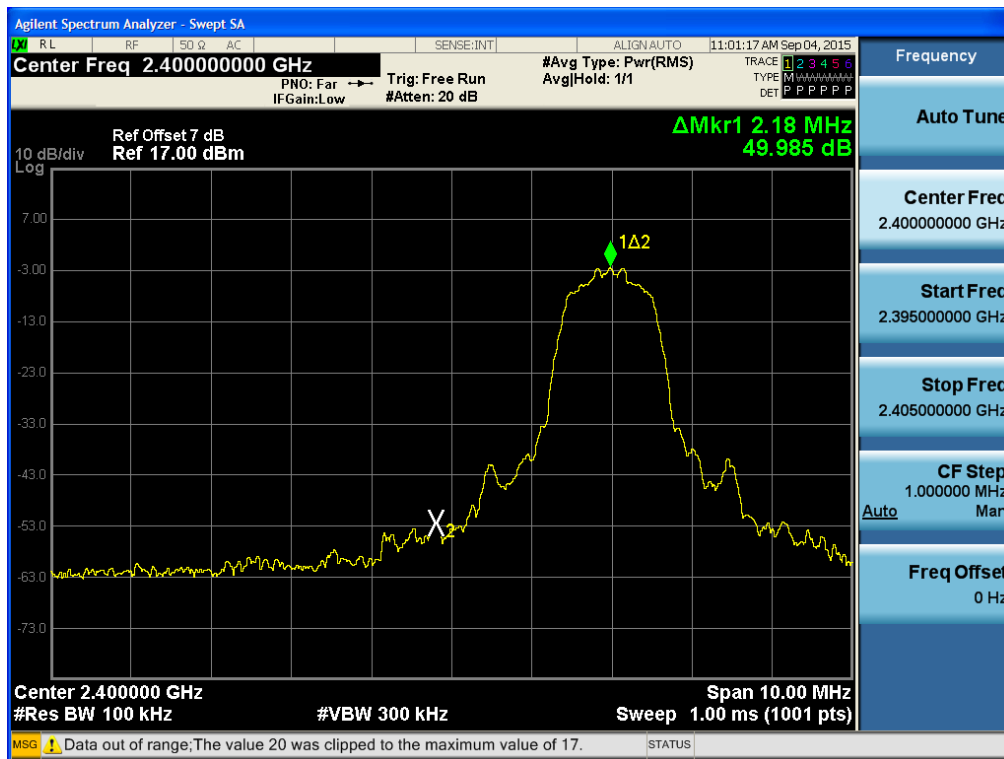

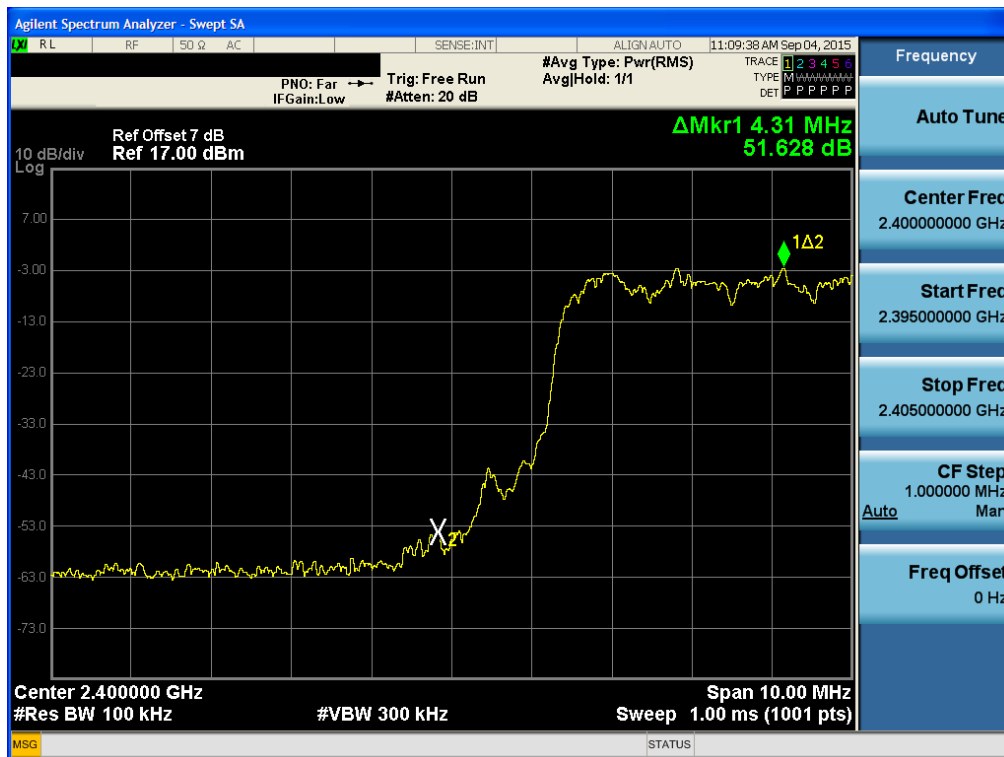


Test Plots with hopping (GFSK)
Band Edges (High-CH)



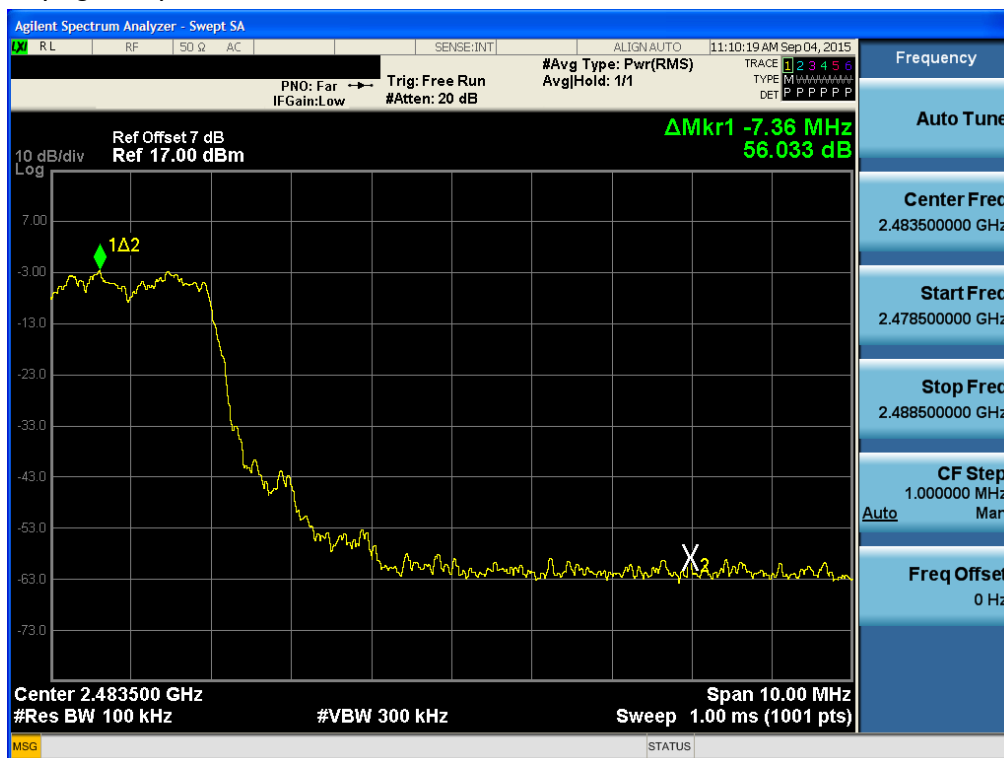

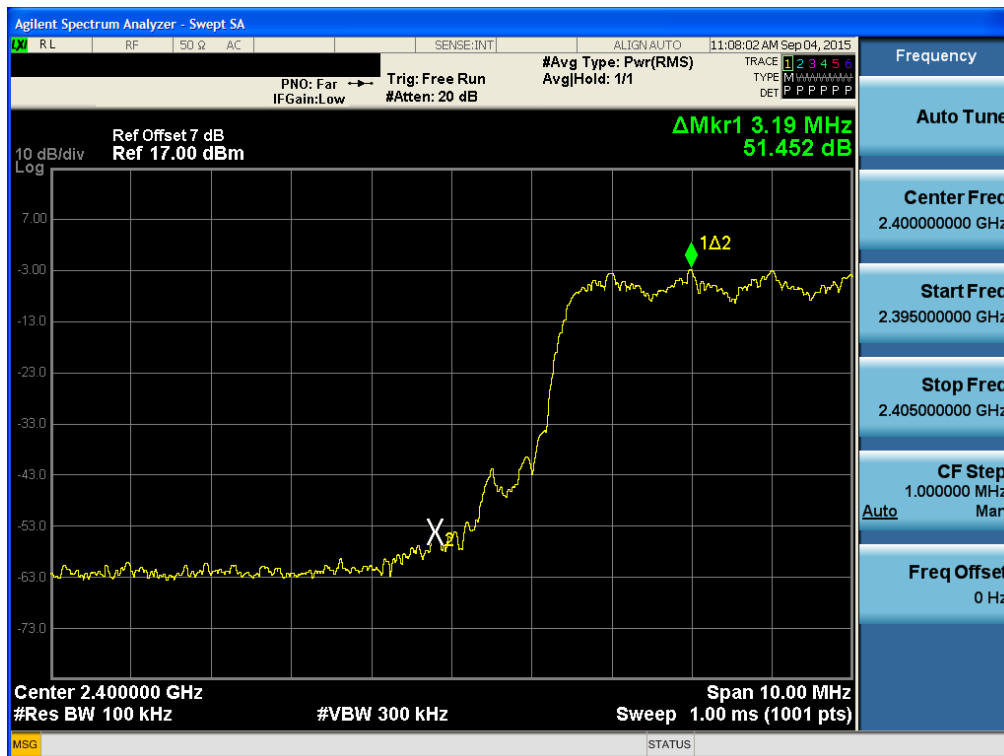

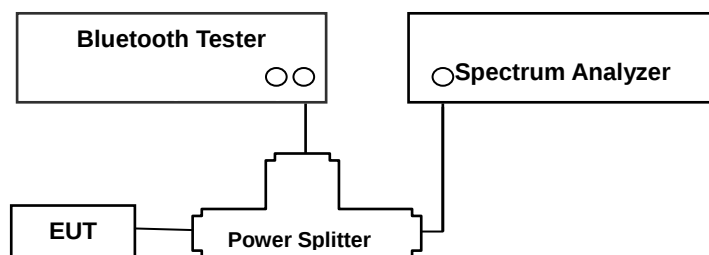


8.3 FREQUENCY SEPARATION / OCCUPIED BANDWIDTH (99% BW)

LIMIT

According to §15.247(a)(1), Frequency hopping systems operating in the 2400–2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater.

Test Configuration



TEST PROCEDURE

The Channel Separation test is performed with hopping on. And the 20 dB Bandwidth test is performed with hopping off.

The Spectrum Analyzer is set to (7.8.2 in ANSI 63.10-2013)

- 1) Span: Wide enough to capture the peaks of two adjacent channels
- 2) RBW: Start with the RBW set to approximately 30% of the channel spacing; adjust as necessary to best identify the center of each individual channel.
- 3) VBW $\geq$ RBW
- 4) Sweep: Auto
- 5) Detector: Peak
- 6) Trace: Max hold
- 7) All the trace to stabilize.

Use the marker-delta function to determine the separation between the peaks of the adjacent channels. Compliance of an EUT with the appropriate regulatory limit shall be determined. A plot of the data shall be included in the test report.

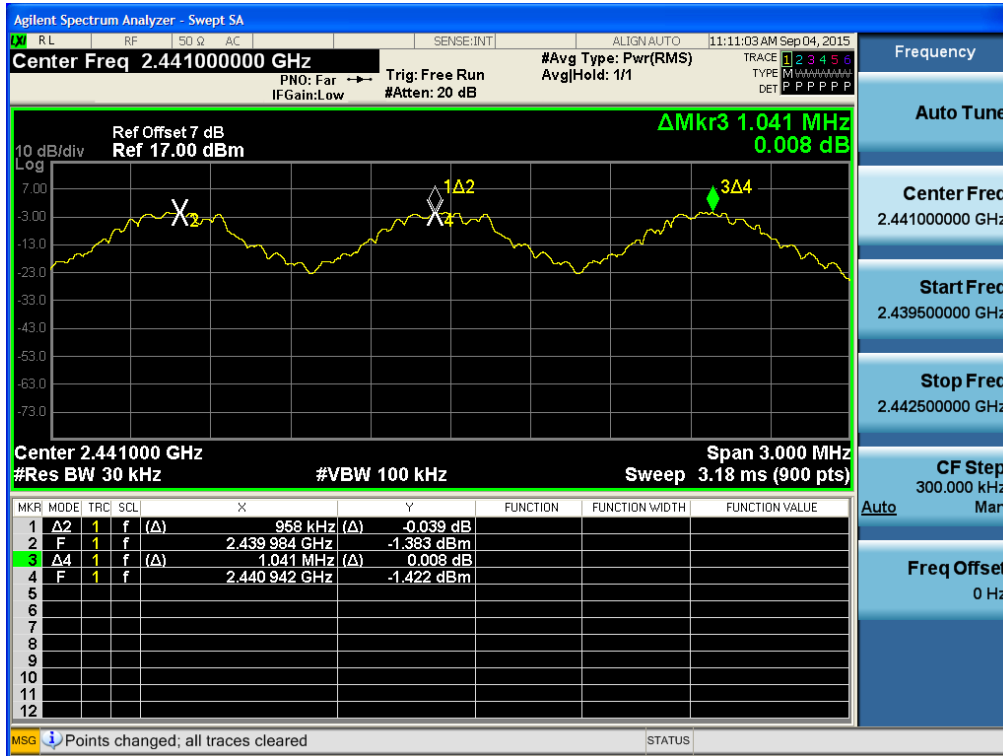

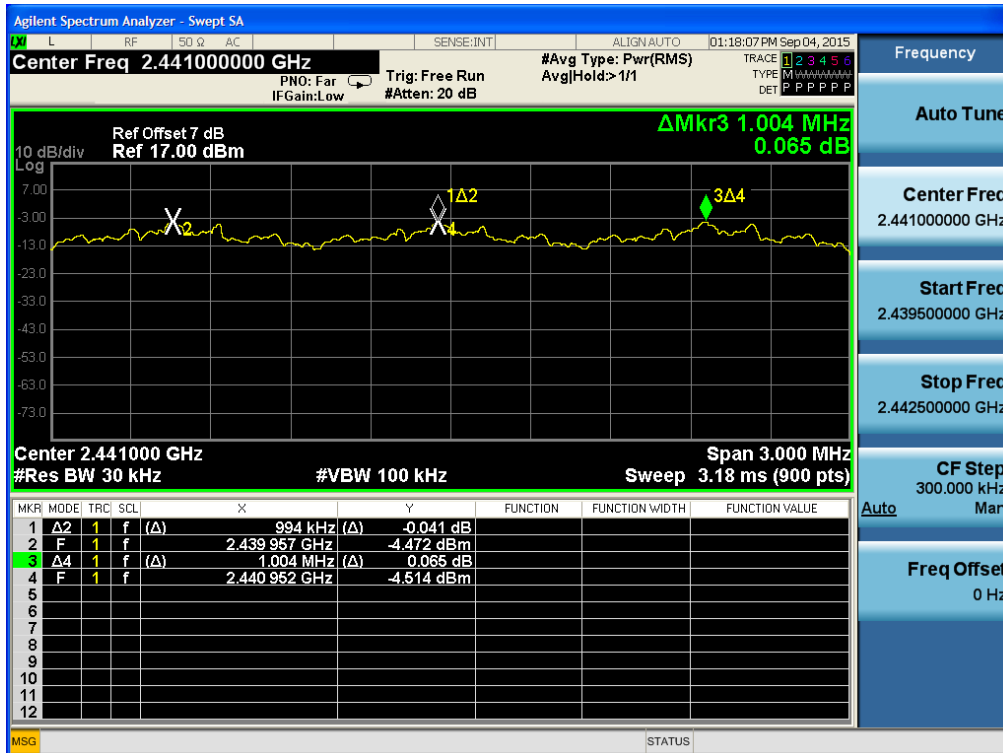

Channel Separation

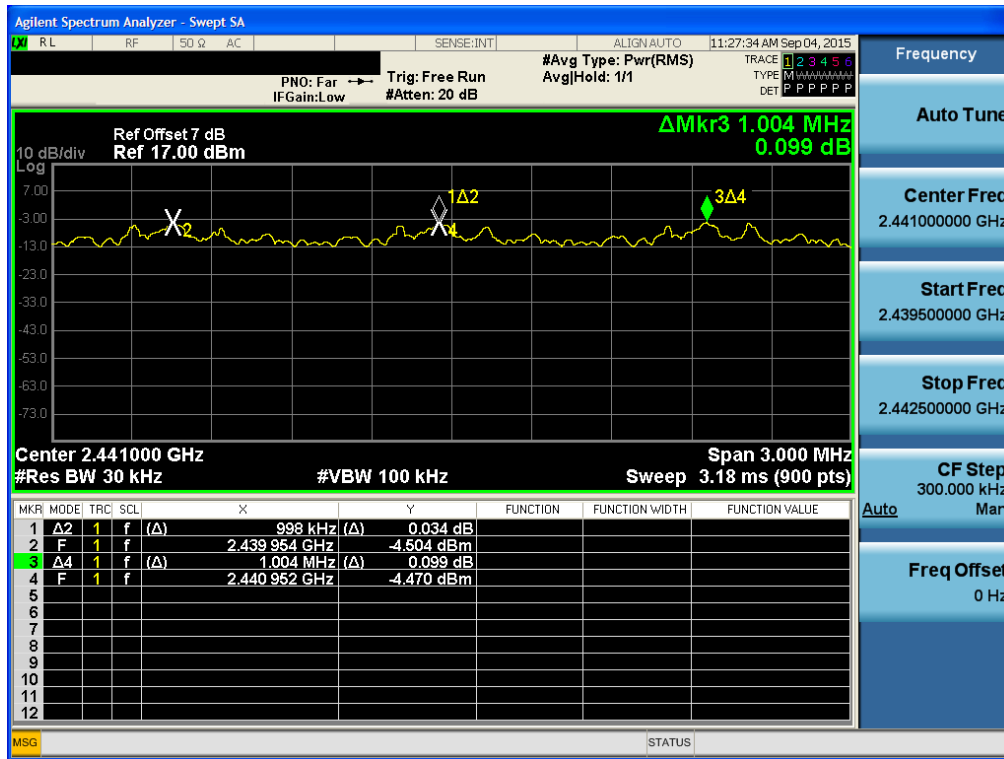


Test Plots (8DPSK)

Channel Separation

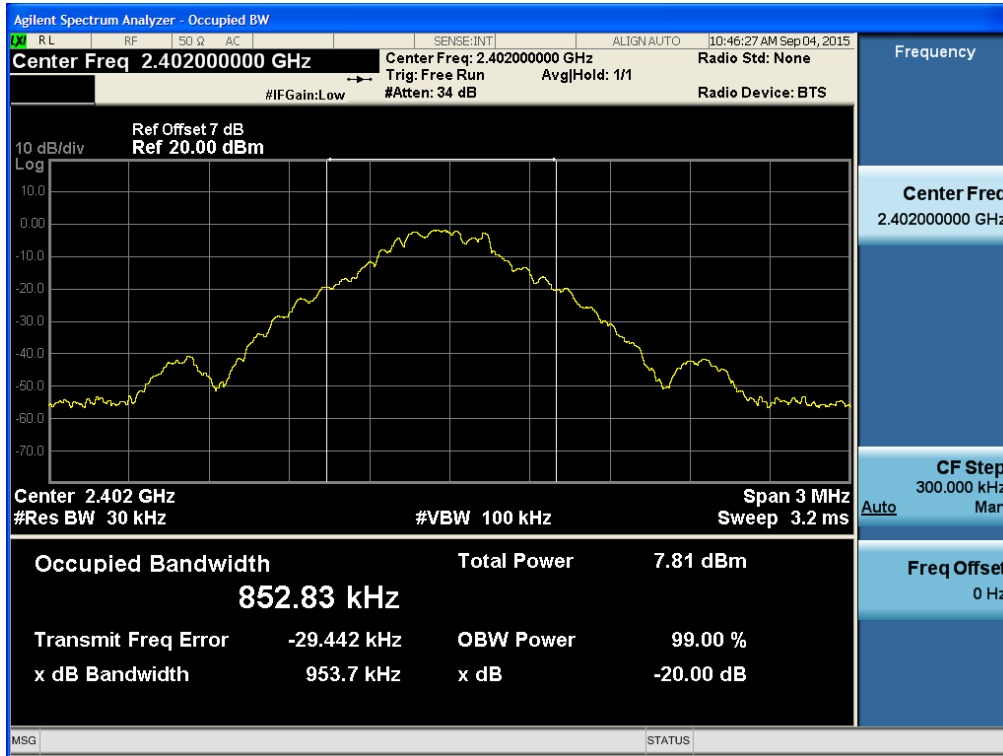


Test Plots ($\pi/4$ DQPSK)
Channel Separation



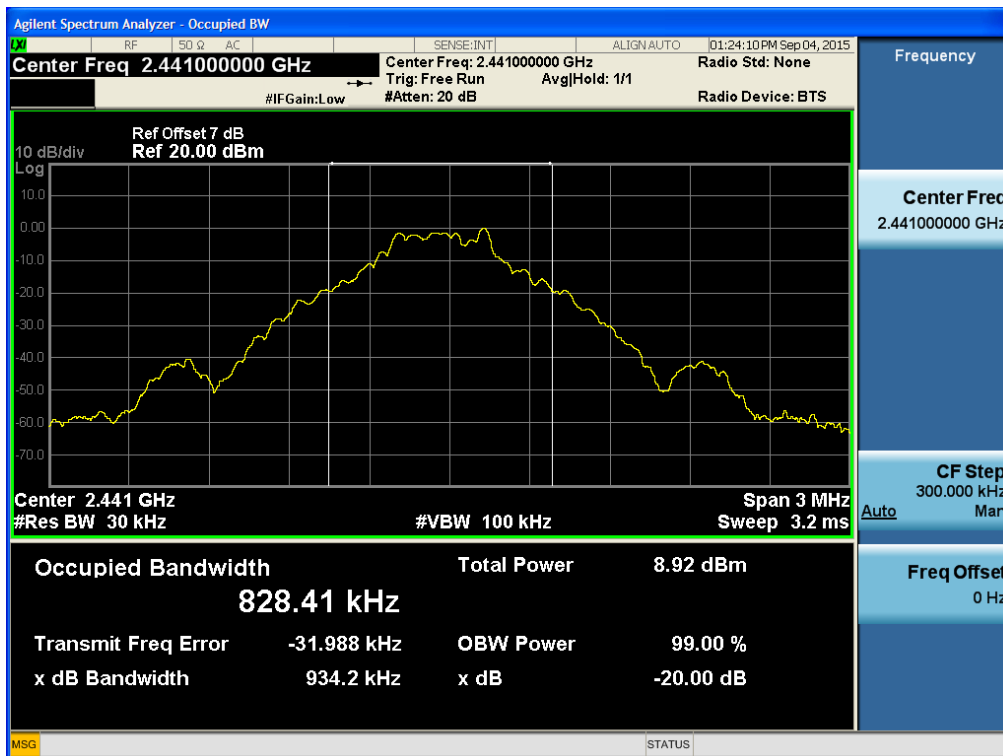

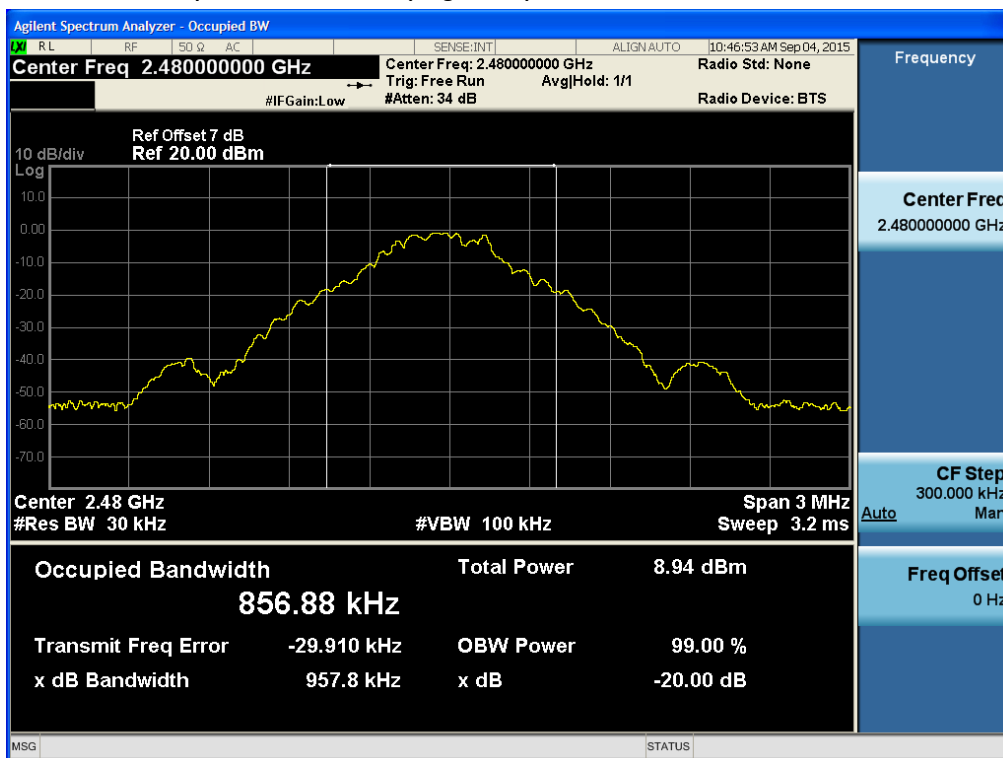

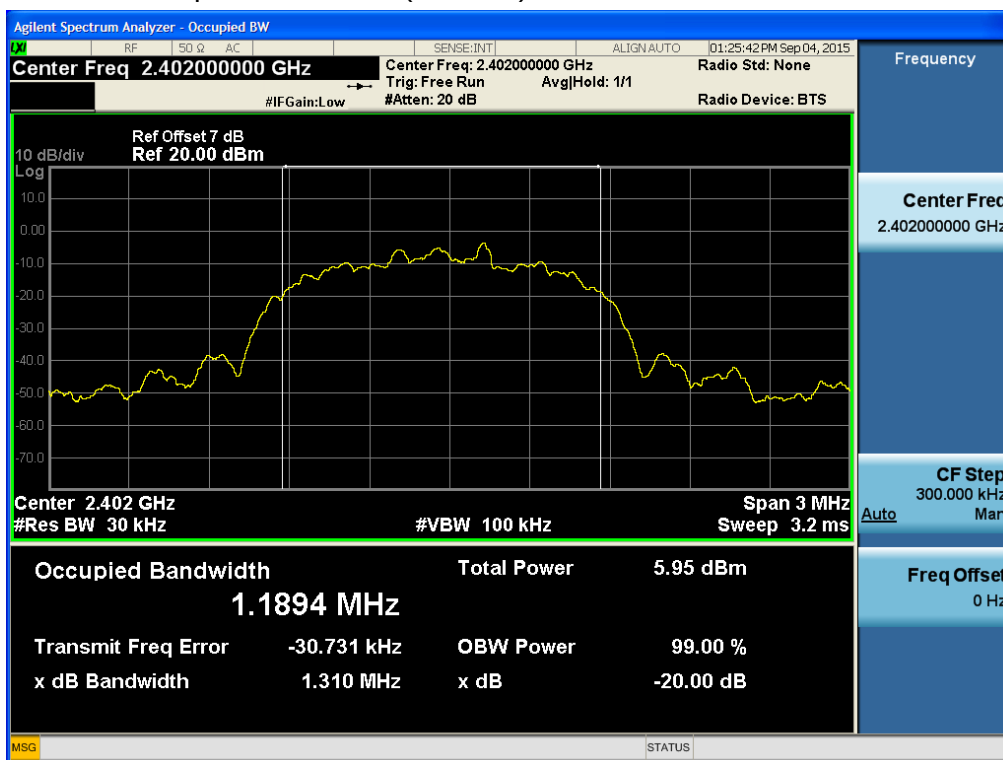

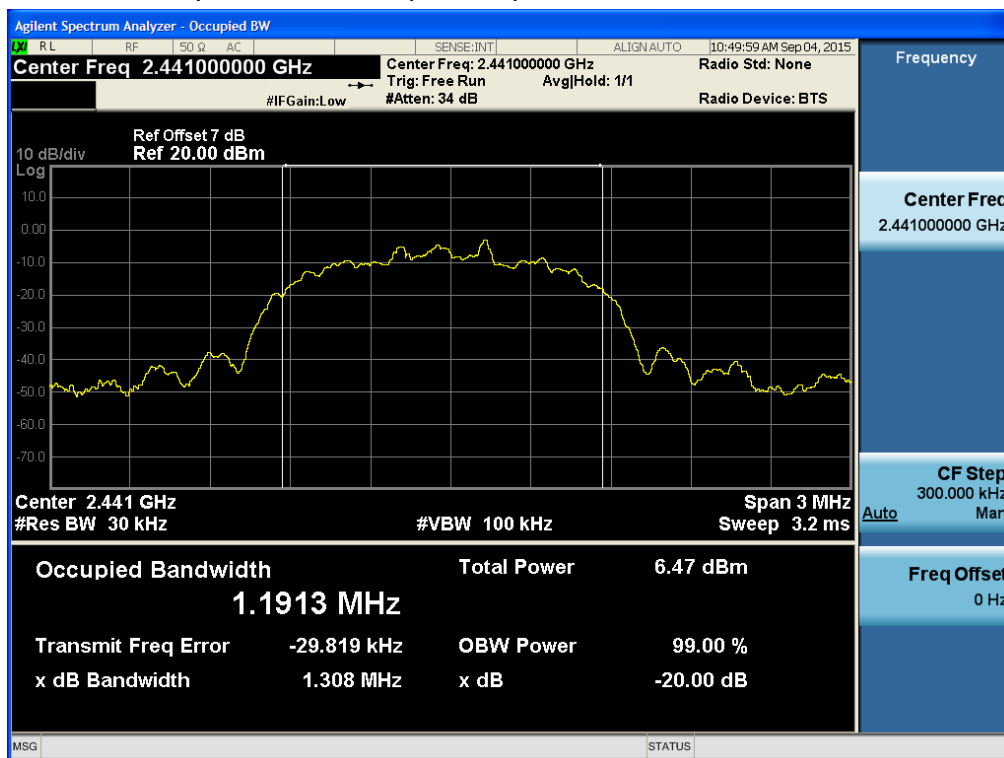

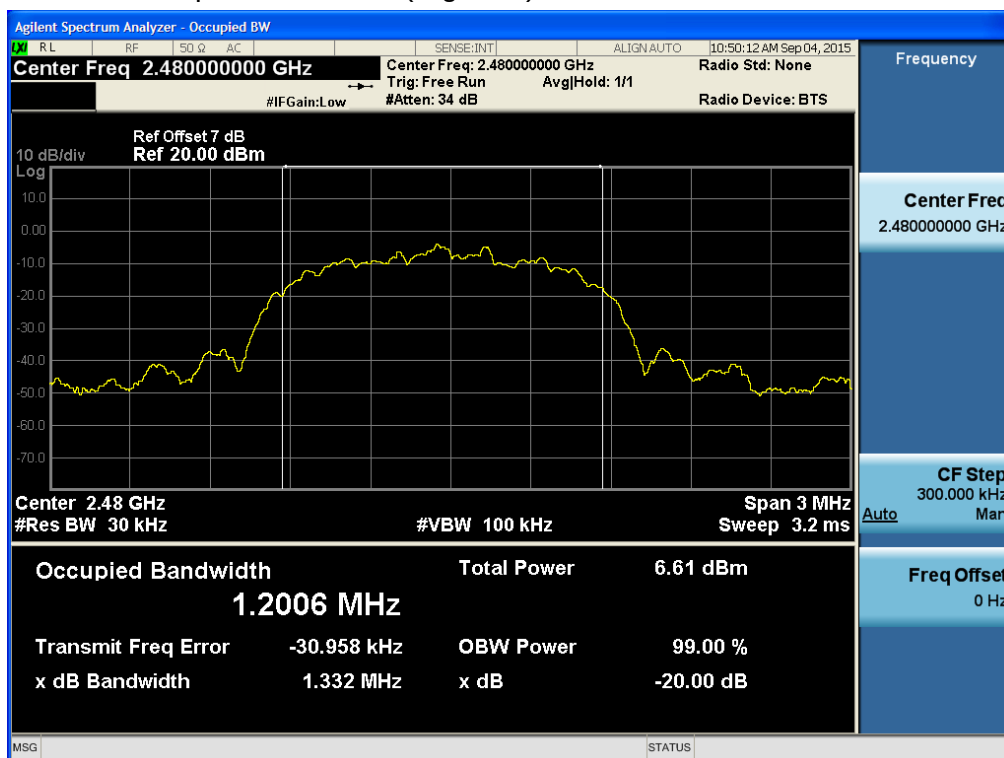

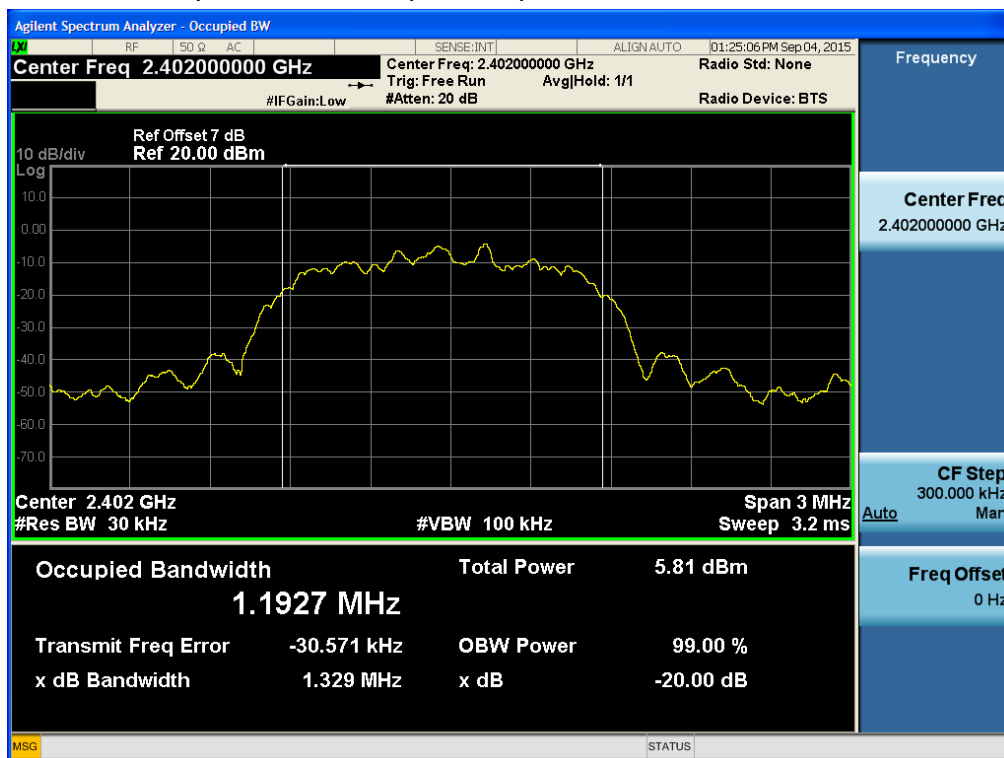

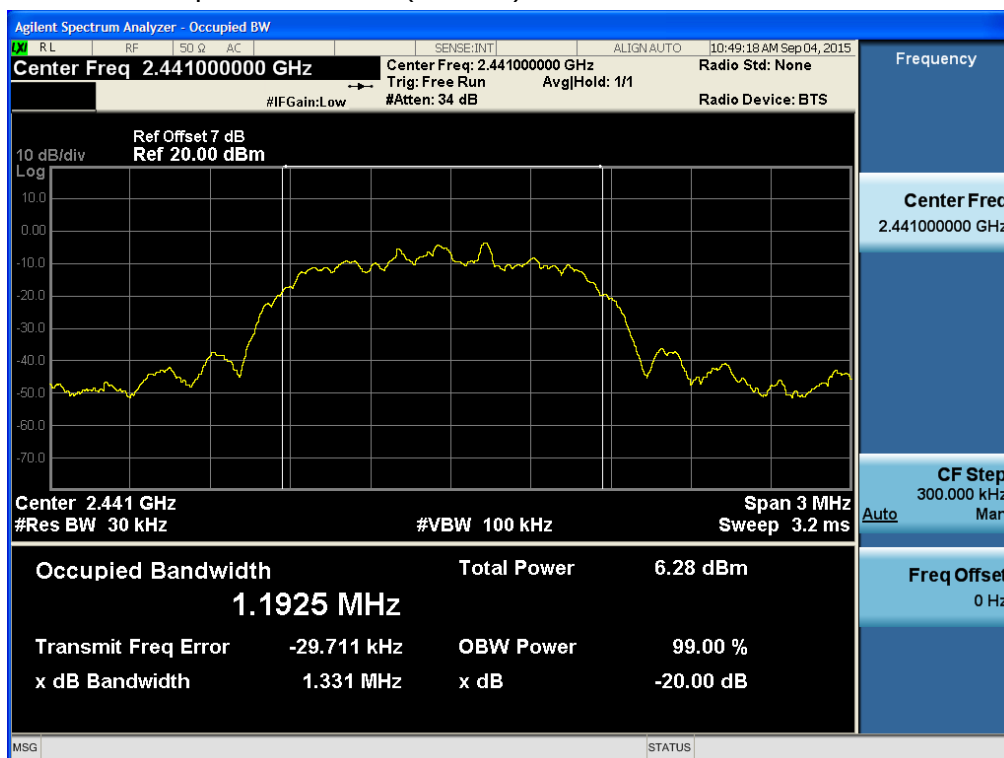

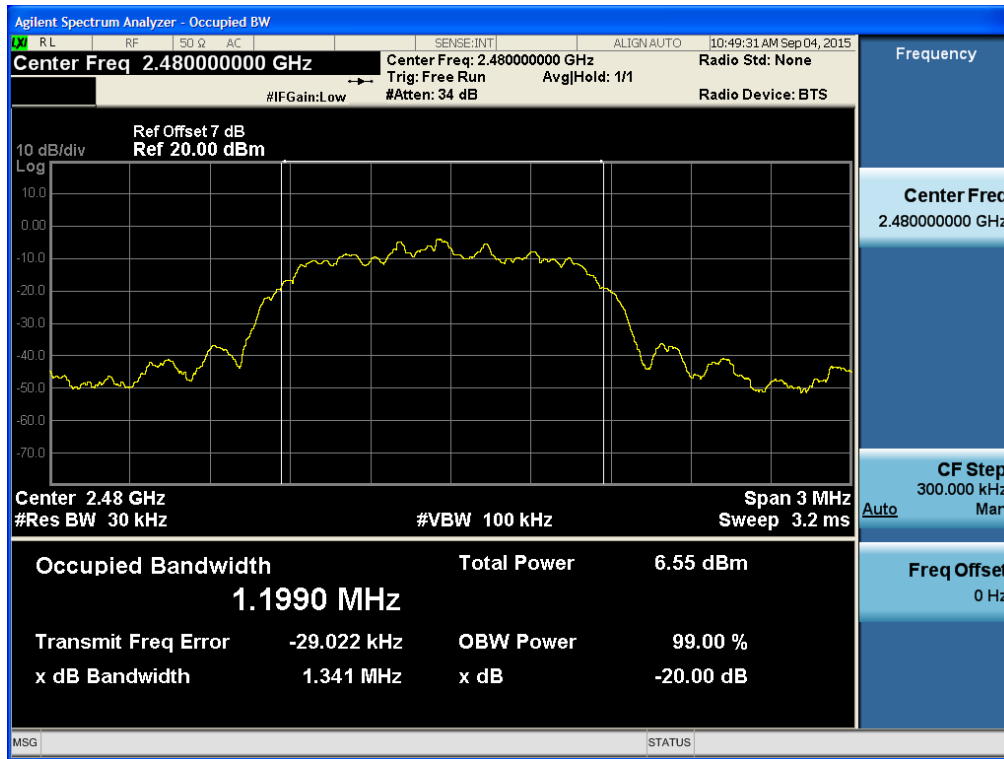
Test Plots ($\pi/4$ DQPSK)

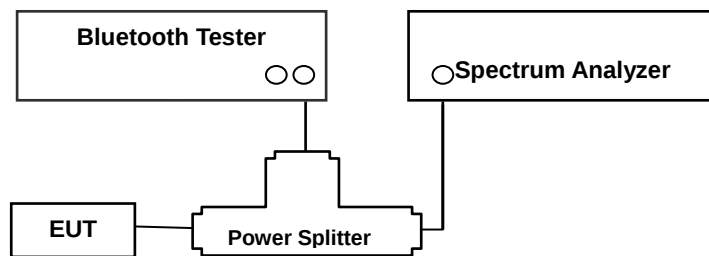


8.4 NUMBER OF HOPPING FREQUENCY

LIMIT

According to §15.247(a)(1)(iii), Frequency hopping systems operating in the 2400 MHz ~ 2483.5 MHz bands shall use at least 15 hopping frequencies.

TEST PROCEDURE

The Bluetooth frequency hopping function of the EUT was enabled.

The Spectrum Analyzer is set to (7.8.3 in ANSI 63.10-2013)

- 1) Span: the frequency band of operation
- 2) RBW: To identify clearly the individual channels, set the RBW to less than 30% of the channel spacing or the 20 dB bandwidth, whichever is smaller.
- 3) VBW $\geq$ RBW
- 4) Sweep: Auto
- 5) Detector: Peak
- 6) Trace: Max hold
- 7) Allow the trace to stabilize.

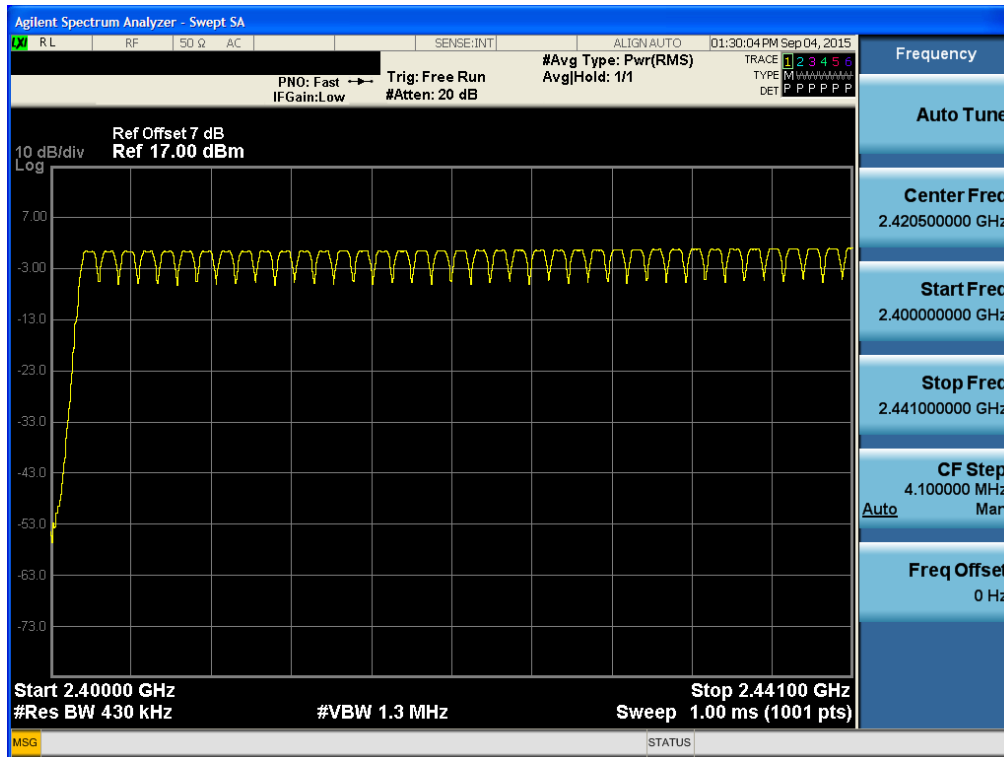

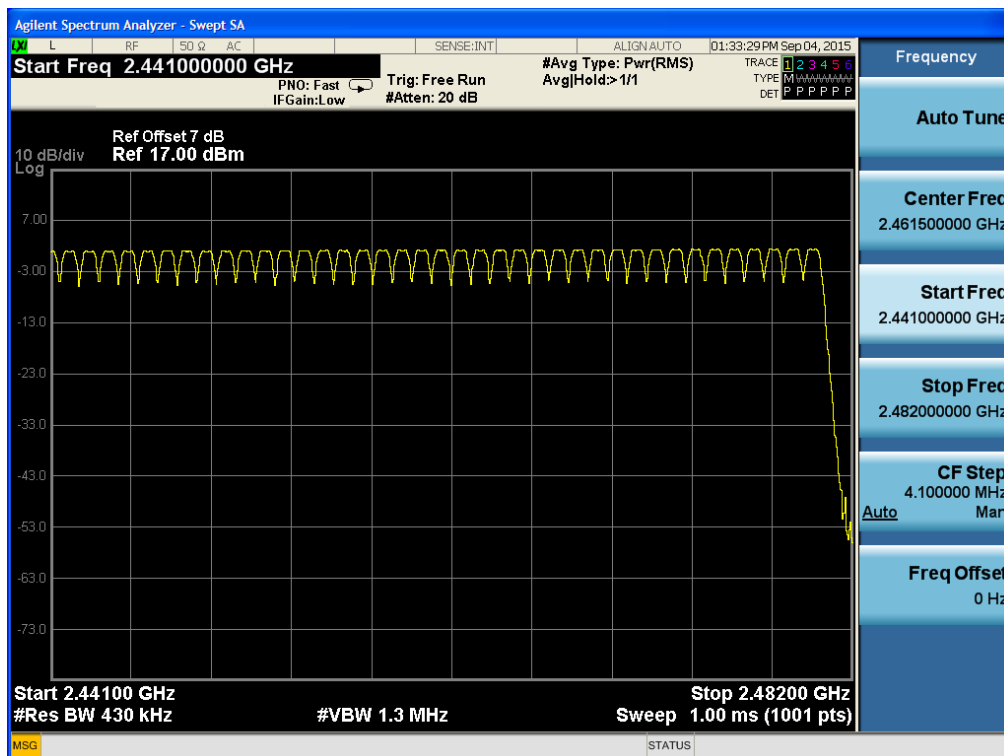

Number of Channels (2.4 GHz - 2.441 GHz)



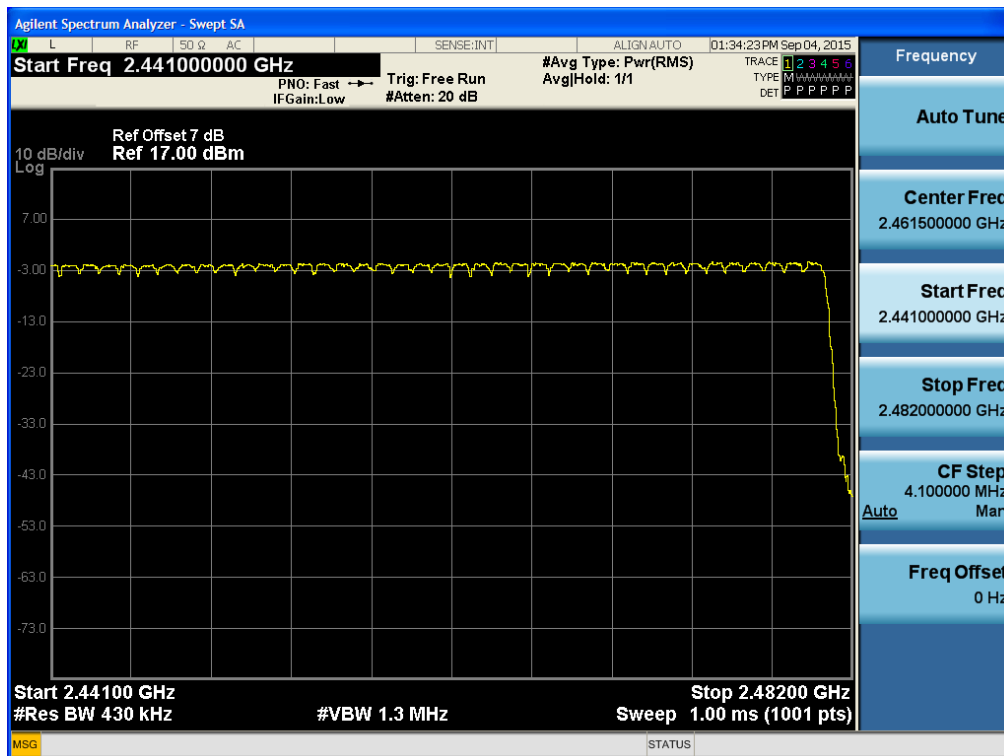
Test Plots (GFSK)

Number of Channels (2.441 GHz - 2.4835 GHz)



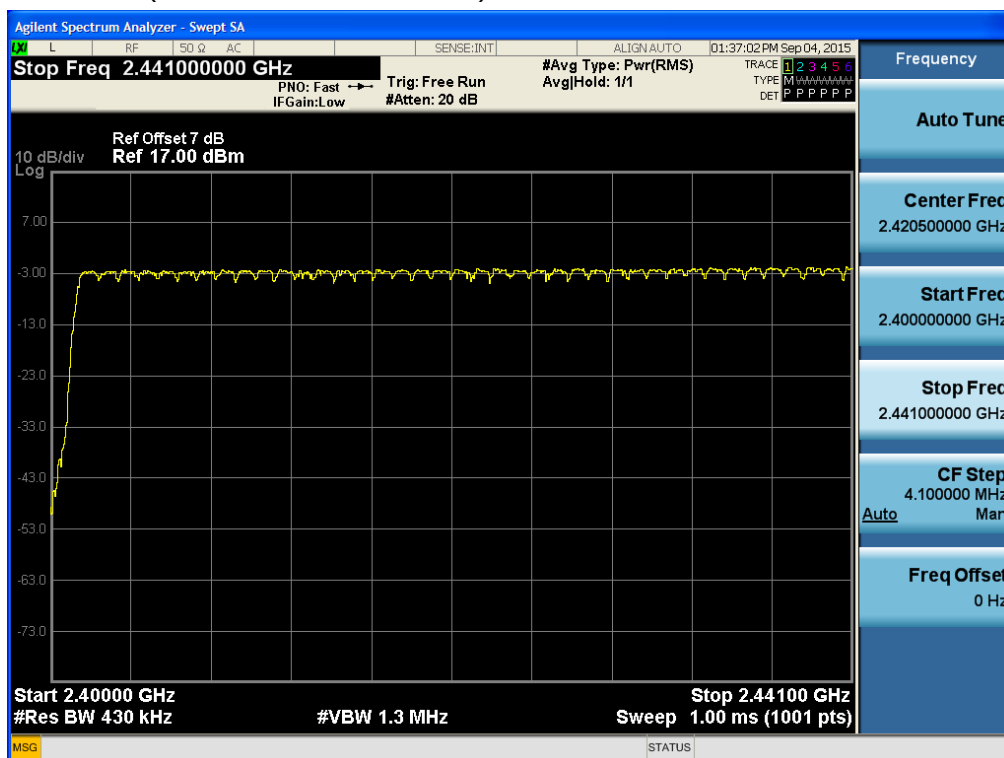

Number of Channels (2.4 GHz - 2.441 GHz)



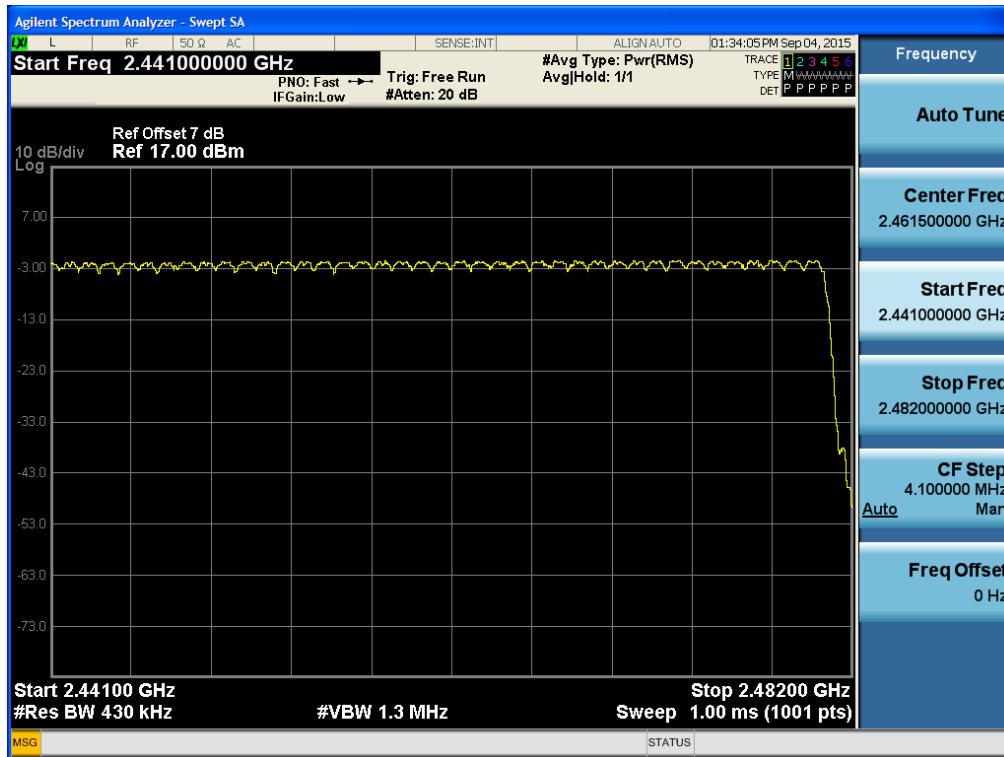

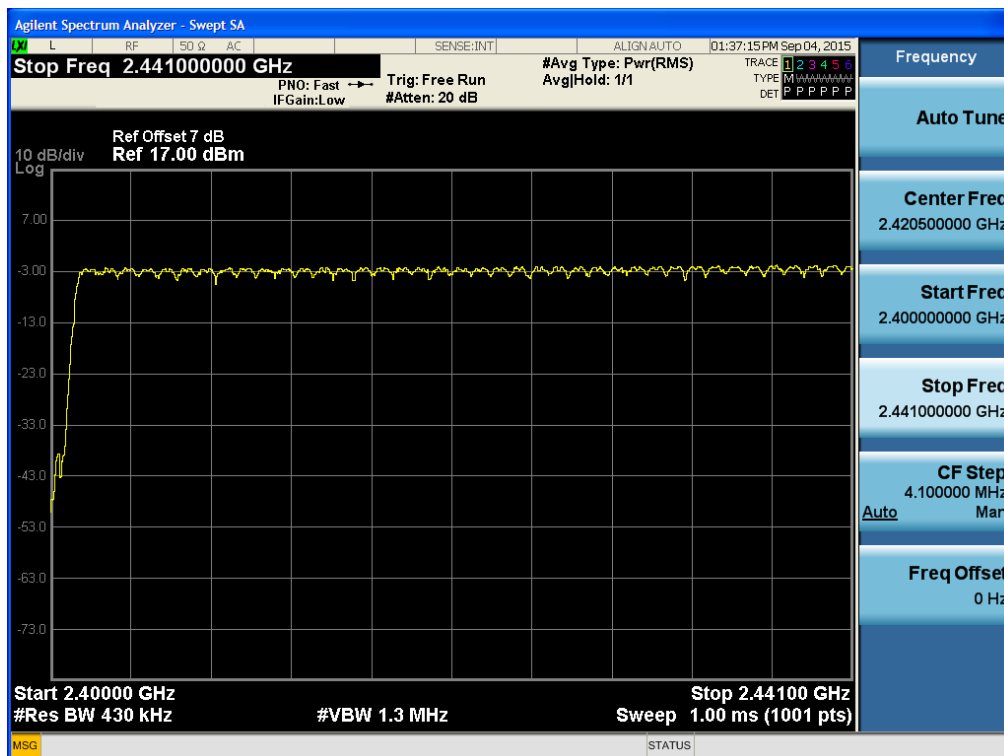

Number of Channels (2.441 GHz - 2.4835 GHz)

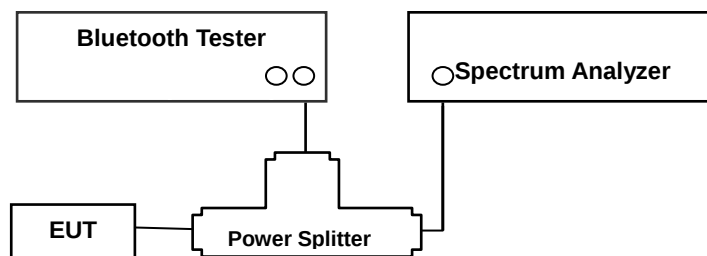


8.5 TIME OF OCCUPANCY (DWELL TIME)

LIMIT

According to §15.247(a)(1)(iii), Frequency hopping systems operating in the 2400 MHz ~ 2483.5 MHz bands. The average time of occupancy on any channels shall not greater than 0.4 s within a period 0.4 s multiplied by the number of hopping channels employed.

TEST PROCEDURE

This test is performed with hopping off.

EUT was set to transmit the longest packet type (DH5)

The Spectrum Analyzer is set to (7.8.4 in ANSI 63.10-2013)

- 1) Span: Zero span, centered on a hopping channel
- 2) RBW shall be $\leq$ channel spacing and where possible RBW should be set $\gg 1/T$, where T is the expected dwell time per channel.
- 3) Sweep = as necessary to capture the entire dwell time per hopping channel
- 4) Detector: Peak
- 5) Trace: Max hold

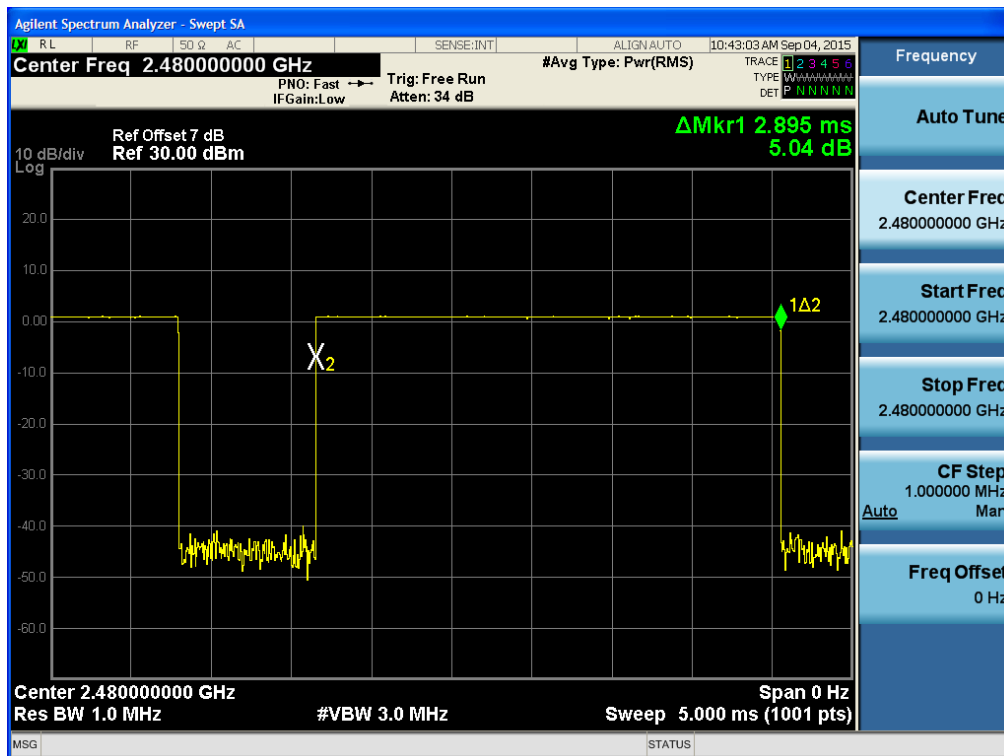

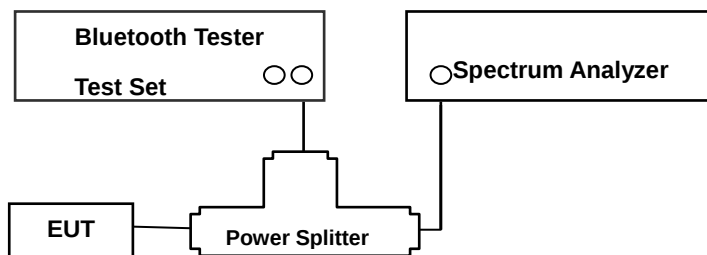
8.6.1 CONDUCTED SPURIOUS EMISSIONS

Test Requirements and limit, §15.247(d)

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. TEST PROCEDURE

Conducted RF measurements of the transmitter output were made to confirm that the EUT antenna port conducted emissions meet the specified limit and to identify any spurious signals that require further investigation or measurements on the radiated emissions site.

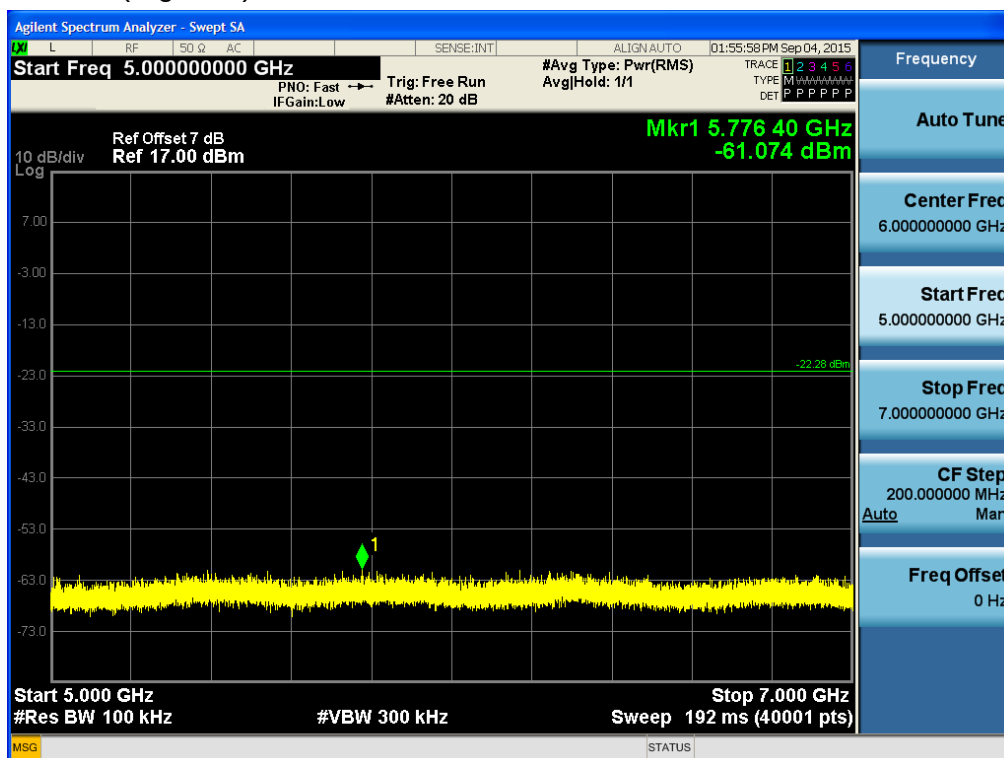
Test Plots (8DPSK)- 1 GHz – 3 GHz

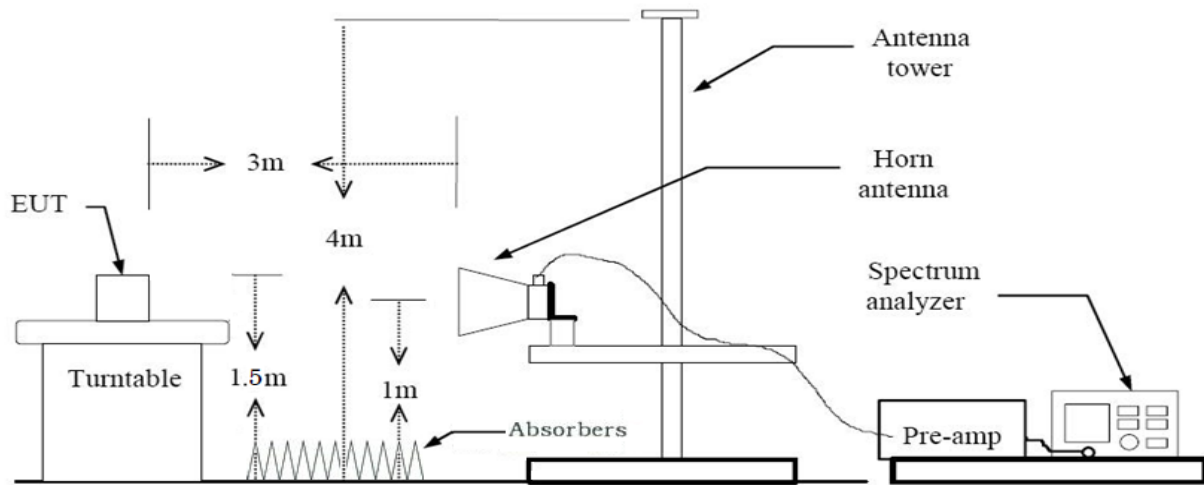

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in section 15.209(a) (See section 15.205(c)).

8.7 POWERLINE CONDUCTED EMISSIONS

LIMIT

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolt (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range is listed as follows:

Compliance with this provision shall be based on the measurement of the radio frequency voltage between each power line (LINE and NEUTRAL) and ground at the power terminals.

TEST PROCEDURE

1. The EUT is placed on a wooden table 80 cm above the reference ground plane.
2. The EUT is connected via LISN to a test power supply.
3. The measurement results are obtained as described below:
4. Detectors – Quasi Peak and Average Detector.

Quasi-peak(Final Result) = Reading Value + Correction Factor

Note : We don't perform powerline conducted emission test. Because this EUT is used with vehicle.
