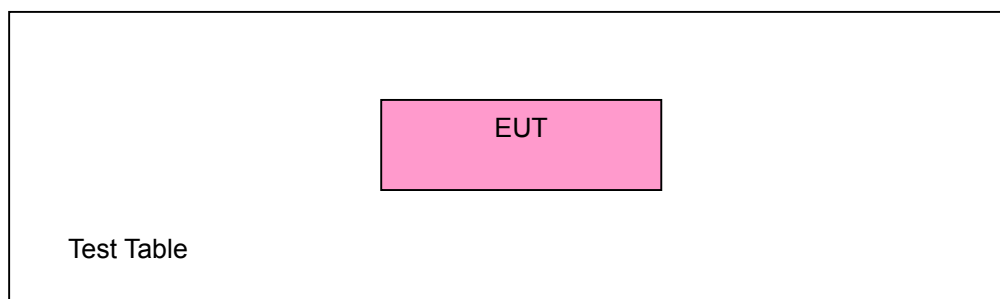

3.2.3 TEST PROCEDURES

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meters semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

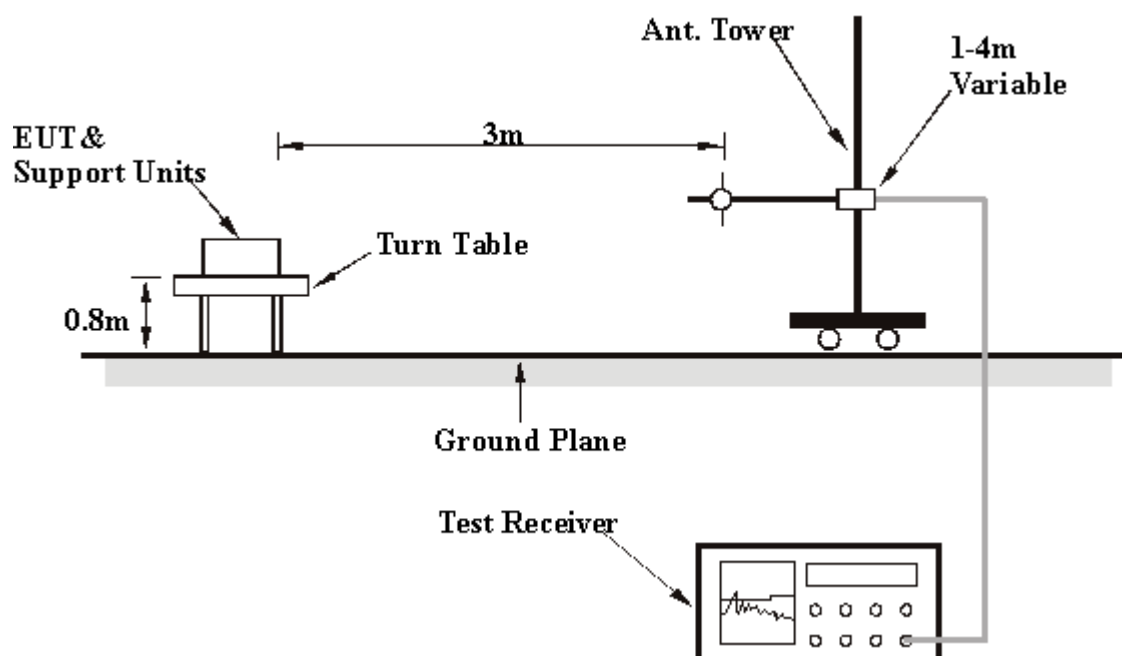

2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection at frequency above 1GHz.
3. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 10 Hz for Average detection (AV) at frequency above 1GHz.

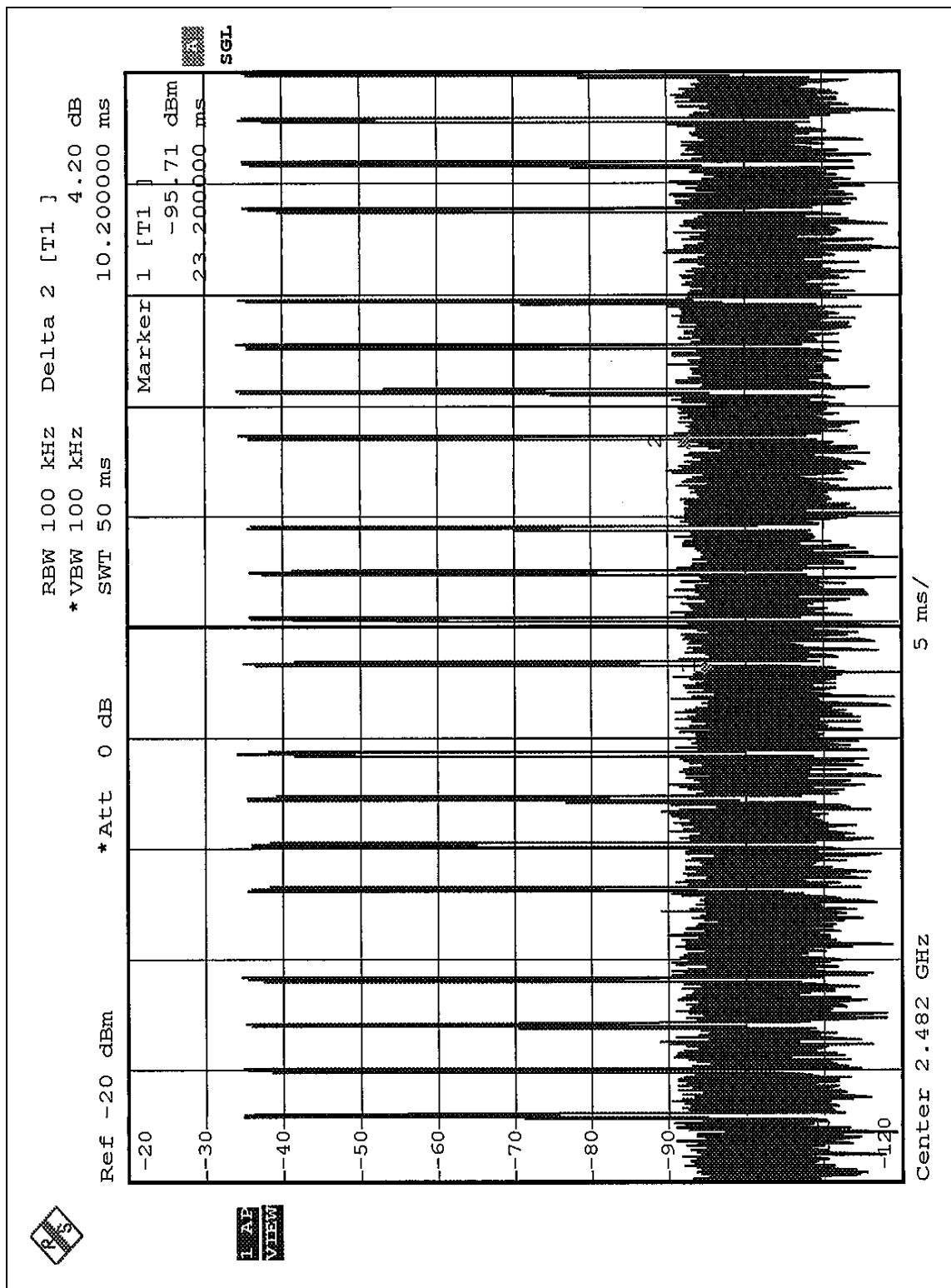

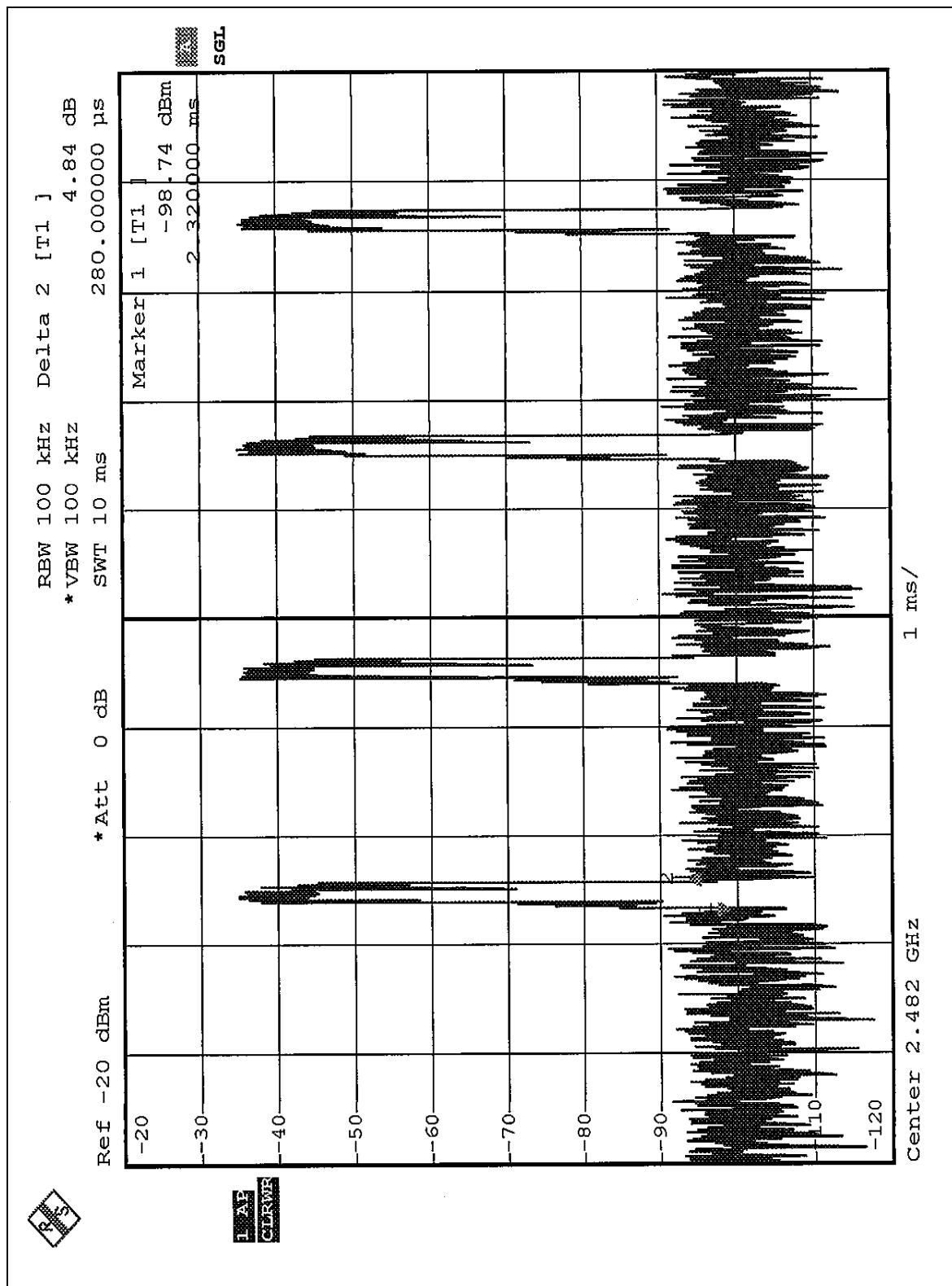

The transmitter output was connected to the spectrum analyzer via a low loss cable. Set both RBW and VBW of spectrum analyzer to 100kHz with suitable frequency span including 100 MHz bandwidth from band edge. The band edges was measured and recorded.

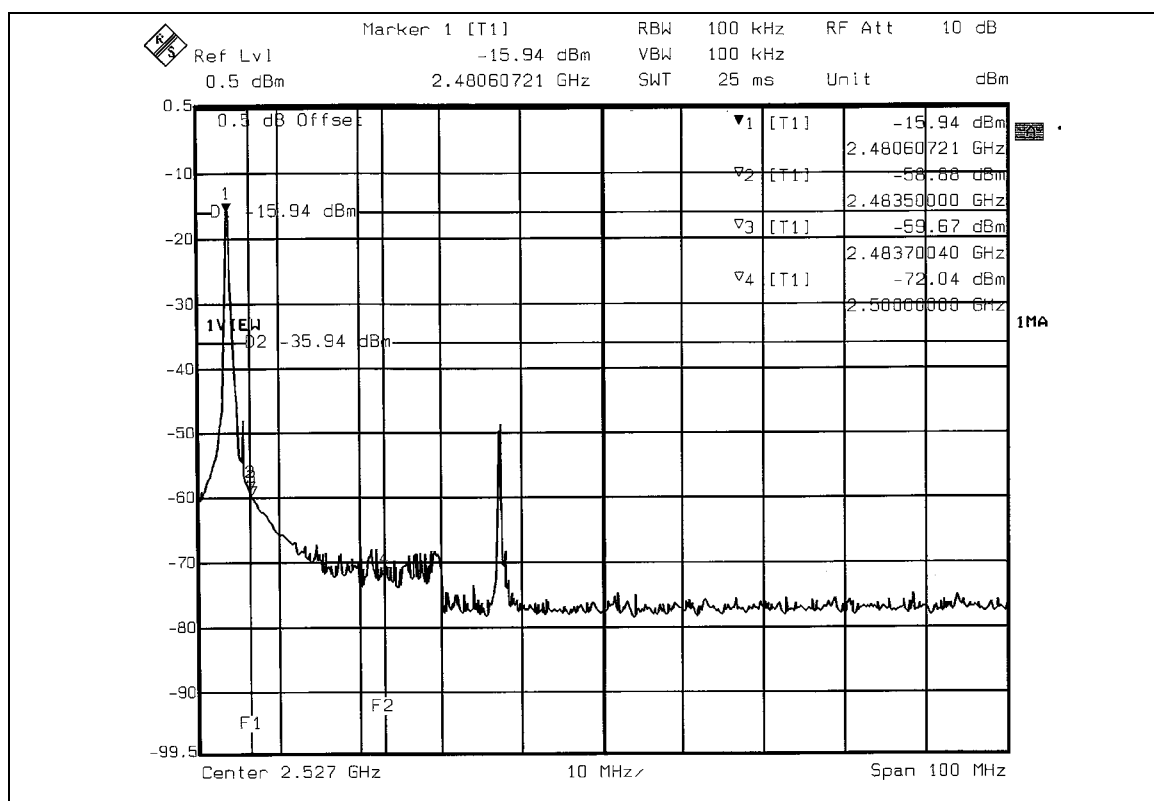
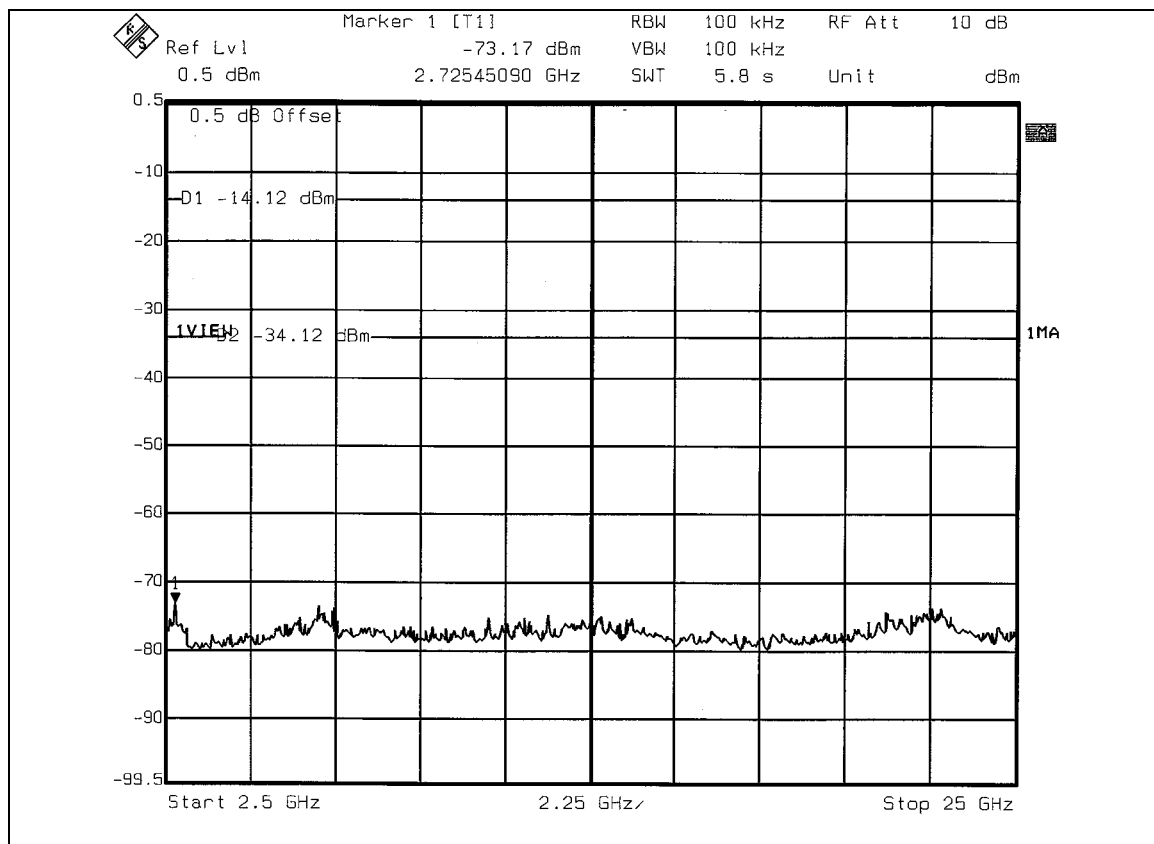
NOTE 1: The band edge emission plot of DSSS technique on page 21 shows 34.25dB between carrier maximum power and local maximum emission in restrict band (2.3425GHz). The emission of carrier strength list in the test result of channel 1 at the item 3.2.7 is 92.41dBuV/m (Peak), so the maximum field strength in restrict band is $92.41 - 34.25 = 58.18$ dBuV/m which is under 74dBuV/m limit.

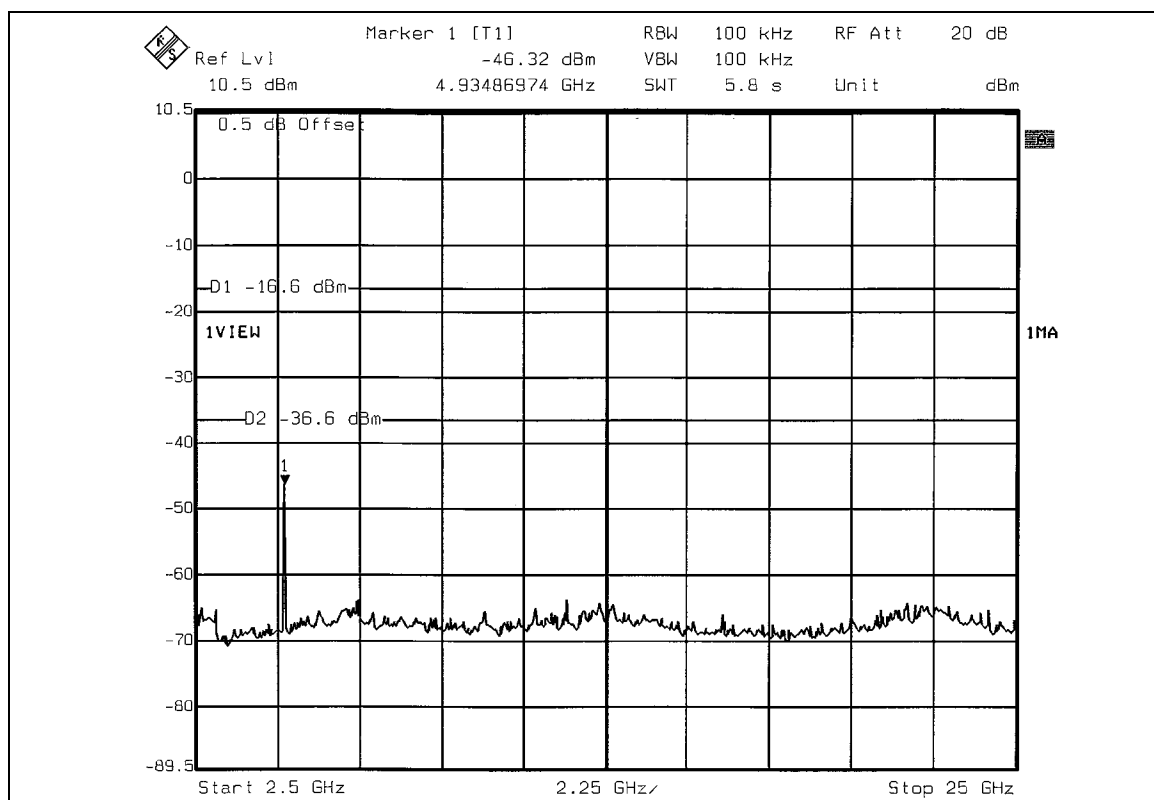
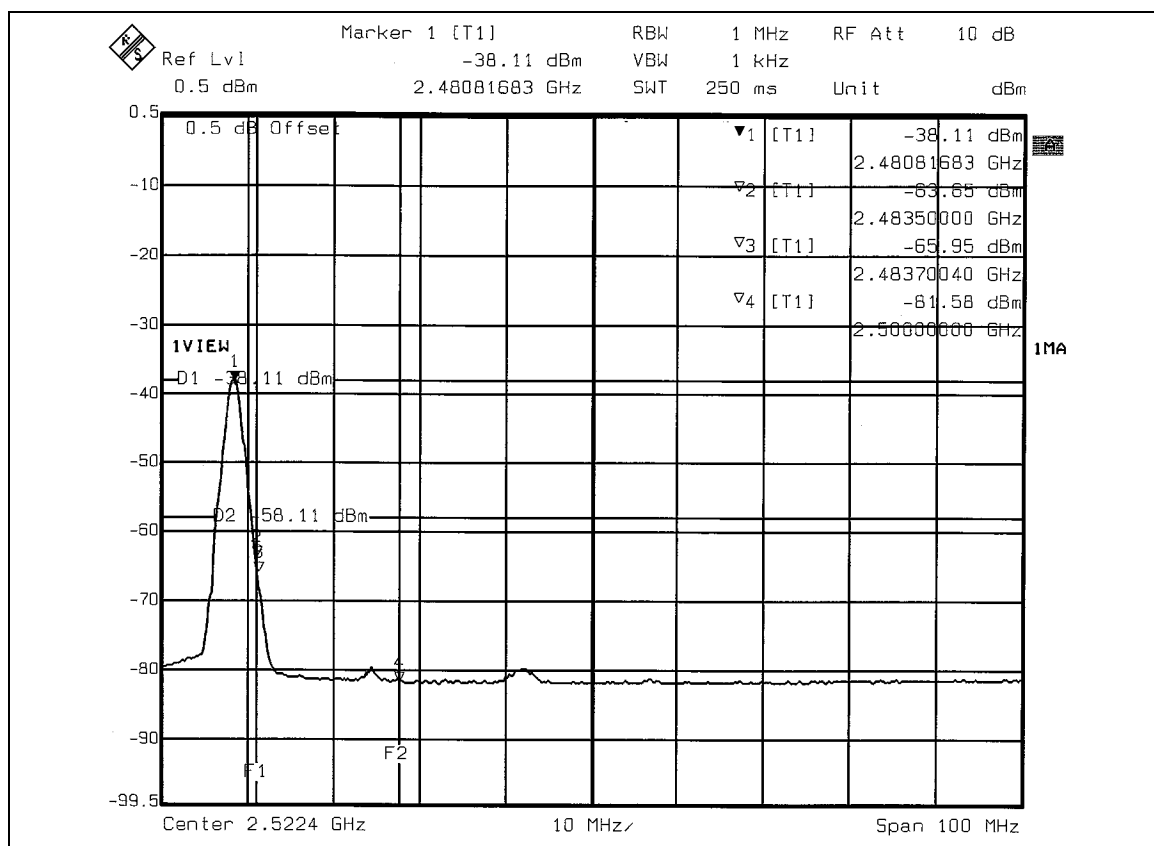
The band edge emission plot of DSSS technique on page 21 shows 43.51dB between carrier maximum power and local maximum emission in restrict band (2.3749GHz). The emission of carrier strength list in the test result of channel 1 at the item 3.2.7 is 73.53dBuV/m (Average), so the maximum field strength in restrict band is $73.53 - 43.51 = 30.02$ dBuV/m which is under 54dBuV/m limit.

The band edge emission plot of DSSS technique on page 23 shows 25.54dB between carrier maximum power and local maximum emission in restrict band (2.4835GHz). The emission of carrier strength list in the test result of channel 7 at the item 3.2.7 is 70.67dBuV/m (Average), so the maximum field strength in restrict band is $70.67 - 25.54 = 45.13$ dBuV/m which is under 54dBuV/m limit.
