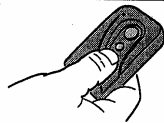

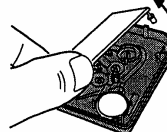
HOW TO CHANGE THE REMOTE'S BATTERIES

② CAREFULLY REMOVE THE CIRCUIT BOARD



③ INSTALL TWO TYPE 2016 BATTERIES PLUS (+) SIDE DOWN



④ REASSEMBLE THE UNIT WHEN FINISHED
