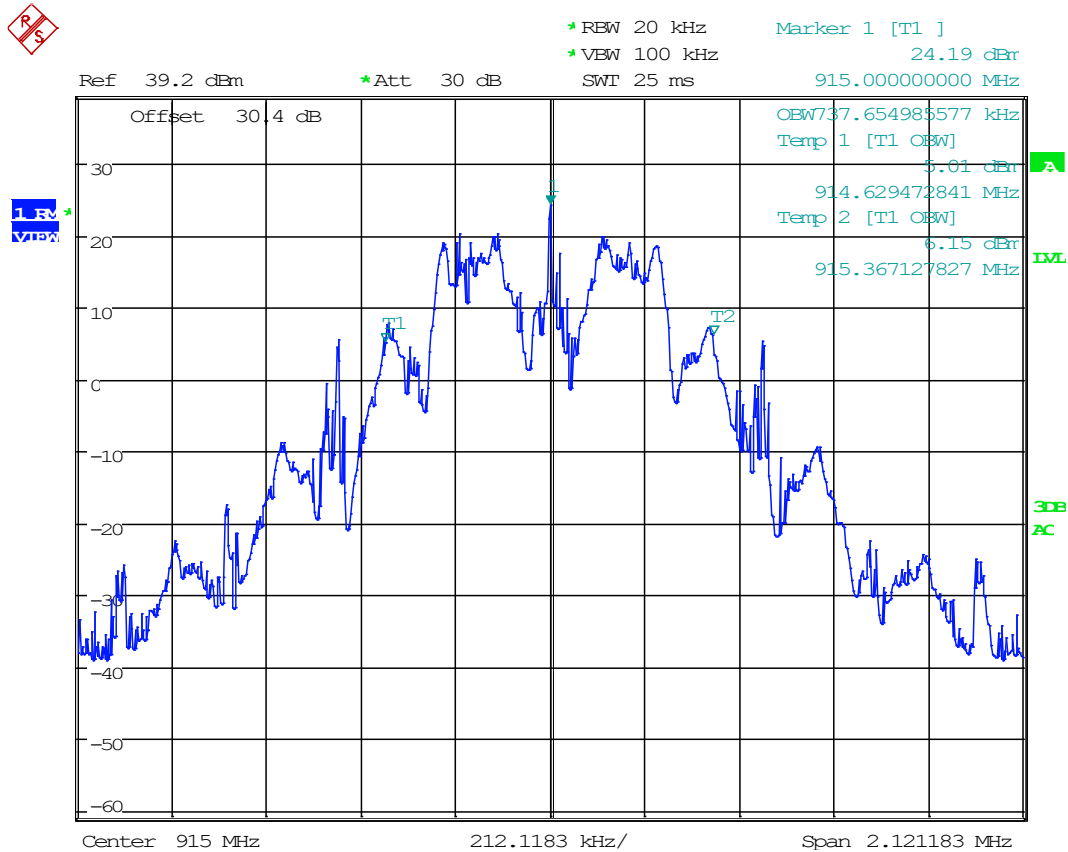

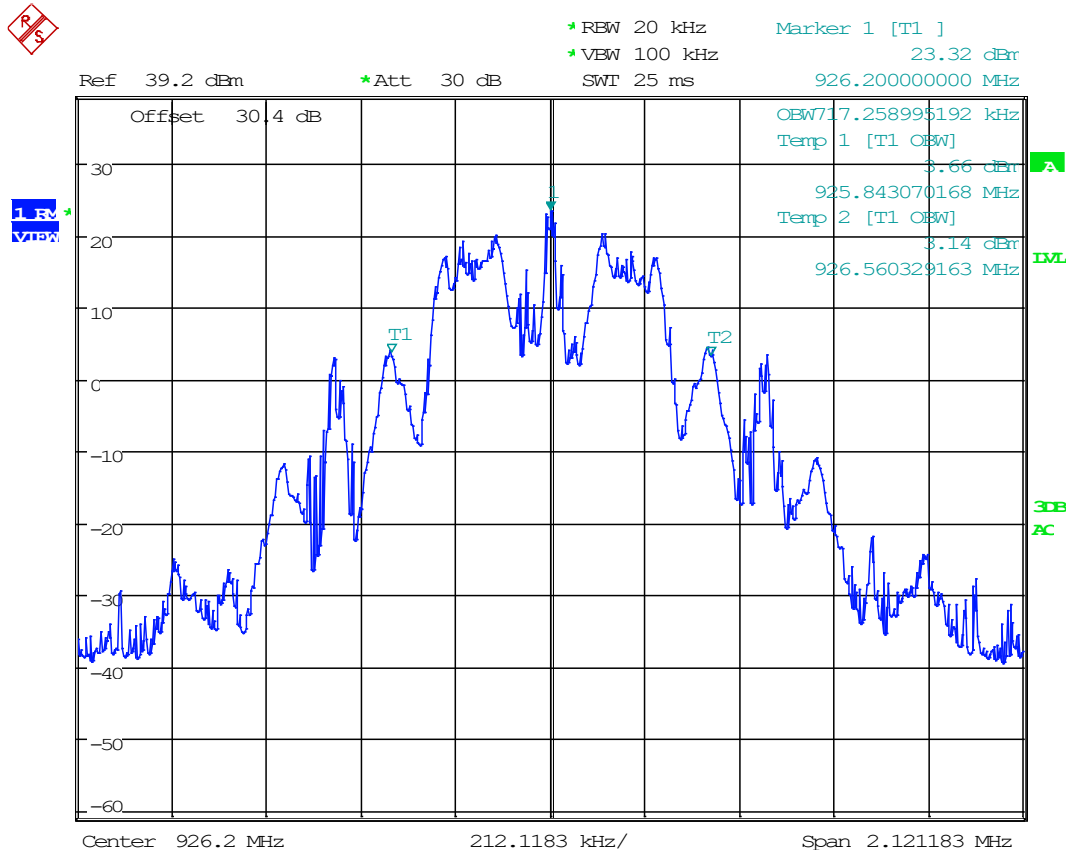

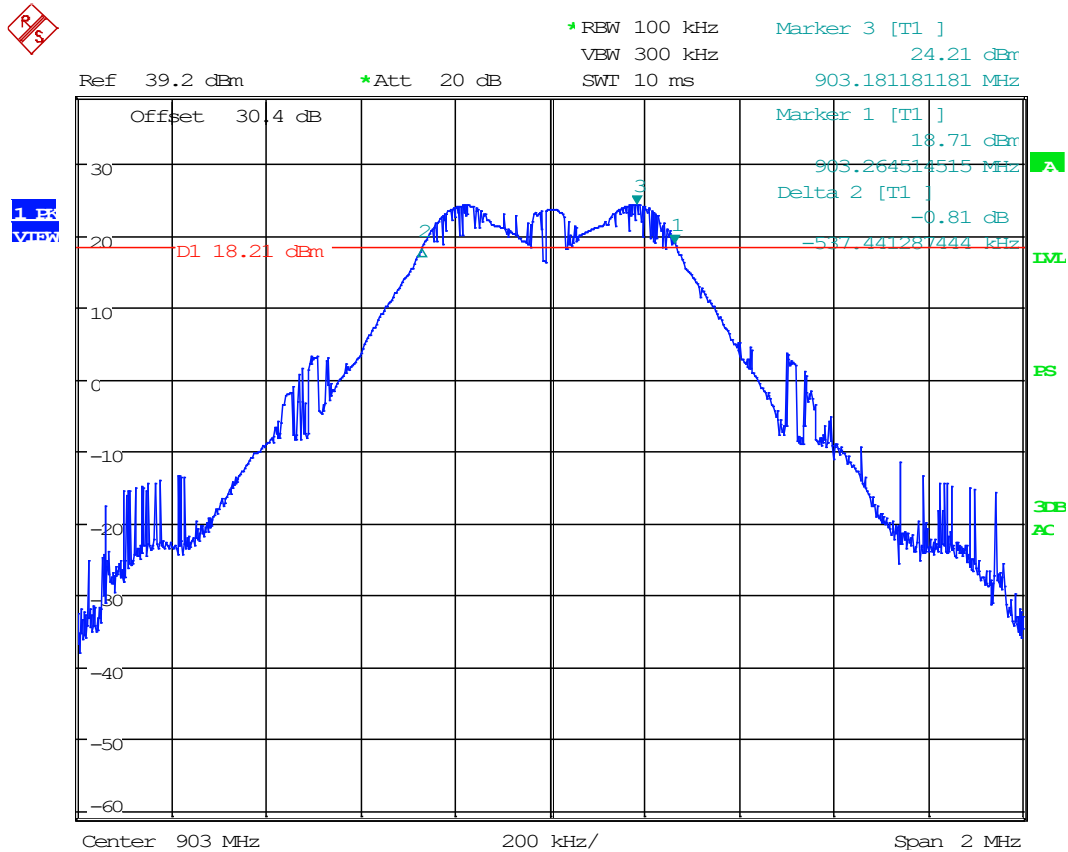
8.1.3 99% Occupied Bandwidth Test Data / Spectrum Plots, 926.2 MHz

8.1.4 6dB Occupied Bandwidth Test Data / Spectrum Plots, 903 MHz

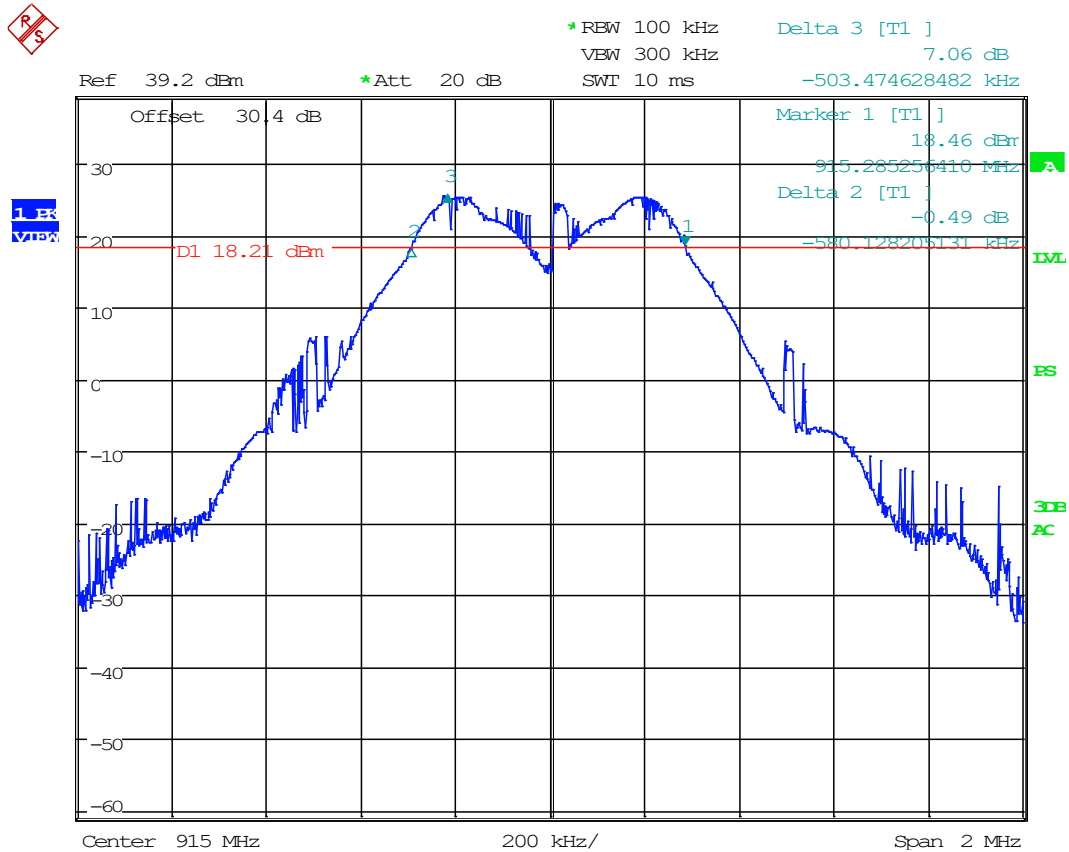

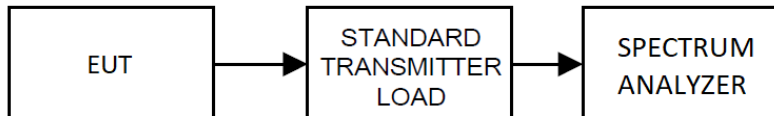

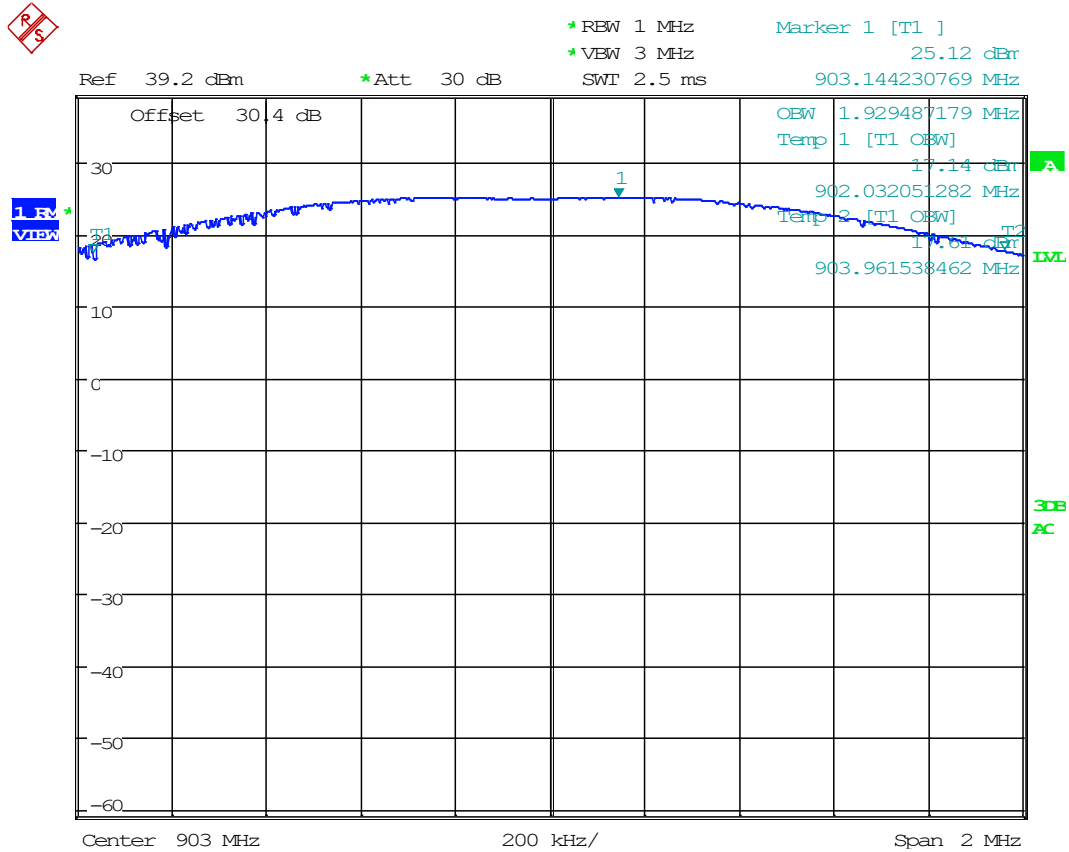

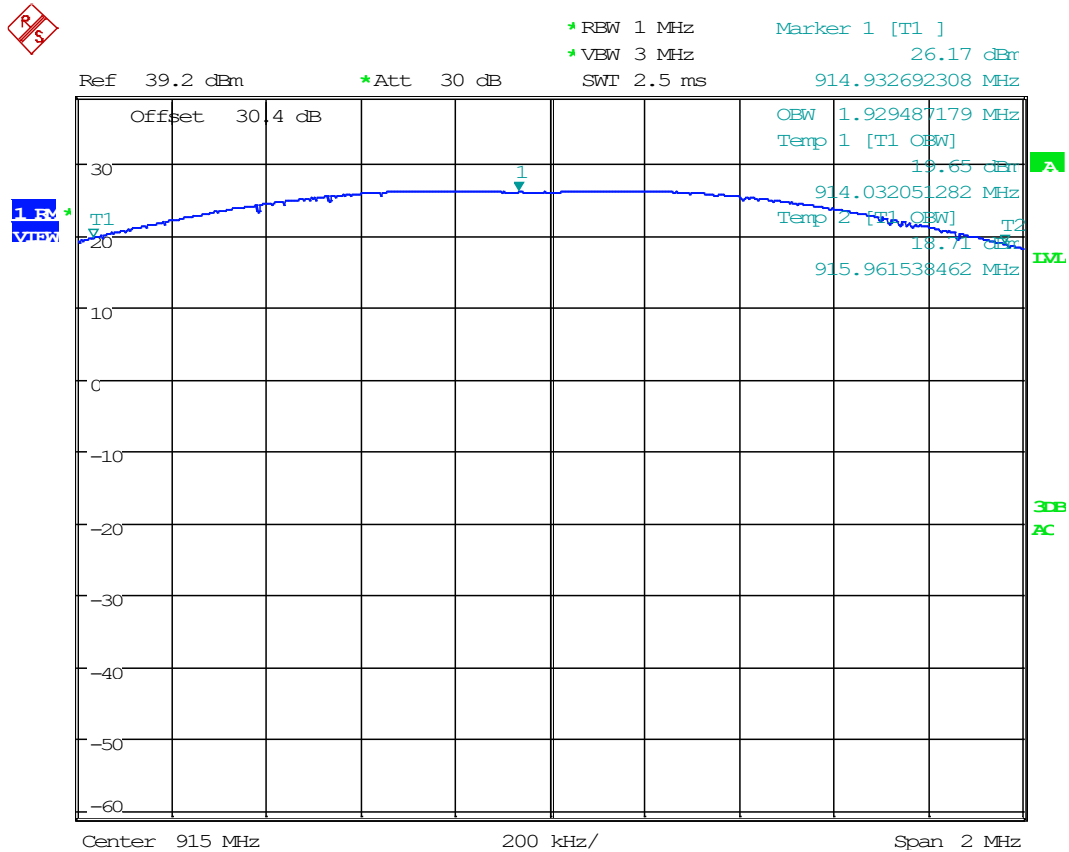

8.2.2 Conducted Output Power Test Data / Spectrum Plots, 915 MHz

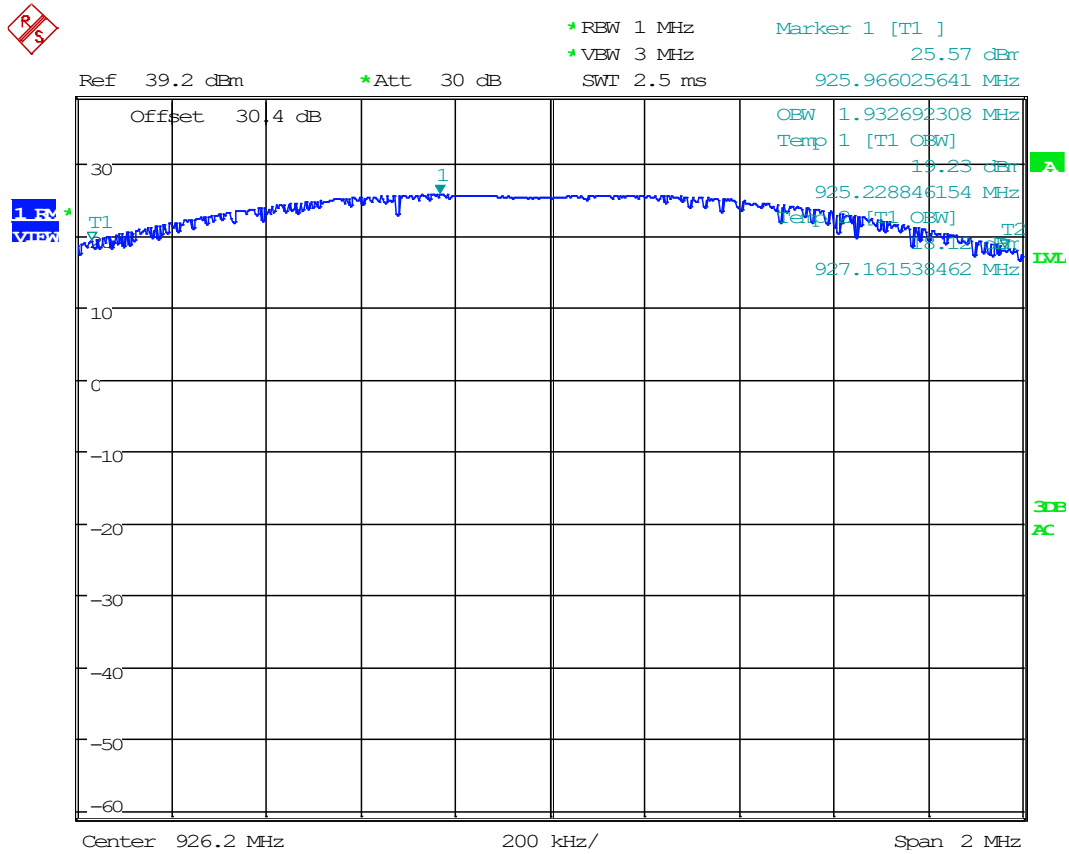

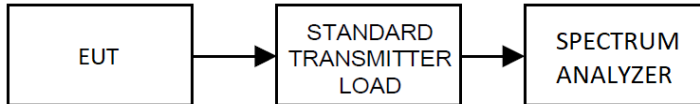

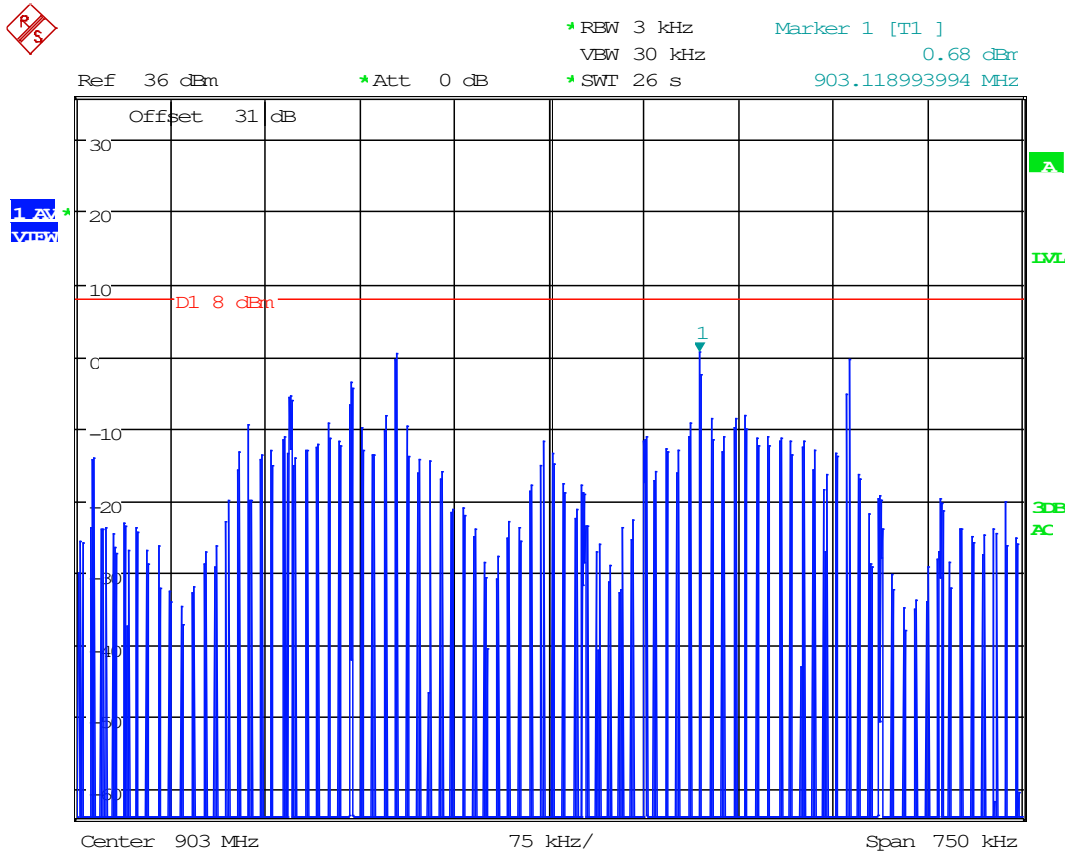

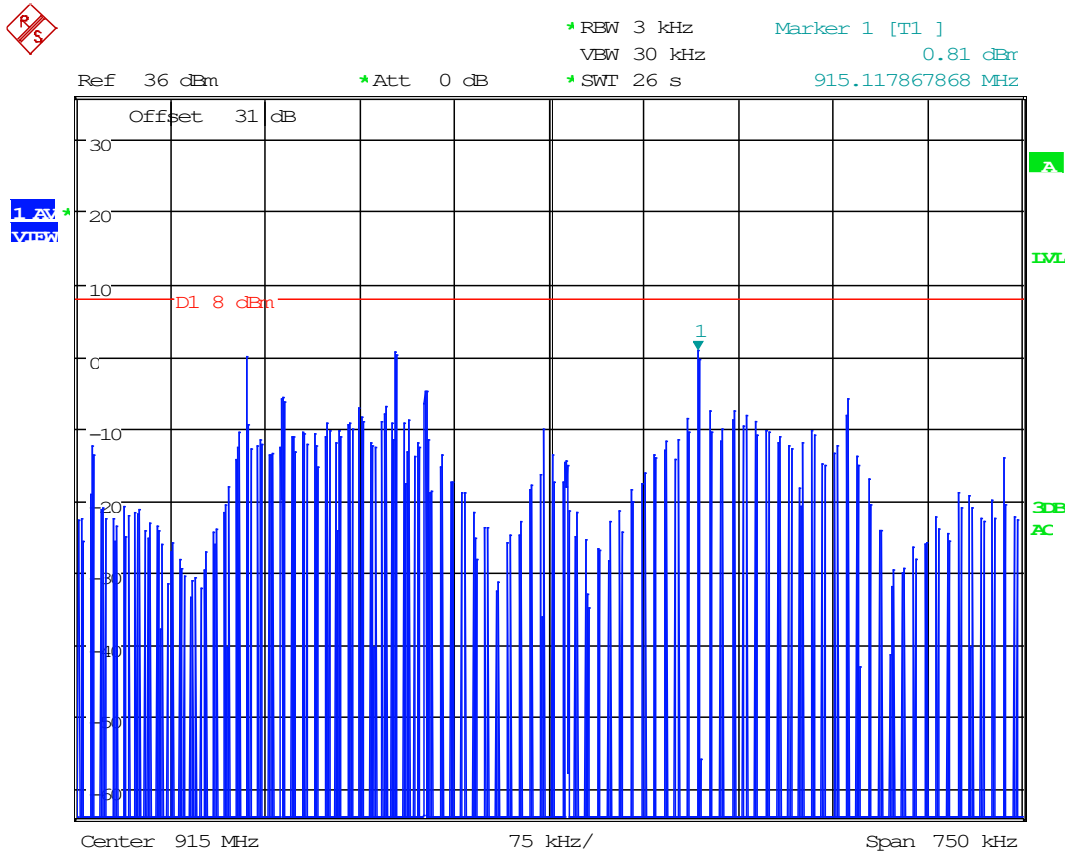


8.3.1 Power Spectral Density (PSD) Test Data / Spectrum Plots, 903 MHz



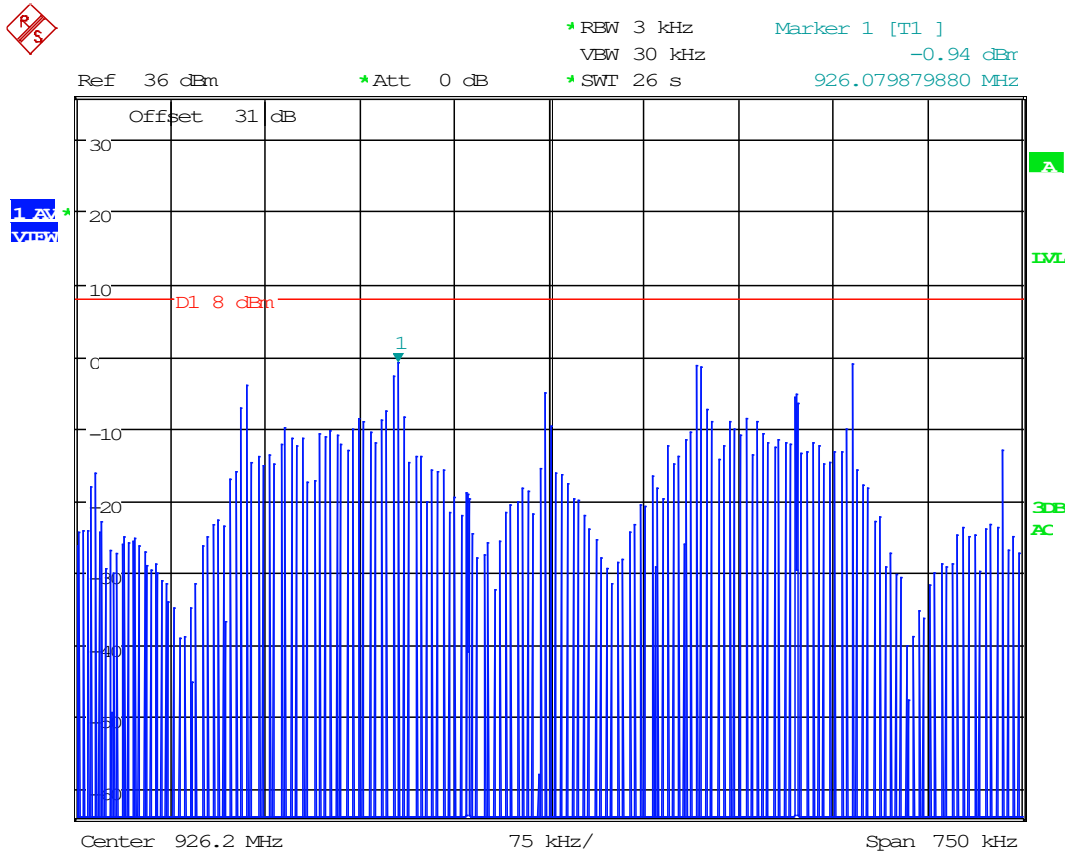

8.3.3 Power Spectral Density (PSD) Test Data / Spectrum Plots, 926.2 MHz

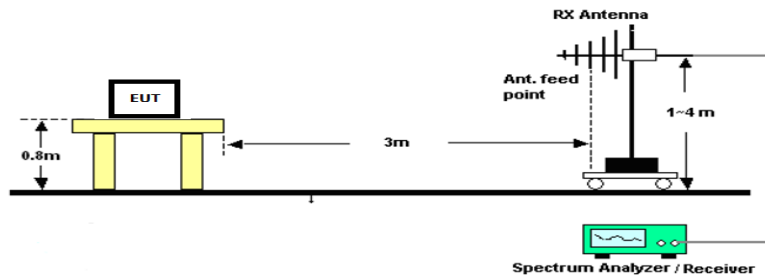

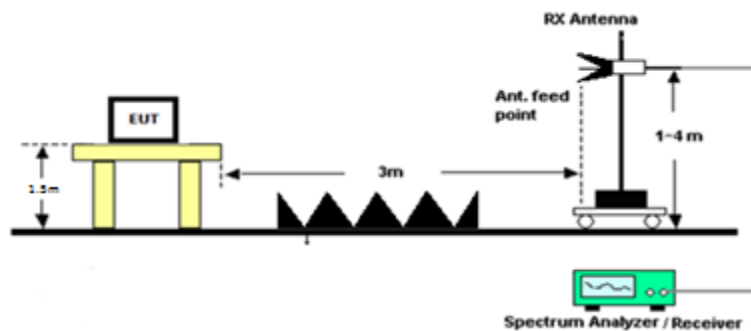

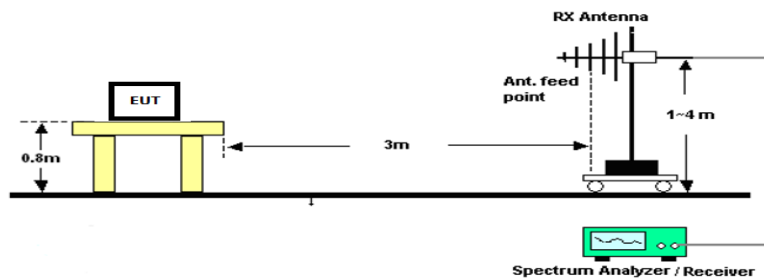

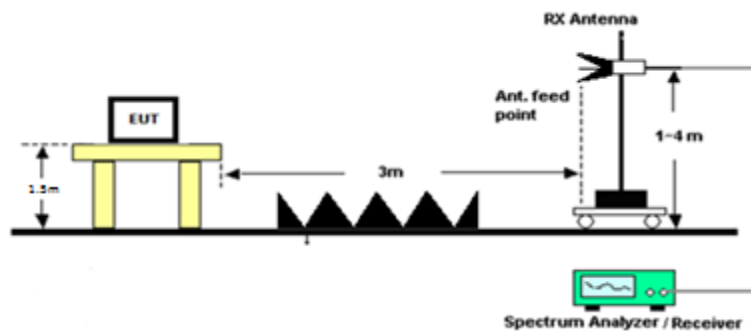
Conducted Test Setup



Radiated Test Setup, 30 – 1000 MHz



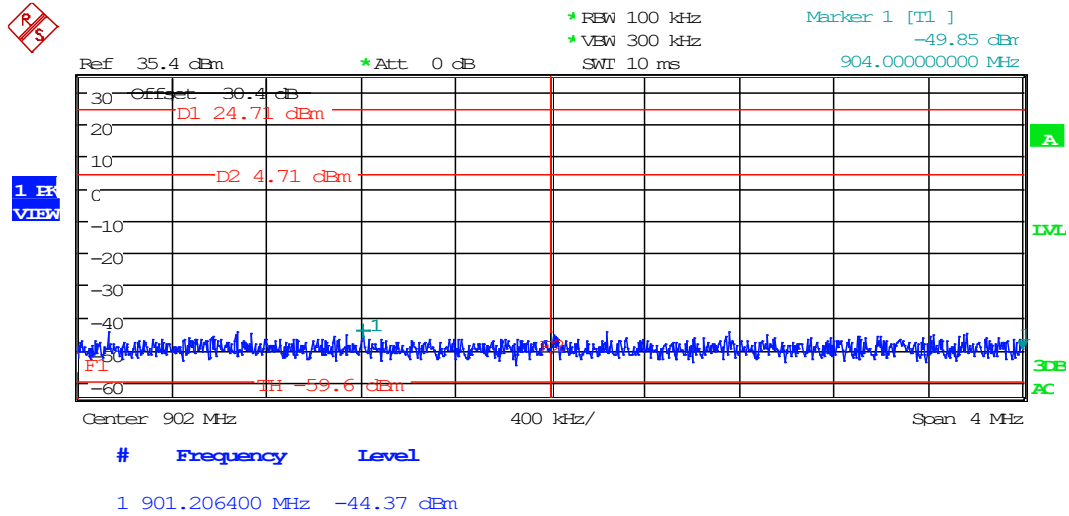
Radiated Test Setup, Above 1000 MHz

8.5.1 Lower Band Edge Plot

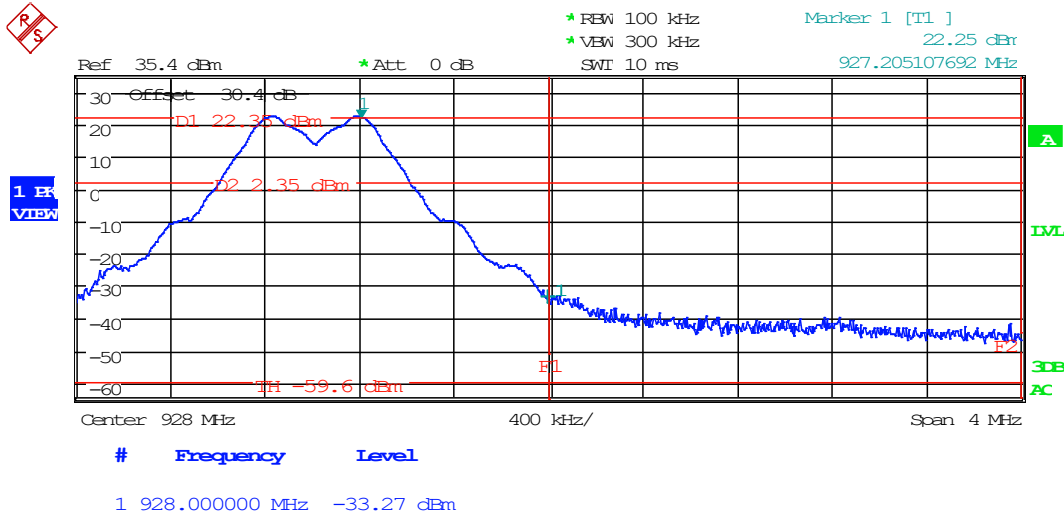
