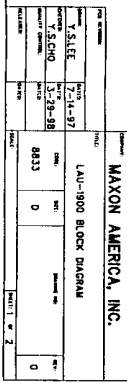
LAU-1900 TEL-LINE INTERFACE & CID SCHEMATIC

LAU-1900 PCS MODULE BLOCK DIAGRAM

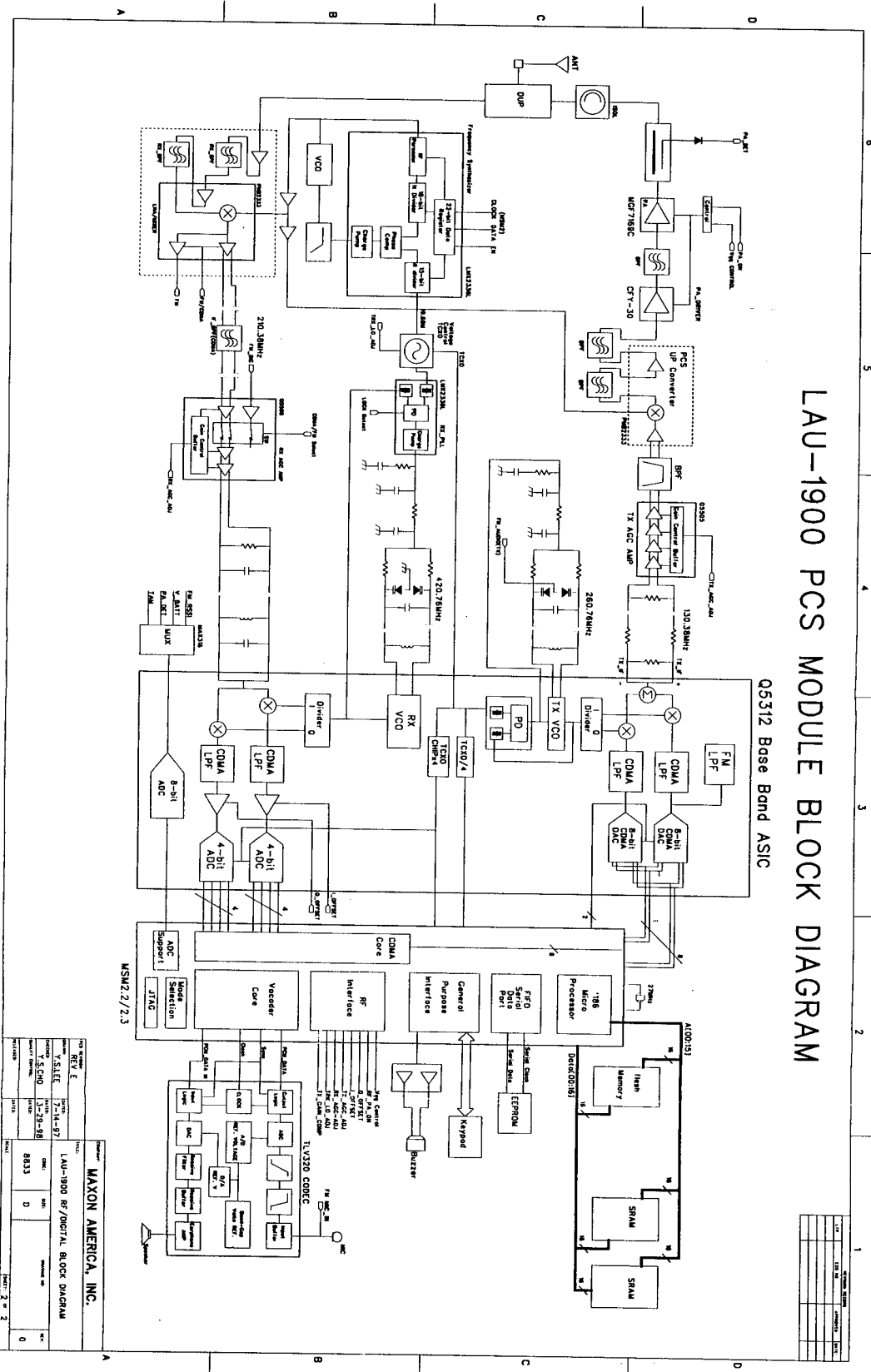
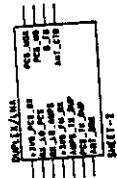
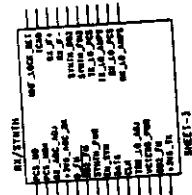
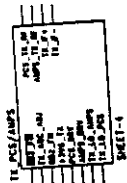
