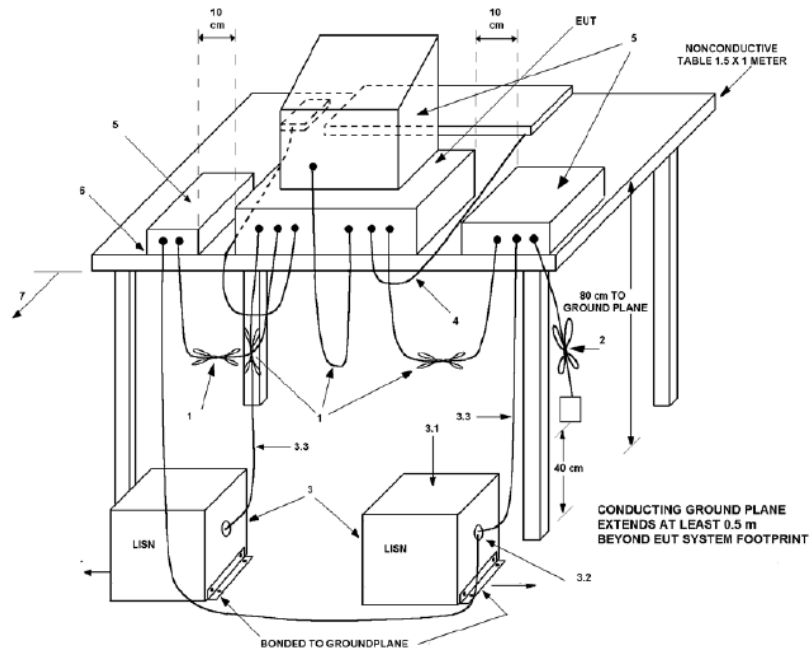

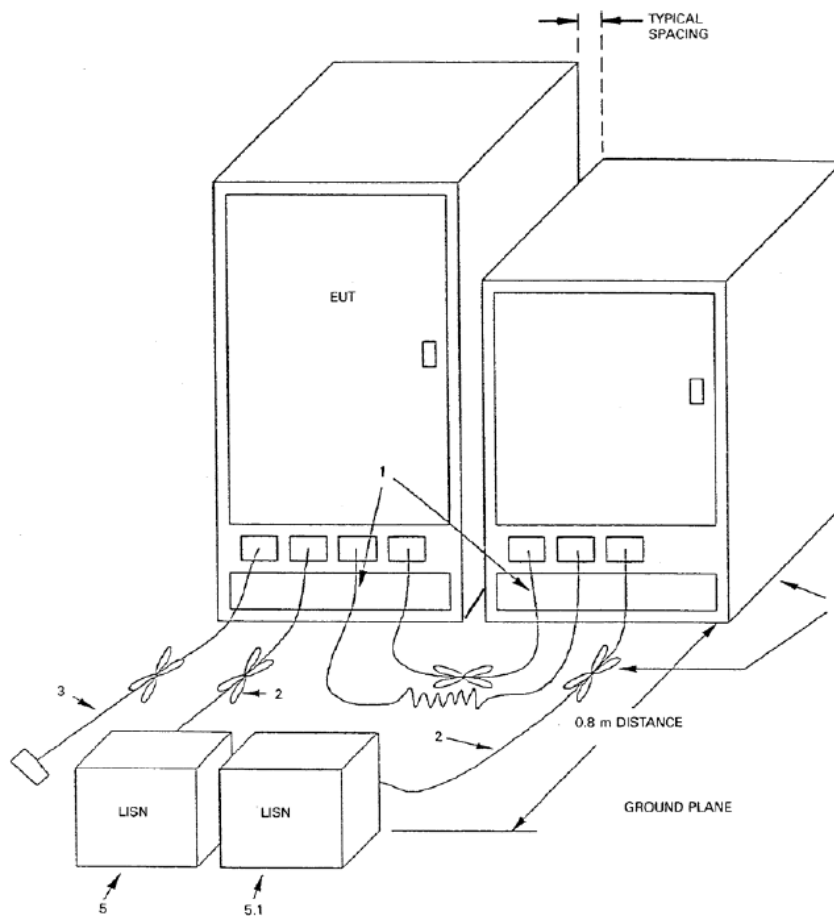

Measurement was performed in shielded room, and instruments used were following clause 4 and clause 5 of ANSI 63.4.

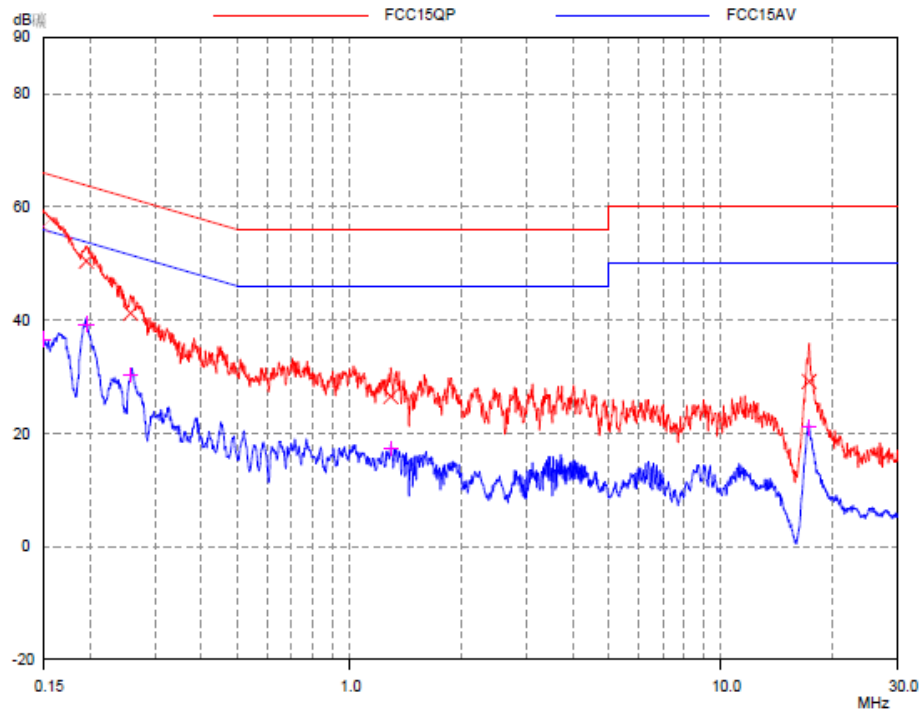
Detailed test procedure was following clause 7.3 of ANSI 63.4.

EUT arrangement and operation conditions were according to clause 6 and clause 7 of ANSI 63.4.

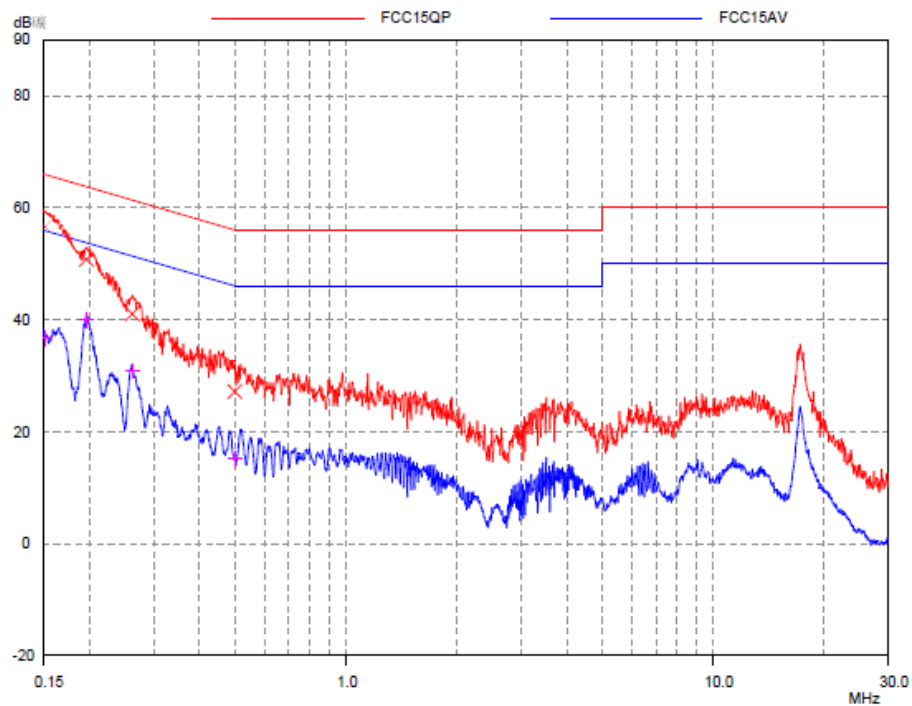
Frequency range 150kHz – 30MHz was checked and EMI receiver measurement bandwidth was set to 9 kHz.

Example: Assuming LISN Factor = 10.00dB, Cable Loss = 2.00dB,
 Original Receiver Reading = 10.00dBuV, Limit = 66.00dBuV.
 Then Correct Factor = 10.00 + 2.00 = 12.00dB;
 Corrected Reading = 10dBuV + 12.00dB = 22.00dBuV;
 Margin = 66.00dBuV – 22.00dBuV = 44.00dB.

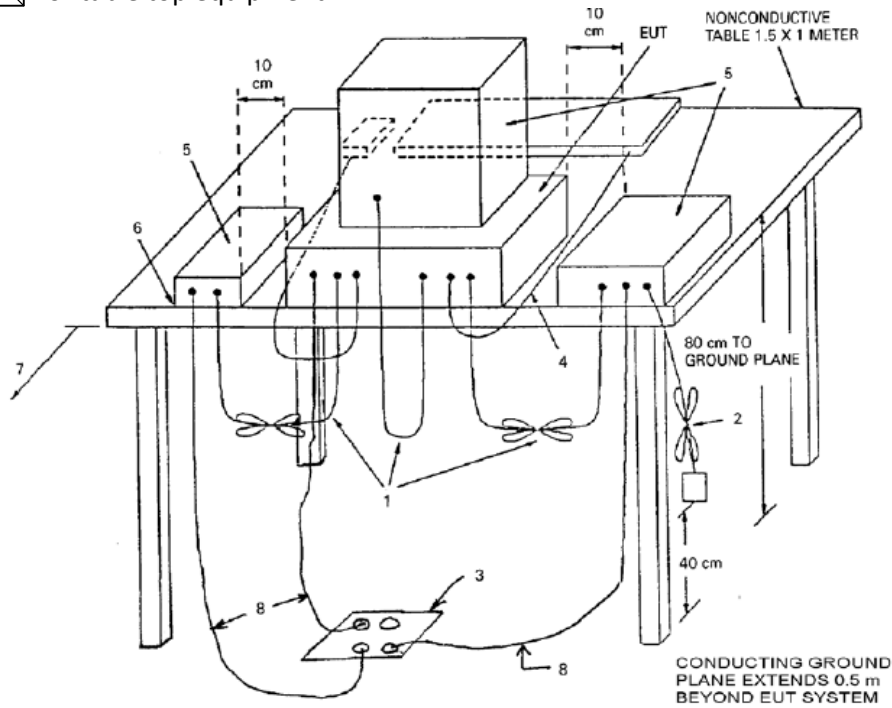

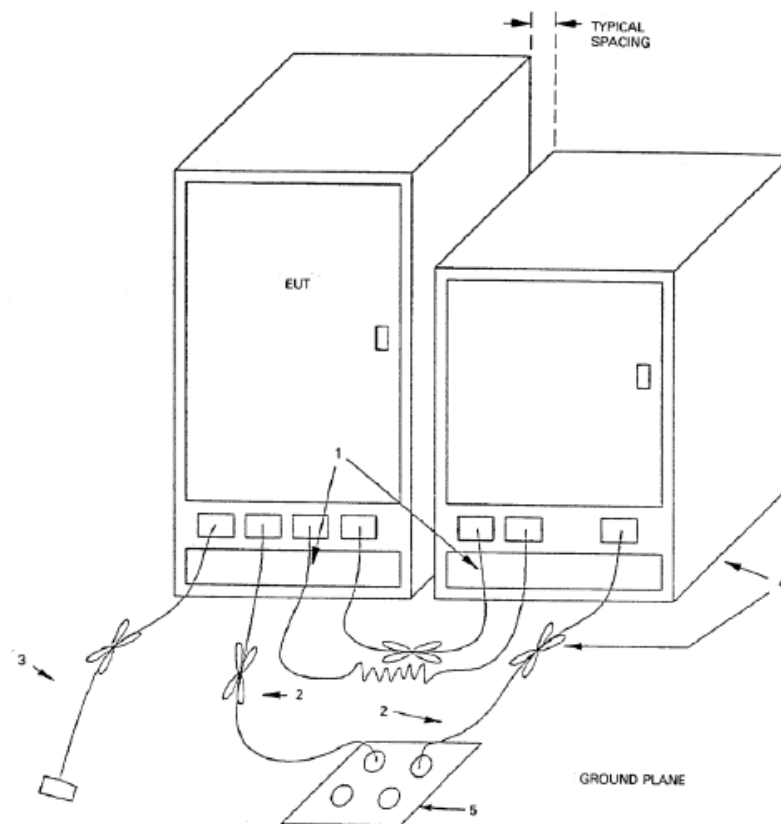

4.3 Test Setup and Test Procedure

The measurement was performed in a semi-anechoic chamber.

The distance from EUT to receiving antenna is 3 meter.

Measurement was performed according to clause 4 and clause 5 of ANSI 63.4.

Test procedure was according to clause 8.3 of ANSI 63.4.

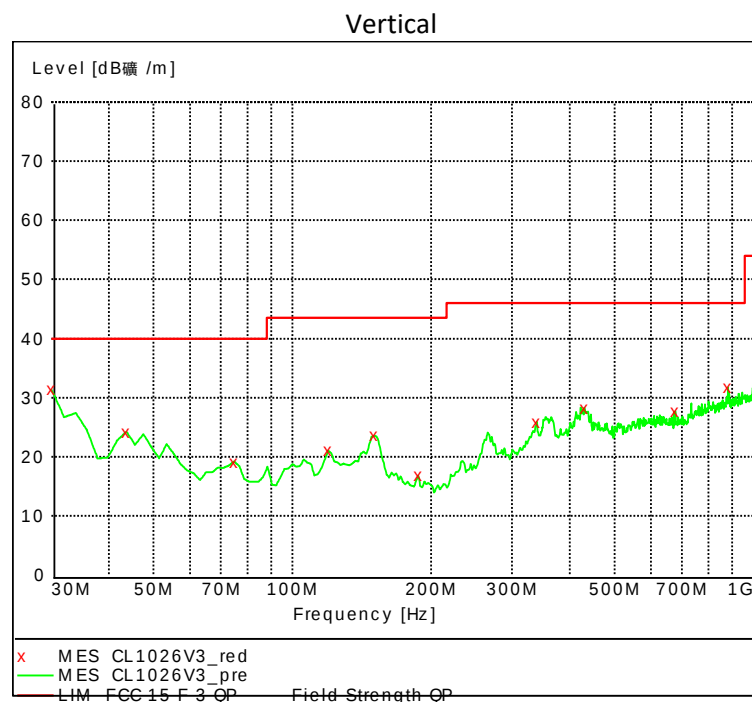
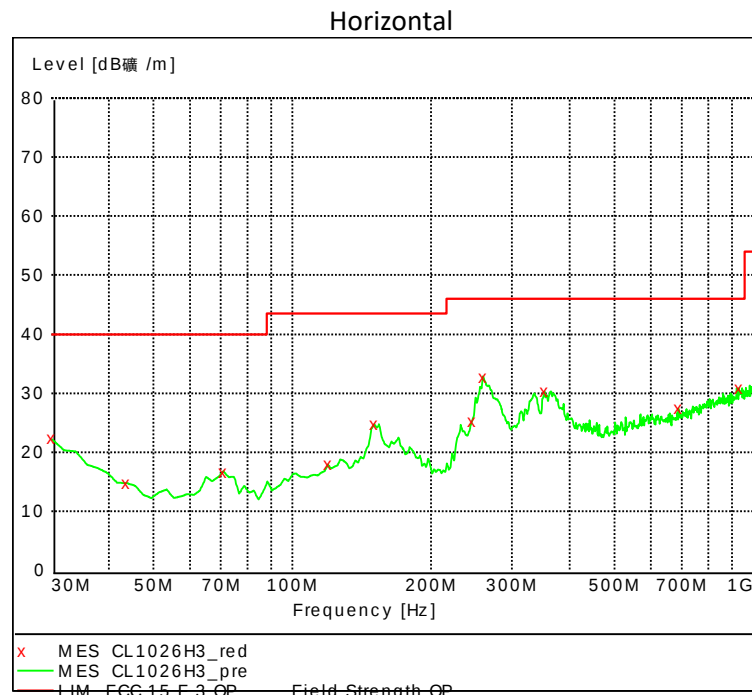
EUT arrangement and operate condition were according to clause 6 and clause 8 of ANSI 63.4.

The bandwidth setting on R&S Test Receiver was 120 kHz.

The required measurement frequency range was checked.
