2. GENERAL INFORMATION

2.1 GENERAL DESCRIPTION OF EUT

Note: The EUT is a dual-speed (10/100Mbps) hub with sixteen 10/100BASE-TX ports. It allows you to set up a network with both Ethernet (10Mbps) and Fast Ethernet (100Mbps) workstations and other devices. The port senses the speed of the connected equipment and operates at the appropriate speed.

The EUT has two model names which are identical to each other in all aspects except for the following:

Model: 3C16751, brand: 3COM

Model: EH3016-32, brand: ACCTON

From the above models, model: 3C16751 was selected as representative model for the test, and its data is recorded in this report.

The EUT is supplied with a power adapter, made by BTC model: ADP-305 with nonshielded power cord.

The rating of the power adapter is Input: 100V~240Vac, 47~63 Hz, 1A, Output: 5V, 6A. There is a manufacturer-implemented ferrite core on the DC power cable (1.2m) connected to the EUT.

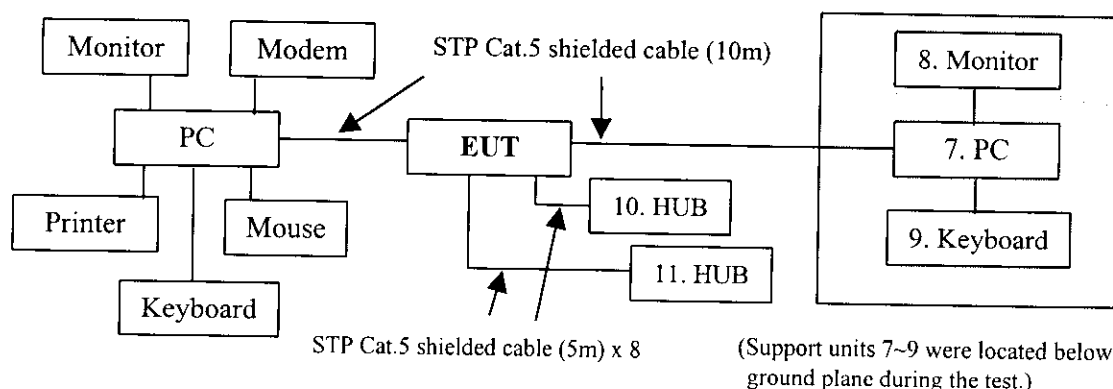

Note: 1. Support unit 1 acted as SERVER PC and communicated with support unit 7-9 which acted as HOST PC and systems of communication partner. They communicated with each other via EUT at 100Mbps speed with two STP (Shielded Twisted Pair) cables (10m). The HOST PC was kept in the control room.

2. Other ports of the EUT were connected to support unit 10,11 via a STP cable (5M) individually and support unit 10,11, were located under the test table in a stack.



2.3 TEST METHODOLOGY AND CONFIGURATION

Both conducted and radiated testing were performed according to the procedures in ANSI C63.4:1992. Radiated testing was performed at an antenna to EUT distance of 10 m on an open area test site. Please refer to the photos of test configuration in Item 5.

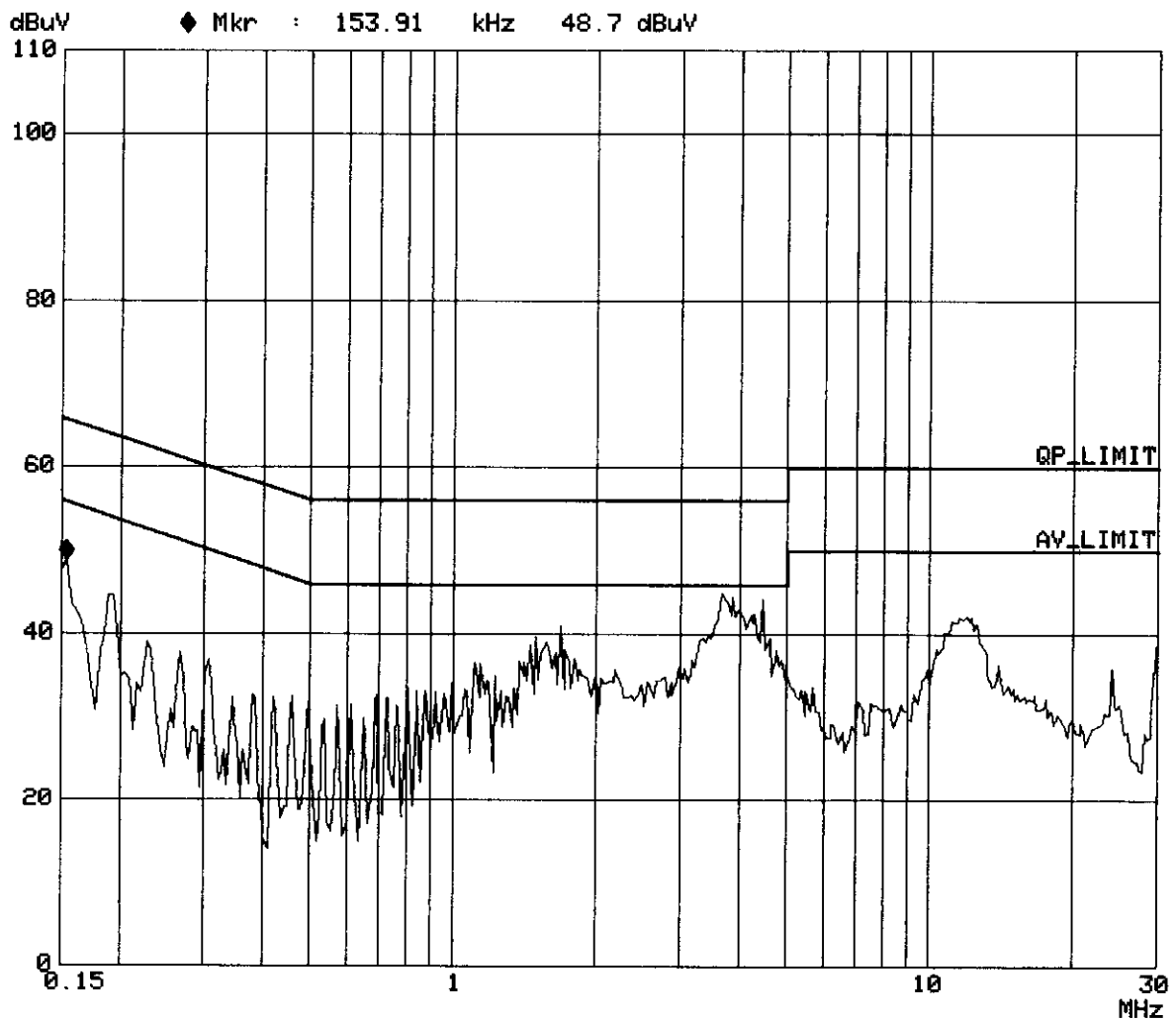

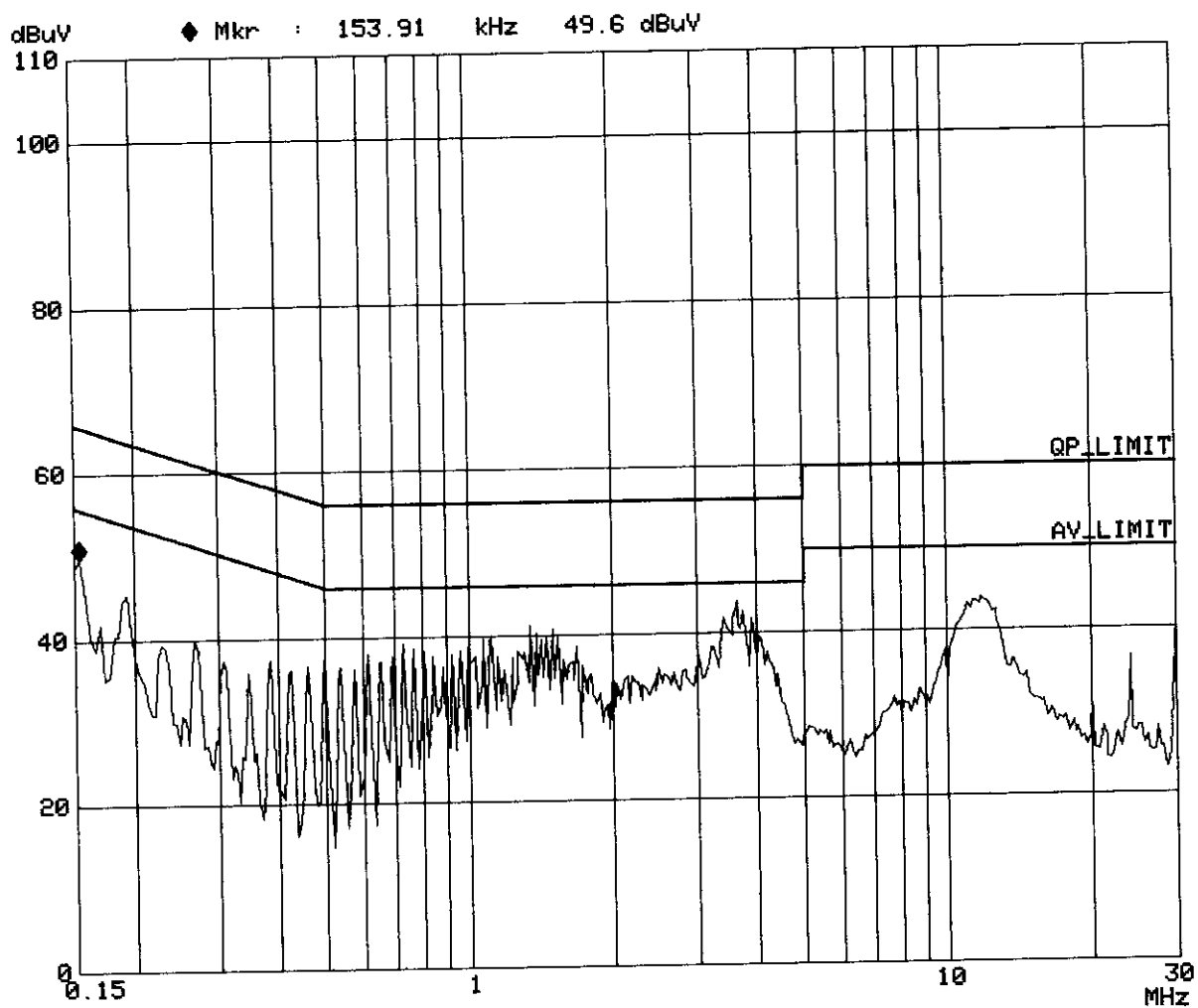
