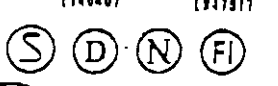
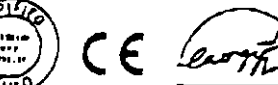


Drawing of Model Nameplate

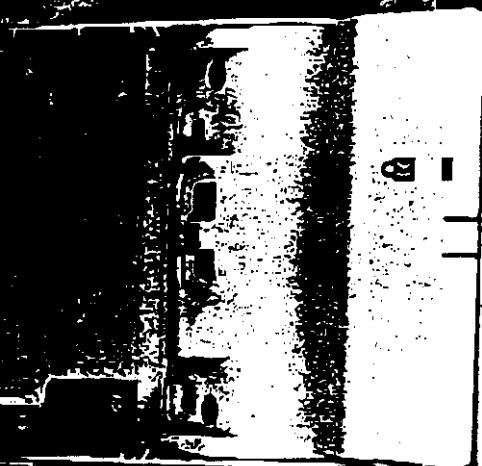
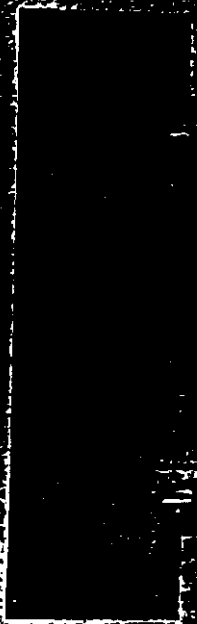
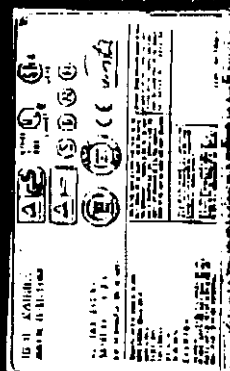
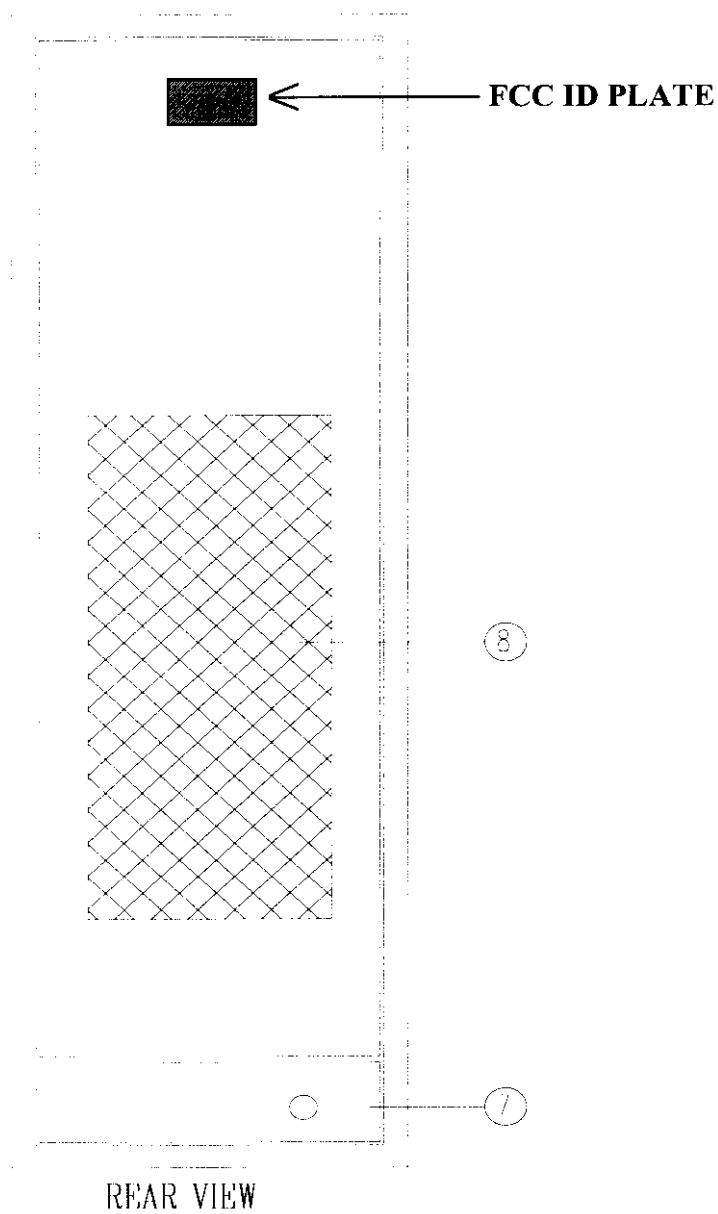


Fig. 3 Rear view of TX-05(31NMF) without pedestal ring
