3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 Part 15 Subpart C.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

3.2 EUT EXERCISE

The calibrated antennas used to sample the radiated field strength are mounted on a non-conductive, motorized antenna mast 3 or 10 meters from the leading edge of the turntable.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 7.1 of ANSI C63.4. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-Peak detector mode.

Radiated Emissions

The EUT is placed on a turntable, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

- (b) Except as provided in paragraphs (d) and (e), the field strength of emissions appearing within these frequency bands shall not exceed the limits shown in Section 15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in Section 15.35 apply to these measurements.

3.5 DESCRIPTION OF TEST MODES

The EUT (model: PMD-B100-CR) had been tested under operating condition and tested in continuous transmitting mode.

During the test, boot into Windows CE, execute the player program and played a 1kHz tone mp3.

Audio signal is then modulated through the FM transmitter and Channel Low (88.3MHz), Channel Mid (106.7MHz) and Channel High (107.7MHz) were chosen for full testing.

The field strength of spurious emission was measured in the following position: EUT stand-up position (Z axis), lie-down position (X, Y axis) and cradle mode. The worst emission was found in cradle mode and the worst case was recorded.



4. INSTRUMENT CALIBRATION

4.1 MEASURING INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipment, which is traceable to recognized national standards.

4.2 MEASUREMENT EQUIPMENT USED

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with preselectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

The test facilities used to perform radiated and conducted emissions tests are accredited by National Voluntary Laboratory Accreditation Program for the specific scope of accreditation under Lab Code: 200600-0 to perform Electromagnetic Interference tests according to FCC PART 15 AND CISPR 22 requirements. 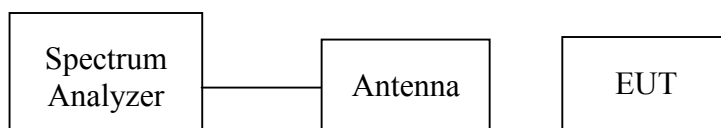
7. FCC PART 15.239 REQUIREMENTS

7.1 20 dB BANDWIDTH

LIMIT

According to §15.239(a), emissions from the intentional radiator shall be confined within a band 200kHz wide centered on the operating frequency. The 200kHz band shall lie wholly within the frequency range of 88-108 MHz.

Test Configuration



TEST PROCEDURE

1. Place the EUT on the table and set it in the transmitting mode.
2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
3. Set the spectrum analyzer as RBW=10kHz, VBW = RBW, Span = 1MHz, Sweep = auto.
4. Mark the peak frequency and 20dB (upper and lower) frequency.
5. Repeat until all the rest channels are investigated.

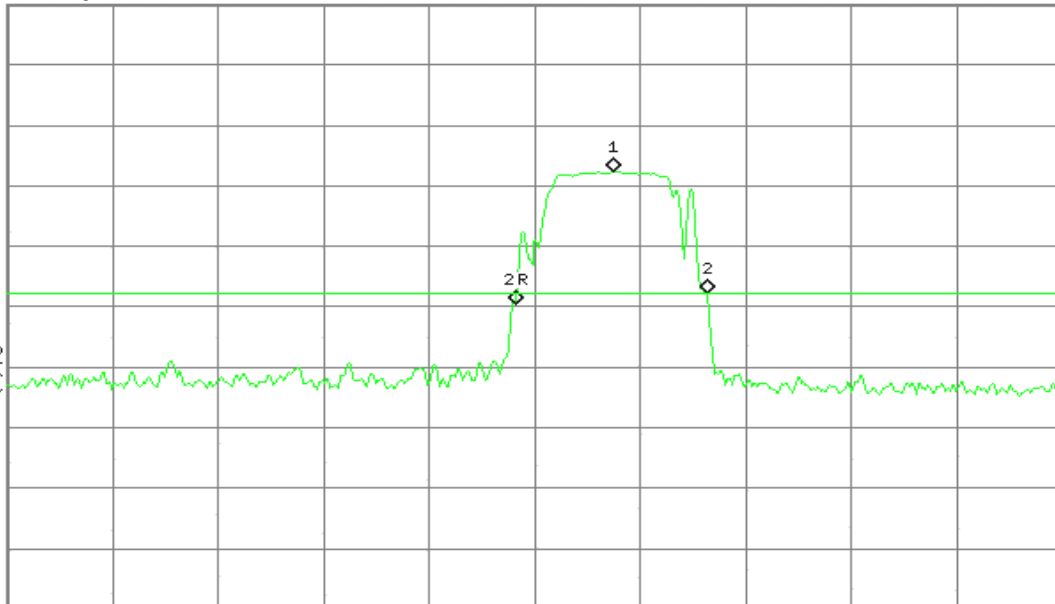

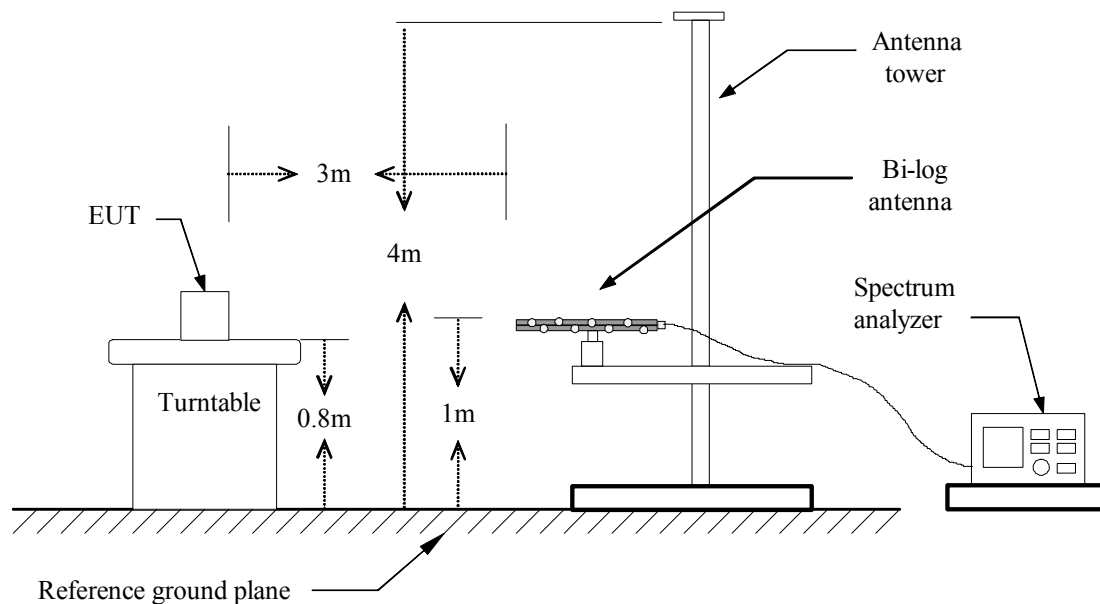


7.2 BAND EDGES MEASUREMENT

LIMIT

According to §15.239(c), the field strength of any emissions radiated on any frequency outside of the specified 200kHz band shall not exceed the general radiated emission limits in Section 15.209.

Test Configuration



TEST PROCEDURE

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Position the EUT as shown in figure 1 and measurement the turn on the EUT. Then set it to any one measured frequency within its operating range and make sure the instrument is operated in its linear range.
3. Set both RBW and VBW of spectrum analyzer to 100kHz and 100kHz respectively with a convenient frequency span including 200kHz bandwidth of the emission.
4. Mark the bandwidth of 200kHz points and plot the graph on spectrum analyzer.
5. Repeat the procedures until all measured frequencies were complete.

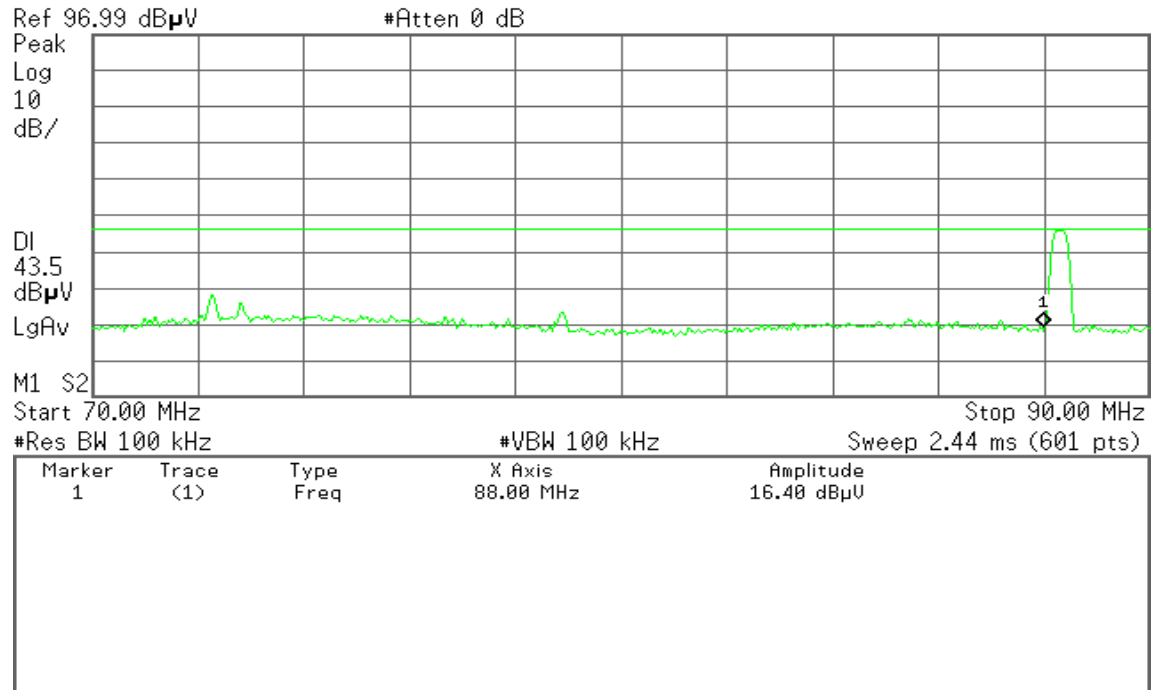

Polarity: Vertical

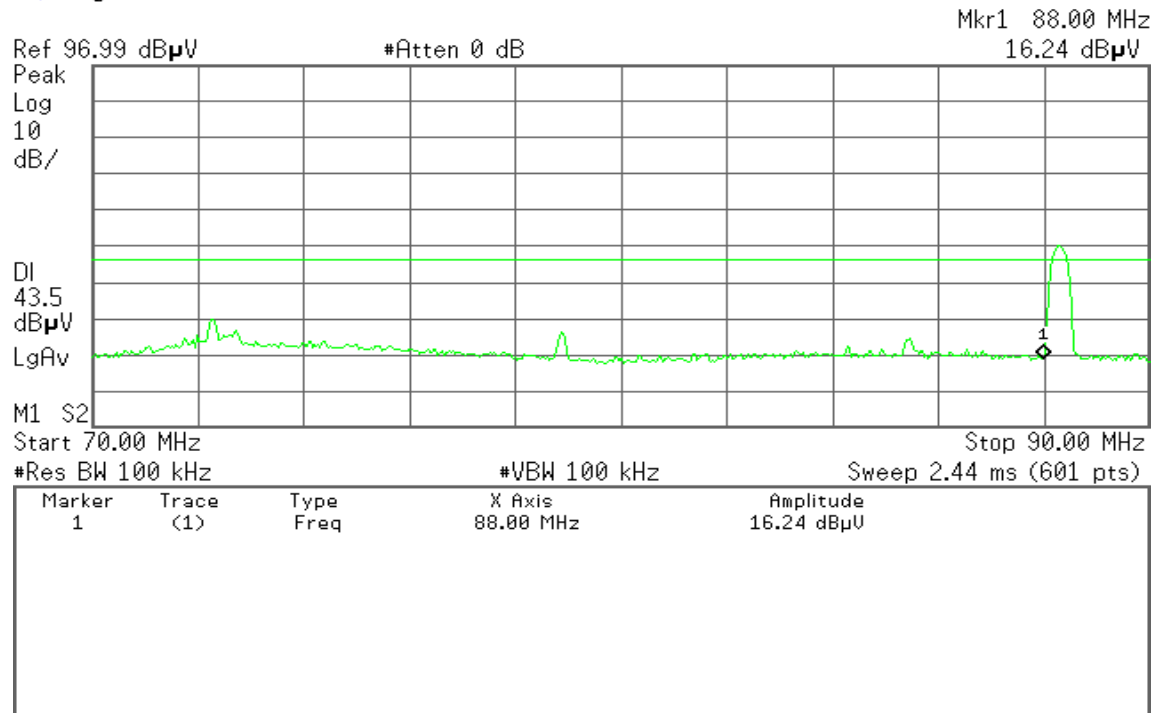

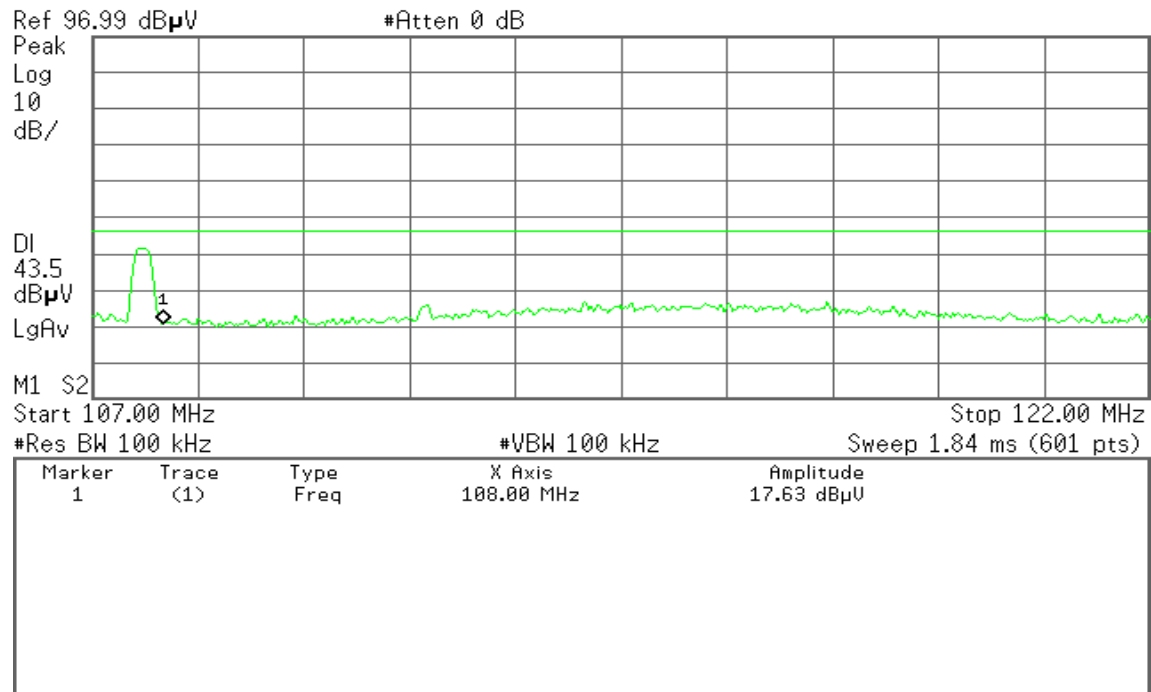


Band Edges (CH High)

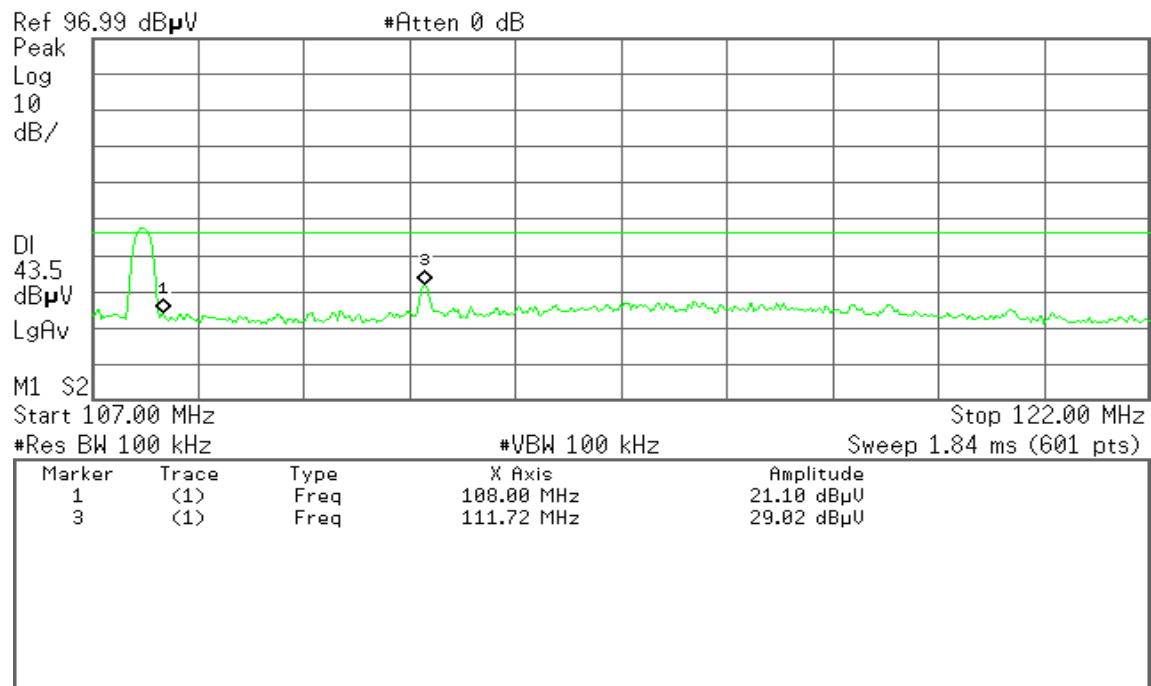

7.3 RADIATED EMISSIONS

LIMIT

1. The field strength of any emission within this band (section 15.239 frequency between 88 MHz –108 MHz) shall not exceed 250 microvolts /meter at 3 meters. (48dB μ V/m at 3m) The emission limit in this paragraph is based on measurement instrumentation employing an average detector. The provisions in section 15.35 for limiting peak emissions apply.

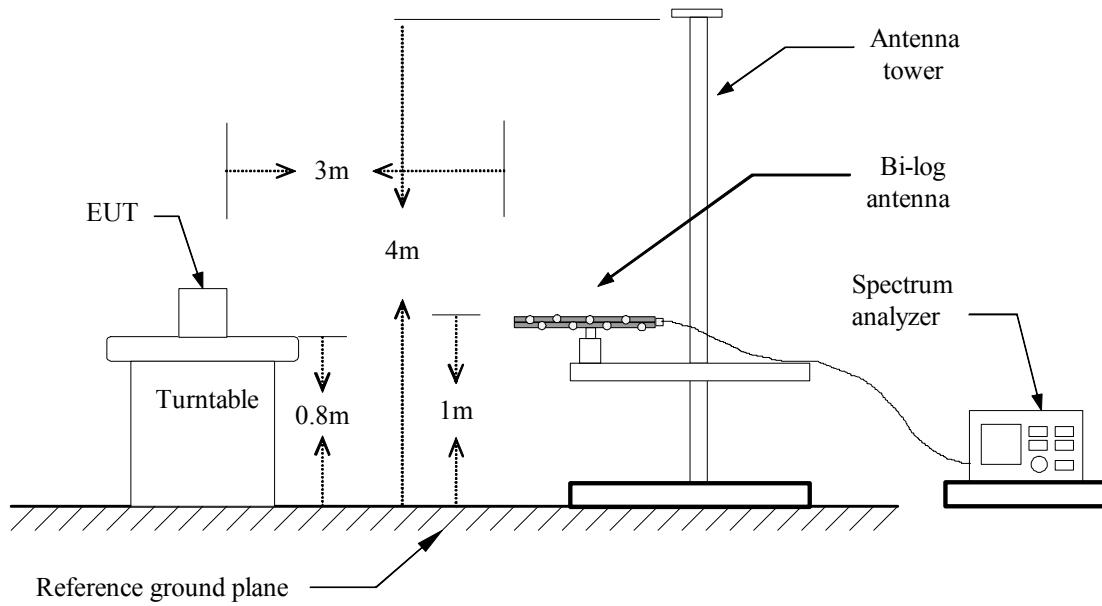

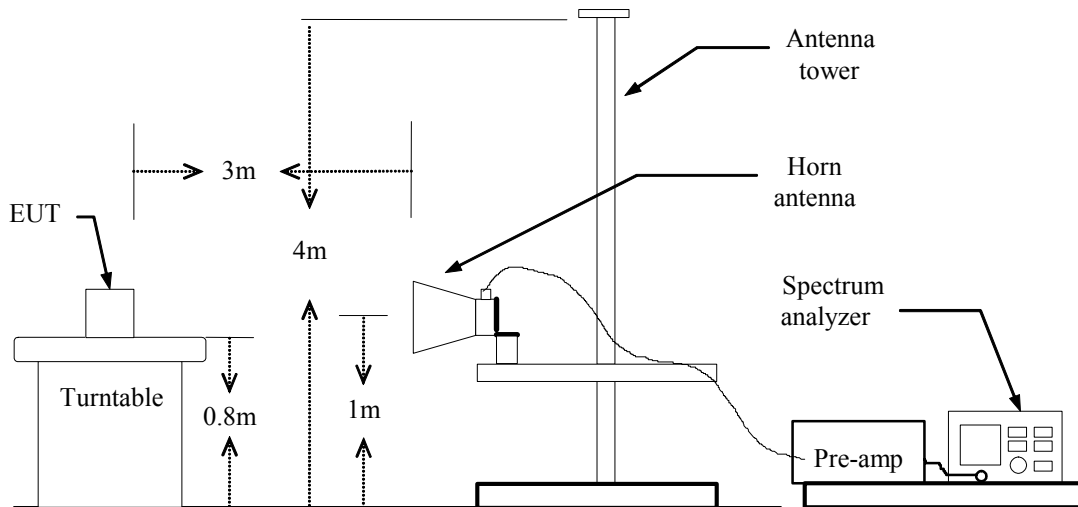

1. The EUT is placed on a turntable, which is 0.8m above ground plane.
2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emissions.
4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
6. Set the spectrum analyzer in the following setting as:

Below 1GHz:

RBW=100kHz / VBW=300kHz / Sweep=AUTO

Above 1GHz:

(a) PEAK: RBW=VBW=1MHz / Sweep=AUTO

(b) AVERAGE: RBW=1MHz / VBW=10Hz / Sweep=AUTO

7. Repeat above procedures until the measurements for all frequencies are complete.

7.4 POWERLINE CONDUCTED EMISSIONS

LIMIT

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range is listed as follows:
