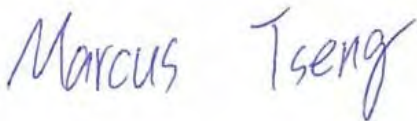

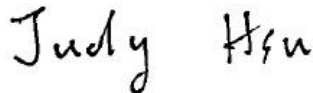

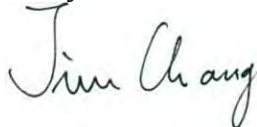

2. SYSTEM TEST CONFIGURATION

2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2. EUT Exercise

The EUT (Transmitter) was tested with a test program to fix the Tx/RX frequency that was for the purpose of the measurements. For more information please see test data and APPENDIX 1 for set-up photographs.

2.3. Test Procedure

2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. According to the requirements in Section 7.3.1 of ANSI C63.4-2009 and RSS-Gen:2010, conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and Average detector mode.

2.3.2 Radiated Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna. according to the requirements in Section 8 and 13 of ANSI C63.4-2009 and DA 00-705..

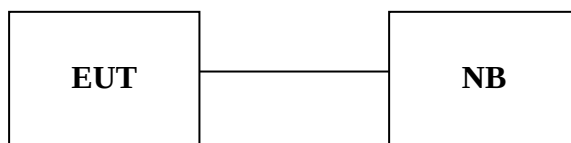

Conducted

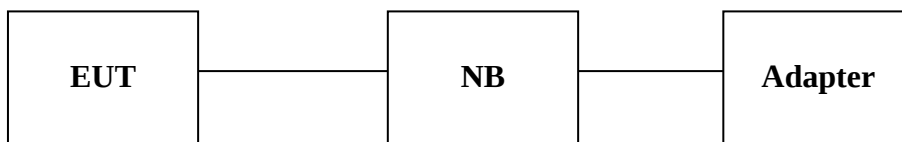

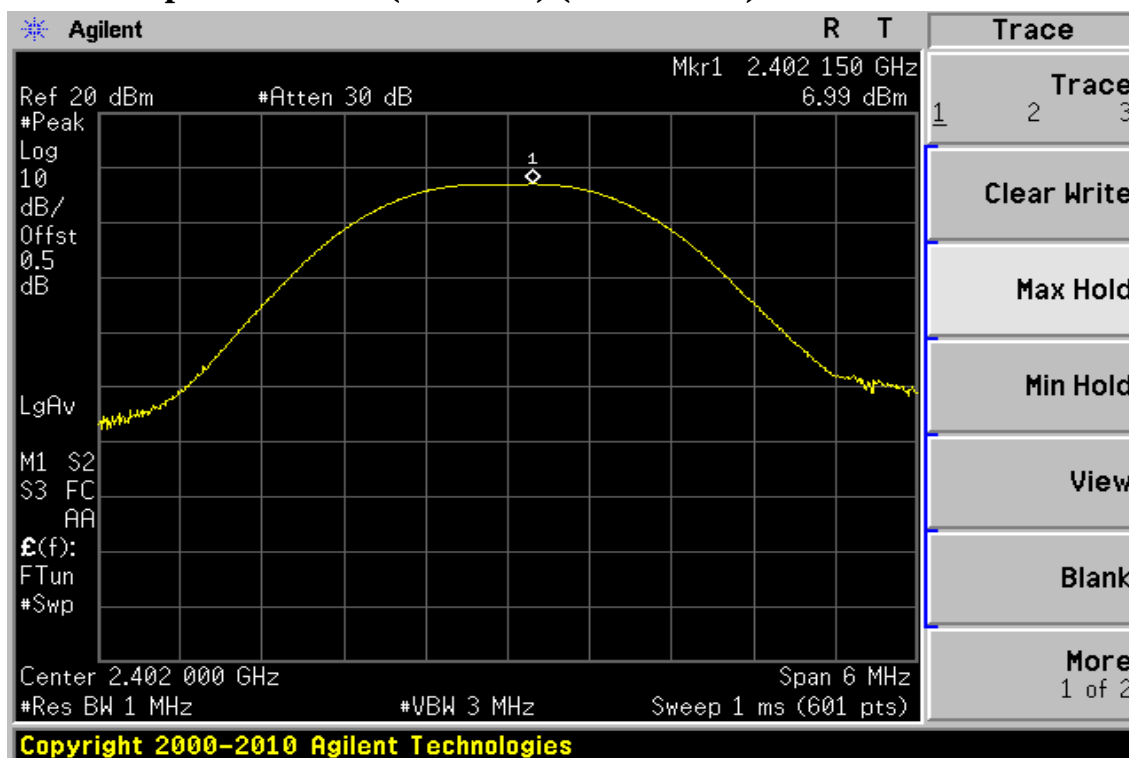

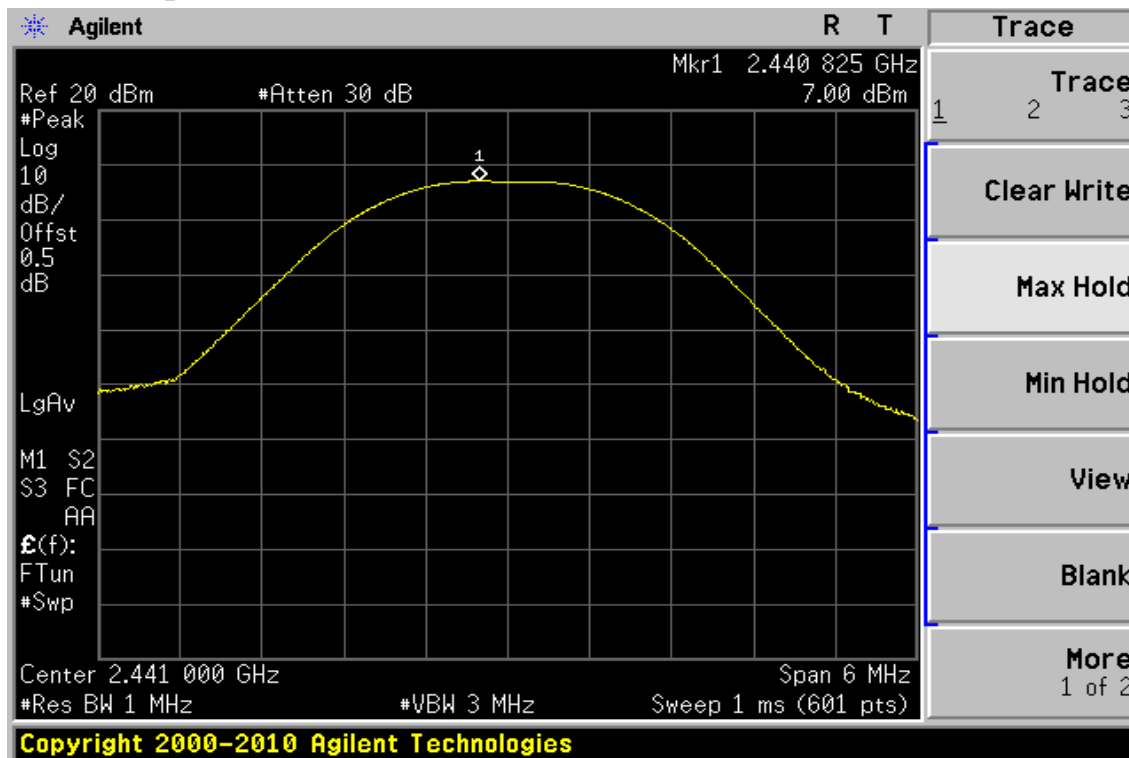

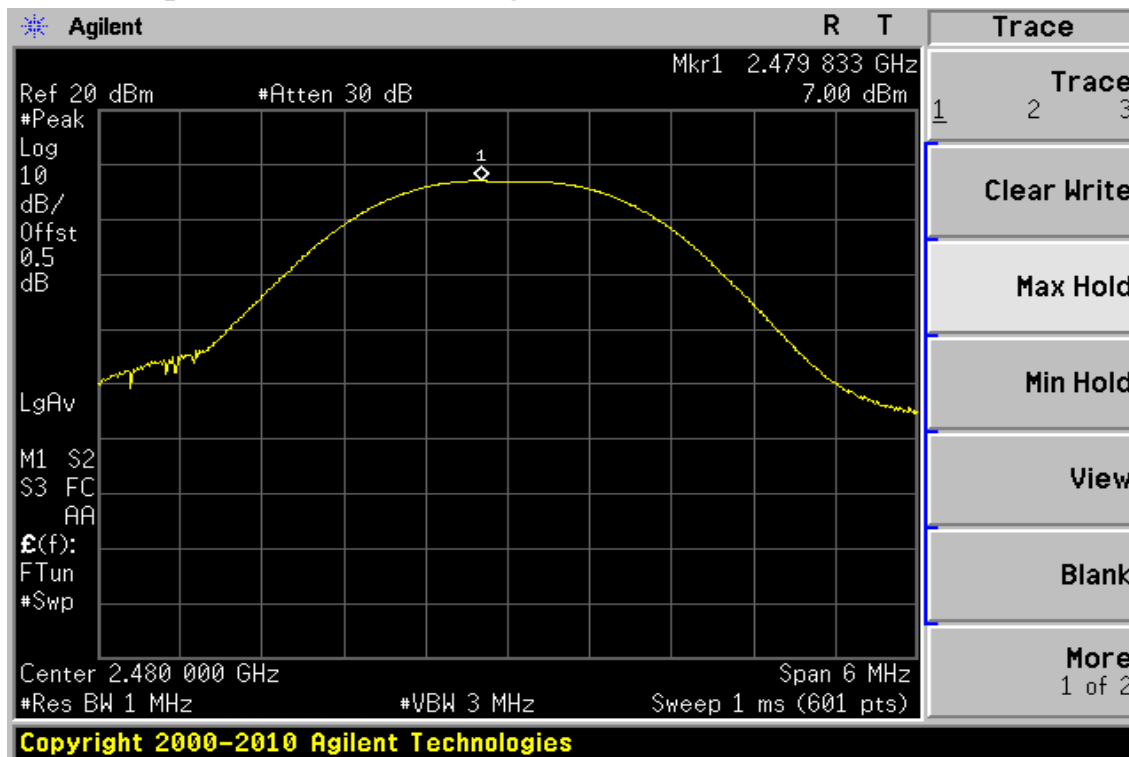

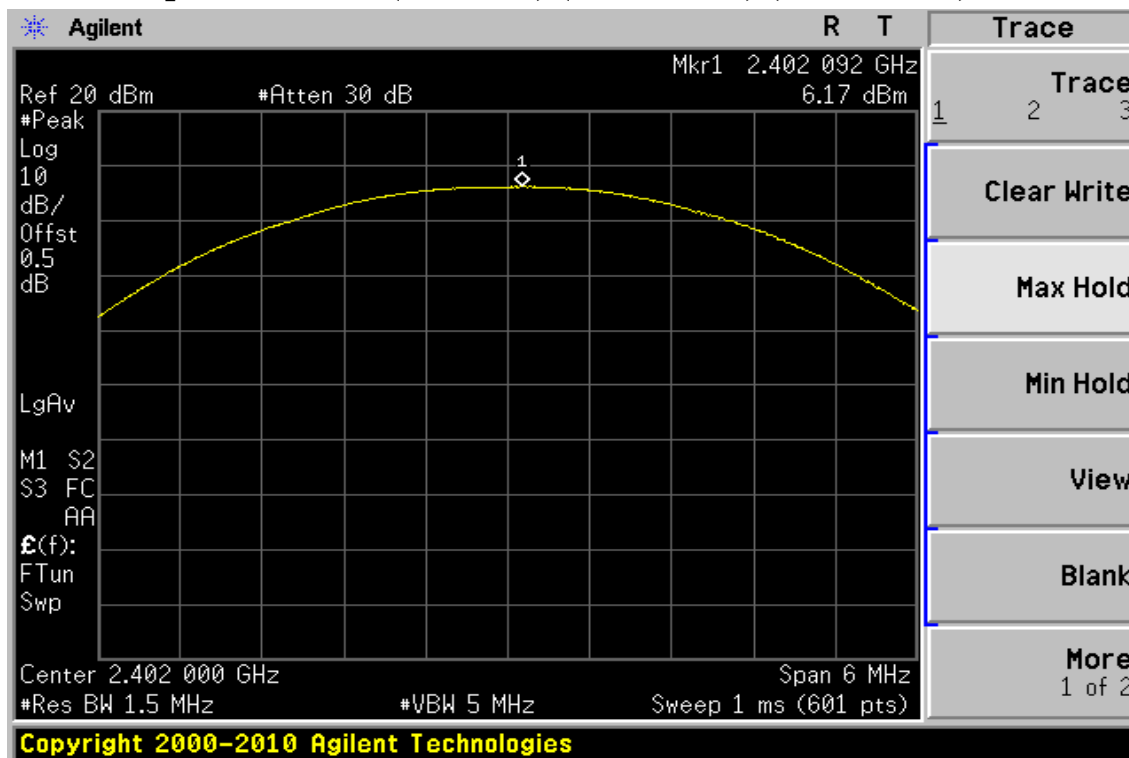

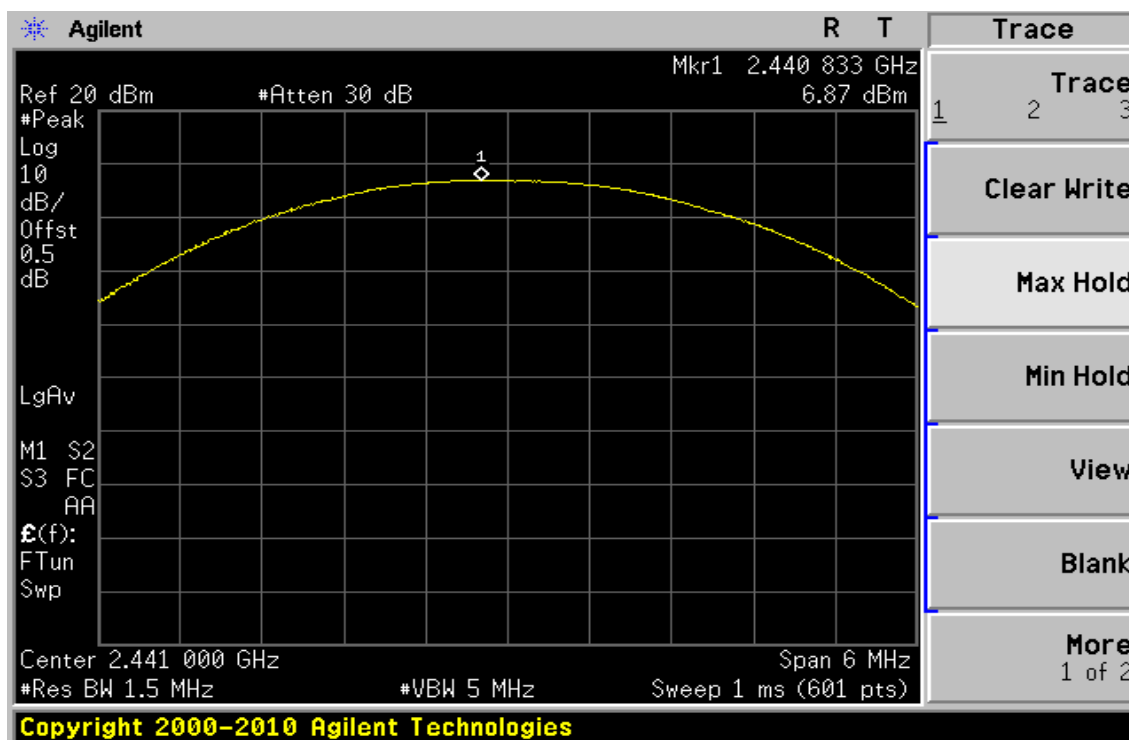

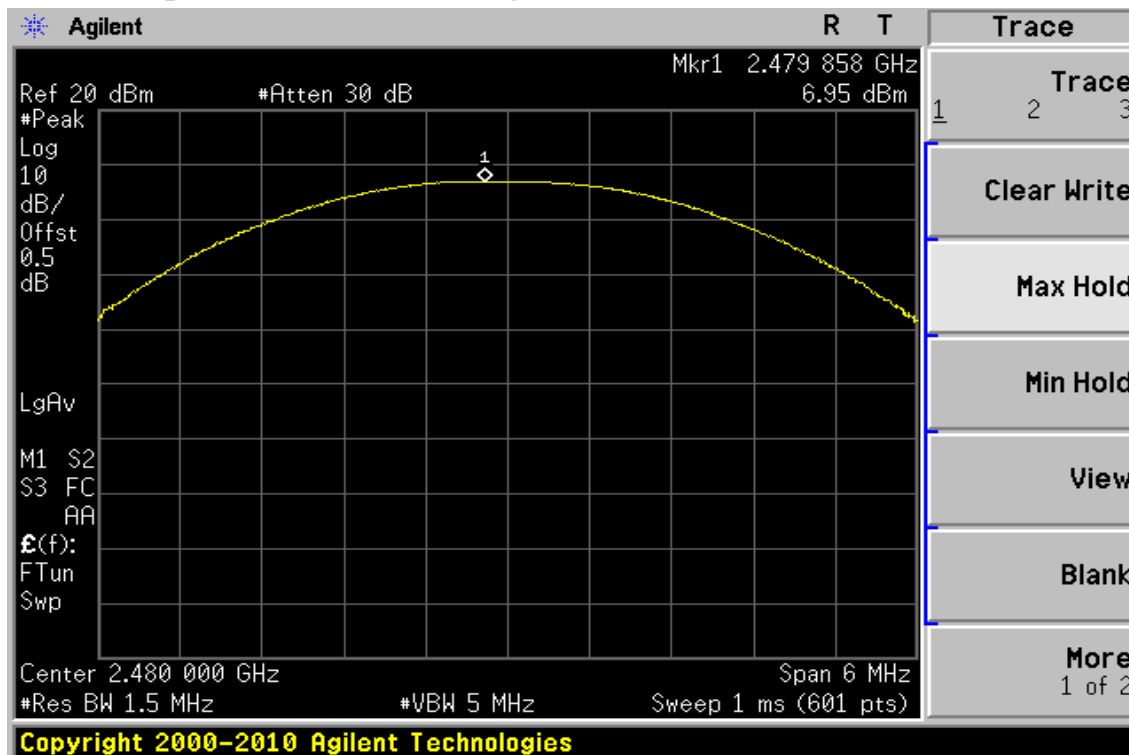

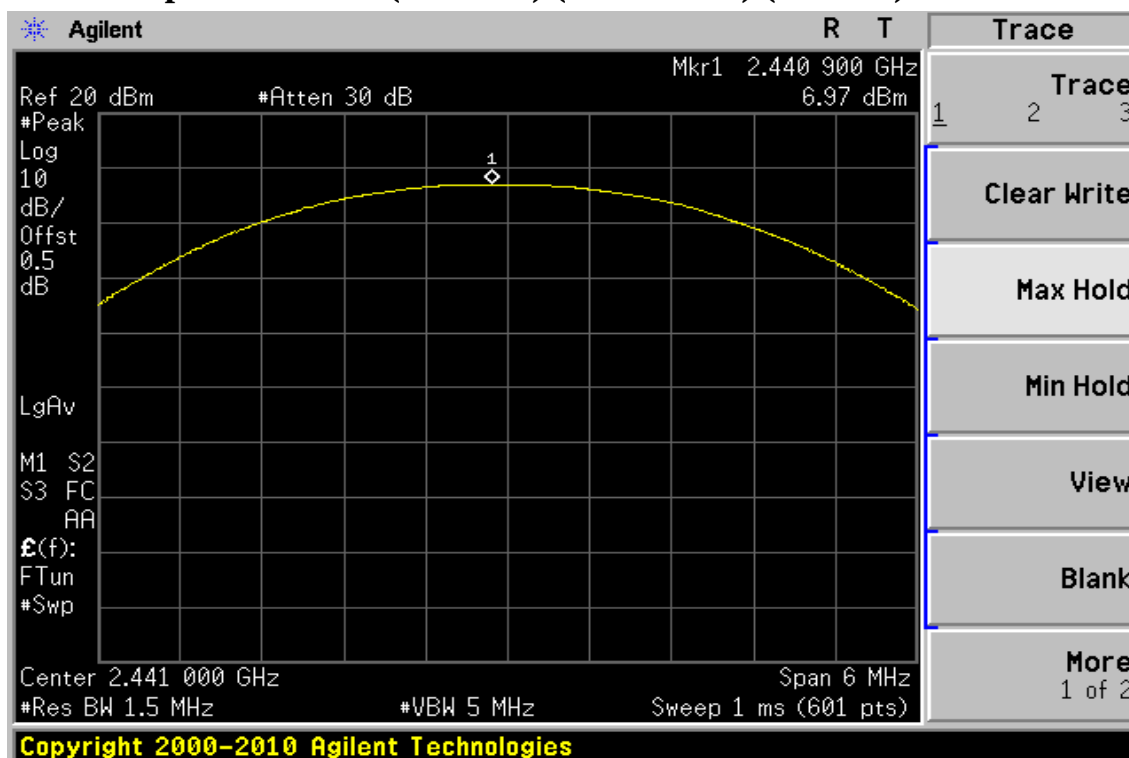

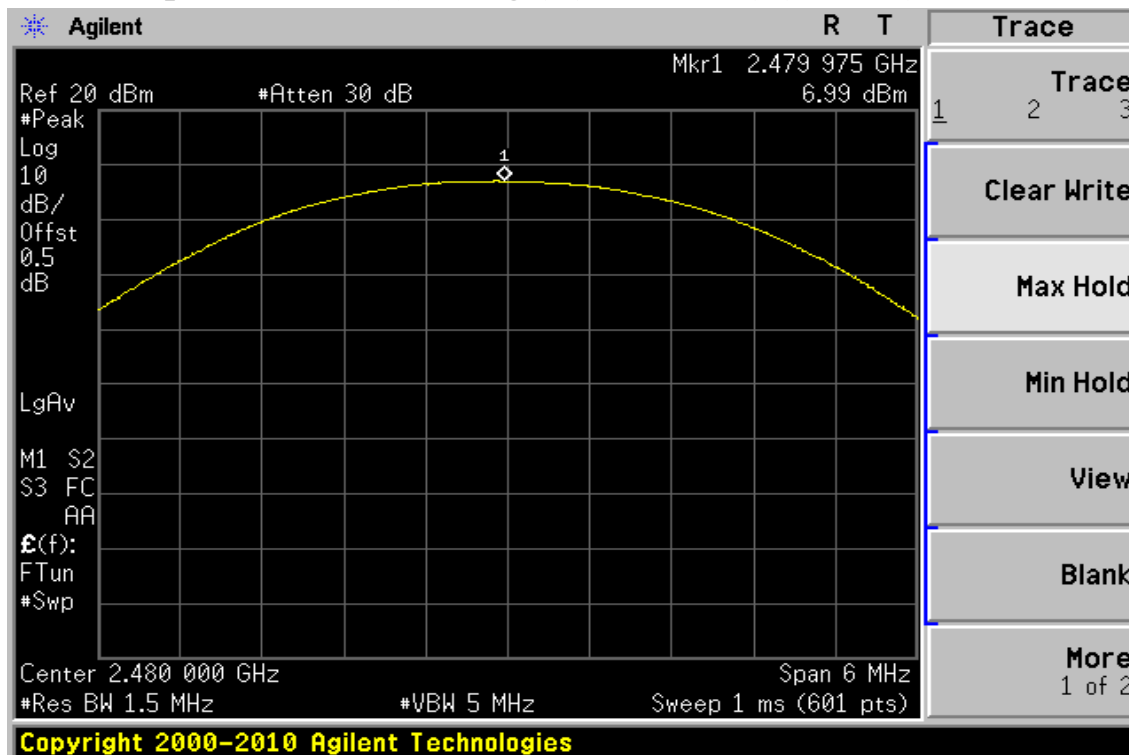

8. 100KHz BANDWIDTH OF BAND EDGES MEASUREMENT

8.1. Standard Applicable:

In addition, radiated emissions which fall in the restricted bands of Table 1 must also comply with the radiated emission limits specified in Tables 2 and 3.

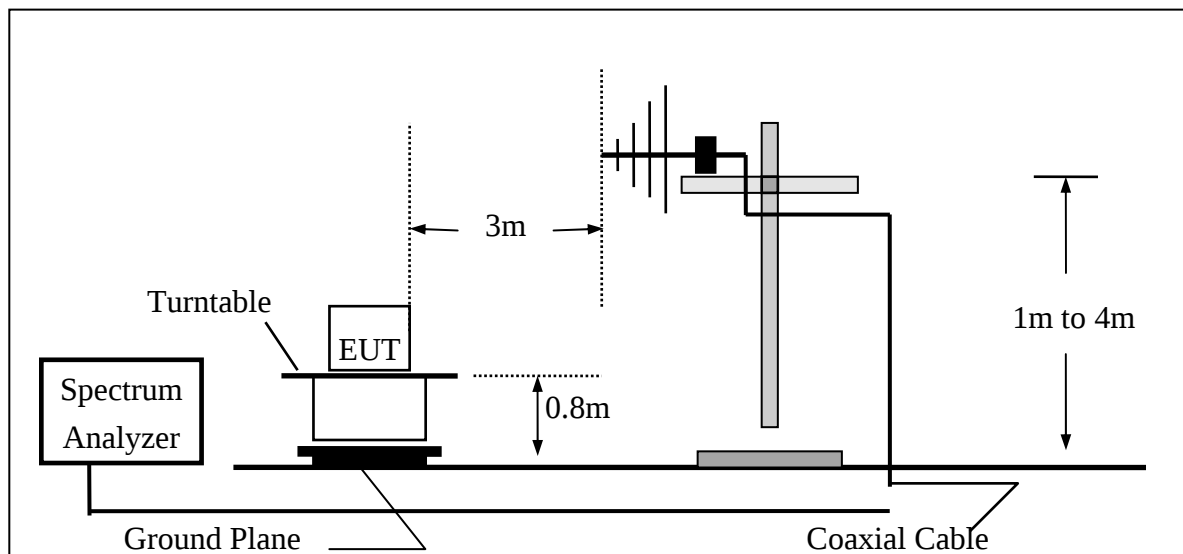

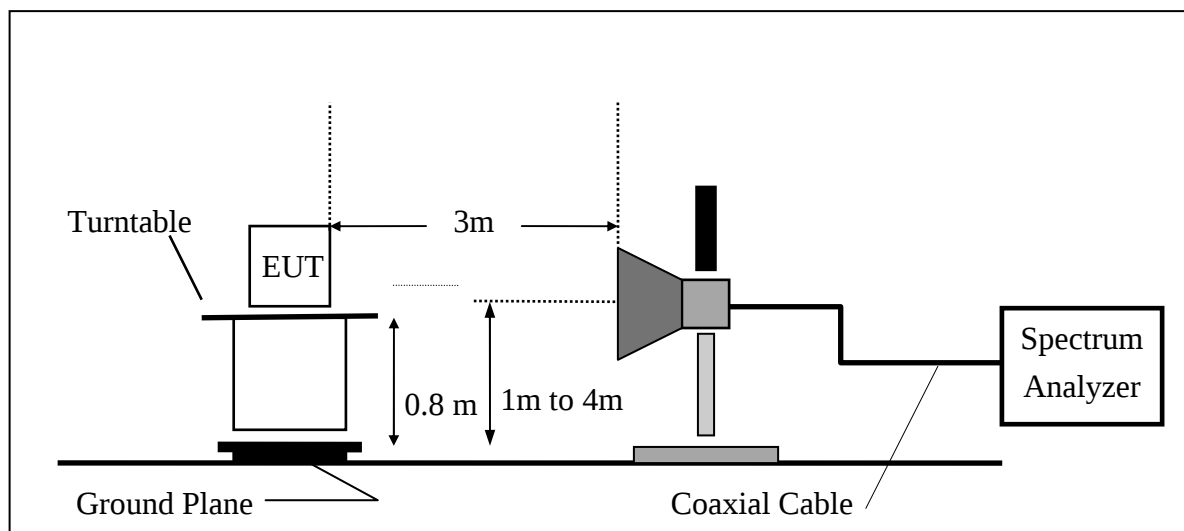

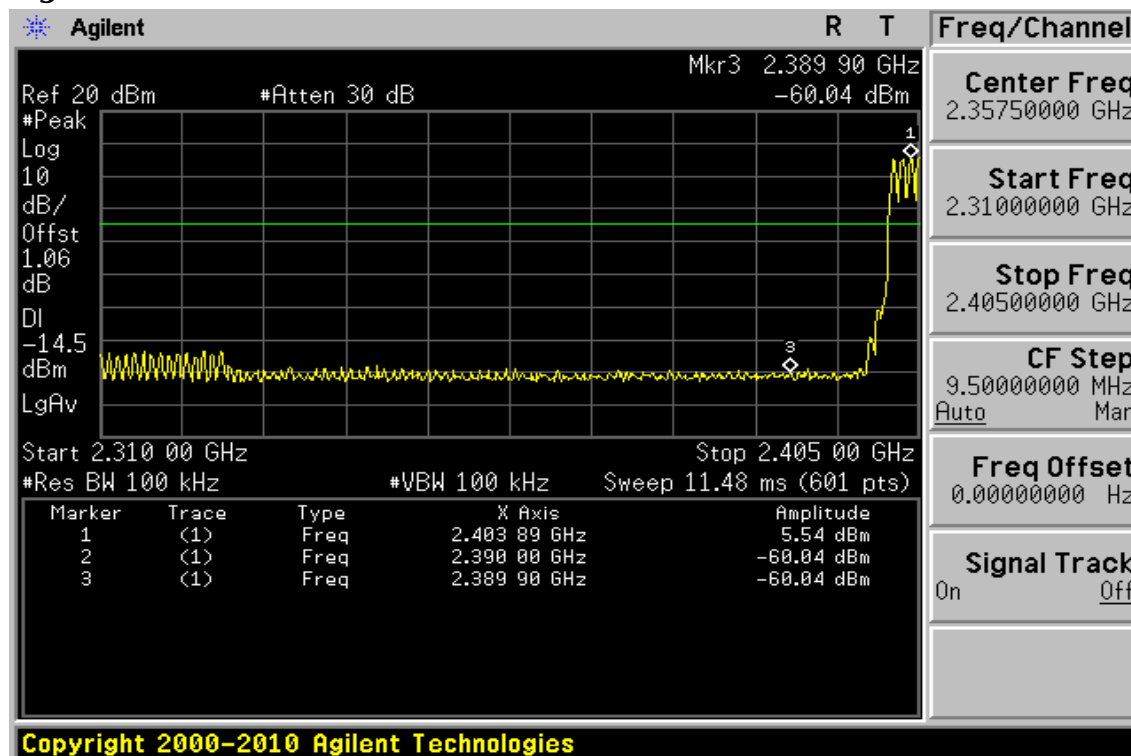

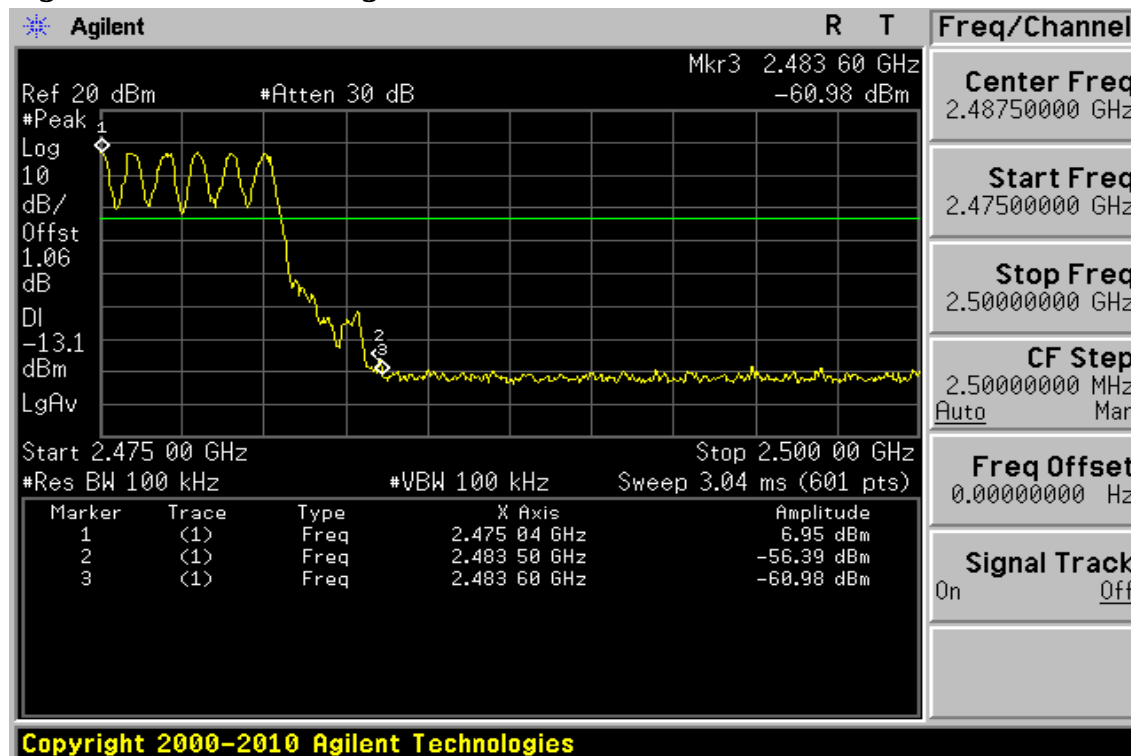

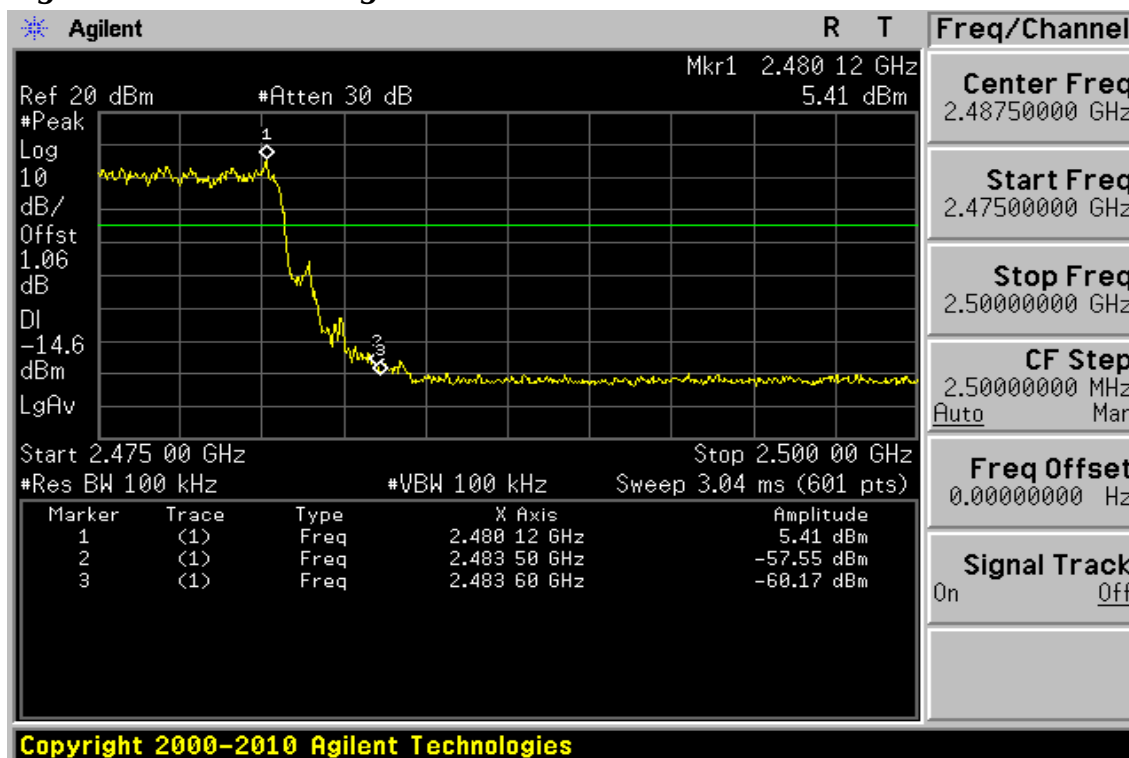

2. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.

When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.
5. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
6. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
7. Repeat above procedures until all frequency measured were complete.

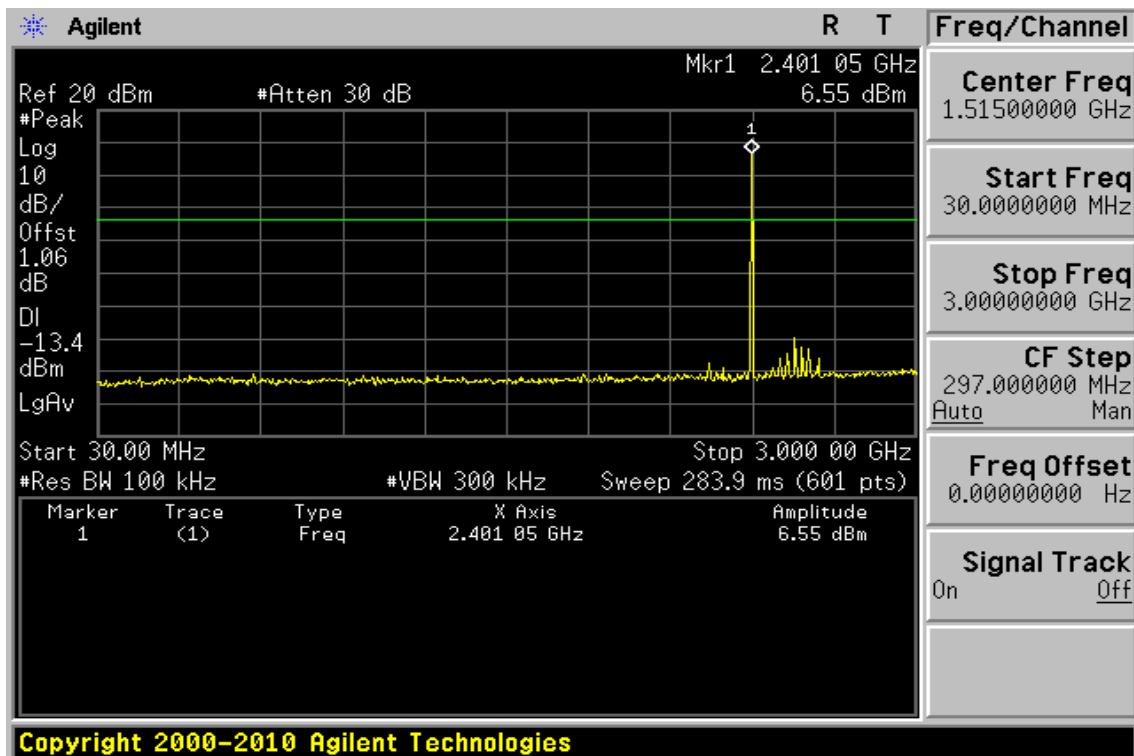

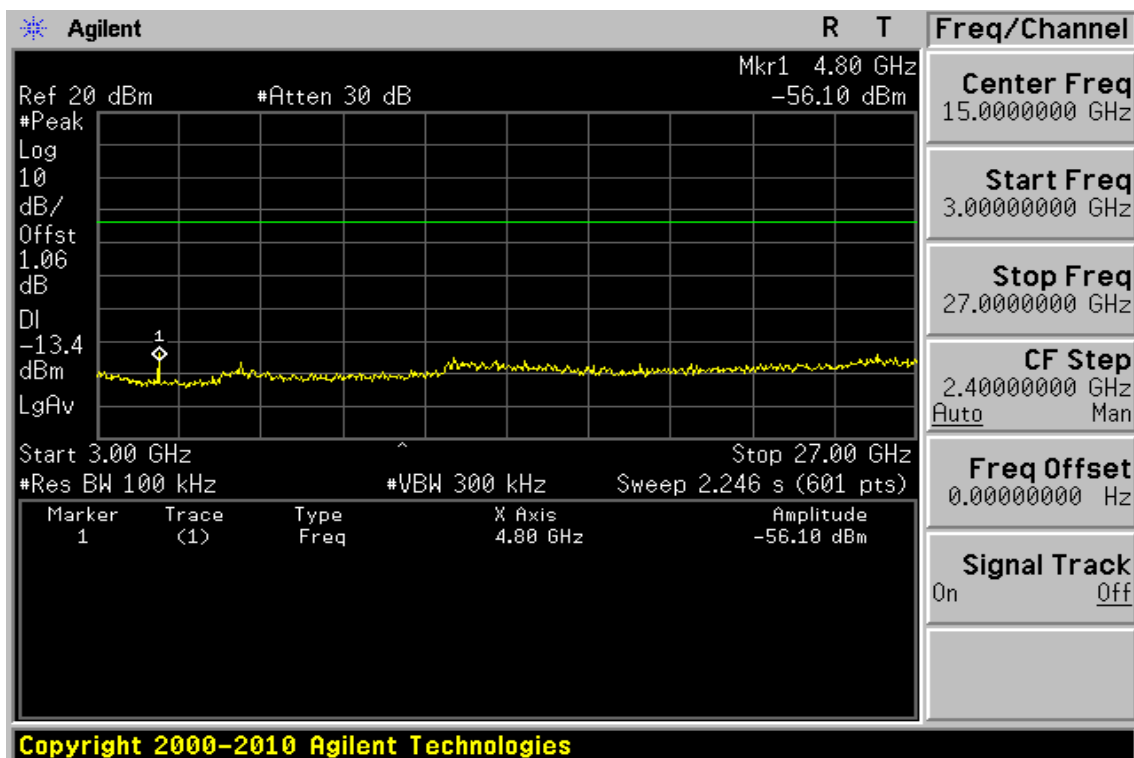

Ch Low 3GHz – 26.5GHz

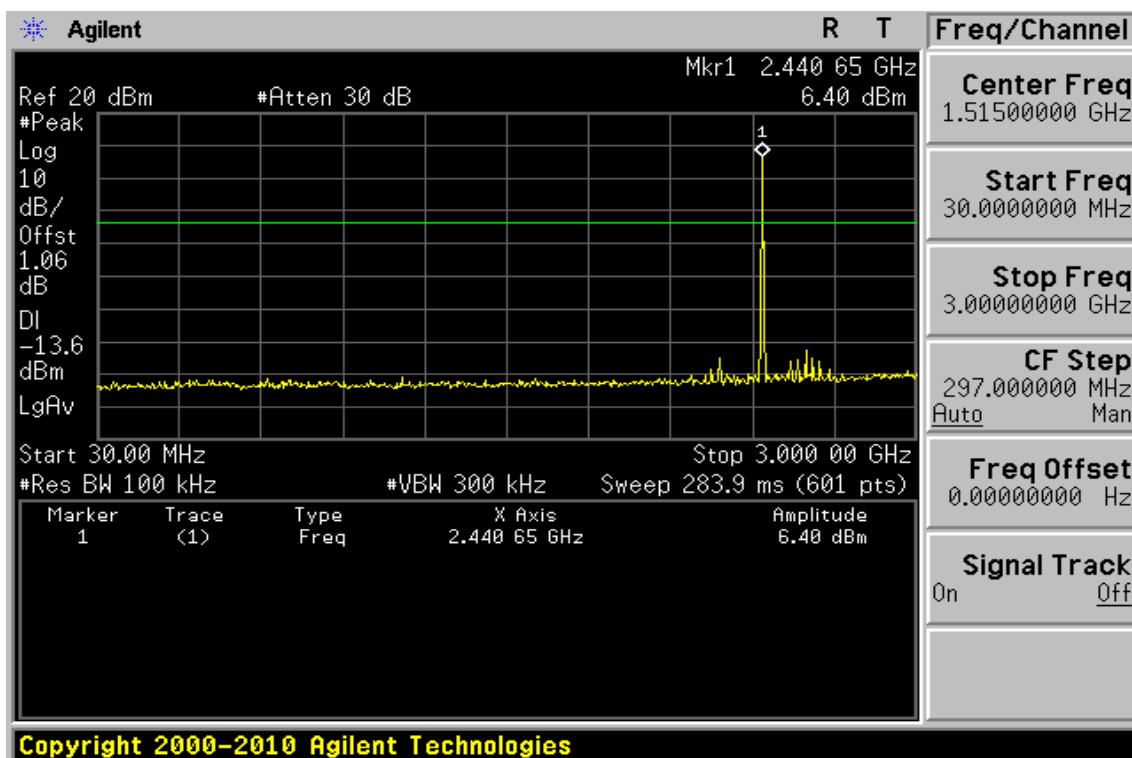

14. ANTENNA REQUIREMENT

14.1. Standard Applicable:

According to §15.203, an intentional radiator shall be designed to ensure that no antenna other than furnished by the responsible party shall be used with the device.

And according to §15.246(1), if transmitting antennas of directional gain greater than 6dBi are used the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

According to RSS-GEN 7.1.2, a transmitter can only be sold or operated with antennas with which it was certified. A transmitter may be certified with multiple antenna types. An antenna type comprises antennas having similar in-band and out-of-band radiation patterns.
