Limited Warranty, Disclaimer, Limitation Of Liability

Proxim offers a thirty (30) day money-back guarantee for the purchase price of the Symphony product(s). If you are not satisfied with the Symphony product(s) for any reason, return it to your place of purchase within (30) days from the date of purchase for a refund of the purchase price. You may be required to present a receipt showing the purchase date in order to receive this refund. Contact your place of purchase for details.

In addition, for a period of one (1) year for the date of purchase by the retail customer, Proxim warrants the Symphony product(s) against defects in materials and workmanship. If a product is found defective during the warranty period, Proxim will repair or replace the product with the same or a similar model, which may be a reconditioned unit, without charge for parts or labor. Any replaced or repaired product will have either a ninety (90) day warranty, under the conditions described herein, or the remainder of the initial one (1) year warranty, whichever is longer.

Proxim also warrants the media containing the Symphony software against failure for a period of ninety (90) days.

Proxim will not honor this warranty if there has been any attempt to tamper with or remove the product's external foil label. This warranty does not cover and Proxim will not be liable for any damage or failure caused by misuse, abuse, acts of god, accidents, or other causes beyond Proxim's control, or claim by any entity other than the original purchaser.
