1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 Element Test Location

Measurements were conducted at the Element laboratory indicated in Section 1.3 below. All measurement facilities are compliant with the test site requirements specified in ANSI C63.4-2014 and KDB 414788 D01 v01r01.

1.3 Test Facility / Accreditations

Measurements were performed at Element lab located in Columbia, MD 21046, U.S.A.

2.0 PRODUCT INFORMATION

2.1 Equipment Description

The Equipment Under Test (EUT) is the **Garmin Portable Digital Transceiver FCC ID: IPH-05172** and **IC: 1792A-05172**. The test data contained in this report pertains only to the emissions due to the EUT's licensed transmitters that operate under the provisions of Part 25 and RSS-170.

The EUT integrated a certified module (Nordic) which is authorized under FCC ID: 2ANPO00NRF9151 and IC: 24529-NRF9151

For this EUT configuration, only the NB-IoT capability of the module is enabled for NTN specific operation

2.2 Device Capabilities

This device contains the following capabilities:

Multi-band LTE (CAT-M1) / Multi-band NTN / Bluetooth (1x, EDR, LE) / ANT+ / 802.11b/g/n WLAN / NFC

For NTN operation under B255 (1626.5 – 1660.5MHz) and B23/252 (2000.1 - 2019.9MHz), this device supports both 3.75kHz and 15kHz subcarrier spacings with QPSK and BPSK modulations.

2.3 Test Configuration

The EUT was tested per the guidance of ANSI C63.26-2015. See Section 7.0 of this test report for a description of the radiated and antenna port conducted emissions tests.

The EUT was configured for testing using client-provided software/instruction that allowed direct control of the modem operating parameters. The device was connected to a call box to establish and maintain a communication link, enabling the EUT to operate in a controlled transmit state. The call box was configured to force the EUT to transmit at maximum output power for all applicable measurements.

3.0 DESCRIPTION OF TESTS

3.1 Evaluation Procedure

The measurement procedures described in the “American National Standard for Compliance Testing of Transmitters Used in Licensed Radio Services” (ANSI C63.26-2015) were used in the measurement of the EUT.

3.2 Radiated Power and Radiated Spurious Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. For measurements below 1GHz, the absorbers are removed. A raised turntable is used for radiated measurement. The turn table is a continuously rotatable, remote-controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm tall test table made of Styrodur is placed on top of the turn table. A Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

The equipment under test was transmitting while connected to its integral antenna and is placed on a turntable 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer.

For radiated power measurements, ERP or EIRP are calculated based on the manufacturer provided antenna gain and the measured conducted output power per the guidance of ANSI C63.26:2015. The power of the emission is calculated using the following formula:

$$\text{ERP or EIRP}_{[\text{dBm}]} = P_{\text{measured} [\text{dBm}]} + G_T [\text{dBd/dBi}];$$

where ERP or EIRP_[dBm] is the effective radiated power or equivalent isotropically radiated power, P_{measured} is measured transmitter output power or PSD, in dBm or dBW, G_T is gain of the transmitting antenna in dBd (ERP) or dBi (EIRP)

For radiated spurious emissions measurements, the field strength conversion method is used per the formulas in Section 5.2.7 of ANSI C63.26:2015. Field Strength (EIRP) is calculated using the following formulas:

$$E_{[\text{dB}\mu\text{V/m}]} = \text{Measured amplitude level}_{[\text{dBm}]} + 107 + \text{Cable Loss}_{[\text{dB}]} + \text{Antenna Factor}_{[\text{dB/m}]}$$

And

$$\text{EIRP}_{[\text{dBm}]} = E_{[\text{dB}\mu\text{V/m}]} + 20\log D - 104.8; \text{ where } D \text{ is the measurement distance in meters.}$$

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4:2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 414788 D01 v01r01.

Radiated power and radiated spurious emission levels are investigated with the receive antenna horizontally and vertically polarized per ANSI C63.26:2015.

4.0 MEASUREMENT UNCERTAINTY

The measurement uncertainties shown below were calculated in accordance with the requirements of ANSI C63.4-2014. All measurement uncertainty values are shown with a coverage factor of $k = 2$ to indicate a 95% level of confidence. The measurement uncertainty shown below meets or exceeds the U_{CISPR} measurement uncertainty values specified in CISPR 16-4-2 and, thus, can be compared directly to specified limits to determine compliance.

- 1) All modes of operation and data rates were investigated. The test results shown in the following sections represent the worst-case emissions.
- 2) The analyzer plots were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables, directional couplers, and attenuators used as part of the system to maintain a link between the call box and the EUT at all frequencies of interest.
- 3) All antenna port conducted emissions testing was performed on a test bench with the antenna port of the EUT connected to the spectrum analyzer through calibrated cables, attenuators, and couplers.
- 4) All conducted emissions measurements are performed with automated test software to capture the corresponding plots necessary to show compliance. The measurement software utilized is EMC Software Tool v2.3.0.
- 5) This report is based on the original report (Report No. 5121ERM.001A1) for Model: nRF9151 (FCC ID: 2ANPO00NRF9151 and IC: 24529-NRF9151). The firmware remains identical, with only a difference in the software name. The new sample has been evaluated to verify worst-case Radiated Spurious Emissions (RSE) and conducted power. Accordingly, this report includes only the conducted power and RSE results. All other test data are leveraged from the original report as noted in the Data Leveraged column of the above table.

7.2 Conducted Output Power & Radiated Power (EIRP)

Test Overview

7.3 Occupied Bandwidth

Test Overview

The occupied bandwidth, that is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission shall be measured. 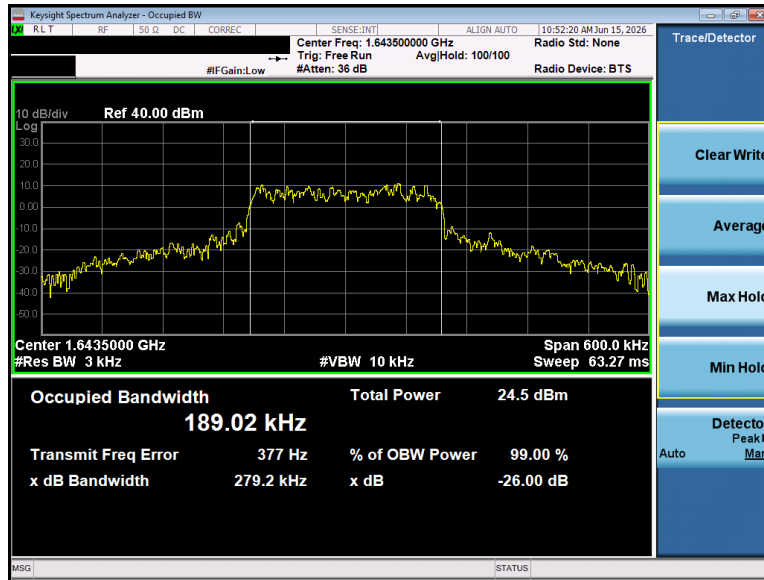

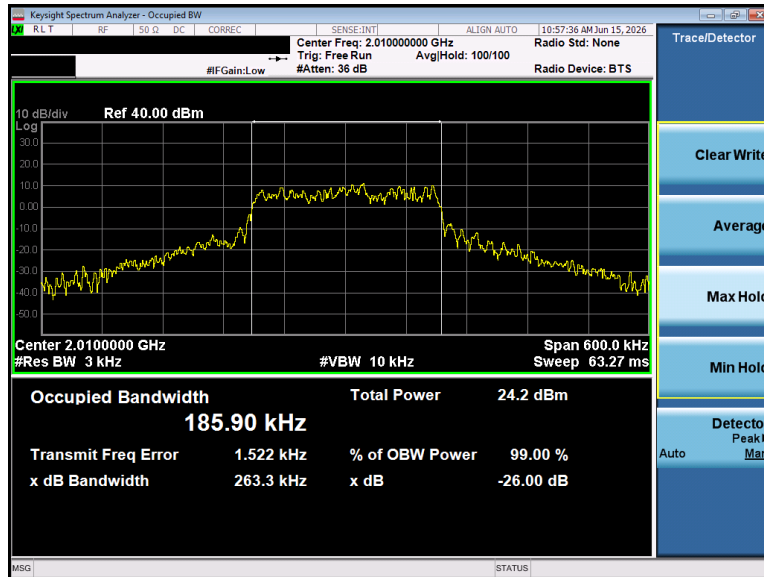

7.4 Radiated Spurious Emissions Measurements

Test Overview

Radiated spurious emissions measurements are performed using the field strength conversion method described in ANSI C63.26-2015 with the EUT transmitting into an integral antenna. Measurements on signals operating below 1GHz are performed using hybrid (biconical/log) antennas. Measurements on signals operating above 1GHz are performed using vertically and horizontally polarized broadband horn antennas. 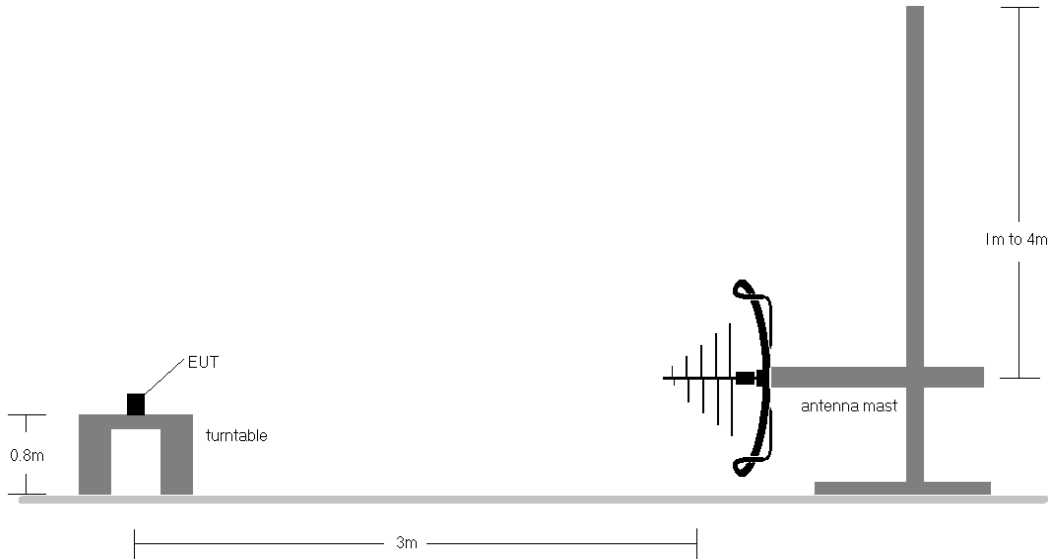


Figure 7-3. Test Instrument & Measurement Setup < 1GHz

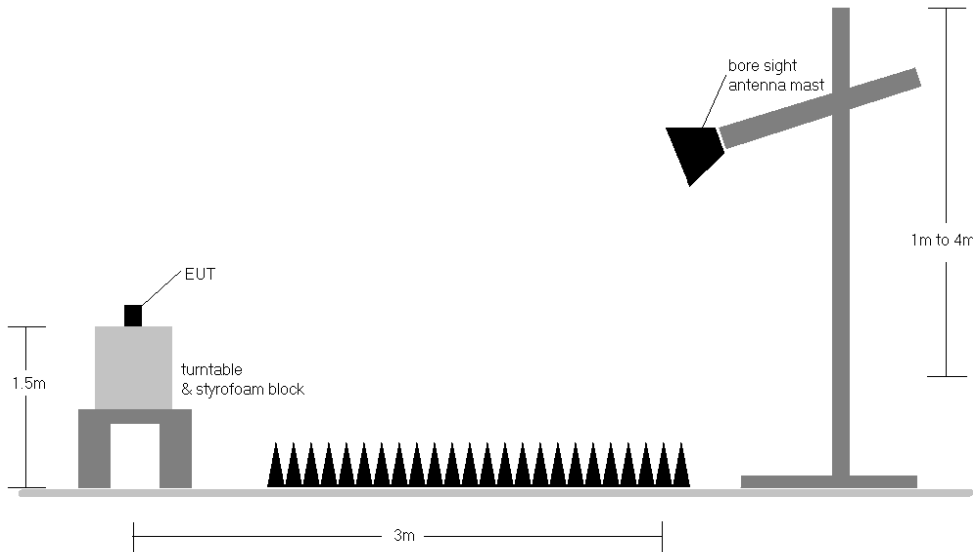


Figure 7-4. Test Instrument & Measurement Setup >1 GHz

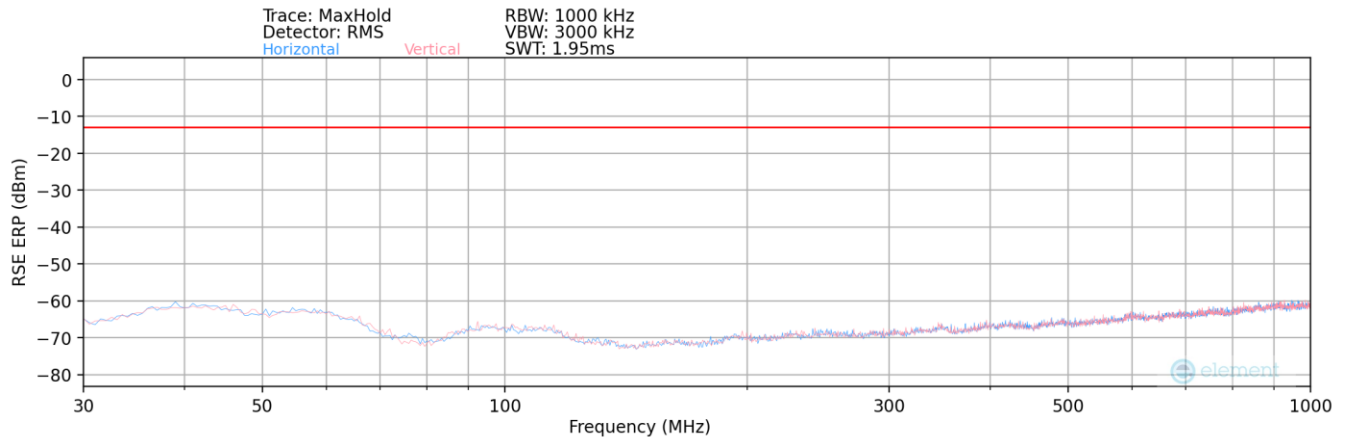

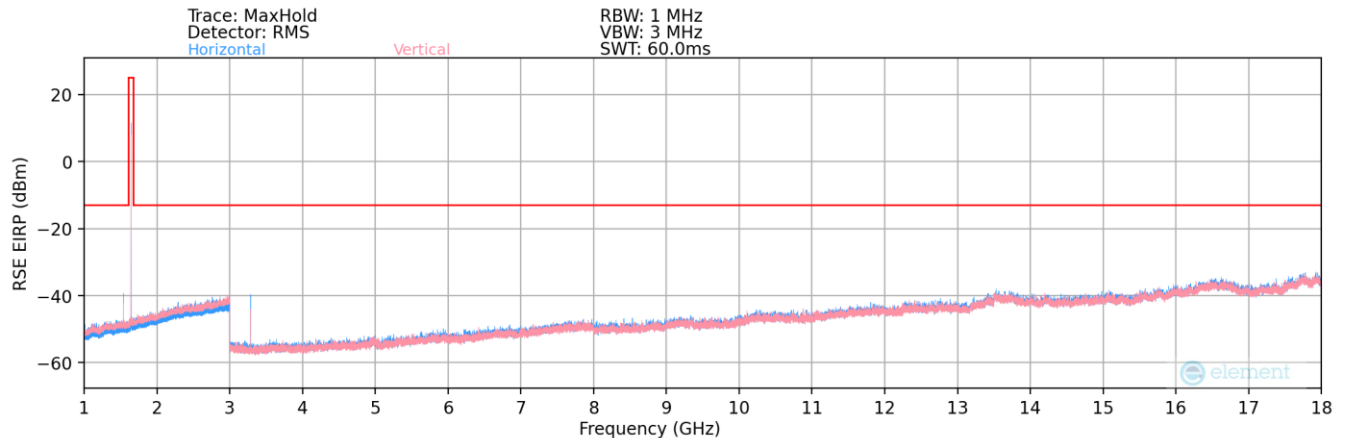


Plot 7-3. Radiated Spurious Plot – Band 255

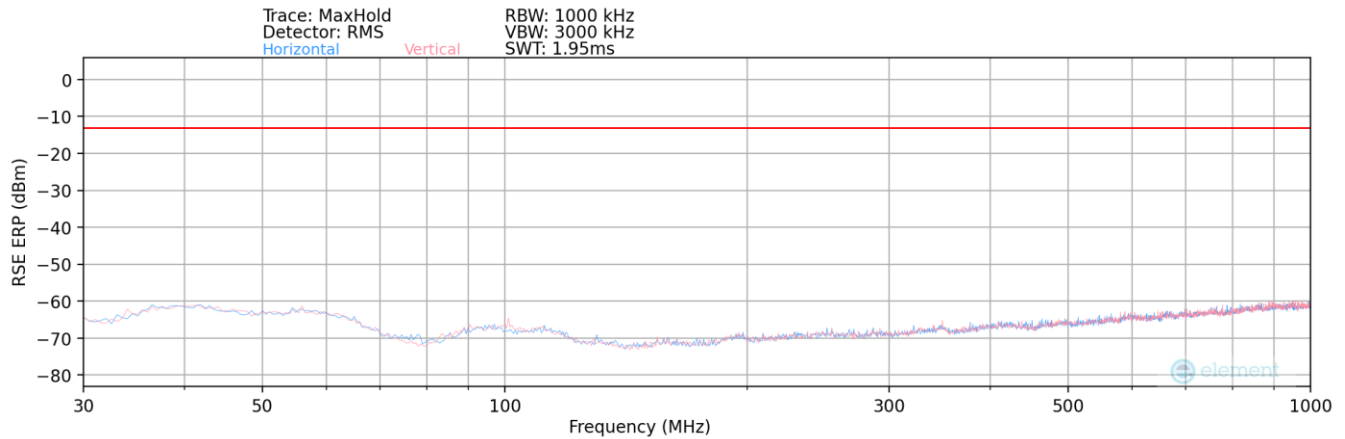

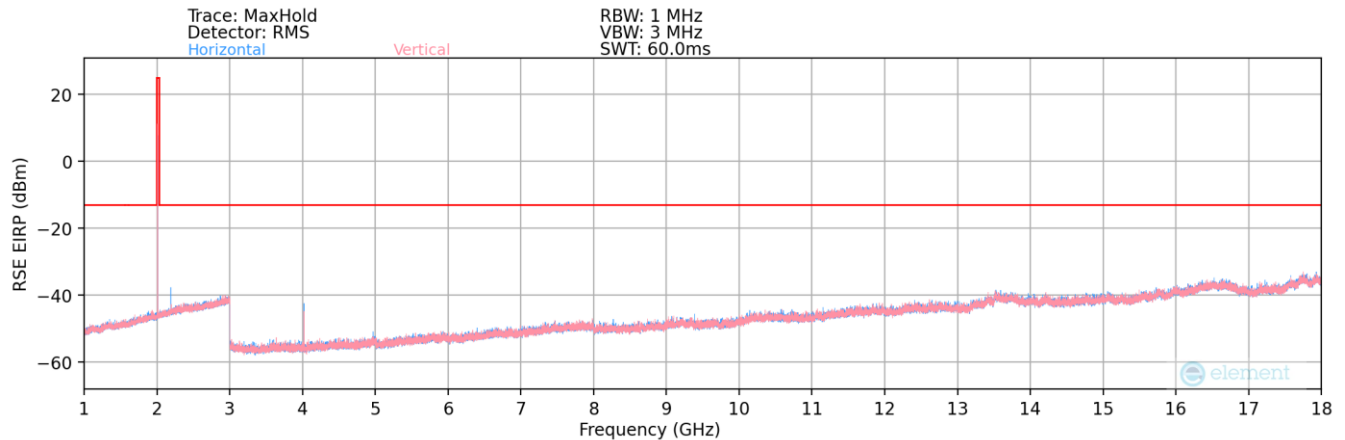


Plot 7-5. Radiated Spurious Plot – Band 23/252

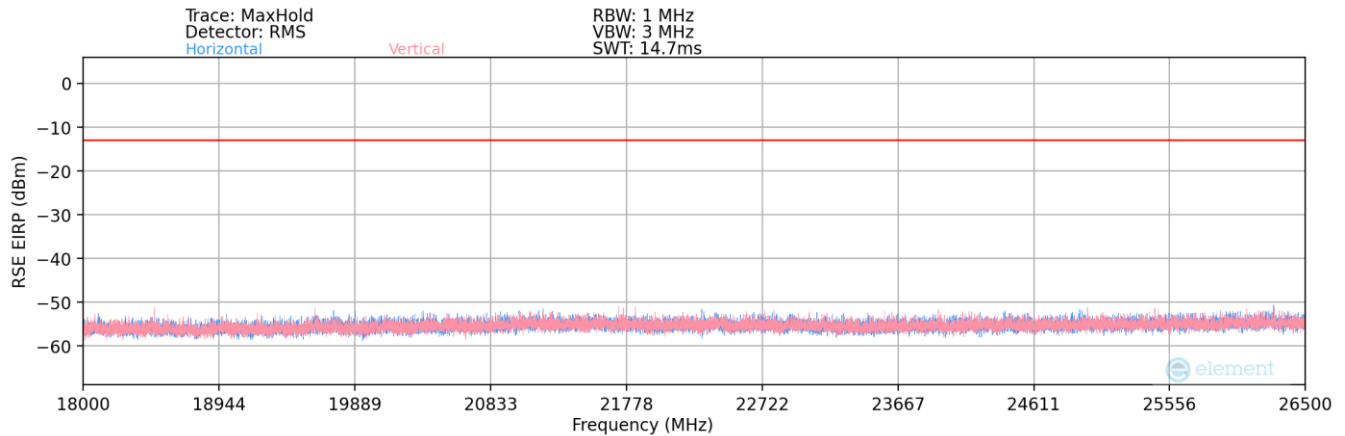

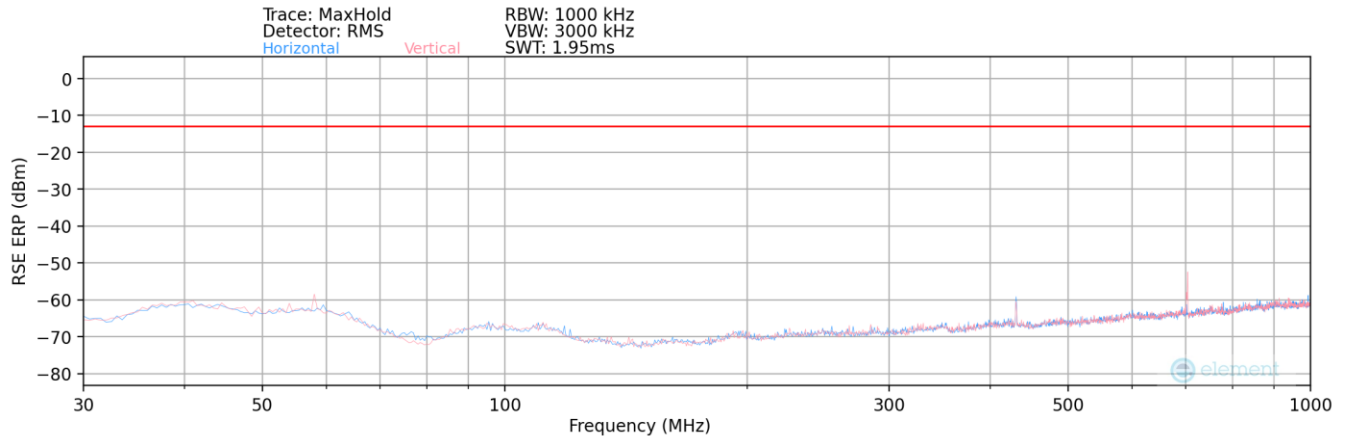

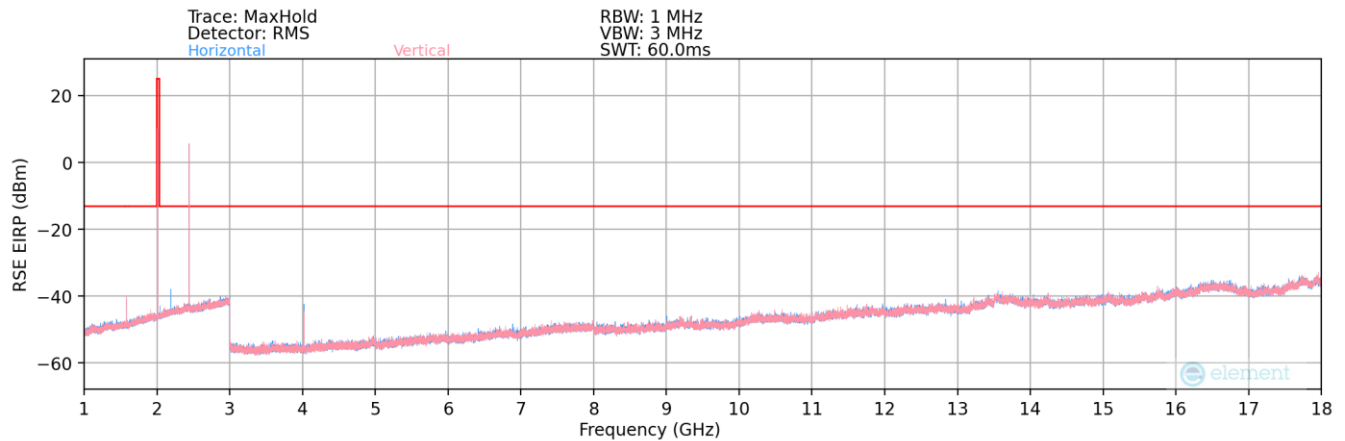

7.5 Radiated Spurious Emissions Measurements (1559 – 1610MHz)

Test Overview

Radiated spurious emissions measurements are performed using the field strength conversion method described in ANSI C63.26-2015 with the EUT transmitting into an integral antenna. Measurements on signals operating below 1GHz are performed using hybrid (biconical/log) antennas. The e.i.r.p of discrete emissions of less than 700 Hz bandwidth from such stations shall not exceed a level determined by linear interpolation from -80 dBW at 1605 MHz to -56 dBW at 1610 MHz, averaged over any 2 millisecond active transmission interval.

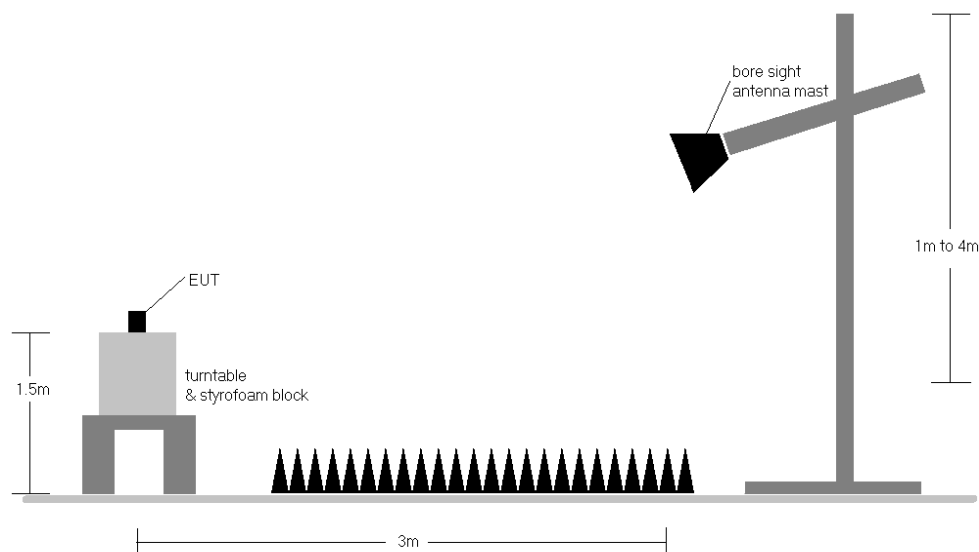


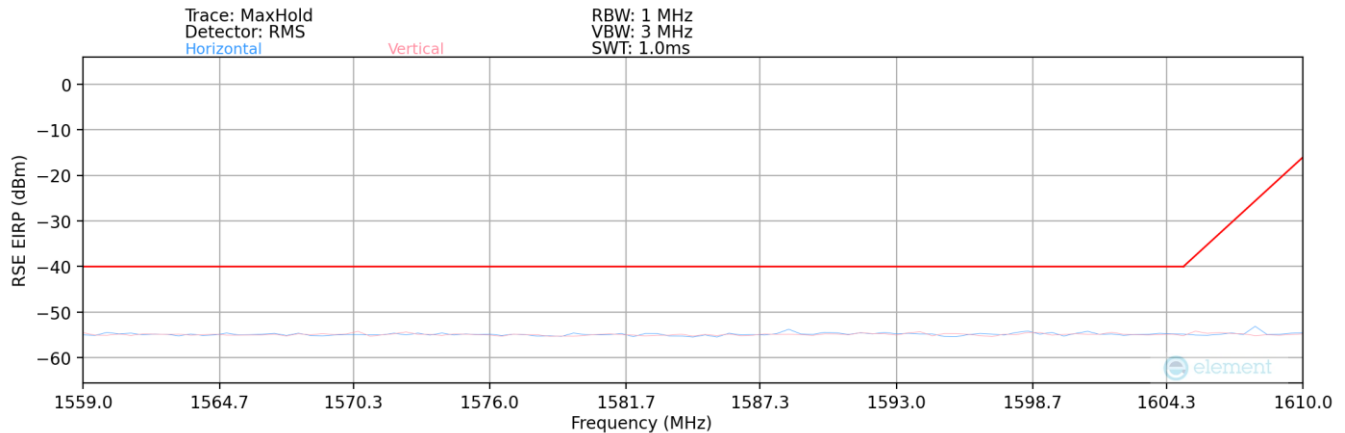
Figure 7-5. Test Instrument & Measurement Setup >1 GHz

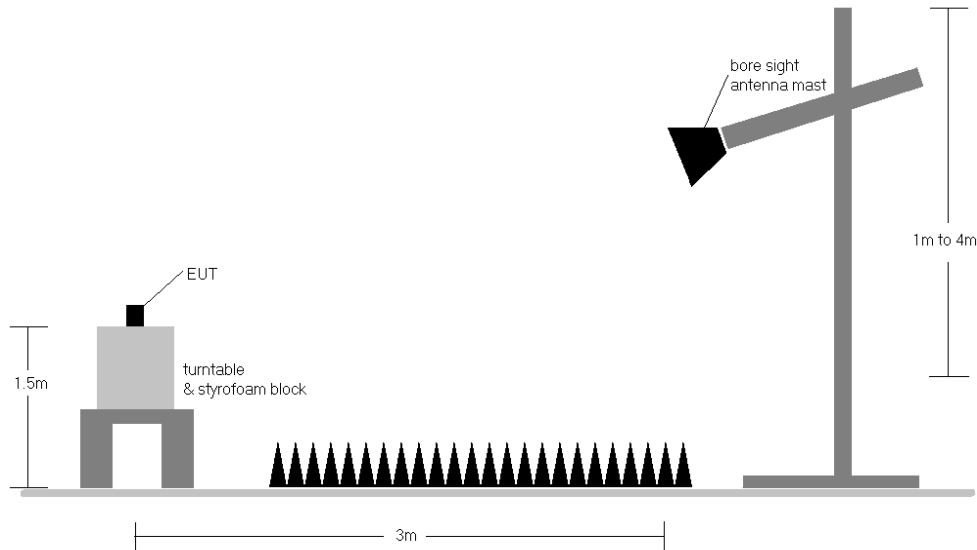


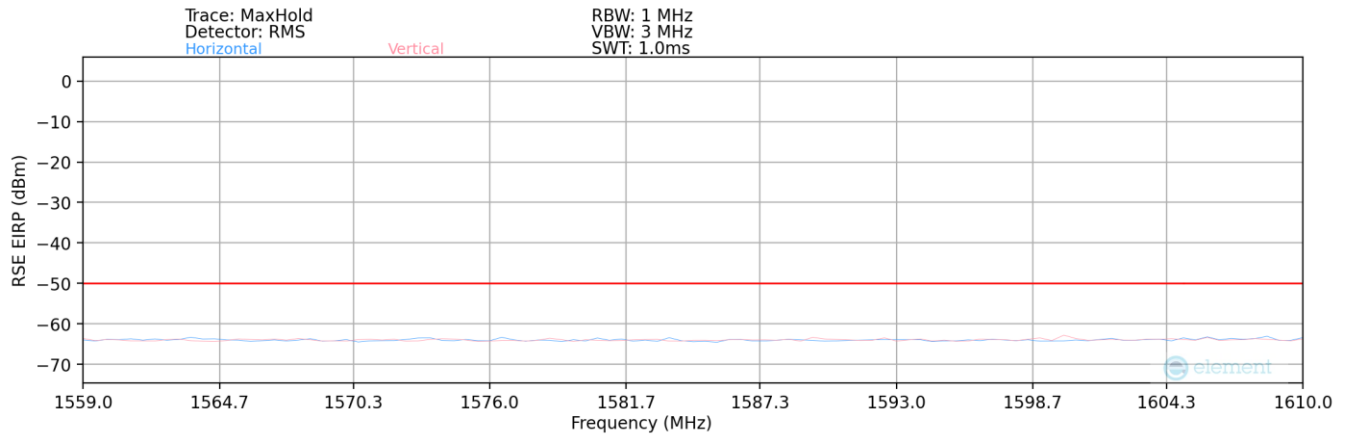
Figure 7-6. Test Instrument & Measurement Setup >1 GHz
