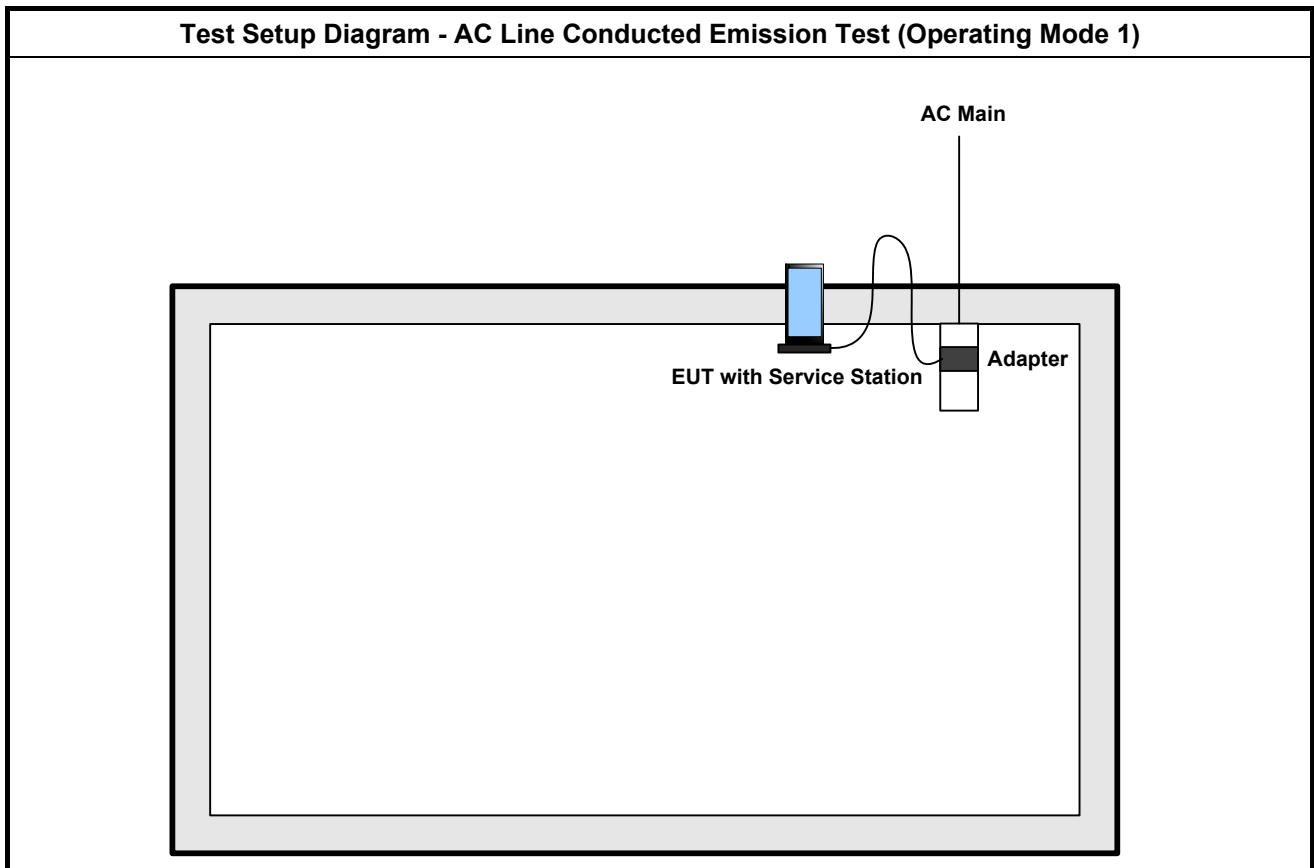

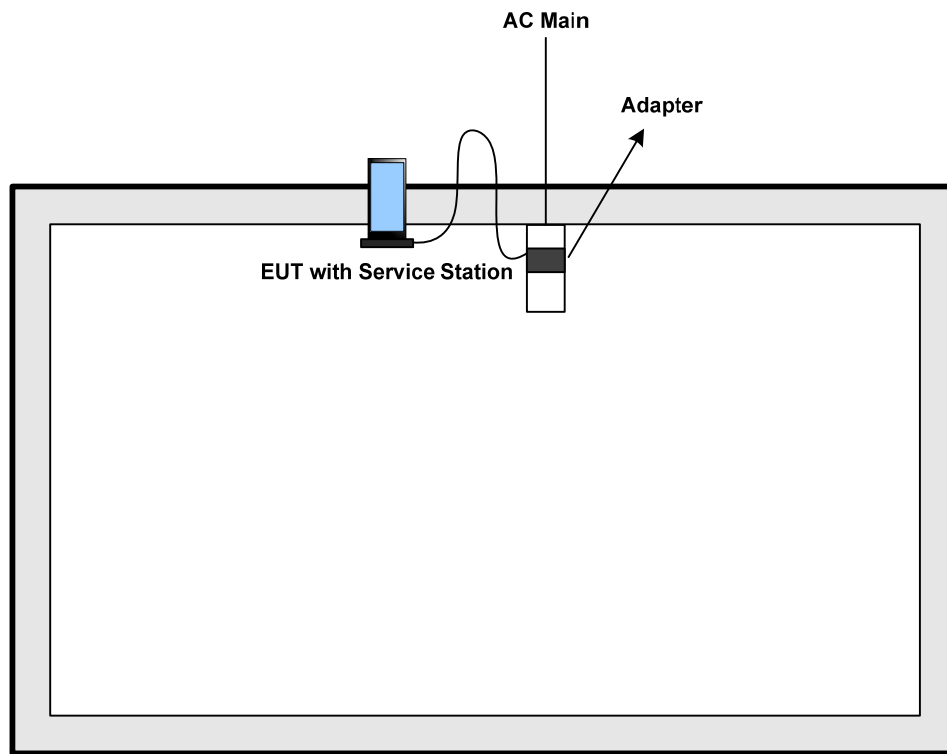

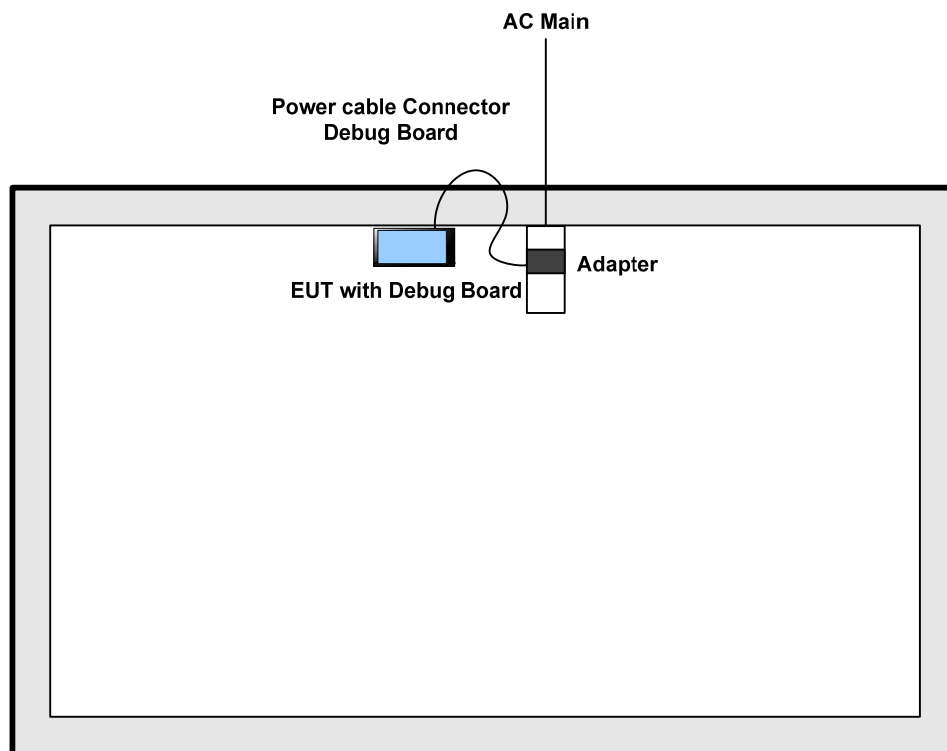

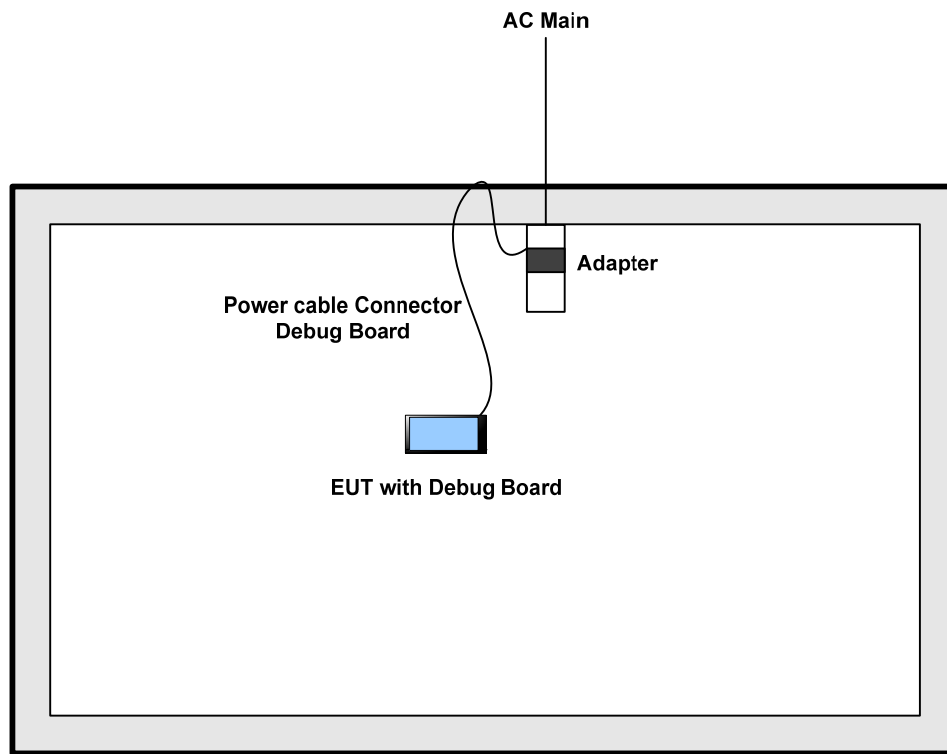
Test Setup Diagram - Radiated Test Below 1GHz (Operating Mode 1)

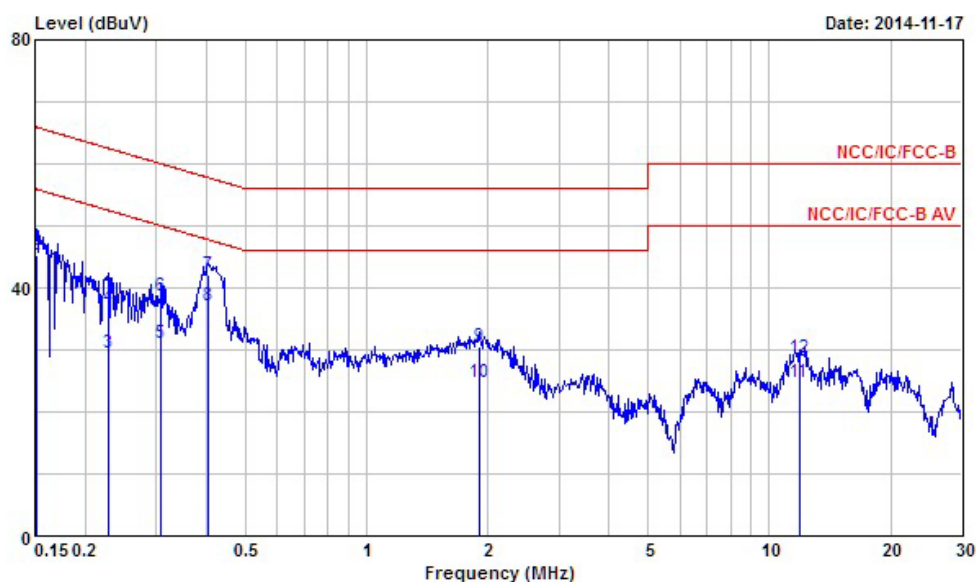

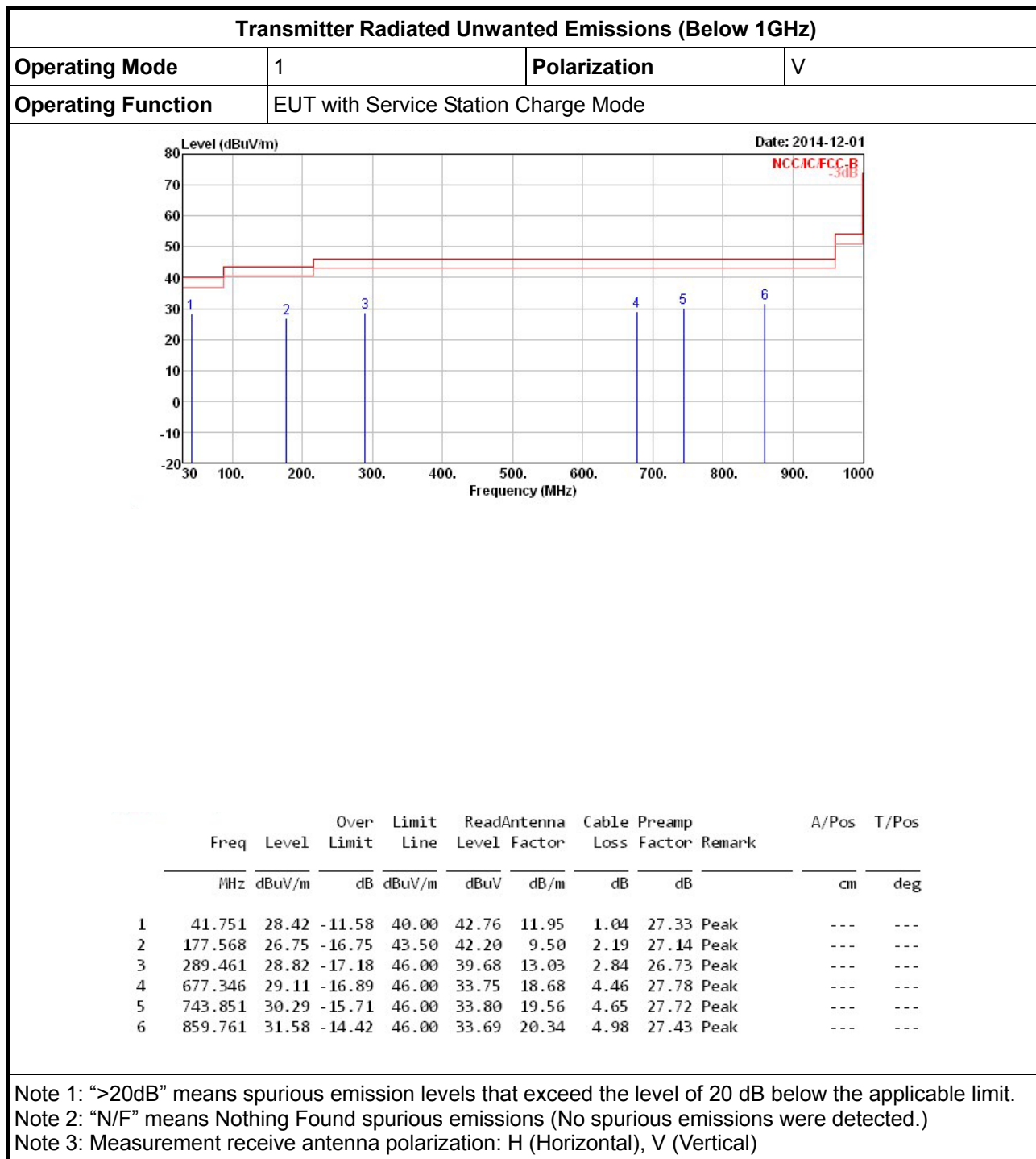
Transmitter Radiated Unwanted Emissions (Above 1GHz)
