To investigate the maximum EMI emission characteristics generates from EUT, the test system was pre-scanning tested base on the consideration of following EUT operation mode or test configuration mode which possible have effect on EMI emission level. Each of these EUT operation mode(s) or test configuration mode(s) mentioned above was evaluated respectively.

Mode 1 1600*1200/106KHz/85Hz VGA and DVI Port (CRT & Projector) - "H" pattern

Mode 2 1024*768/99KHz/120Hz VGA and DVI Port (CRT & Projector) - "H" pattern

Mode 3 800*600/98KHz/150Hz VGA and DVI Port (CRT & Projector) - "H" pattern

Mode 4 1024*768/48KHz/120Hz DVI and S-Video Port (Projector & TV) - "Color Bar" pattern

Mode 5 1024*768/48KHz/120Hz VGA and AV Port (CRT & TV) - "H" pattern

The EUT system operated Mode 1, 2, 3, 4, and 5, mentioned above were found to be the worst cases during the pre-scanning test.

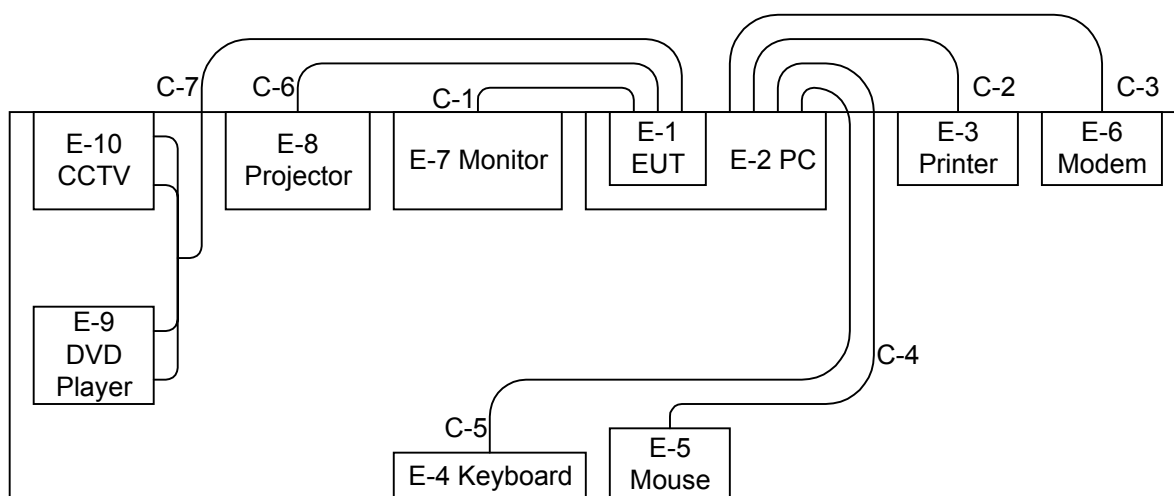

2.9 EUT Operating Conditions

- (a) Both conducted and radiated testing were performed during the max. EMI emission evaluation.
- (b) The system was configured for testing in a typical fashion (as a customer would normally use it). The EUT was connected to support equipment-personal computer. Peripherals of EUT and PC, such as monitor, keyboard, modem, DVD player and printer were contained in this system in order to comply with the CISPR22 Rules requirement. This operating condition was tested and used to collect the included data.
- (c) The EUT exercise program used during radiated and/or conducted emission measurement was designed to exercise the various system components in a manner similar to a typical use. The program contained on a PC hard disk and is auto-starting on power-up. Once loaded, the program sequentially exercises each system component in turn. The sequence used is:
 - 1. Read (write) from (to) mass storage device (Disk).
 - 2. Send "H" pattern to video port device (EUT - Monitor or TV or Projector)
 - 3. Send "Color Bar" pattern to video port device (DVD Player – EUT - Monitor or TV or Projector)
 - 4. Send " H " pattern to parallel port device (Printer).
 - 5. Send " H " pattern to serial port device (Modem).
 - 6. Repeated from 2 to 5 continuously.As the keyboard and mouse are strictly input devices, no data is transmitted to (from) them during test. They are, however, continuously scanned for data input activity.

3.2 Measurement Justification

3.2.1 Conducted Emission

The initial step in collecting conducted emission data is a spectrum analyzer peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and these signals are then Quasi Peak detector mode and Average detector mode re-measured.

Data of **Table - 4.** lists the significant emission frequencies, measured levels, limits and safe margins. All readings are Peak Mode measured unless otherwise stated as QP or AV in column of " Remark ".

If the Peak Mode measured value lower than both QP Mode and AV Mode Limit, EUT shall be deemed to compliance with both QP & AV Limits and then no additional QP Mode or AV Mode measurement performed.

If additional QP or AV Mode measurement needed, and if the QP Mode measured value compliance with the QP Mode Limit and lower than AV Mode Limit, the EUT shall be deemed to meet both QP & AV Limits and then only QP Mode was measured, but AV Mode was not performed °

3.2.2 Radiated Emission

The initial step in collecting conducted emission data is a spectrum analyzer peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then Quasi Peak detector mode re-measured.
