Enabling/Disabling Selectable Step Triggers

You can enable the switches to shorten the travel distance of the left and right triggers by sliding the switches outwards. To go back to full trigger mode, simply slide the switches inwards.

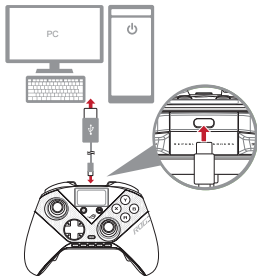

Getting started

Connect to PC

Via wired connection

1. Set the connection switch to USB mode.
2. Connect your controller to the PC with the bundled USB Type-C® cable, and the controller will automatically power on.



Via 2.4GHz

1. Set the connection switch to 2.4GHz mode.
2. Open the dongle cover on the back of the controller to pick up the bundled USB dongle.
3. Insert the USB dongle into an available USB port on your PC.
4. Press the power button on your controller to power it on.

Via Bluetooth

1. Set the connection switch to Bluetooth mode.
2. Press the power button on your controller to power it on.
3. Press and hold the pairing button until the display panel displays "Pairing...", indicating that the controller has started pairing.
4. Find the Bluetooth icon on the task bar on your PC, then click **Add a device > ROG RAIKIRI II PRO PC > Finish**.
5. The display panel displays "Pairing successful", indicating that the controller has been connected to the PC successfully.

NOTE:

- Your controller will automatically pair with the previously paired PC.
 - If pairing is not successful within 1 minute, the F keys indicator will turn off.
 - IOS and macOS devices are not supported for Bluetooth connection.

6. Execute the driver for installation.

On-screen control settings

With display control button

You can press and hold the display control button for 3 seconds to enter or exit the on-screen control menu. When enabled, use the left or right buttons on the hybrid D-pad to navigate through options. Press A to confirm a selection or press B to go back.

- **Profile change.** Switch between profiles 1 to 5.

NOTE: You can also press the display control button briefly to cycle through profiles.

- **Button setting.** Configure remapping, macros, and turbo functions.
- **Lighting brightness.** Adjust the brightness of the RGB LED lighting.
- **Animation Setting.** Select the display animation.
- **Panel brightness.** Adjust the brightness of the display panel.
- **Vibration.** Adjust the controller vibration level.
- **Calibration.** Calibrate the thumbsticks.
- **Factory reset.** Reset the controller to factory settings.

With F keys

You can press F keys (F1/F2/F3/F4) to configure button remapping, macro and turbo functions.

- **F1.** Remap buttons.
- **F2.** Assign macro functions.
- **F3.** Configure turbo functions.
- **F4.** Turn the turbo function on or off.

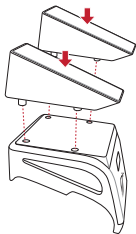

Using the stand holders

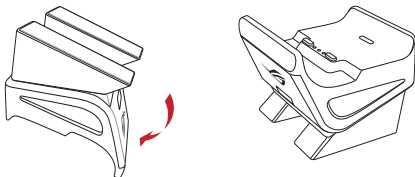
Your controller is bundled with stand holders for the charging dock, allowing you to charge your controller outside the ROG bag.

To install the stand holders:

1. Attach the stand holders to the bottom of the charging dock.



2. Flip the charging dock with its top facing upwards.



Charging your controller

To charge your controller:

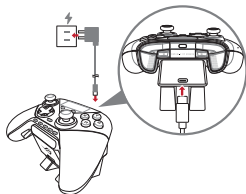
1. Align the female Pogo pin on the bottom of your controller with the male Pogo pin on the charging dock.



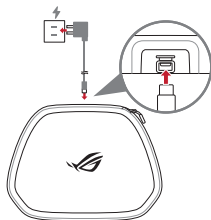

3. Connect the charging dock to a power source using the bundled USB Type-C® cable.



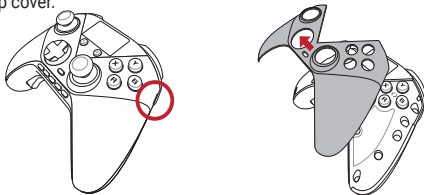

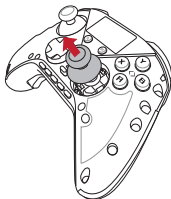
Replacing the thumbstick caps and/or thumbstick modules

To replace the thumbstick caps and/or thumbstick modules:

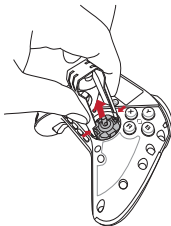
1. Locate the notches on both sides of your controller to remove the magnetic top cover.



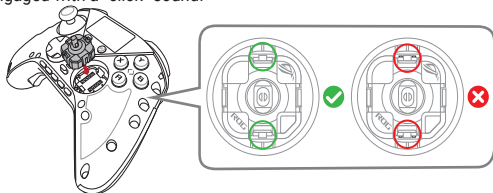
2. Pull off the thumbstick cap.



3. If you need to replace the thumbstick, use the thumbstick puller to release the latches on the thumbstick module, then pull it upward to remove it.

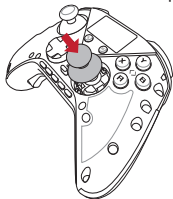


Align the female Pogo pin on the replacement thumbstick module with the male Pogo pin on your controller, then press the thumbstick module into your controller until it is firmly placed. Ensure that the snap-in feet are fully engaged with a “click” sound.

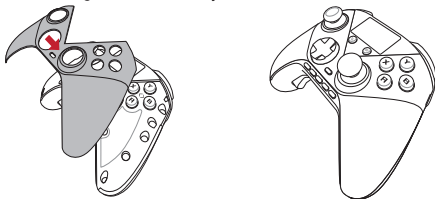


NOTE: Make sure you calibrate the thumbstick module through the display panel or via Gear Link after replacing the thumbstick module.

4. Attach the thumbstick cap.



5. Install the magnetic cover that you removed before.

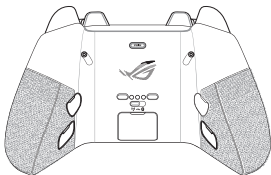
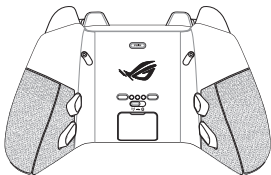


Using the rear button cover

Your controller comes with four magnetic covers for the magnetic multi-functional rear buttons, allowing you to easily replace the unused rear buttons with covers to avoid misclicks.

To install the rear button cover:

1. Remove the multi-functional rear button from your controller.
2. Insert the rear button cover into the slot and ensure it is securely placed.

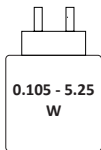
