9.1 Standard Applicable

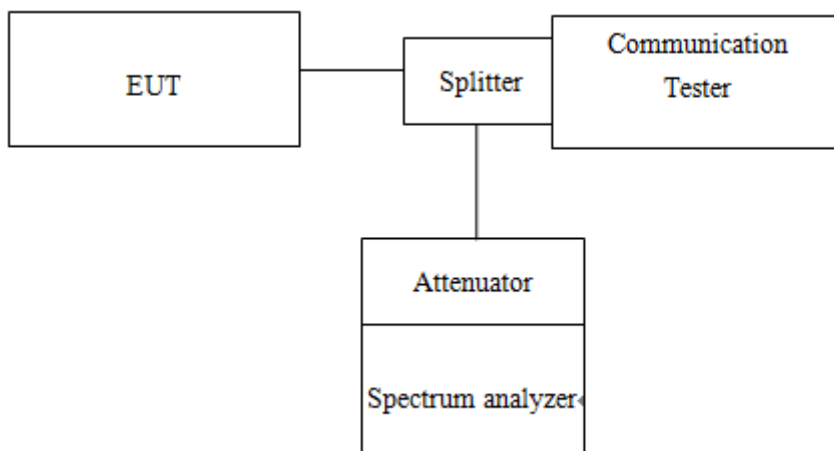

1. To connect Antenna Port of EUT to Spectrum.

4. Repeat above procedures until all default test channel measured were complete.

9.3.2 Band Edge

1. To connect Antenna Port of EUT to Spectrum.
2. The band edge of low and high channels for the highest RF powers was measured. Setting RBW $\geq$ 1% EBW.

4. Repeat above procedures until all default test channel measured were complete.

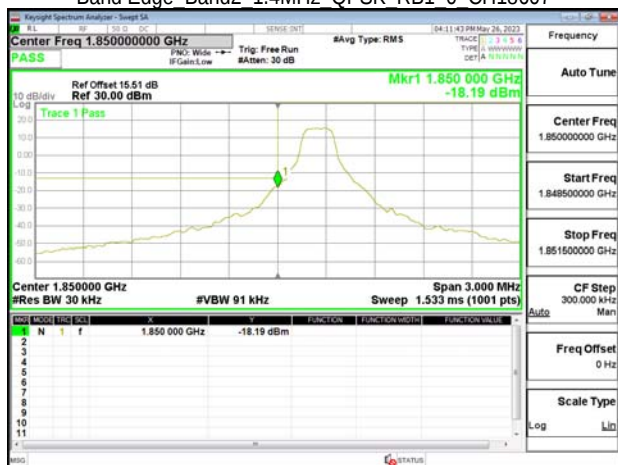

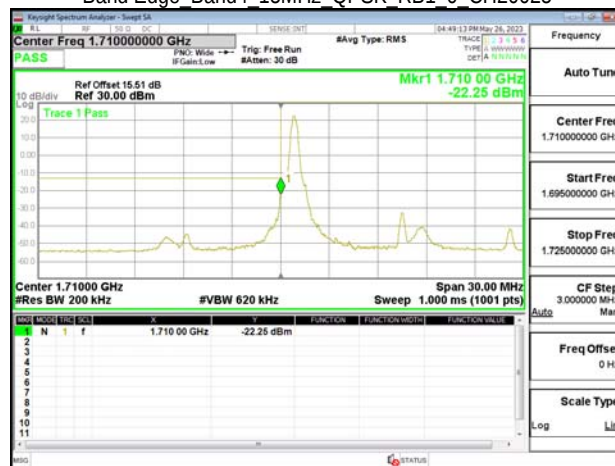
