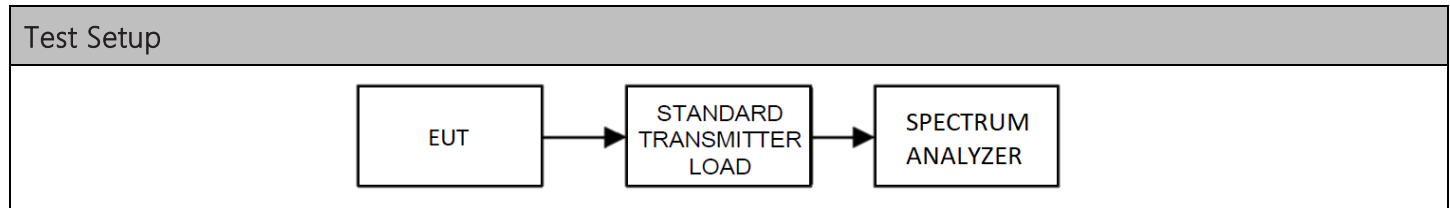

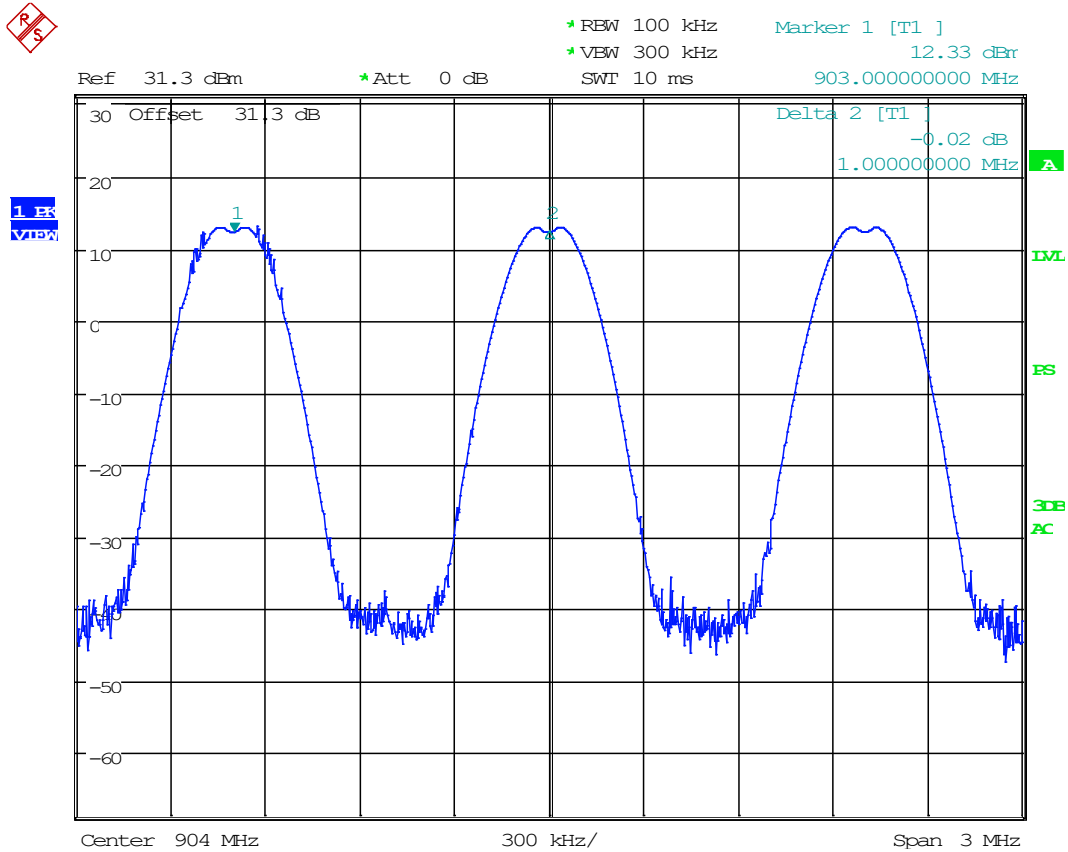

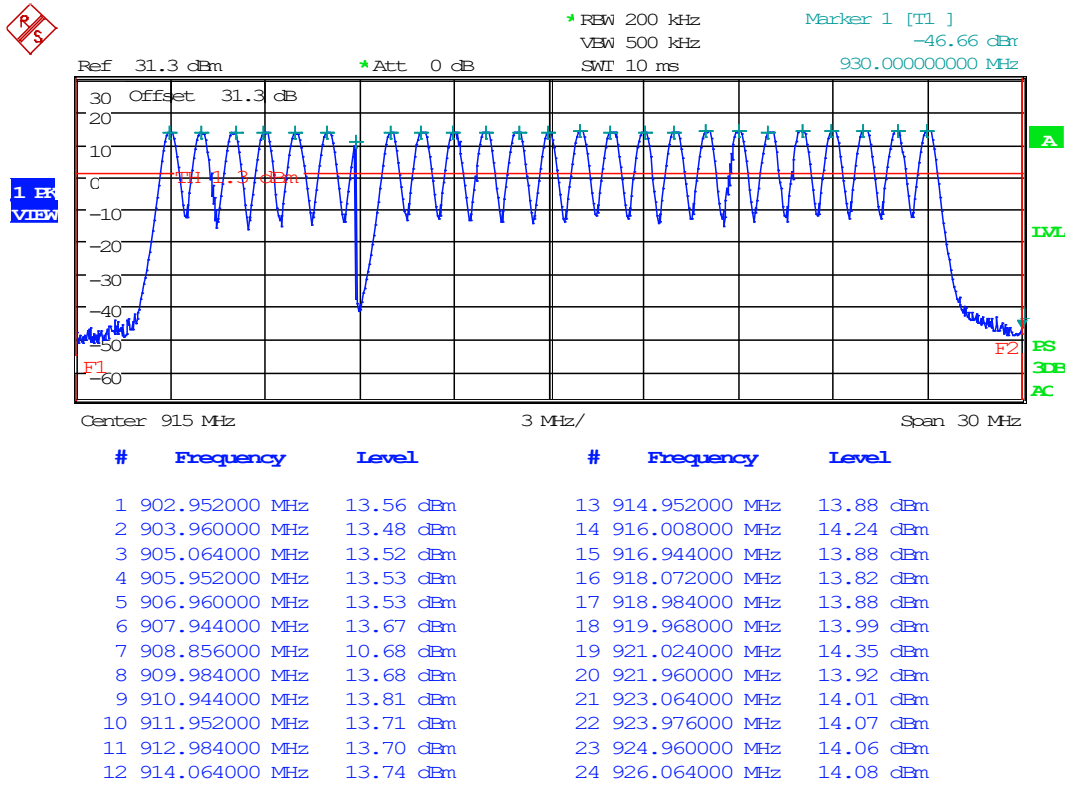
Hopping Characteristics, Spectrum Plots

8.1.2 Carrier Frequency Separation Plot



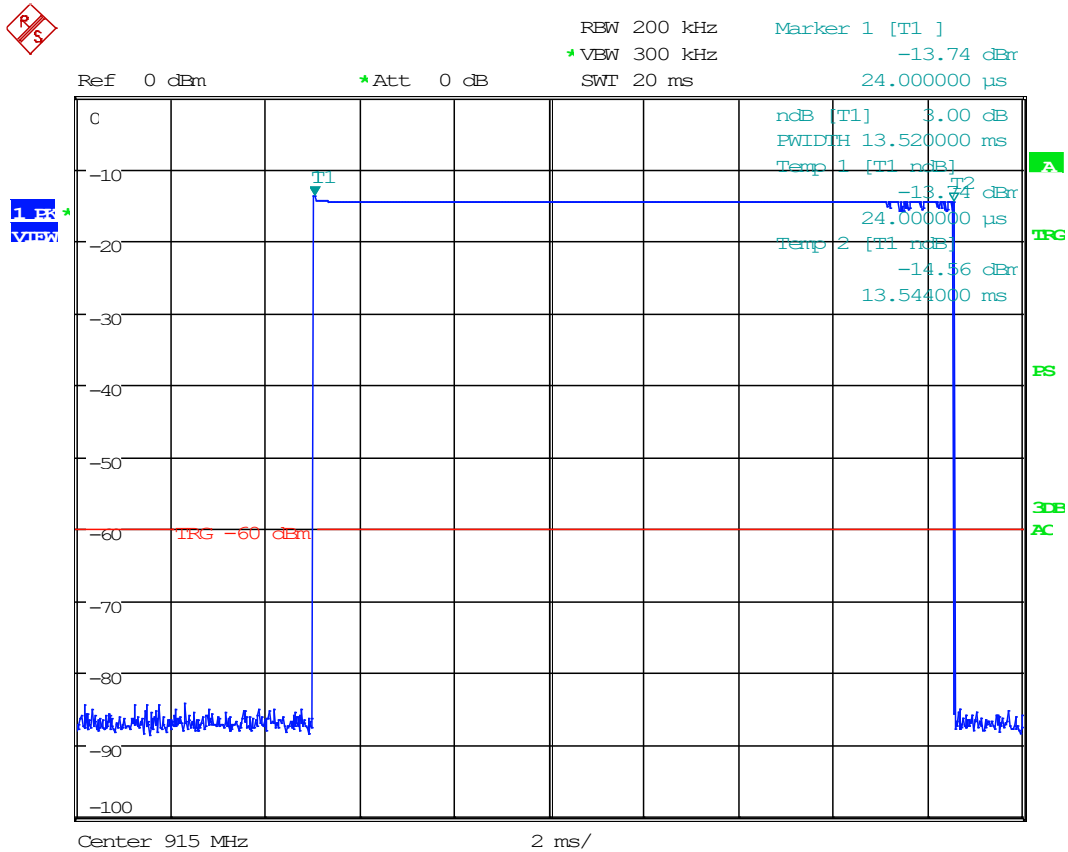

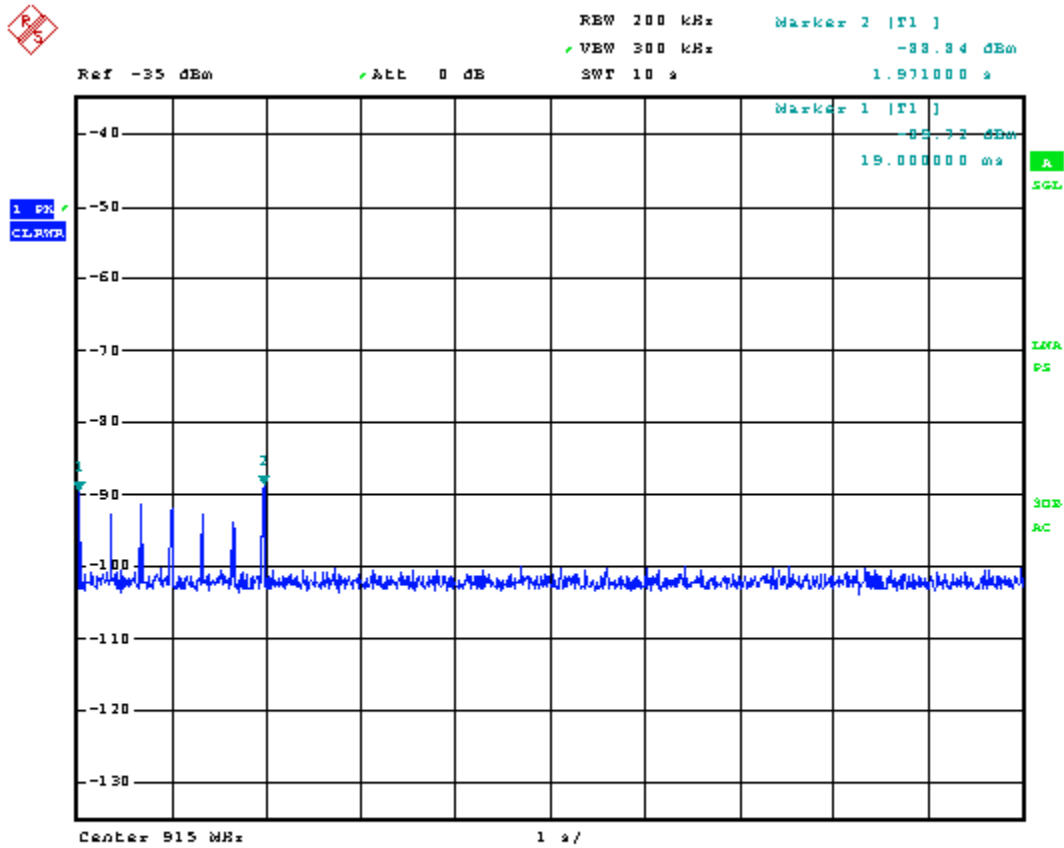

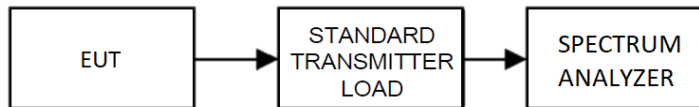

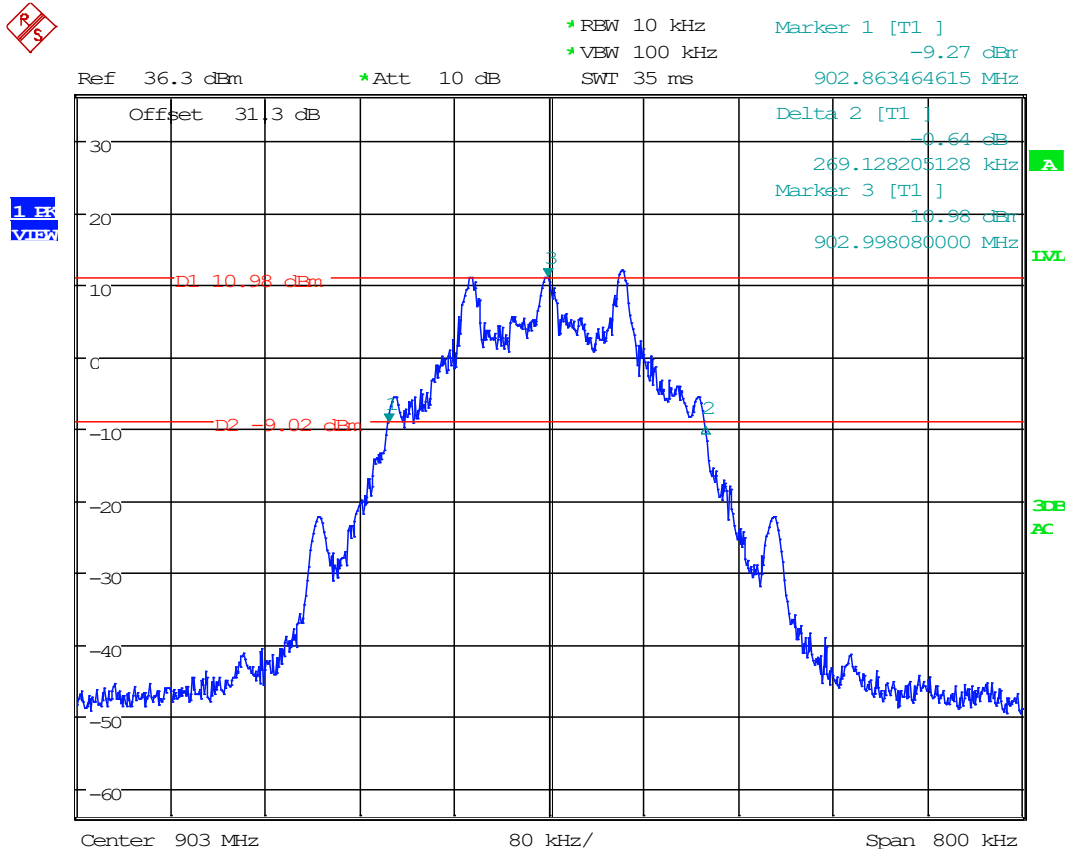

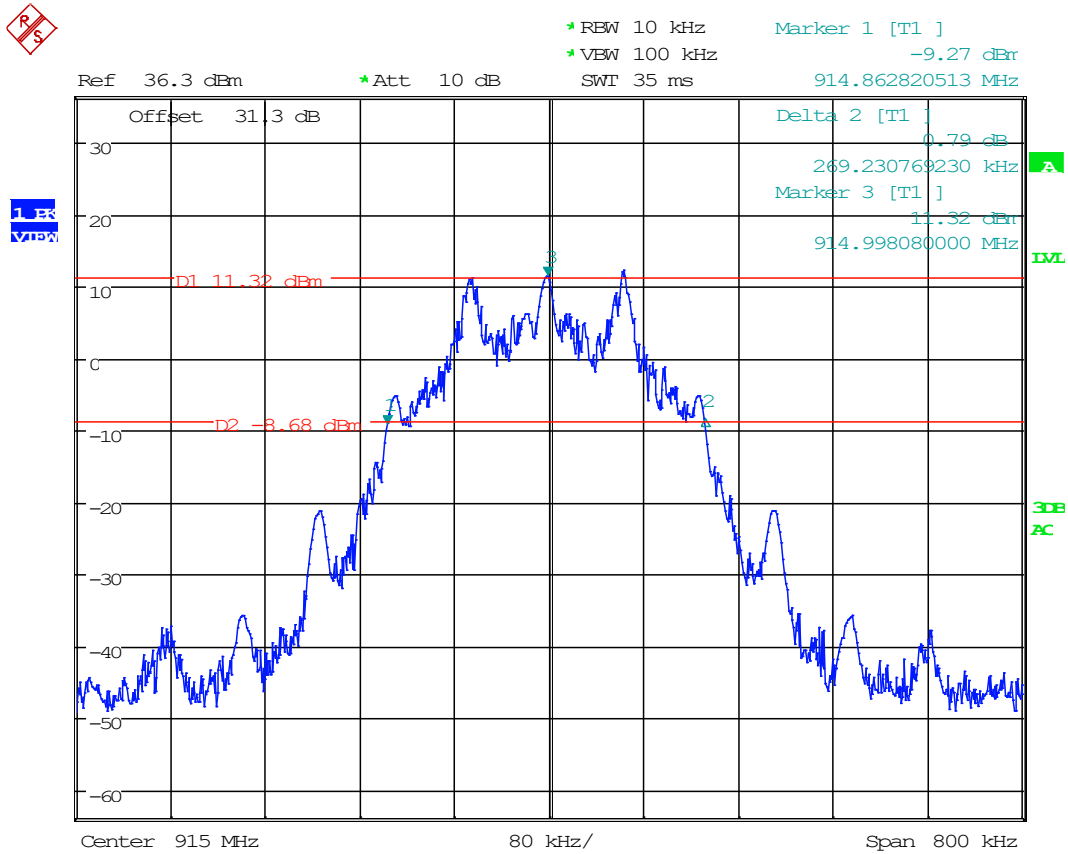
Occupied Bandwidth, Spectrum Plots

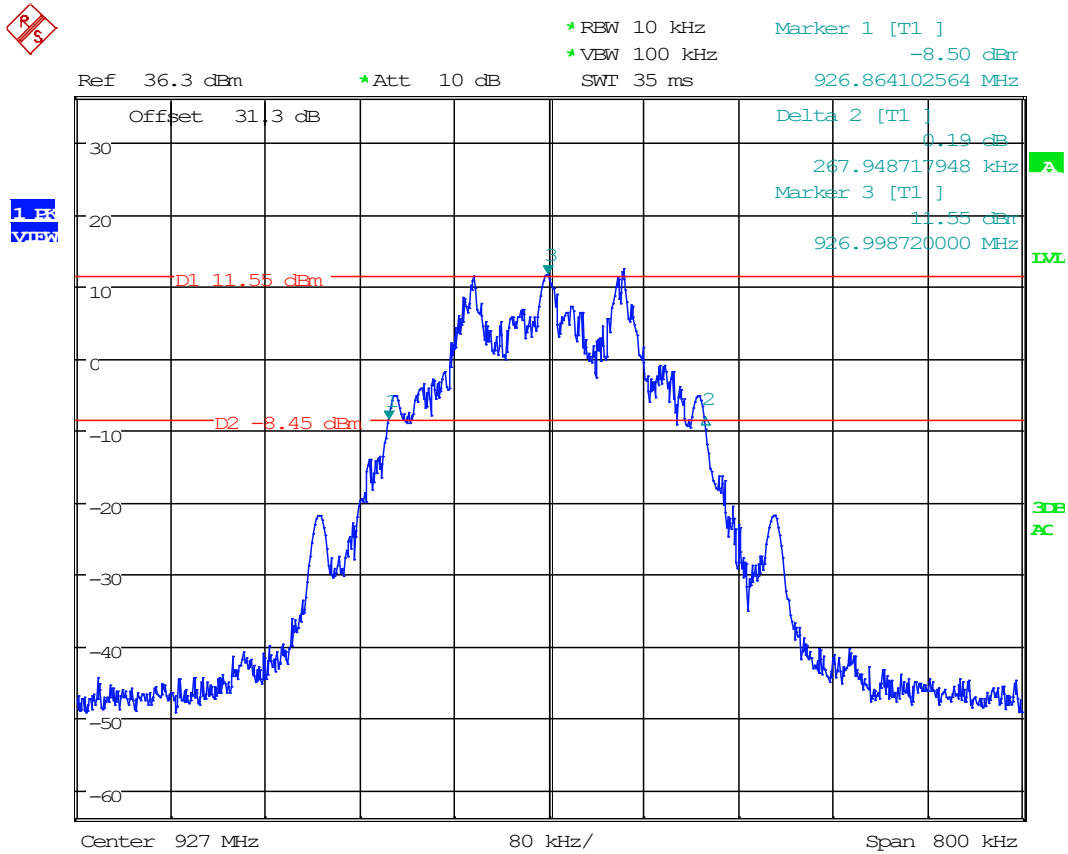

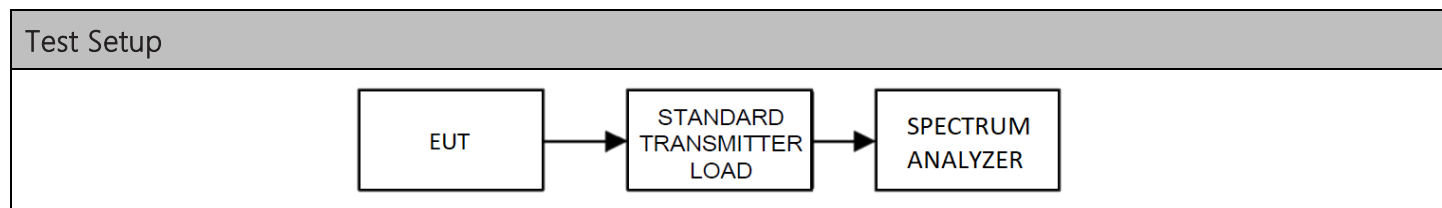

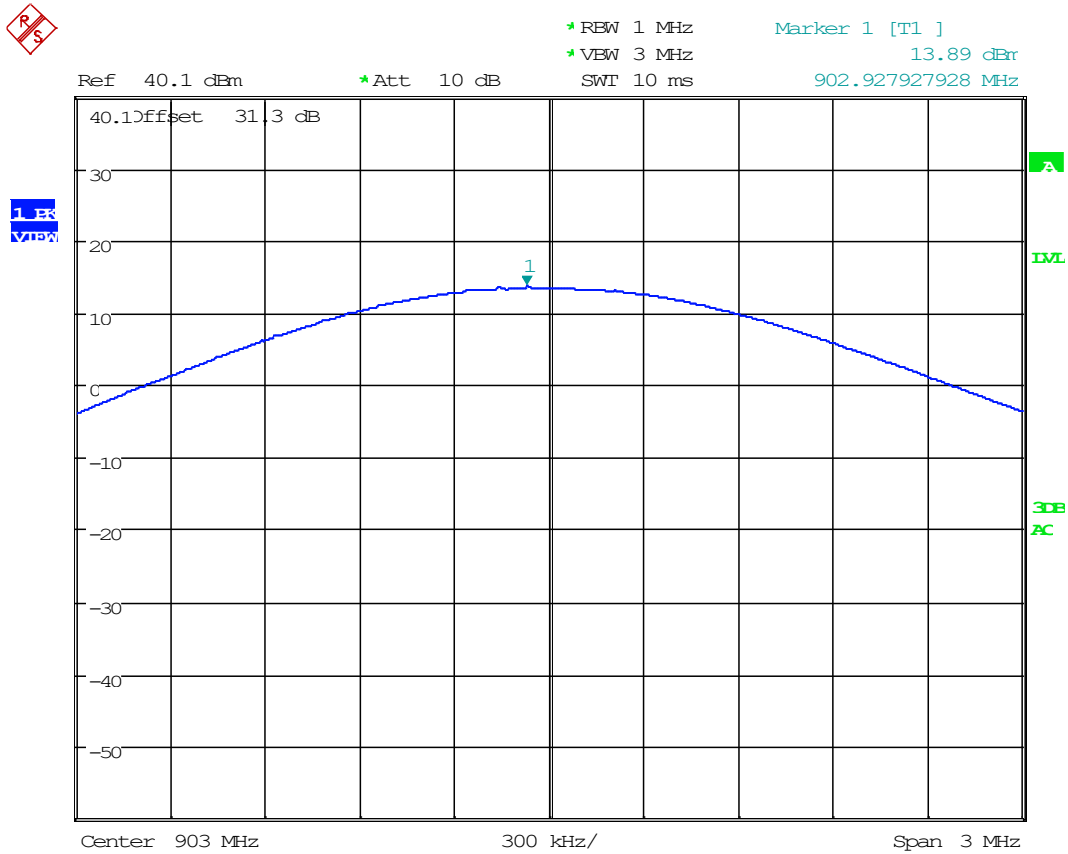

Conducted Output Power, Spectrum Plots

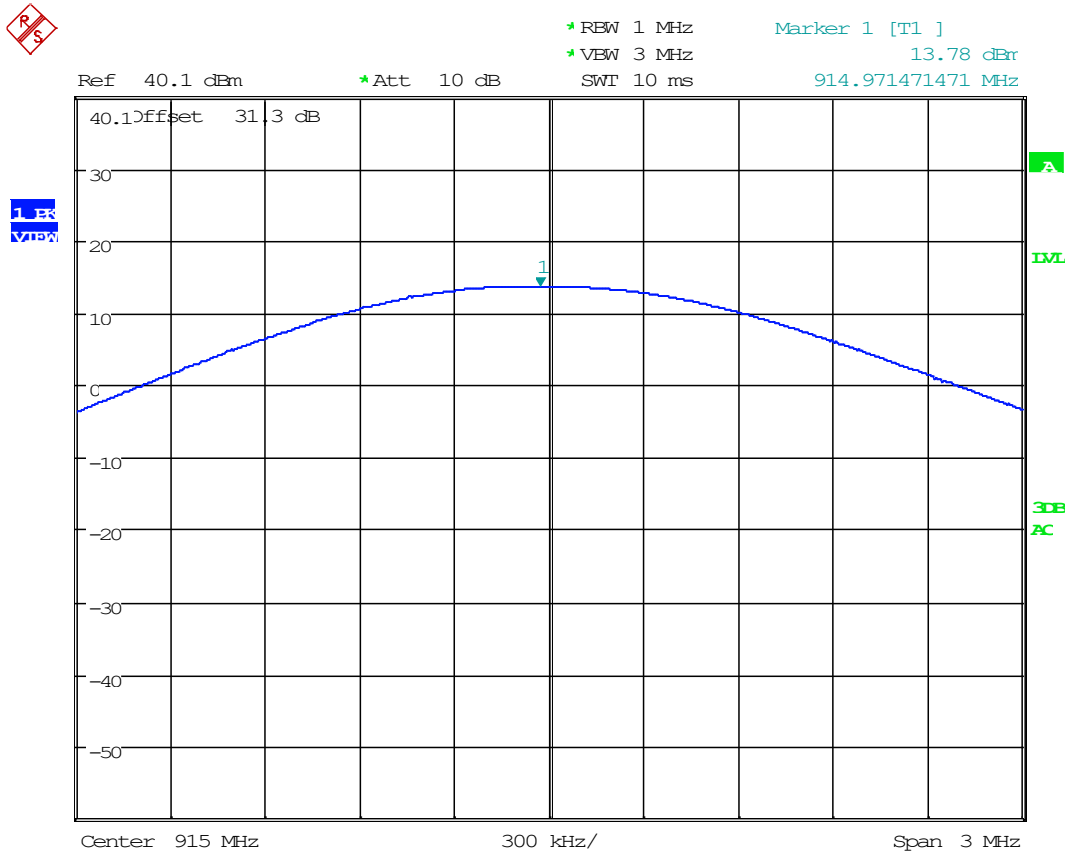

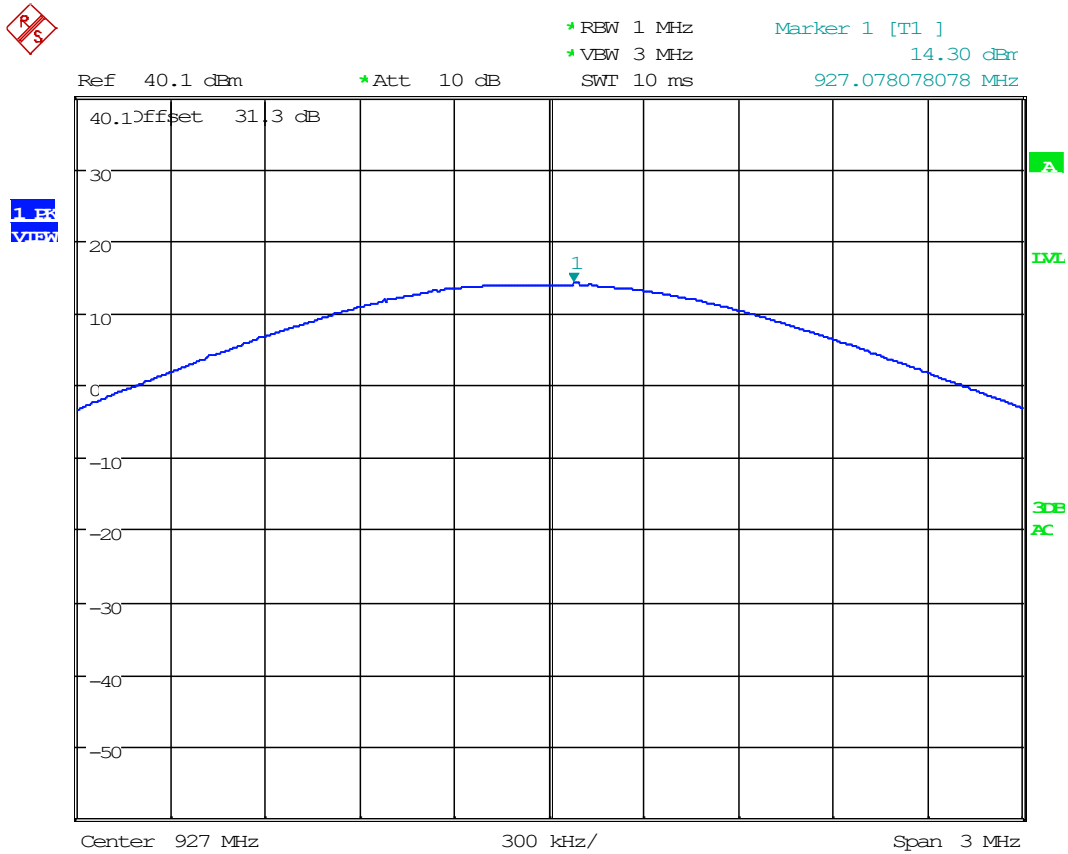
8.3.2 Conducted Output Power, 915 MHz

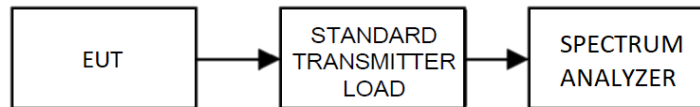

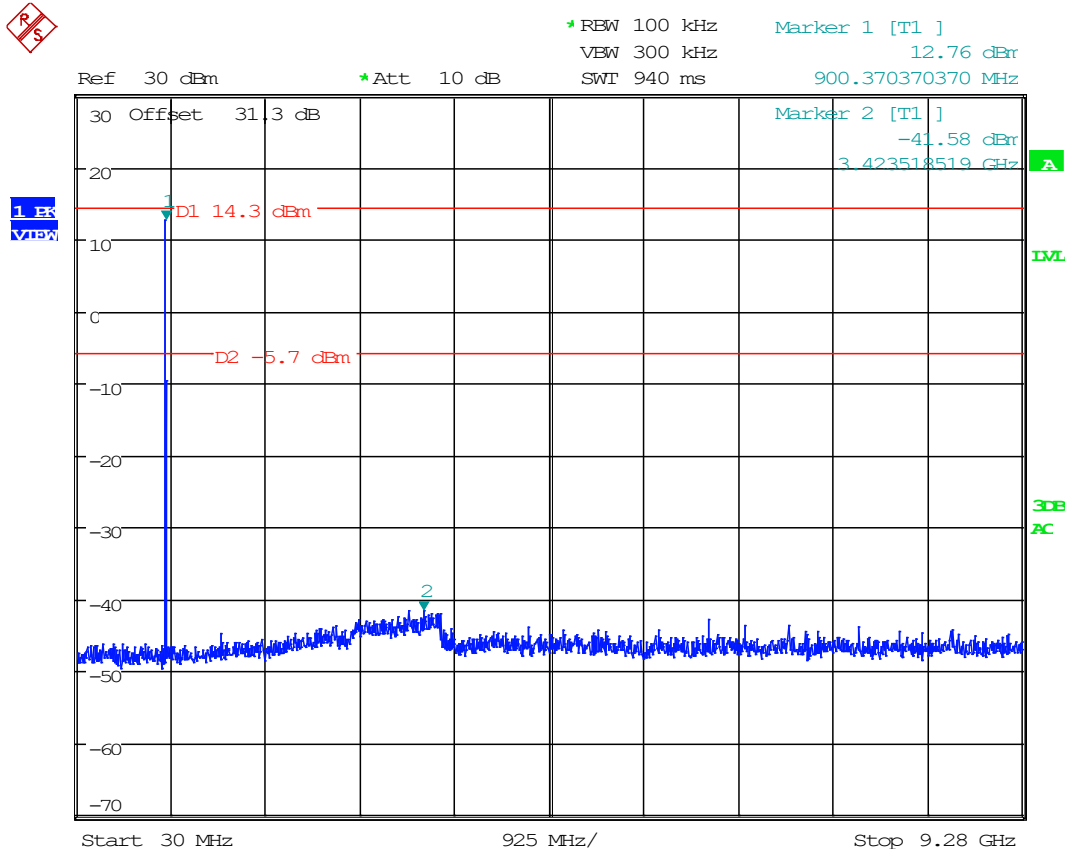

Conducted Emissions in Non-Restricted Bands, Spectrum Plots

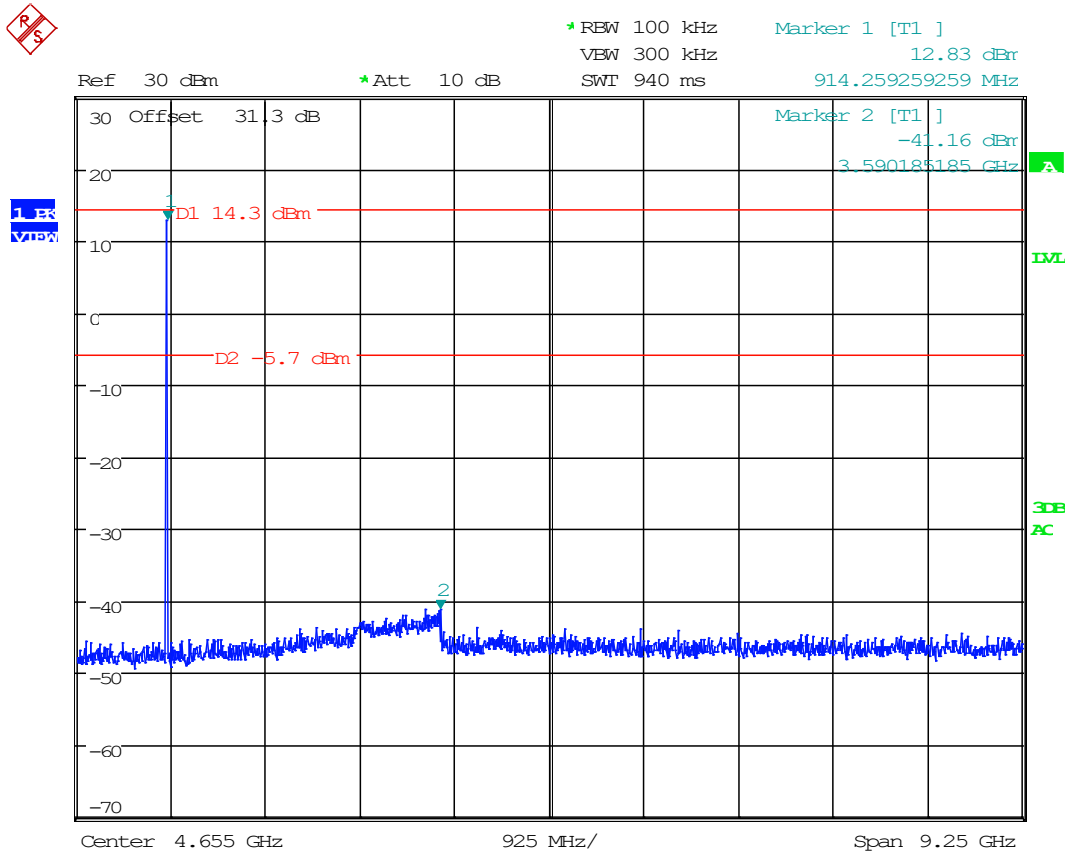

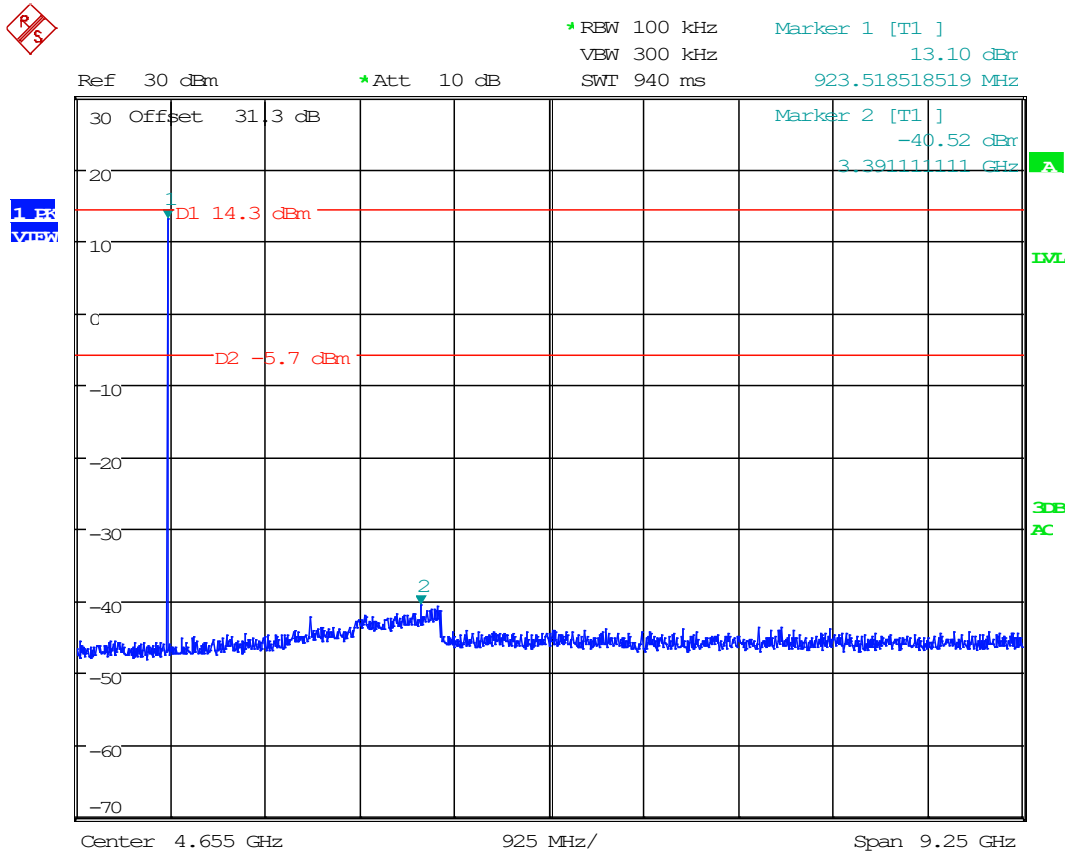

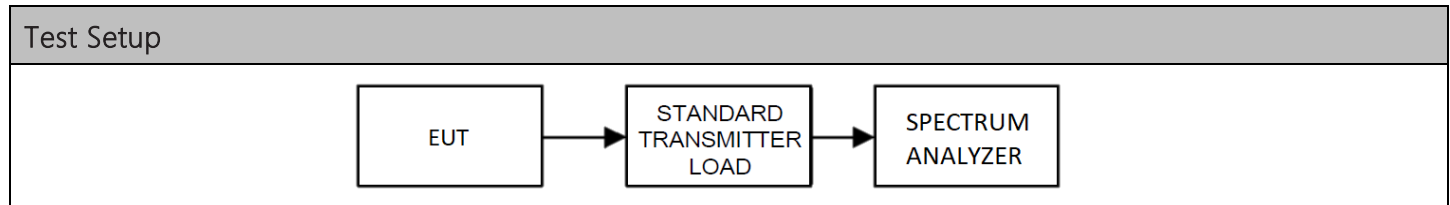

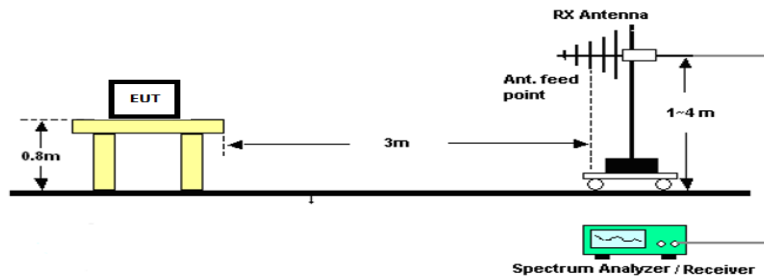

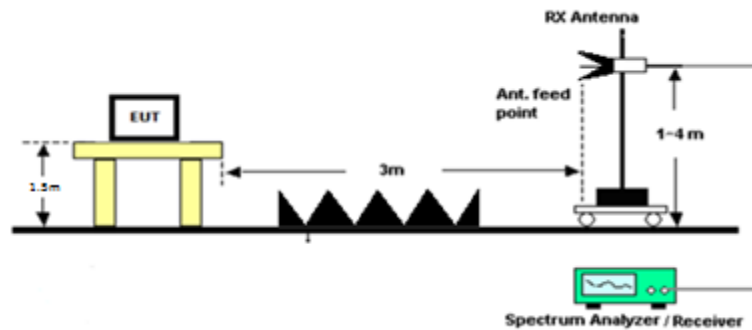
Conducted Test Setup

Radiated Test Setup, Above 1000 MHz

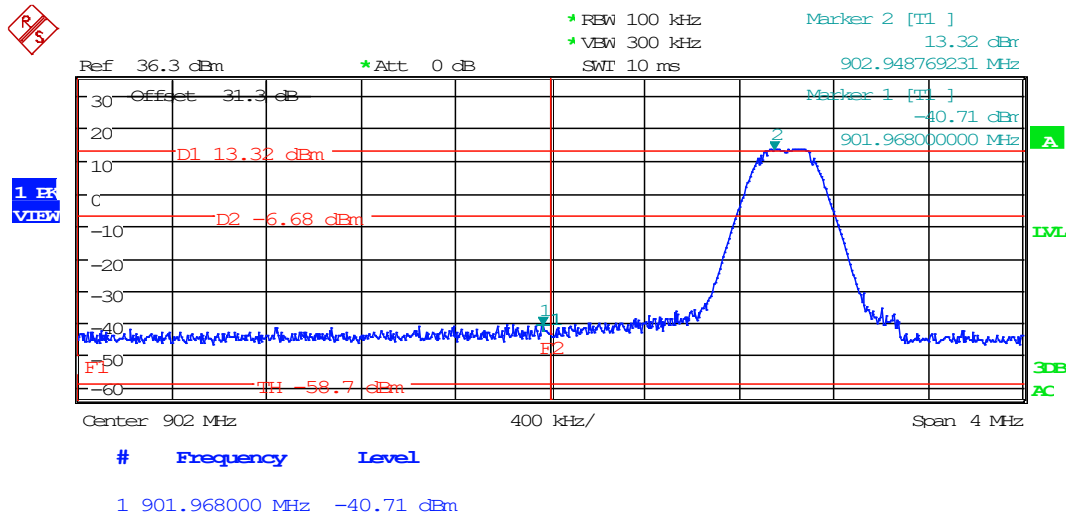

8.6.1 Lower Band Edge Plot, Stopped

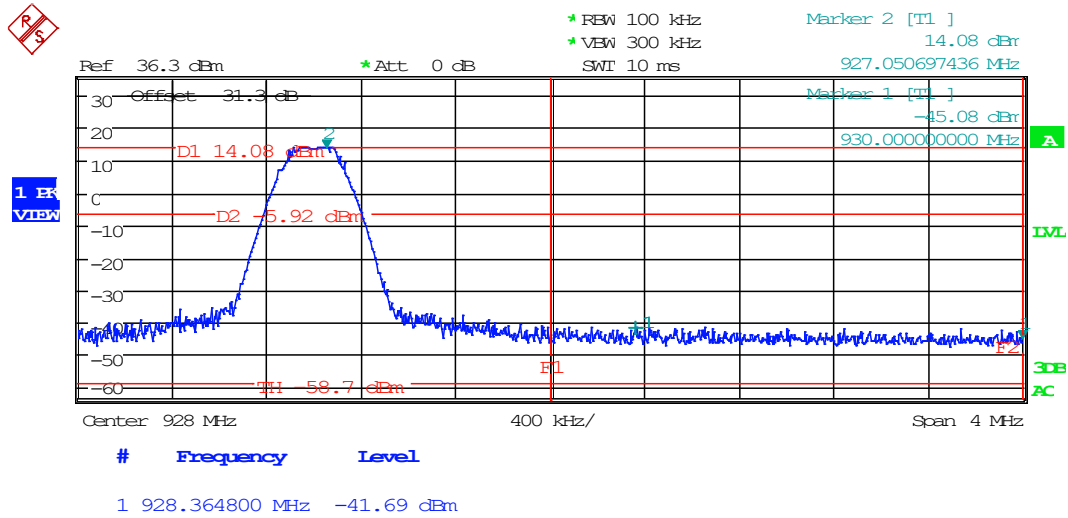

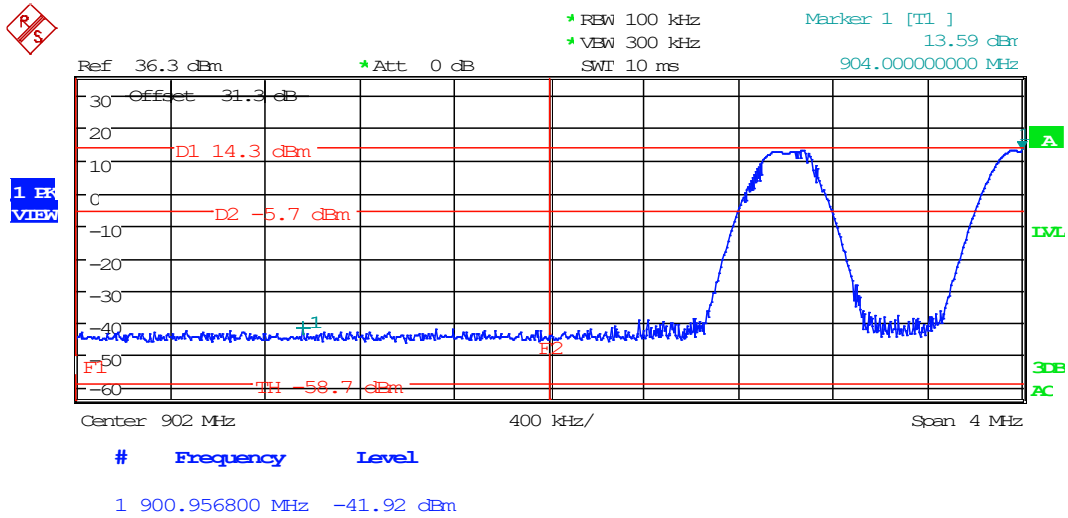

8.6.2 Upper Band Edge Plot, Stopped



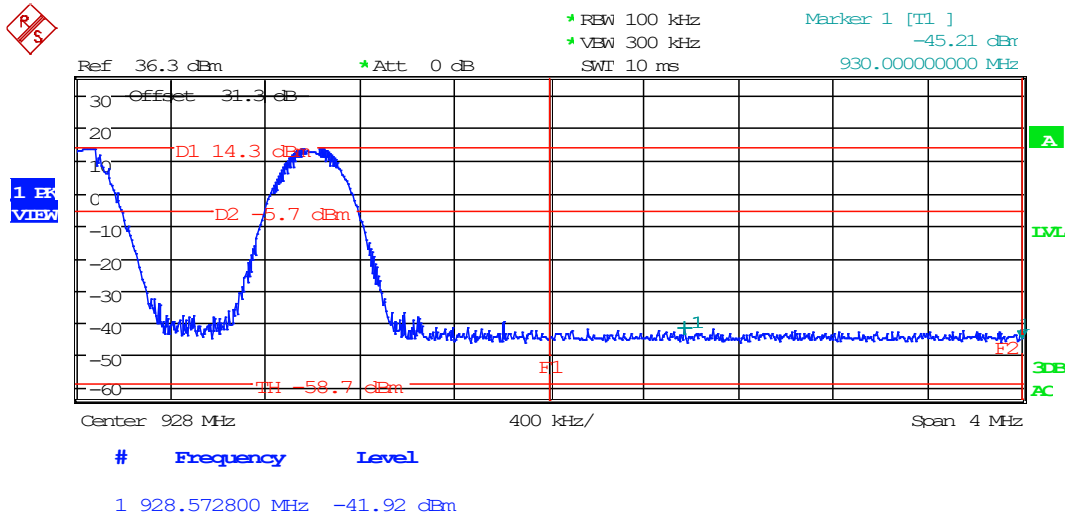

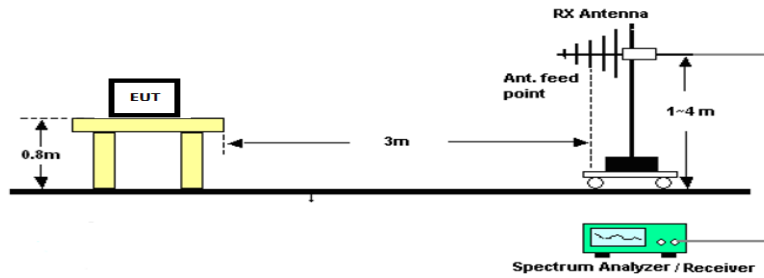

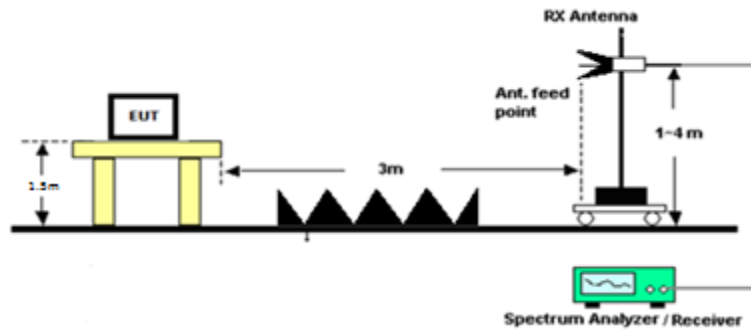
