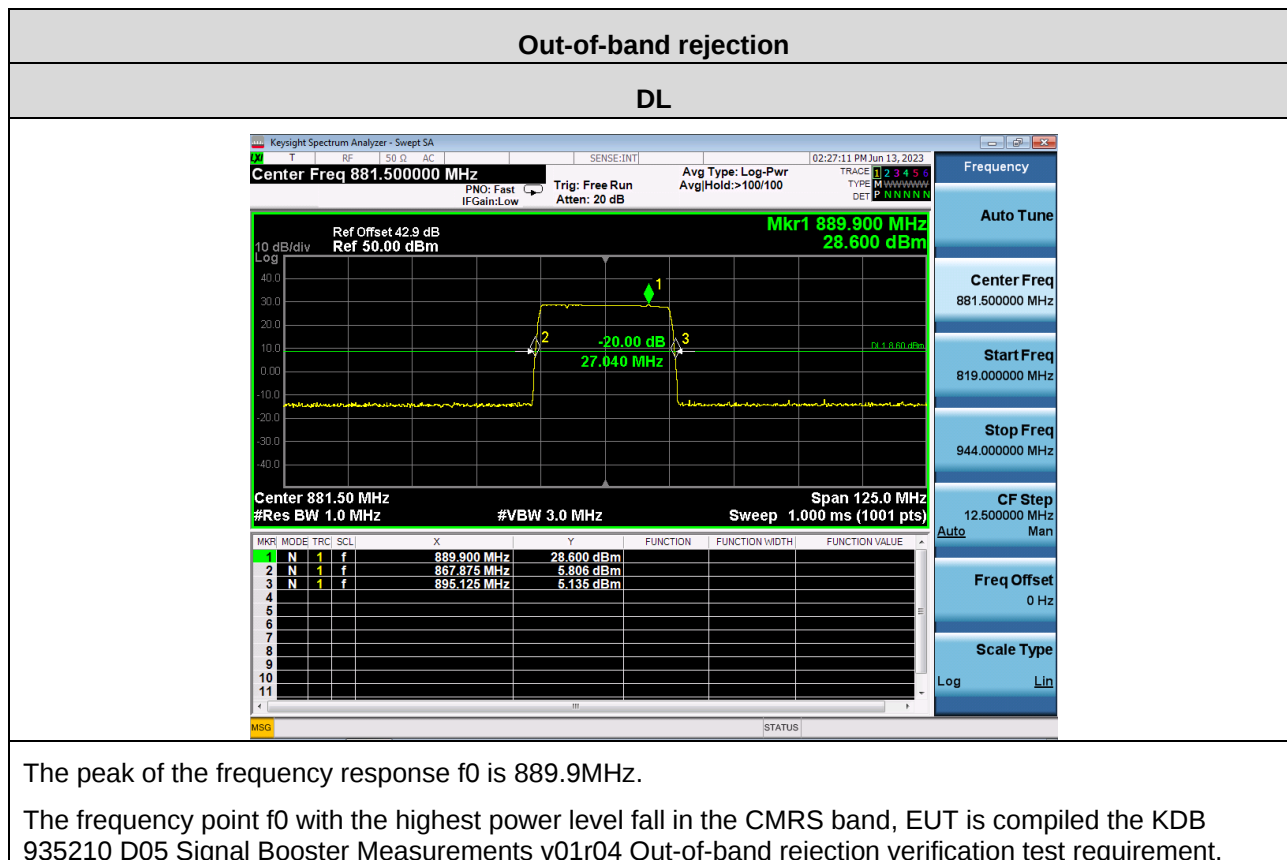

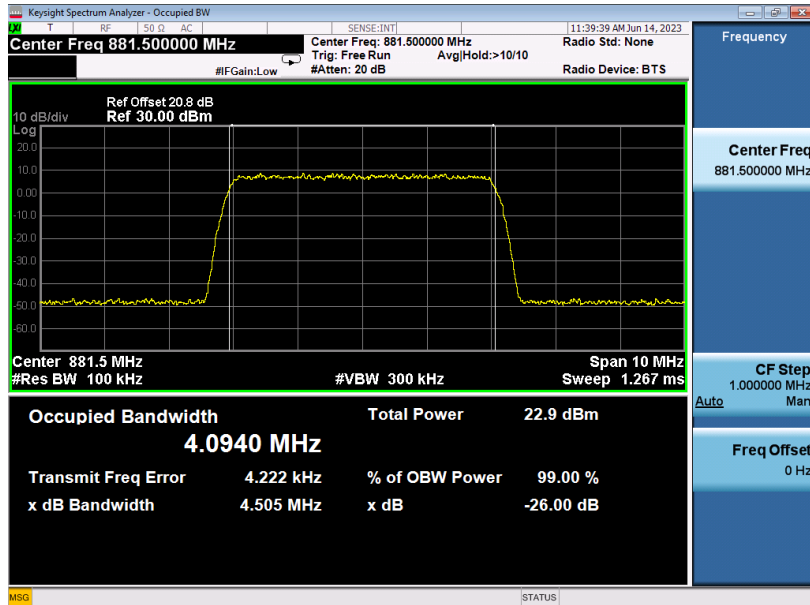

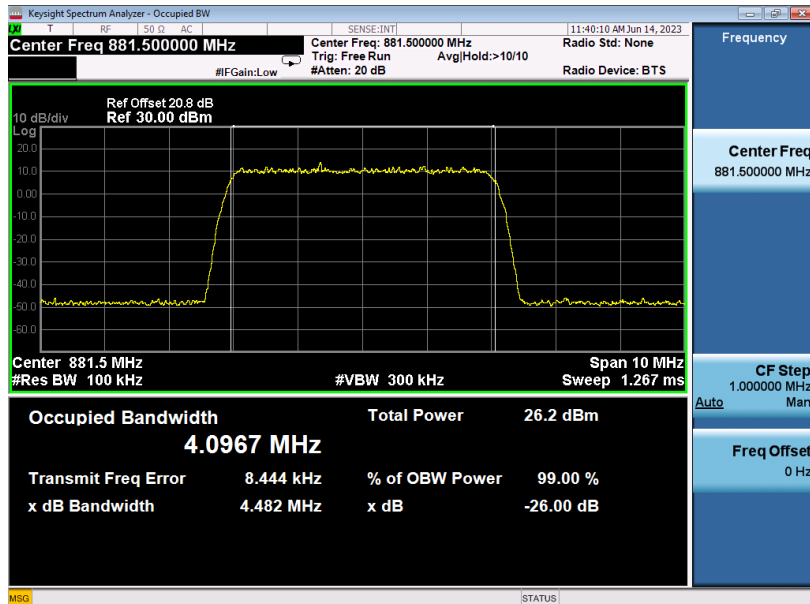

DL_4.1MHz AWGN_MCH_Input_3dB above AGC

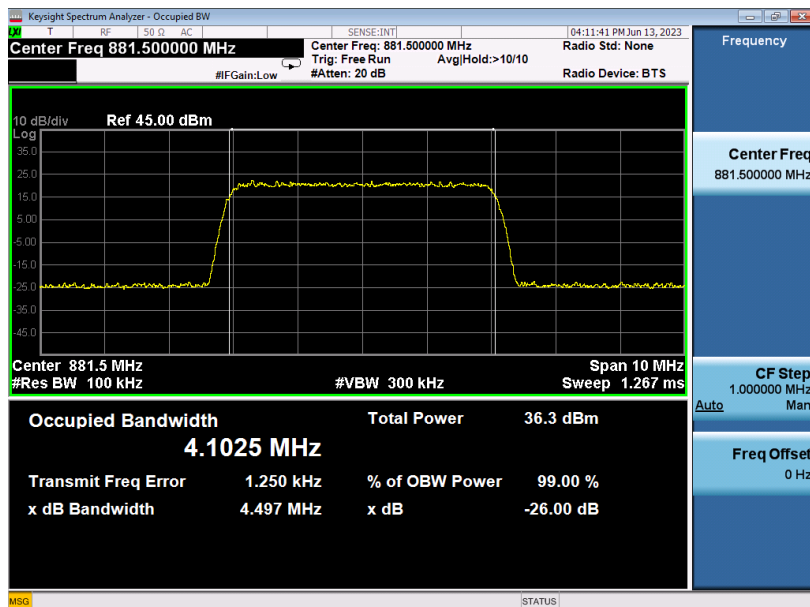

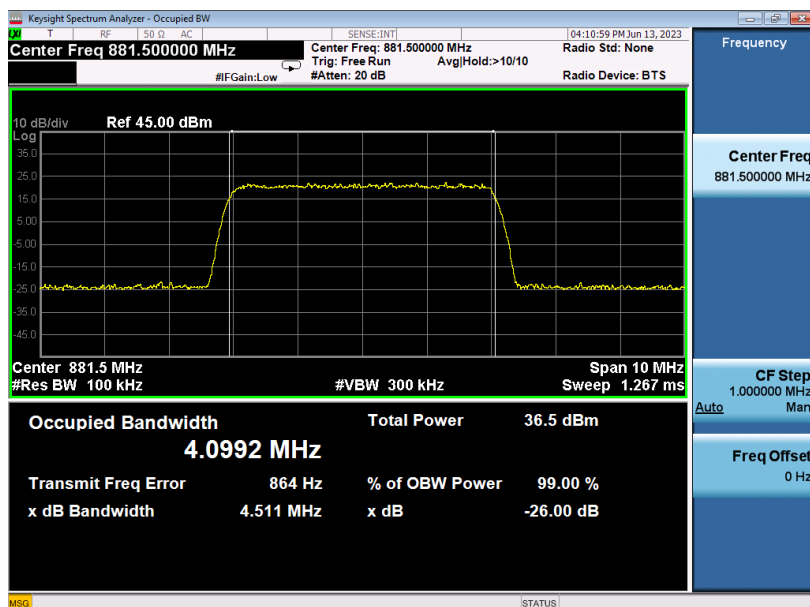

DL_4.1MHz AWGN_MCH_Output_3dB above AGC

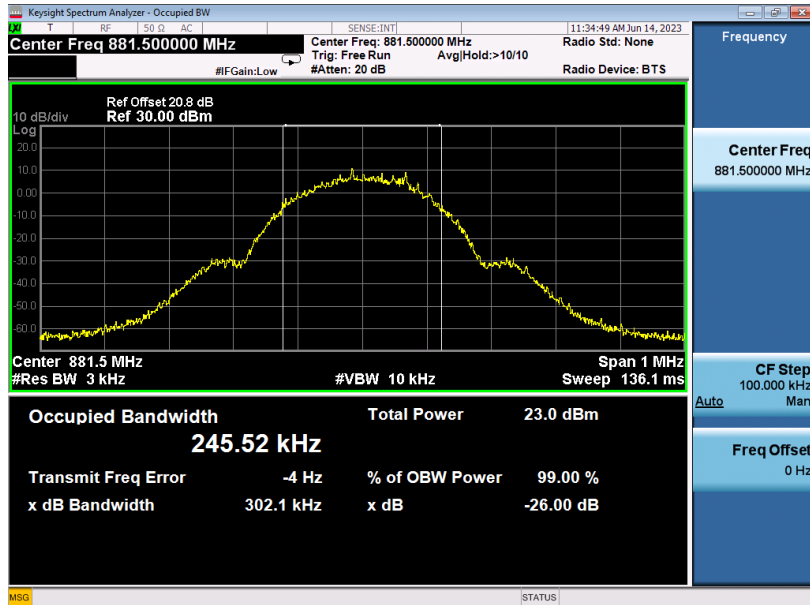

DL_100MHz AWGN_MCH_Input_3dB above AGC

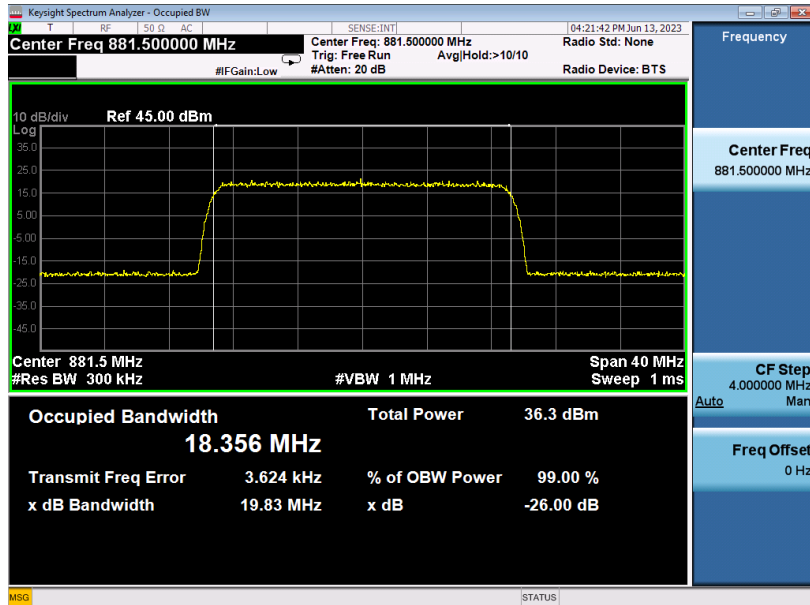

DL_GSM_LCH_a single test signal_3dB above AGC

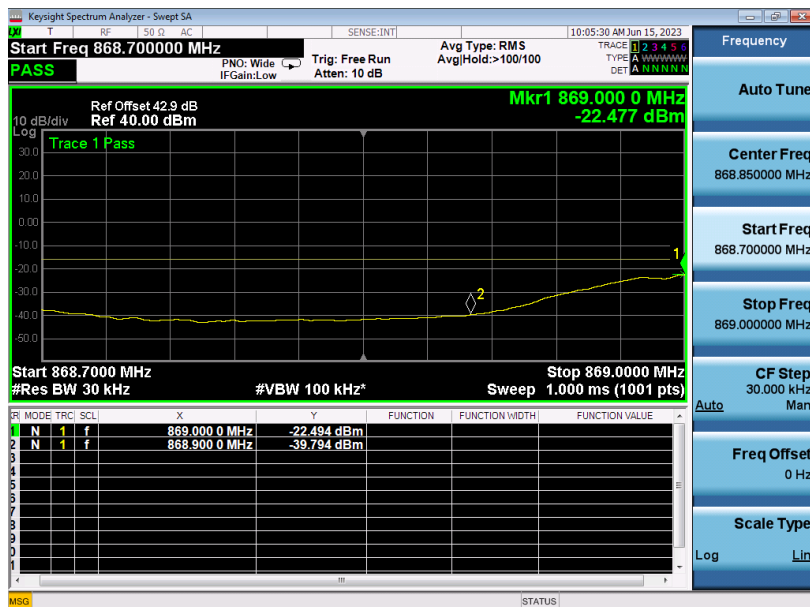

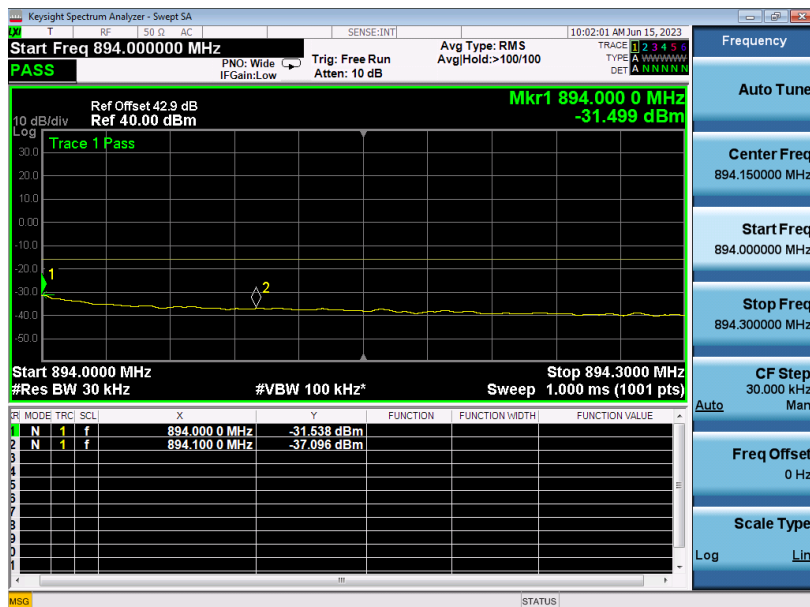

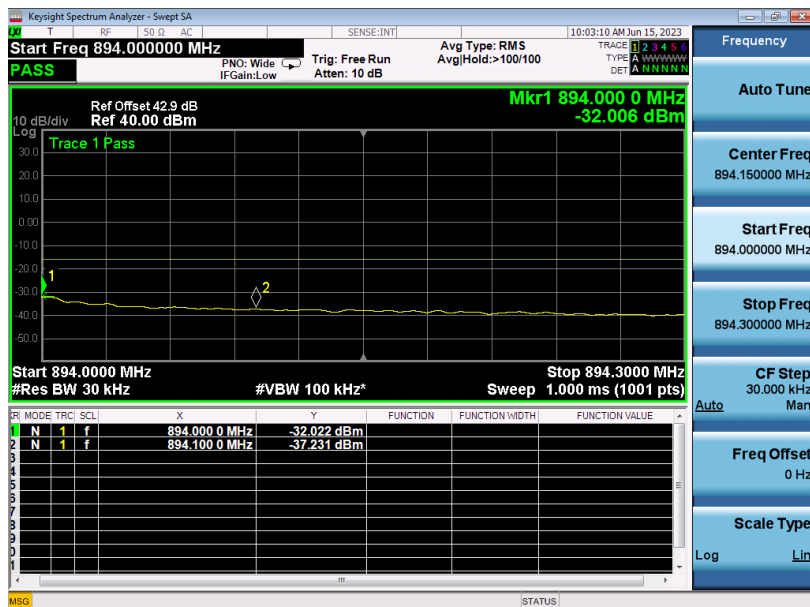

DL_GSM_HCH_a single test signal_3dB above AGC

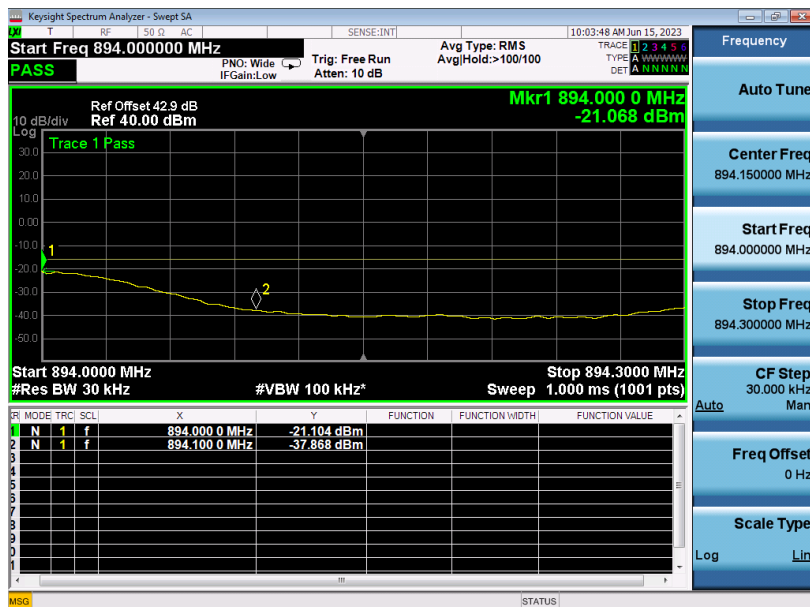

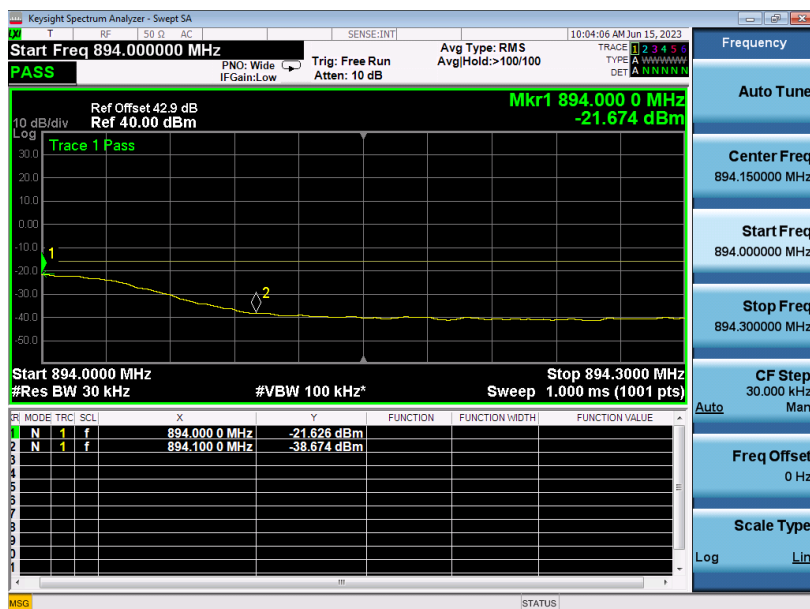

DL_GSM_HCH_two adjacent test signals_3dB above AGC



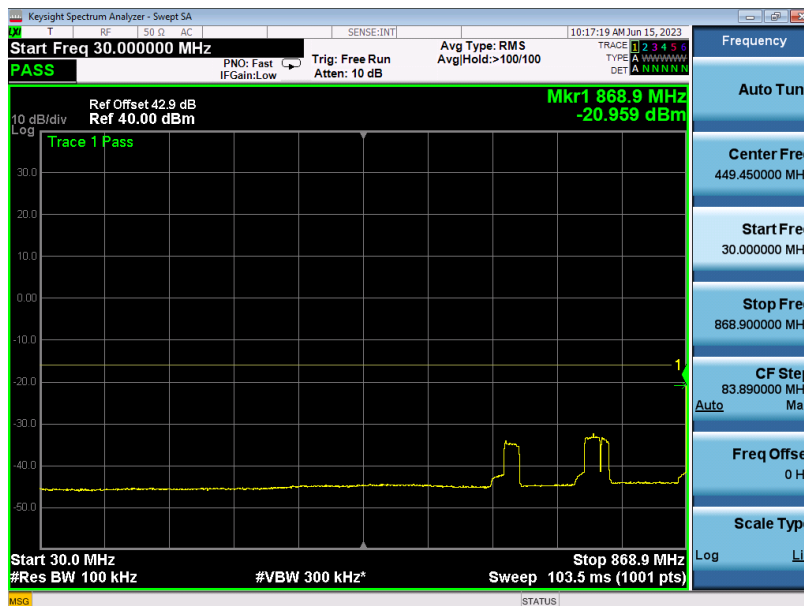

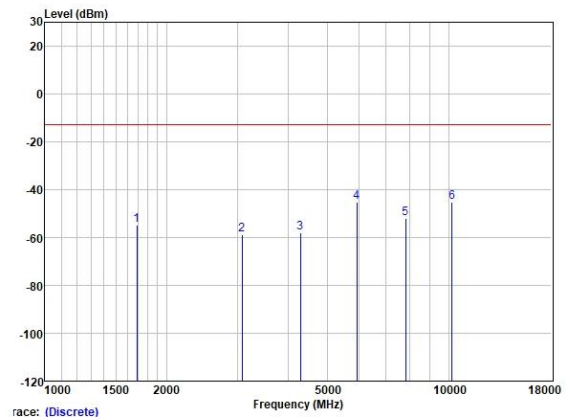
