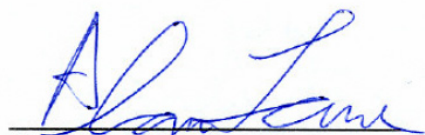

- b) 3 meters measurement distance was used in this test.

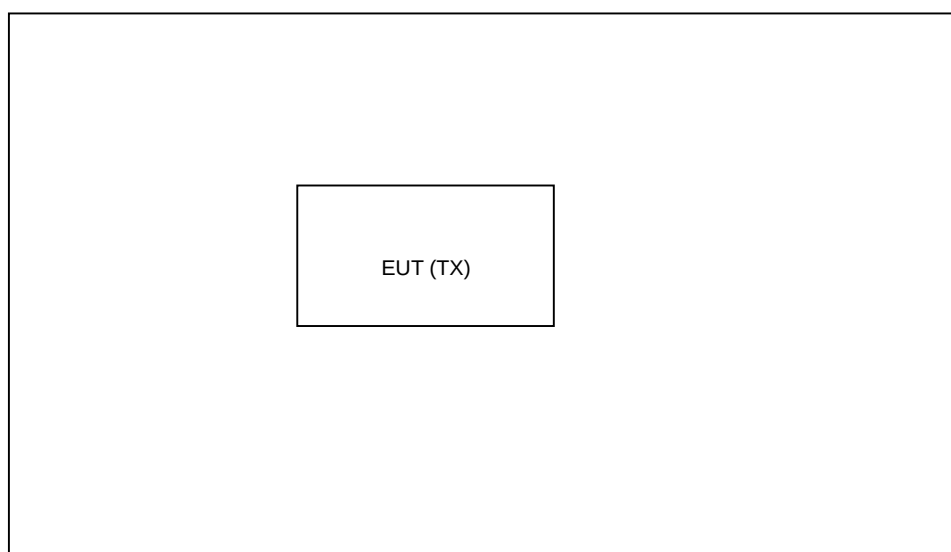

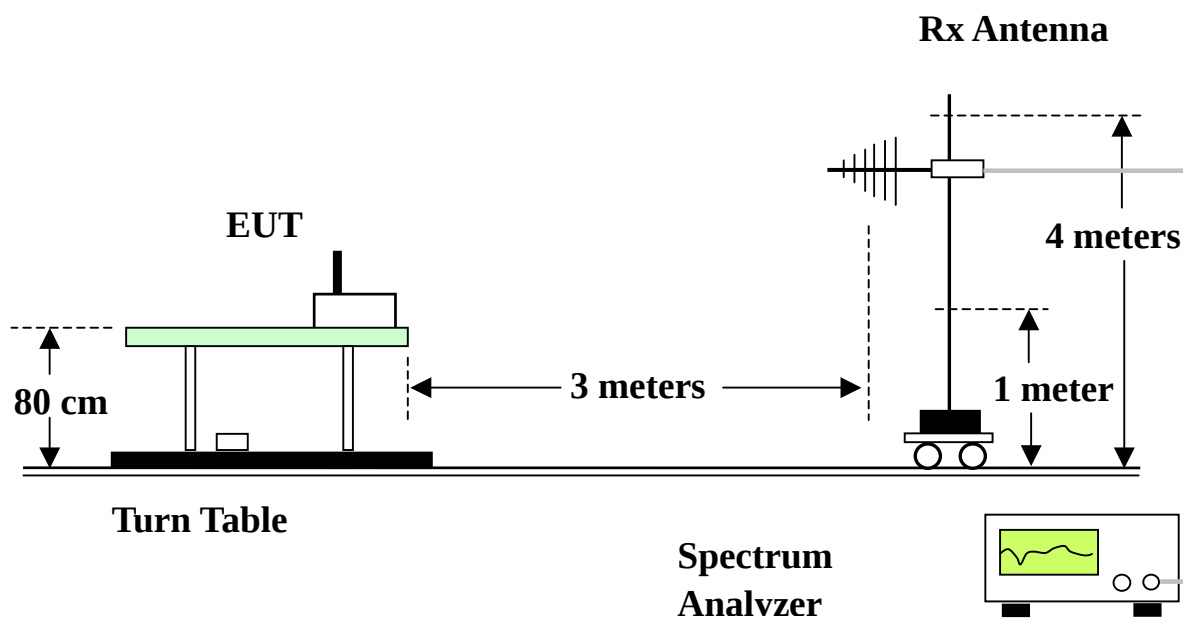

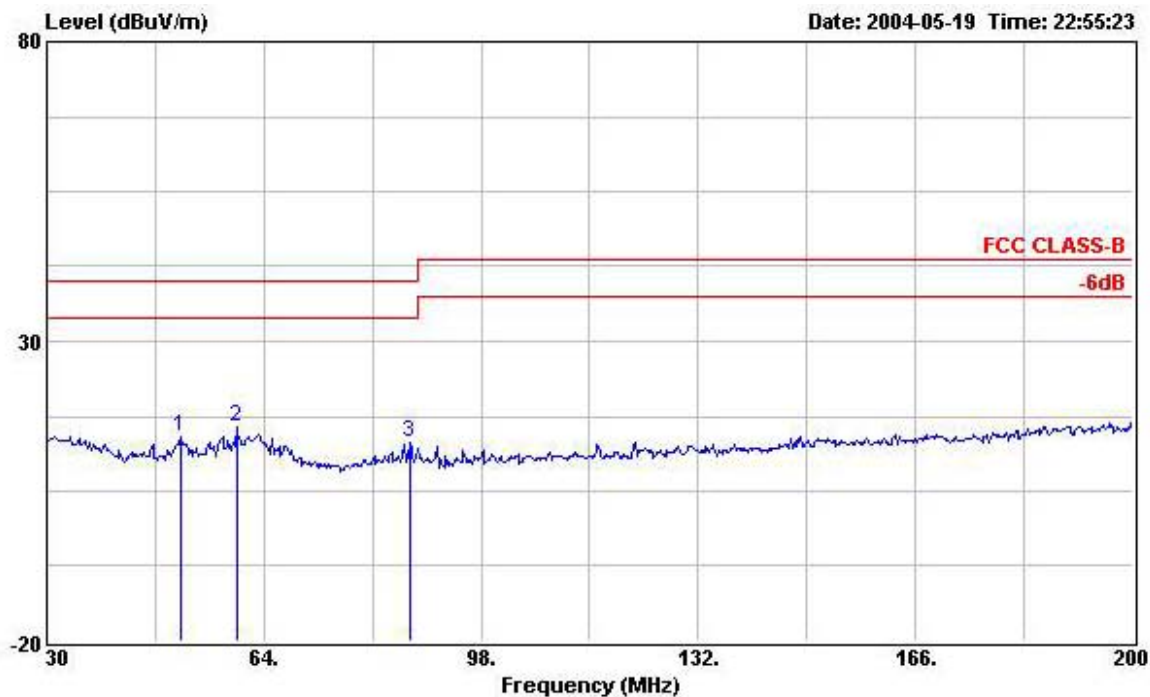

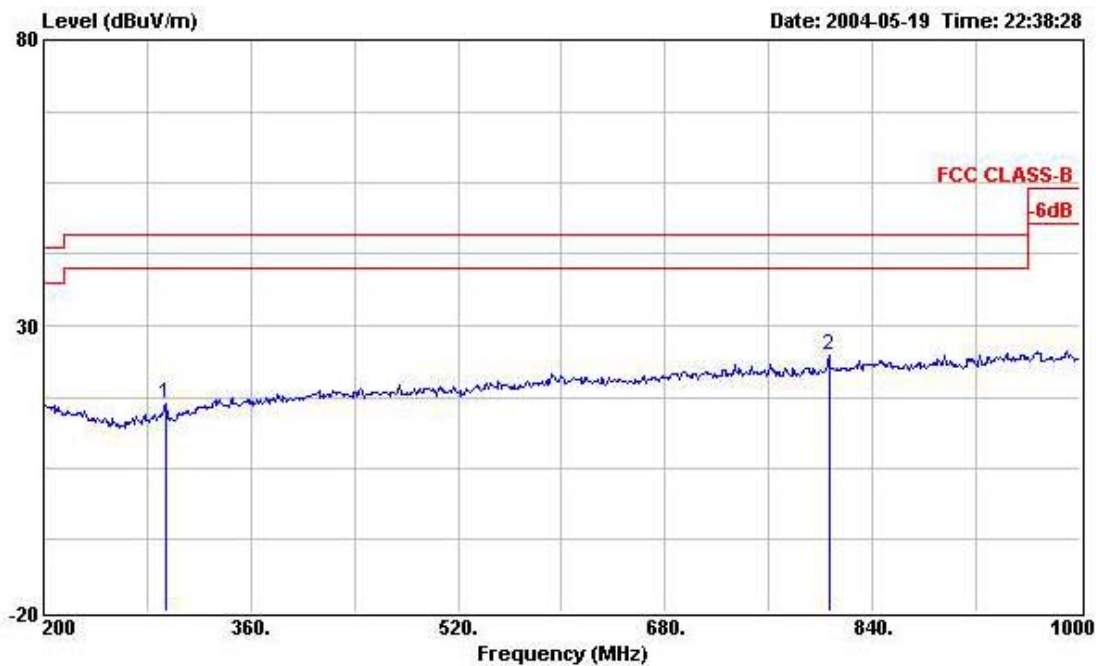

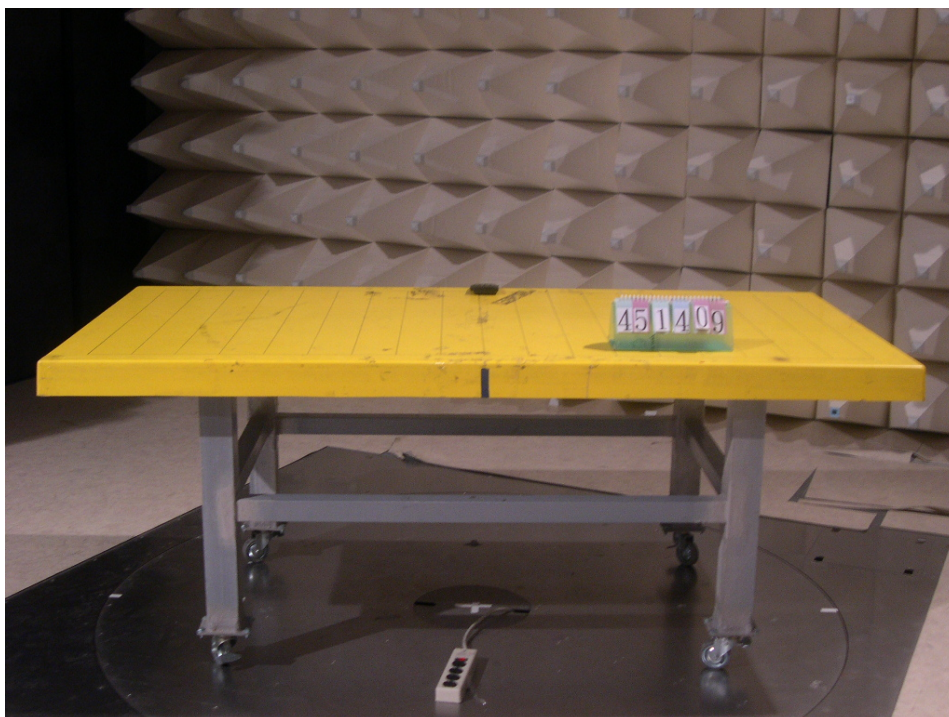

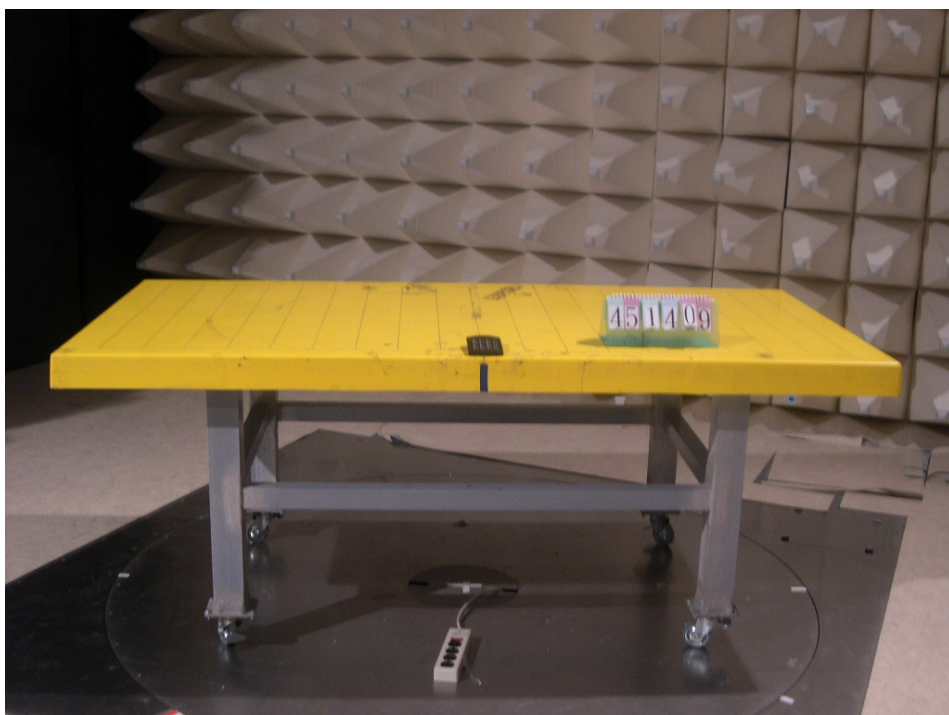
