The sample was placed 0.8m above the ground plane on the OATS *. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigate all operating modes, rotated about all 3 axis (X, Y & Z) to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

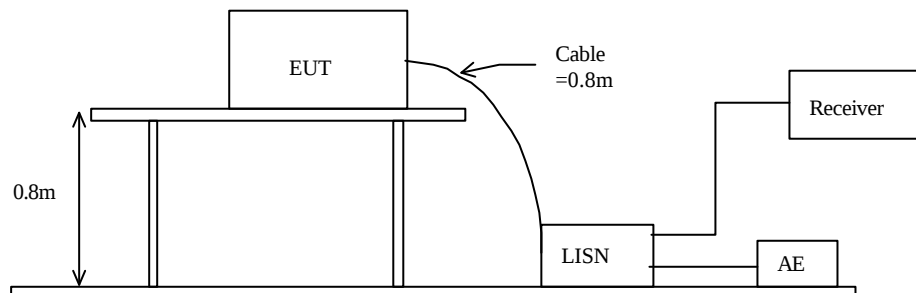

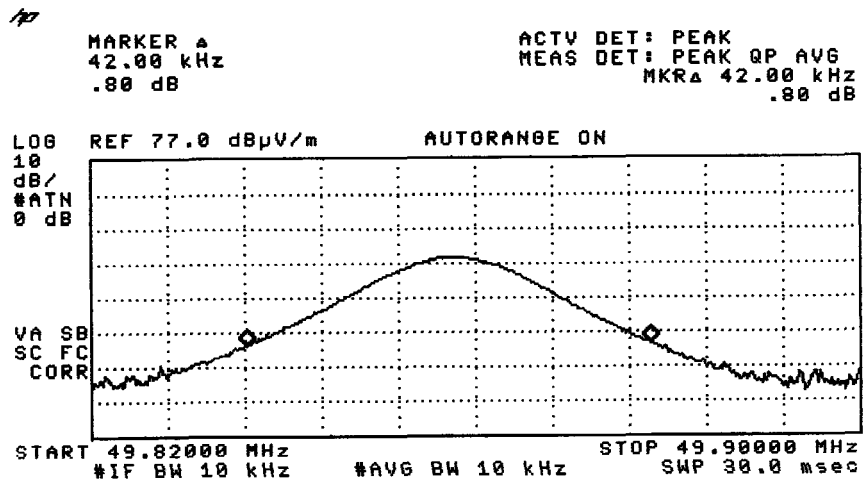

Appendix B**Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (91.5msec) never exceeds a series of 23 long (2msec) or short (1.75msec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worse case transmit duty cycle would be considered $23 \times 2\text{msec}$ per $91.5\text{msec} = 50.2\%$ duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.

Remarks:

Duty Cycle Correction = $20\text{Log}(0.502) = -60.0\text{dB}$

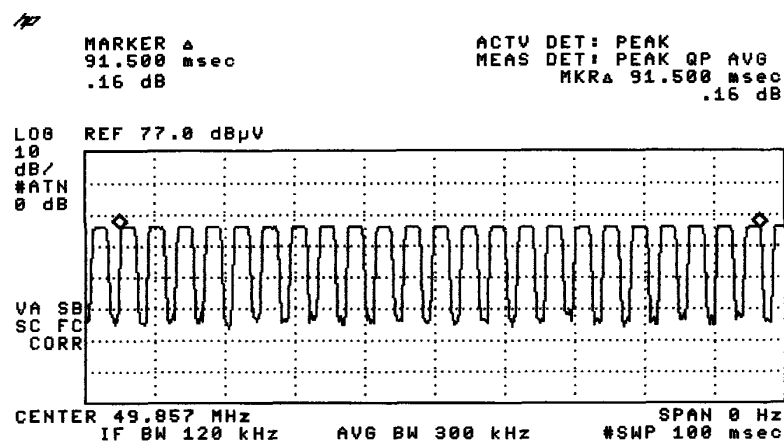
Figure A [Pulse Train]

Figure B [Long Pulse]

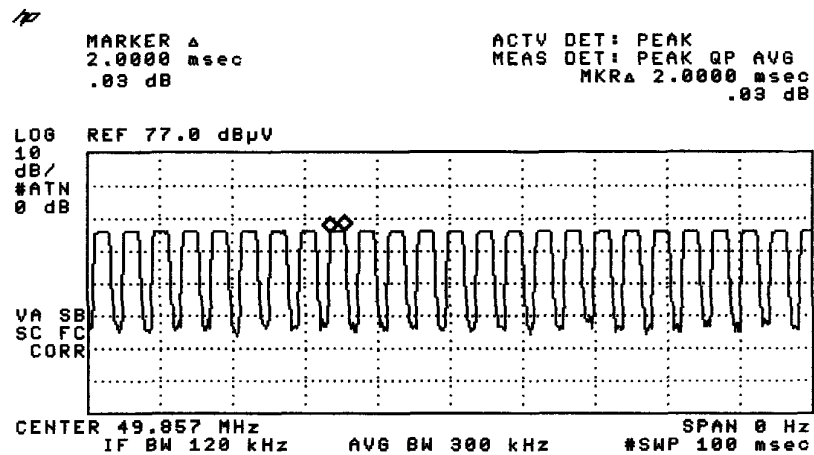
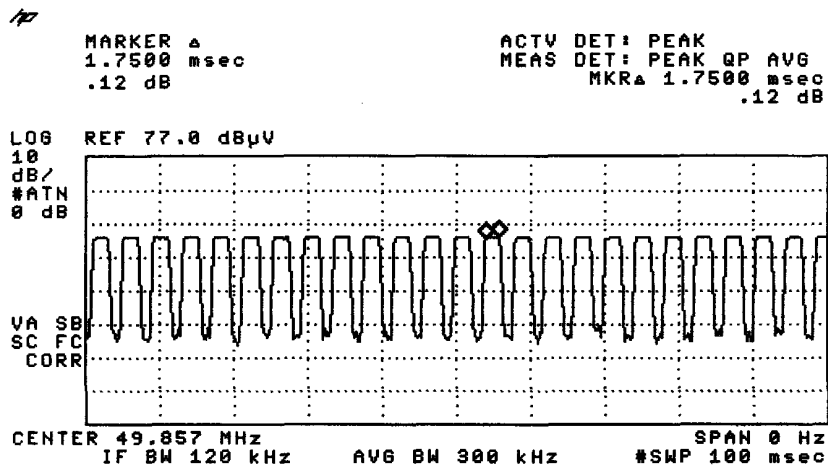


Figure C [Short Pulse]

Modification Method

1. Add two c capacitors of 5pF.
2. The antenna coil was changed to 6T:6T.
3. The resistor was changed from 100ohm to 150ohm.
4. Delete a resistor of 3K 3ohm.
5. Delete a c cap. of 100pF.
6. Added a c capacitor of 0.1µF across XT case and SW(+).

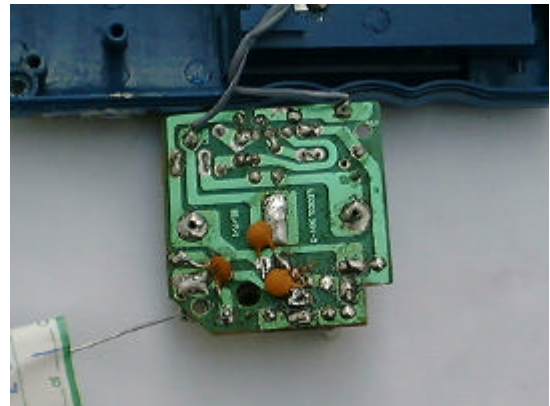
Rear View of the product
