1 - GENERAL INFORMATION

1.1 Product Description for Equipment Under Test (EUT)

The *STARWISE INDUSTRIAL (HONG KONG) LTD.*'s *REW-7E*, *REW-11E*, *REW-15E*, *REW-20E* or the "EUT" as referred to in this report is a light bulb. The EUT with different model names measure 1.5" L x 1.5" W x 5.25"H, 1.5" L x 1.5" W x 6"H, 1.5" L x 1.5" W x 7"H and 1.5" L x 1.5" W x 7.75" respectively.

For market purpose, the manufacturer applies four model names: *REW-7E*, *REW-11E*, *REW-15E*, *REW-20E* to the same EUT. The above applicant affirms that no changes have been made that warrant retest or resubmission. .

Note: The test data was only good for the test sample. It may have deviation for other test sample.

1.2 Objective

The following test report is prepared on behalf of *STARWISE INDUSTRIAL (HONG KONG) LTD.* in accordance with Part 2, Subpart J, and Part 18, Subparts A, B, and C of the Federal Communication Commissions rules and regulations.

The objective of the manufacturer is to demonstrate compliance with FCC Part 18 limit requirements for Industrial, Scientific, and Medical Equipment.

1.3 Related Submittal(s)/Grant(s)

No Related Submittals.

1.4 Test Methodology

All measurements contained in this report were conducted with ANSI C63.4 –1992, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz. All radiated and conducted emissions measurement was performed at Bay Area Compliance Laboratory Corp. The radiated testing was performed at an antenna-to-EUT distance of 3 Meters.

1.5 Test Facility

The Open Area Test site used by Bay Area Compliance Laboratory Corporation to collect radiated and conducted emission measurement data is located in the back parking lot of the building at the back parking lot of the building at 230 Commercial Street, Sunnyvale, California, USA.

Test site at Bay Area Compliance Laboratory Corporation has been fully described in reports submitted to the Federal Communication Commission (FCC) and Voluntary Control Council for Interference (VCCI). The details of these reports has been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on February 11 and December 10, 1997 and Article 8 of the VCCI regulations on December 25, 1997. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-1992.

The Federal Communications Commission and Voluntary Control Council for Interference has the reports on file and is listed under FCC file 31040/SIT 1300F2 and VCCI Registration No.: C-1298 and R-1234.

The test site has been approved by the FCC and VCCI for public use and is listed in the FCC Public Access Link (PAL) database.

Additionally, Bay Area Compliance Laboratory Corporation is a National Institute of Standards and Technology (NIST) accredited laboratory, under the National Voluntary Laboratory Accredited Program (NVLAP). The scope of the accreditation covers the FCC Method - 47 CFR Part 15 - Digital Devices, IEC/CISPR 22: 1998, and AS/NZS 3548: Electromagnetic Interference - Limits and Methods of Measurement of Information Technology Equipment test methods under NVLAP Lab Code 200167-0.

The EUT was tested under normal mode as used by a common (typical) user.

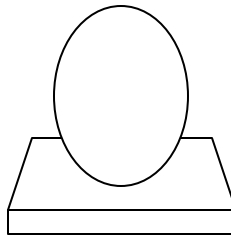

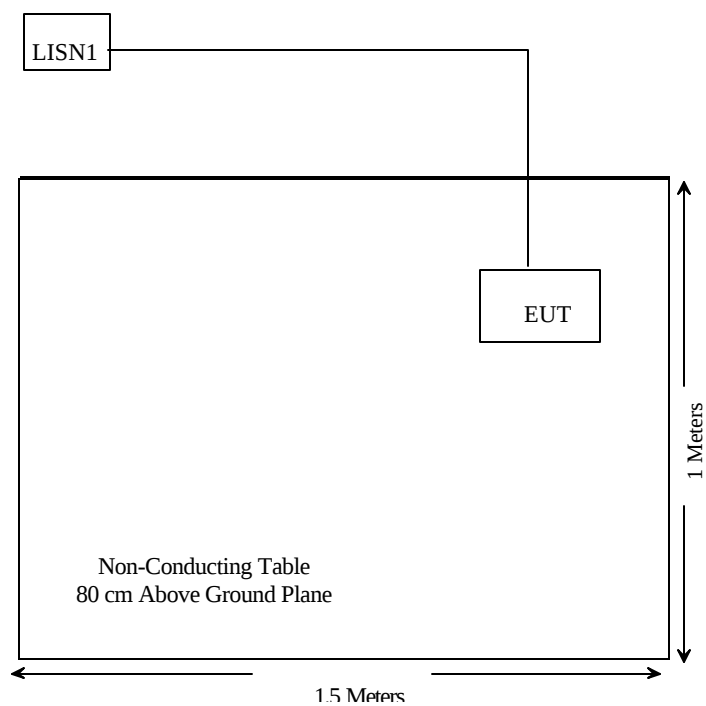
2.3 Equipment Modifications

3 - CONDUCTED EMISSIONS TEST DATA

3.1 Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, and LISN.

Based on NIS 81, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of any conducted emissions measurement at BACL is ± 2.4 dB.

3.2 EUT Setup

The measurement was performed at the **Open Area Test Site**, using the same setup per ANSI C63.4 - 1992 measurement procedure. The specification used was the FCC Part 18 limits.

The EUT was placed on the center of the back edge on the test table.

The power cord extension of the EUT was connected with 110 Vac/60 Hz power source.

3.3 Spectrum Analyzer Setup

The spectrum analyzer was set with the following configuration during the conduction test:

3.4 Test Procedure

During the conducted emission test, the power cord of the power cord extension was connected to the auxiliary outlet of the first LISN.

Maximizing procedure was performed on the six (6) highest emissions to ensure that the EUT is compliant with all installation combination.

All data was recorded in the peak detection mode. Quasi-peak readings were only performed when an emission was found to be marginal (within -4 dB μ V of specification limits). Quasi-peak readings are distinguished with a "Qp".

The EUT was tested under the normal modes during the final qualification test to represent the worst case results.

3.5 Summary of Test Results

According to the data in section 3.6, the EUT complied with the FCC 18 Conducted margin for industry, scientific and medical device, and with the worst margin reading of:

- 21.9 dB μ V at 0.80 MHz at the **Neutral** mode, 0.45-30MHz. (model REW-7E)
- 13.9 dB μ V at 0.78 MHz at the **Neutral** mode, 0.45-30MHz. (model REW-11E)
- 17.6 dB μ V at 0.80 MHz at the **Neutral** mode, 0.45-30MHz. (model REW-15E)
- 18.4 dB μ V at 0.78 MHz at the **Line** mode, 0.45-30MHz. (model REW-20E)

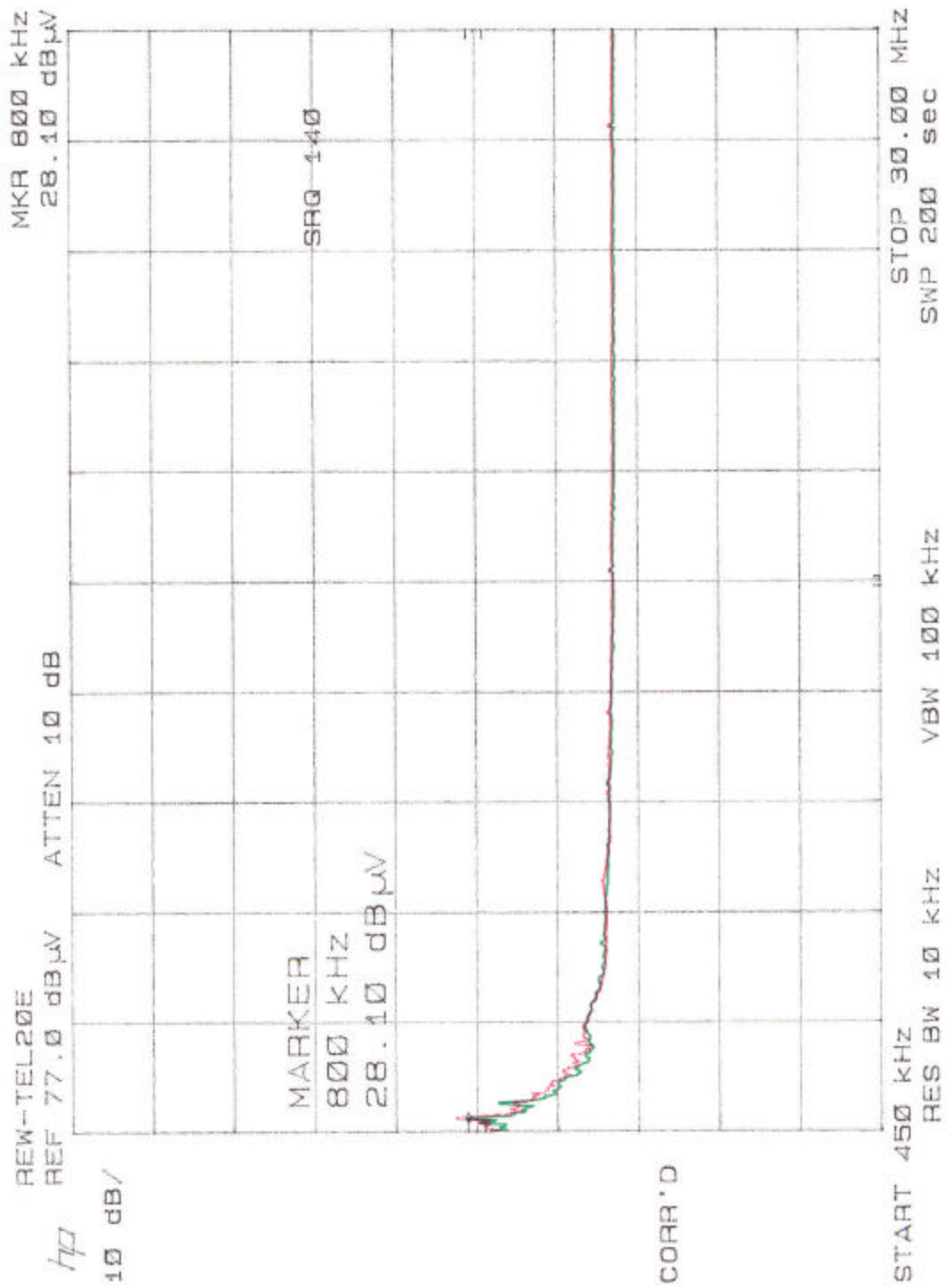

4 - RADIATED EMISSION DATA

4.1 Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in the field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on NIS 81, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at BACL is ± 4.0 dB.

4.2 EUT Setup

The radiated emission tests were performed in the open area 3-meter test site, using the setup accordance with the ANSI C63.4 - 1992. The specification used in this report was the FCC Part 18 limits.

The EUT was placed on the center of the back edge on the test table.

The power cord extension of the EUT was connected with 110 Vac/60 Hz power source.

4.3 Spectrum Analyzer Setup

According to FCC Rules, the system was tested to 1000 MHz.

4.4 Test Procedure

For the radiated emissions test, the power cord of the power cord extension was connected to the AC floor outlet.

Maximizing procedure was performed on the six (6) highest emissions to ensure EUT is compliant with all installation combinations.

All data was recorded in the peak detection mode. Quasi-peak readings was performed only when an emission was found to be marginal (within -4 dB μ V of specification limits), and are distinguished with a "Qp" in the data table.

The EUT was under normal mode during the final qualification test and the configuration was used to represent the worst case results.

4.5 Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain from the Amplitude reading. The basic equation is as follows:

$$\text{Corr. Ampl.} = \text{Indicated Reading} + \text{Antenna Factor} + \text{Cable Factor} - \text{Amplifier Gain}$$

The “**Margin**” column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of -7dBμV means the emission is 7dBμV below the maximum limit for FCC Part 18. The equation for margin calculation is as follows:

$$\text{Margin} = \text{Corr. Ampl.} - \text{FCC Part 18 Limit}$$

4.6 Summary of Test Results

According to the data in section 4.7, the EUT complied with the FCC Part 18 standards for a industry, scientific and medical device, and had the worst margin of:

- 10.2 dBmV at 47.82 MHz in the **Horizontal** polarization, 30 to 1000MHz, 3 meters (model REW-7E)
- 11.9 dBmV at 49.87 MHz in the **Vertical** polarization, 30 to 1000MHz, 3 meters (model REW-11E)
- 6.7 dBmV at 893.4 MHz in the **Horizontal** polarization, 30 to 1000MHz, 3 meters (model REW-15E)
- 14.5 dBmV at 50.53 MHz in the **Vertical** polarization, 30 to 1000MHz, 3 meters (model REW-20E)

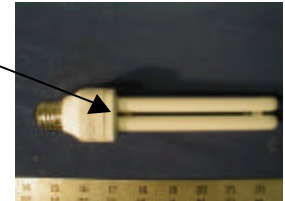

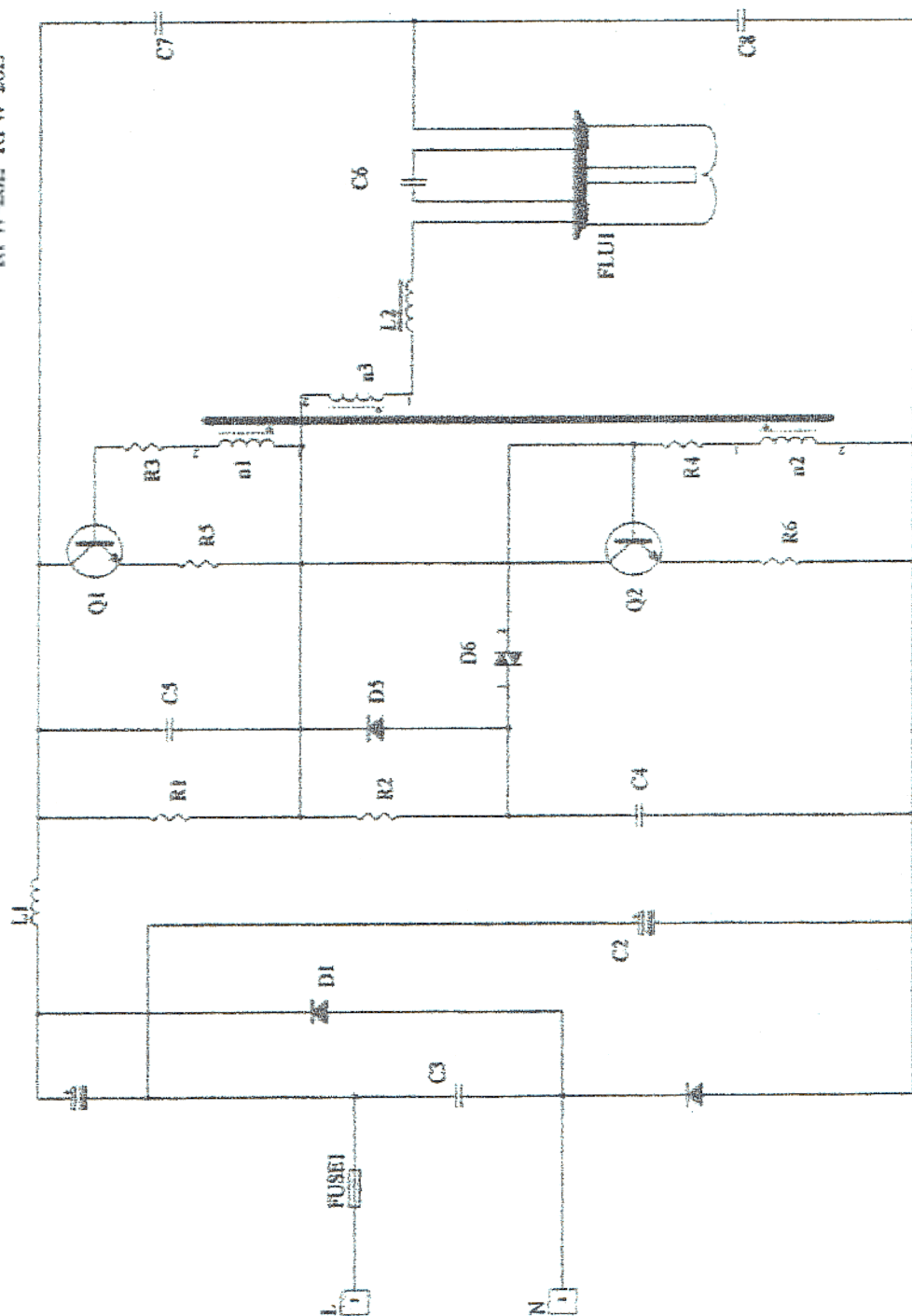
