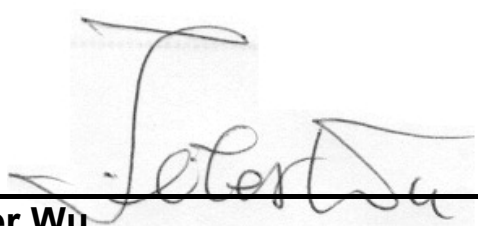

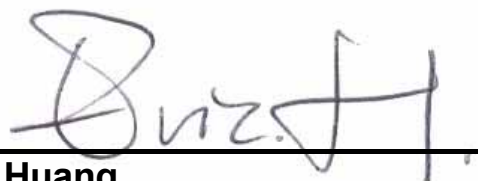

3. DESCRIPTION OF TEST MODES

The EUT is a Smart Handle.

The RF module is manufactured by ISSC Technologies Corp.

The antenna peak gain -5.64Bi (highest gain) were chosen for full testing.

DSSS mode

The EUT had been tested under operating condition.

There are three channels have been tested as following:

Channel	Frequency (MHz)
Low	2402
Middle	2440
High	2480

DSSS mode: 1Mbps long data rates (worst case) were chosen for full testing.

The worst-case data rates are determined according to the description above, based on the investigations by measuring the PSD, peak power and average power across all the data rates, bandwidths, modulations and spatial stream modes.



4. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 15.207, 15.209 and 15.247 and KDB 558074.

5. FACILITIES AND ACCREDITATIONS

5.1 FACILITIES

All measurement facilities used to collect the measurement data are located at No.8, Jiucengling, Xinhua Dist., Tainan City 712, Taiwan (R.O.C.)

The sites are constructed in conformance with the requirements of ANSI C63.7:1992, ANSI C63.4: 2009 and CISPR Publication 22.

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with preselectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

5.3 LABORATORY ACCREDITATIONS LISTINGS

The test facilities used to perform radiated and conducted emissions tests are accredited by Taiwan Accreditation Foundation for the specific scope of accreditation under Lab Code: 1109 to perform Electromagnetic Interference tests according to FCC PART 15 AND CISPR 22 requirements. 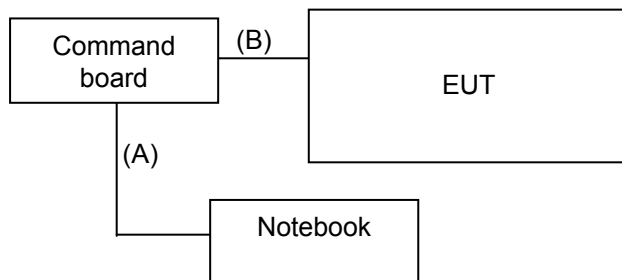

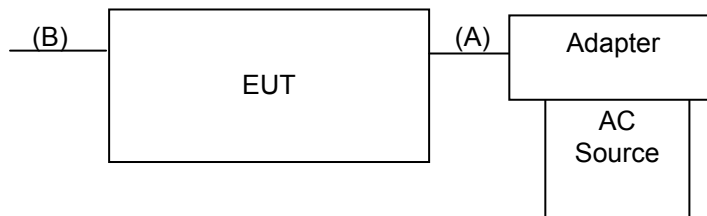

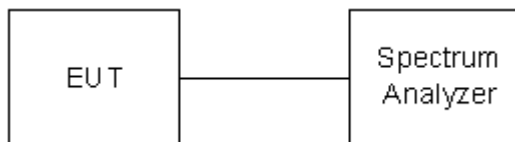

The tests were performed in accordance with KDB 558074 8.1 & 8.2.

Option 1:

- Set RBW = 100 kHz.
- Set the video bandwidth (VBW) ≥ 3 RBW.
- Detector = Peak.
- Trace mode = max hold.
- Sweep = auto couple.
- Allow the trace to stabilize.
- Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

Option 2:

The automatic bandwidth measurement capability of an instrument may be employed using the X dB bandwidth mode with X set to 6 dB, if the functionality described above (i.e., RBW = 100 kHz, VBW ≥ 3 RBW, peak detector with maximum hold) is implemented by the instrumentation function. When using this capability, care shall be taken so that the bandwidth measurement is not influenced by any intermediate power nulls in the fundamental emission that might be ≥ 6 dB.

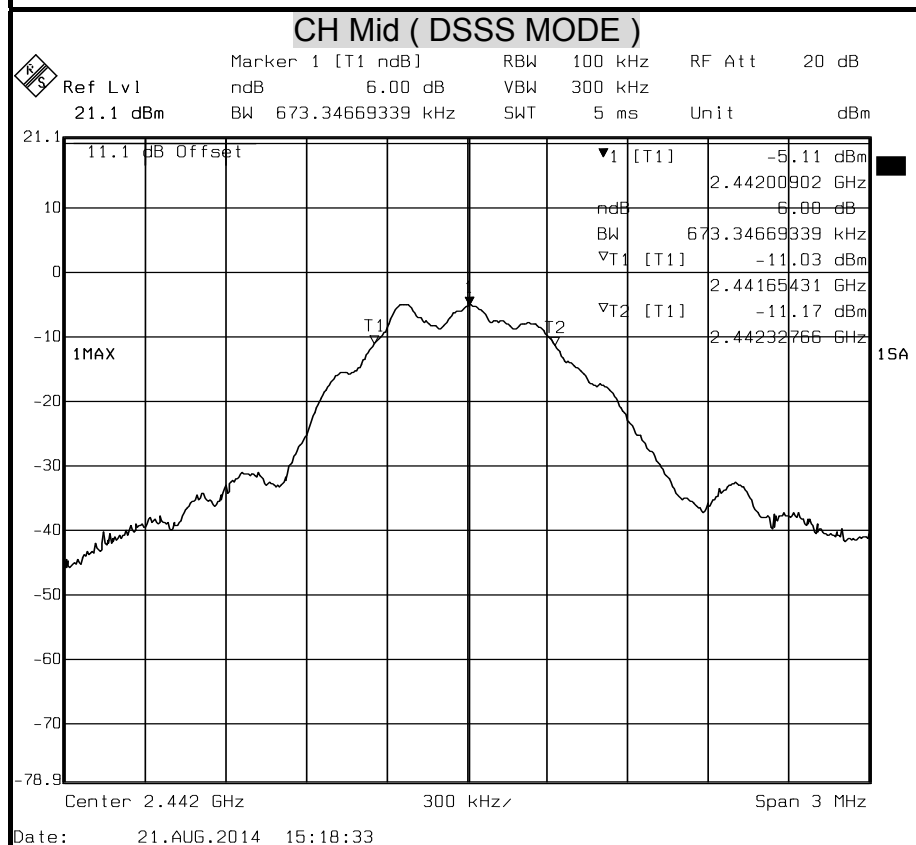
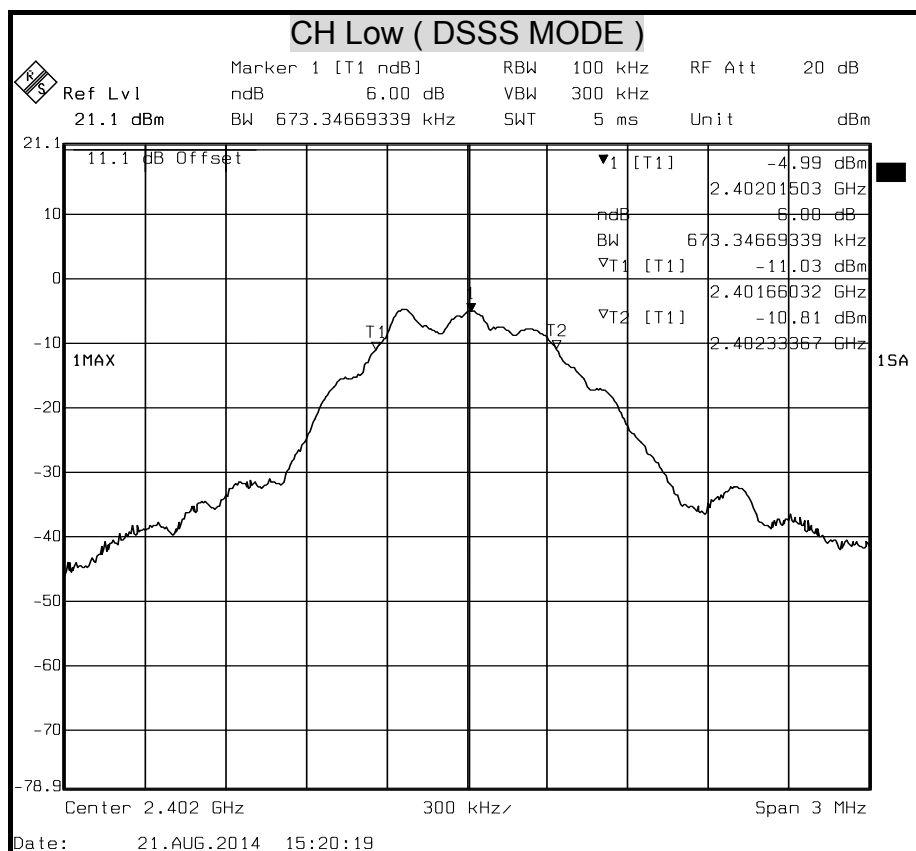

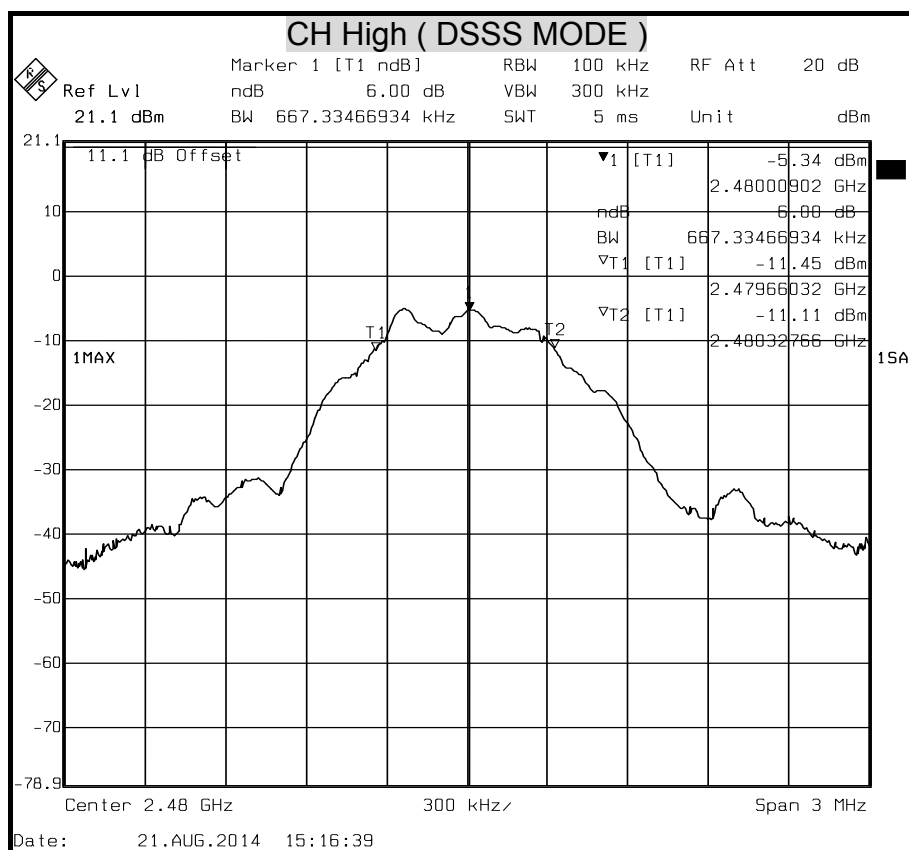

§ 15.247(b) (3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands : 1 watt.

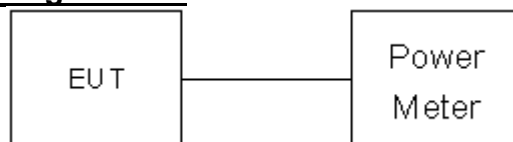

TEST PROCEDURE

The tests were performed in accordance with KDB 558074 9.1.2 & 9.2.2.3 .

Integrated band power method

This procedure may be used when the maximum available RBW of the measurement instrument is less than the DTS bandwidth.

- a) Set the RBW = 1 MHz.
- b) Set the VBW ≥ 3 RBW
- c) Set the span $\geq 1.5 \times$ DTS bandwidth.
- d) Detector = peak.
- e) Sweep time = auto couple.
- f) Trace mode = max hold.
- g) Allow trace to fully stabilize.
- h) Use the instrument's band/channel power measurement function with the band limits set equal to the DTS bandwidth edges (for some instruments, this may require a manual override to select peak detector). If the instrument does not have a band power function, sum the spectrum levels (in linear power units) at intervals equal to the RBW extending across the DTS bandwidth.

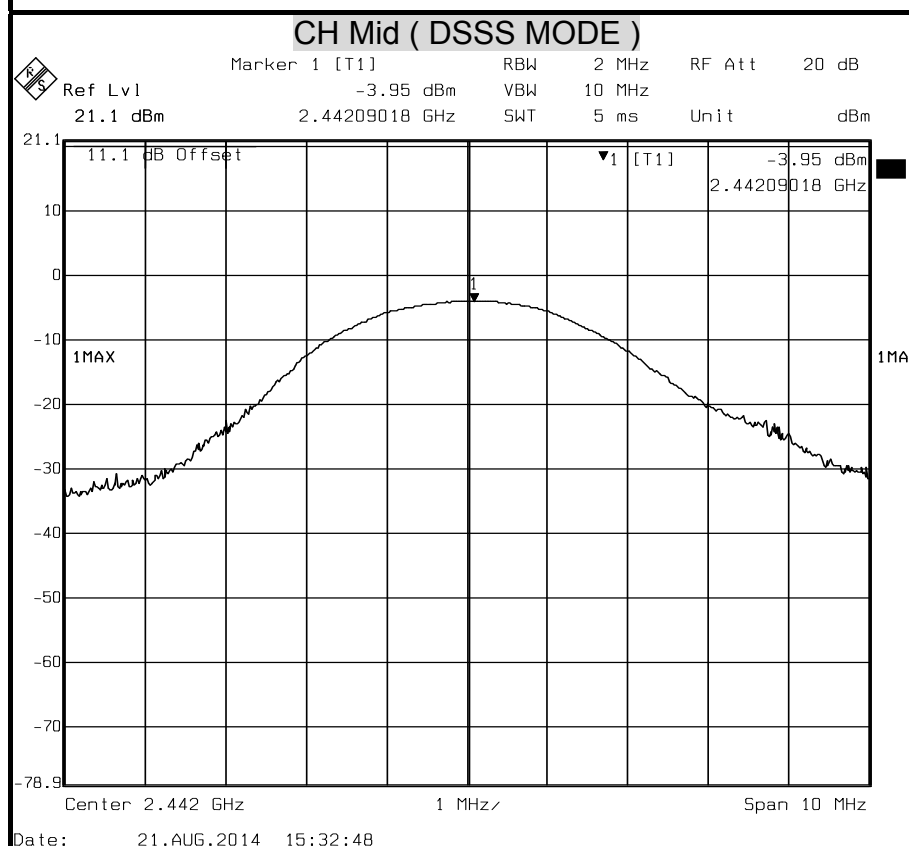
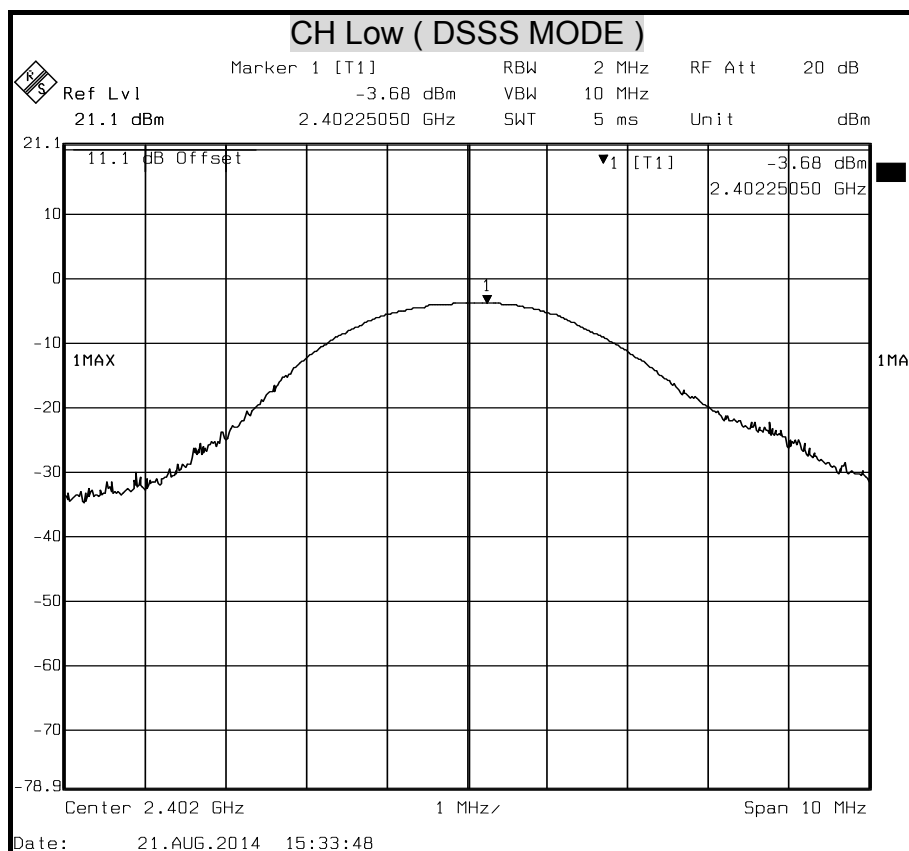

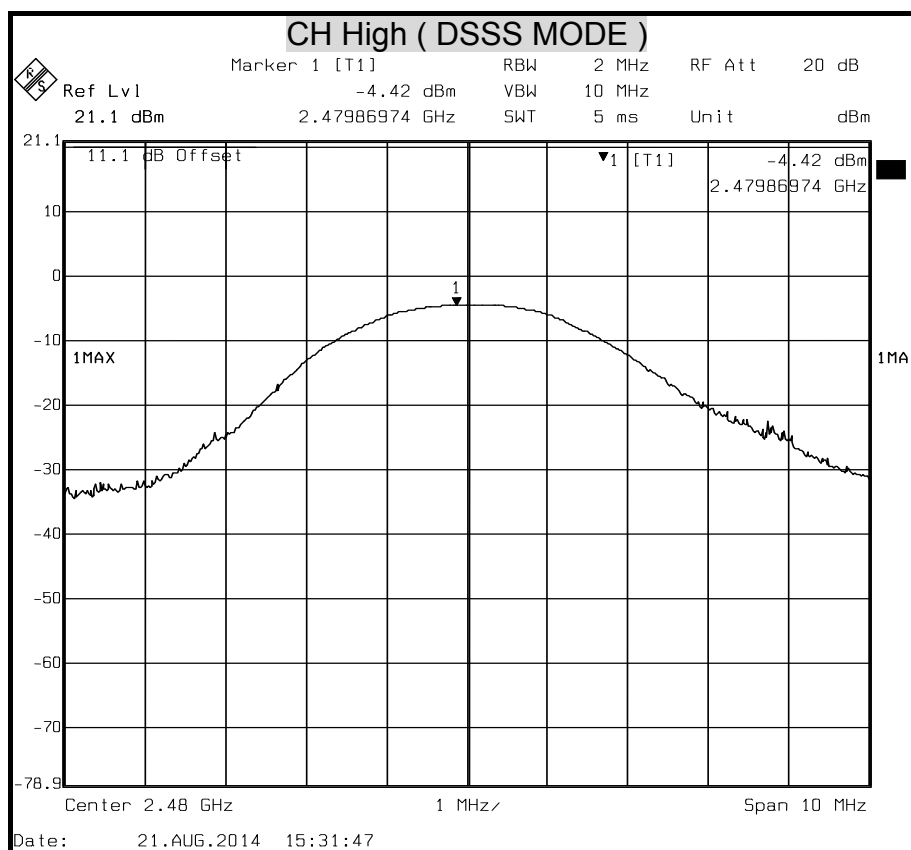

Combining equations and re-arranging the terms to express the distance as a function of the remaining variables yields:

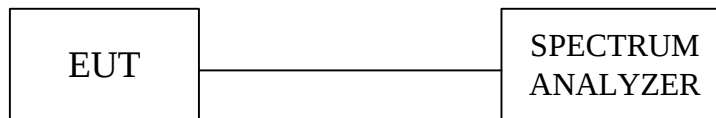

Method PKPSD (peak PSD)

This procedure shall be used if maximum peak conducted output power was used to demonstrate compliance, and is optional if the maximum conducted (average) output power was used to demonstrate compliance.

- Set analyzer center frequency to DTS channel center frequency.
- Set the span to 1.5 times the DTS bandwidth.
- Set the RBW to: $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$.
- Set the VBW $\geq 3 \times \text{RBW}$.
- Detector = peak.
- Sweep time = auto couple.
- Trace mode = max hold.
- Allow trace to fully stabilize.
- Use the peak marker function to determine the maximum amplitude level within the RBW.
- If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

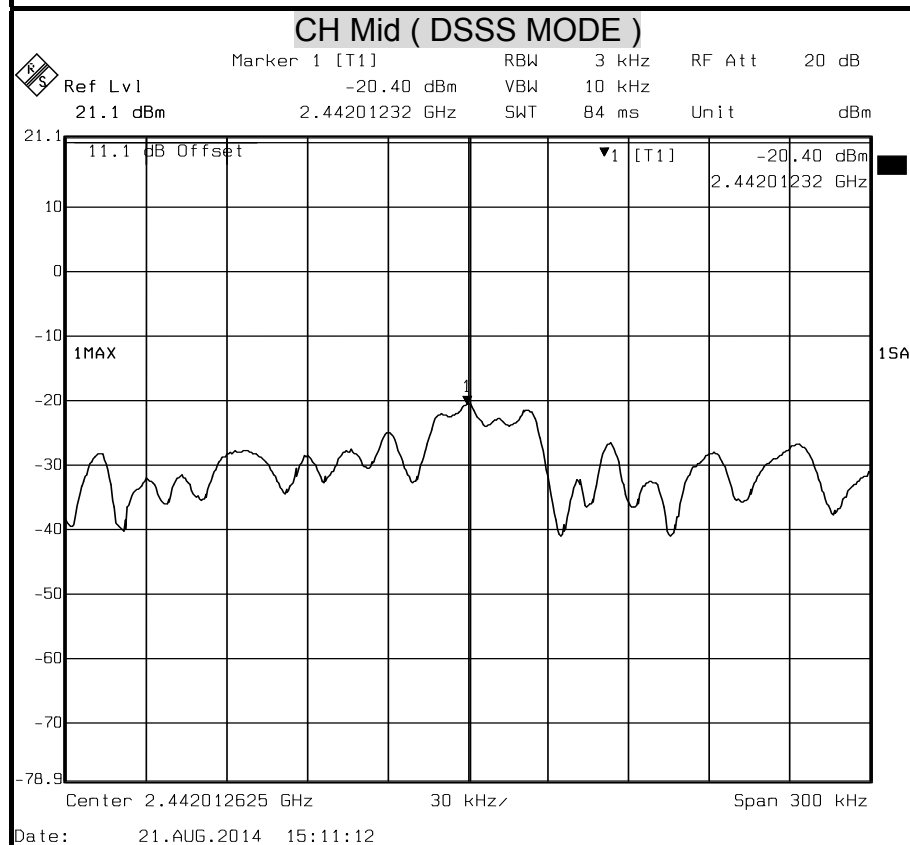
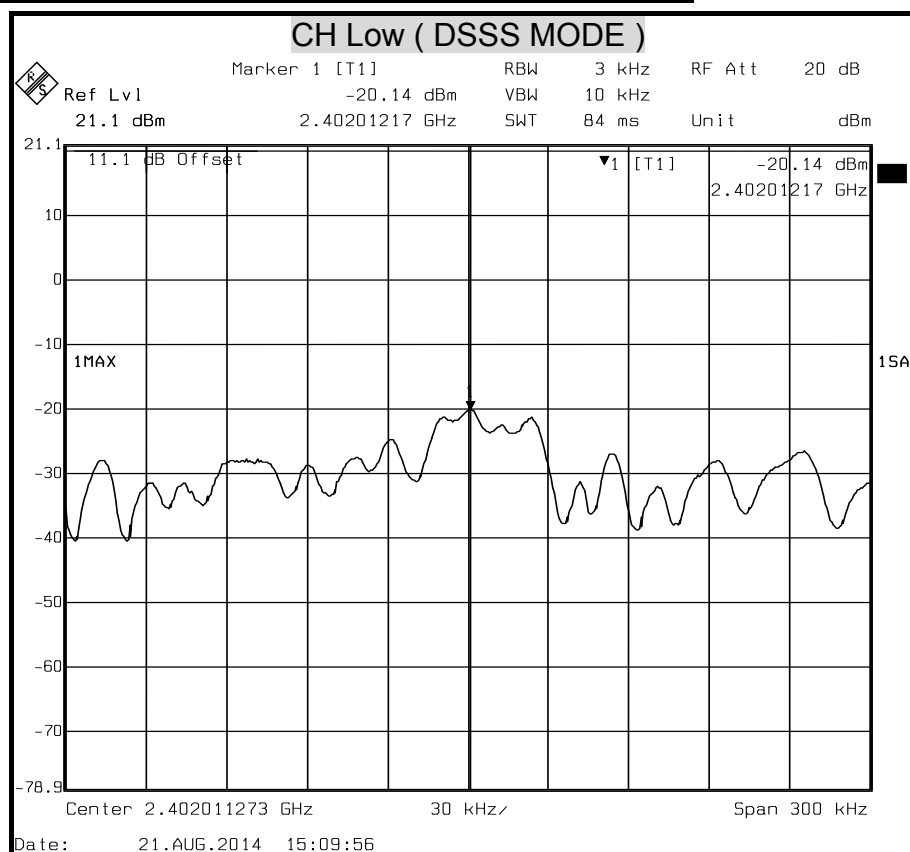

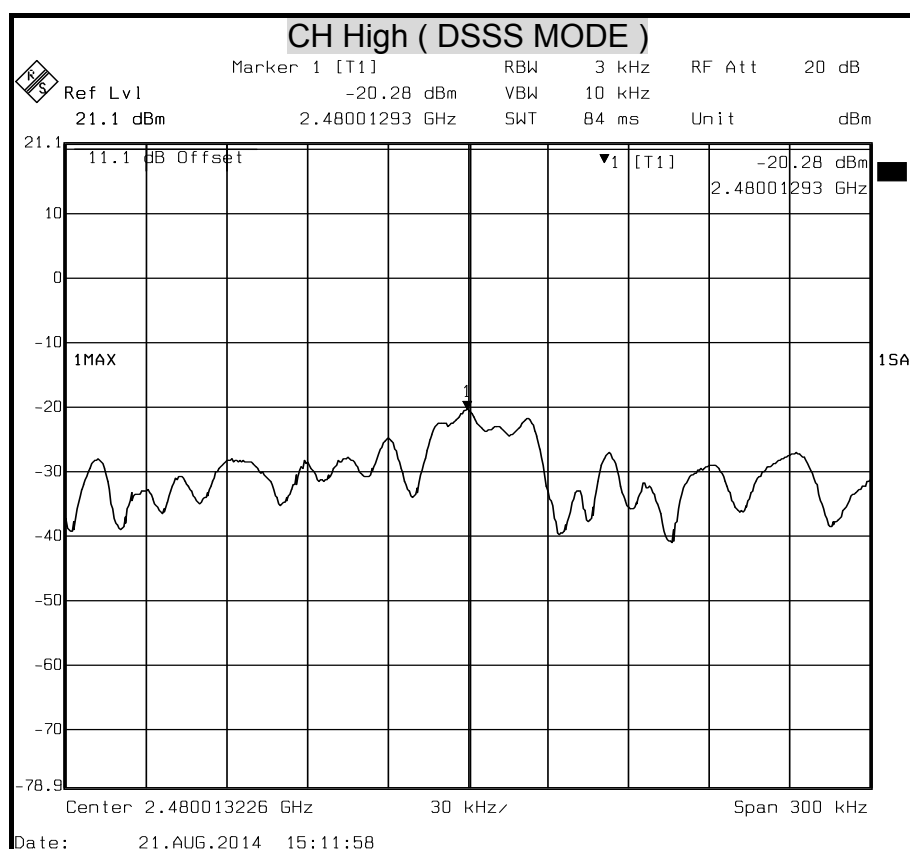

8.5 CONDUCTED SPURIOUS EMISSION

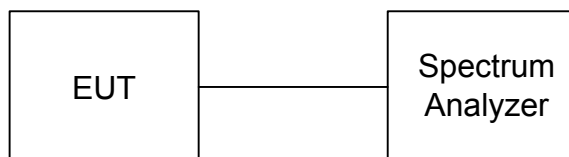
§ 15.247(d) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in § 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in § 15.205(a), must also comply with the radiated emission limits specified in § 15.209(a) (see § 15.205(c)).

- Set the span to ≥ 1.5 times the *DTS bandwidth*.
- Set the RBW = 100 kHz.
- Set the VBW $\geq 3 \times$ RBW.
- Detector = peak.
- Sweep time = auto couple.
- Trace mode = max hold.
- Allow trace to fully stabilize.
- Use the peak marker function to determine the maximum PSD level.

Note that the channel found to contain the maximum PSD level can be used to establish the



reference level.

11.3 Emission level measurement

- a) Set the center frequency and span to encompass frequency range to be measured.
- b) Set the RBW = 100 kHz.
- c) Set the VBW $\geq 3 \times$ RBW.
- d) Detector = peak.
- e) Ensure that the number of measurement points $\geq$ span/RBW
- f) Sweep time = auto couple.
- g) Trace mode = max hold.
- h) Allow trace to fully stabilize.
- i) Use the peak marker function to determine the maximum amplitude level.

Ensure that the amplitude of all unwanted emissions outside of the authorized frequency band (excluding restricted frequency bands) are attenuated by at least the minimum requirements specified in 11.1 a) or 11.1 b). Report the three highest emissions relative to the limit.

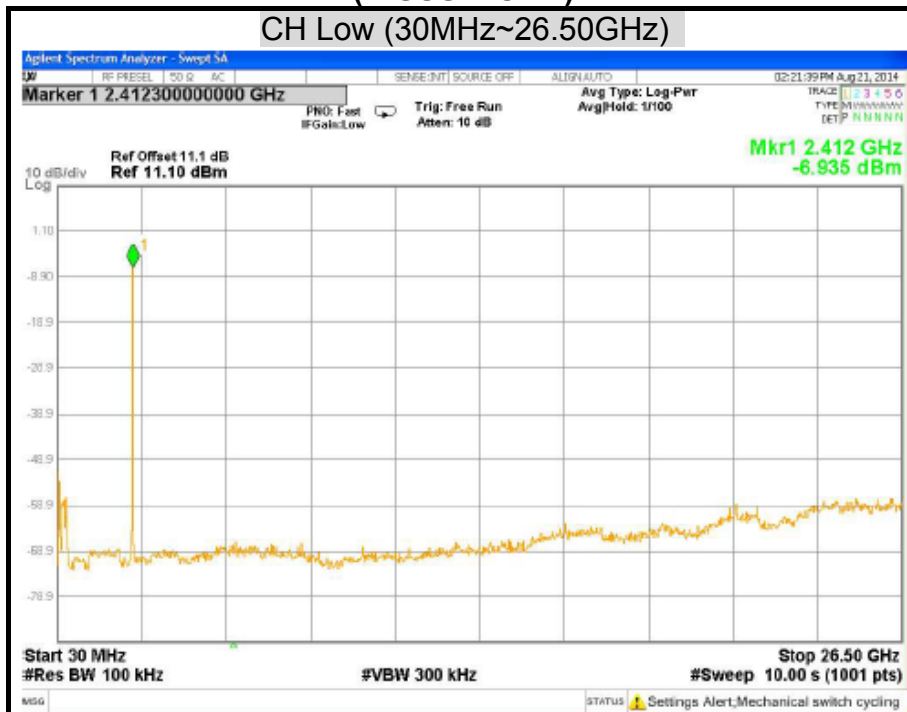

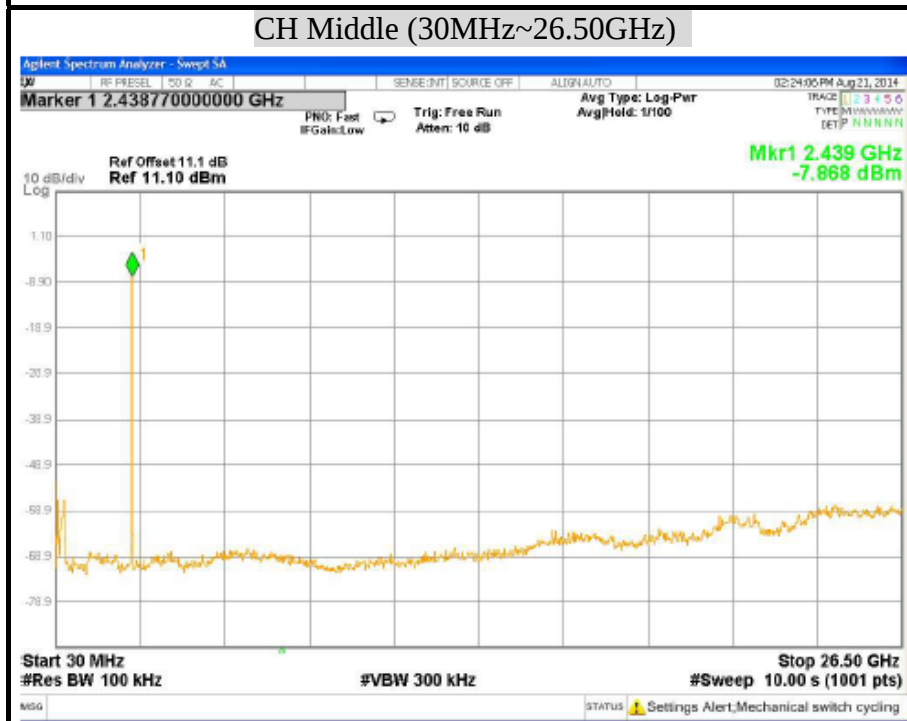
OUT-OF-BAND SPURIOUS EMISSIONS-CONDUCTED MEASUREMENT

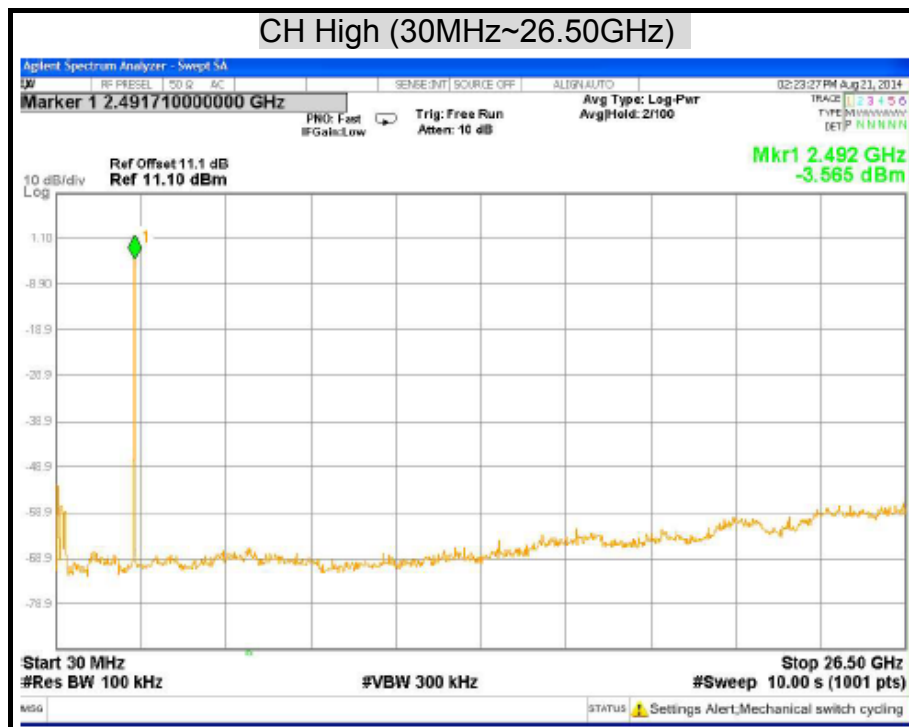

§ 15.205 (b) Except as provided in paragraphs (d) and (e), the field strength of emissions appearing within these frequency bands shall not exceed the limits shown in Section 15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in Section 15.35 apply to these measurements.



§ 15.209 (a) Except as provided elsewhere in this Subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table :

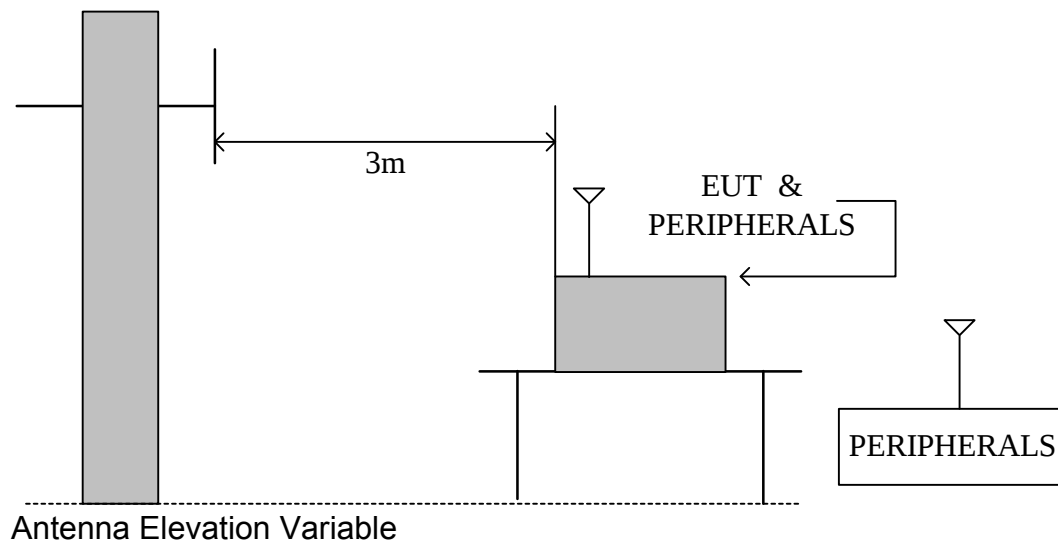

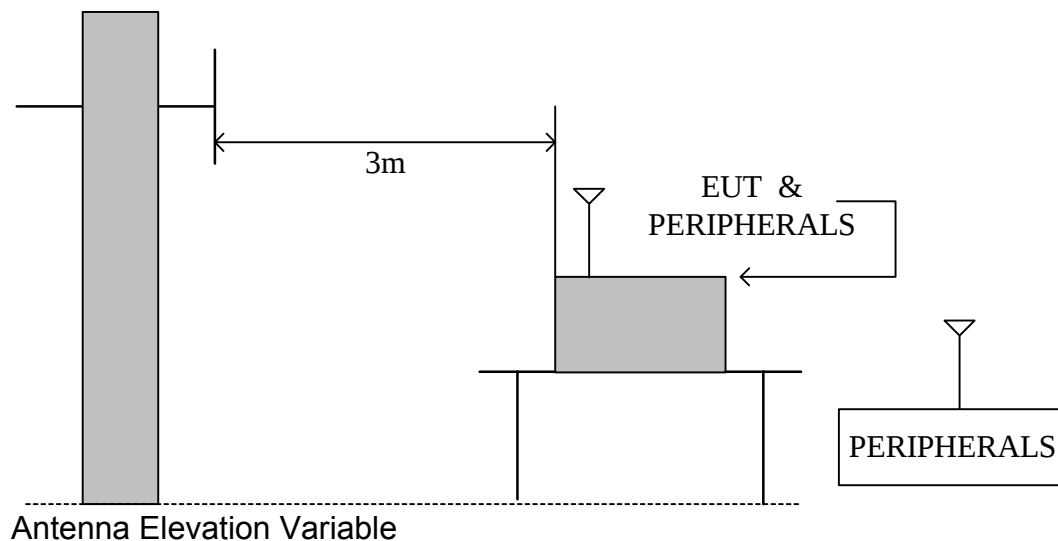


TEST SETUP

TEST PROCEDURE

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. While measuring the radiated emission below 1GHz, the EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower. While measuring the radiated emission above 1GHz, the EUT was set 3 meters away from the interference-receiving antenna
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarization of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
- g. The tests were performed in accordance with KDB 558074 5.4.

NOTE :

1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 KHz for Peak detection (PK) and Quasi-peak detection (QP) at frequency below 1GHz.
2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection and frequency above 1GHz.
3. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 10 Hz for Average detection (AV) at frequency above 1GHz.
4. **No emission is found between lowest internal used/generated frequency to 30MHz (9kHz~30MHz)**

8.8 POWERLINE CONDUCTED EMISSIONS

§ 15.207 (a) Except as shown in paragraph (b) and (c) this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 μ H/50 ohms line impedance stabilization network (LISN). 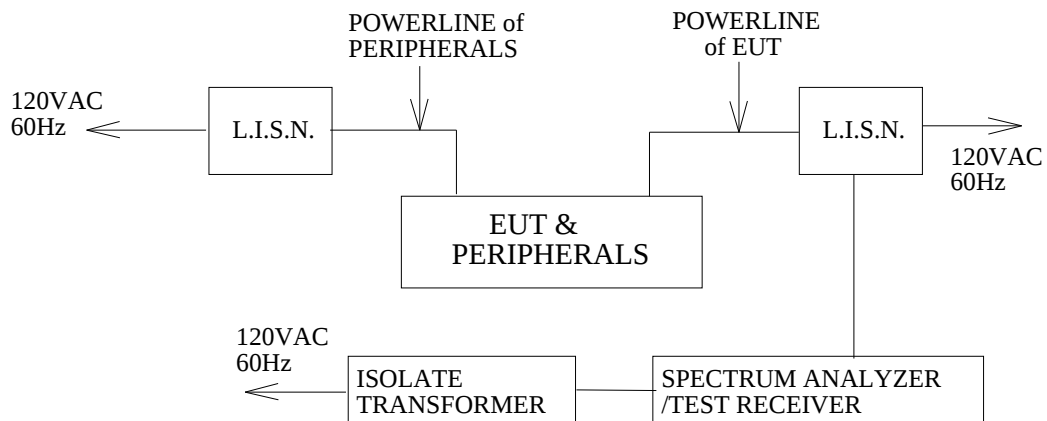

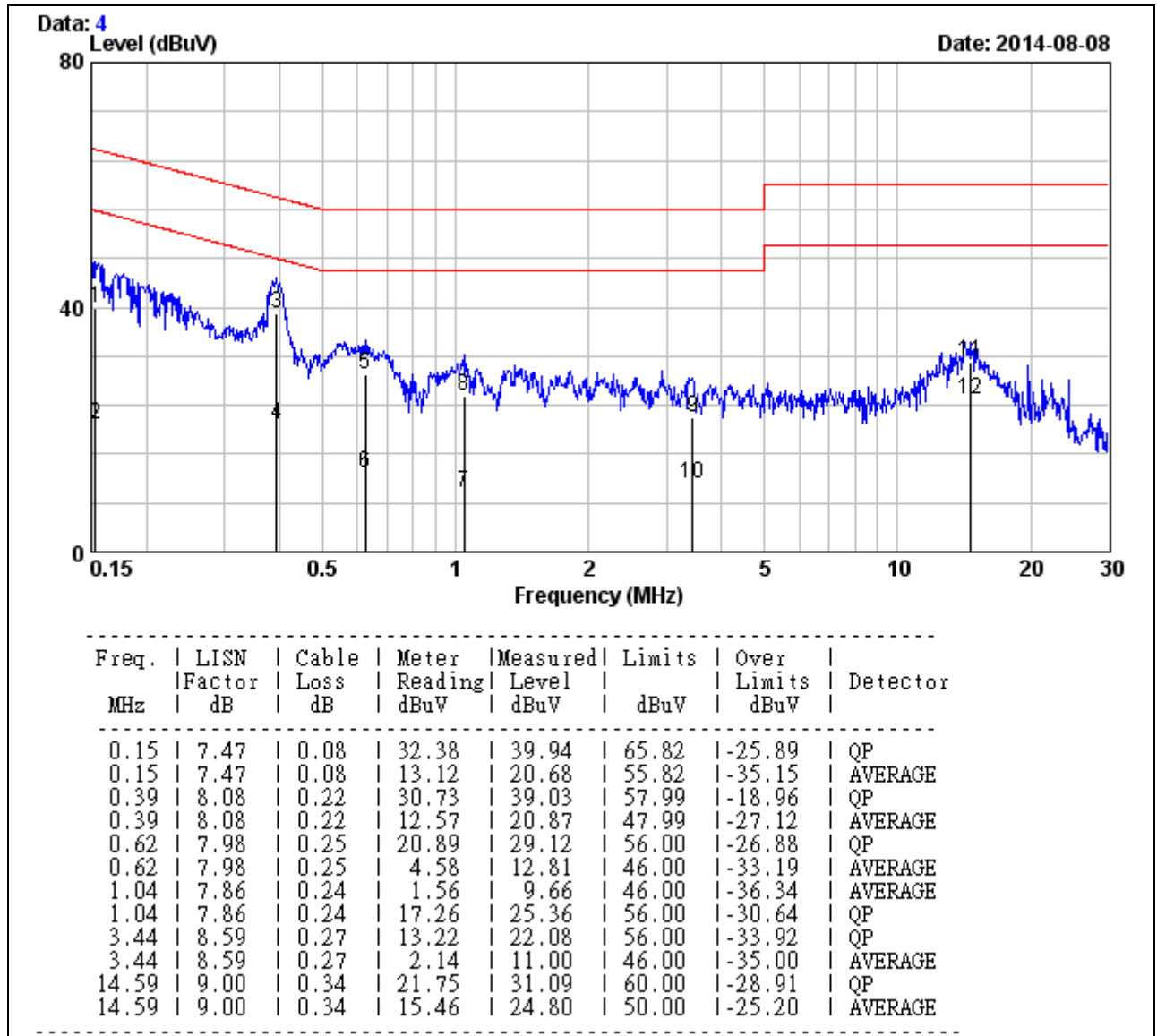

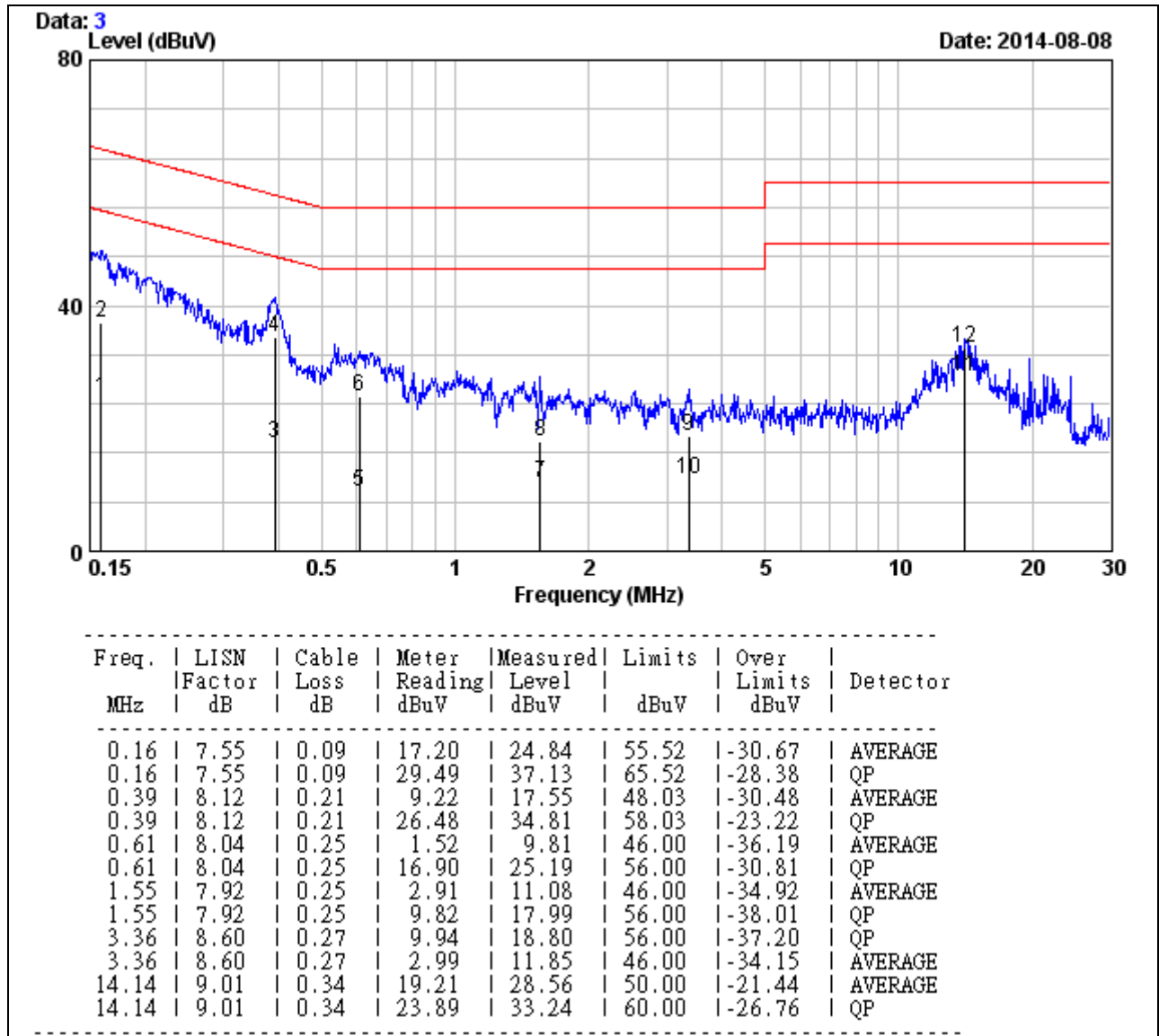
