Chris,

I just finished preparing your check and Service Agreement. It will be overnighted and you will receive it Monday morning.

As for the 2-part label for the M6000 -- what are the size requirements? Because of the belt clip, there isn't much room for a large sticker. The serial number is going to be placed on a paper label inside the battery compartment. The FCC sticker of course will be a permanent, printed label. Is there a minimum point-size for the font, as I was assuming the minimum size was 8 point? So, I guess what I'm asking is, if we need the 2-part label, what is the smallest size font that can be used, in order to make the label small? Can the sticker be placed on a removable item, such as the 9V battery door? I'd hate to put the FCC label on the front, just because there wasn't room on the back. The M6000 user's manual does have the 2-Part label information, along with the Class B notice. Any ideas?
