8. RADIATED OUTPUT POWER

8.1 PROVISIONS APPLICABLE

The radiation test is carried out in a semi-anechoic chamber.

According to the test, put the device under test on a non-conductive platform 3 meters away from the receiving antenna (ANSI/TIA-603-E-2016 Article 2.2.17).

The following rules are for the maximum radiated power limit requirements of the product:

LTE Band 2	< 2 Watts max. EIRP (33dBm)
LTE Band 4	< 1 Watts max. EIRP (30dBm)
LTE Band 5	< 7 Watts max. ERP (38.45dBm)
LTE Band 12	< 3 Watts max. ERP (34.77dBm)

RADIATION CONSTRUCTION METHOD:

1. The turntable is rotated through 360 degrees, and the receiving antenna scans in order to determine the level of the maximized emission.
2. A half wave dipole is then substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator and the previously recorded signal was duplicated.

The power is calculated by the following formula:

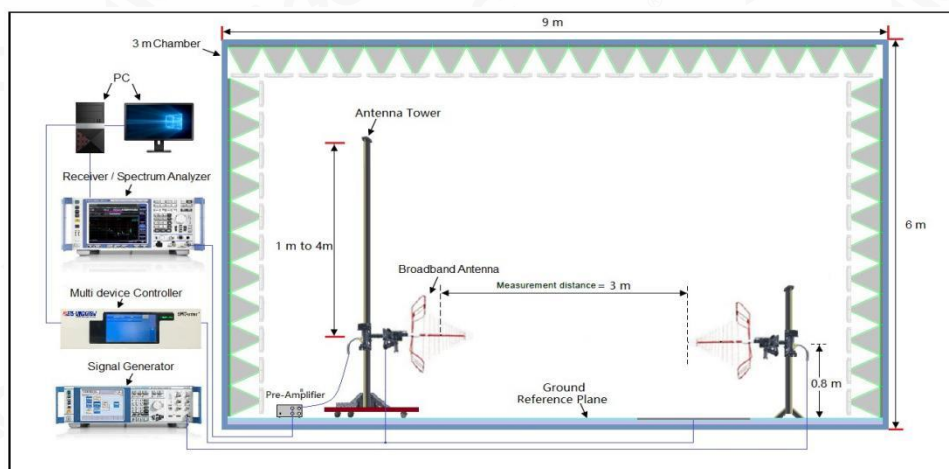

Where: P_d is the dipole equivalent power and P_g is the generator output power into the substitution antenna.

3. The maximum value is calculated by adding the forward power to the calibrated source plus its appropriate gain value. These steps are repeated with the receiving antenna in both vertical and horizontal polarization. the difference between the gain of the horn and an isotropic antenna are taken into consideration
4. The EUT was tested in three orthogonal planes (X, Y, Z) and in all possible test configurations and positioning.
5. All measurements are performed as RMS average measurements while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies.

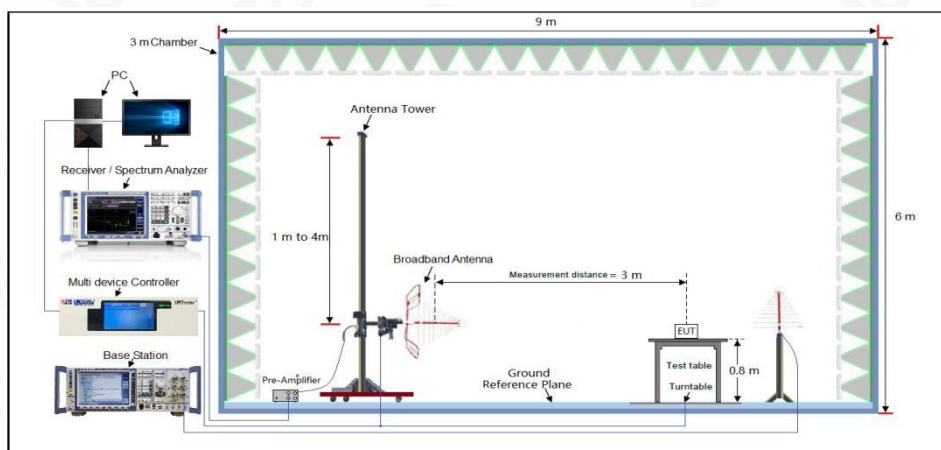
Radiated Power 30MHz to 1GHz Test setup



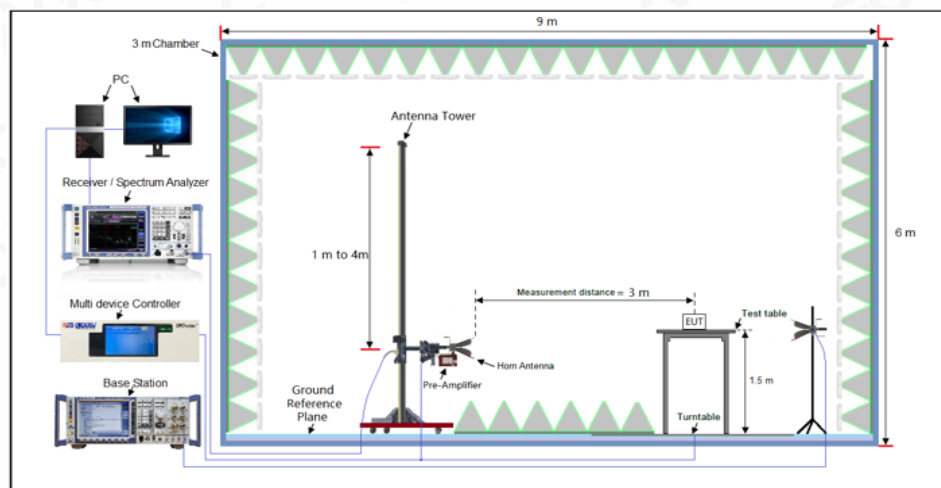
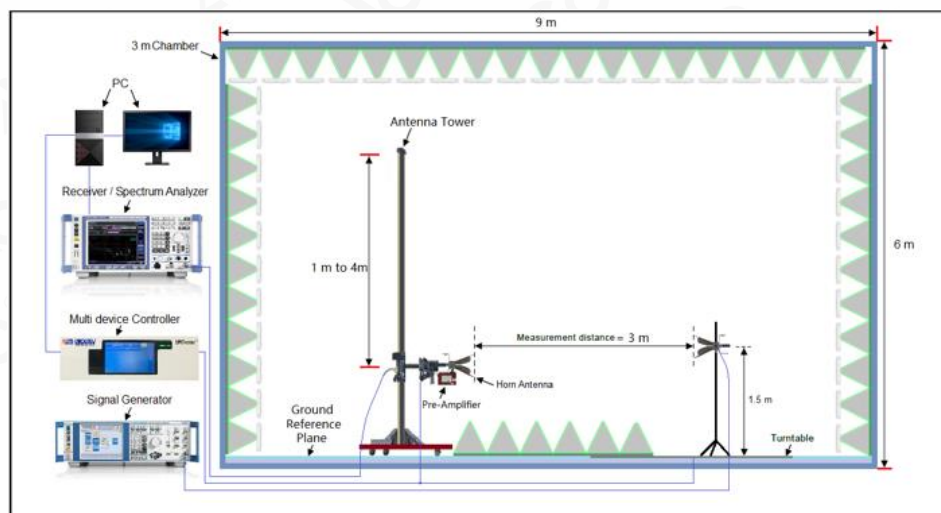
