1 General information

The format of the label is based on a label SVF 930 1392 (33,2 x 46,2 mm).

If applicable, or nothing else specified, Zebra printer Scaleable Smooth Font CG Triumvirate Bold Condensed is imposed. When needed, the text is adjusted to fit the label.

All bar codes, when applicable, are according to Ericsson corporate standard 102 01–109 Uen. All bar codes shall fulfil minimum print quality C according to ANSI X3.182-1990 as stated in Ericsson corporate standard 102 01–1003 Uen. No bar codes are allowed to be closer to a label edge than 2 mm! (quiet zone).

“(x/y)” under each line number specifies the bottom / left alignment for text, graphics and bar codes, x is measured vertically, and y horizontally from the upper left corner of the label (landscape format), both in mm. When needed, the alignment is adjusted to fit the label.

The label shall be placed on the back of the telephone according to the Assembly Drawing (151 88-) for the KRH.
