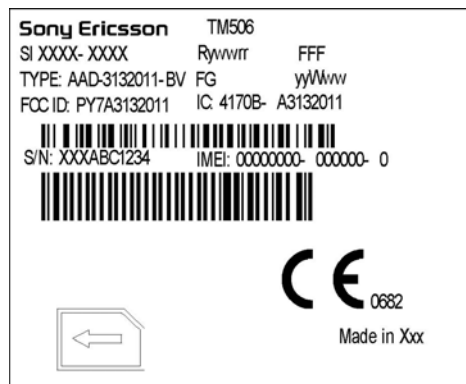

3.2 Label placement
