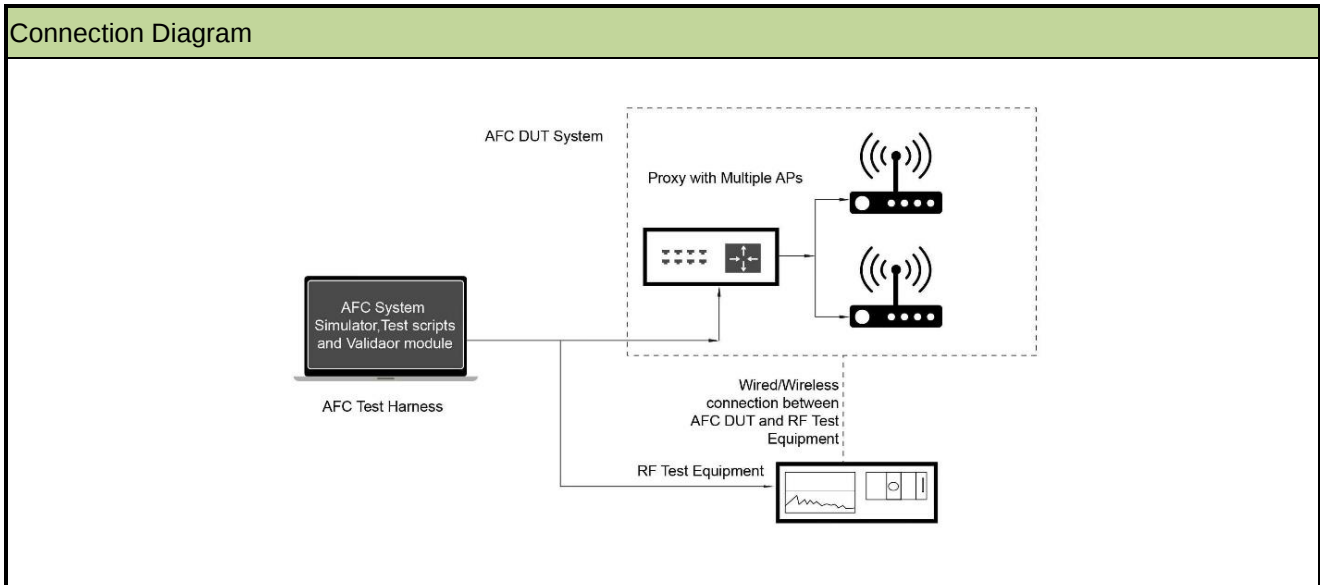

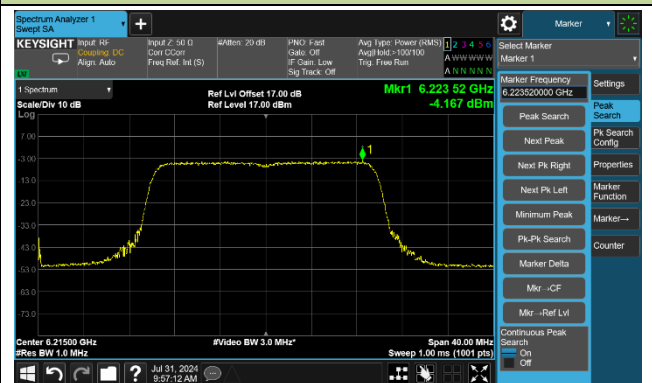


802.11ax-HE20 – Channel 53 (6215MHz) Power Spectral Density

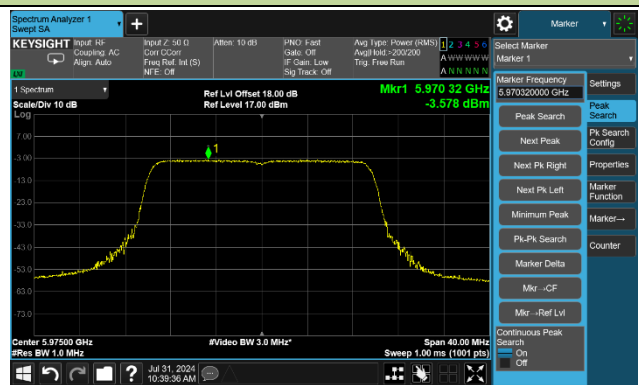

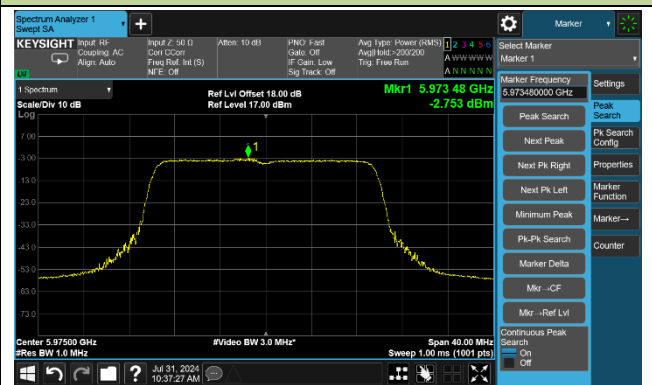


802.11ax-HE20 – Channel 5 (5975MHz) Power Spectral Density

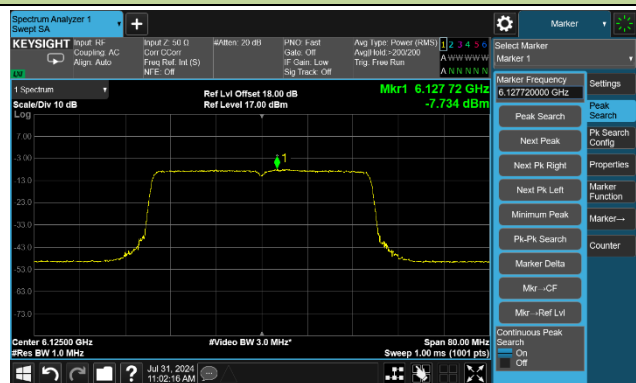

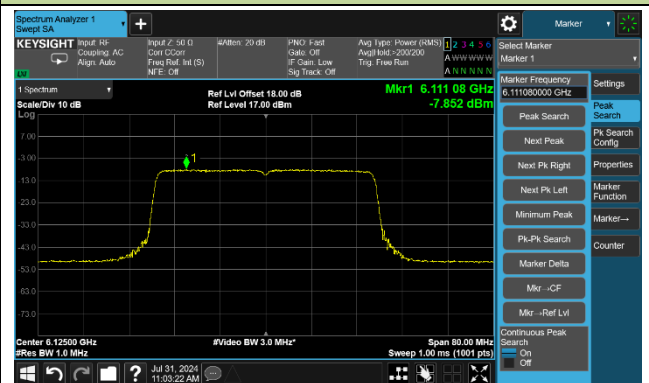


802.11ax-HE40 – Channel 35 (6125MHz) Power Spectral Density

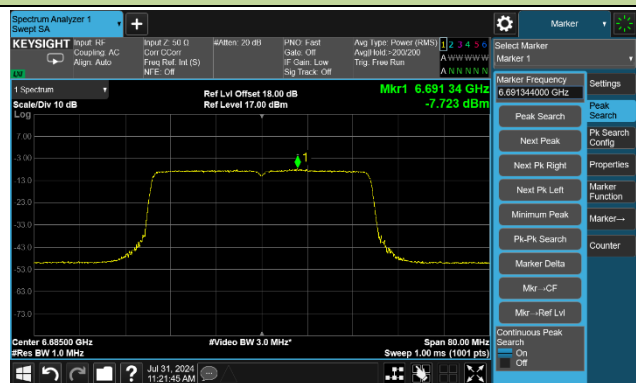

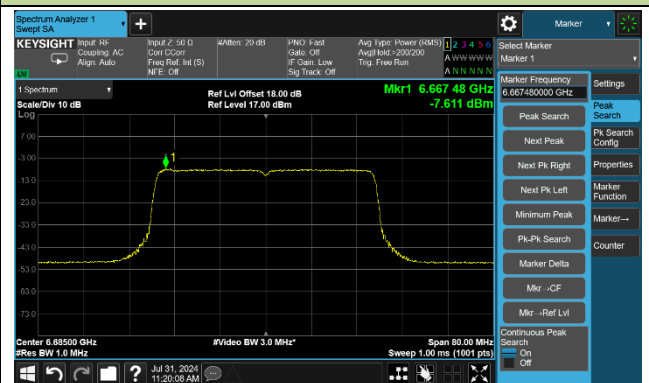


802.11ax-HE40 – Channel 147 (6685MHz) Power Spectral Density

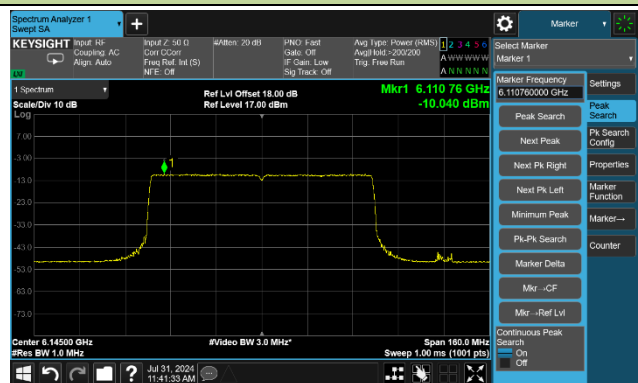

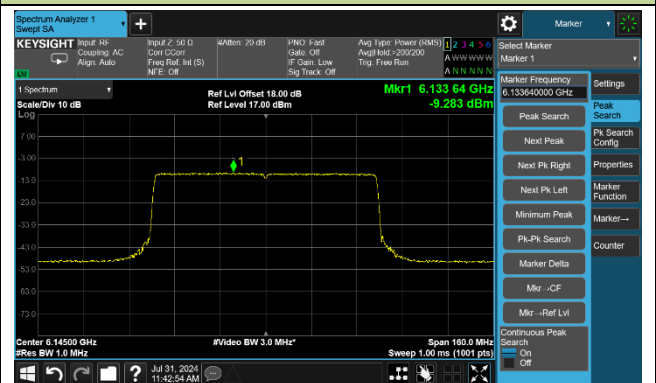


802.11ax-HE80 – Channel 39 (6145MHz) Power Spectral Density

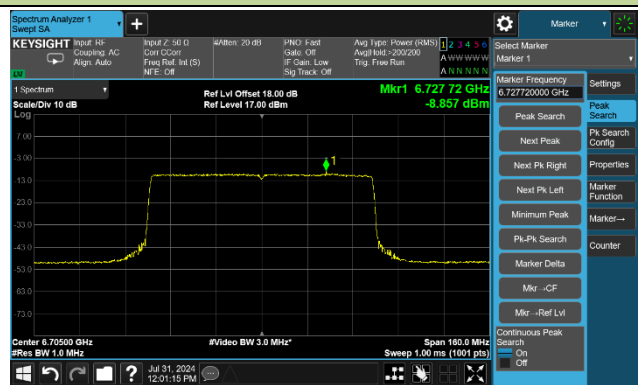

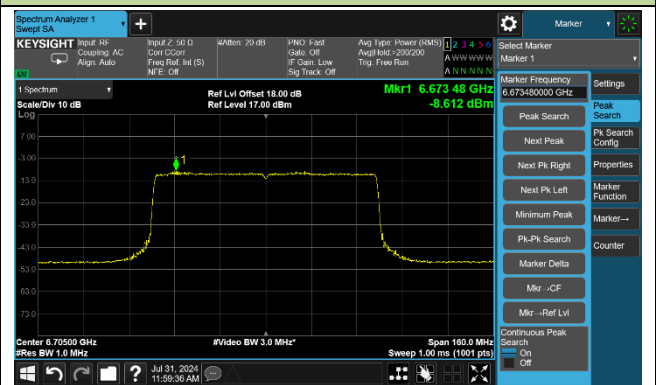


802.11ax-HE80 – Channel 151 (6705MHz) Power Spectral Density

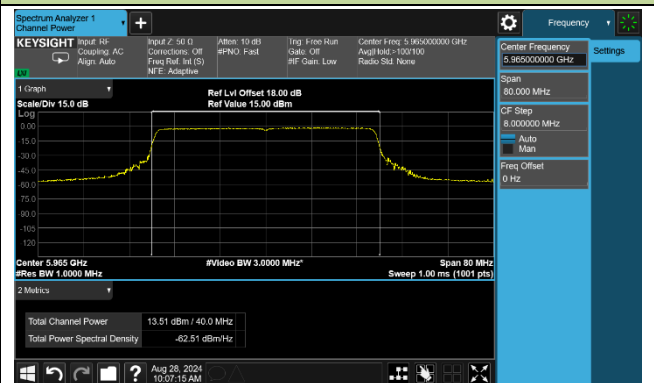


802.11ax-HE40 – Channel 3 (5965MHz) Average Power

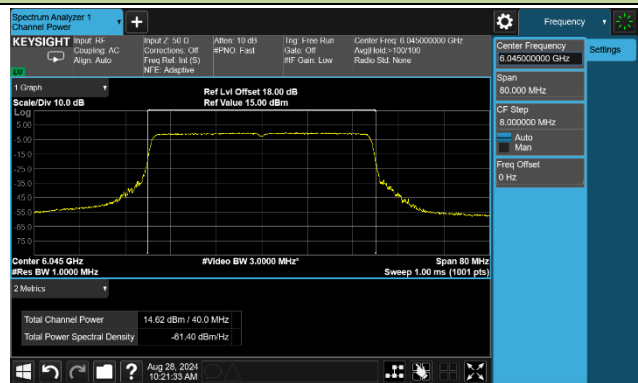

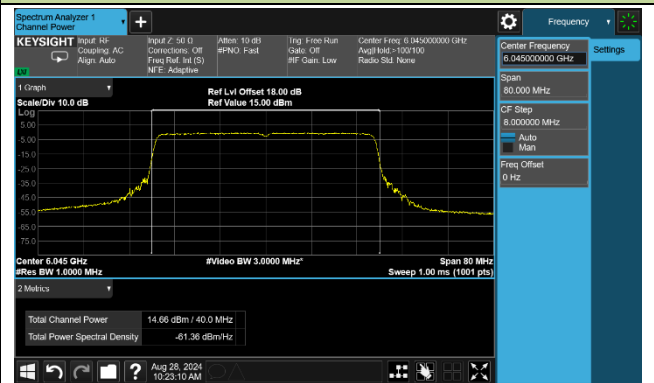


802.11ax-HE40 – Channel 19 (6045MHz) Average Power

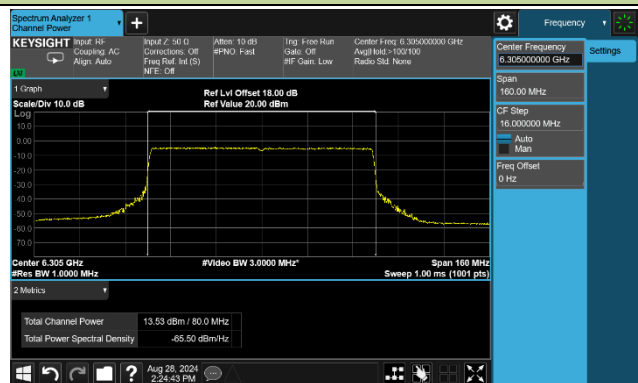

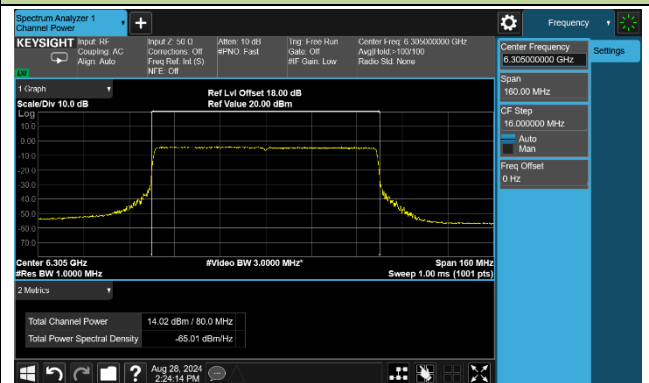


802.11ax-HE80 – Channel 71 (6305MHz) Average Power

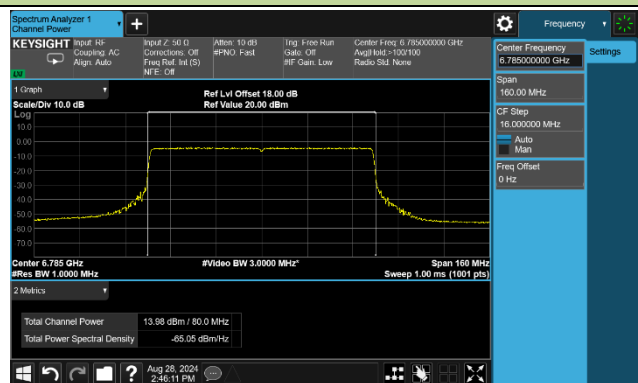

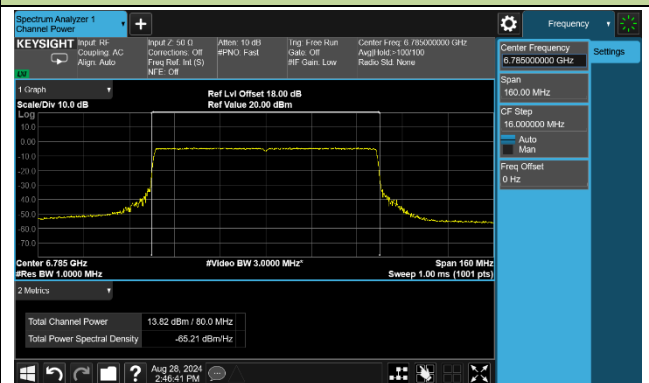


802.11ax-HE80 – Channel 167 (6785MHz) Average Power

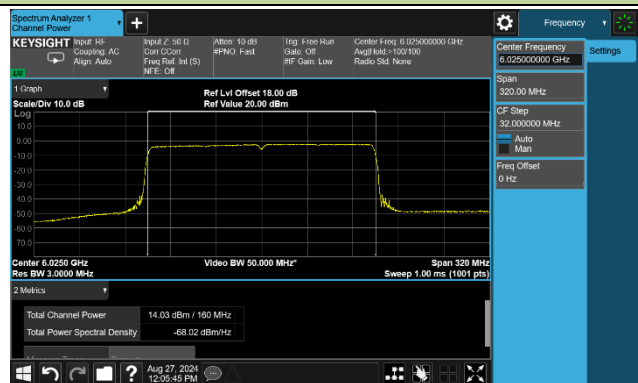

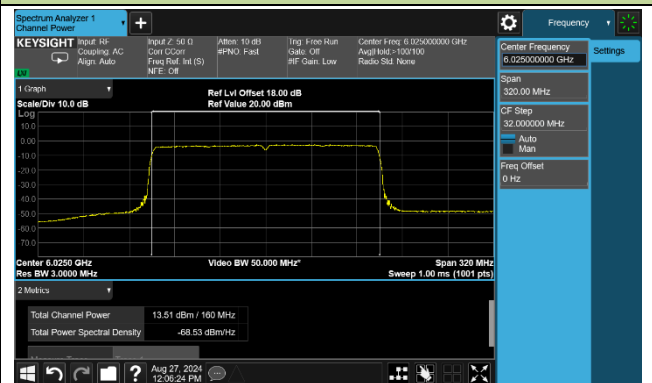


802.11ax-HE160 – Channel 15 (6025MHz) Average Power

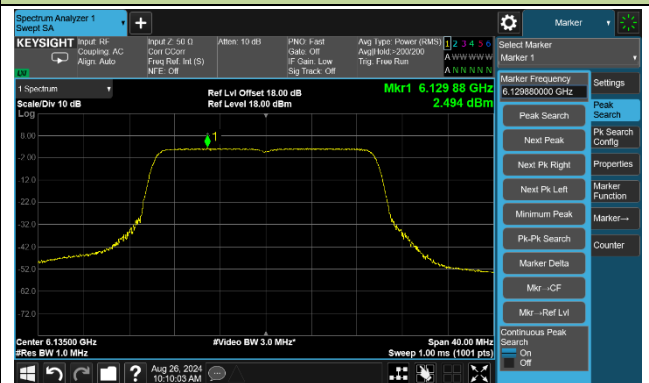


802.11ax-HE20 – Channel 37 (6135MHz) Power Spectral Density

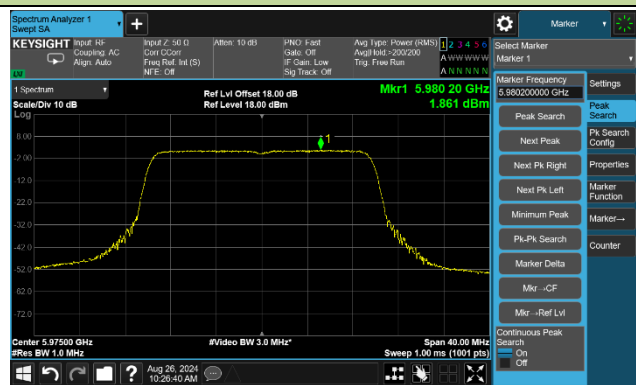

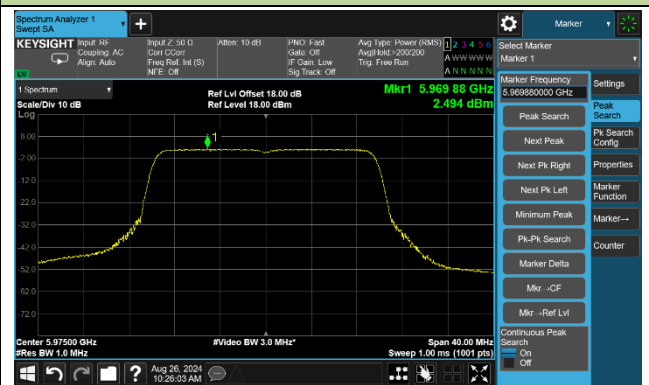


802.11ax-HE20 – Channel 5 (5975MHz) Power Spectral Density

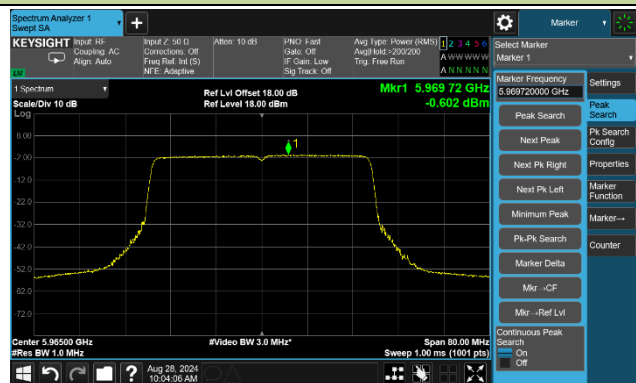

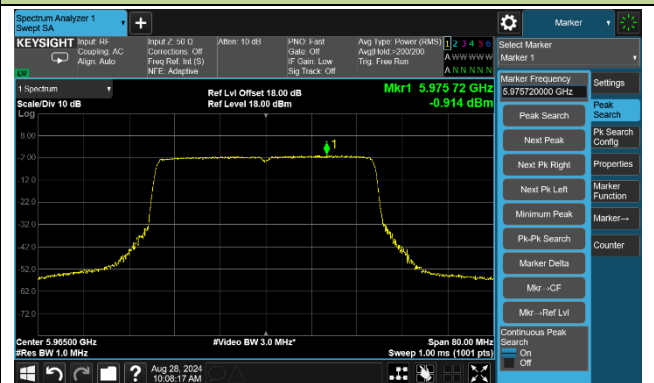


802.11ax-HE40 – Channel 3 (5965MHz) Power Spectral Density

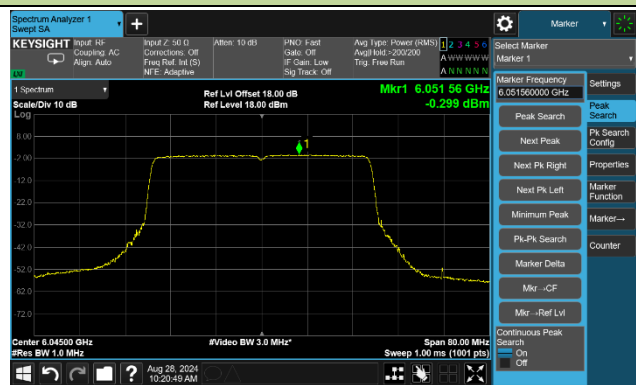

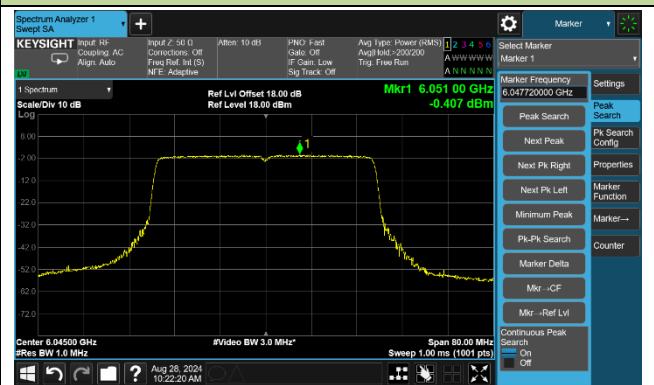


802.11ax-HE40 – Channel 19 (6045MHz) Power Spectral Density

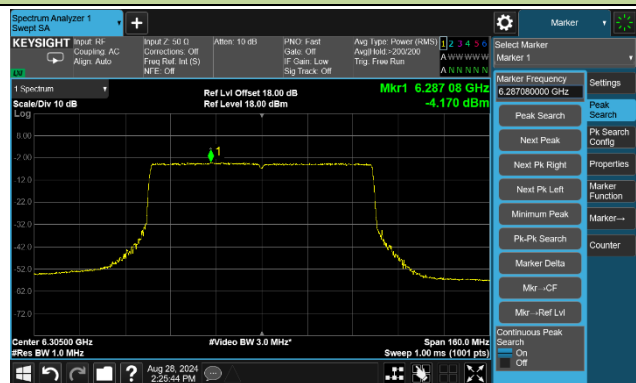

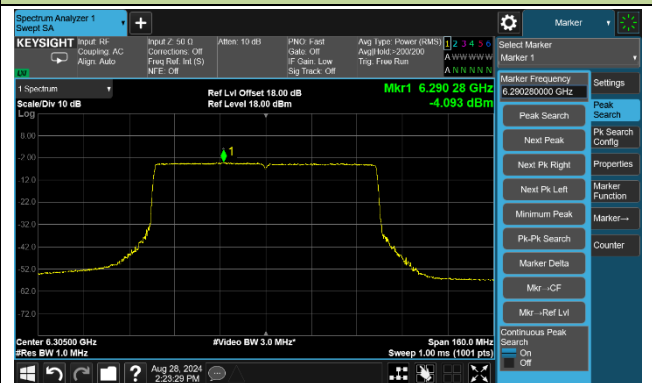


802.11ax-HE80 – Channel 71 (6305MHz) Power Spectral Density

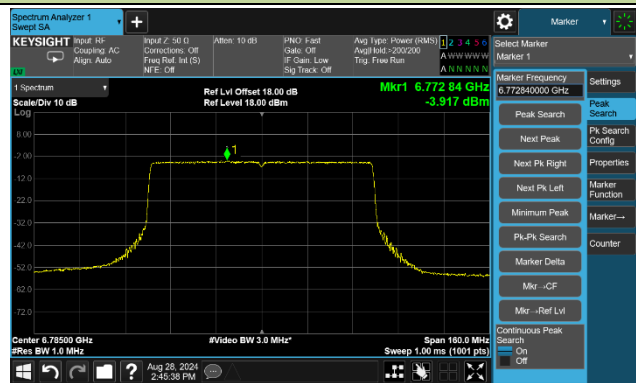
