4. 20 DB BANDWIDTH

4.1. Limit

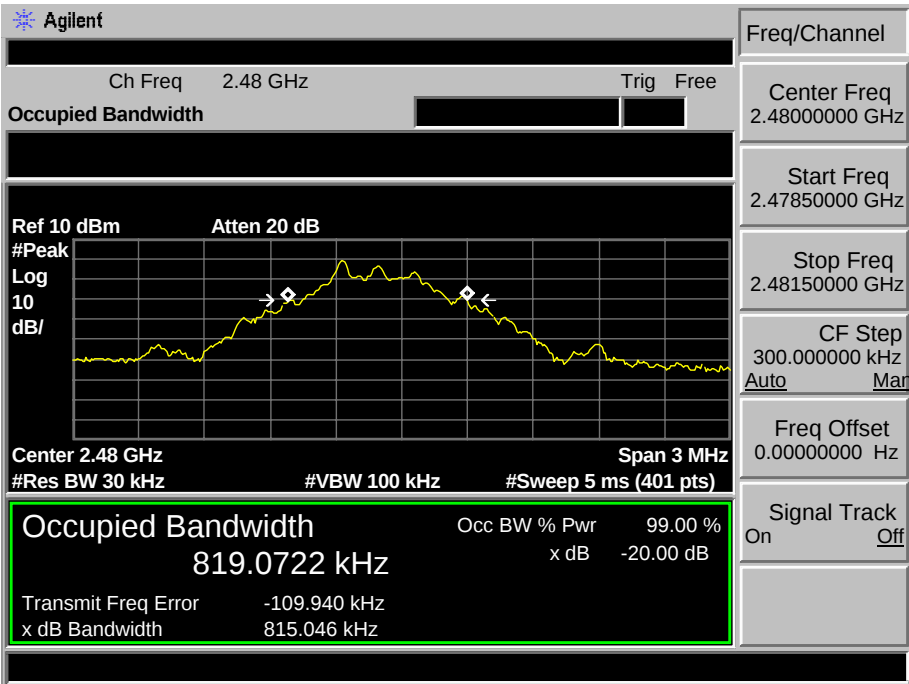
The transmitter output was coupled to a spectrum analyzer via a antenna. The bandwidth of the fundamental frequency was measured by spectrum analyzer with 30kHz RBW and 100kHz VBW. The 20dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 20dB.

5. CARRIER FREQUENCY SEPARATION

5.1. Limit

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW

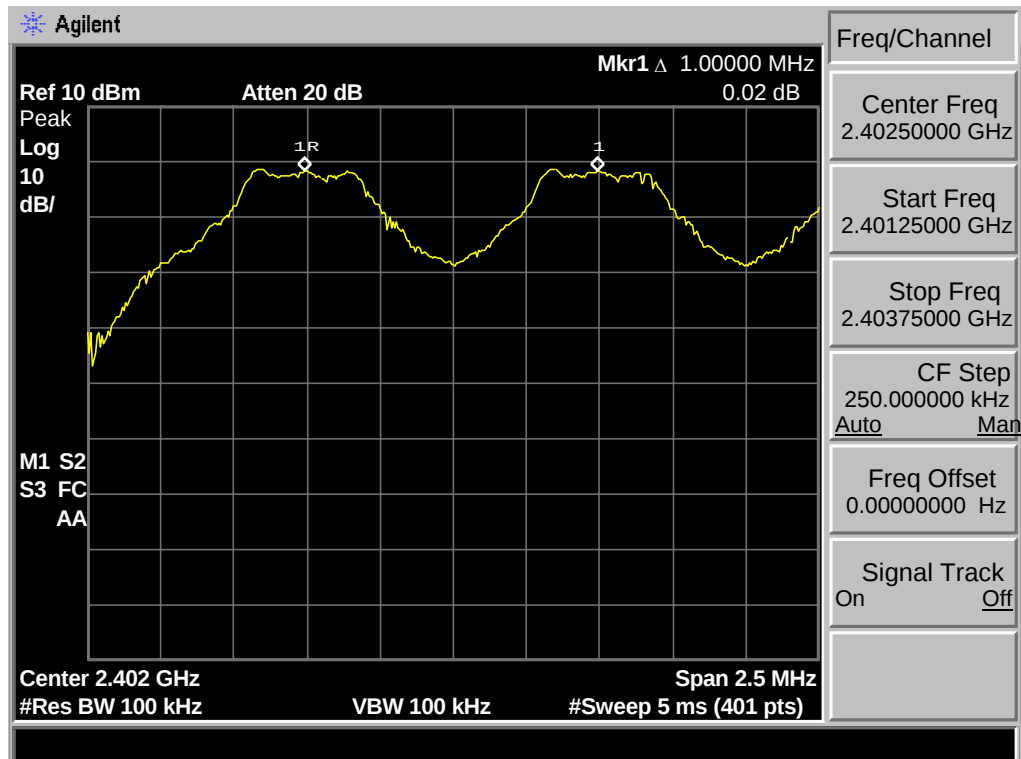

The transmitter output was coupled to a spectrum analyzer via a antenna. The carrier frequency was measured by spectrum analyzer with 100kHz RBW and 100kHz VBW.

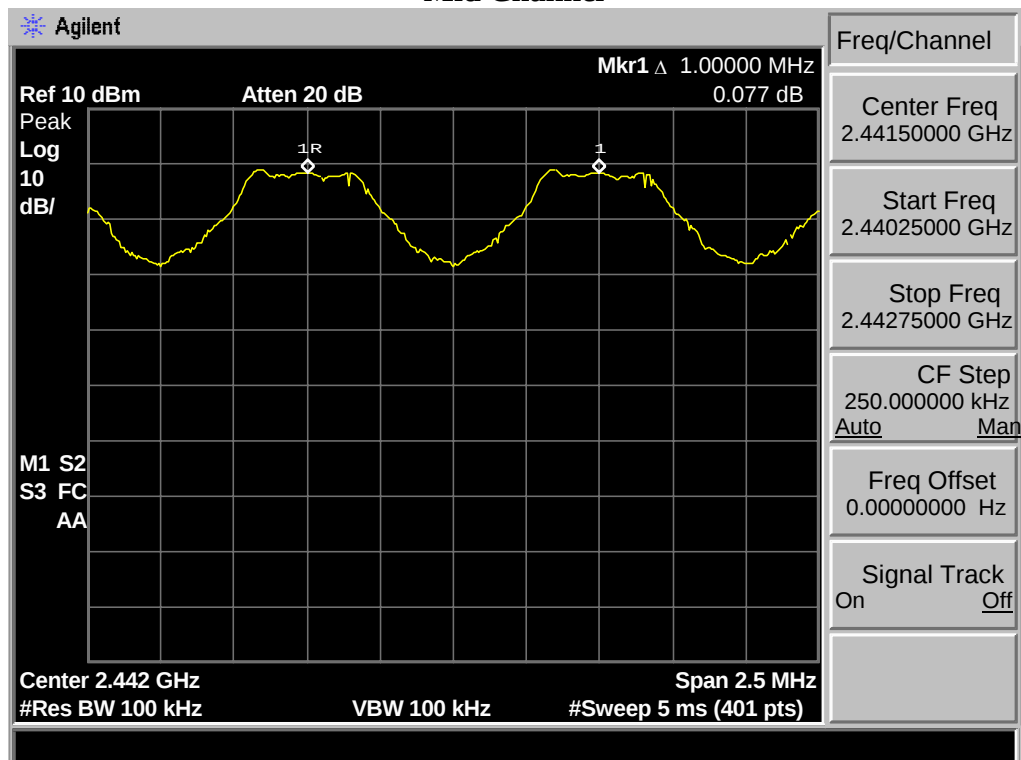

7. DWELL TIME

7.1. Limit

The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed.

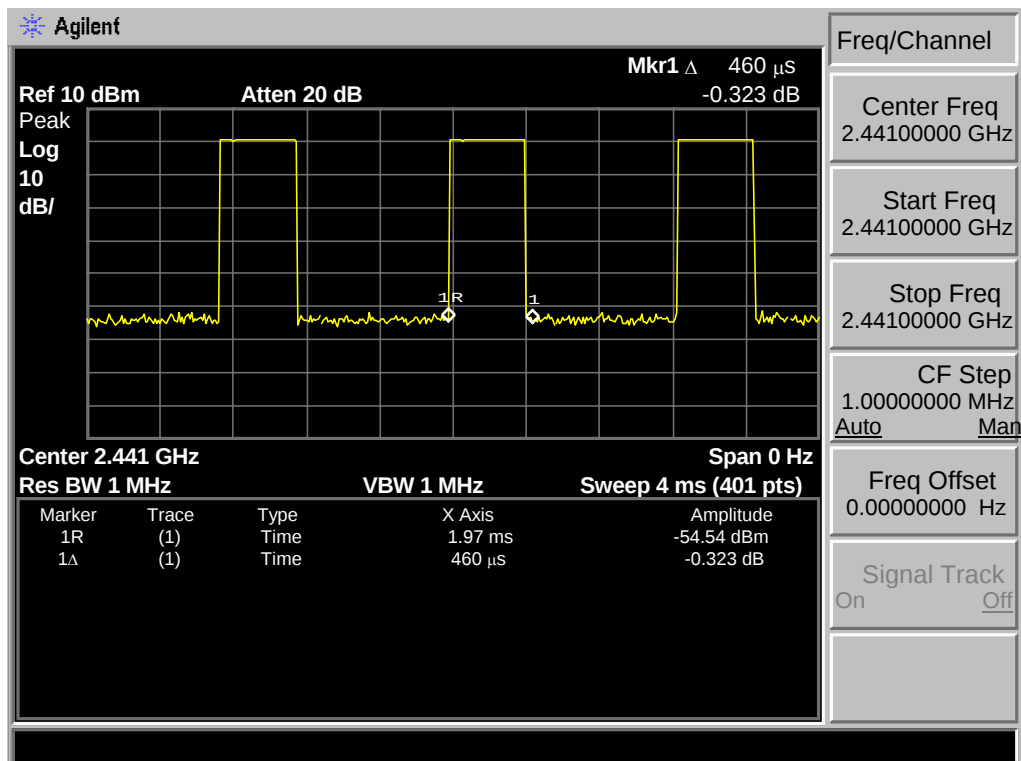
- (1.) Connect EUT antenna output to spectrum analyzer by RF cable.
 - (2.) Measure the hopping number and on time of each pulse with spectrum analyzer in zero span Set, and calculate dwell time formula Dwell time = total hops * pulses on time.
- DH1 Packet permit maximum $1600/79/2=10.12$ hops per second in each channel (1 time slot RX, 1 time slot TX). So, total hops is $10.12*31.6=320.0$
- DH3 Packet permit maximum $1600/79/4=5.06$ hops per second in each channel (3 time slot RX, 1 time slot TX). So, total hops is $5.06*31.6=160.0$
- DH5 Packet permit maximum $1600/79/6=3.37$ hops per second in each channel (5 time slot RX, 1 time slot TX). So, total hops is $3.37*31.6=106.6$
- 3DH1 Packet permit maximum $1600/79/2=10.12$ hops per second in each channel (1 time slot RX, 1 time slot TX). So, total hops is $10.12*31.6=320.0$
- 3DH3 Packet permit maximum $1600/79/4=5.06$ hops per second in each channel (3 time slot RX, 1 time slot TX). So, total hops is $5.06*31.6=160.0$
- 3DH5 Packet permit maximum $1600/79/6=3.37$ hops per second in each channel (5 time slot RX, 1 time slot TX). So, total hops is $3.37*31.6=106.6$

8.3. Test Procedure

EUT was placed on a turn table, which is 0.8 meter high above ground. The turn table can rotate 360 degrees to determine the position of the maximum emission level. Power on the EUT and let it working in test mode, then test it. EUT is set 3 meters away from the receiving antenna, which is mounted on a antenna tower. The antenna can be moved up and down between 1 meter and 4 meters to find out the maximum emission level. Both horizontal and vertical polarization of the antenna are set on test.

The bandwidth of the EMI test receiver (R&S ESVS10) is set at 120kHz for frequency range from 30MHz to 1000 MHz.

The bandwidth of the Spectrum's VBW is set at 1MHz and RBW is set at 1MHz for peak emissions measurement above 1GHz and 1MHz RBW, 10Hz VBW for average emissions measure above 1GHz

The frequency range from 30MHz to 10th harmonic (25GHz) are checked.

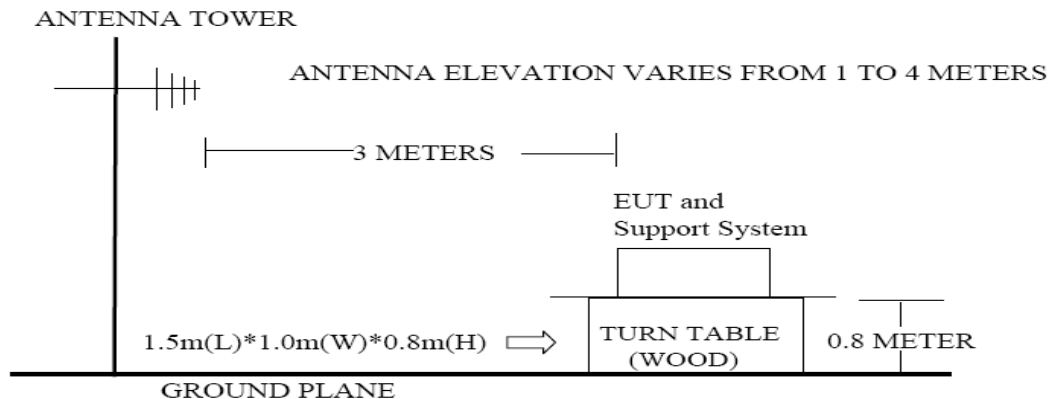

9. BAND EDGE COMPLIANCE

9.1. Limit

All the lower and upper band-edges emissions appearing within 2310MHz to 2390MHz and 2483.5MHz to 2500MHz restricted frequency bands shall not exceed the limits shown in 15.209, all the other emissions outside operation frequency band 2400MHz to 2483.5MHz shall be at least 20dB below the fundamental emissions, or comply with 15.209 limits.

9.3. Test Procedure

EUT was placed on a turn table, which is 0.8 meter high above ground. The turn table can rotate 360 degrees to determine the position of the maximum emission level. Power on the EUT and let it working in test mode, then test it. EUT is set 3 meters away from the receiving antenna, which is mounted on a antenna tower. The antenna can be moved up and down between 1 meter and 4 meters to find out the maximum emission level. Both horizontal and vertical polarization of the antenna are set on test.

Set the spectrum analyzer in the following setting in order to capture the lower and upper band-edges of emissions

- (a) PEAK: RBW=VBW=1MHz / Sweep=AUTO
- (b) AVERAGE: RBW=1MHz / VBW=10Hz / Sweep=AUTO

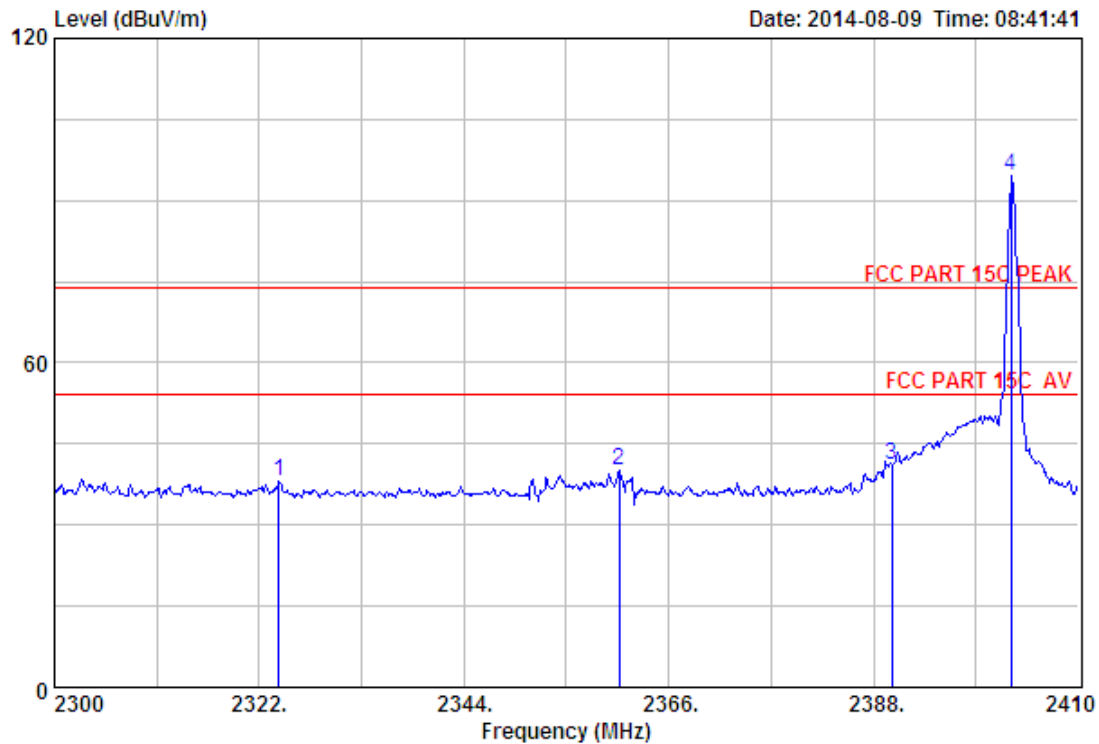

In order to find the maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to ANSI C63.4: 2009 on Conducted Emission Test.

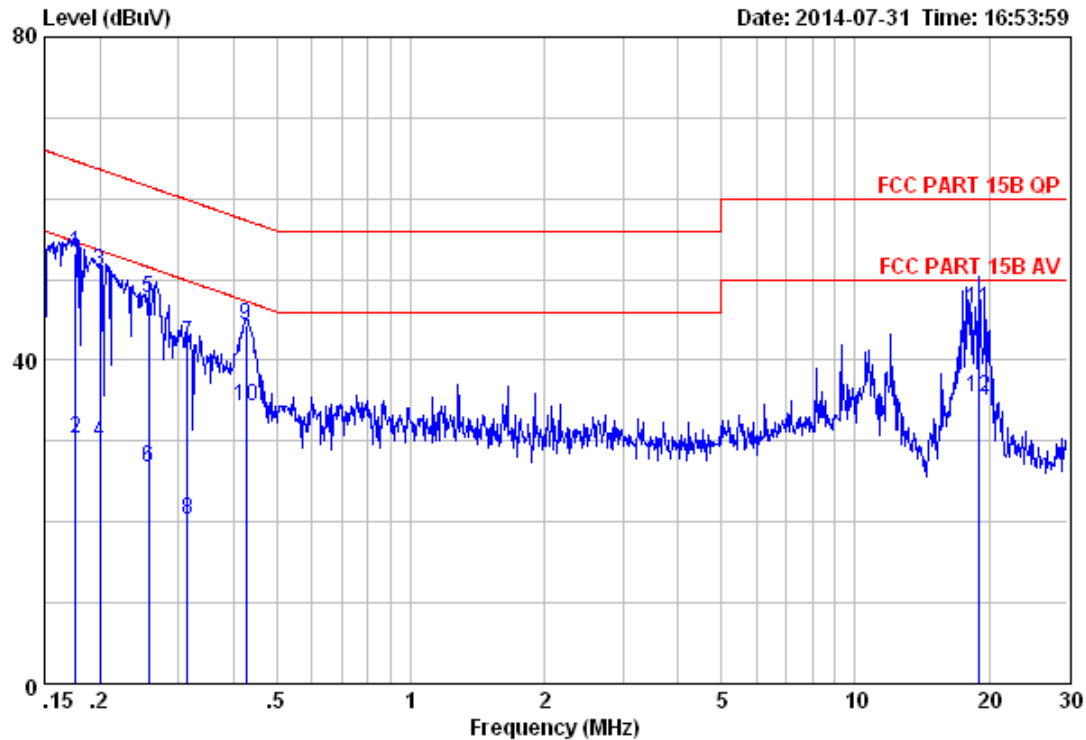

Radiated Test (1000-25000 MHz)



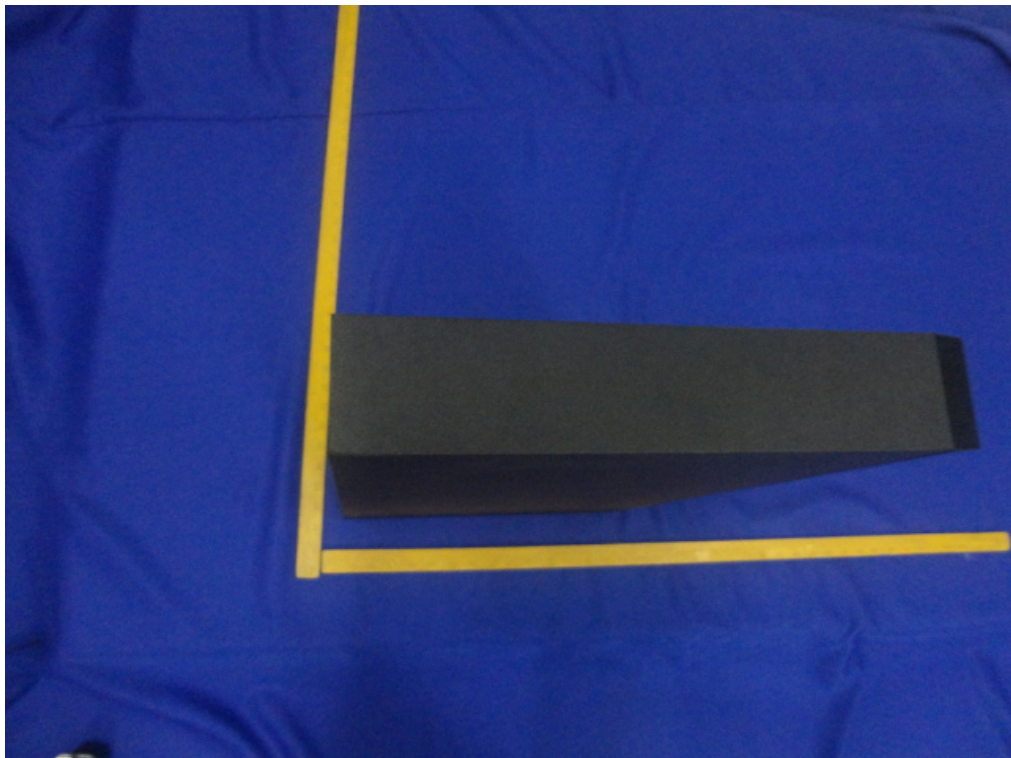
