## ***Summary***

This test report supports an application for certification of a transmitter operating pursuant to 47 CFR 15.249. The product is the Power Measurement ION 6300. It is a transmitter that operates at one channel (916MHz) in the range 902-928MHz. The transmitter module is the Millennial Net i-Bean Gateway (Model GW-5209R).

## ***Test Methodology***

Radiated emissions testing is performed according to the procedures specified in ANSI C63.4 (2003). Emissions were maximized by rotating the device around three orthogonal axes as well as varying the test antenna's height and polarity.

Frequency range investigated: 0.15MHz – 10GHz

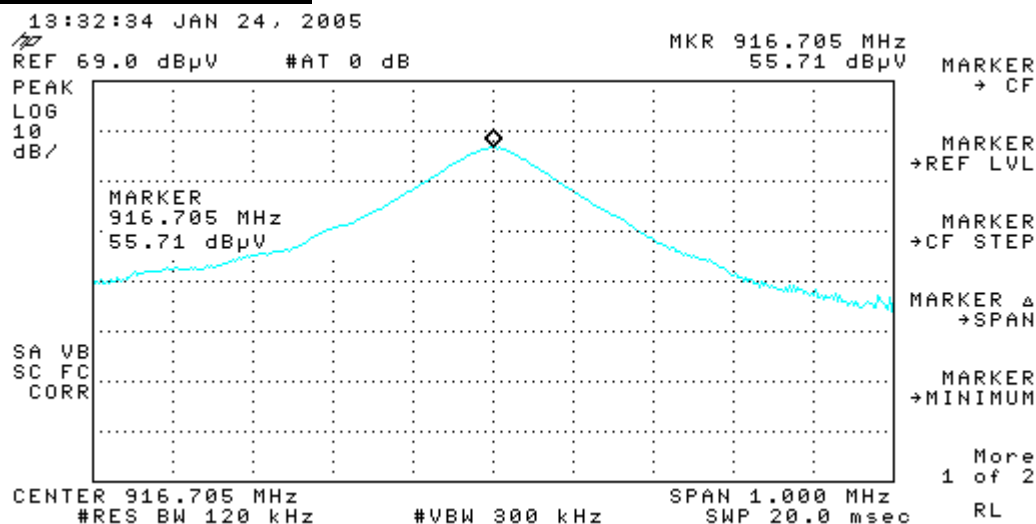

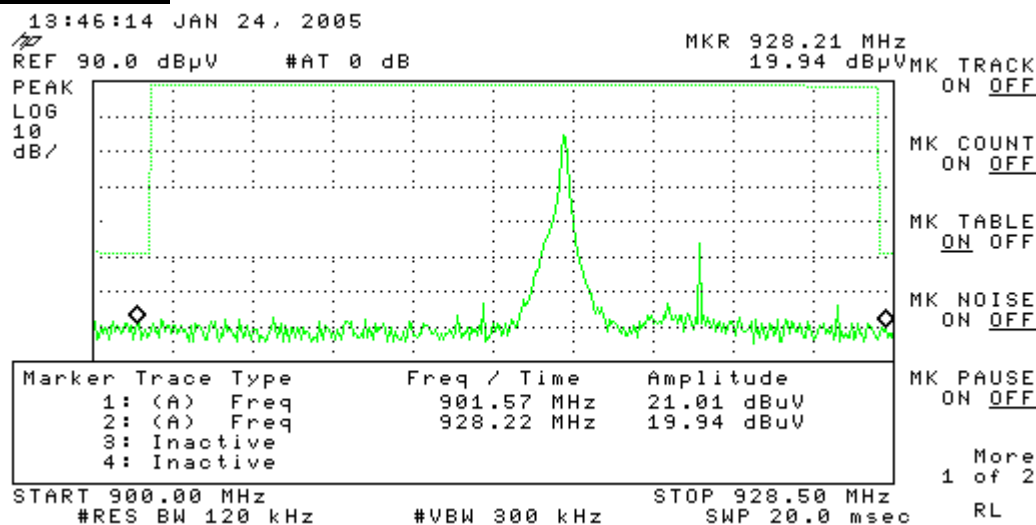
