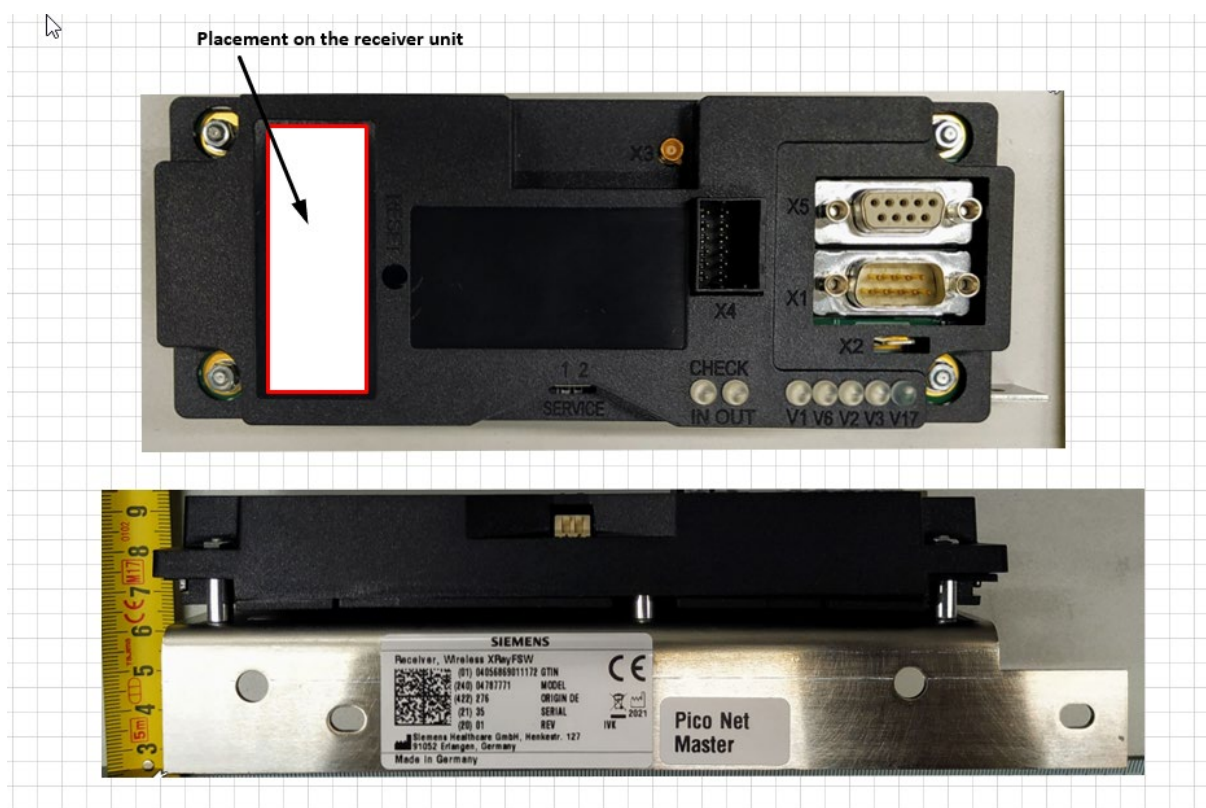


Figure 2: Label placement on Receiver the Wireless XRay Footswitch Model 04787771

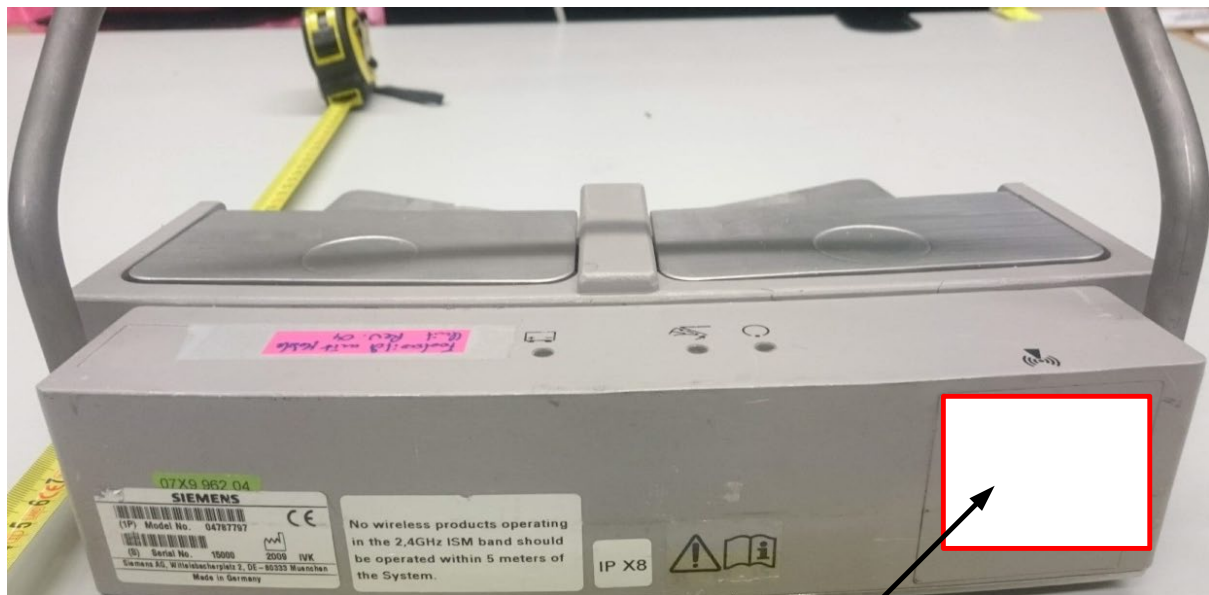
Figure 4 : Label placement on Wireless XRay Footswitch Mono-MP Model 04787813
