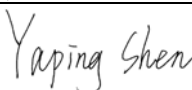

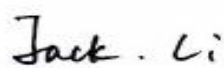

2. System Test Configuration

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The Transmitter was operated in the normal operating mode. the Tx frequency was fixed which was for the purpose of the measurements.

2.3 Test Procedure

2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4-2009 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode.

2.3.2 Radiated Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter(EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4-2009.

3. Description of Test Modes

The Transmitter of EUT is a Door/Window Sensor and powered by host equipment. This is Digital Transmission system(DTS) and have modulation DSSS. According exploratory test, EUT will have maximum output power in those data rate(IEEE802.15.4), so those data rate were used for all test.

The equipment enables high-speed access without wires to network assets. This adapter uses the ZIGBEE protocol to enable wireless communications between the host and Wireless router.

1. For lowest channel : 2405MHz (Channel 1)
2. For middle channel : 2440MHz (Channel 8)
3. For highest channel: 2480MHz (Channel 16)

EUT operating conditions:

The EUT exercise program used during conducted testing was designed to exercise the EUT in a manner similar to typical use, The exercise sequence is listed as below:

1. Setup the EUT and simulators as shown on 2.4.
2. The EUT started to work.

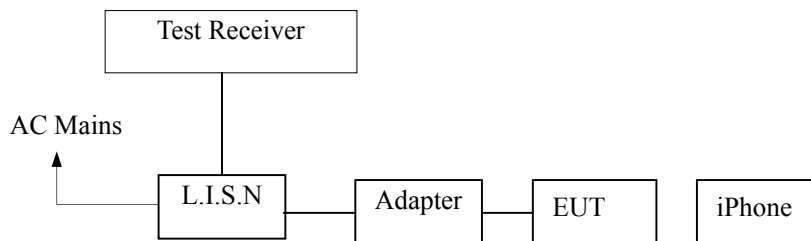

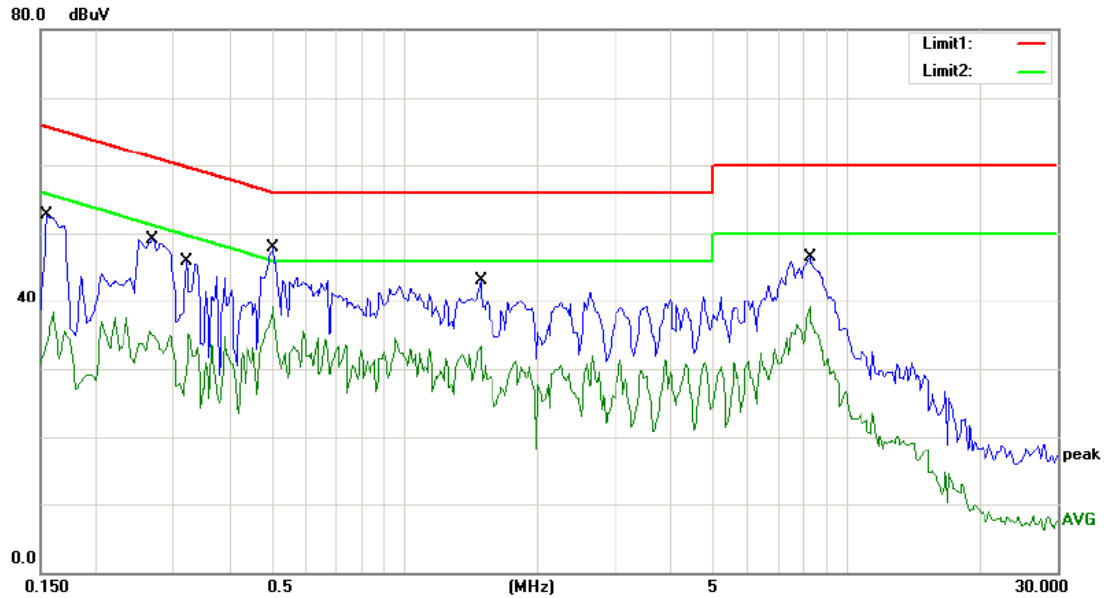

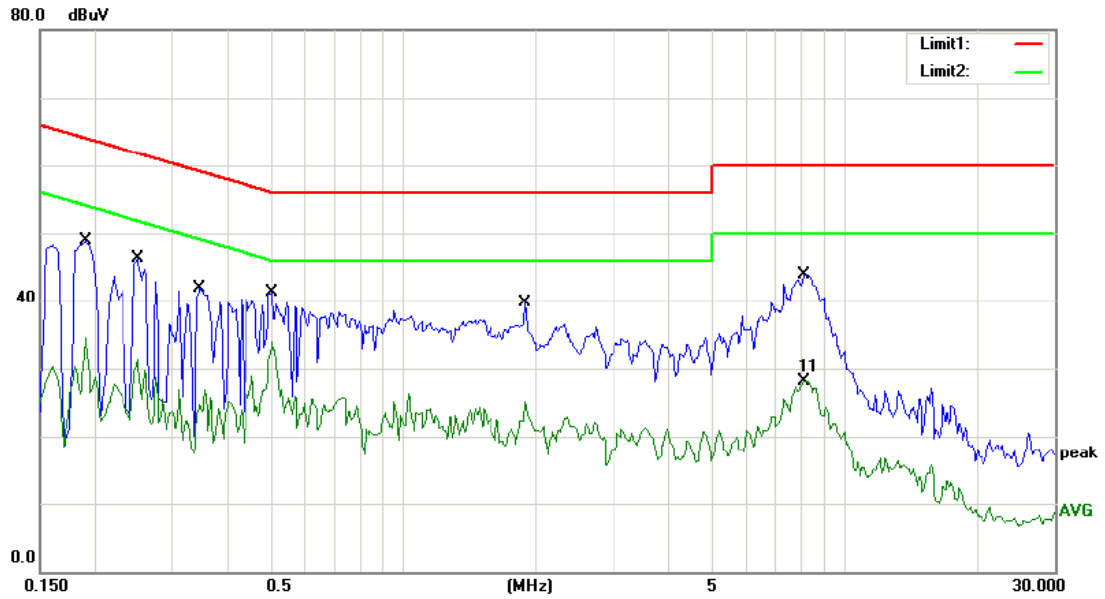

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
4. Repeat above procedures until all frequency measured were complete.

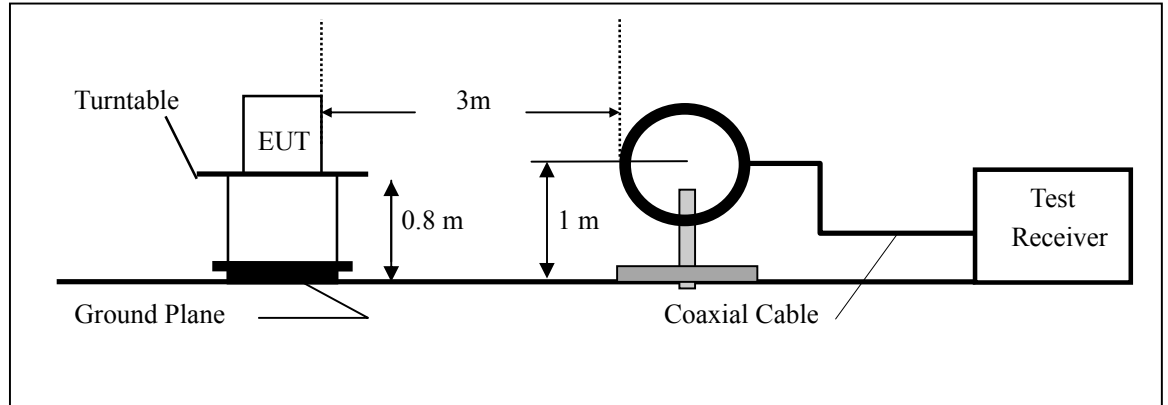

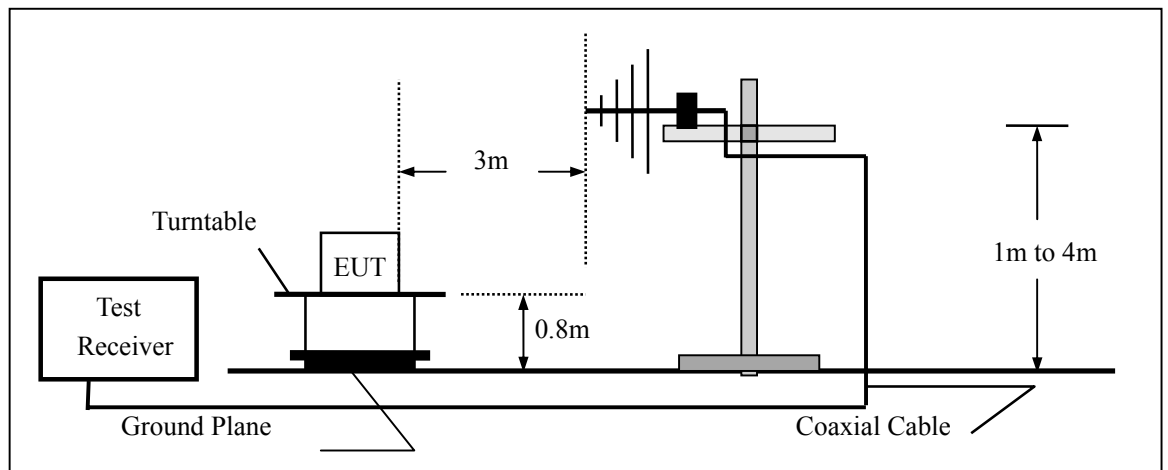

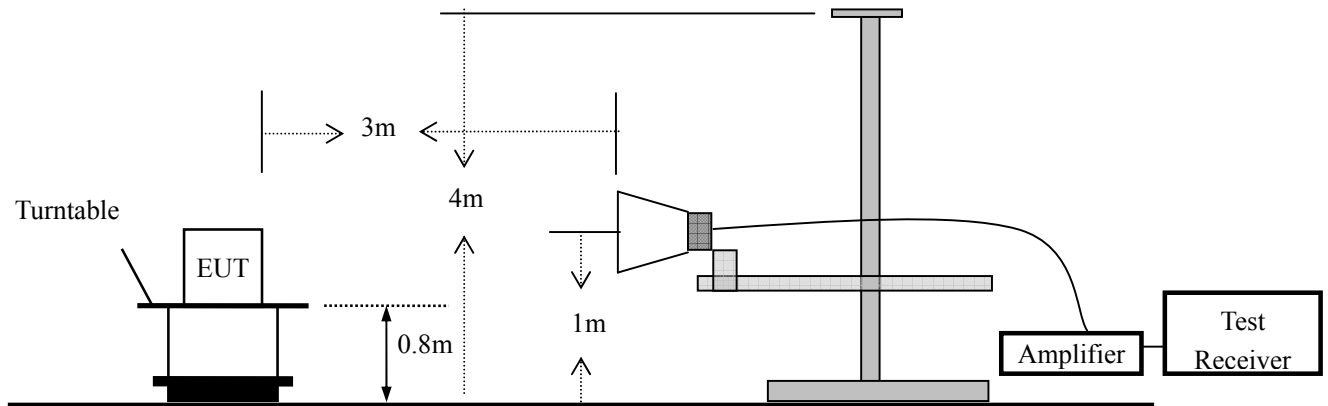
(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

7. Occupied Bandwidth Test

7.1 Measurement Procedure

1. The testing follows FCC KOB Publication No. 558074 OTS 001 Meas. Guidance v03r02
2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
3. Set to the maximum power setting and enable the EUT transmit continuously
4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. Set the Video bandwidth (VBW) = 300 kHz. In order to make an accurate measurement The 6dB bandwidth must be greater than 500 kHz
5. Measure and record the results in the test report.

12. Antenna Application

12.1 Antenna Requirement

Standard	Requirement
FCC CRF Part 15.203	An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §15.211, §15.213, §15.217, §15.219, or §15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

12.2 Result

The antenna is connected via an reverse polarity SMA type connection, and the antenna can't be replaced by the user, The antenna's gain is 2dBi and meets the requirement.
