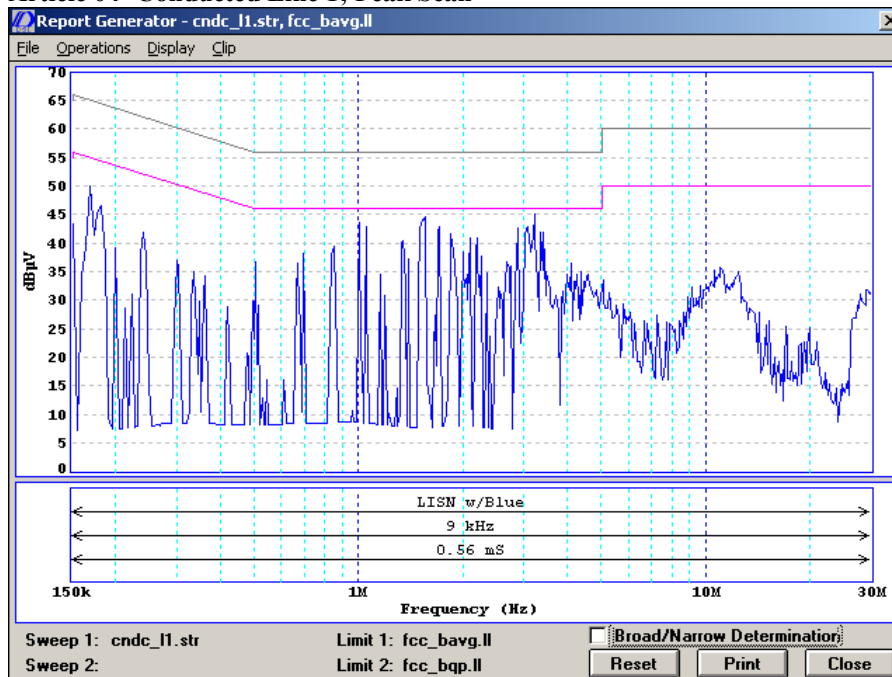

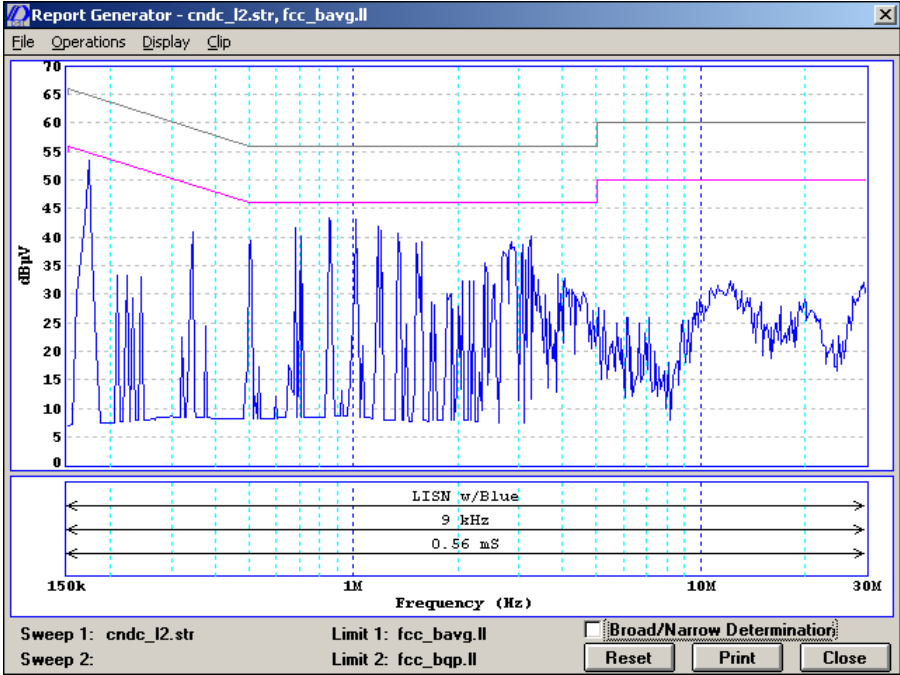
1.2. 15.107, 15.207 Conducted Emissions

Article 04- Conducted Line 1; Peak Scan



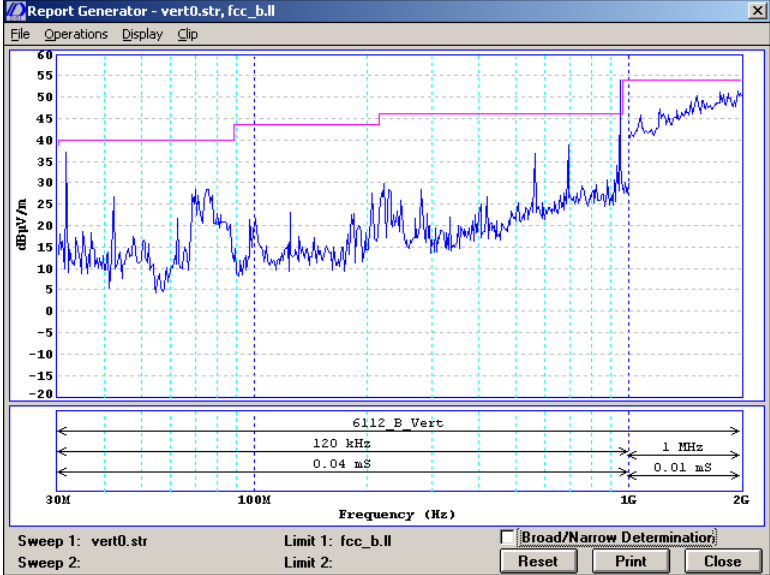

1.3. 15.109, 15.209 Radiated Emissions: 30MHz to 2GHz

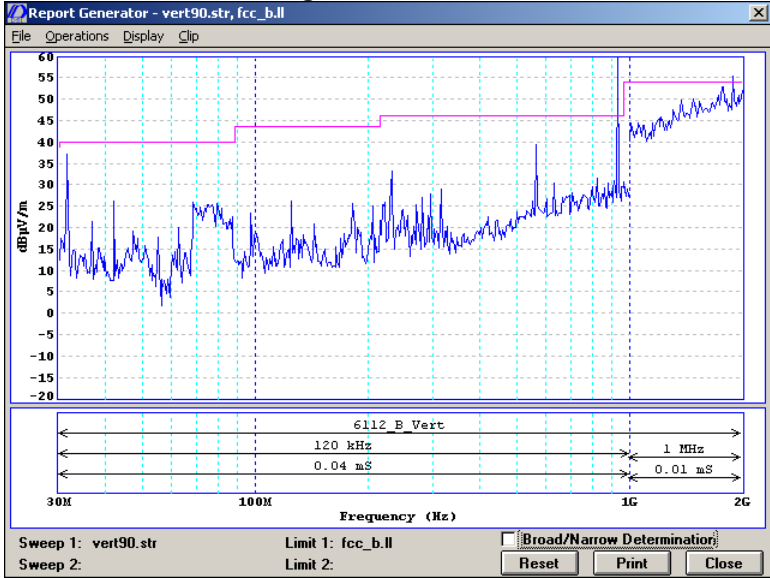

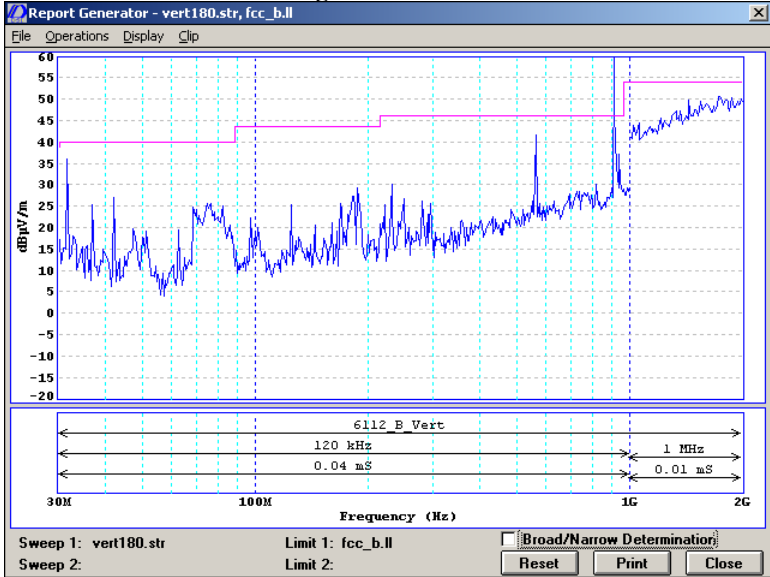

Article 07-Vertical 90 Degrees



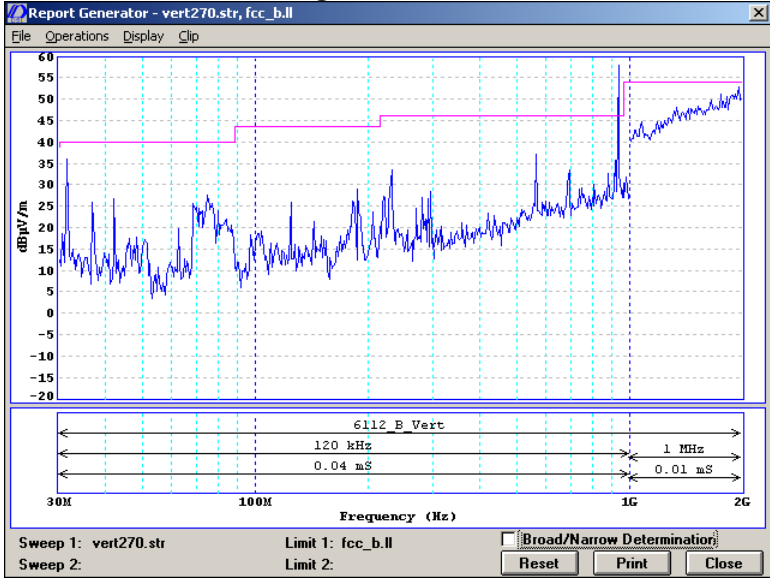
Article 08-Vertical 180 Degrees



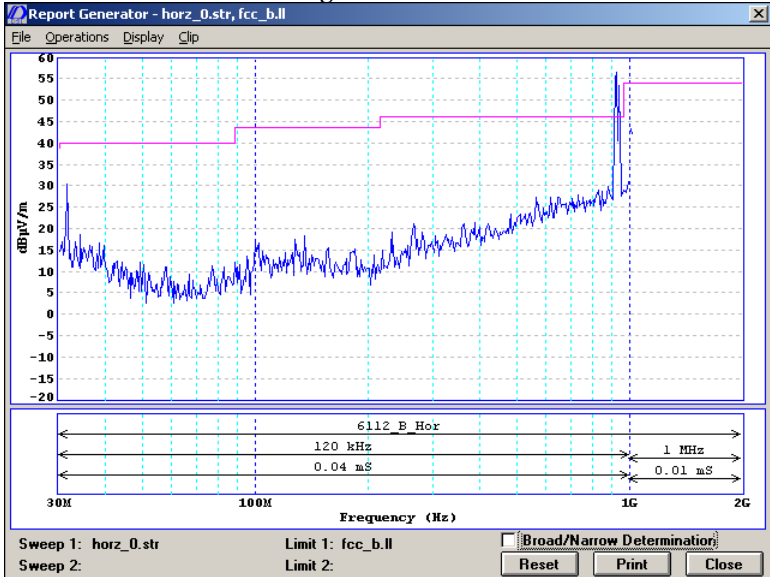

Article 09-Vertical 270 Degrees



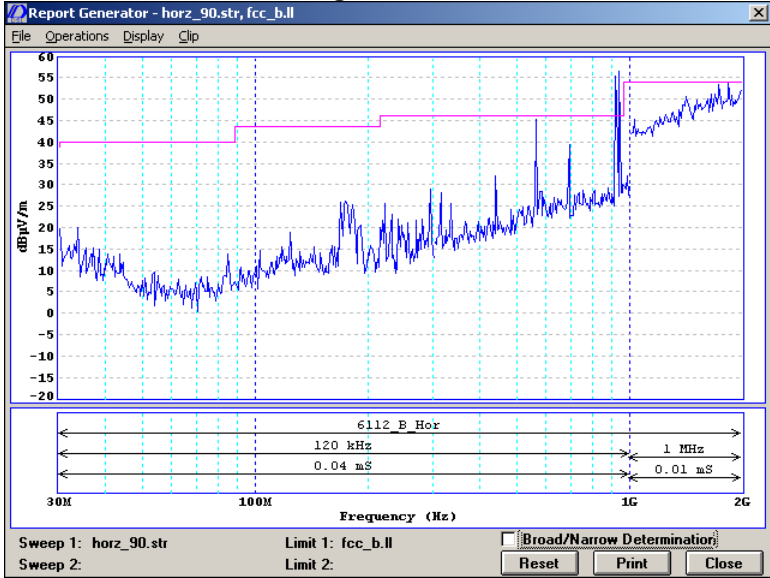
Article 10-Horizontal 0 Degrees



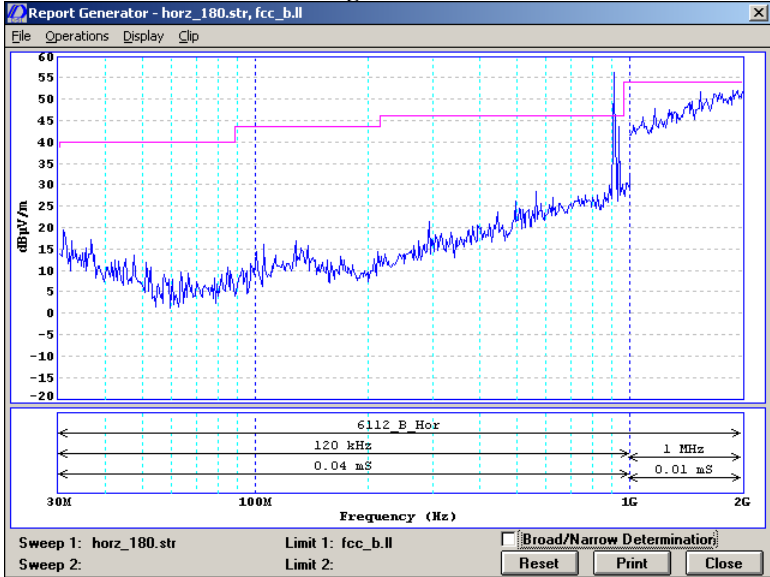

Article 11-Horizontal 90 Degrees



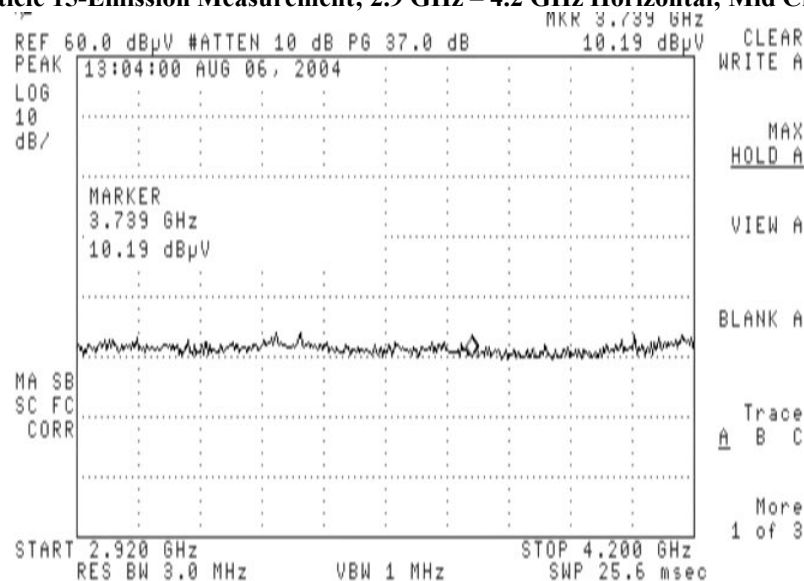

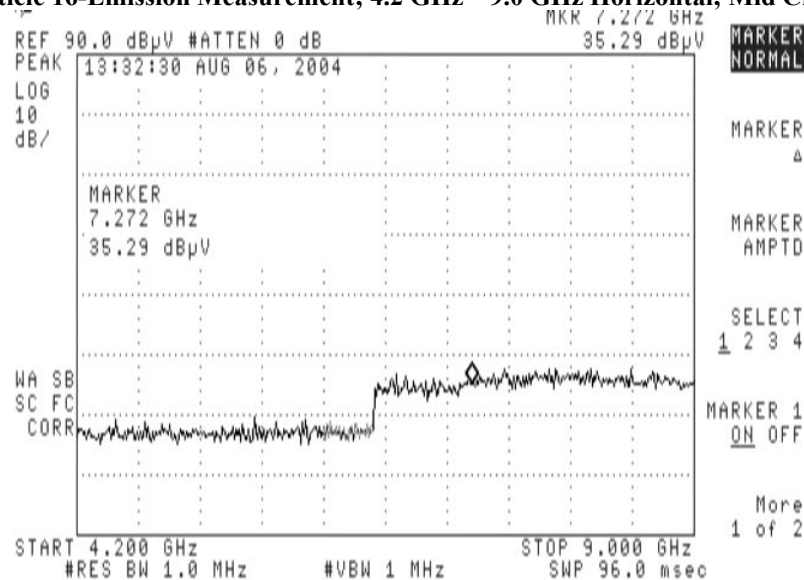

Article 15-Emission Measurement; 2.9 GHz – 4.2 GHz Horizontal; Mid Channel



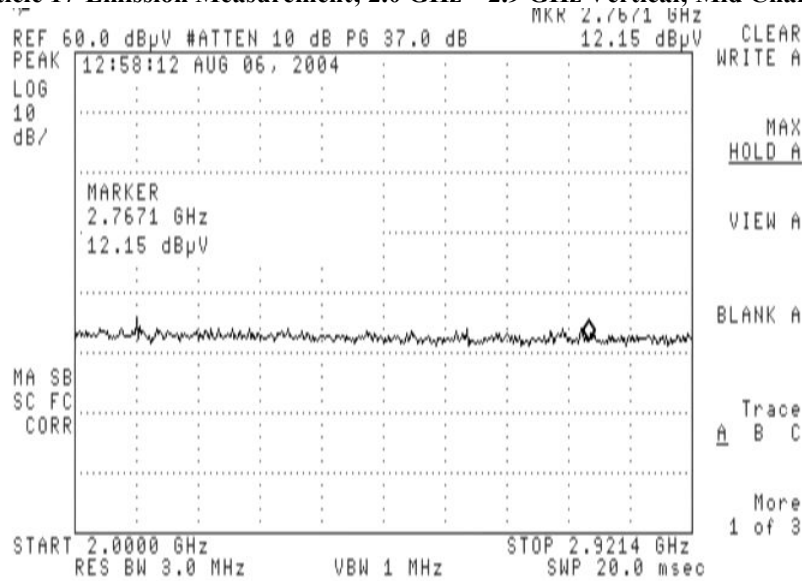
Article 16-Emission Measurement; 4.2 GHz – 9.0 GHz Horizontal; Mid Channel



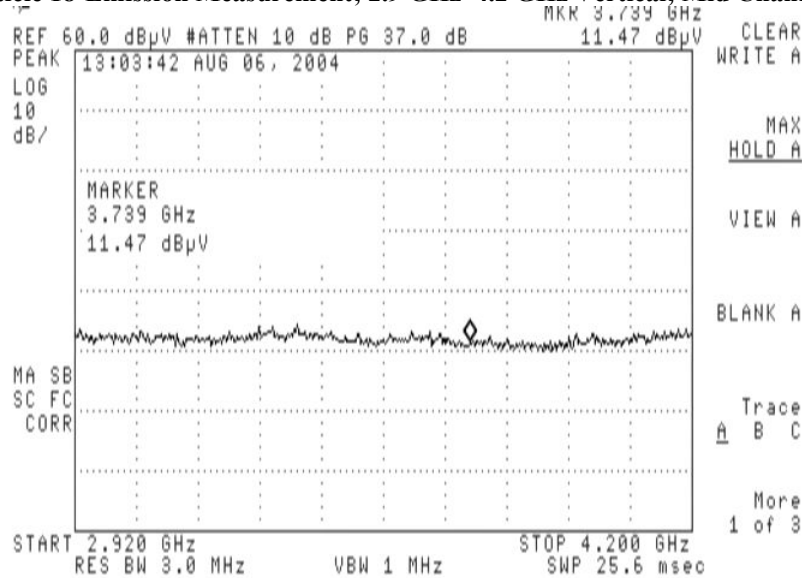

Article 17-Emission Measurement; 2.0 GHz – 2.9 GHz Vertical; Mid Channel



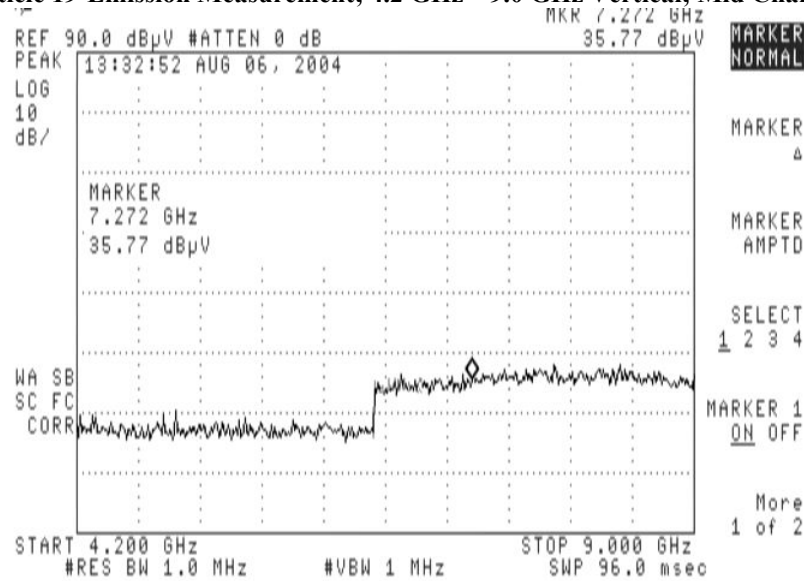
Article 18-Emission Measurement; 2.9 GHz–4.2 GHz Vertical; Mid Channel
