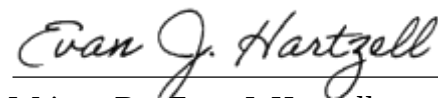

2.2 Description of EUT

The E7-Audience-Indoor is an indoor WiFi 7 access point designed for high-density environments with (1) 10GbE PoE port and (1) 1GbE PoE port. The E7-Audience-Indoor transmits in the 5 GHz, and 6 GHz frequency bands using integral antennas and is powered by an 802.3at PoE power adapter.

This report covers the circuitry of the device subject to FCC Part 15, Subpart E. The circuitry of the device subject to FCC Part 15 Subpart B was found to be compliant and is covered under a separate Unified Compliance Laboratory test report.

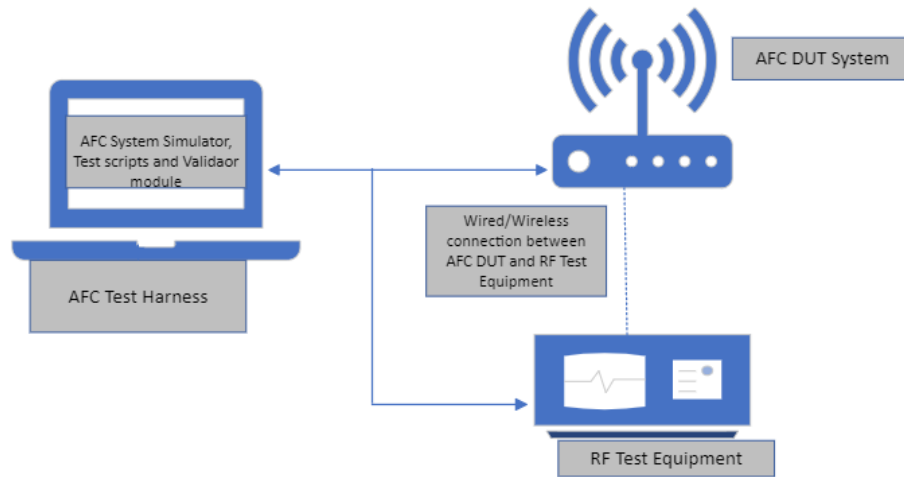


Diagram 1: AFC DUT Setup for Standard Power Access Point- Standalone

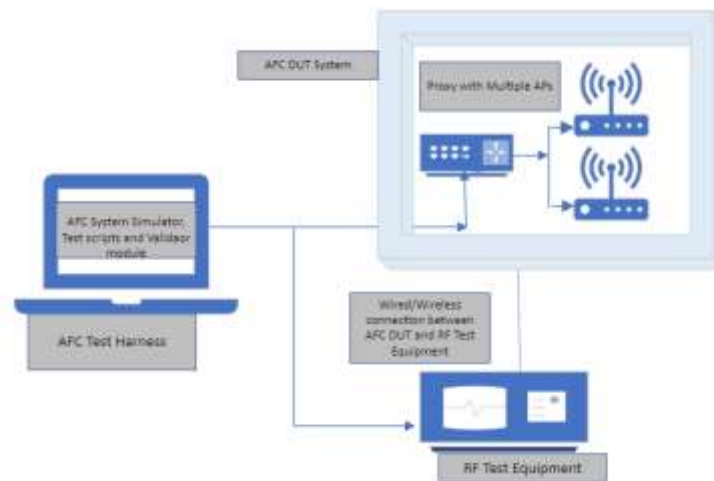


Diagram 2: AFC DUT Setup for Standard Power Access Point (non-standalone) with Proxy

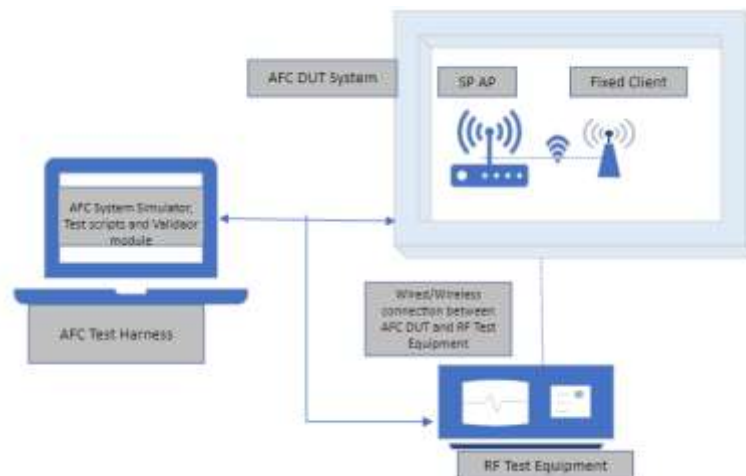


Diagram 3: AFC DUT Setup for Fixed Client**2.9 Modification Incorporated/Special Accessories on EUT**

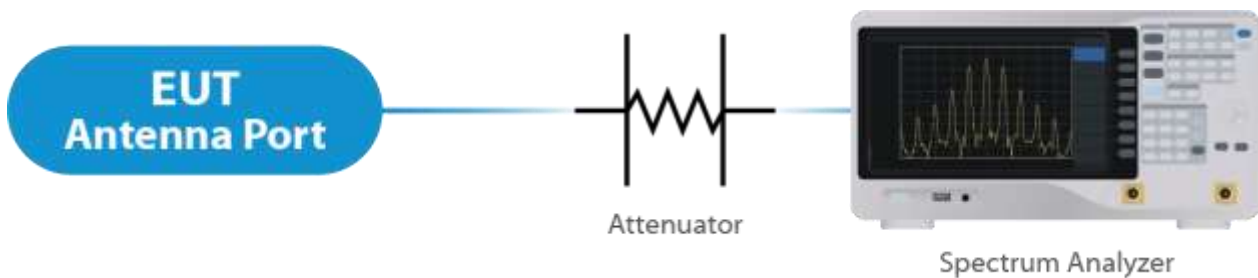


Figure 1: Direct Connect at the Antenna Port Test

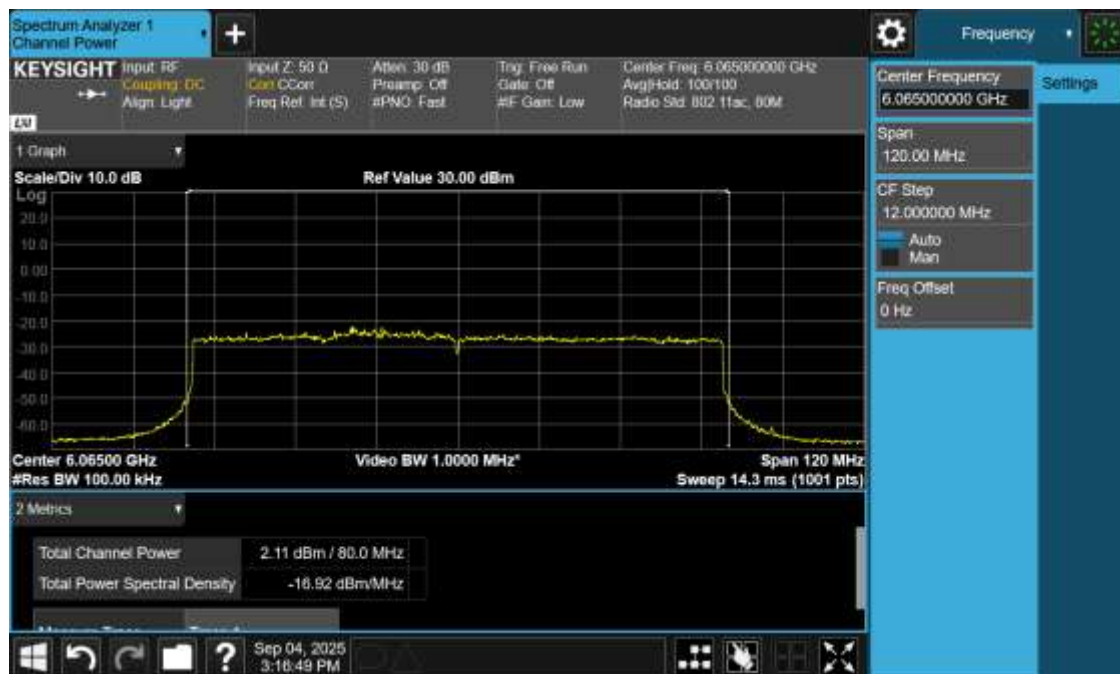


Plot 6: Power and PSD for Standard Power – 6605 MHz

Plot 16: Power and PSD for Low-Power Indoor – 5975 MHz

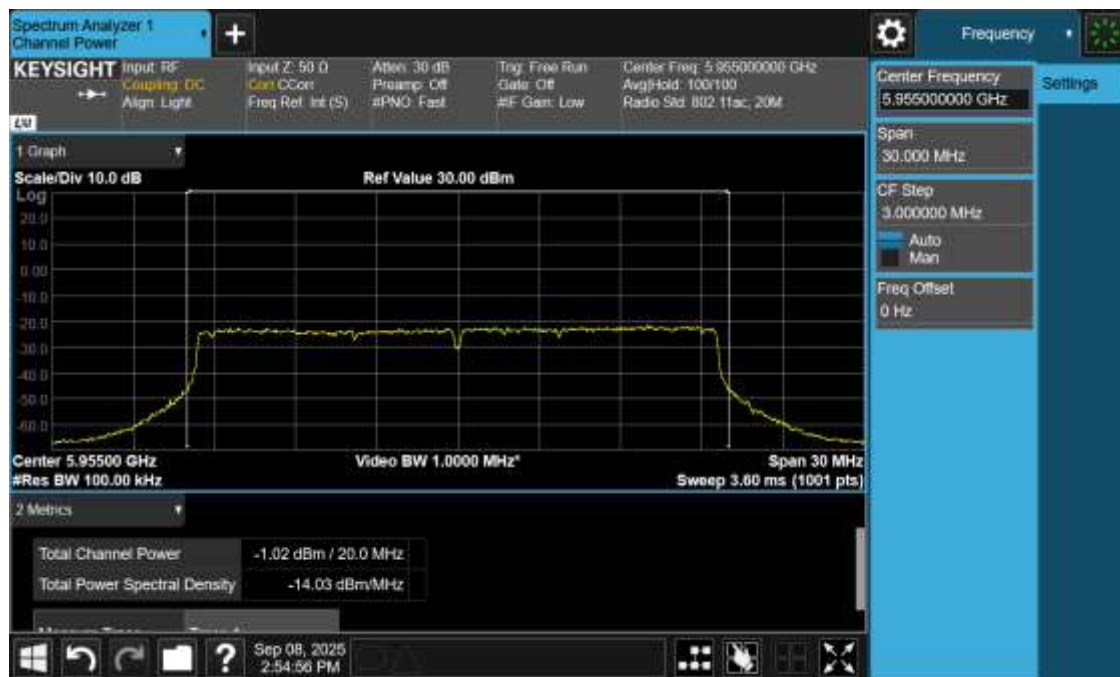


Plot 17: Power and PSD for Low-Power Indoor – 5975 MHz
