- The EUT also supports beamforming mode, and the beamforming support 802.11n/ac/ax only, not include 802.11a/b/g. BF Directional Gain = Max. Gain + $10 \log (N_{ANT} / N_{SS})$.
For beamforming operation, manufacturer automatically backs power down based on a $10 \log (N_{ANT})$ factor based on CDD power. Therefore, only the CDD mode was evaluated in this report.

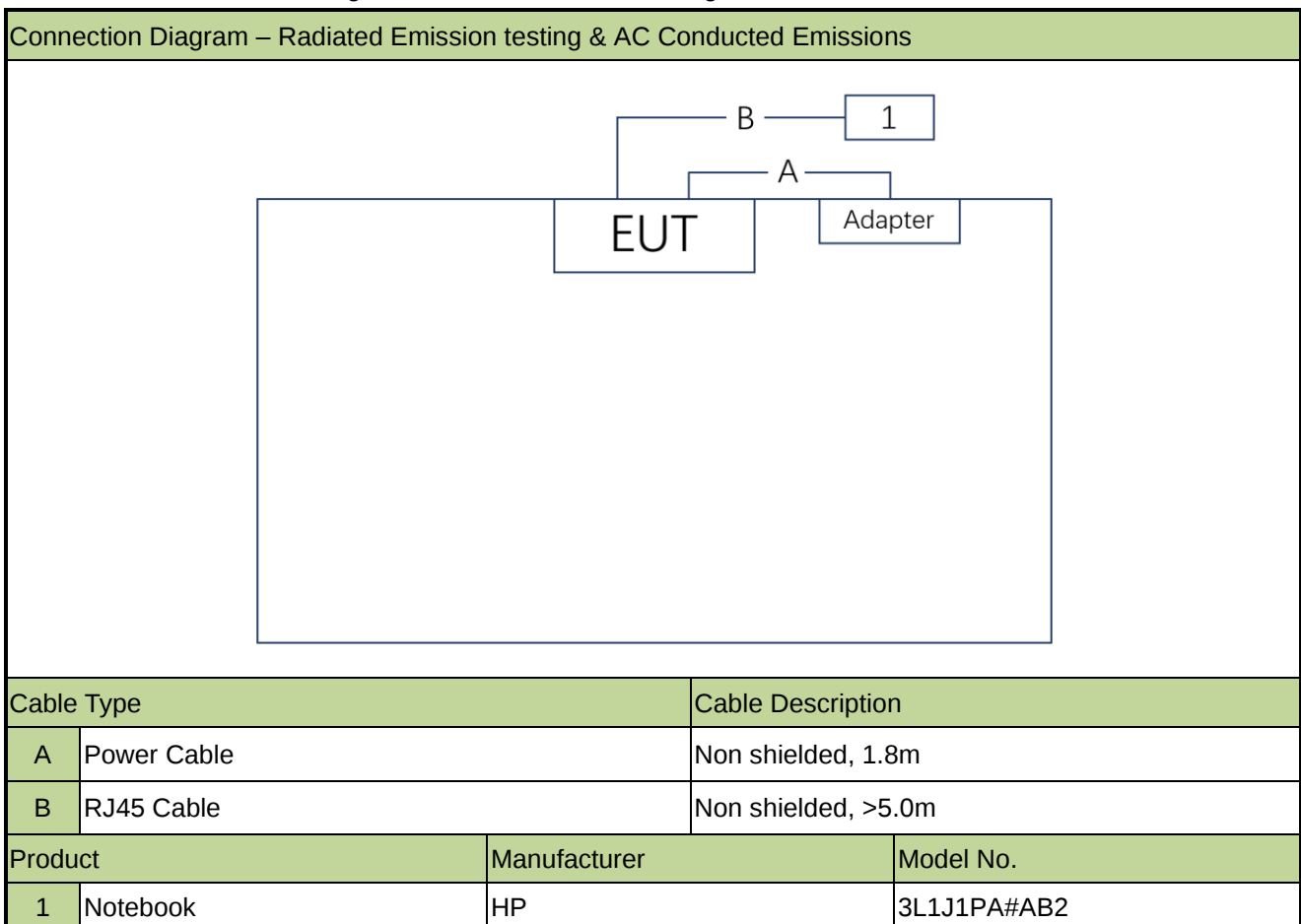

Note: The modulation and bandwidth are similar for 802.11n mode for 20MHz/40MHz and 802.11ac mode for 20MHz/40MHz. Therefore, 802.11ac mode was selected as representative test mode in this report, and the manufacturer will control the power level for 802.11n mode as same as the 802.11ac mode or lower than it.

2.2. Test System Connection Diagram

The device was tested per the guidance ANSI C63.10-2013 was used to reference the appropriate EUT setup for radiated emissions testing and AC line conducted testing.



Note: Only Adapter #1 was selected for all of RF test.

2.3. Test Software

The test utility software used during testing was “Qualcomm Sequence Profiling Resource”, and the version was 5.0-00199. Final power setting please refer to operational description.

5.1. Decision Rules

- The analyzer plots shown in this section were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables and attenuators used as part of the system to connect the EUT to the analyzer at all frequencies of interest.
- For the item of "6dB Bandwidth" and "26 & 99% Bandwidth", we only evaluated the Ant 2 RF port.
- EUT supports one configuration only in 802.11ax full RU mode.

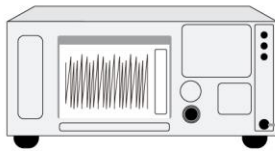
1. The analyzers' automatic bandwidth measurement capability was used to perform the 26dB bandwidth
2. RBW = approximately 1% of the emission bandwidth.
3. VBW > RBW
4. Detector = Peak.
5. Trace mode = max hold.
6. Measure the maximum width of the emission that is 26 dB down from the maximum of the emission.
Compare this with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is approximately 1%.

99% Bandwidth

1. Set center frequency to the nominal EUT channel center frequency.
2. RBW = 1% to 5% of the OBW
3. $VBW \geq 3 \times RBW$
4. Span = 1.5 times to 5 times the OBW
5. Detector = peak
6. Trace mode = max hold
7. Allow the trace to stabilize
8. Use the 99% power bandwidth function of the instrument.

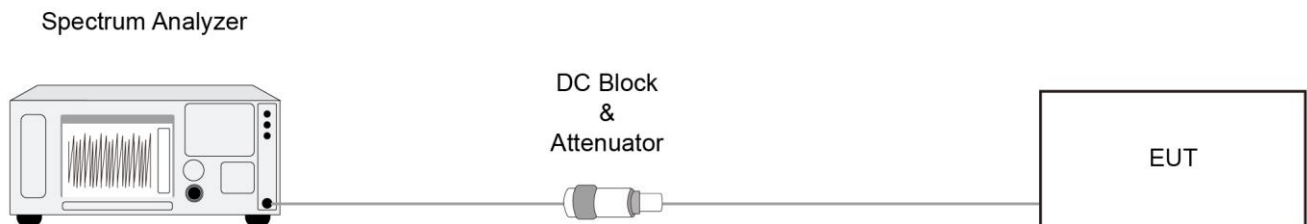

6.3.3. Test Setting

1. Set center frequency to the nominal EUT channel center frequency.
2. RBW = 100 kHz.
3. VBW $\geq 3 \times$ RBW.
4. Detector = Peak.
5. Trace mode = max hold.
6. Sweep = auto couple.
7. Allow the trace to stabilize.
8. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

6.4. Output Power Measurement

6.4.1. Test Limit

For the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6 dBi.

For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW or $11 \text{ dBm} + 10 \log B$, where B is the 26 dB emission bandwidth in megahertz.

For the band 5.725-5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W (30dBm).

If transmitting antennas of directional gain greater than 6dBi are used, the maximum conducted output power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

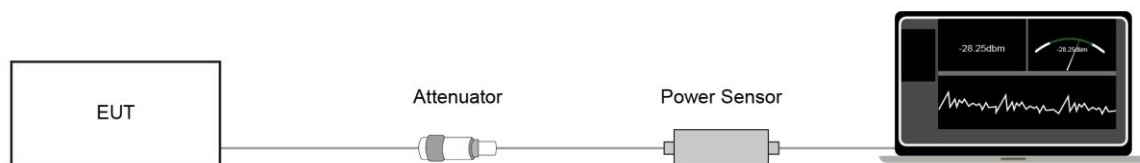

6.5.3. Test Setting

Average power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. The power meter implemented triggering and gating capabilities which were set up such that power measurements were recorded only during the ON time of the transmitter. The trace was averaged over 100 traces to obtain the final measured average power.

6.6. Power Spectral Density Measurement

6.6.1. Test Limit

For the band 5.15-5.25 GHz, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band.

For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band.

For the band 5.725-5.85 GHz, the maximum power spectral density shall not exceed 30 dBm in any 500-kHz band.

If transmitting antennas of directional gain greater than 6dBi are used, the peak power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

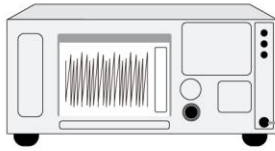

1. Analyzer was set to the center frequency of the UNII channel under investigation

For example, add $10 \cdot \log(1/0.25) = 6 \text{ dB}$ if the duty cycle is 25 percent.

6.7. Frequency Stability Measurement

6.7.1. Test Limit

Manufactures of U-NII devices are responsible for ensuring frequency stability such that an emission is maintained within the band of operation under all conditions of normal operation as specified in the user's manual.

6.7.2. Test Procedure

Frequency Stability Under Temperature Variations:

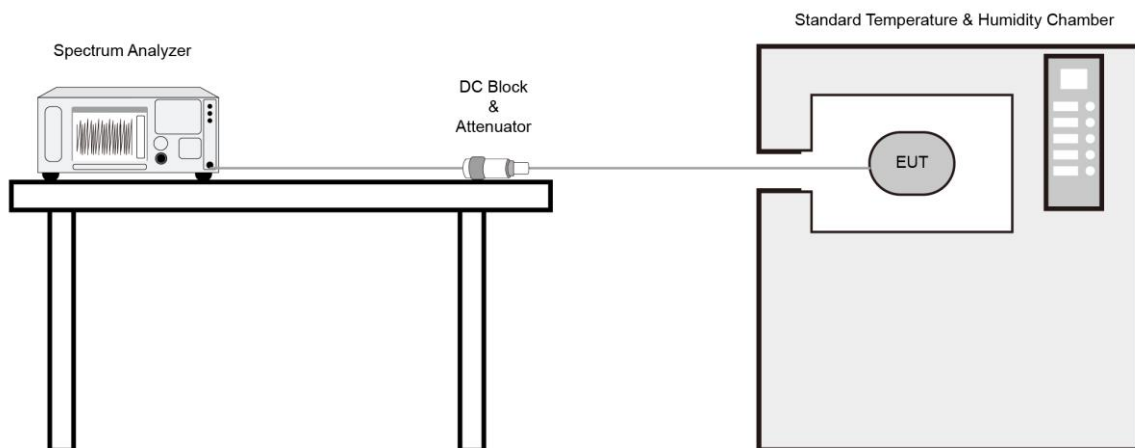
The equipment under test was connected to an external AC or DC power supply and input rated voltage. RF output was connected to a frequency counter or spectrum analyzer via feed through attenuators. The EUT was placed inside the temperature chamber. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and measure EUT 20°C operating frequency as reference frequency. Turn EUT off and set the chamber temperature to highest. After the temperature stabilized for approximately 30 minutes recorded the frequency. Repeat step measure with 10°C decreased per stage until the lowest temperature reached.

Frequency Stability Under Voltage Variations:

Set chamber temperature to 20°C. Use a variable AC power supply / DC power source to power the EUT and set the voltage to rated voltage. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and recorded the frequency.

Reduce the input voltage to specify extreme voltage variation ($\pm 15\%$) and endpoint, record the maximum frequency change.
