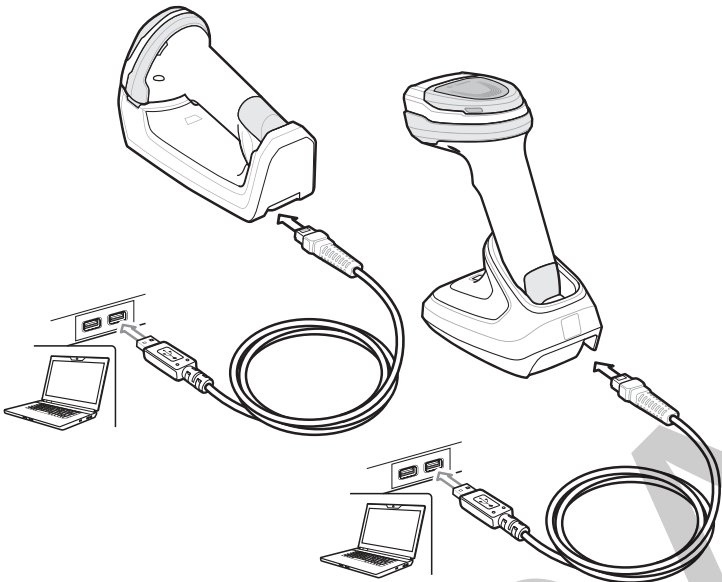
Cradle Cable Connection

Troubleshooting

Digital scanner decoding bar code, but data not transmitting to host

Host interface not configured properly	Scan appropriate host parameter bar codes.
Interface cable is loose	Ensure all cable connections are secure.
Invalid ADF rule	Program the correct ADF rules.
Digital scanner not paired to cradle	Scan cradle pairing bar code.

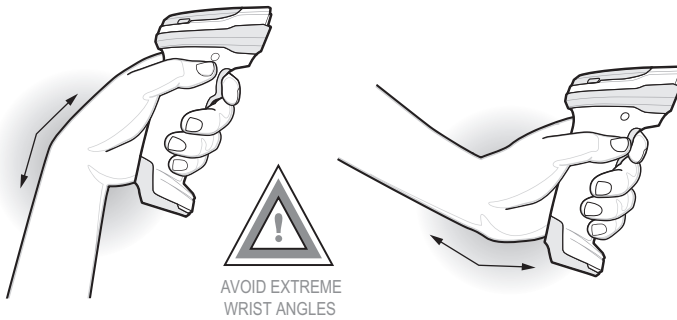

The model DS8278 may be used with either a rechargeable Battery Pack or a rechargeable capacitor based PowerCap.

Zebra approved rechargeable battery packs and PowerCaps are designed and constructed to the highest standards within the industry.

Use only Zebra approved batteries or PowerCaps. Accessories which have charging capability are approved for use with the following battery and PowerCap models: Battery Part Number 82-176890-01 (3.6 Vdc, 2500 mAh); PowerCap Part Number AS-000231-01 (3.7V, 2.0A).

However, to how long a battery pack or PowerCap can operate or be stored before needing replacement. Many factors affect the actual life cycle of a battery pack or PowerCap, such as heat, cold, harsh environmental conditions and severe drops.

When battery packs or PowerCaps are stored over six months, some irreversible deterioration in overall battery quality may occur. Store batteries and PowerCaps at half of full charge in a dry, cool place, removed from the equipment to prevent loss of capacity, rusting of metallic parts and electrolyte leakage.

When storing batteries for one year or longer, the charge level should be verified at least once a year and charged to half of full charge. Replace the battery pack or PowerCap when a significant loss of run time is detected.
