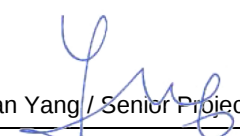

4 Test Set-up and Operation Modes

4.1 Principle of Configuration Selection

Radio Spectrum: The equipment under test (EUT) was configured at its highest power output in order to measure its highest possible radiation and conducted level. The test modes were adapted accordingly in reference to the instructions for use.

Emission: The equipment under test (EUT) was configured to measure its highest possible radiation level. The test modes were adapted accordingly in reference to the instructions for use.

4.2 Test Operation and Test Software

Test operation refers to test setup in chapter 5. All testing were performed according to the procedures in ANSI C63.10: 2013 and ANSI C63.4: 2014.

According to clause 3.2, Radio Spectrum and Radiated Spurious Emission tests were performed on model MBP845CONNECTPU with adapter #1, and Conducted Emission and Radiated Emission tests were performed on model MBP845CONNECTPU with adapter #1, #2 in this report.

Diagram of Measurement Configuration for Radiation Test (Below 1GHz)

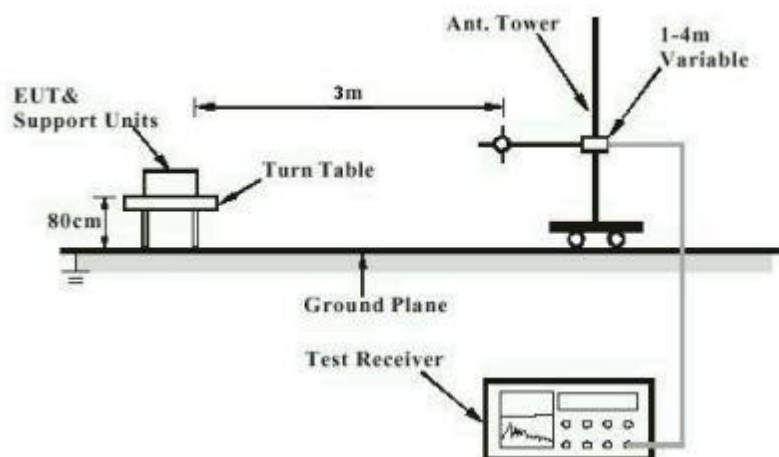


Diagram of Measurement Configuration for Radiation Test (Above 1GHz)

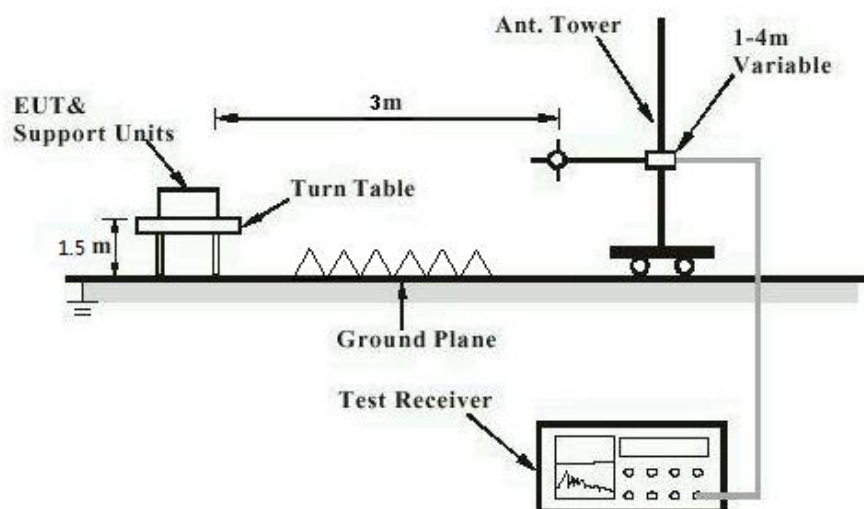
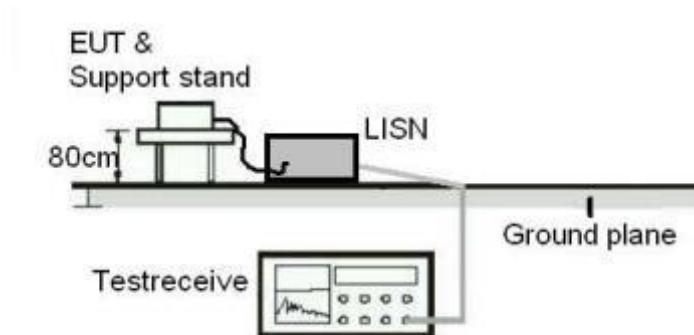
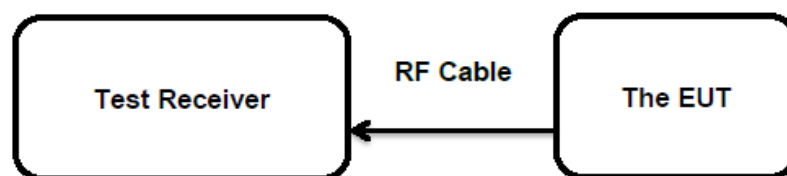


Diagram of Measurement Configuration for Mains Conduction Measurement**Diagram of Measurement Configuration for Conducted Transmitter Measurement**

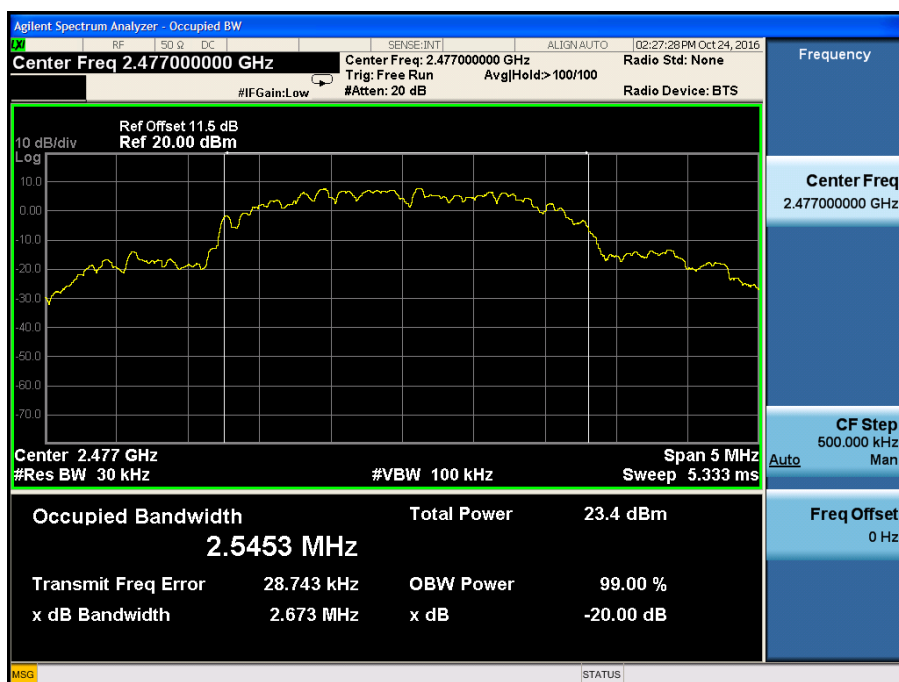
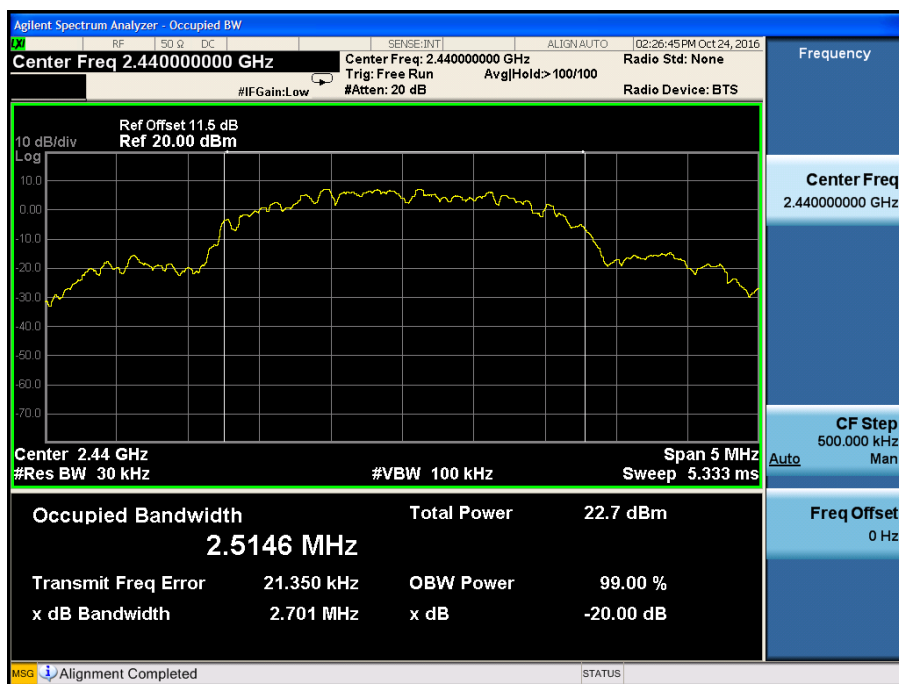
Appendix B.1: Maximum Peak Conducted Output Power





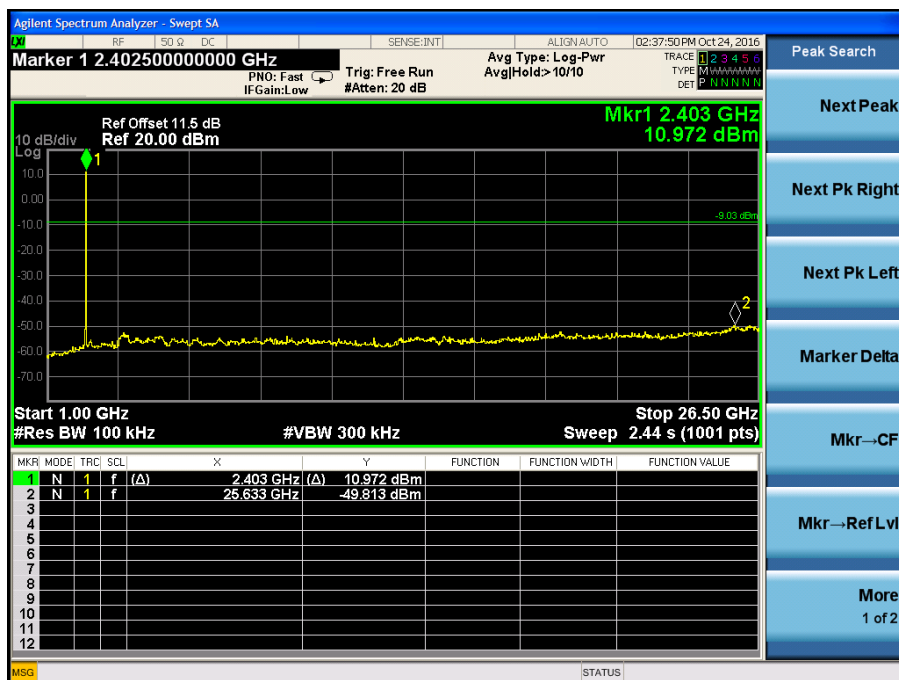
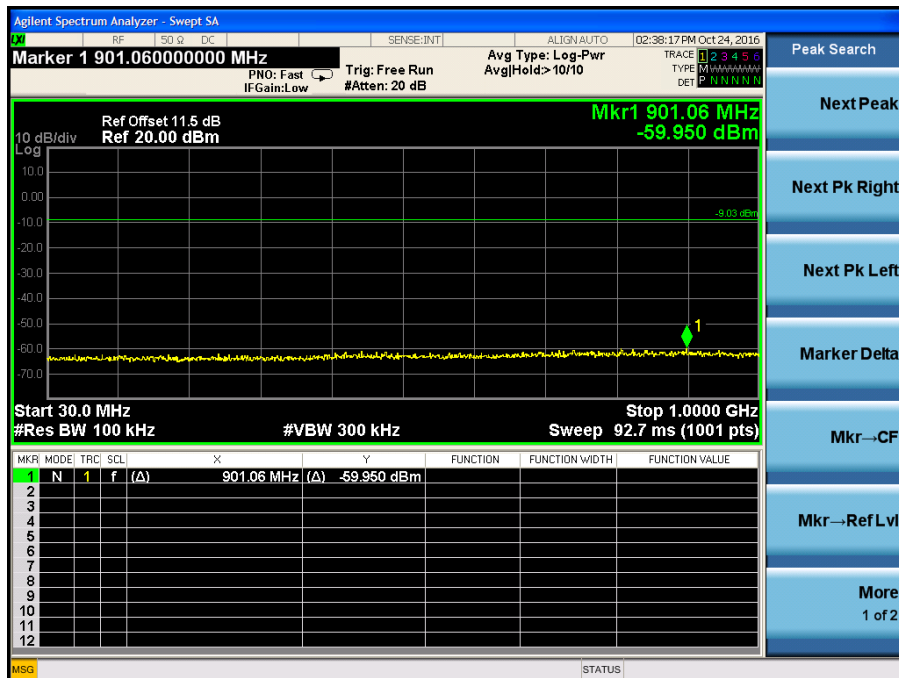
Appendix B.2: 20dB Bandwidth & 99% Bandwidth



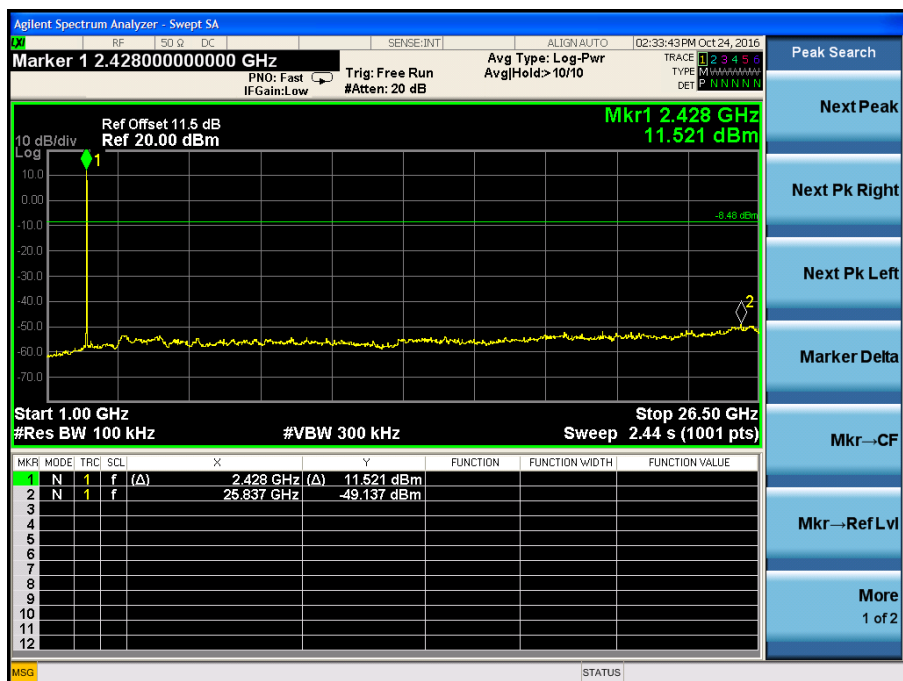
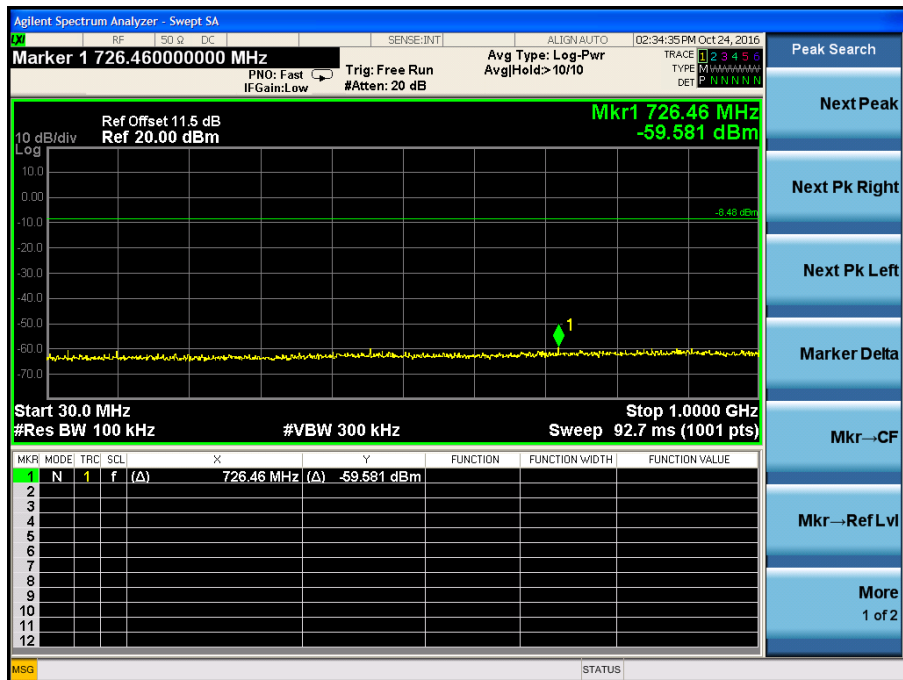

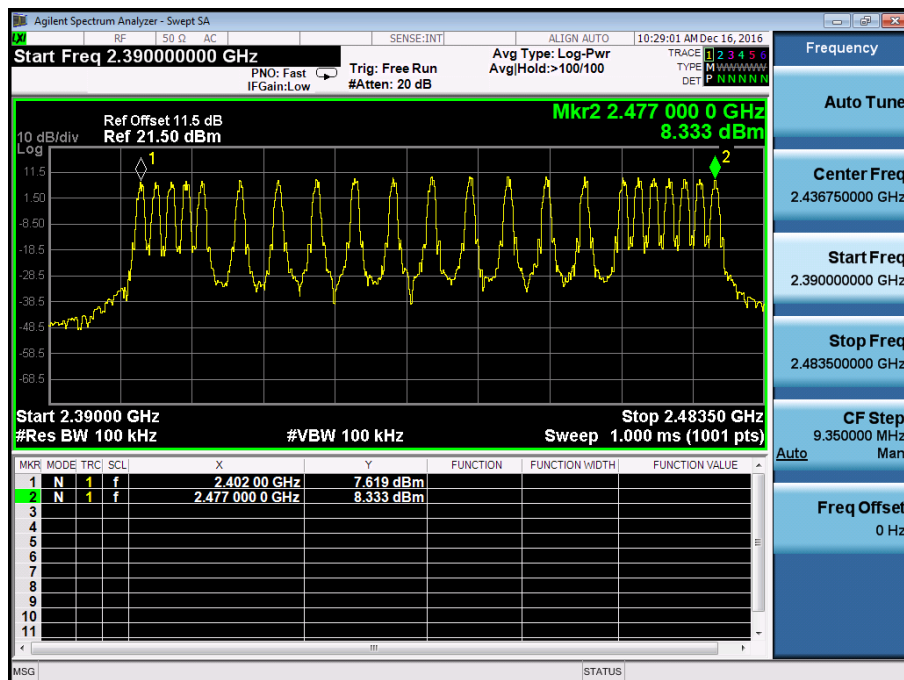


Appendix B.4: Carrier Frequency Separation



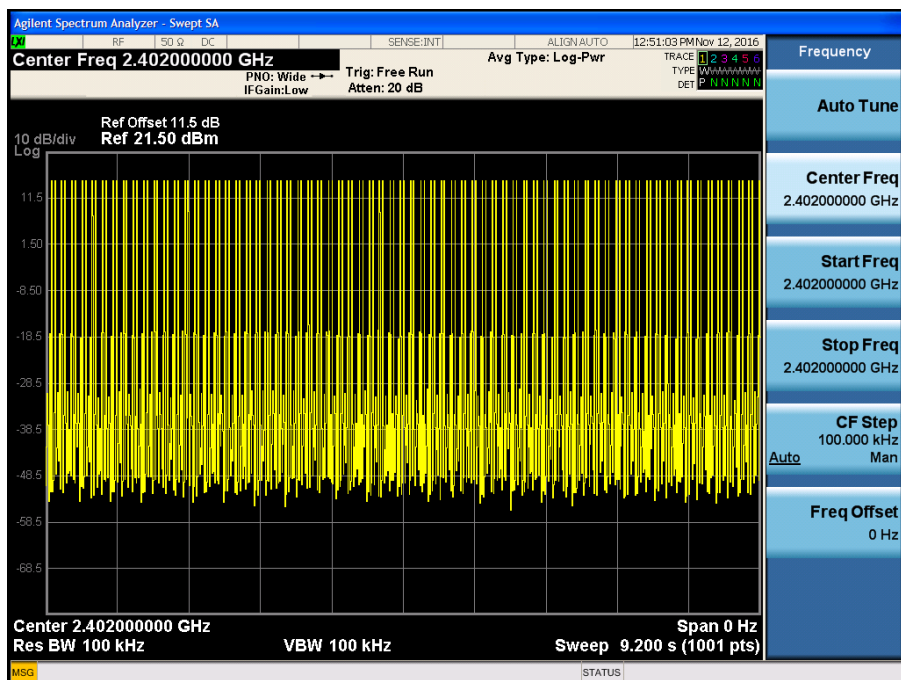
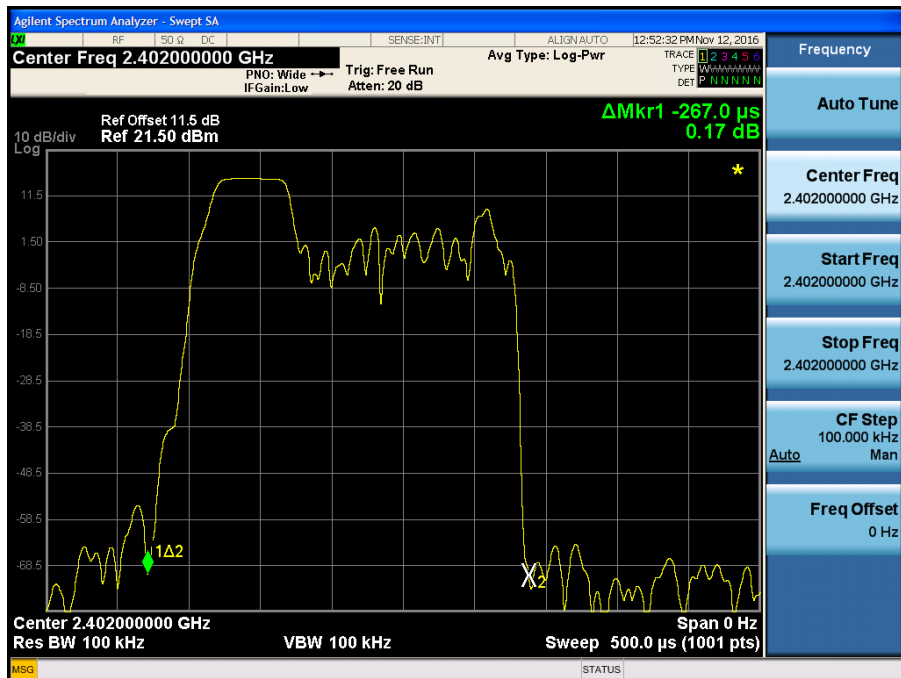


Appendix B.5: Number of Hopping Frequency

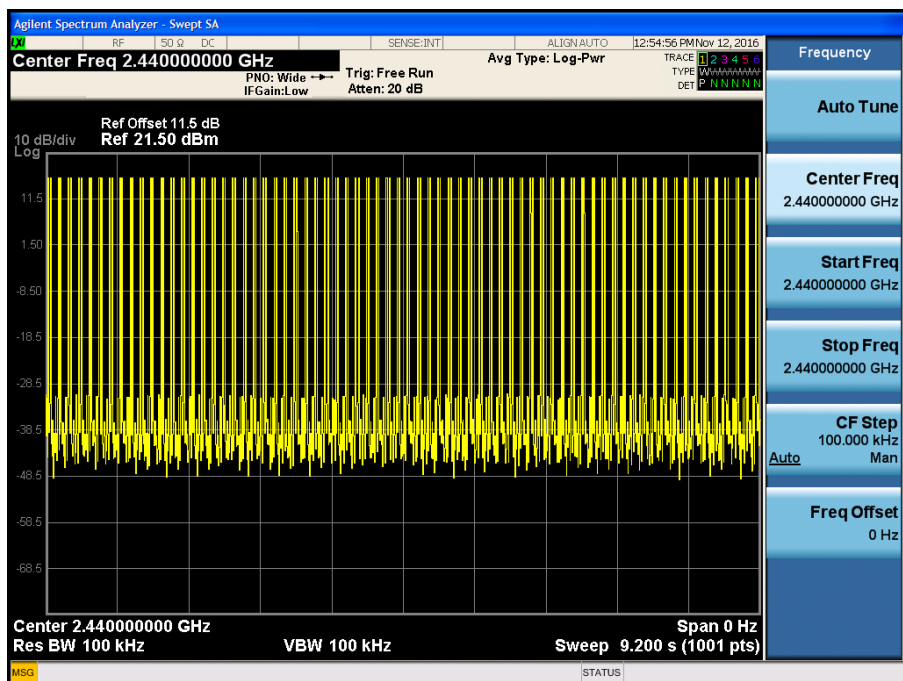
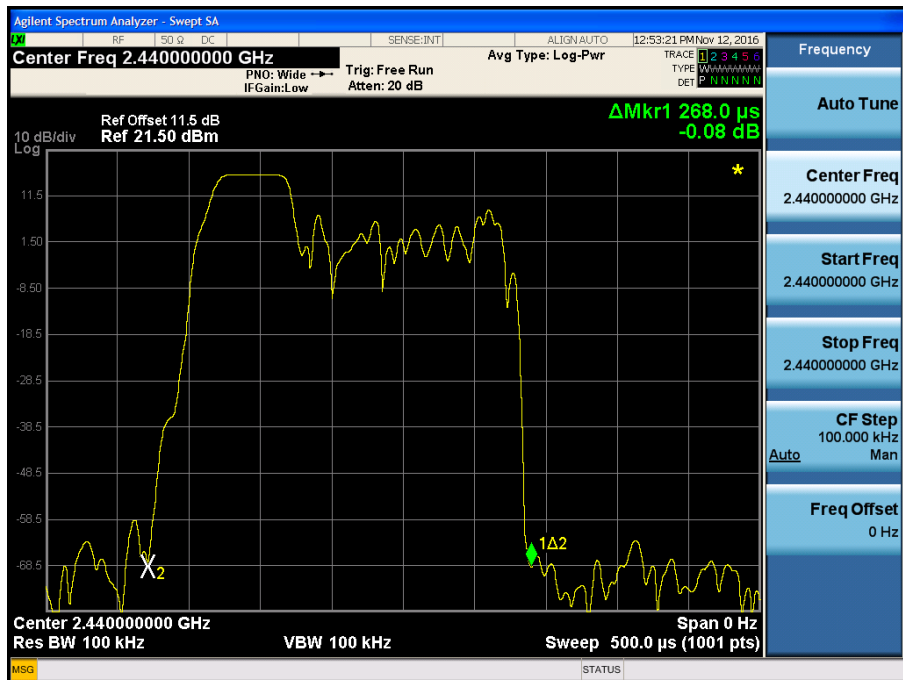

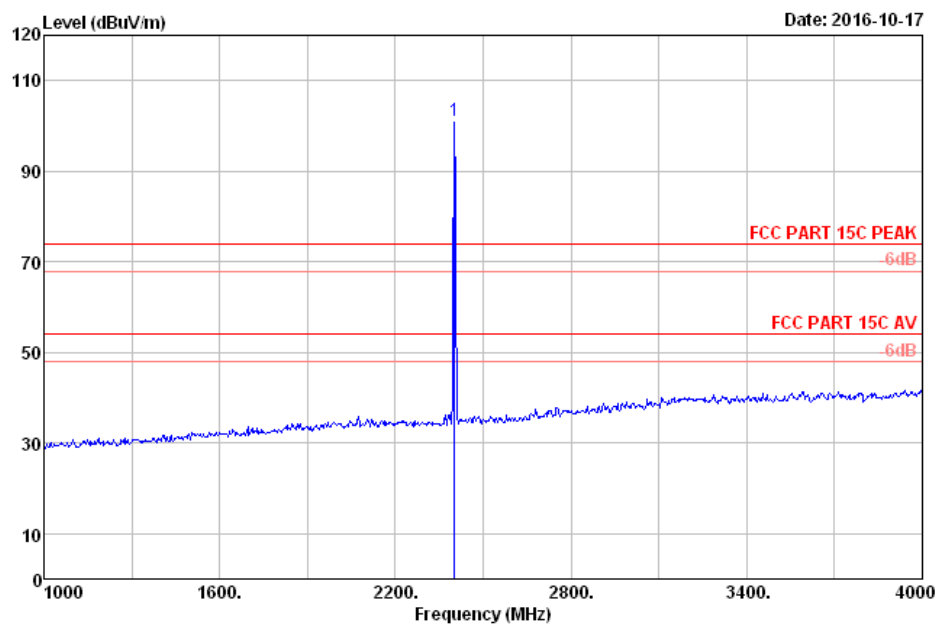
1GHz - 18GHz Duty Cycle

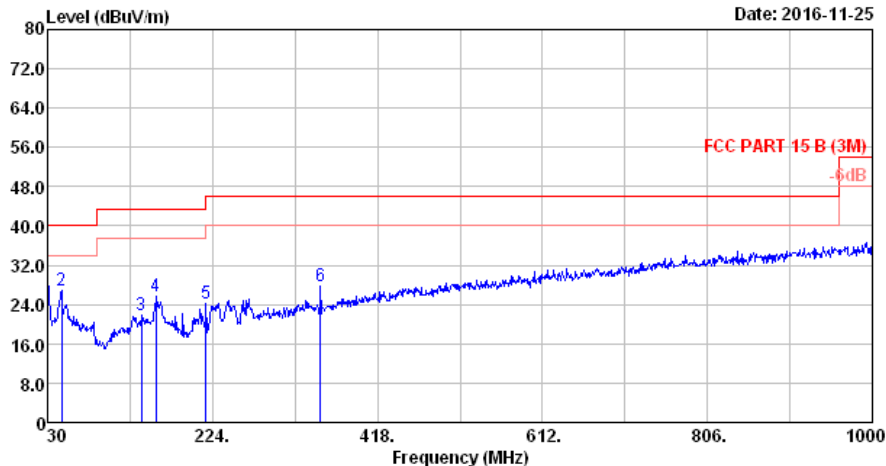
