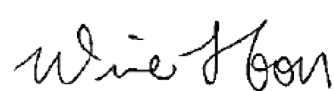

Diagram of Measurement Configuration for Radiation Test (Below 1GHz)

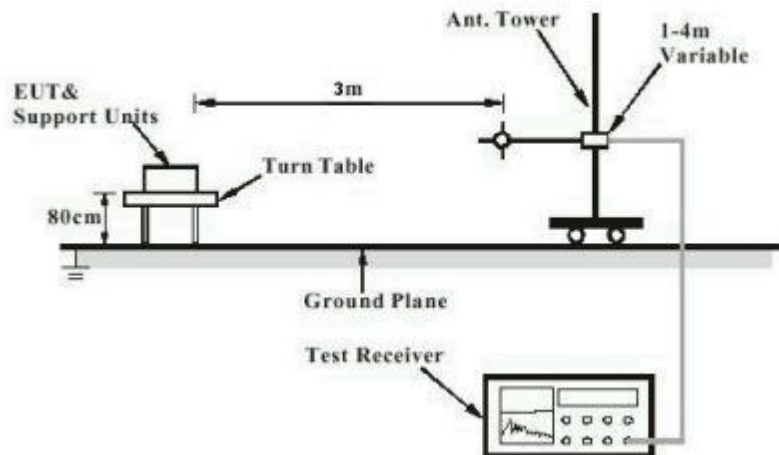


Diagram of Measurement Configuration for Radiation Test (Above 1GHz)

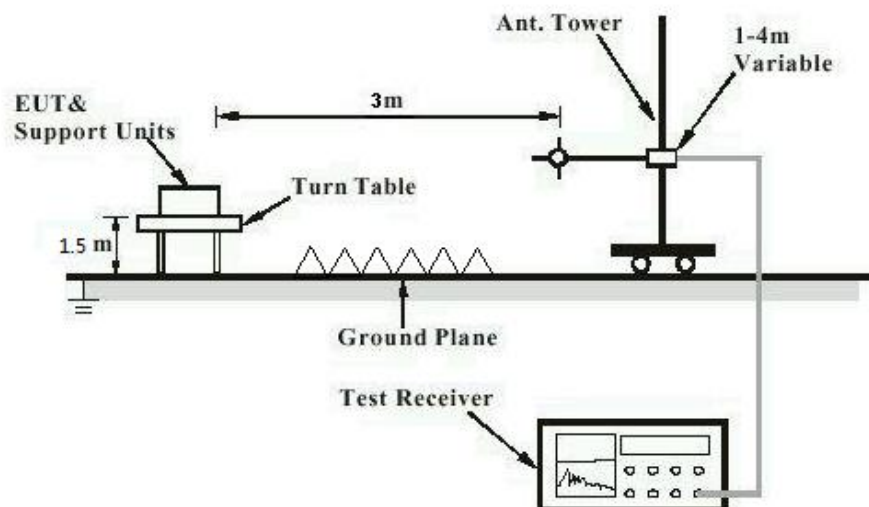


Diagram of Measurement Configuration for Mains Conduction Measurement

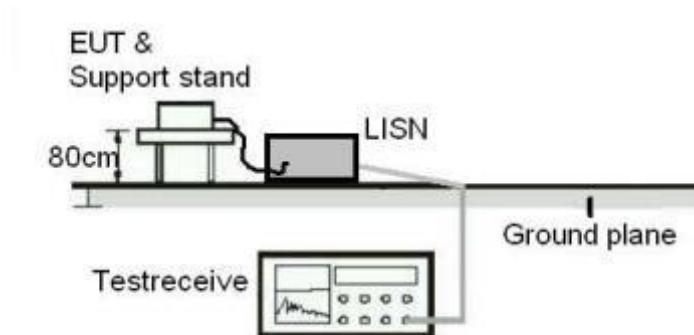
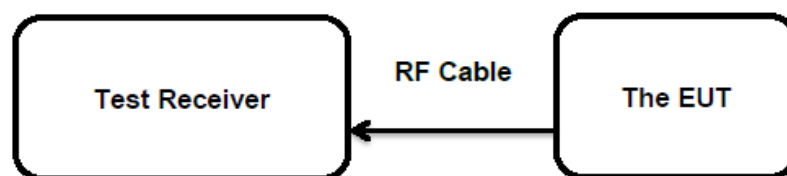


Diagram of Measurement Configuration for Conducted Transmitter Measurement

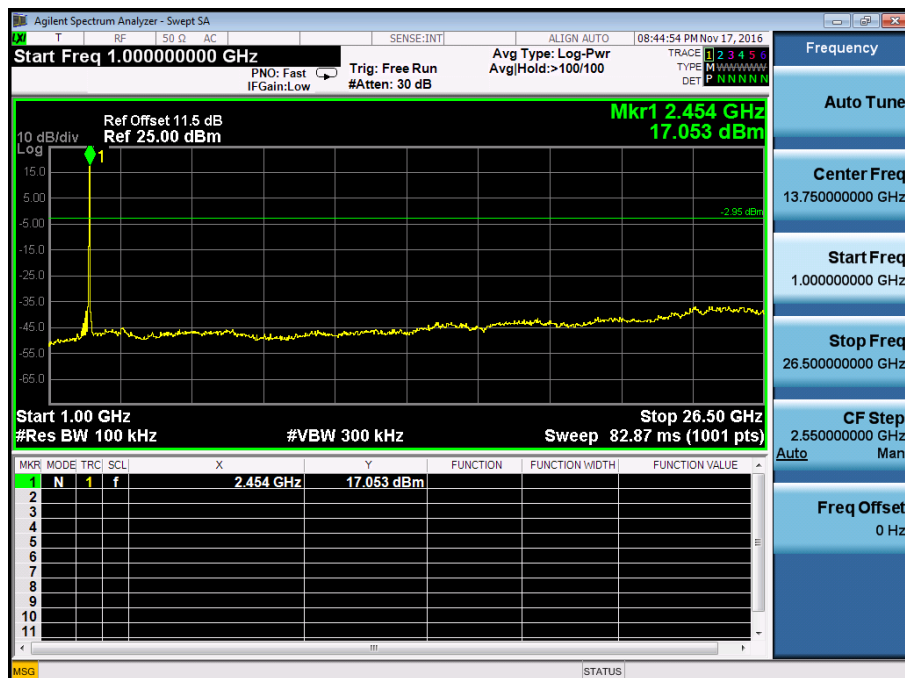
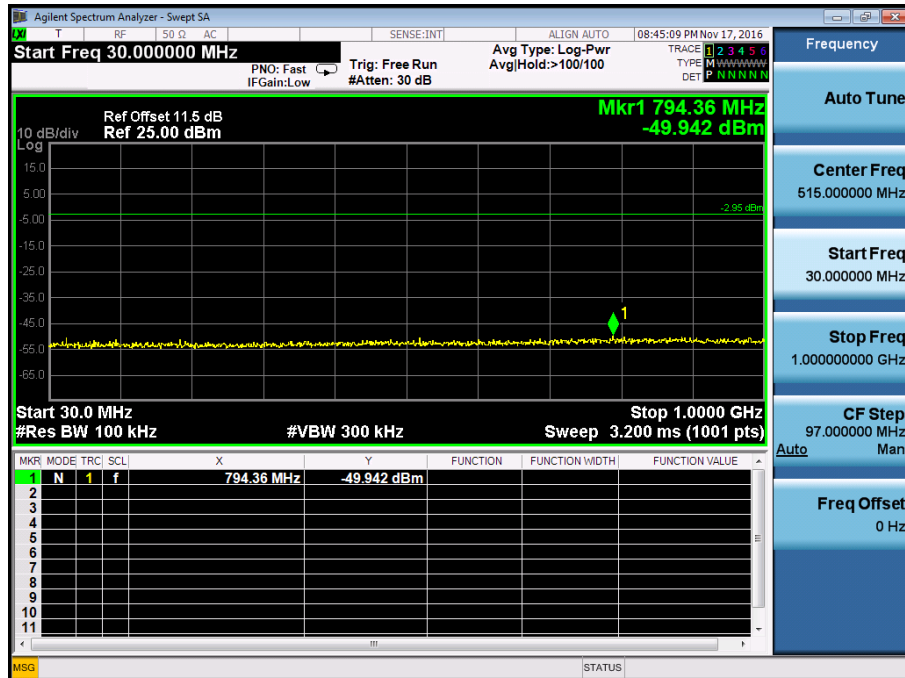


Appendix B.3: Conducted Spurious Emissions Measured in 100 kHz Bandwidth

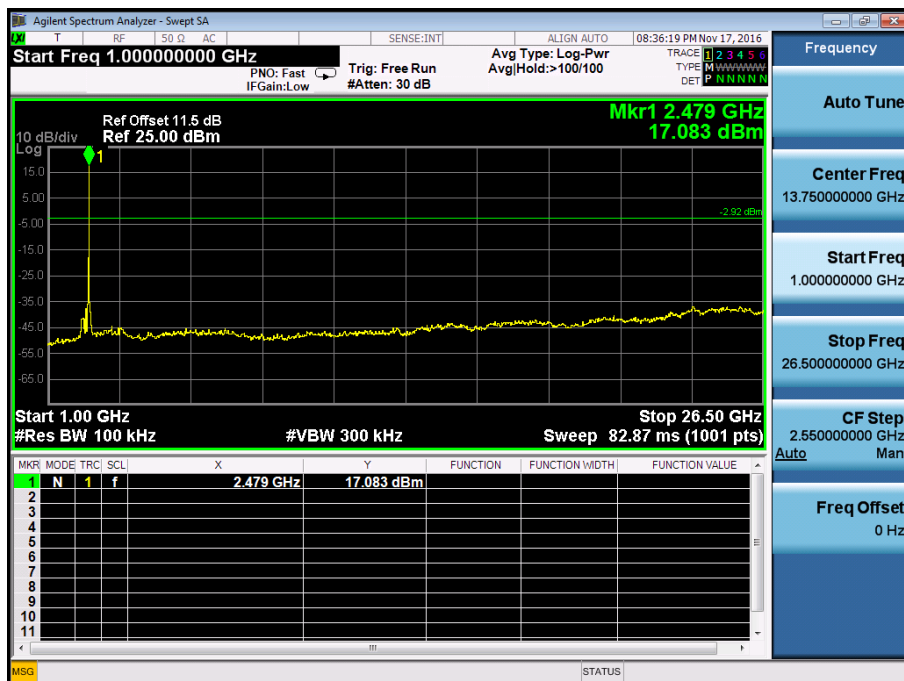
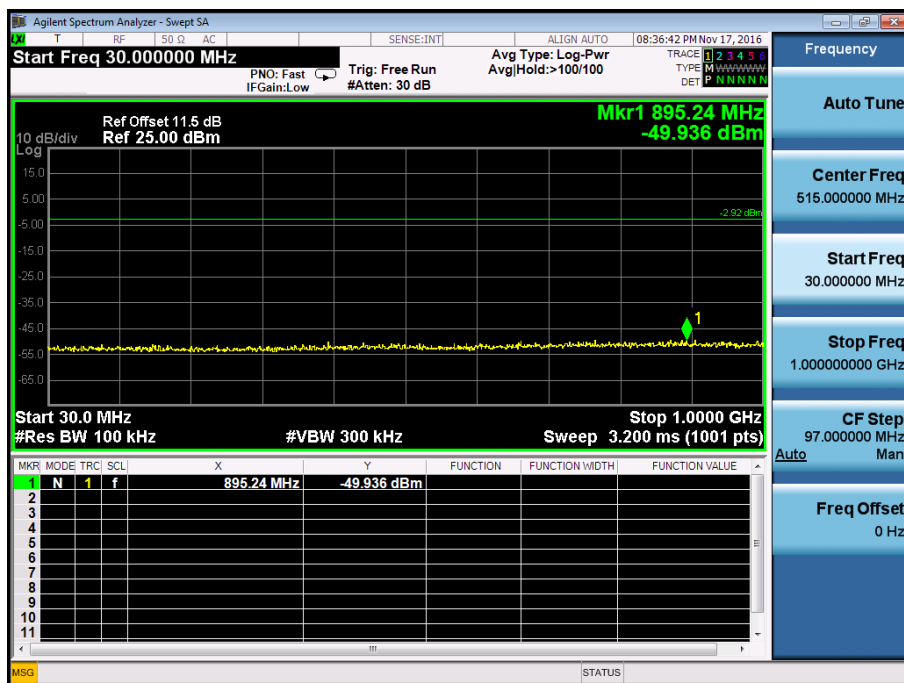

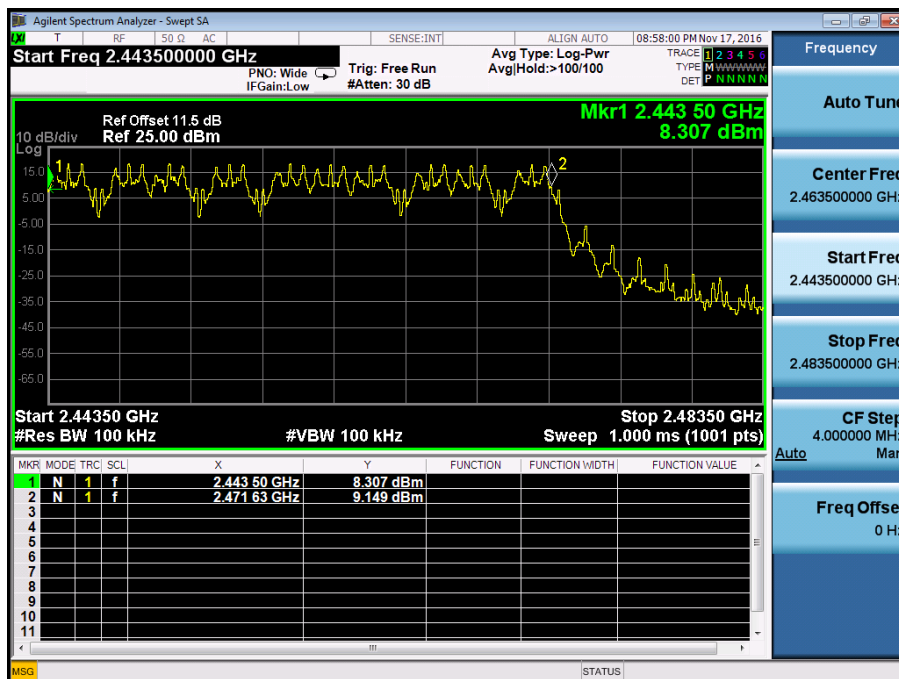
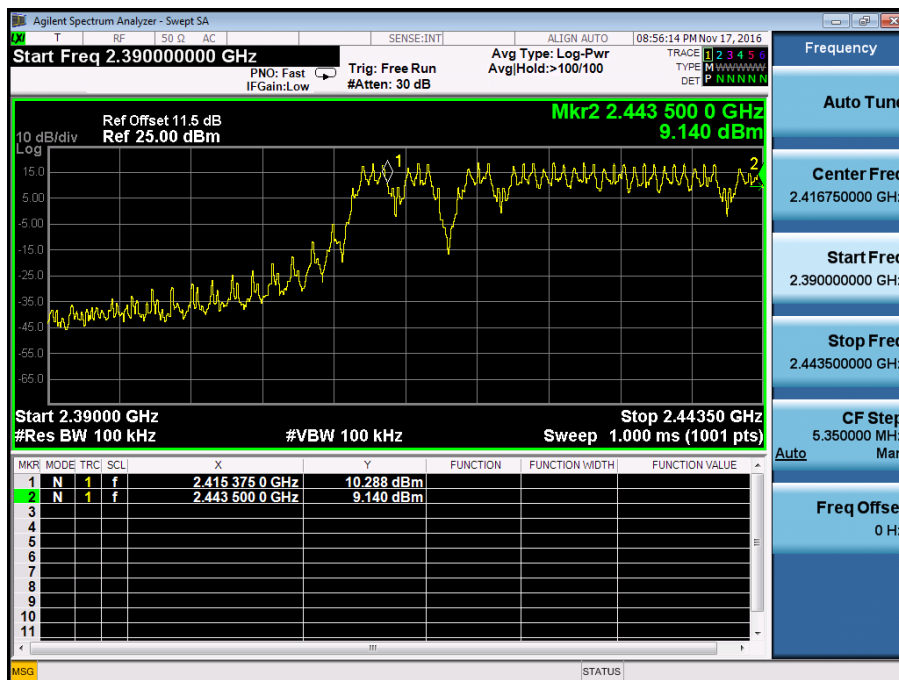


Appendix B.4: Carrier Frequency Separation



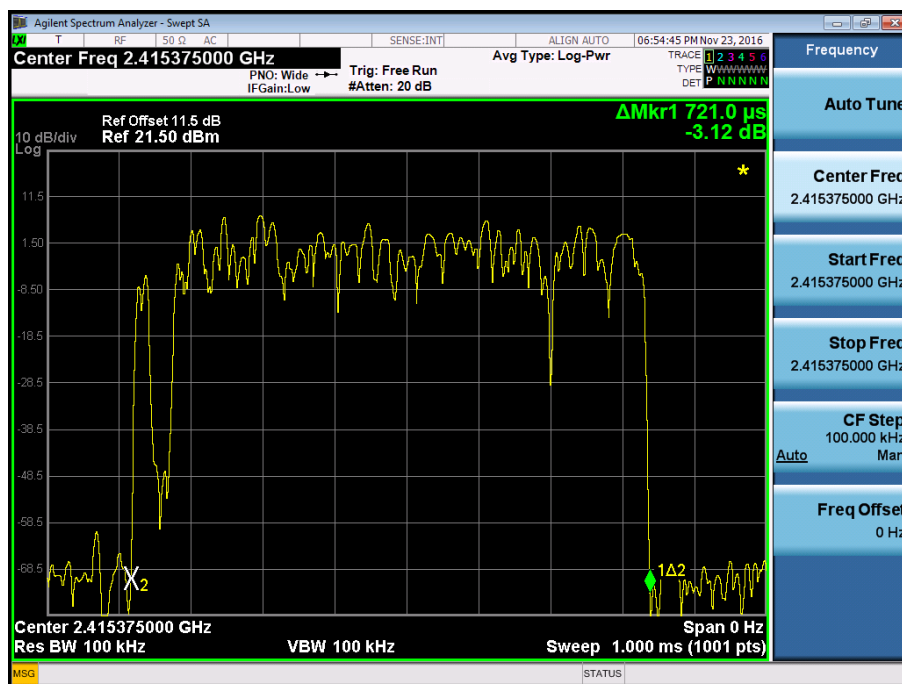
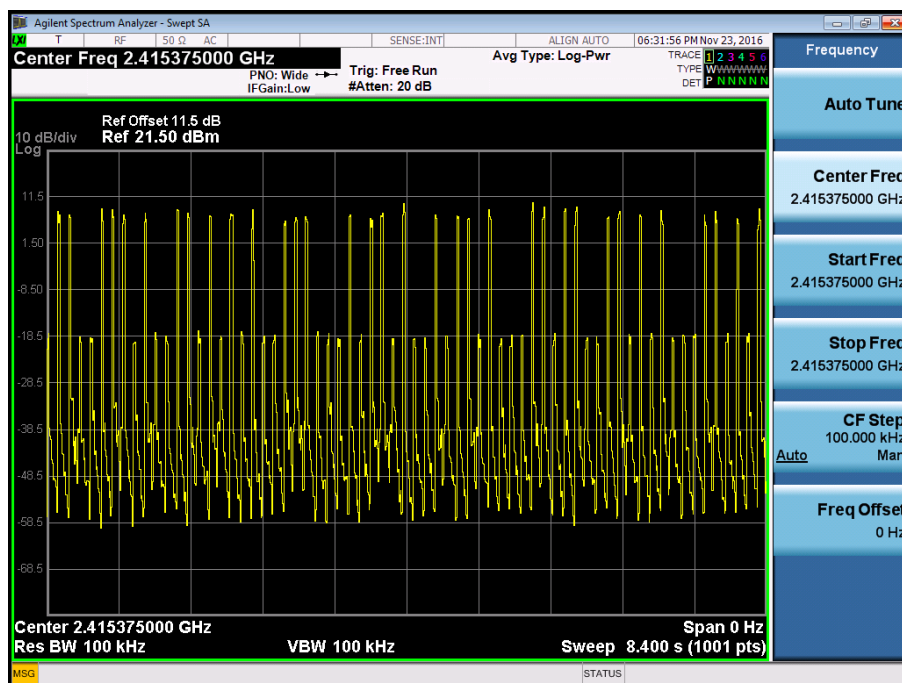
