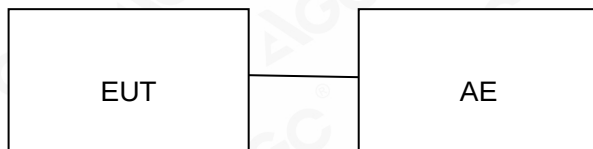

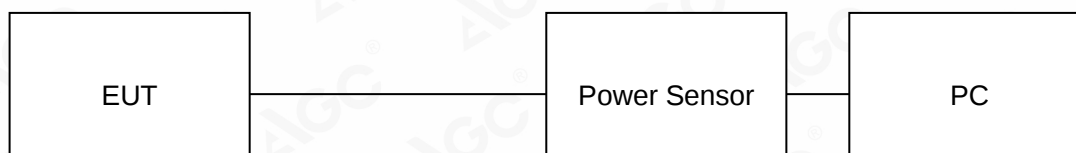
7.1. MEASUREMENT PROCEDURE

2. Connect the power sensor to the PC.
3. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
4. Record the maximum power from the software.

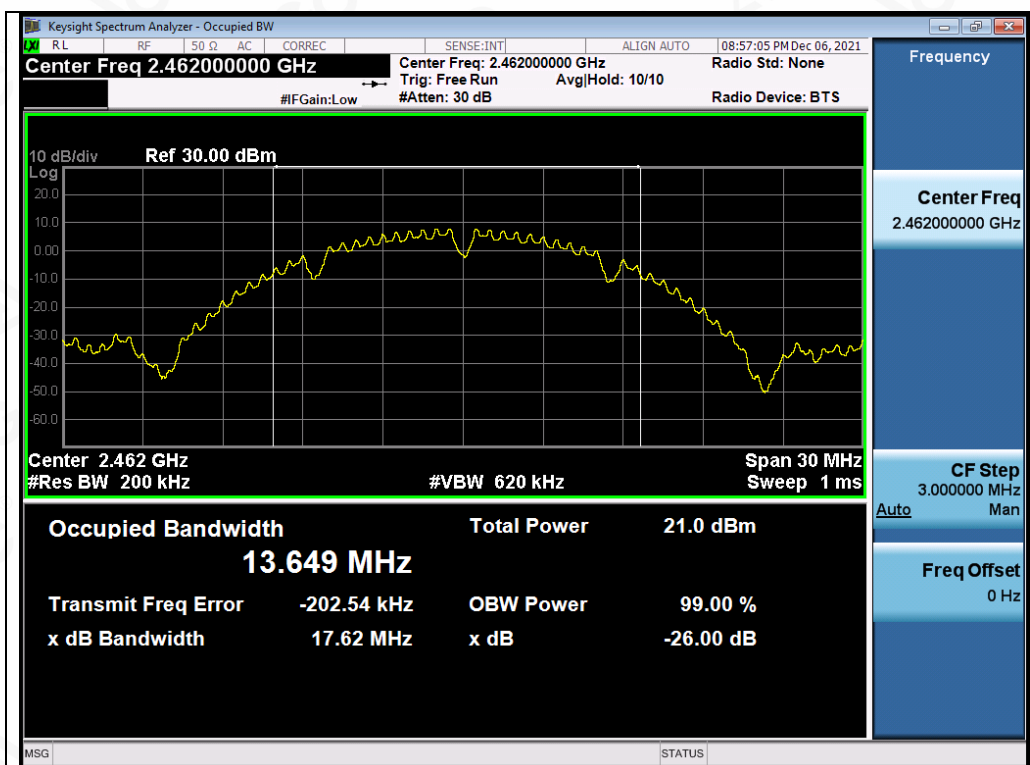

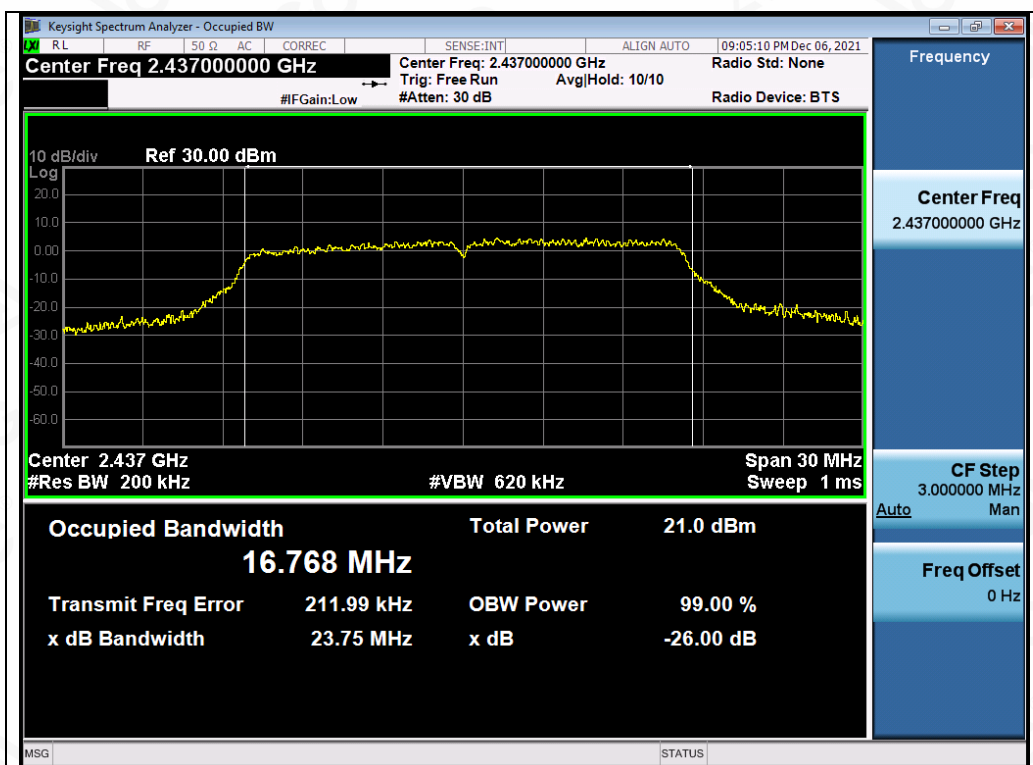


Test Graph 802.11g ANT1 2412 6Mbps OBW

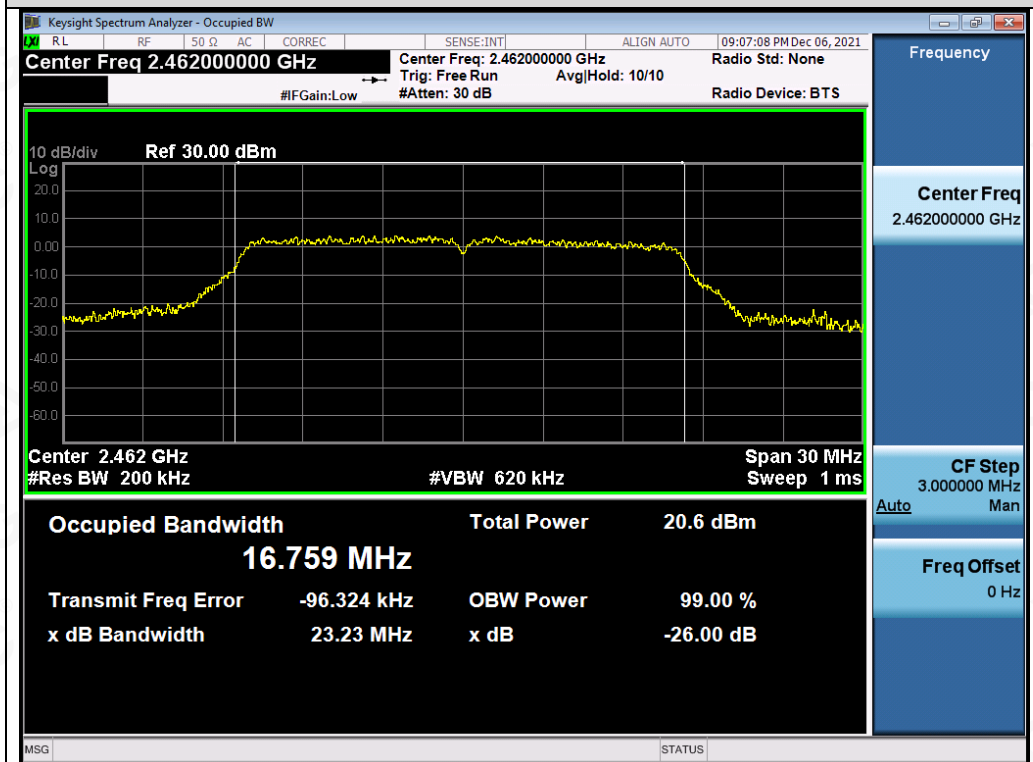

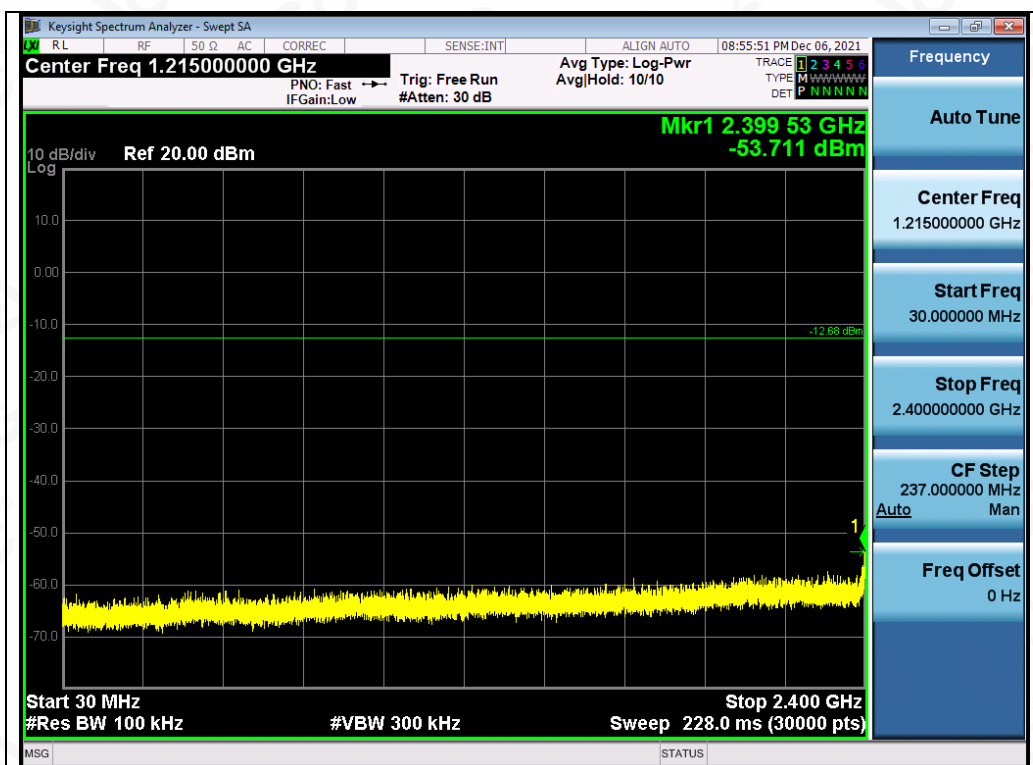

Test_Graph_802.11b_ANT1_2437_1Mbps_Lower Band Emissions

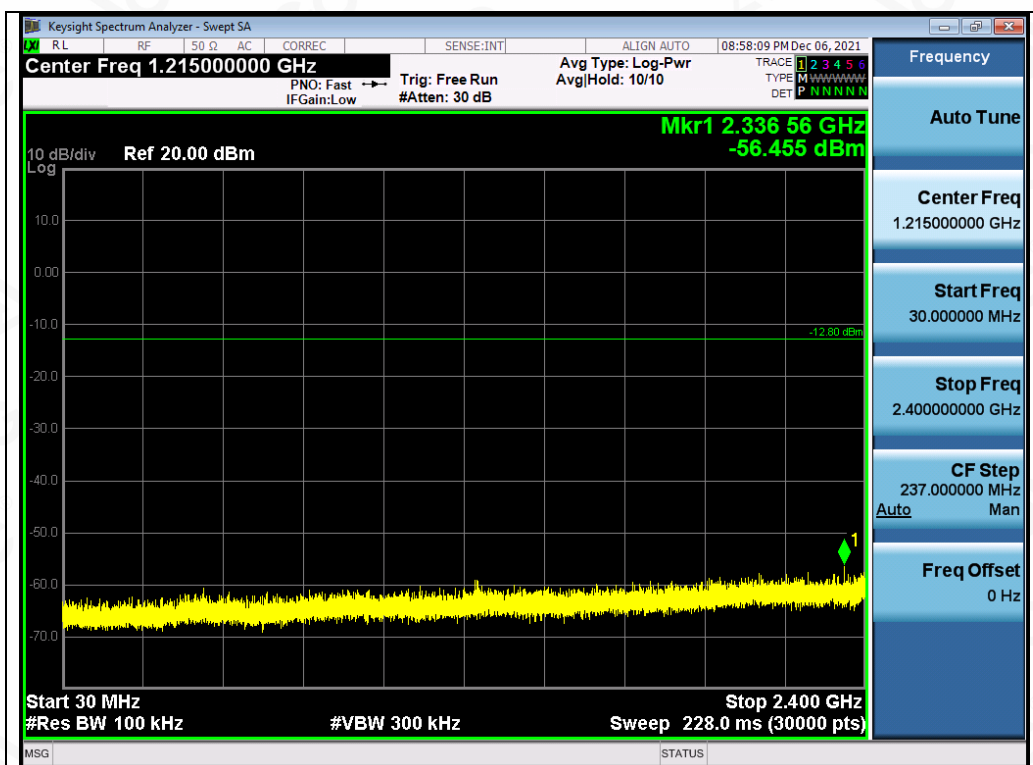

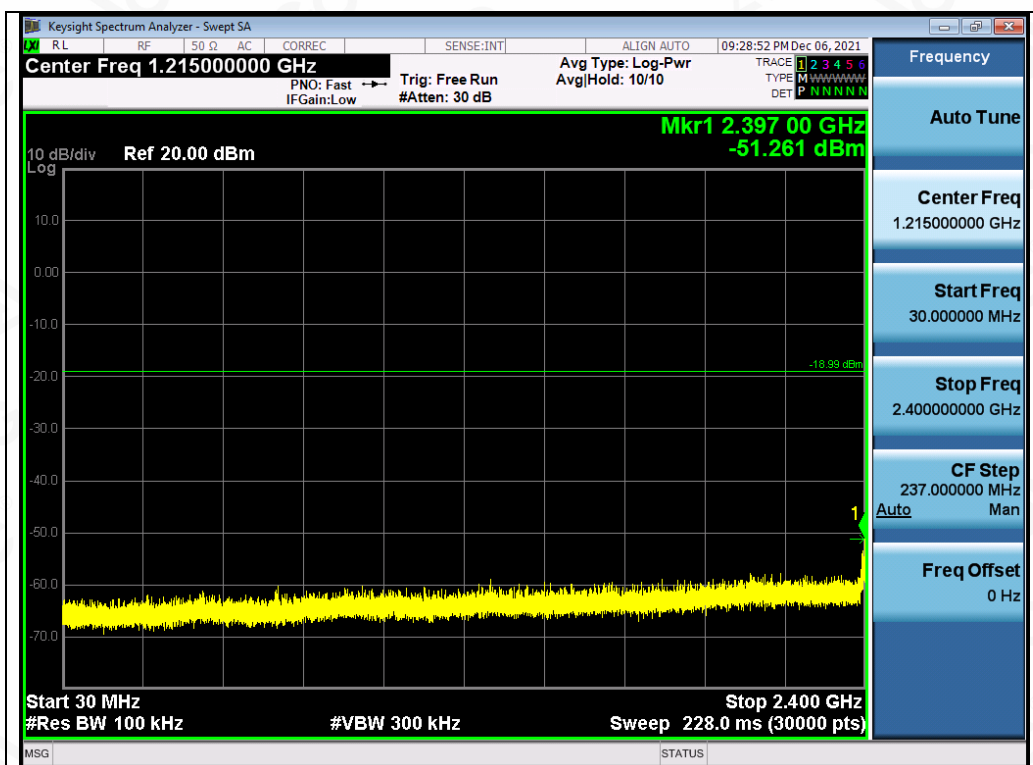

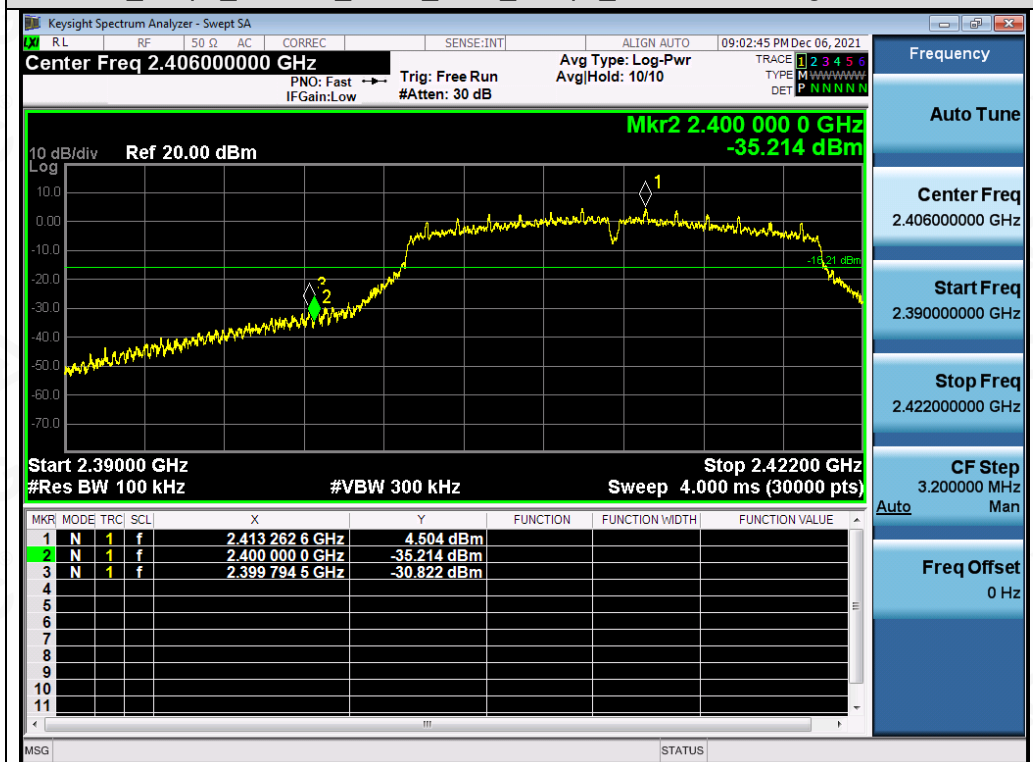
