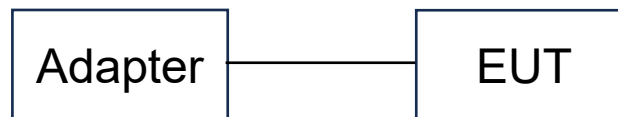

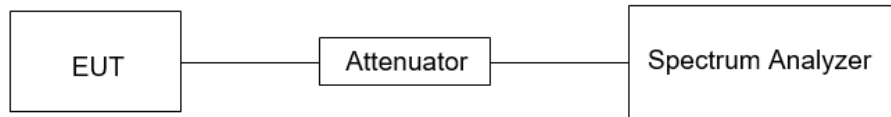

Use a direct connection between the antenna port of the unlicensed wireless device and the spectrum analyzer, through suitable attenuation. Frequency hopping shall be disabled for this test. Use the following spectrum analyzer settings:

- a) Span: Approximately five times the 20 dB bandwidth, centered on a hopping channel.
- b) RBW > 20 dB bandwidth of the emission being measured.
- c) VBW $\geq$ RBW.
- d) Sweep: No faster than coupled (auto) time.
- e) Detector function: Peak.
- f) Trace: Max-hold.
- g) Allow trace to stabilize.
- h) Use the marker-to-peak function to set the marker to the peak of the emission.
- i) The indicated level is the peak output power, after any corrections for external attenuators and cables.
- j) A spectral plot of the test results and setup description shall be included in the test report.

NOTE—A peak responding power meter may be used, where the power meter and sensor system video bandwidth is greater than the occupied bandwidth of the unlicensed wireless device, rather than a spectrum analyzer.

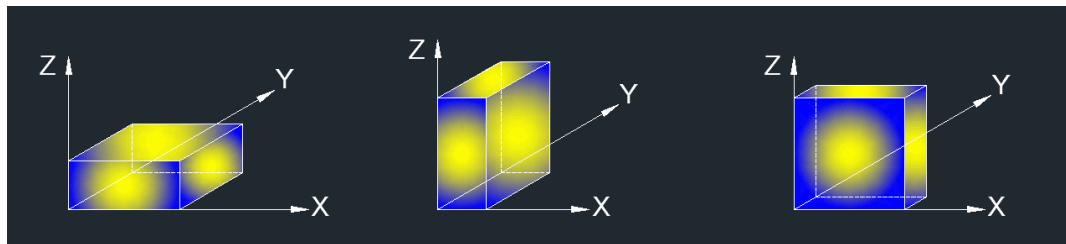

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. 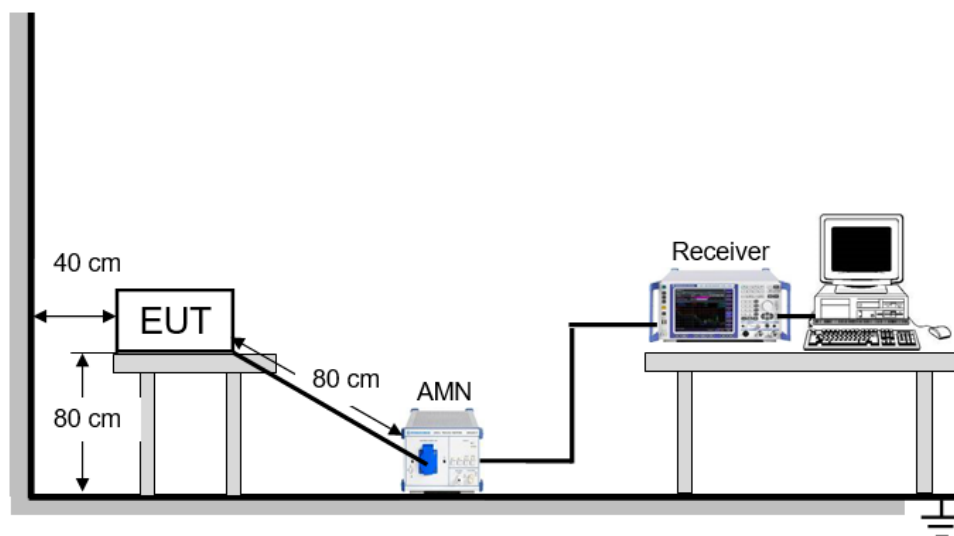
TEST PROCEDURE

Refer to ANSI C63.10-2020 clause 6.2.

The EUT is put on a table of non-conducting material that is 80 cm high. The vertical conducting wall of shielding is located 40 cm to the rear of the EUT. The power line of the EUT is connected to the AC mains through a Artificial Mains Network (A.M.N.). A EMI Measurement Receiver is used to test the emissions from the AC line. According to the requirements in Section 6.2 of ANSI C63.10-2020. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode. The bandwidth of EMI test receiver is set at 9 kHz.

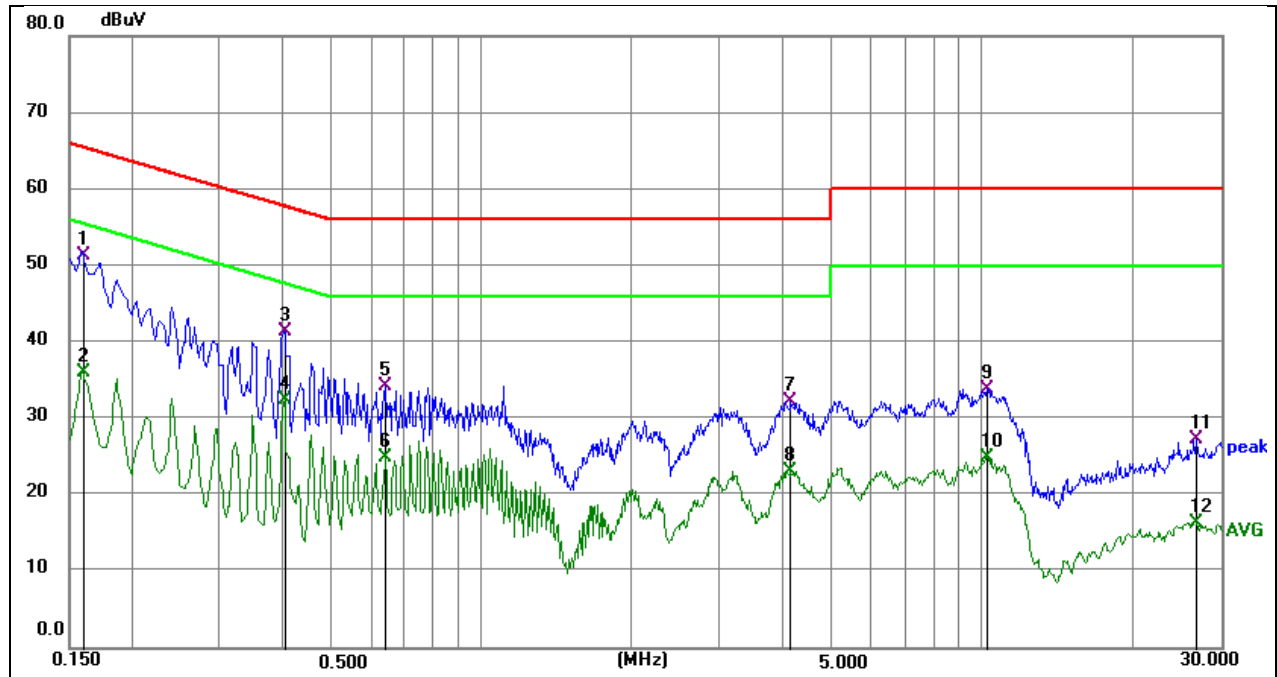

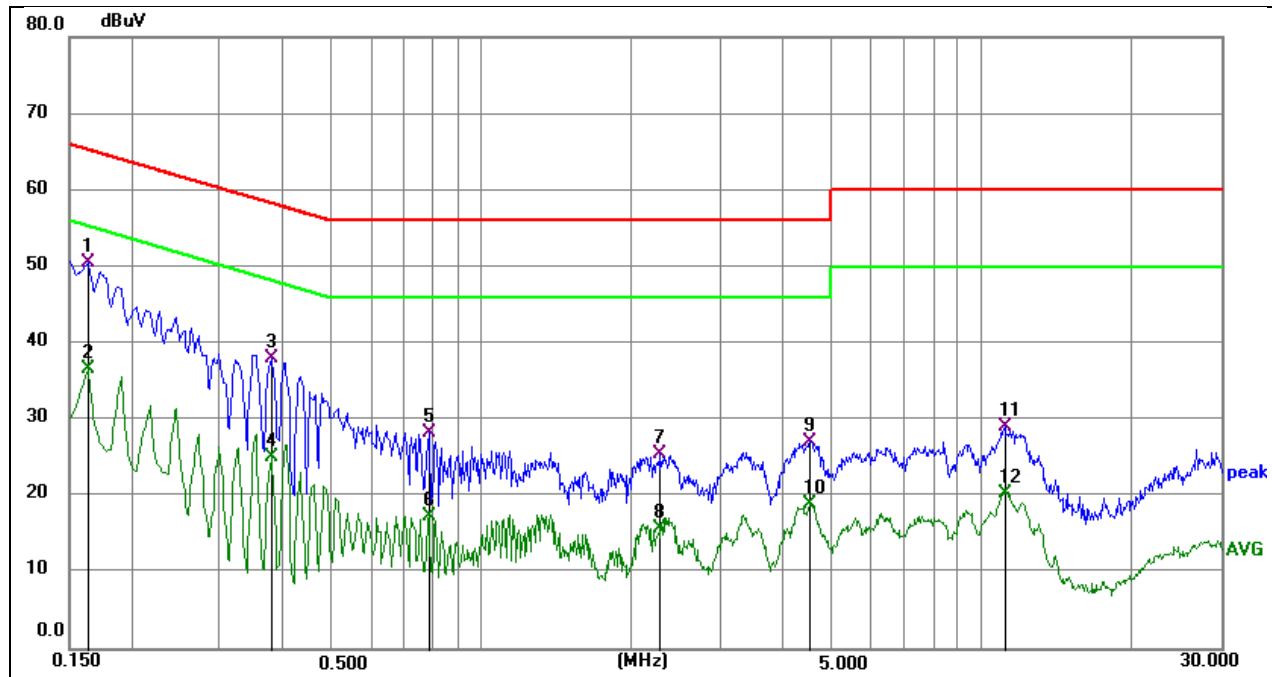
