2 Re-use of Measured Data

2.1 Introduction Section

This application re-uses data collected on a similar device. The subject device of this application (Model: SC20-AX, FCC ID: XMR202201SC20AX) is electrically identical to the reference device (Model: SC20-AL, FCC ID: XMR201911SC20AL) for the portions of the circuitry corresponding to the data being re-used. Based on their similarity, the FCC Part 15C (equipment class: DTS) reuse the original model's result and do spot-check, following the FCC KDB 484596 D01 v01.

The applicant takes full responsibility that the test data as referenced in this report represent compliance for this FCC ID: XMR202201SC20AX .

2.2 Model Difference Information

The **main** difference between FCC ID: XMR201911SC20AL and FCC ID: XMR202201SC20AX is as below:

- SC20-AX uses MCP memory while SC20-AL uses EMCP memory, so the layout of memory part is different
- SC20-AX added U1007 to optimize the Tx performance of B13
- U1502 changed the WiFi 2.4G SAW package size
