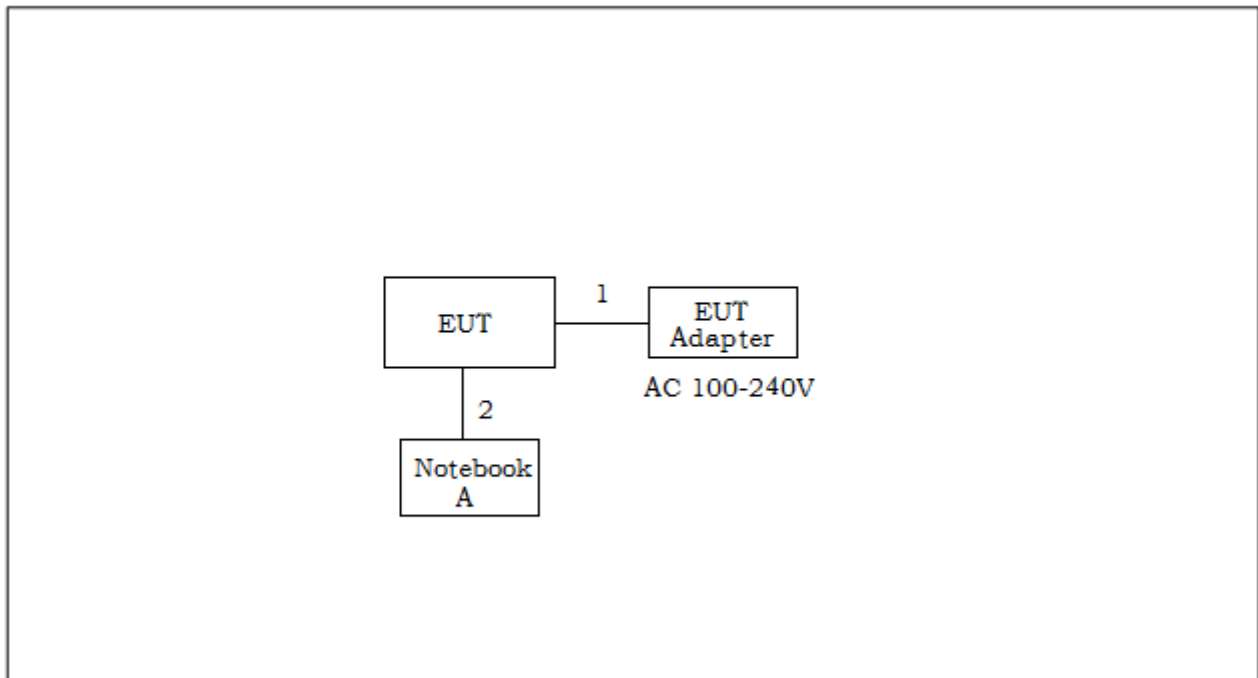
- (1) The measurements are performed at the high, middle, low available channels.
- (2) The measurements for Hopping Channel Separation and Bandwidth were tested during 1Mbps, 2Mbps and 3Mbps, the worst case are 1Mbps and 3Mbps, only worst case was documented except power.
- (3) For radiated emission above 1 GHz test, 1GHz~26.5GHz have been pre-tested and in this report only recorded the worst case. The remaining spurious points are all below the limit value of 20dB.
- (4) For AC power line conducted emissions and radiated spurious emissions below 1 GHz test, the 1 Mbps channel 39 are found to be the worst case and recorded.
- (5) This product has the mode of BT AFH, which was considered during testing, but this mode is not the worst case mode, and this report only shows the worst case mode.
- (6) For AC power line conducted emissions test, Power AC 120V/60Hz and AC 240V/60Hz were evaluated, the worst case is recorded in this test report.

During testing, channel & power controlling software provided by the customer was used to control the operating channel as well as the output power level. The RF output power selection is for the setting of RF output power expected by the customer and is going to be fixed on the firmware of the final end product power parameters of FHSS

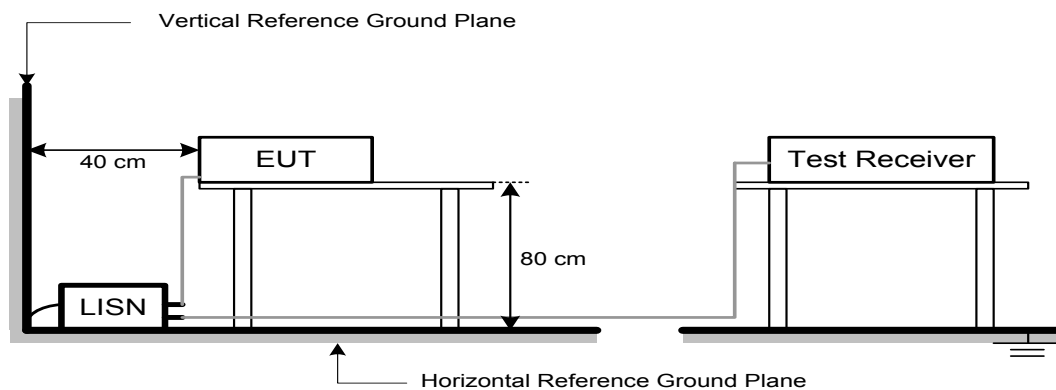
3.2 TEST PROCEDURE

- a. The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipment powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d. LISN at least 80 cm from nearest part of EUT chassis.
- e. For the actual test configuration, please refer to the related Item –EUT Test Photos.

4.2 TEST PROCEDURE

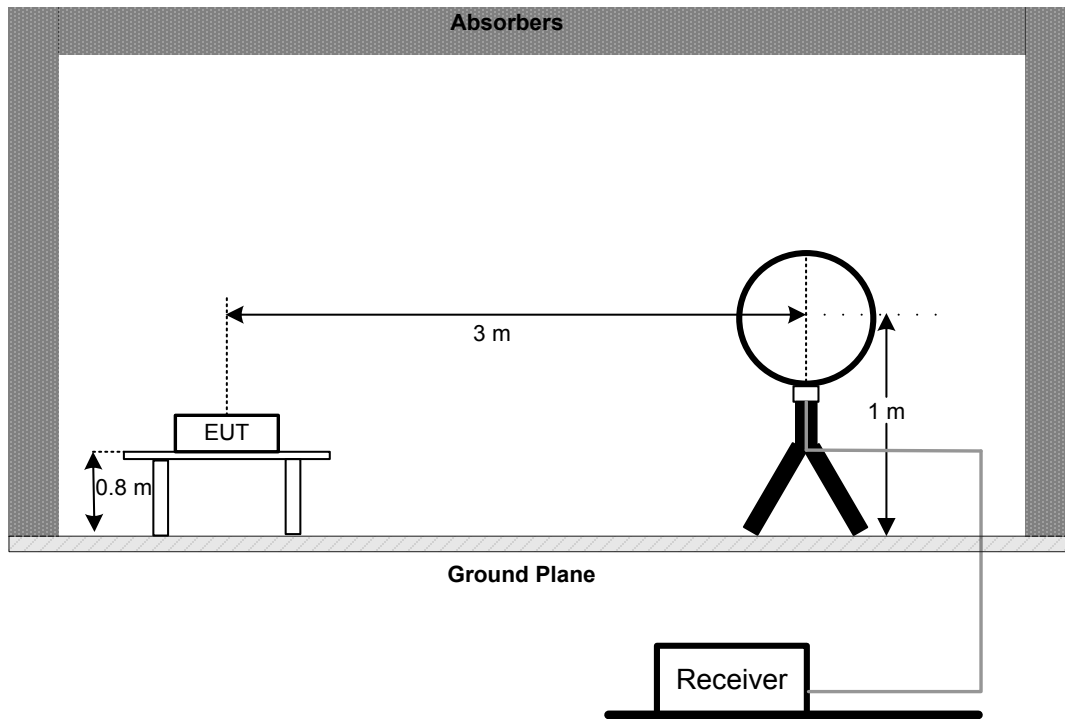
- a. The measuring distance of 3 m shall be used for measurements. The EUT was placed on the top of a rotating table 0.8 meter above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.(below 1 GHz)
- b. The measuring distance of 3 m shall be used for measurements. The EUT was placed on the top of a rotating table 1.5 meter above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.(above 1 GHz)
- c. The height of the equipment or of the substitution antenna shall be 0.8m or 1.5m; the height of the test antenna shall vary between 1 m to 4 m. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights find the maximum reading (used Bore sight function).
- e. The receiver system was set to peak and average detect function and specified bandwidth with maximum hold mode when the test frequency is above 1 GHz.
- f. The initial step in collecting radiated emission data is a receiver peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then Quasi Peak detector mode re-measured.
- g. All readings are Peak unless otherwise stated QP in column of Note. Peak denotes that the Peak reading compliance with the QP Limits and then QP Mode measurement didn't perform. (below 1 GHz)
- h. All readings are Peak Mode value unless otherwise stated AVG in column of Note. If the Peak Mode Measured value compliance with the Peak Limits and lower than AVG Limits, the EUT shall be deemed to meet both Peak & AVG Limits and then only Peak Mode was measured, but AVG Mode didn't perform. (above 1 GHz)

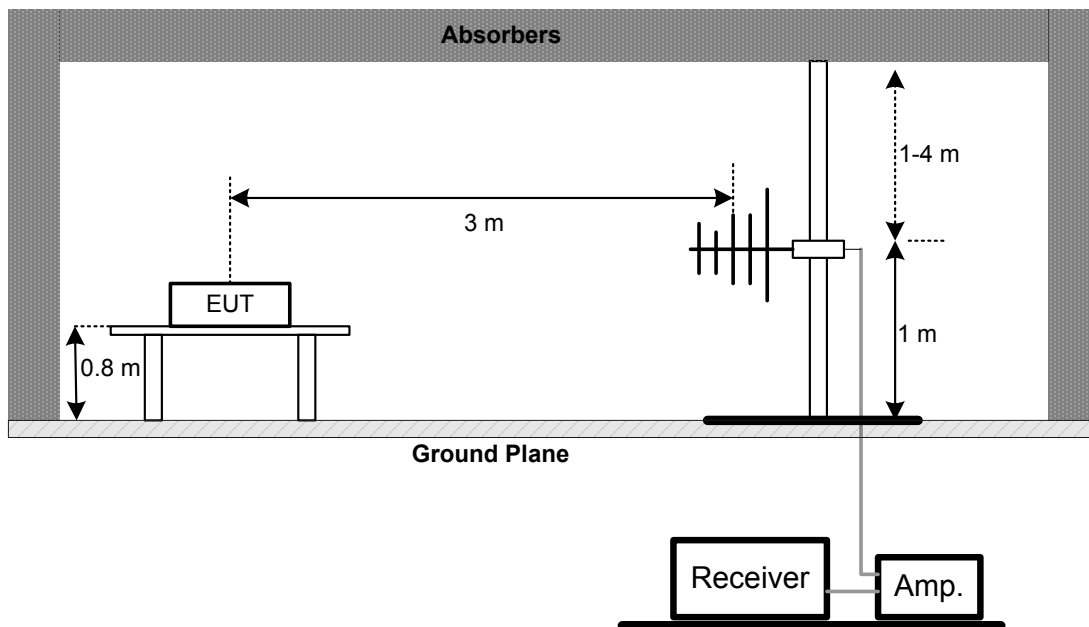

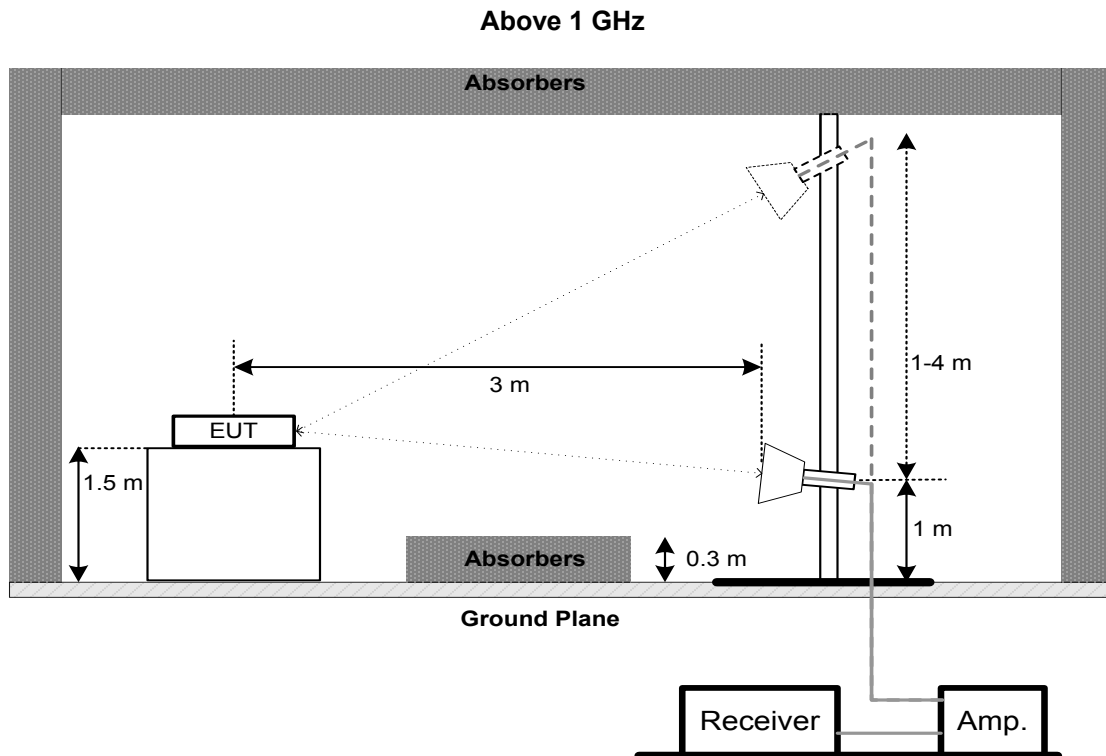

6.2 TEST PROCEDURE

- The transmitter output (antenna port) was connected to the spectrum analyzer
- Set RBW of spectrum analyzer to 1 MHz and VBW to 1 MHz
- Use a video trigger with the trigger level set to enable triggering only on full pulses
- Sweep Time is more than once pulse time
- Set the center frequency on any frequency would be measure and set the frequency span to zero span
- Measure the maximum time duration of one single pulse
- Set the EUT for DH1, DH3 and DH5 packet transmitting
- Measure the maximum time duration of one single pulse
 - DH1 Packet permit maximum $1600 / 79 / 2 = 10.12$ hops per second in each channel (1 time slot TX, 1 time slot RX). So, the dwell time is the time duration of the pulse times $10.12 \times 31.6 = 320$ within 31.6 seconds
