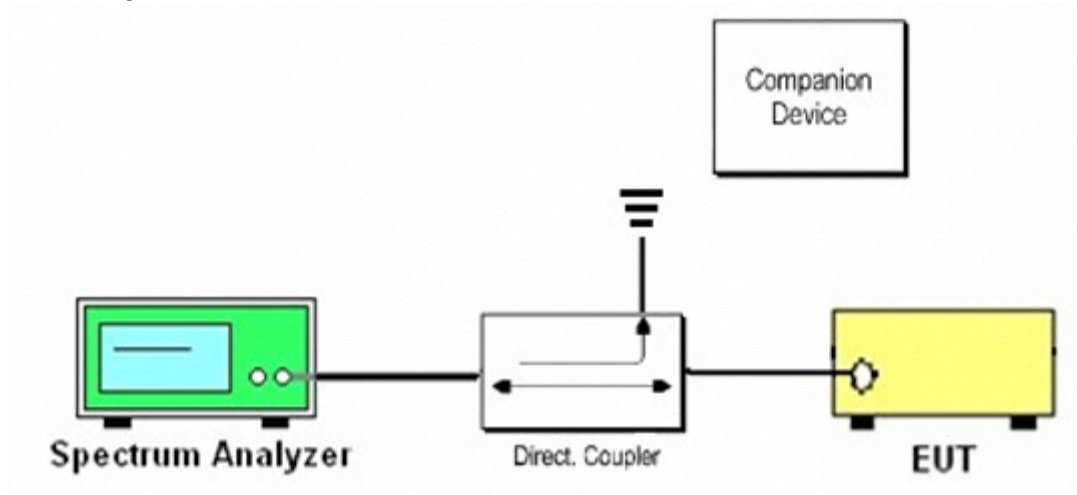

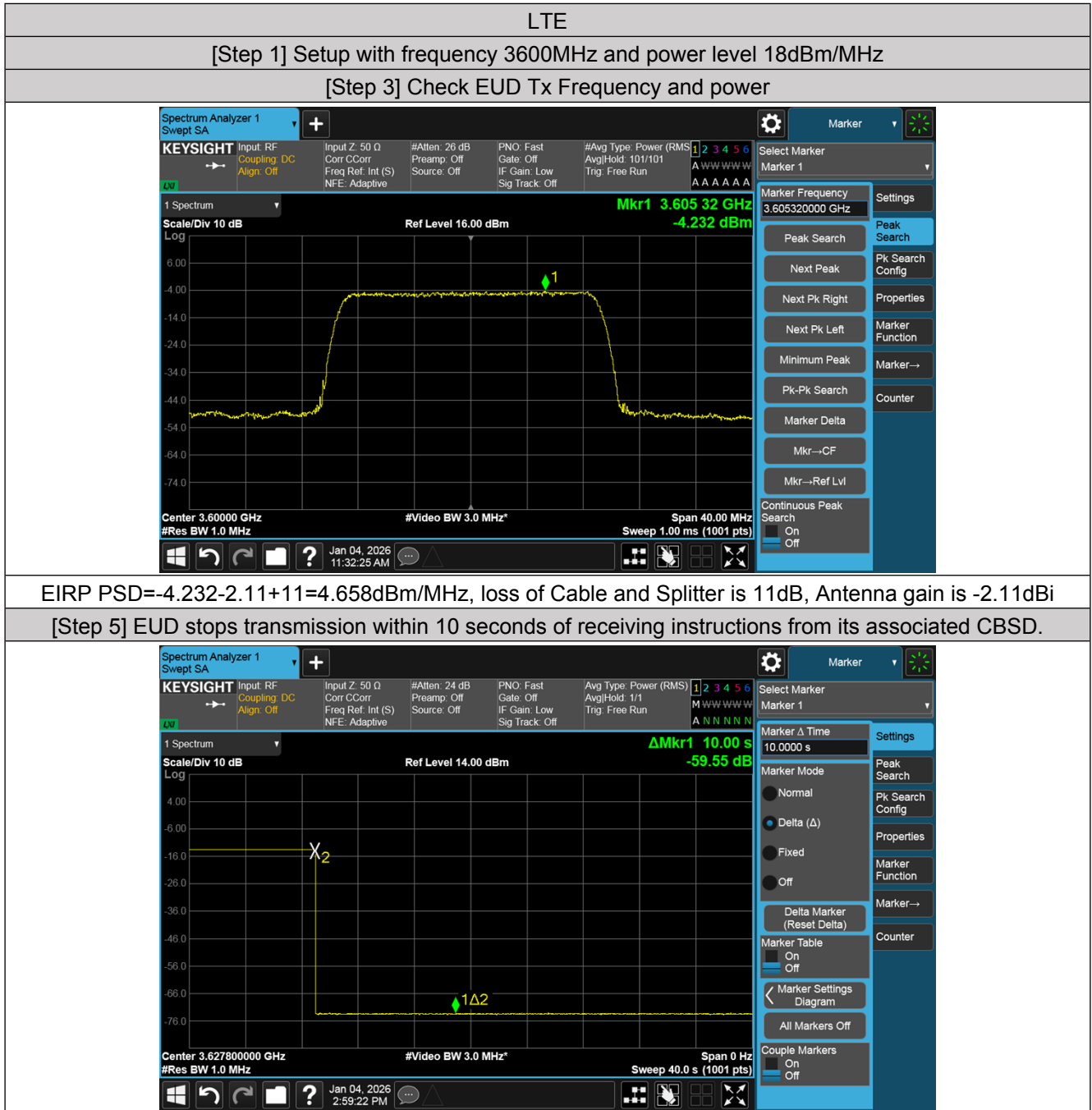

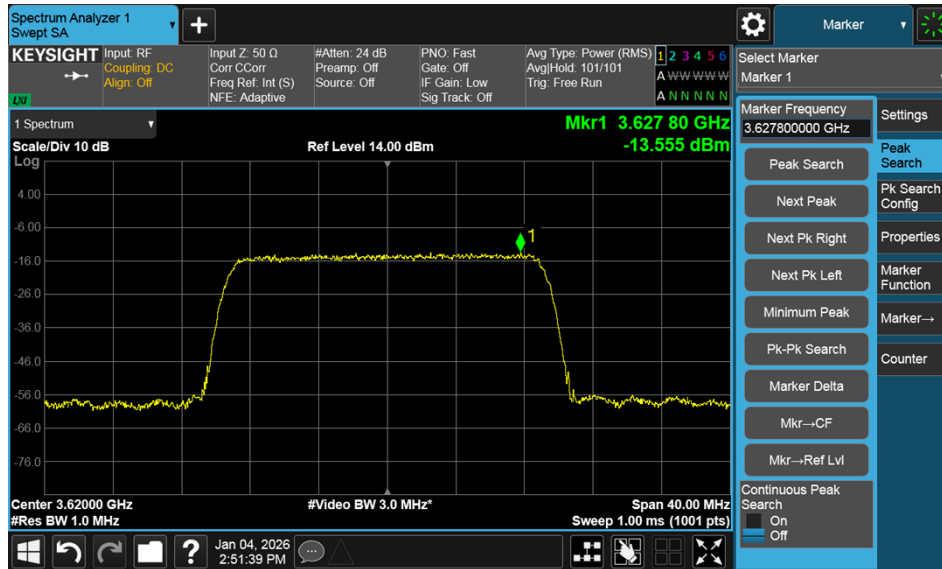
End User Device as UUT, the companion device is certified CBSD

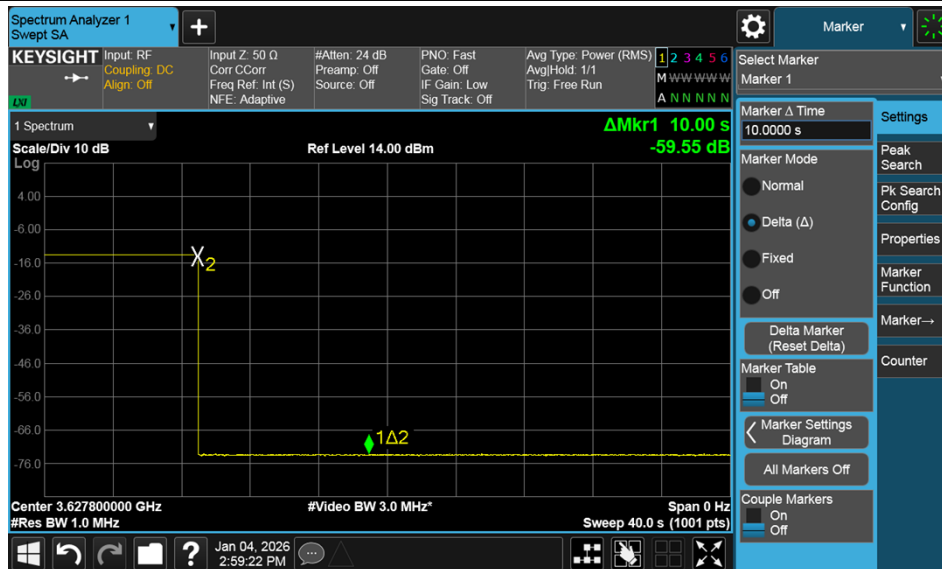
[Step 6] Setup with frequency 3620MHz and power level 8dBm/MHz

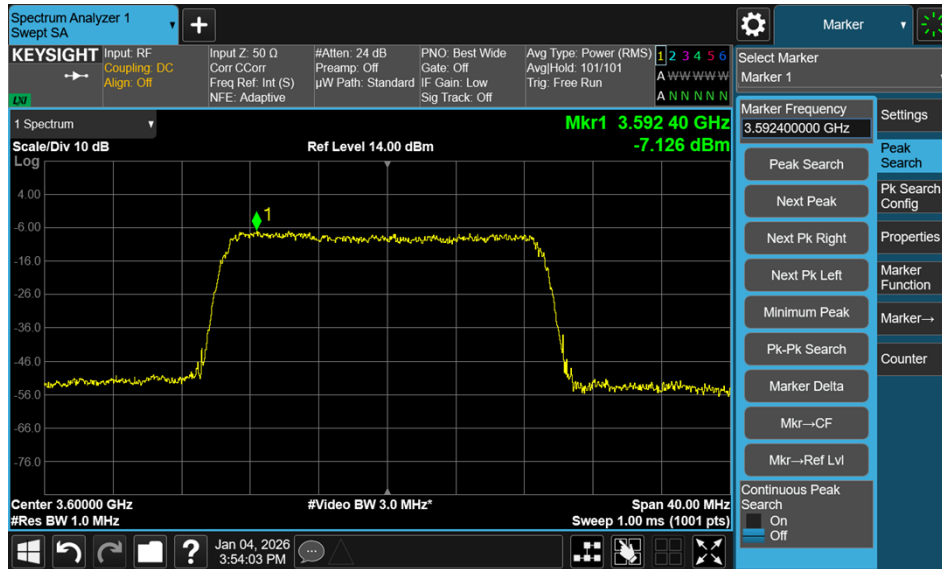

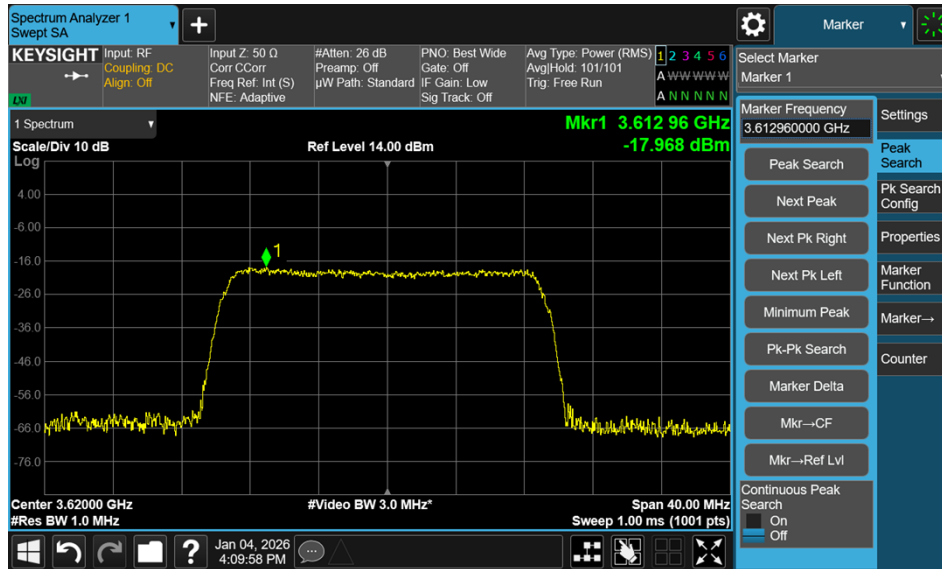

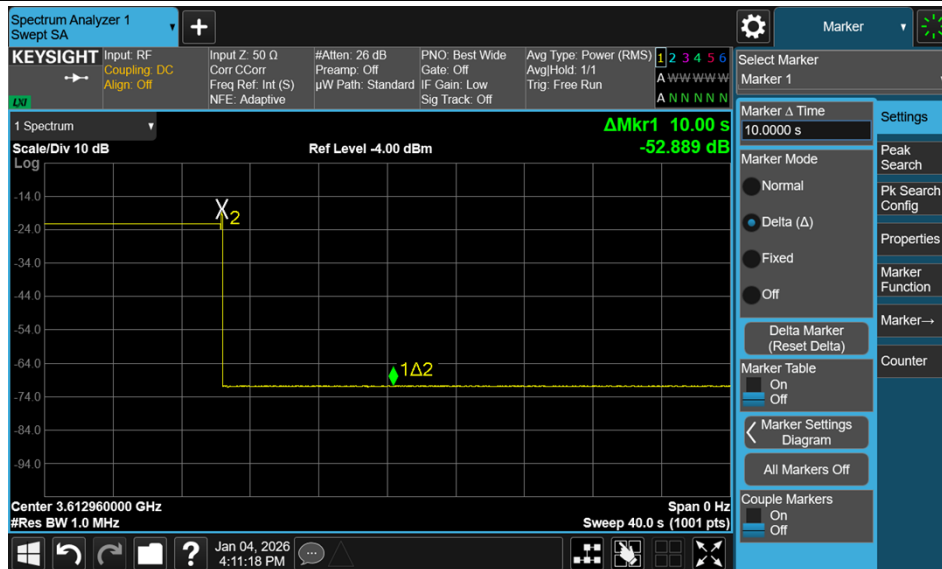
